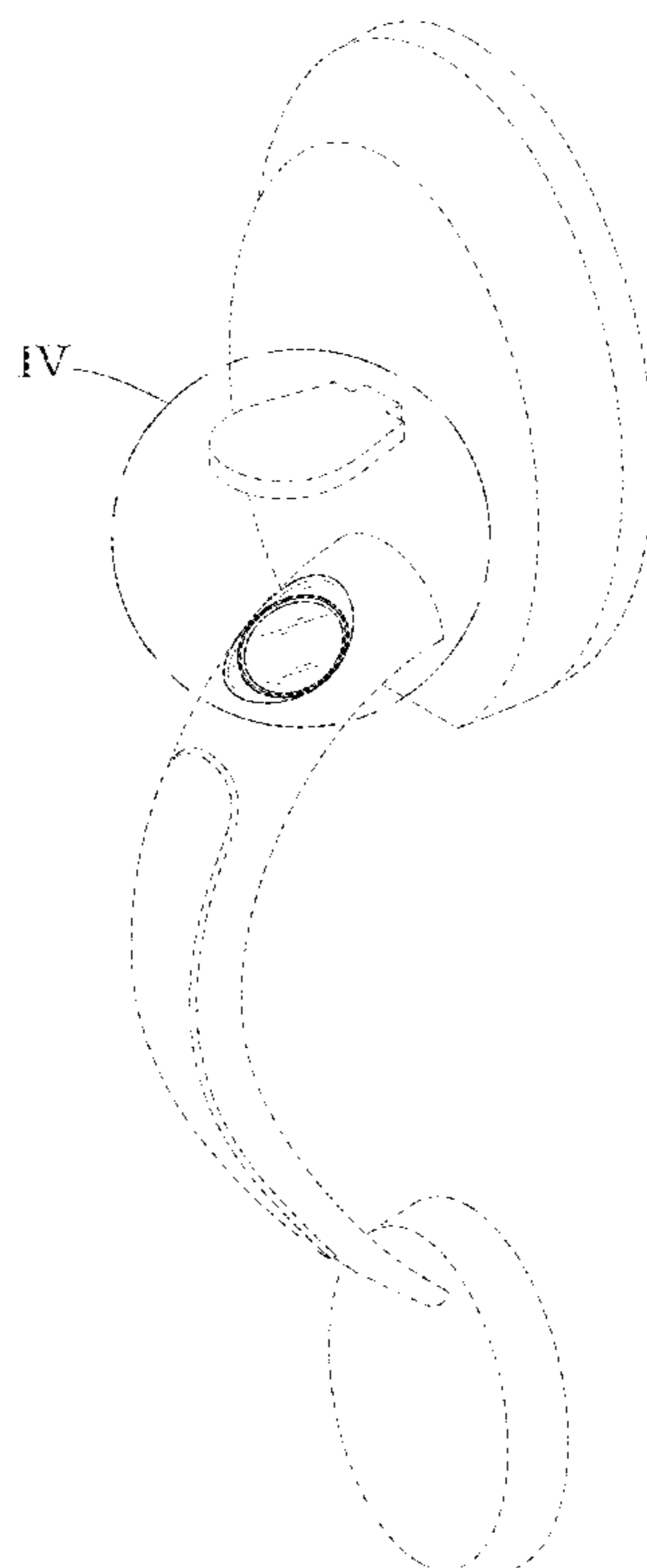
(57) **CLAIM**

The ornamental design for a fingerprint identifying device for a handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a fingerprint identifying device for a handle showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side view thereof; and,  
FIG. 4 is an enlarged view of the encircled portion IV in FIG. 1.  
The broken lines in the drawings illustrate portions of the fingerprint identifying device for a handle which form no part of the claimed design. The dot dash dot broken lines surrounding the detail areas in FIGS. 1 and 4 denote the boundaries of the detail areas and form no part of the claim design.

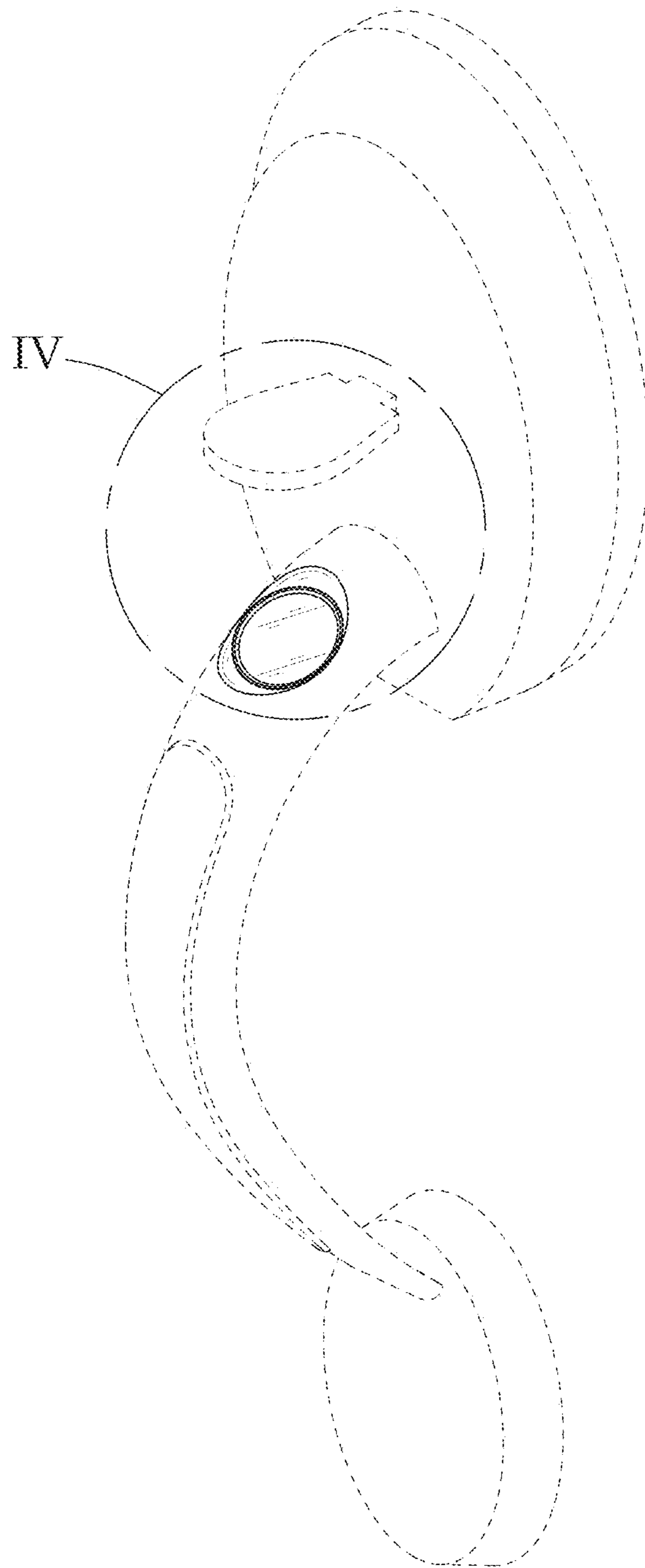

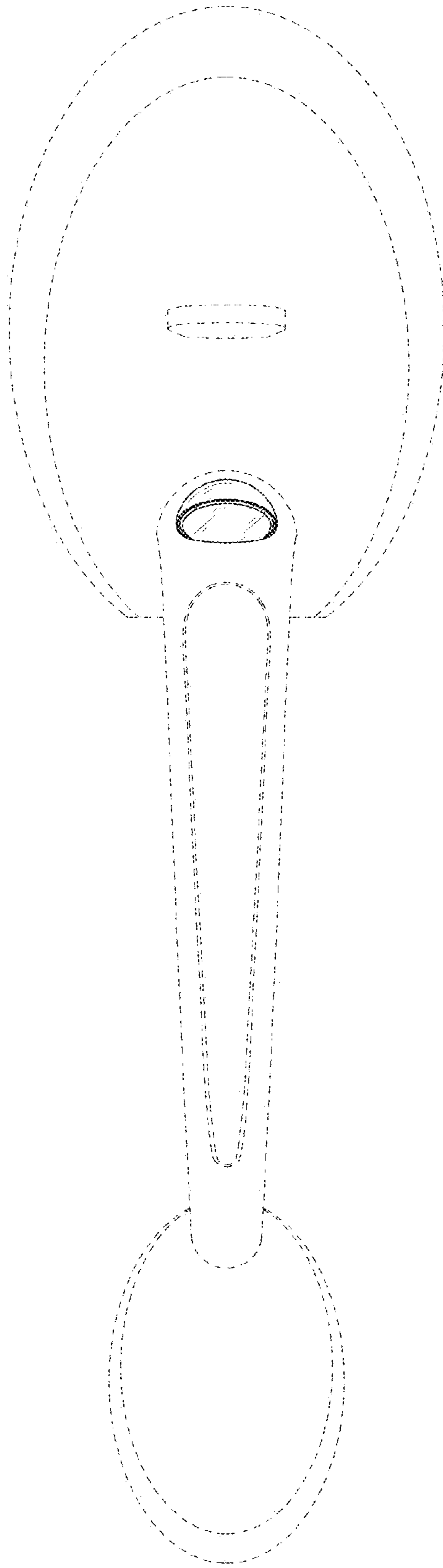

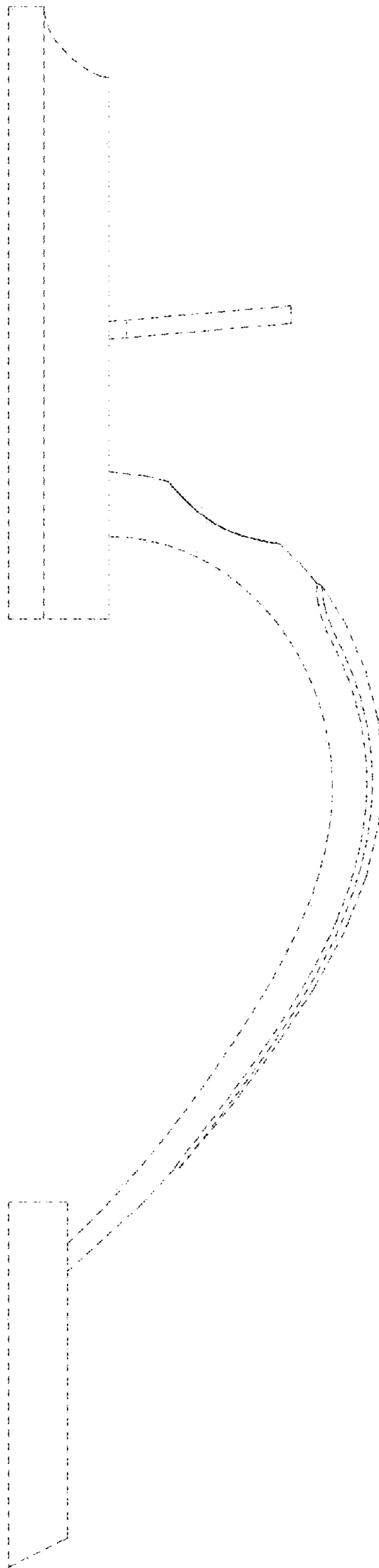

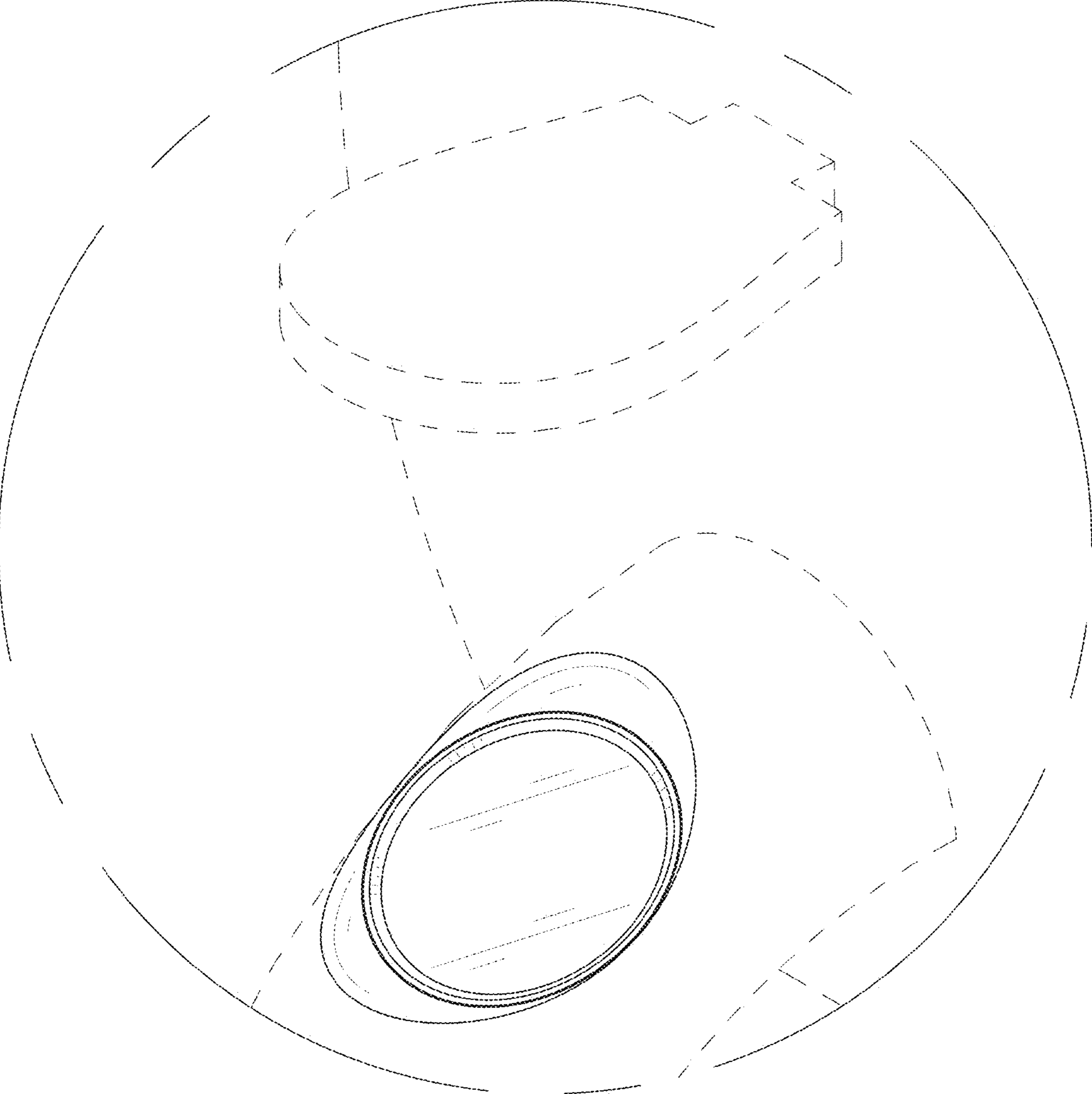
