(57) **CLAIM**

We claim the ornamental design for a sleeve container, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of a sleeve container. FIG. 2 is a rear side perspective view of the sleeve container shown in FIG. 1. FIG. 3 is a front view of the sleeve container shown in FIG. 1. FIG. 4 is a left side view of the sleeve container shown in FIG. 1. FIG. 5 is a right side view of the sleeve container shown in FIG. 1. FIG. 6 is a rear view of the sleeve container shown in FIG. 1. FIG. 7 is a top view of the sleeve container shown in FIG. 1; and, FIG. 8 is a bottom view of the sleeve container shown in FIG. 1.

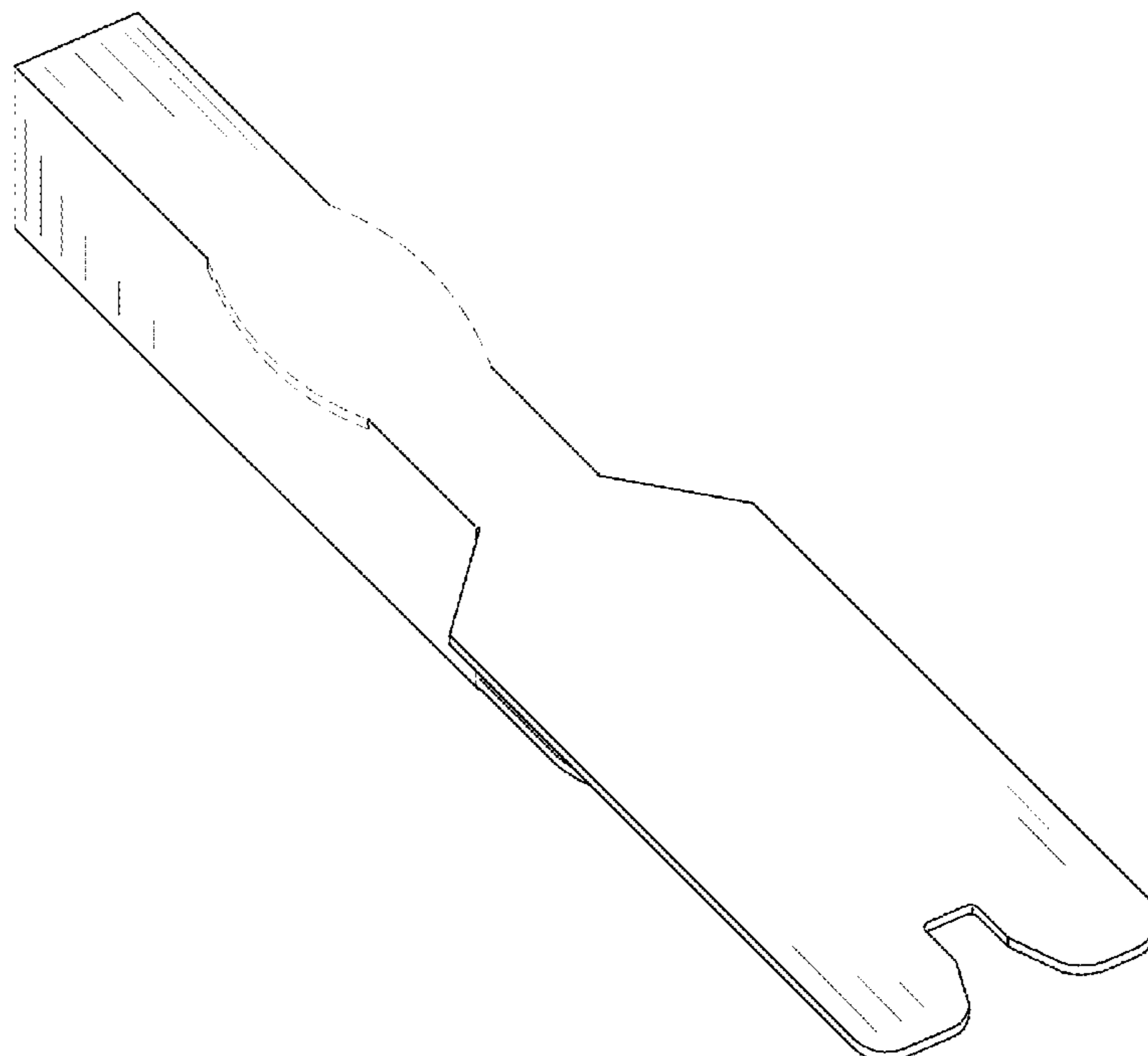
The broken lines in the drawings depict portions of the sleeve container that form no part of the claimed design.

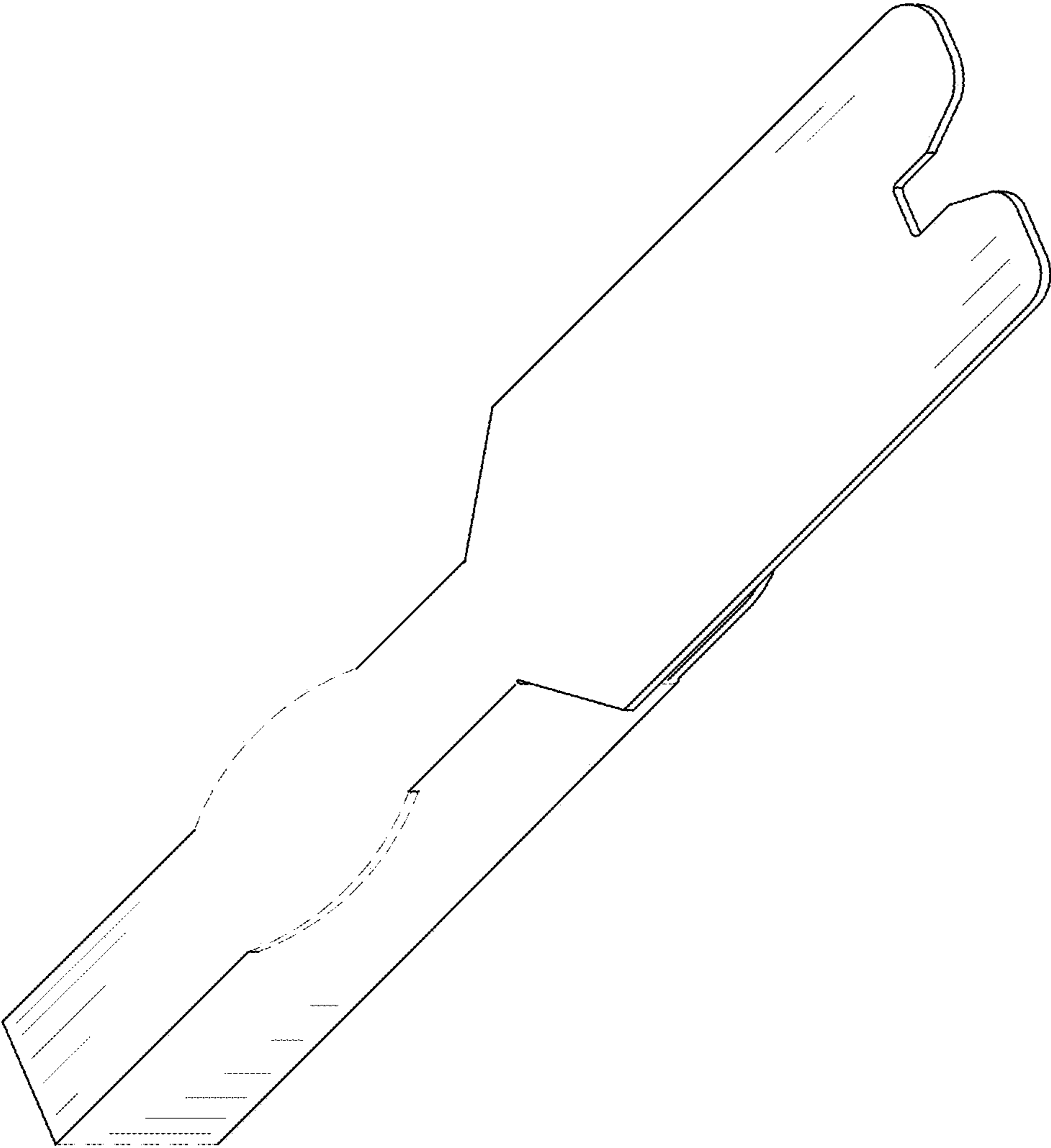

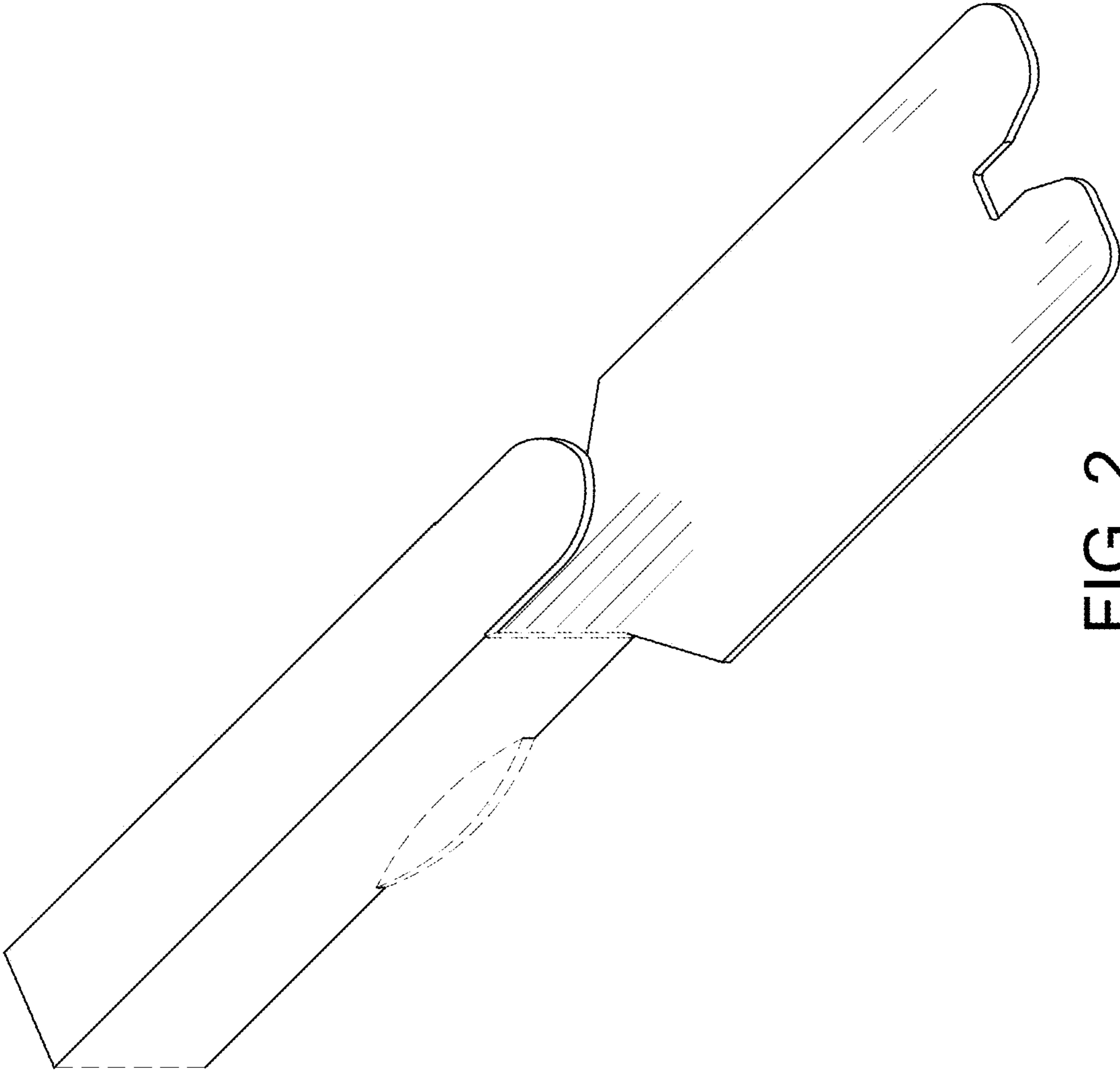

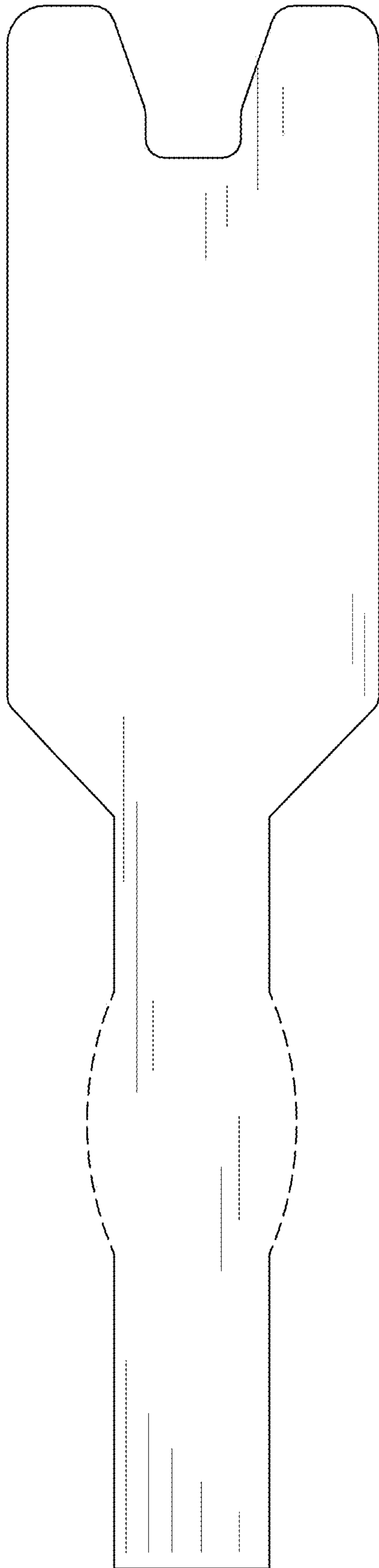

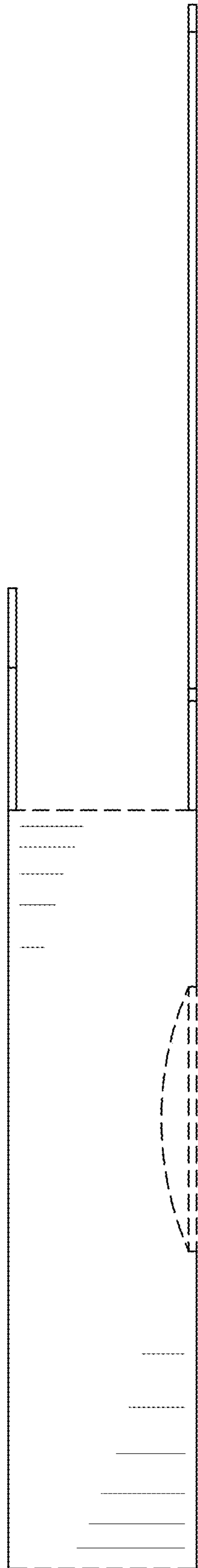

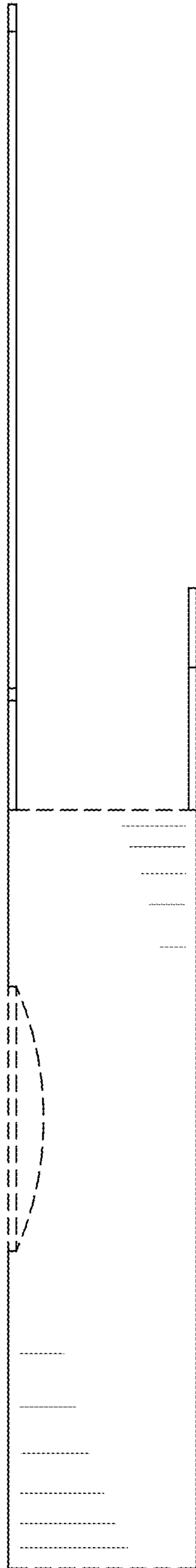

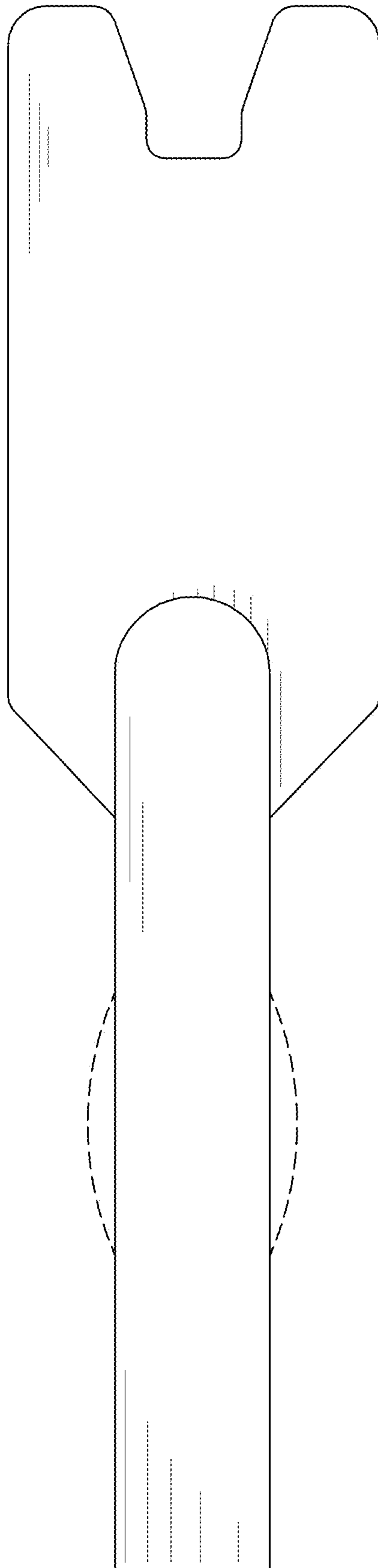

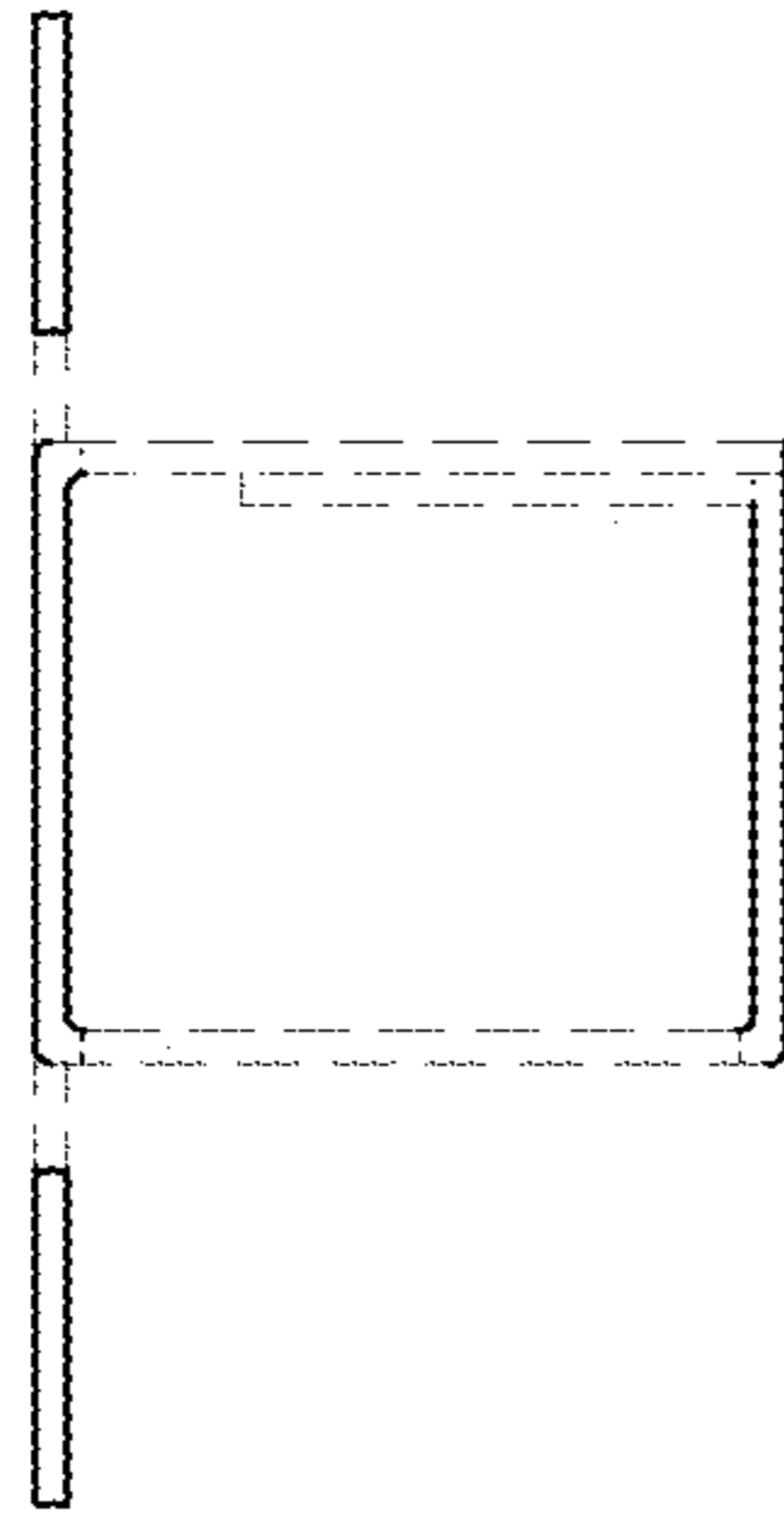

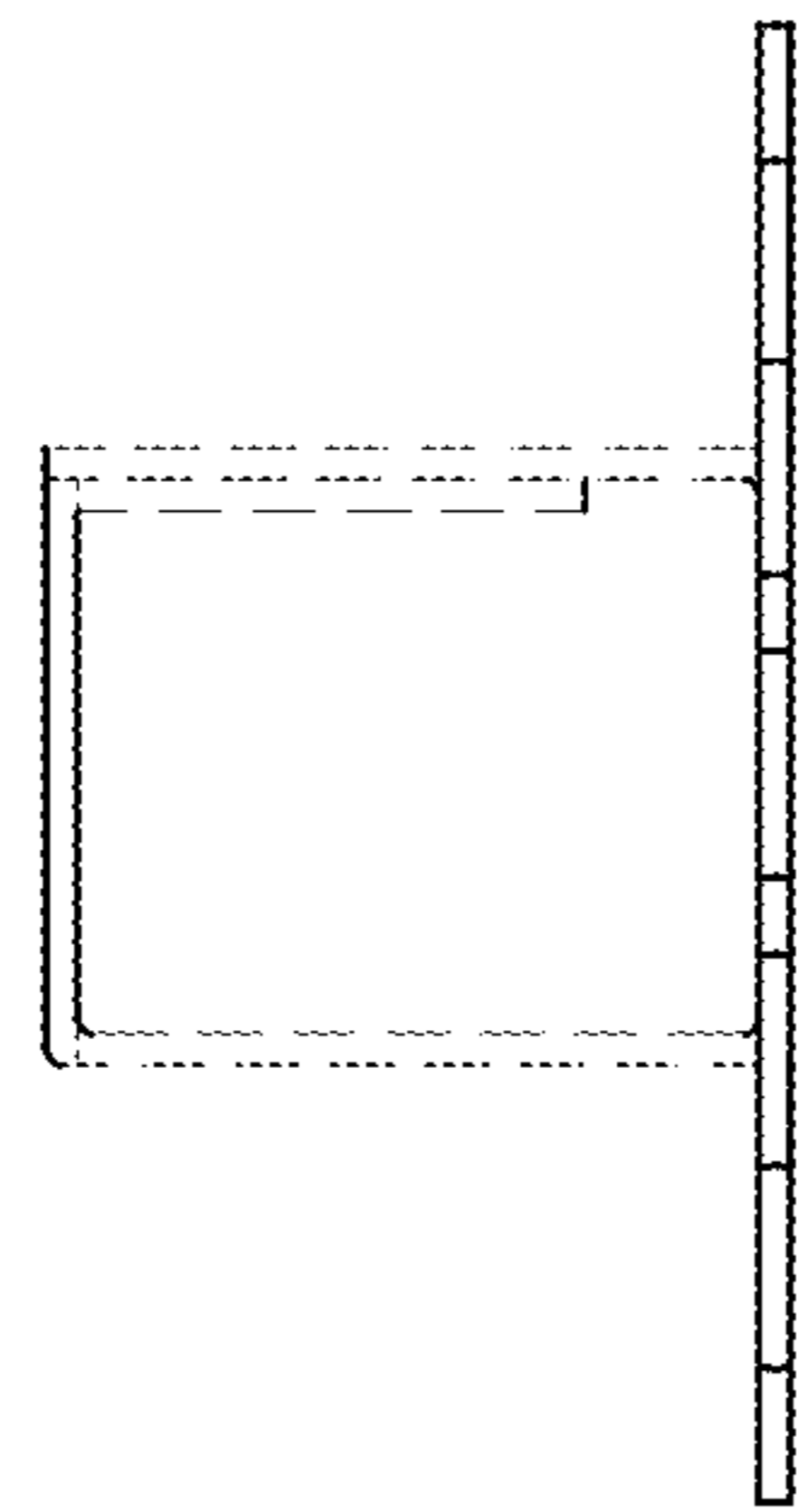
