(57) **CLAIM**

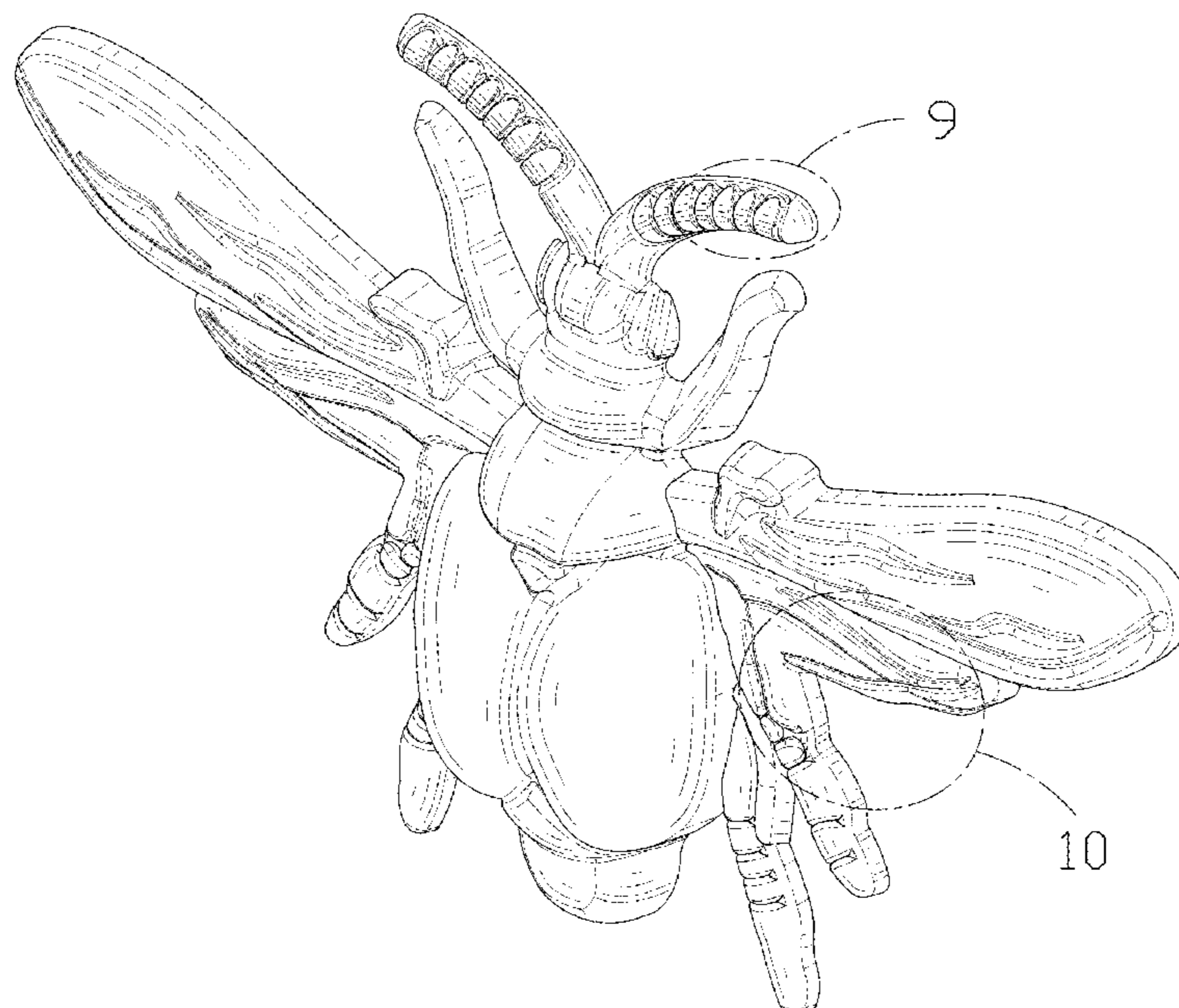
The ornamental design for a bee figure ornament, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a bee figure ornament, showing my new design;
FIG. 2 is a rear and bottom perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof.
FIG. 9 is an enlarged view of the portion labeled with numeric 9 in FIG. 1; and,
FIG. 10 is an enlarged view of the portion labeled with numeric 10 in FIG. 1.

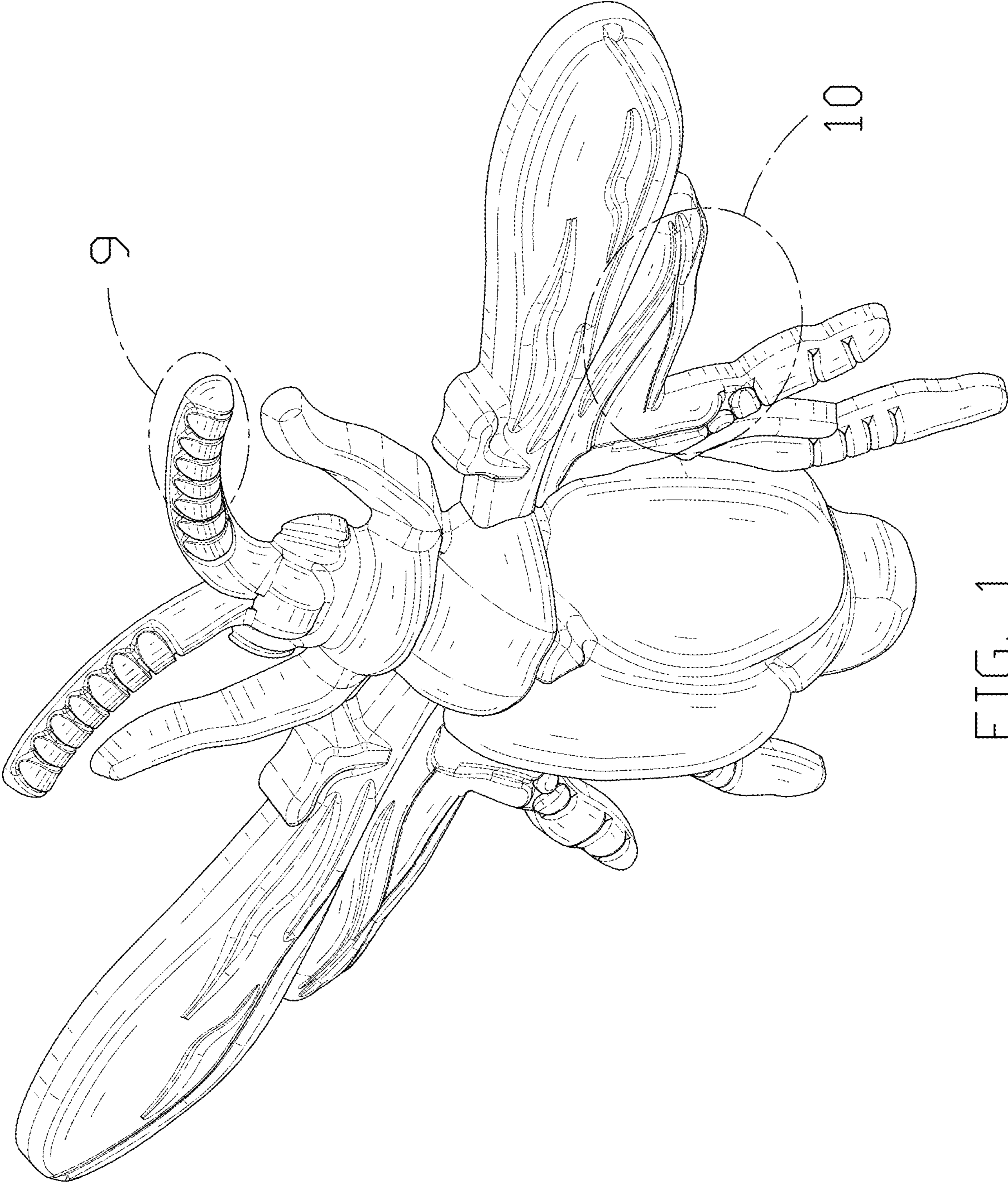

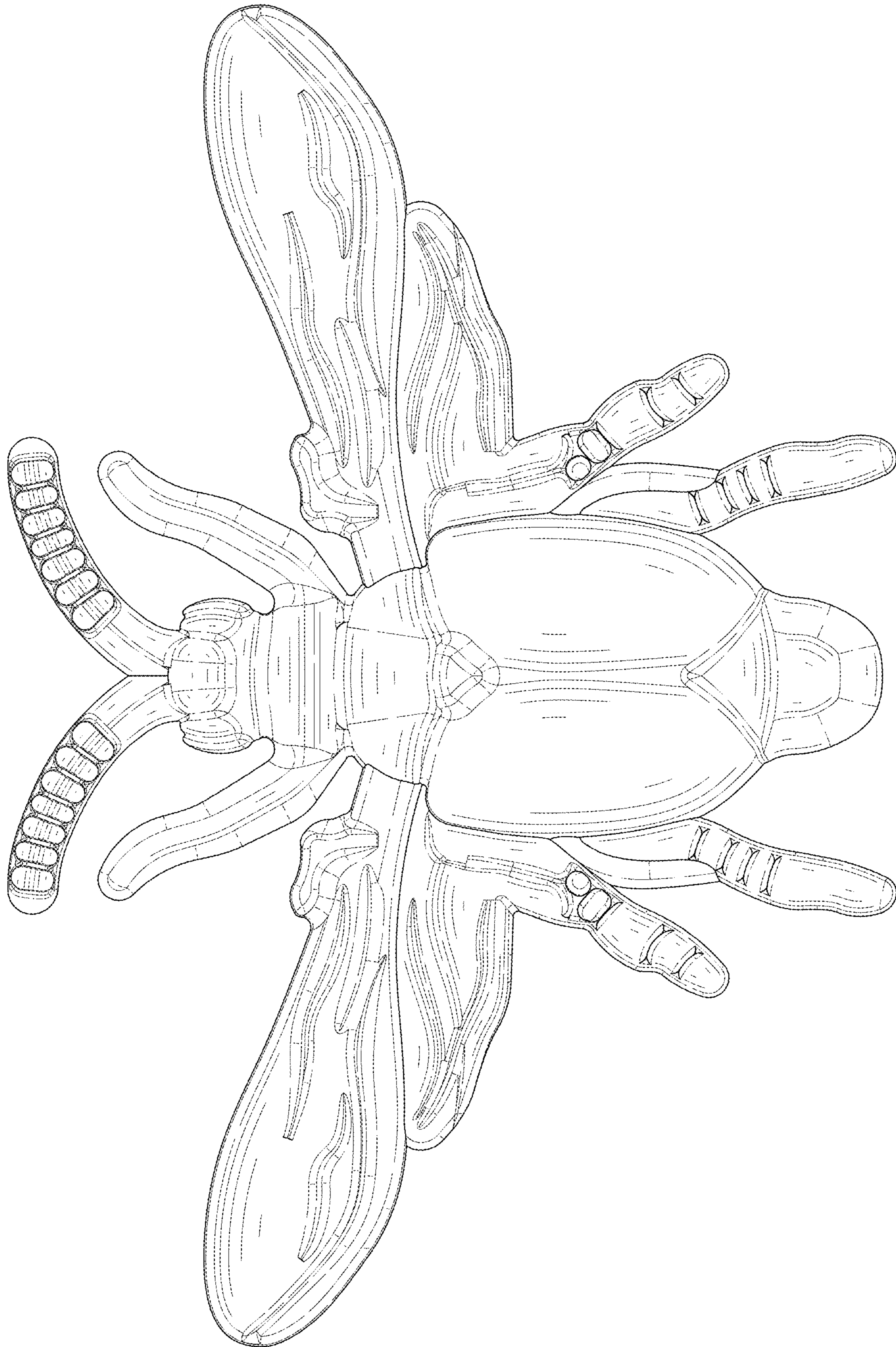

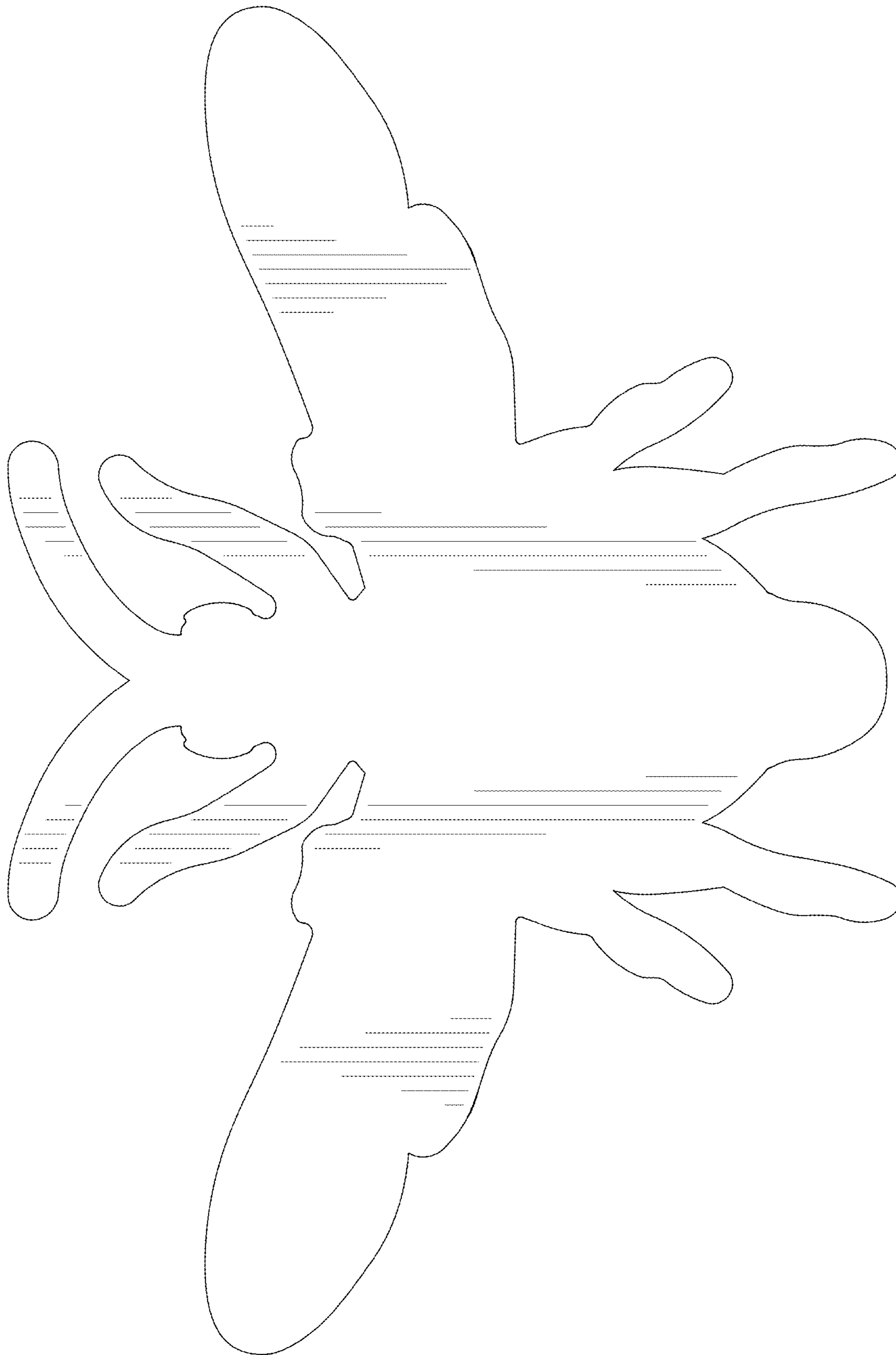

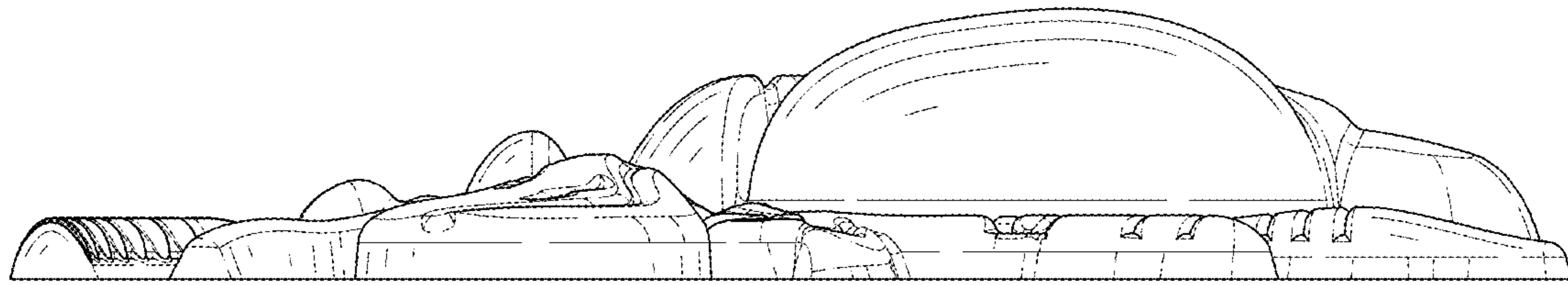

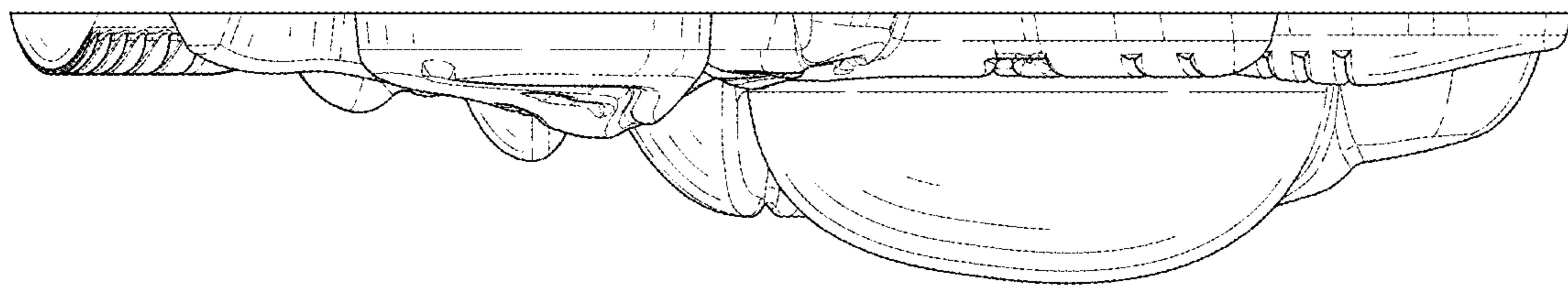

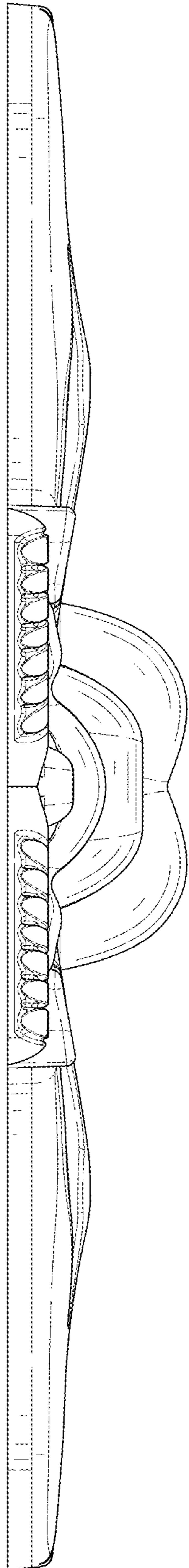

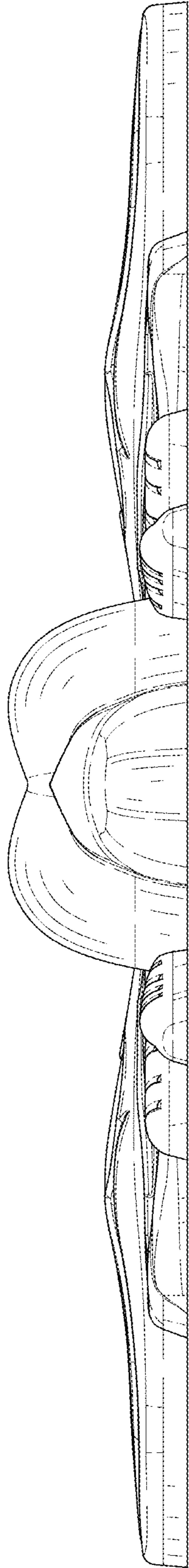

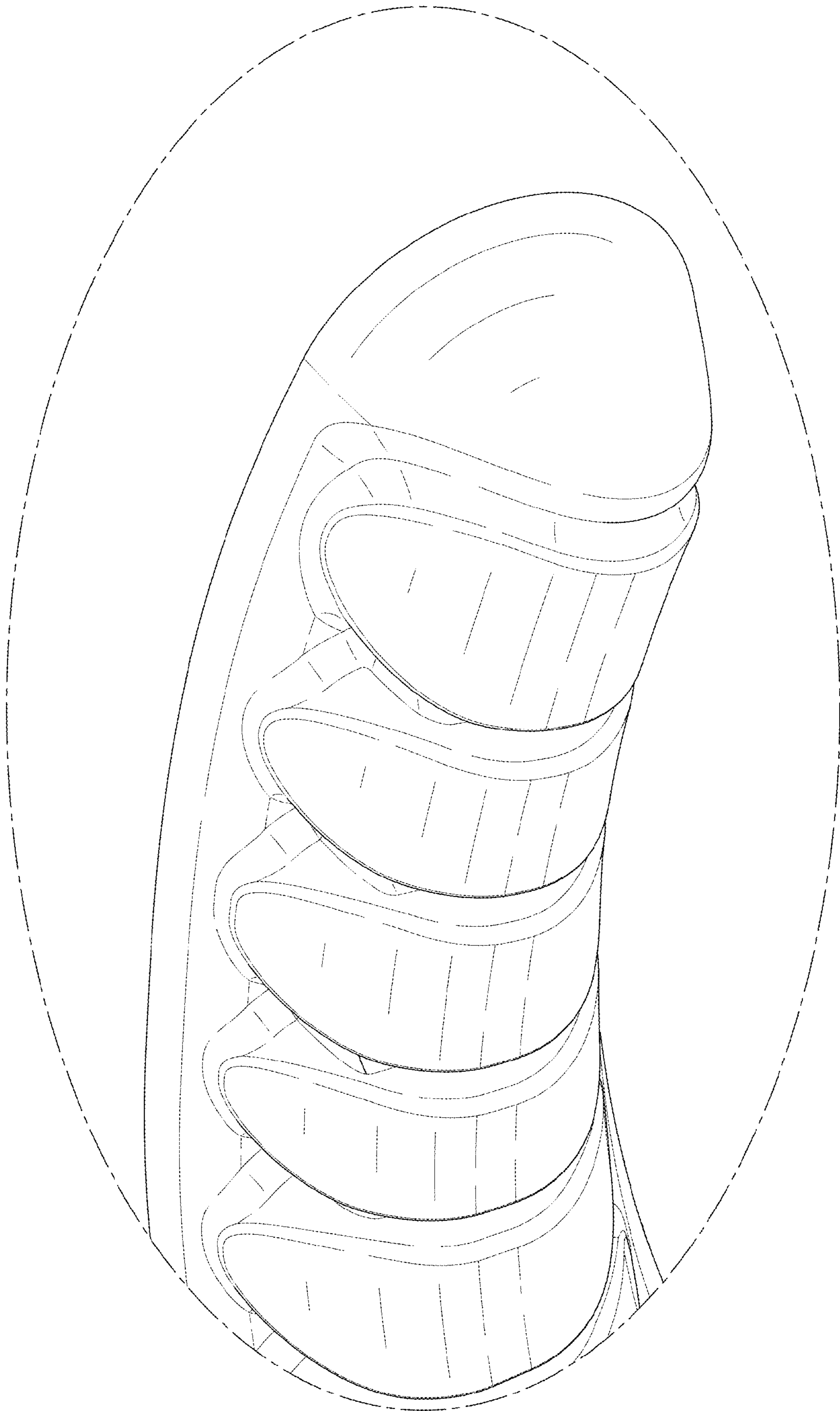

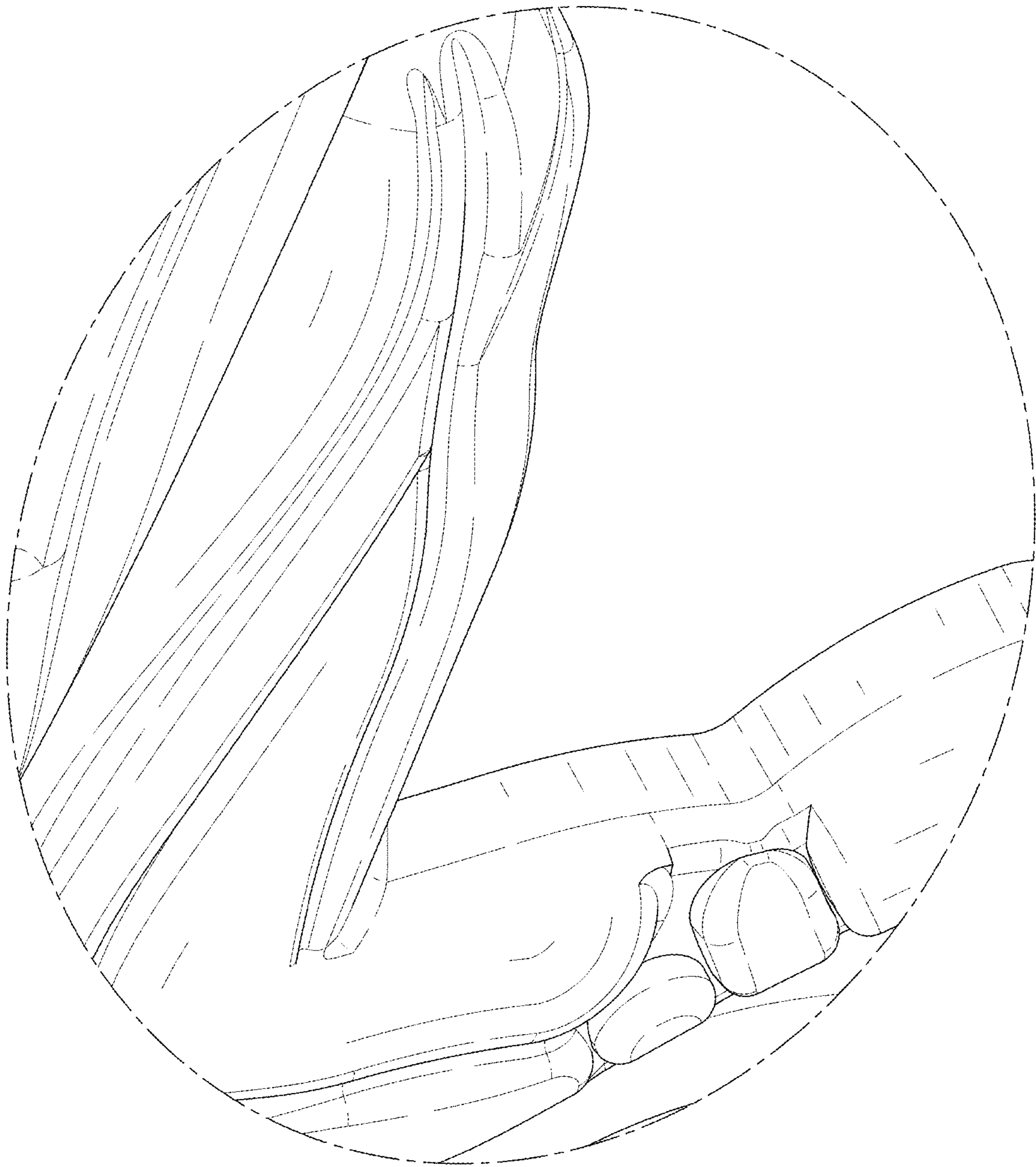
