(57) **CLAIM**

I claim the ornamental design for a wheel hub cap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an embodiment of a wheel hub cap showing my new design;
FIG. 2 is a top plan view thereof; and
FIG. 3 is a bottom plan view thereof.
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a right side elevational view thereof.
In the drawings, the broken lines depict portions of the wheel hub cap that form no part of the claimed design.

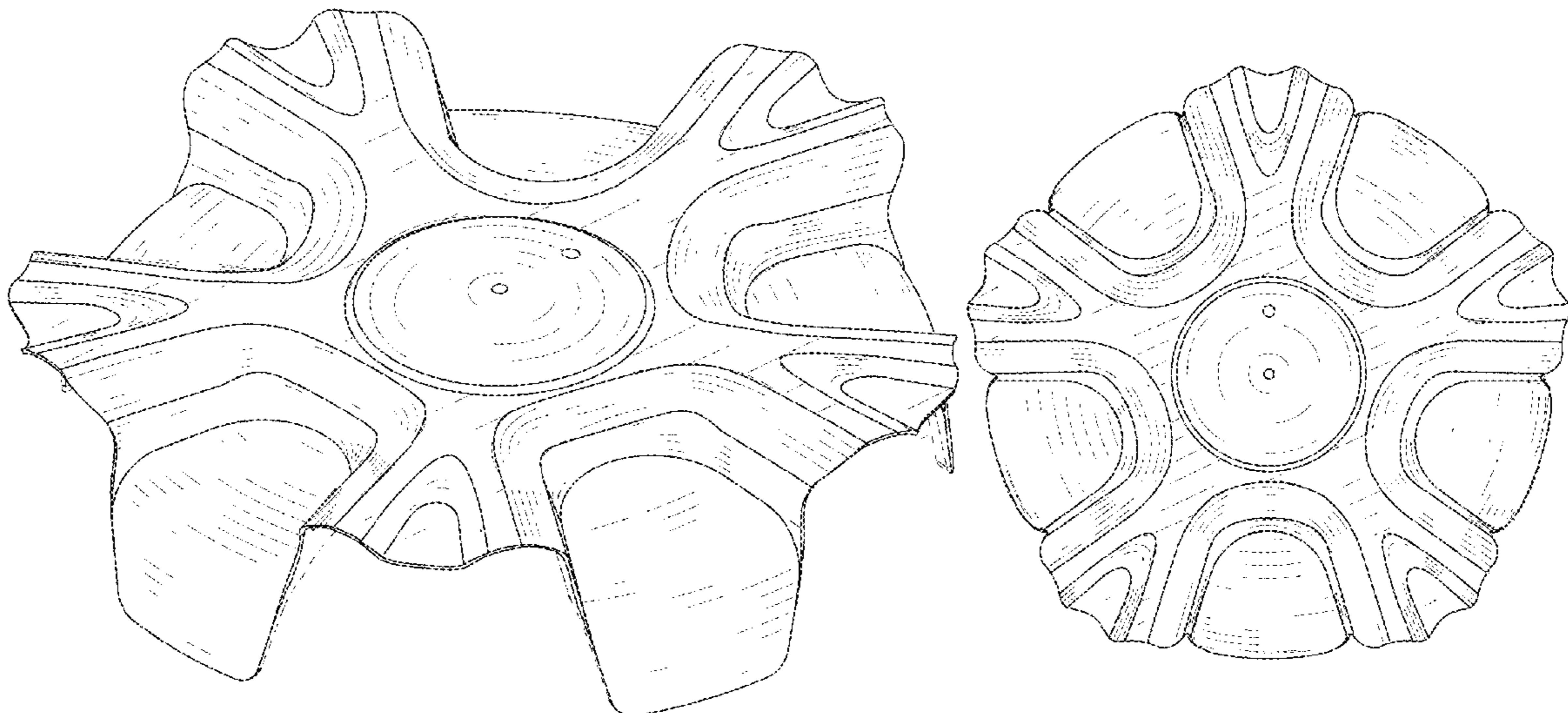

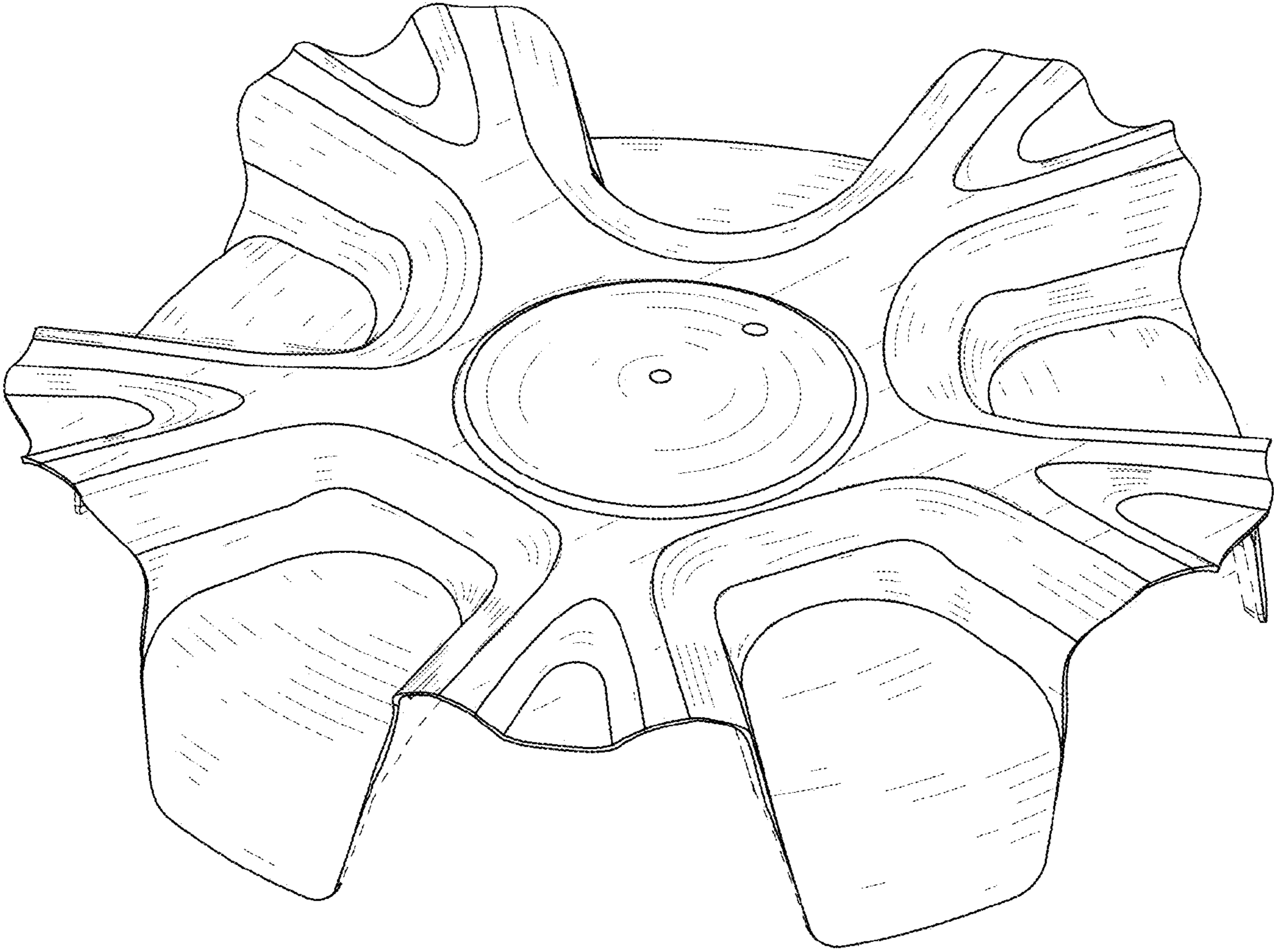

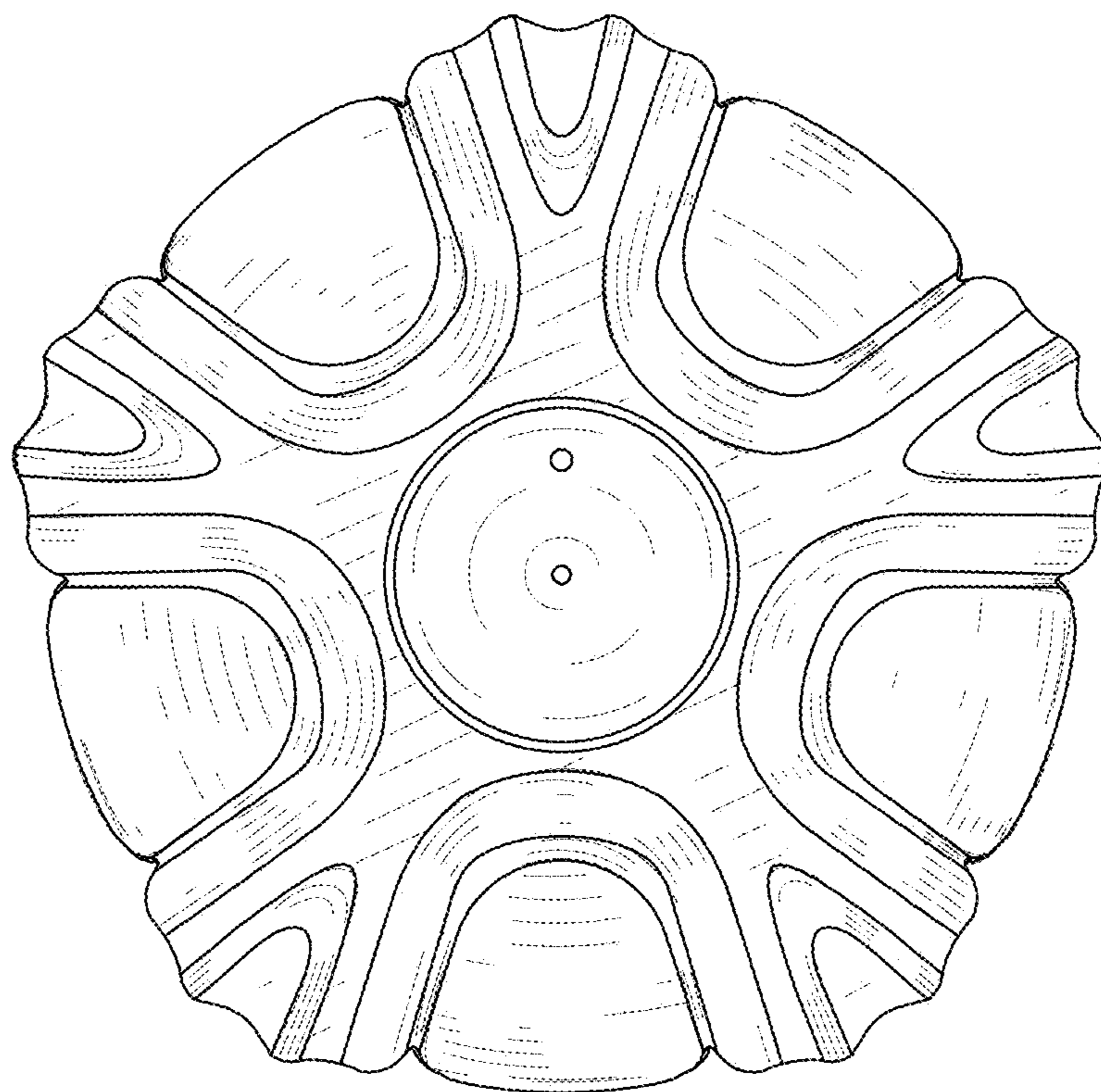

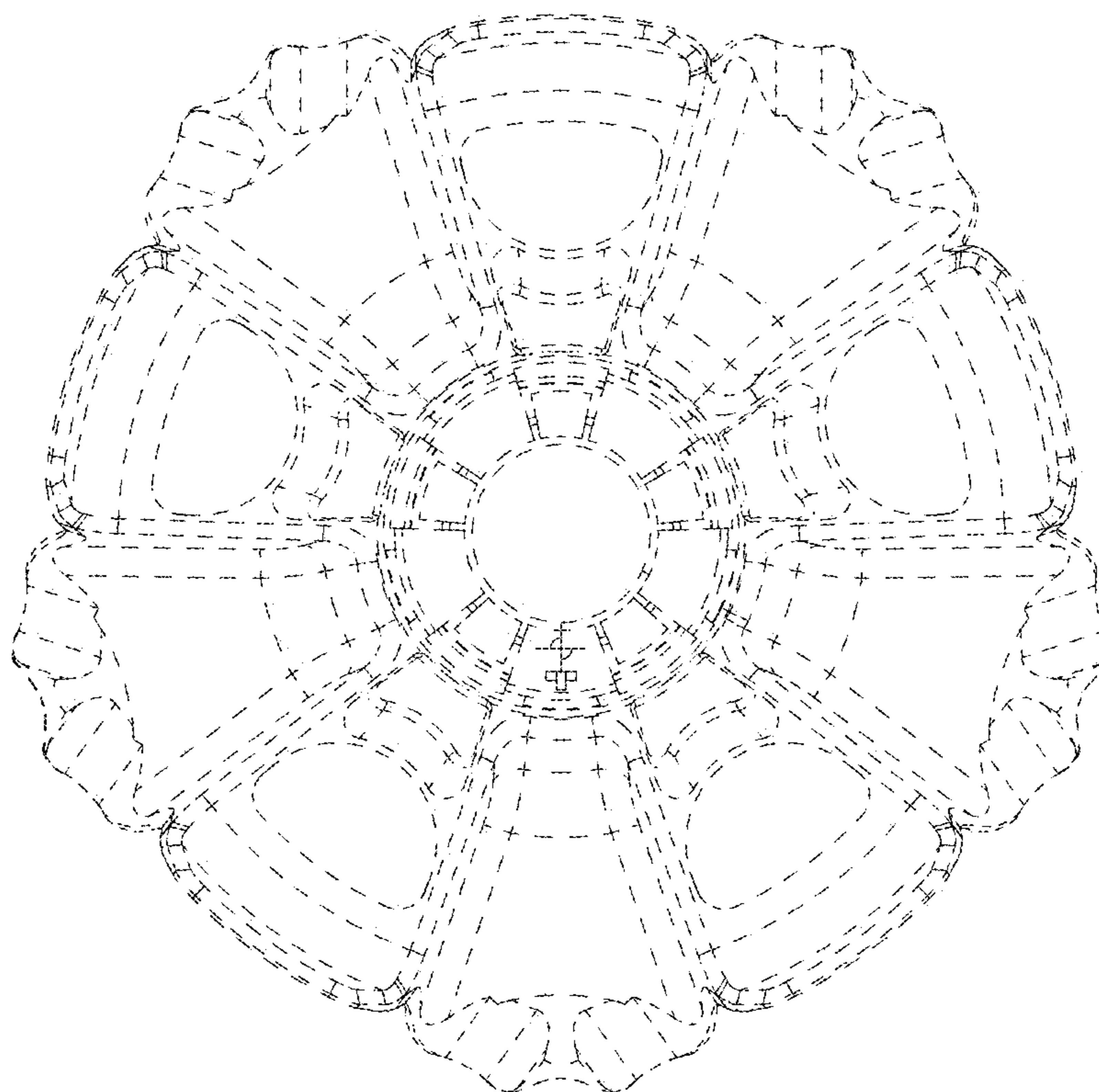

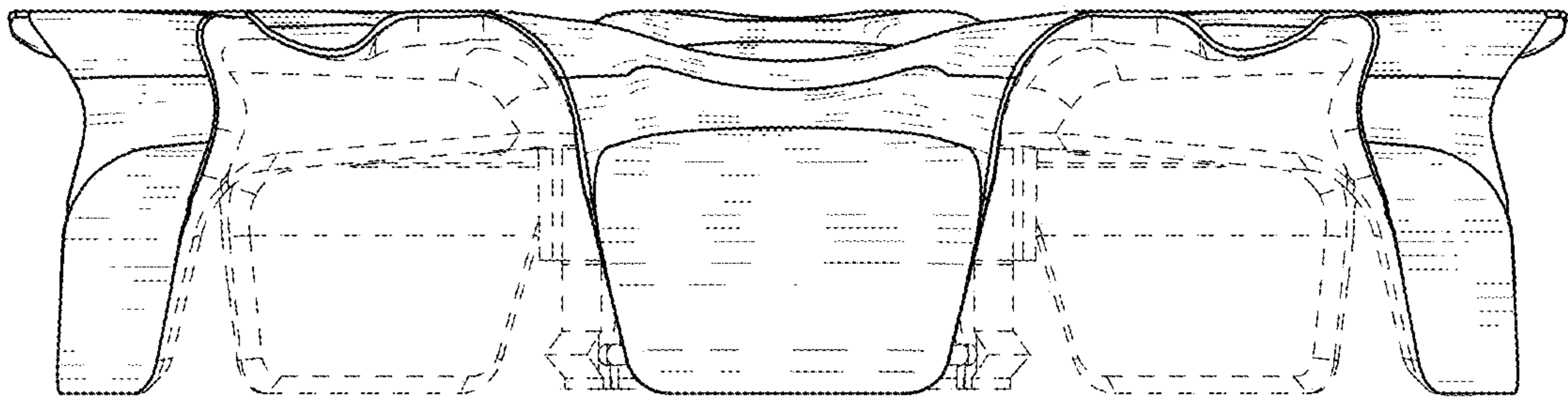

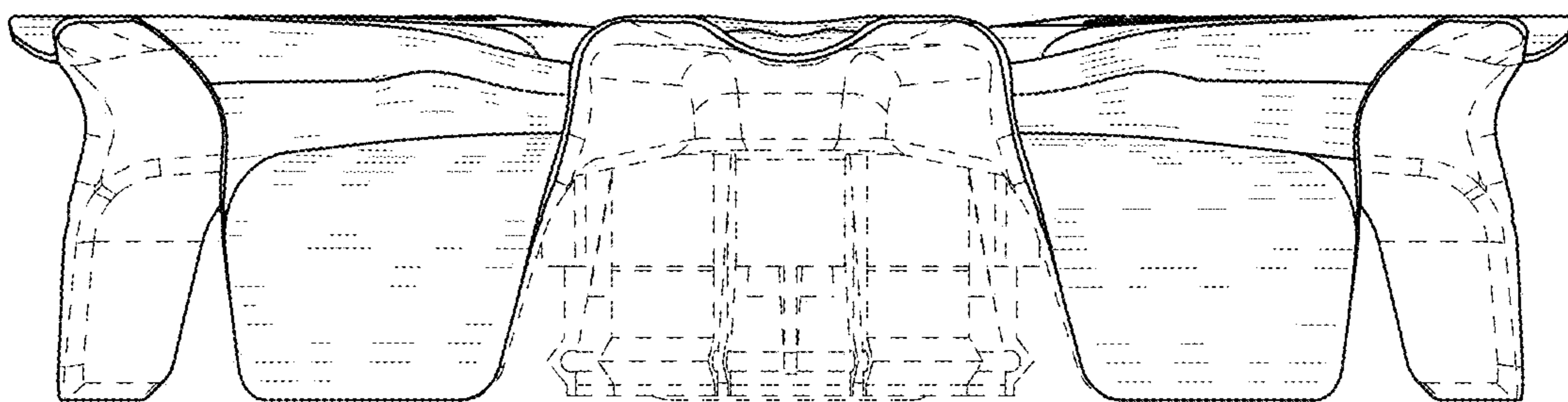

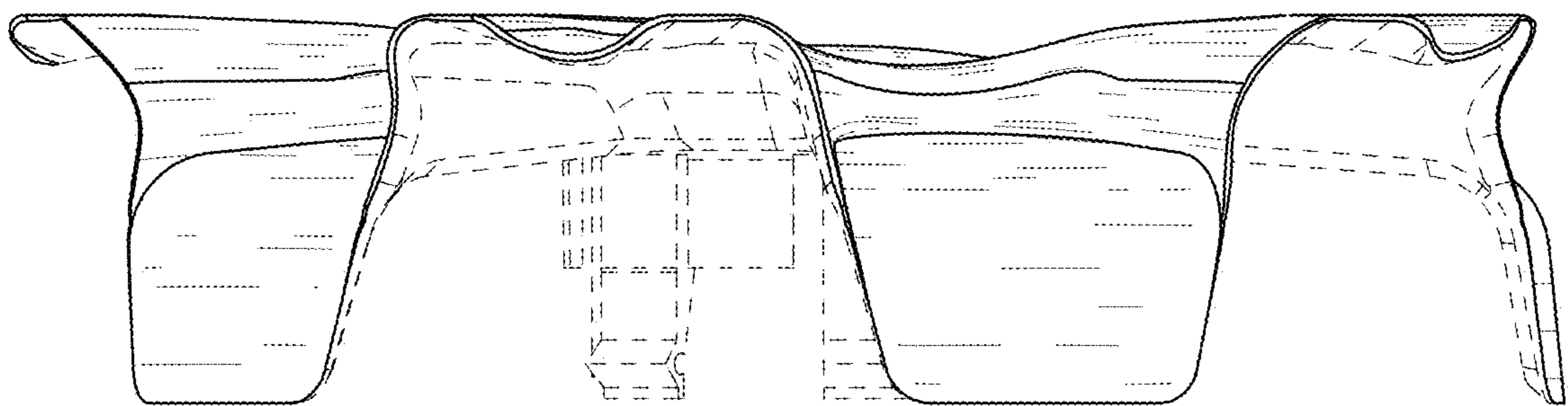
