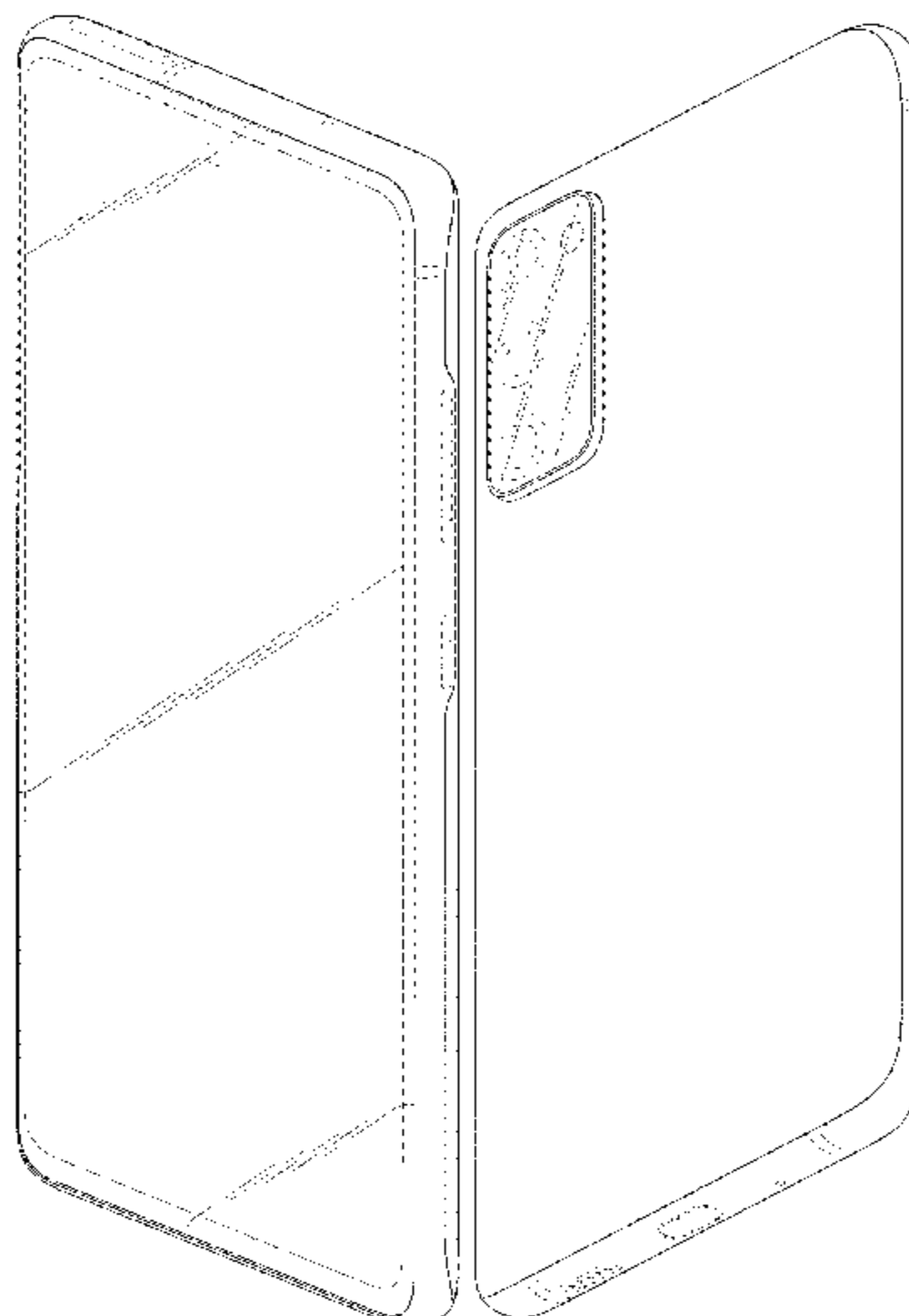
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an electronic device showing our new design;

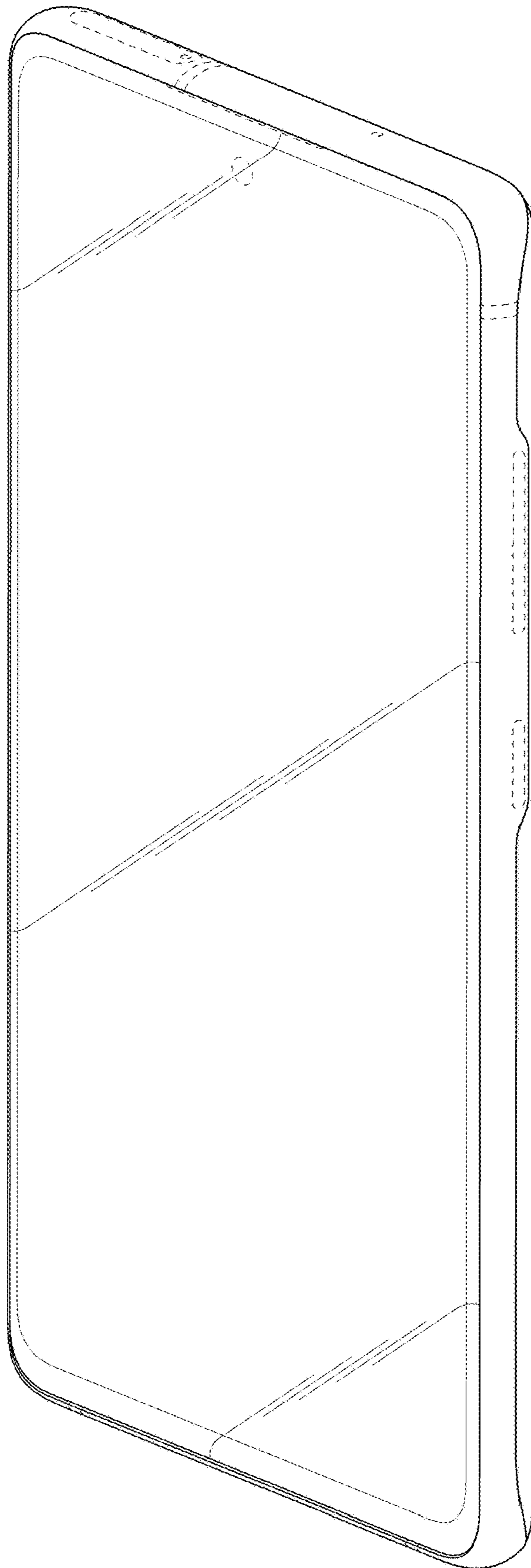

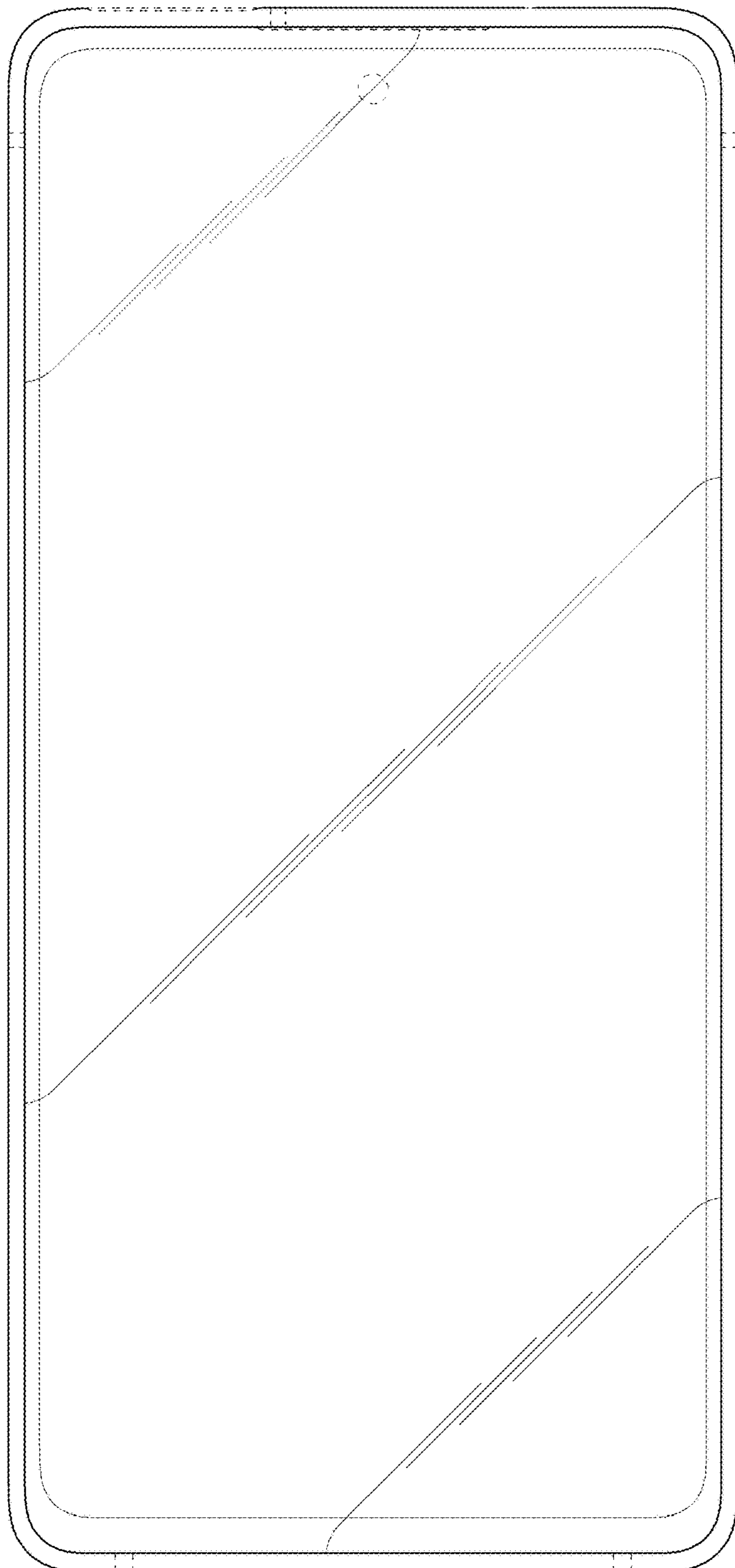

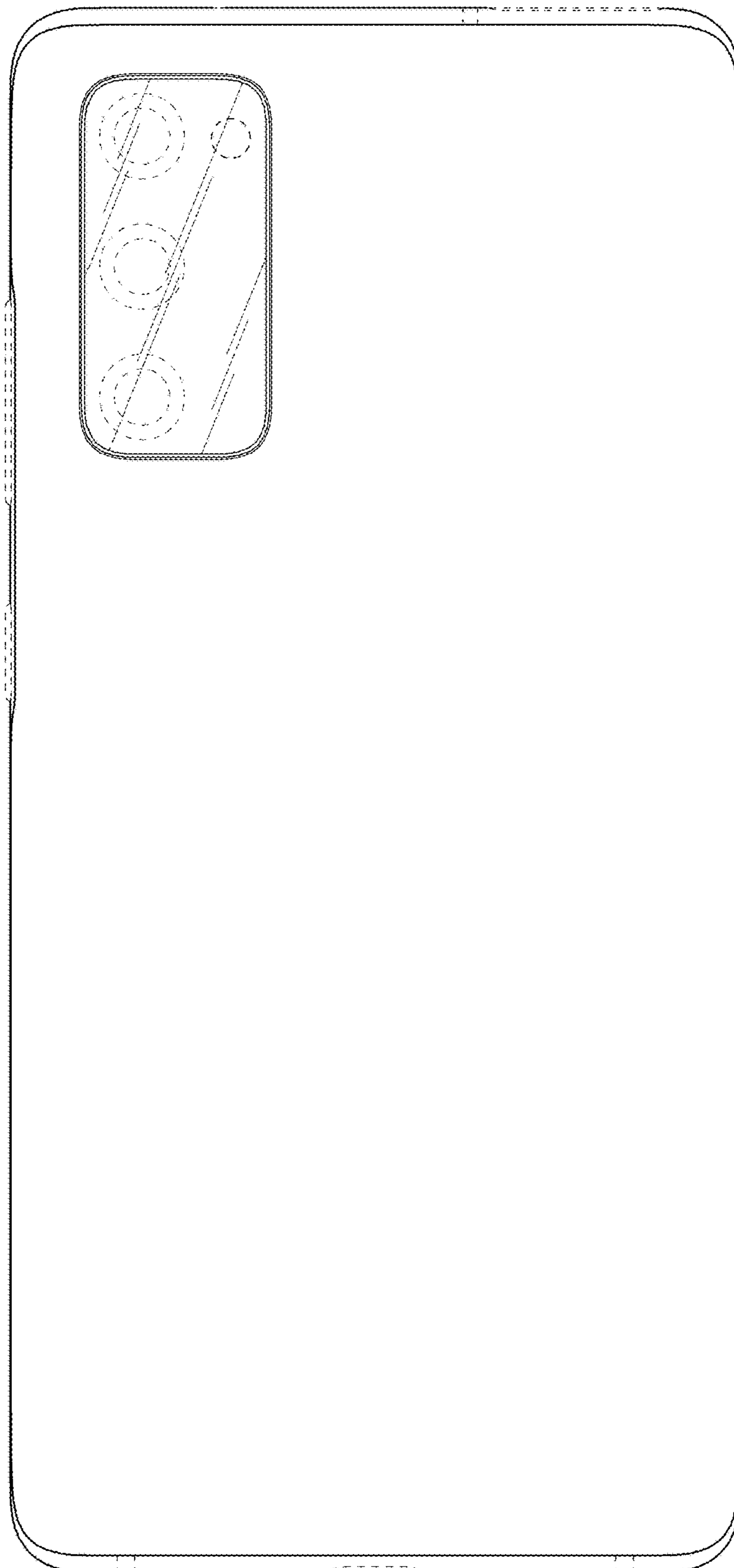

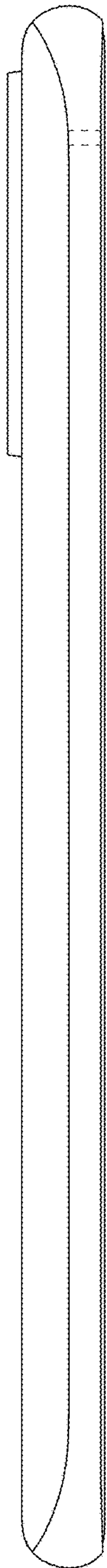

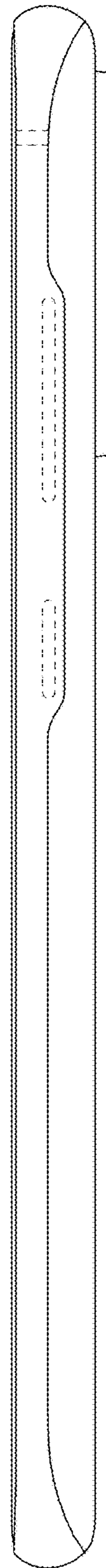

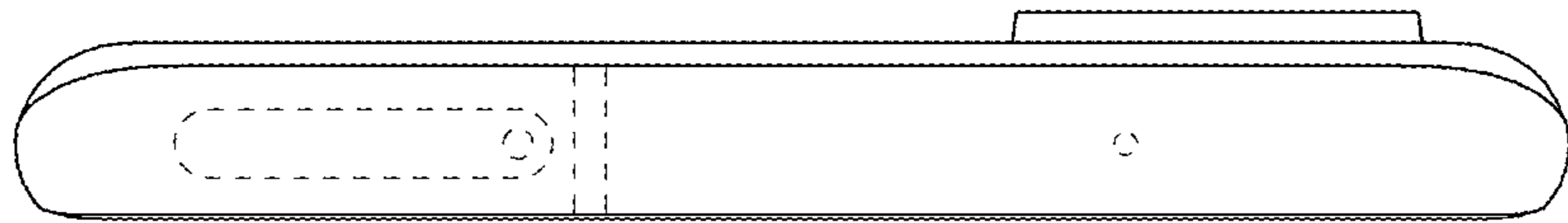

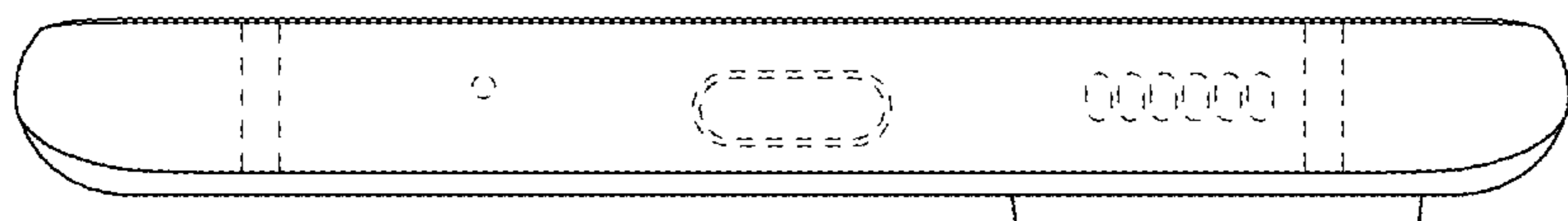
