The FIGURE is a front view of a display screen or portion thereof with a graphical user interface showing our new design.

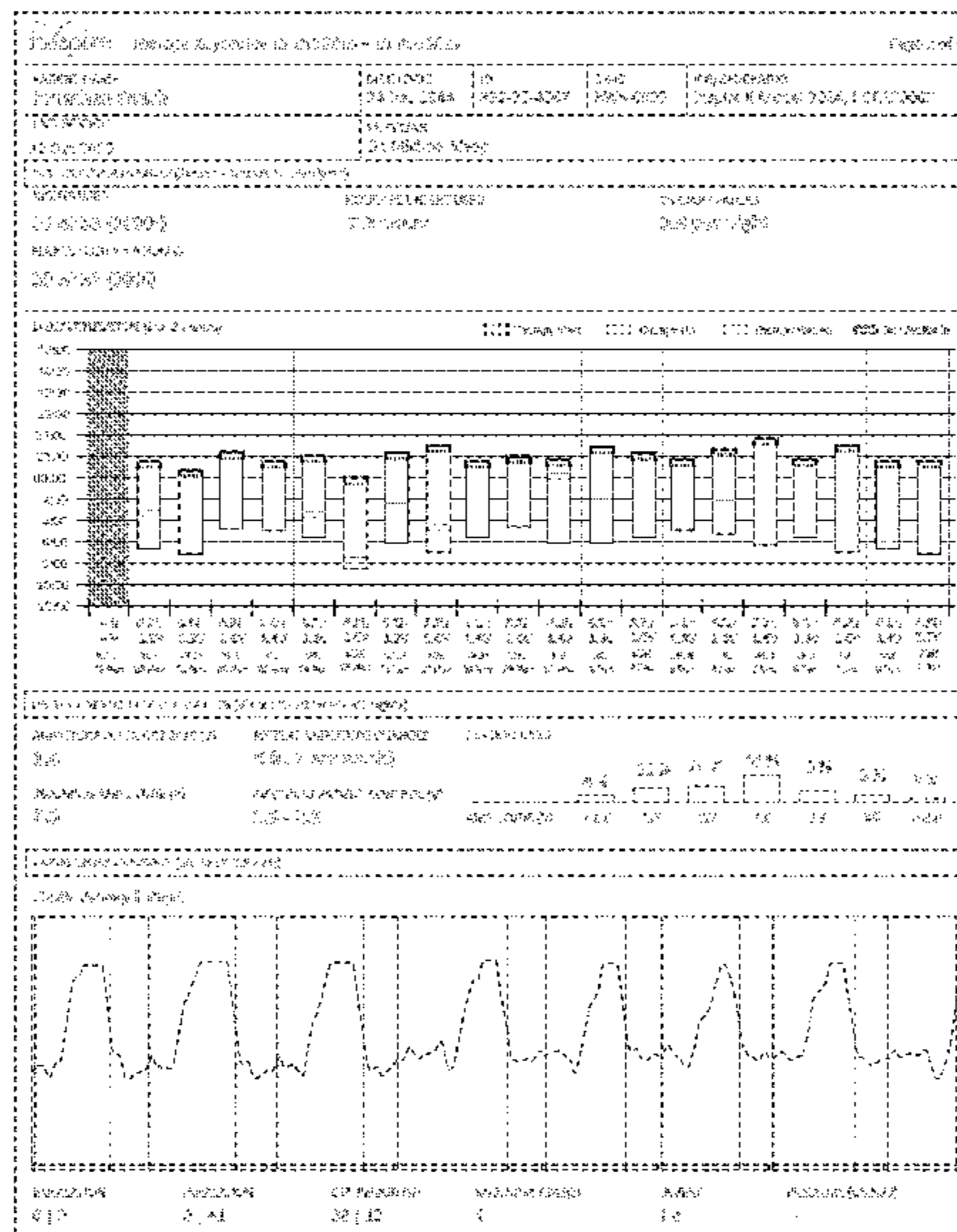
