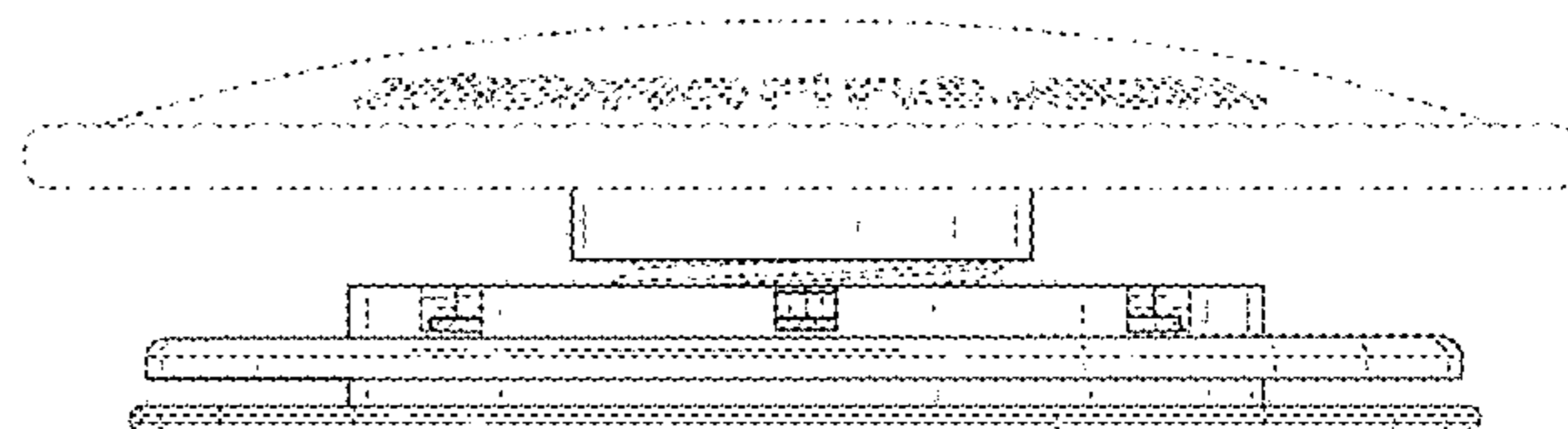
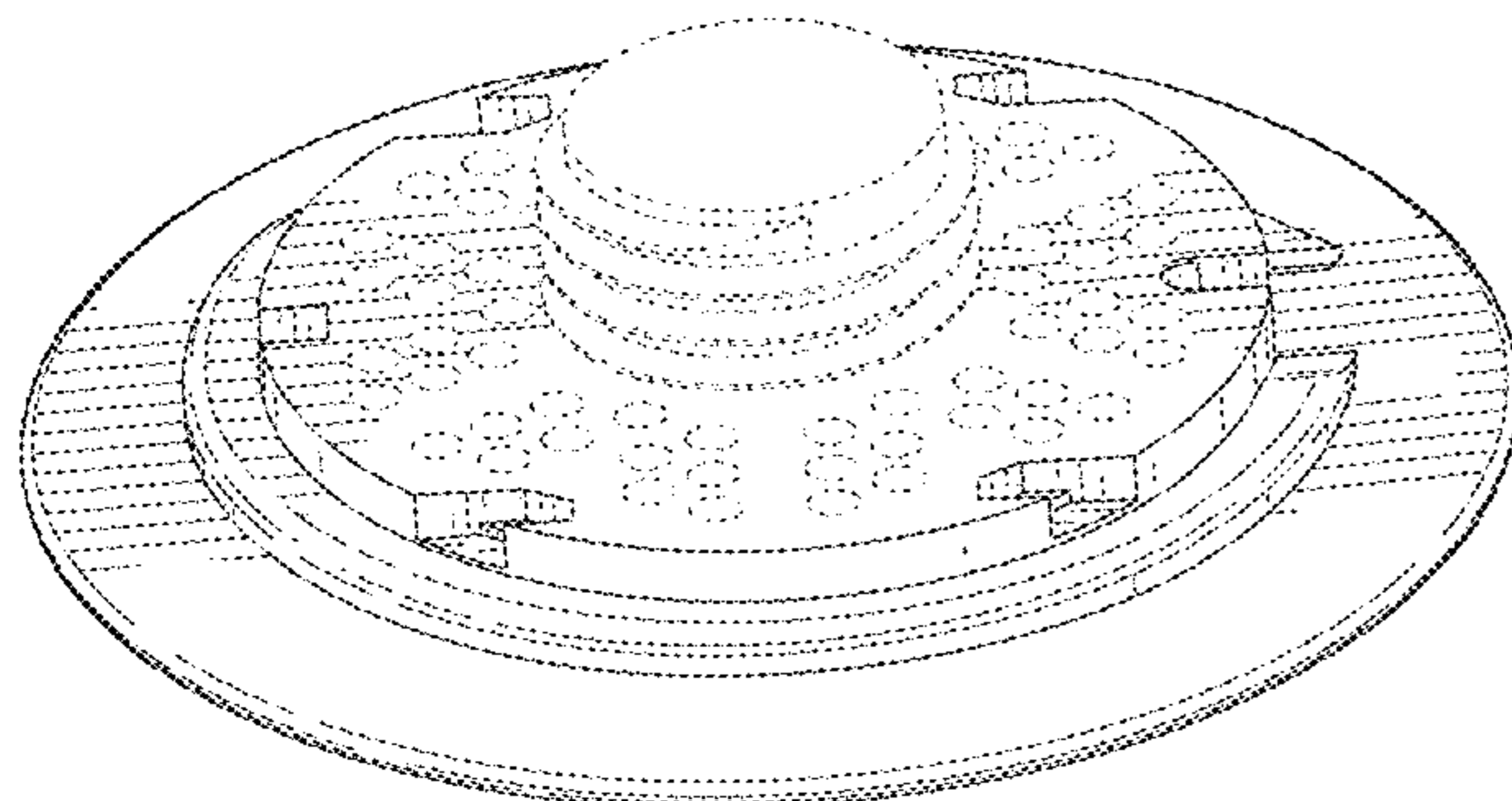
(57) **CLAIM**

The ornamental design for a threadable cover accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of a threadable cover accessory associated with an optional umbrella;  
FIG. 2 is an elevated perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;

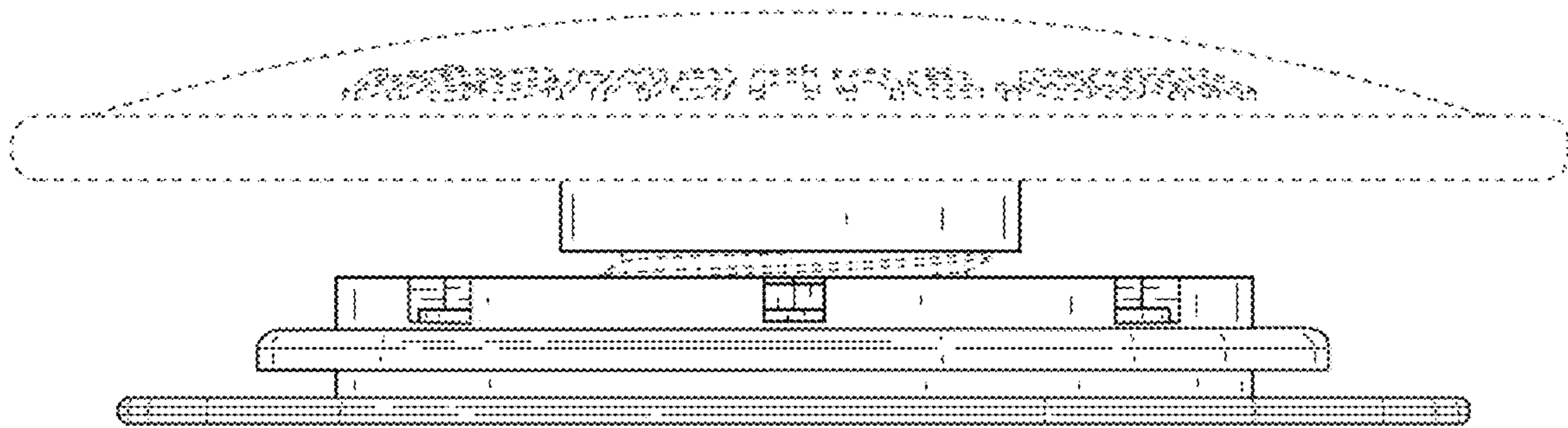

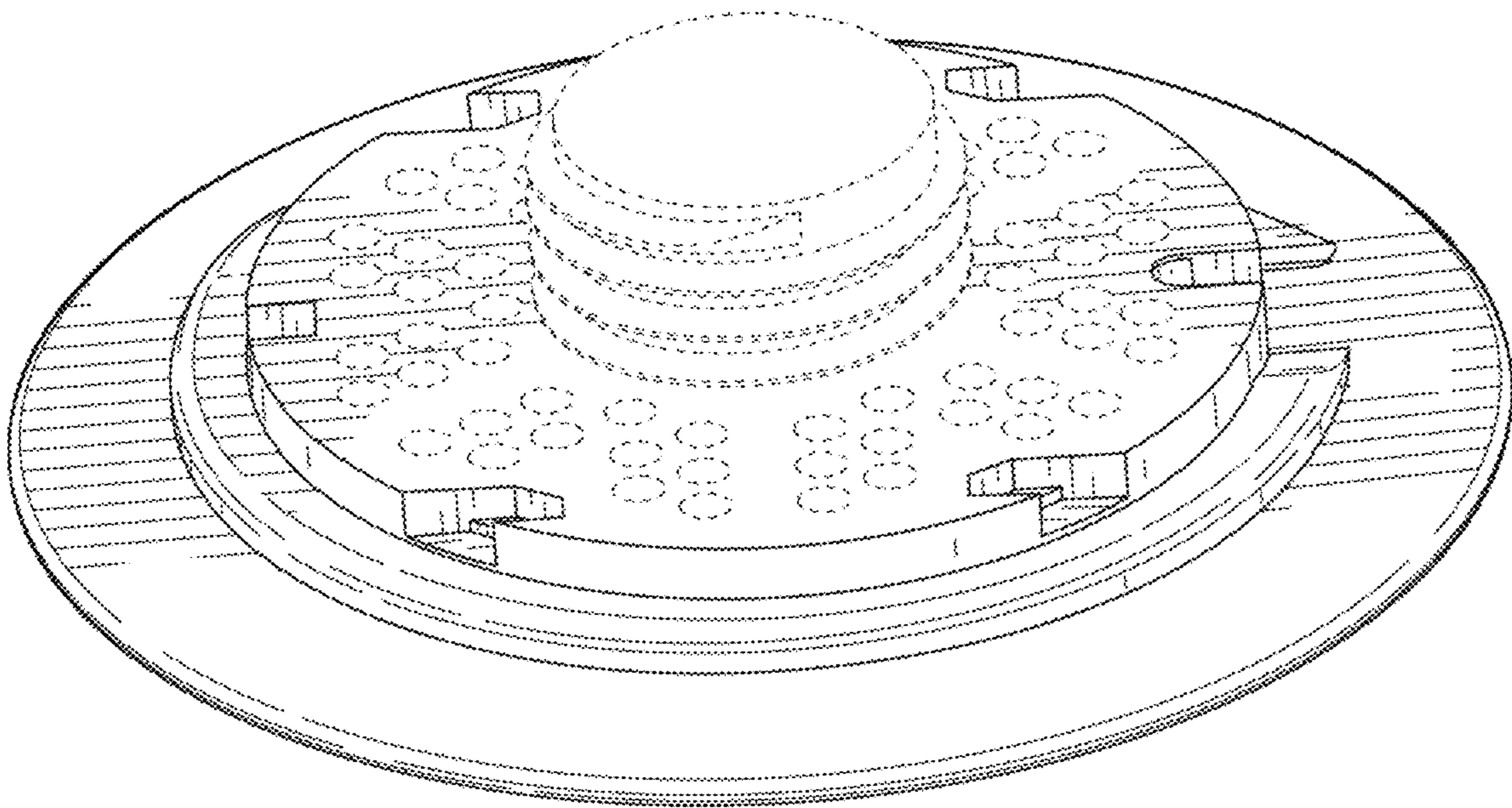

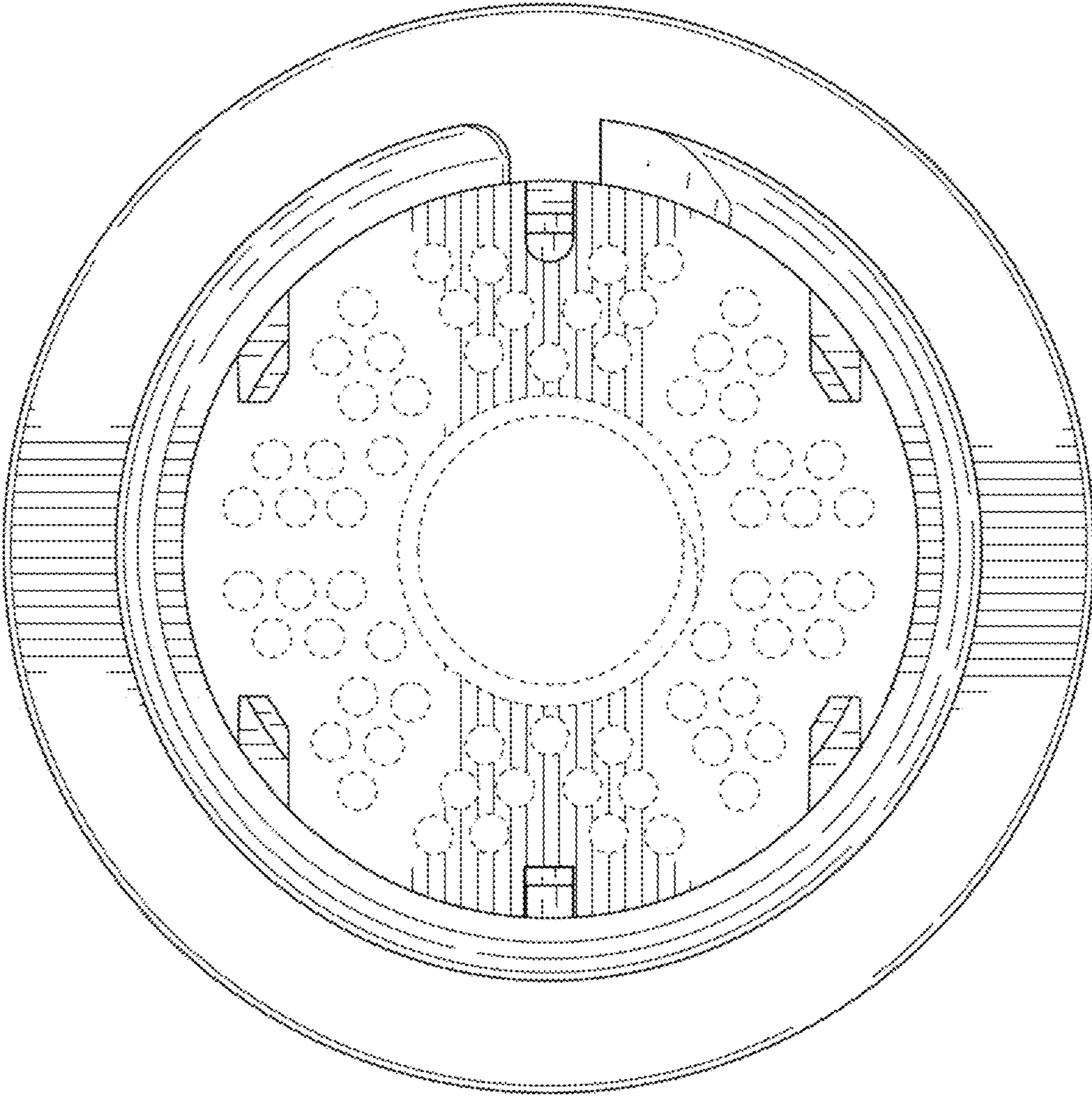

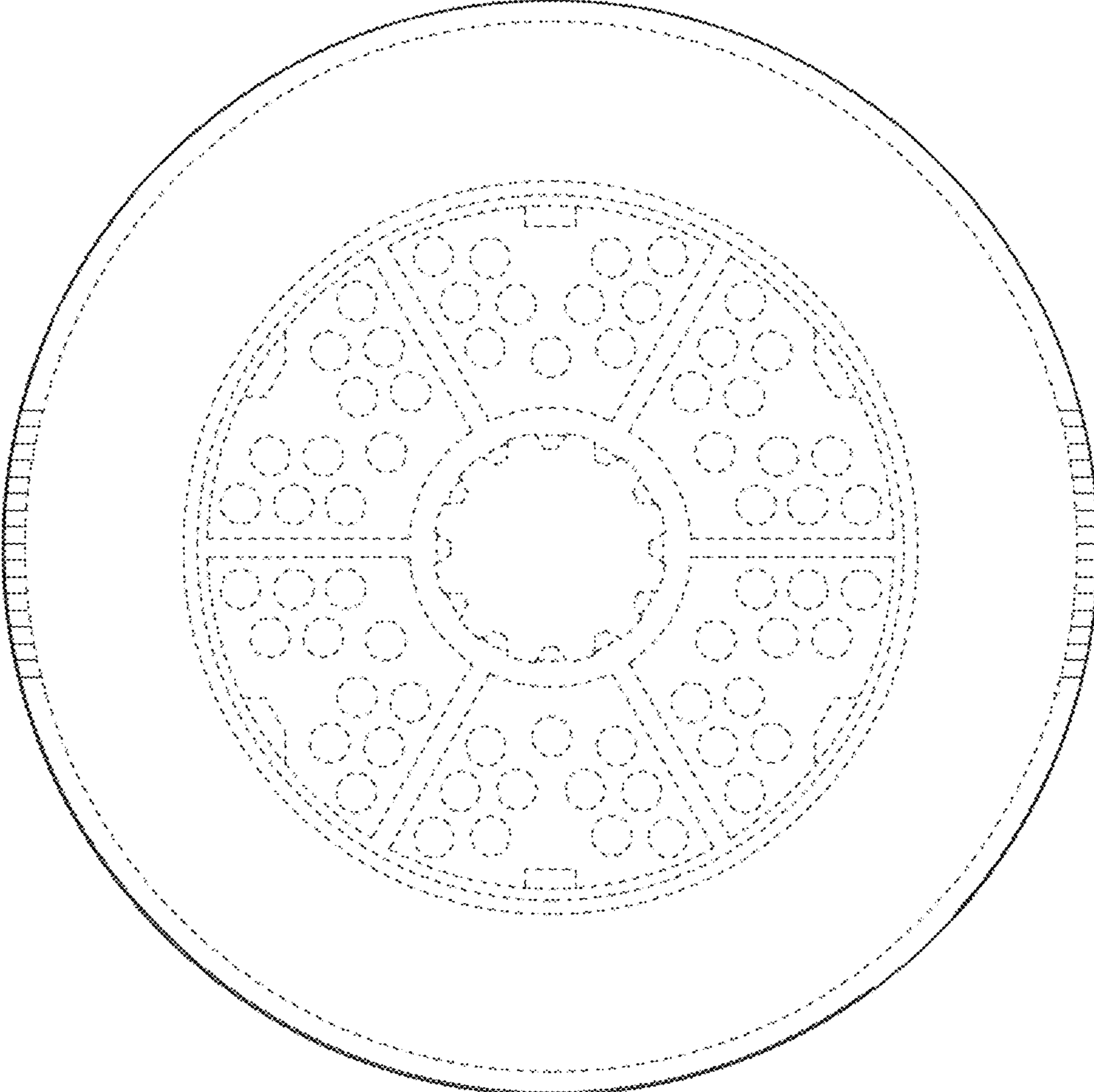

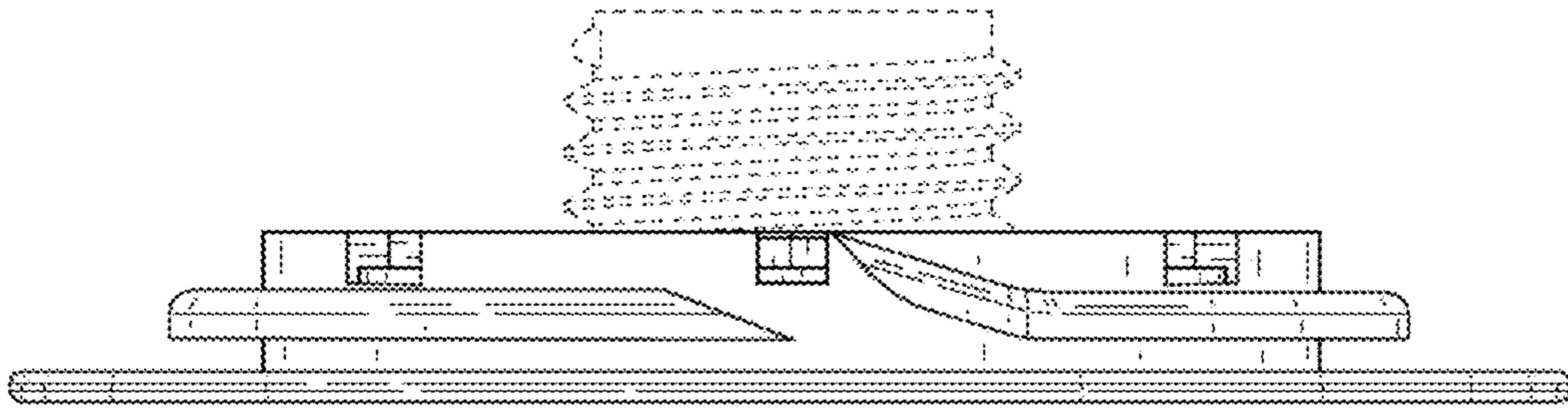

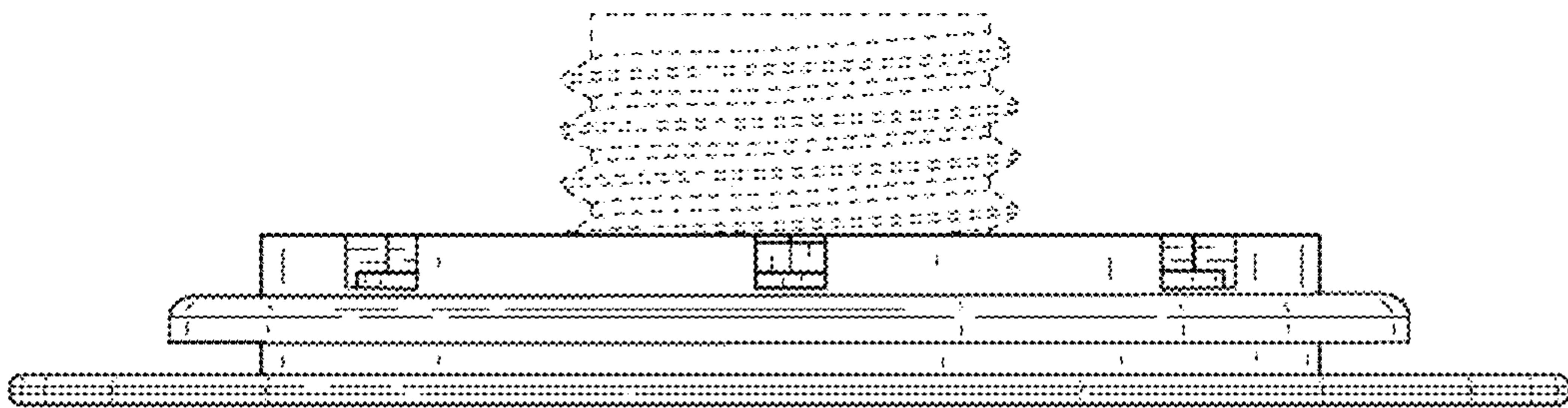

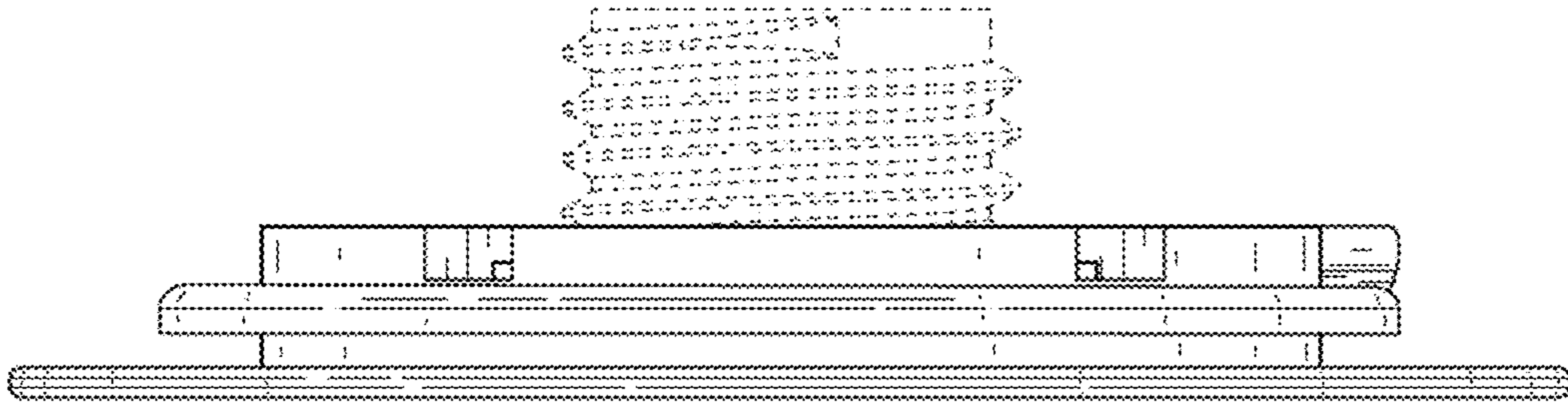

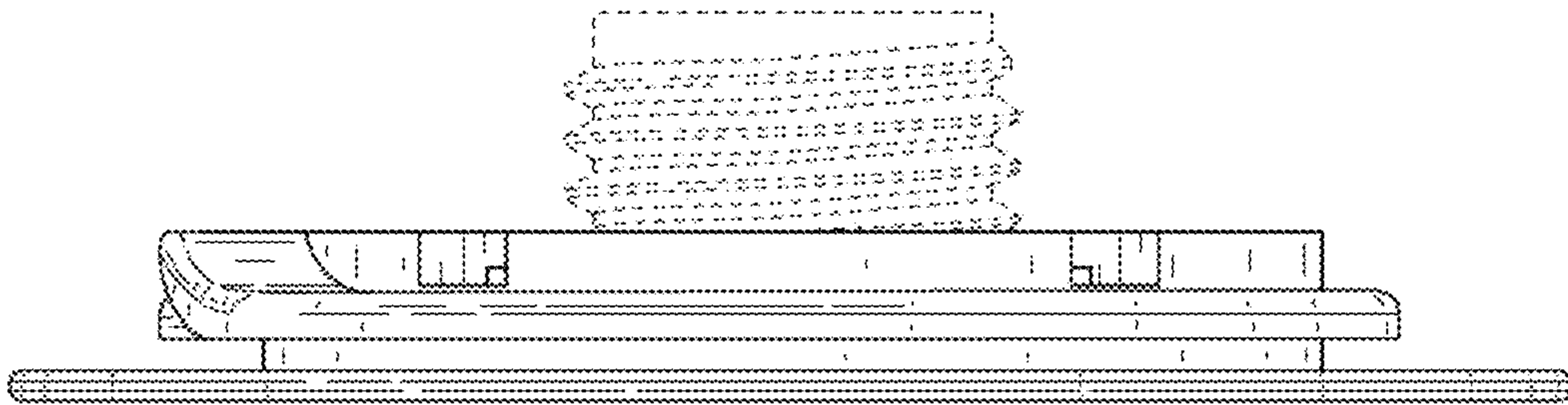

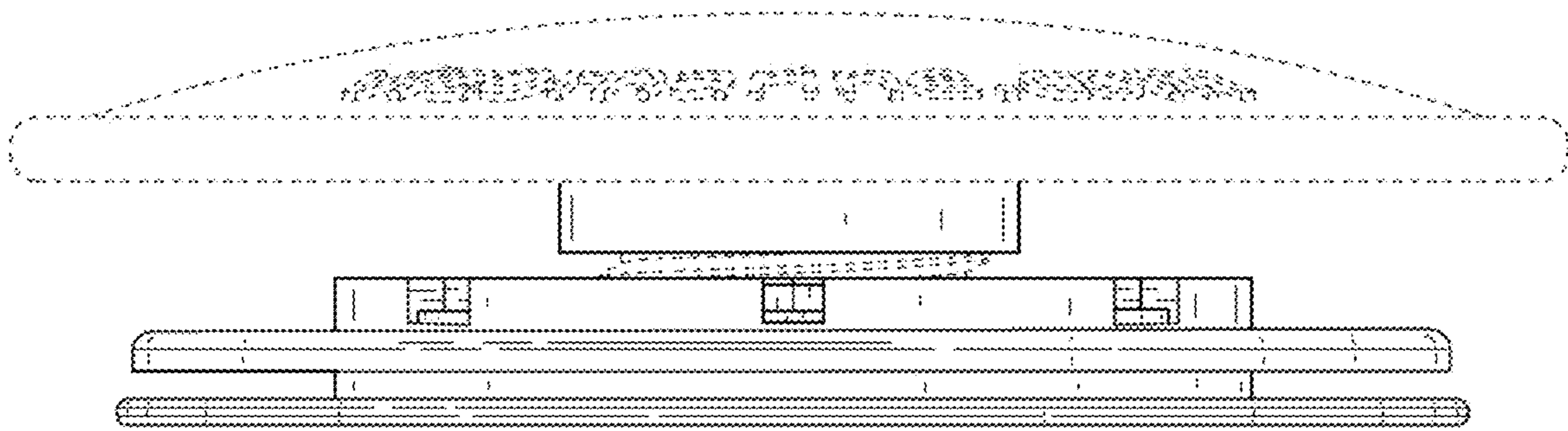

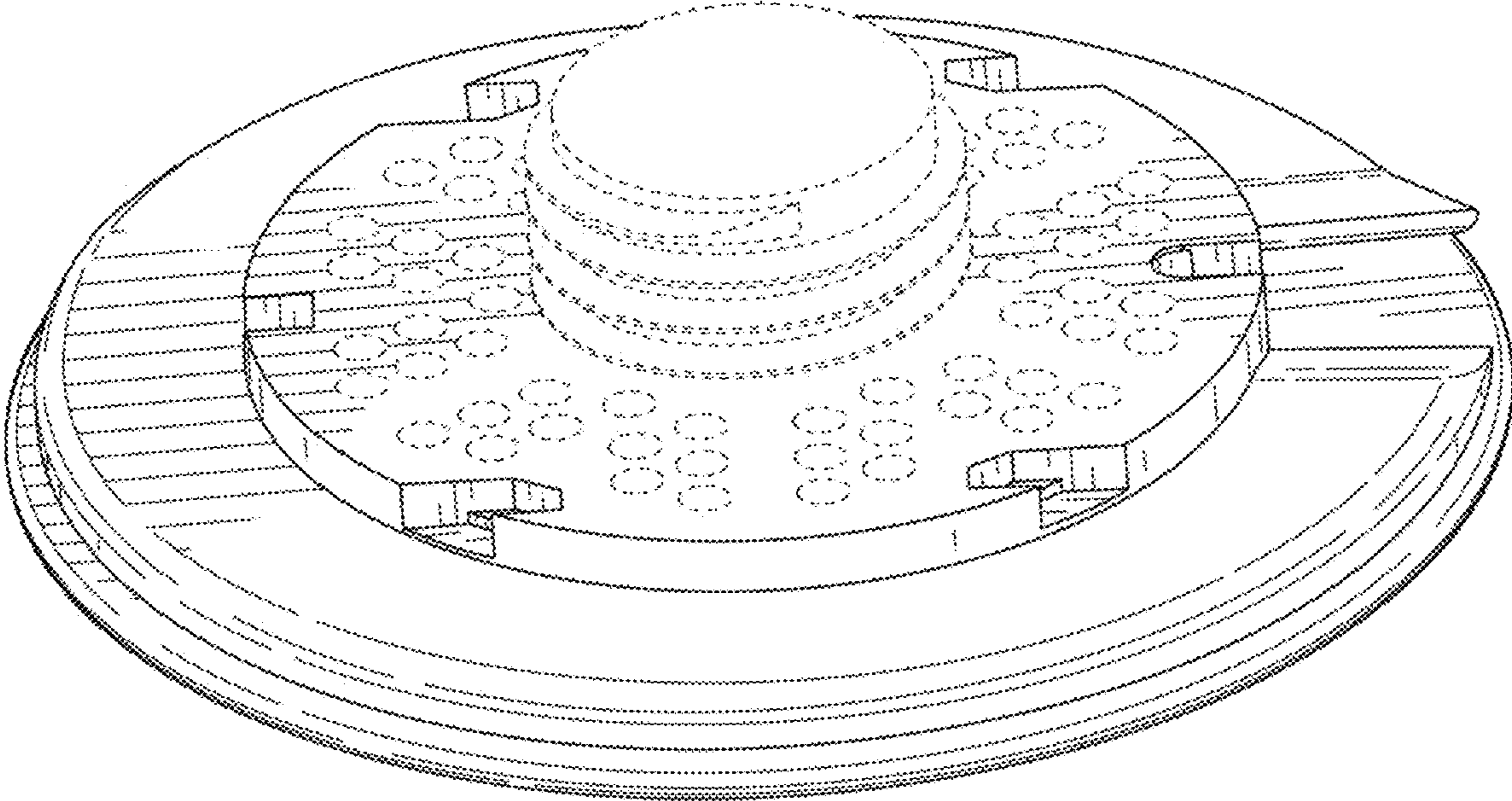

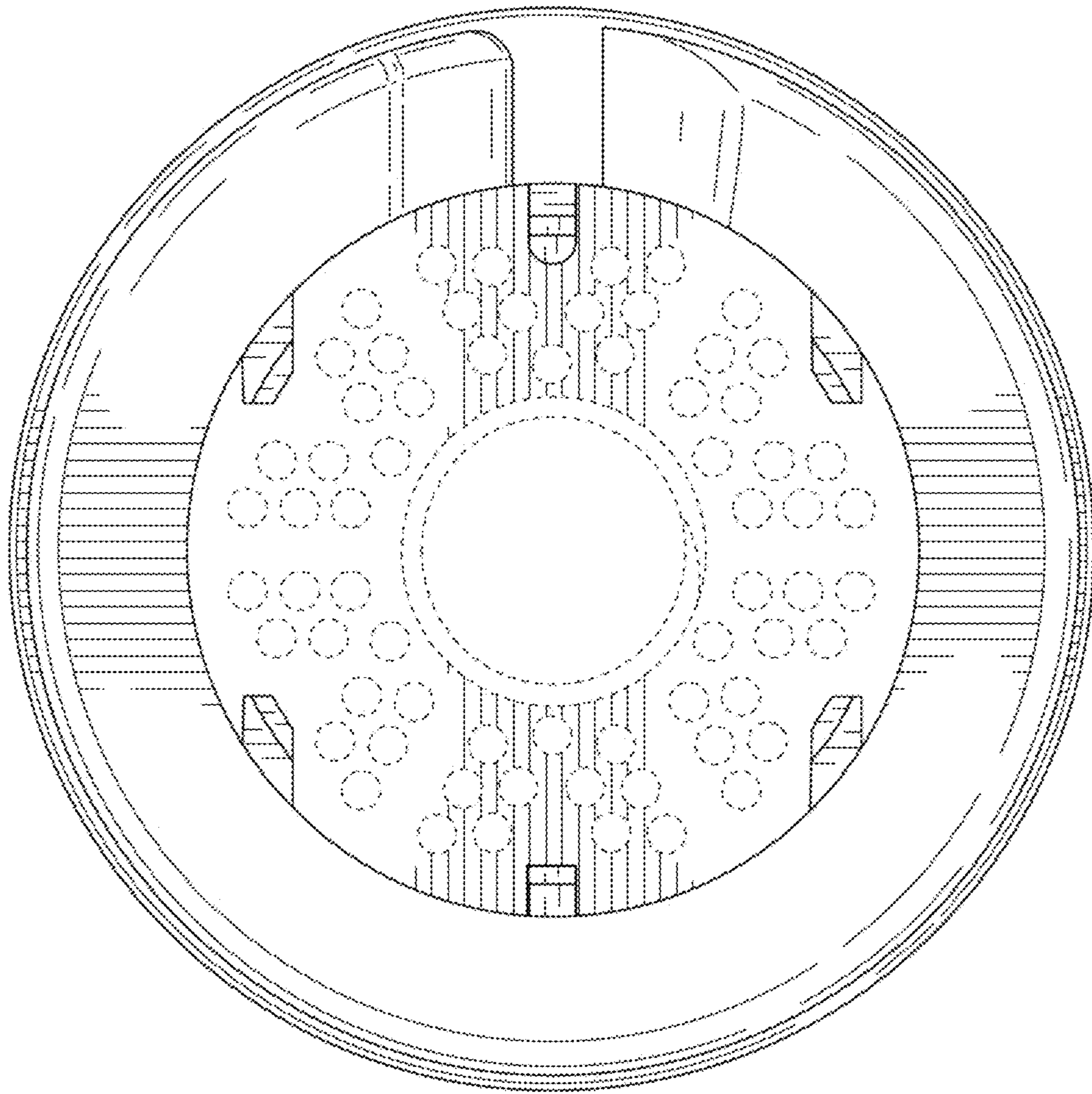

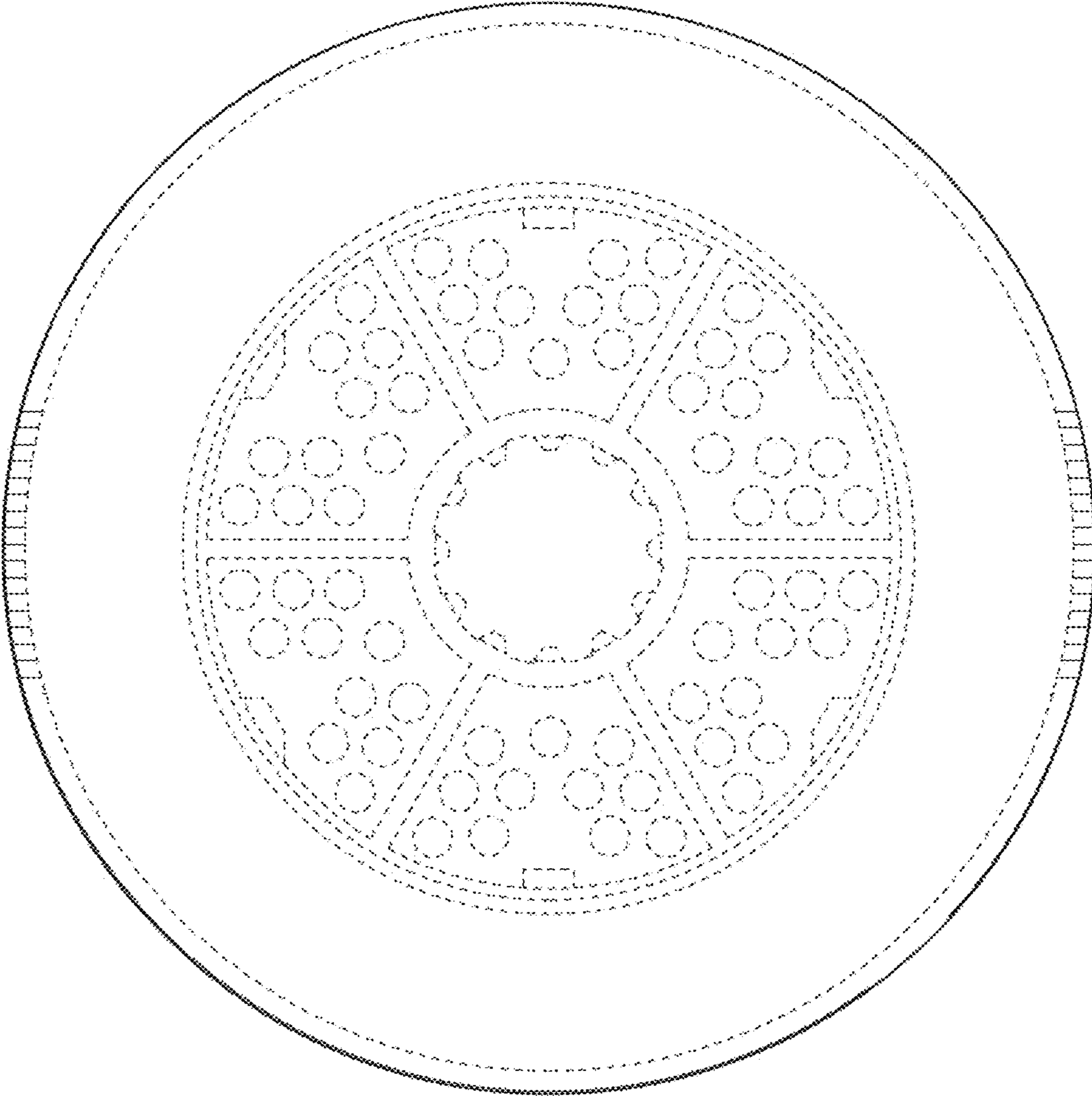

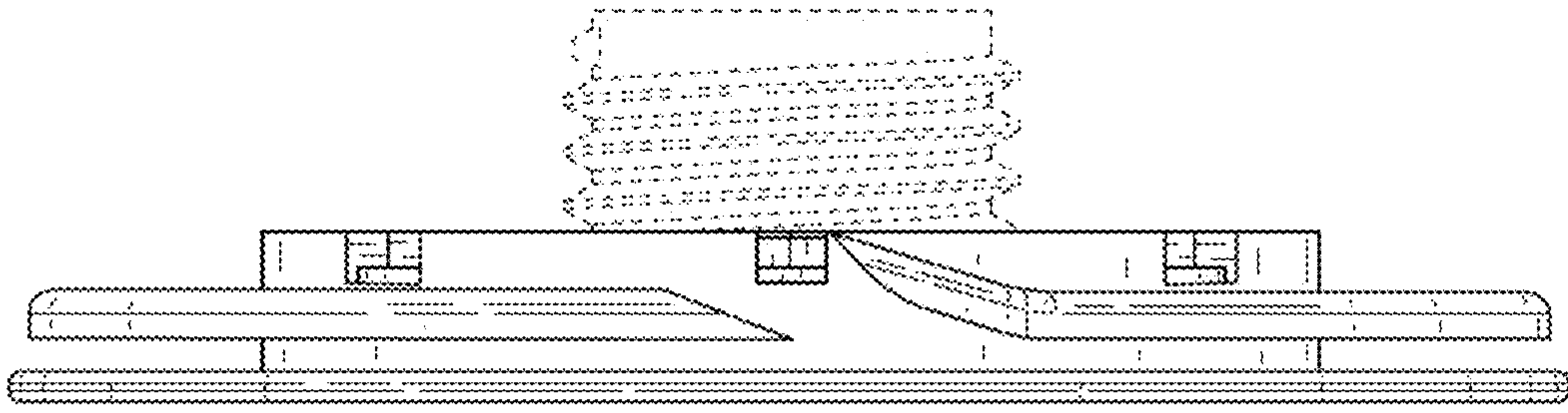

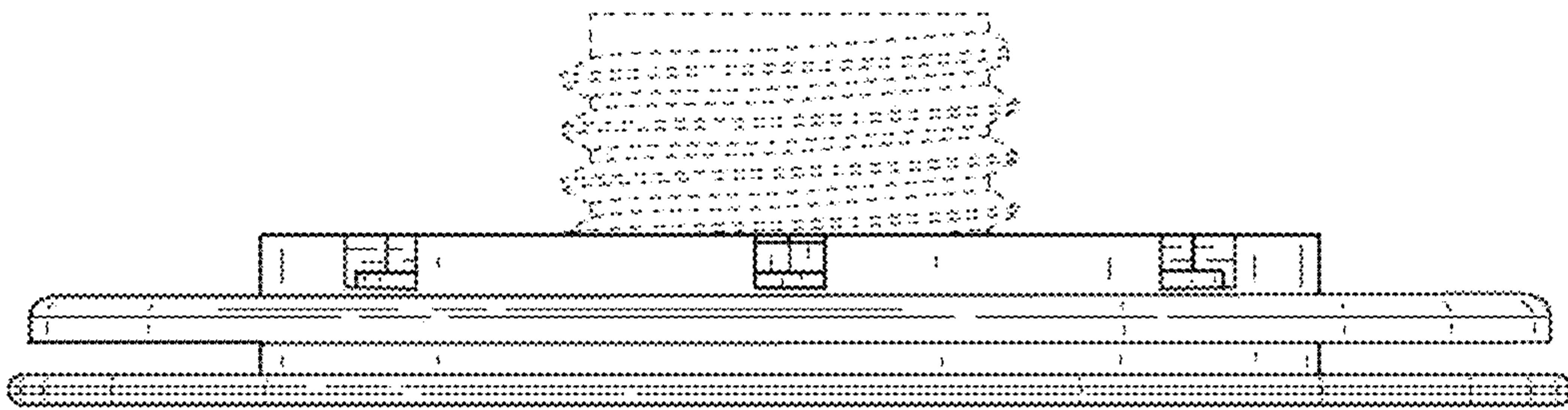

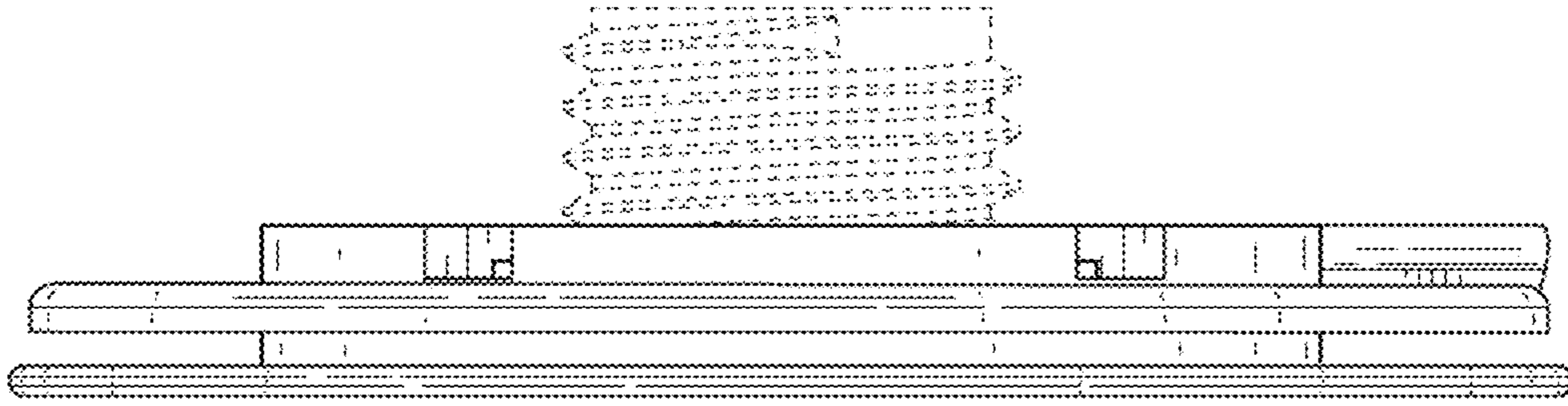

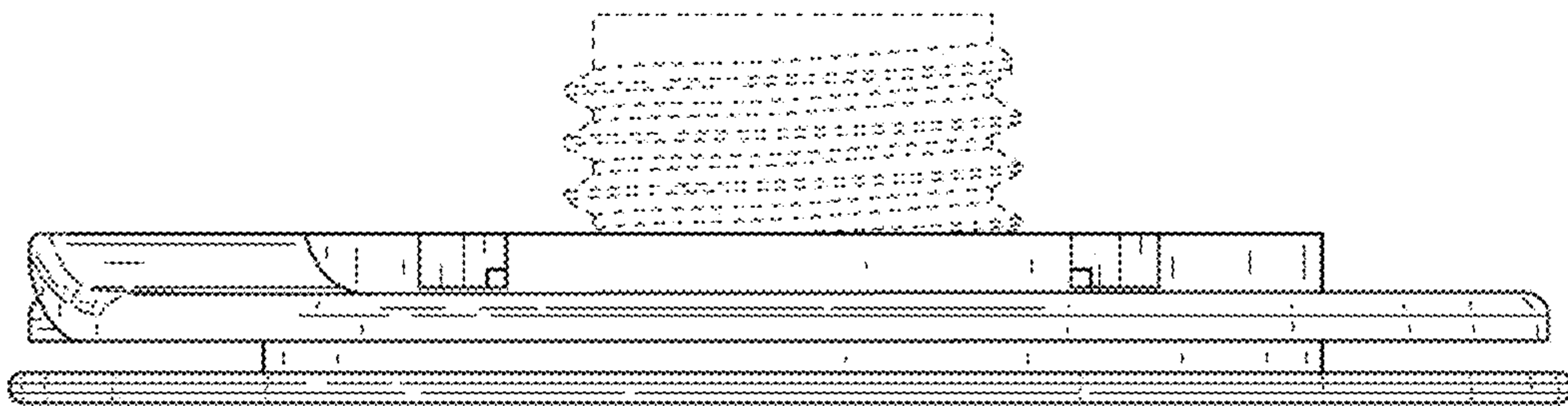
