The ornamental design for an ammunition magazine, as shown and described.

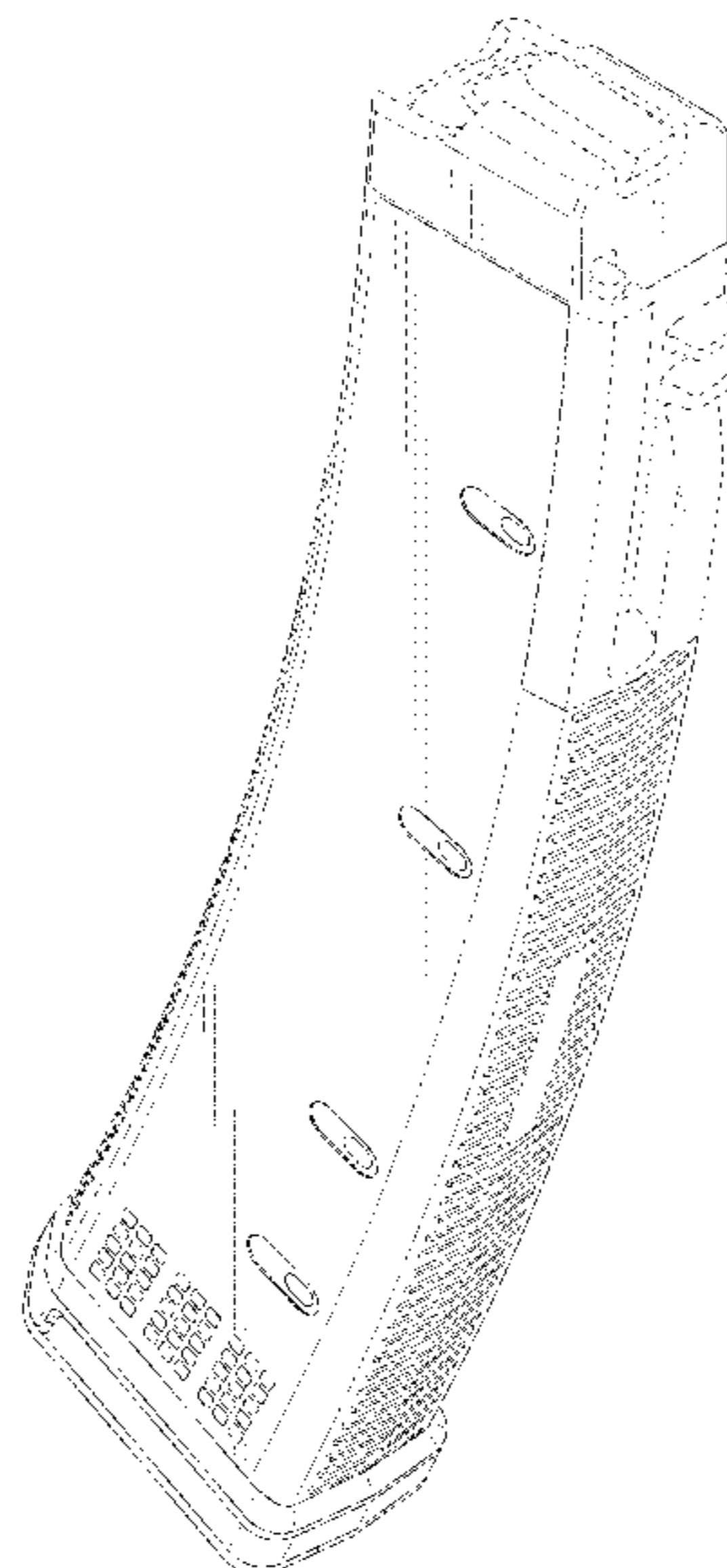
**DESCRIPTION**

FIG. 1 is a right, rear, top perspective view of the ammunition magazine;  
 FIG. 2 is a right side elevation view of the ammunition magazine in FIG. 1;  
 FIG. 3 is a left side elevation view of the ammunition magazine in FIG. 1;  
 FIG. 4 is a front elevation view of the ammunition magazine in FIG. 1;  
 FIG. 5 is a rear elevation view of the ammunition magazine in FIG. 1;  
 FIG. 6 is a top view of the ammunition magazine in FIG. 1;  
 and,  
 FIG. 7 is a bottom view of the ammunition magazine in FIG. 1.

The shade lines in the Figures show contour and not surface ornamentation.

The evenly spaced broken lines and the areas within them in the Figures depict portions of the ammunition magazine that form no part of the claimed design. The dot-dash-dot broken lines depict the boundaries to the claim and form no part thereof.

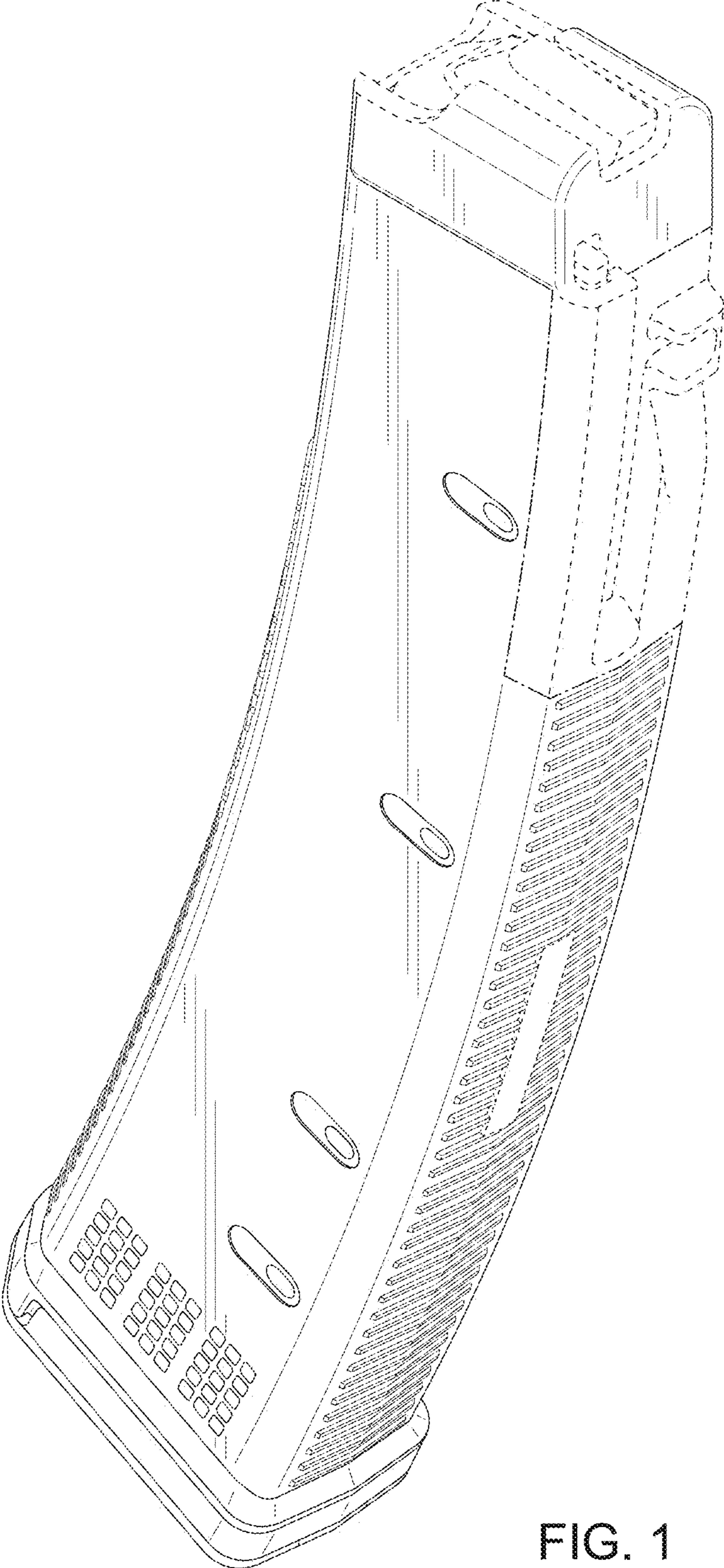

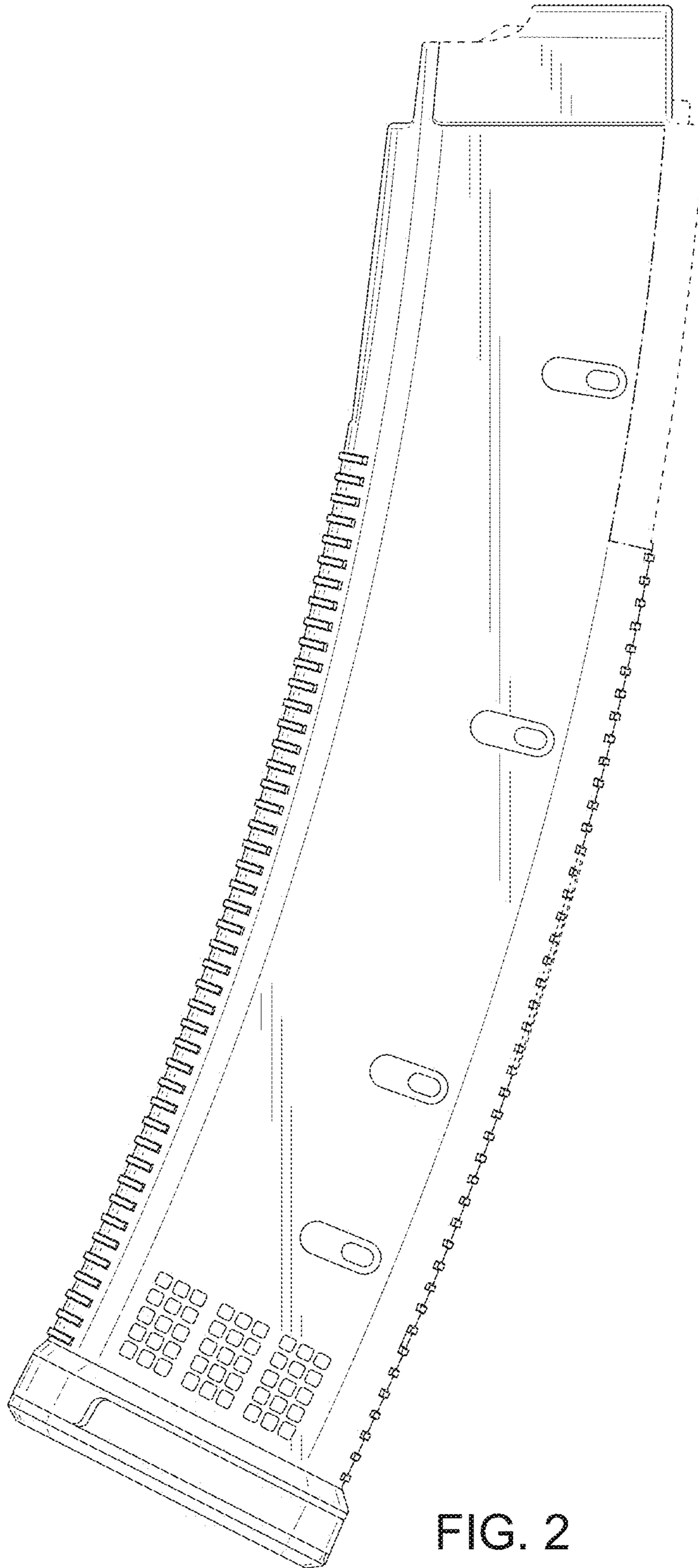

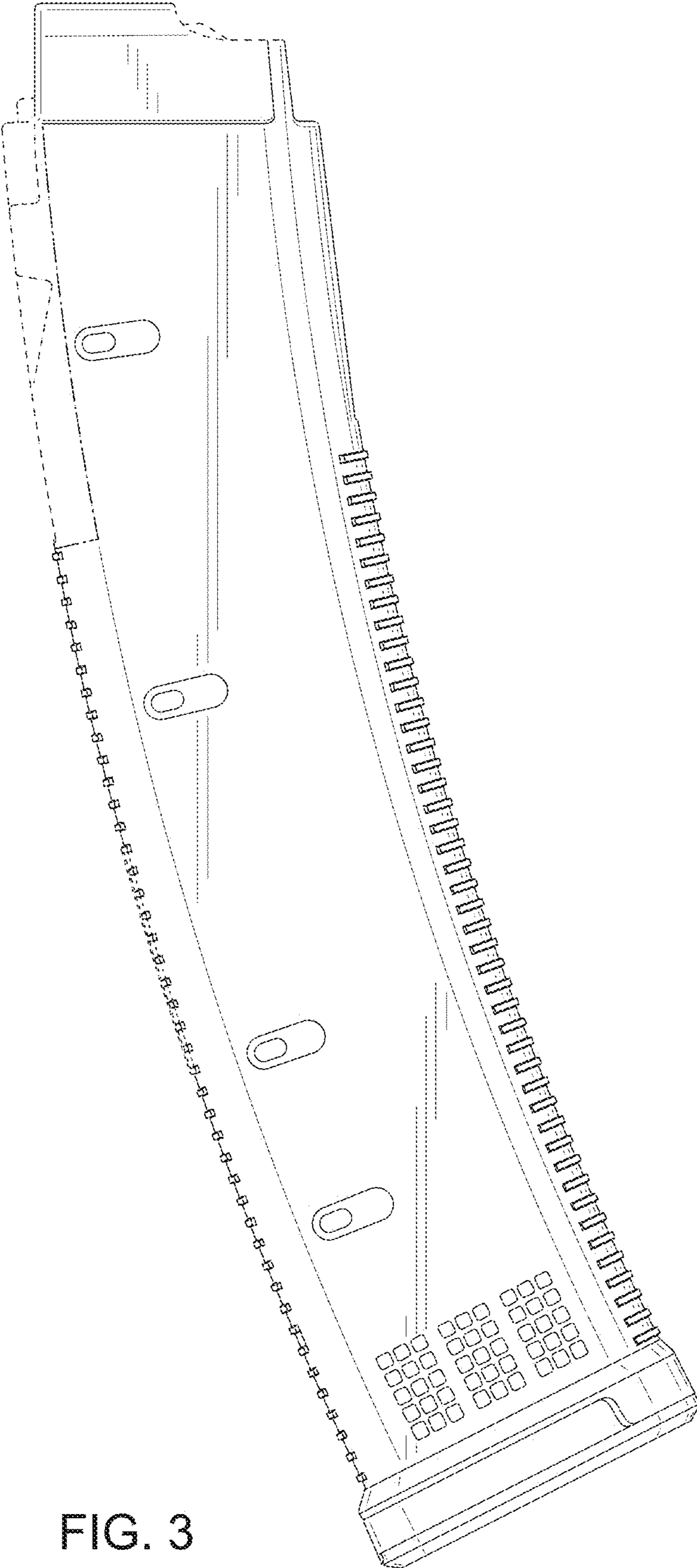

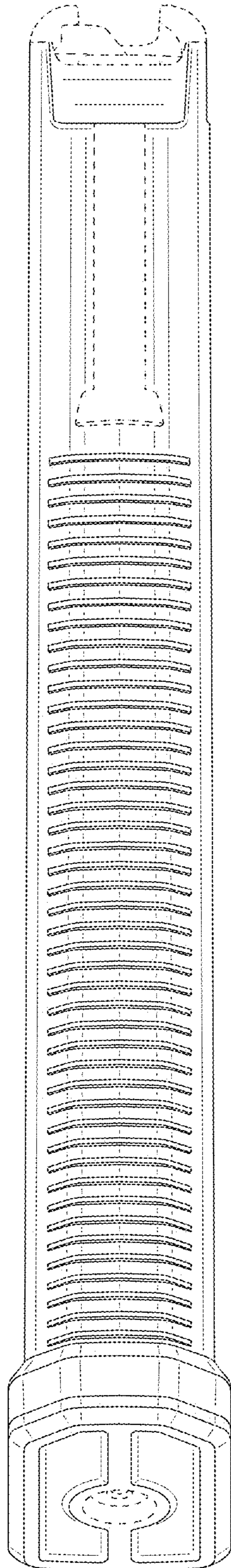

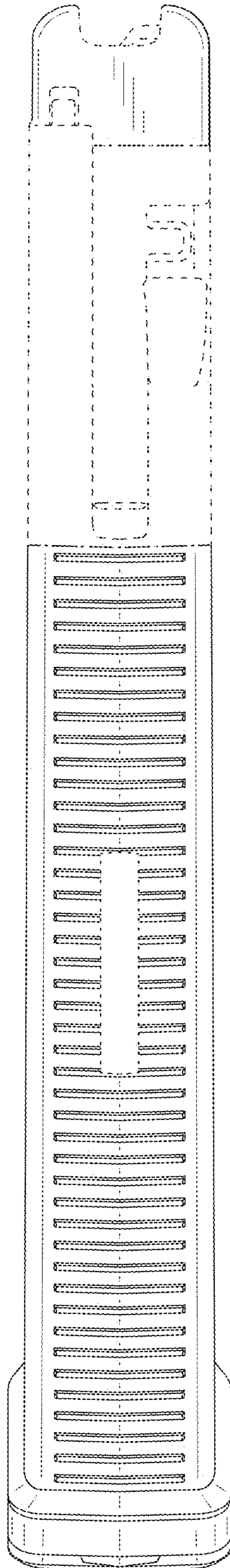

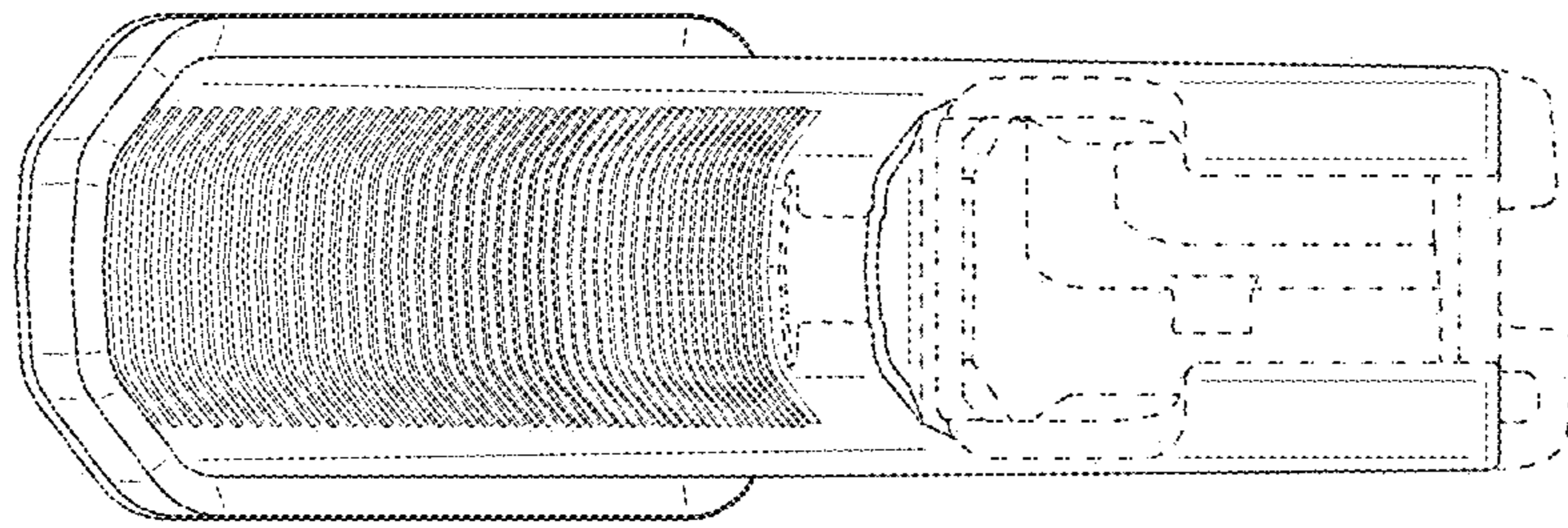

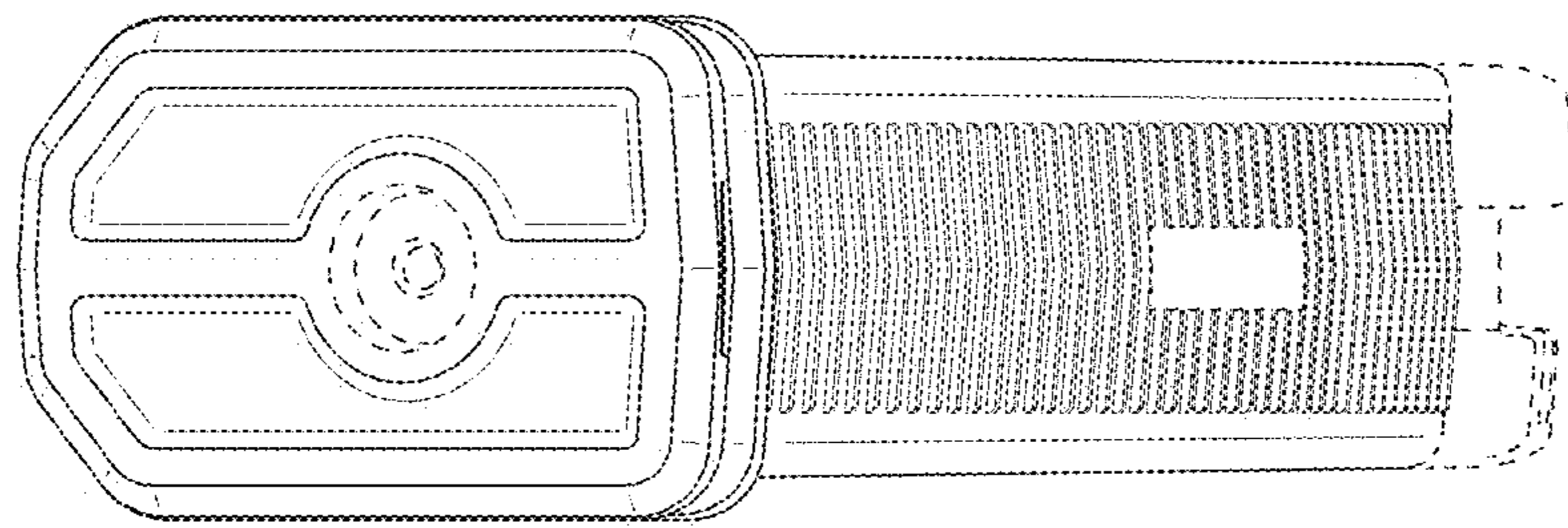
