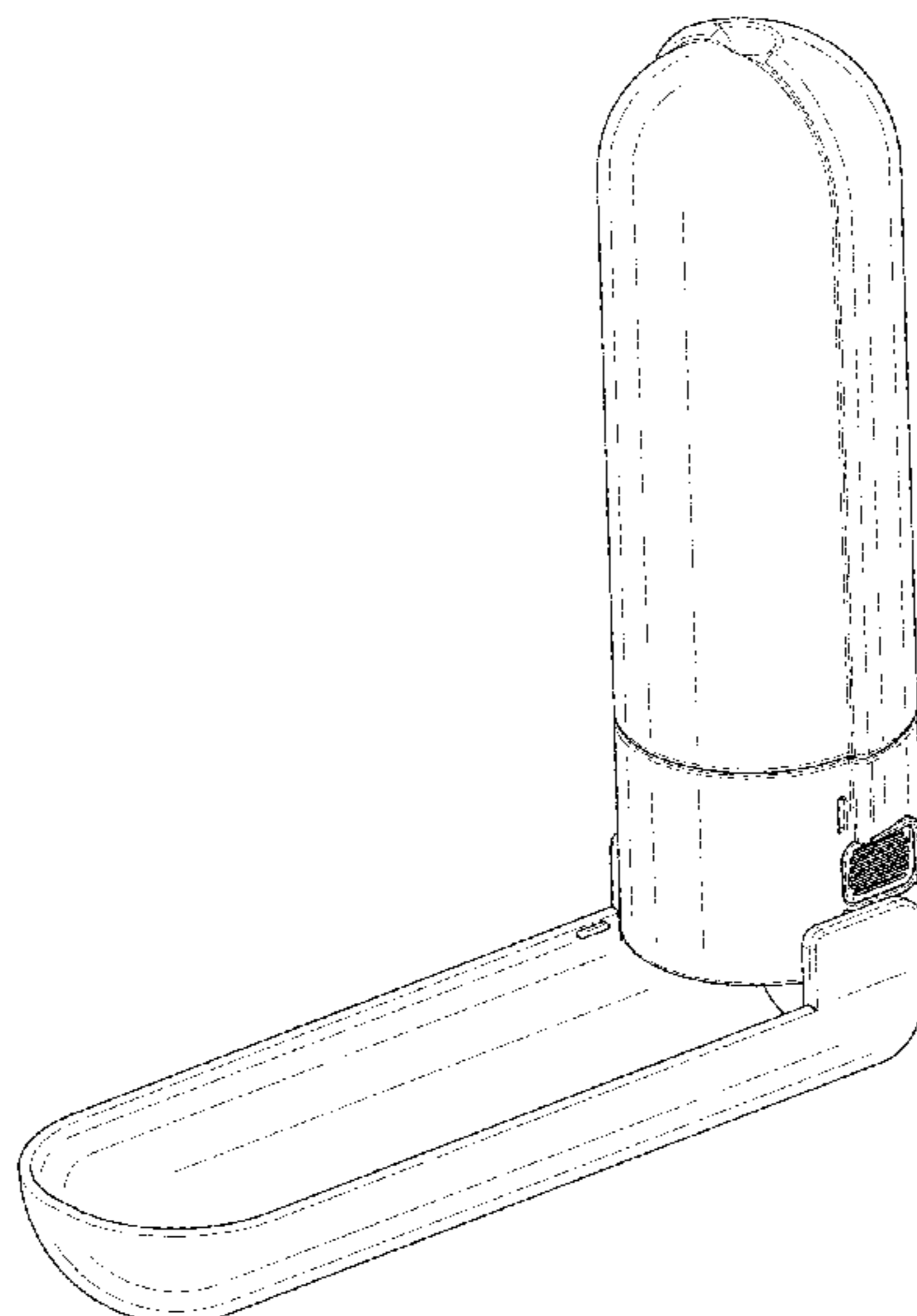
(57) **CLAIM**

The ornamental design for a pet travel cup, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a pet travel cup showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a front, right side, top perspective view thereof showing the pet travel cup in a collapsed state suitable for travel. The broken lines depict portions of the pet travel cup that form no part of the claimed design.

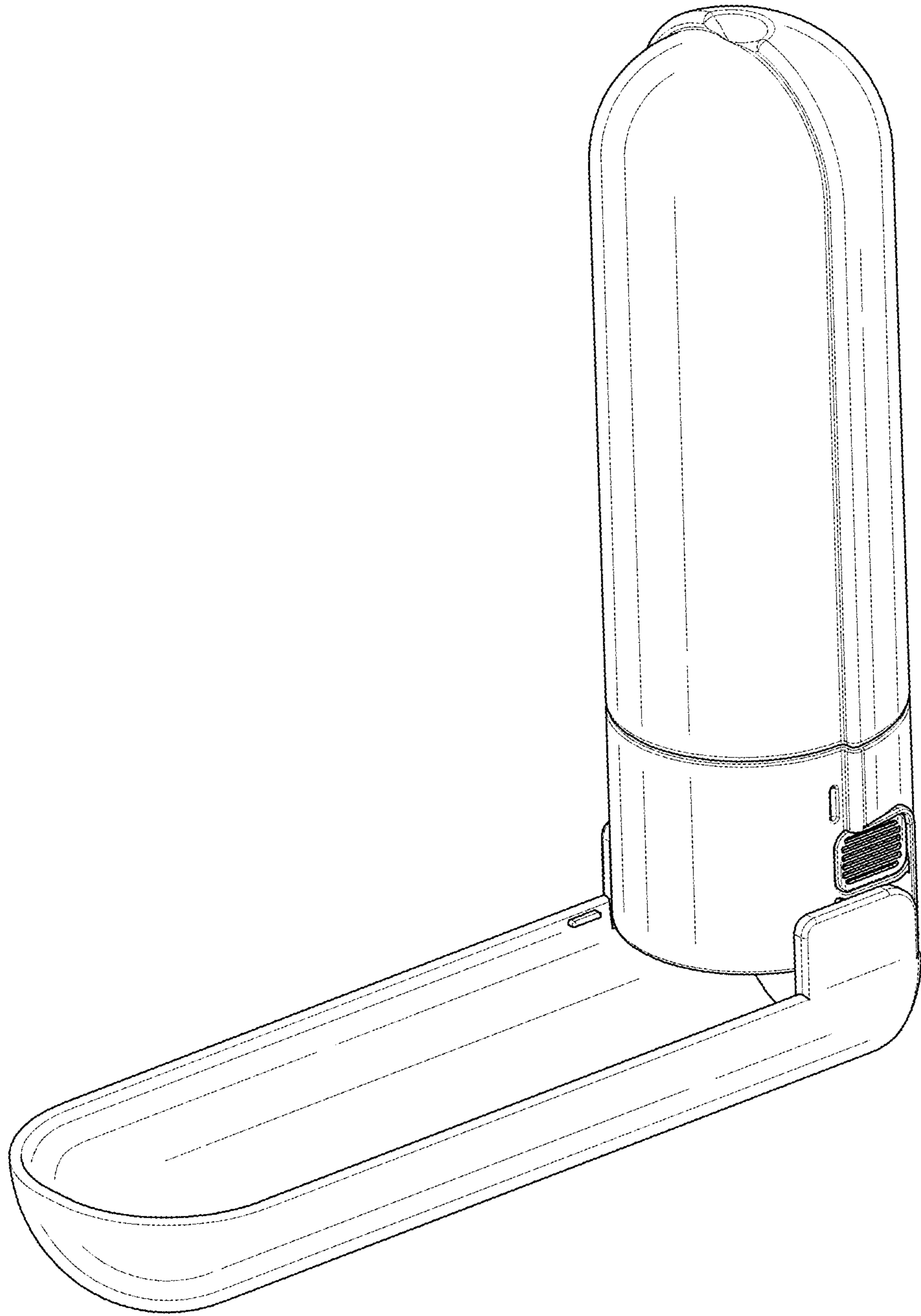

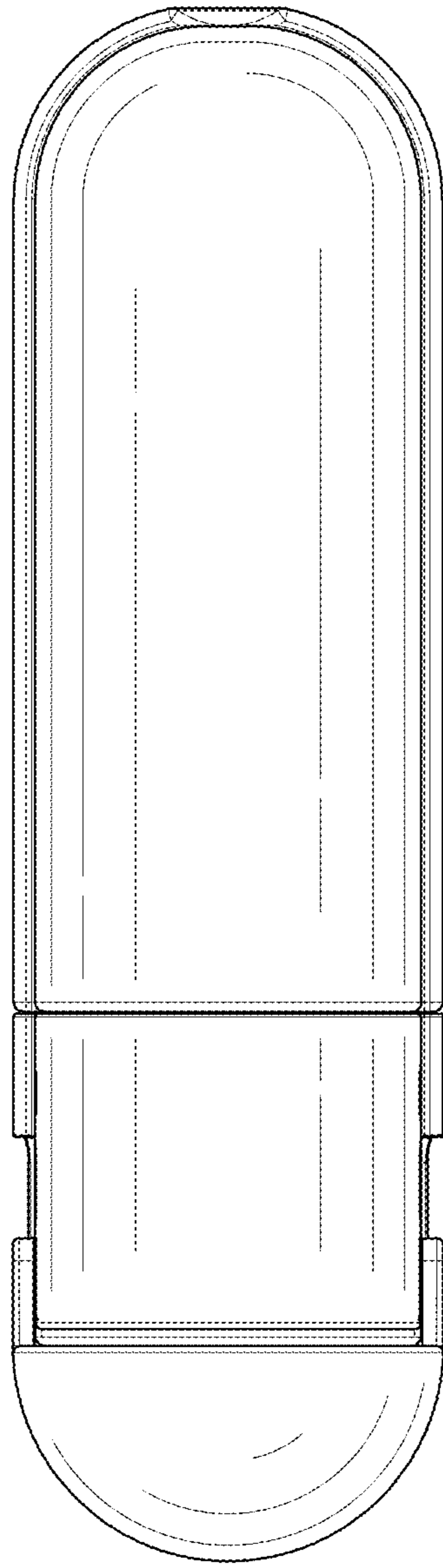

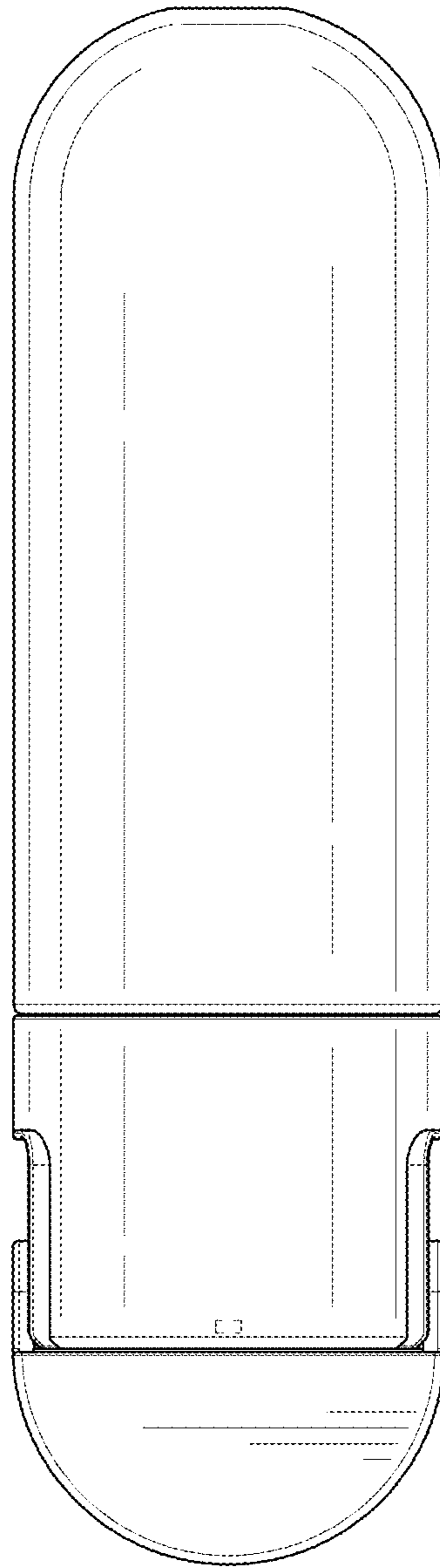

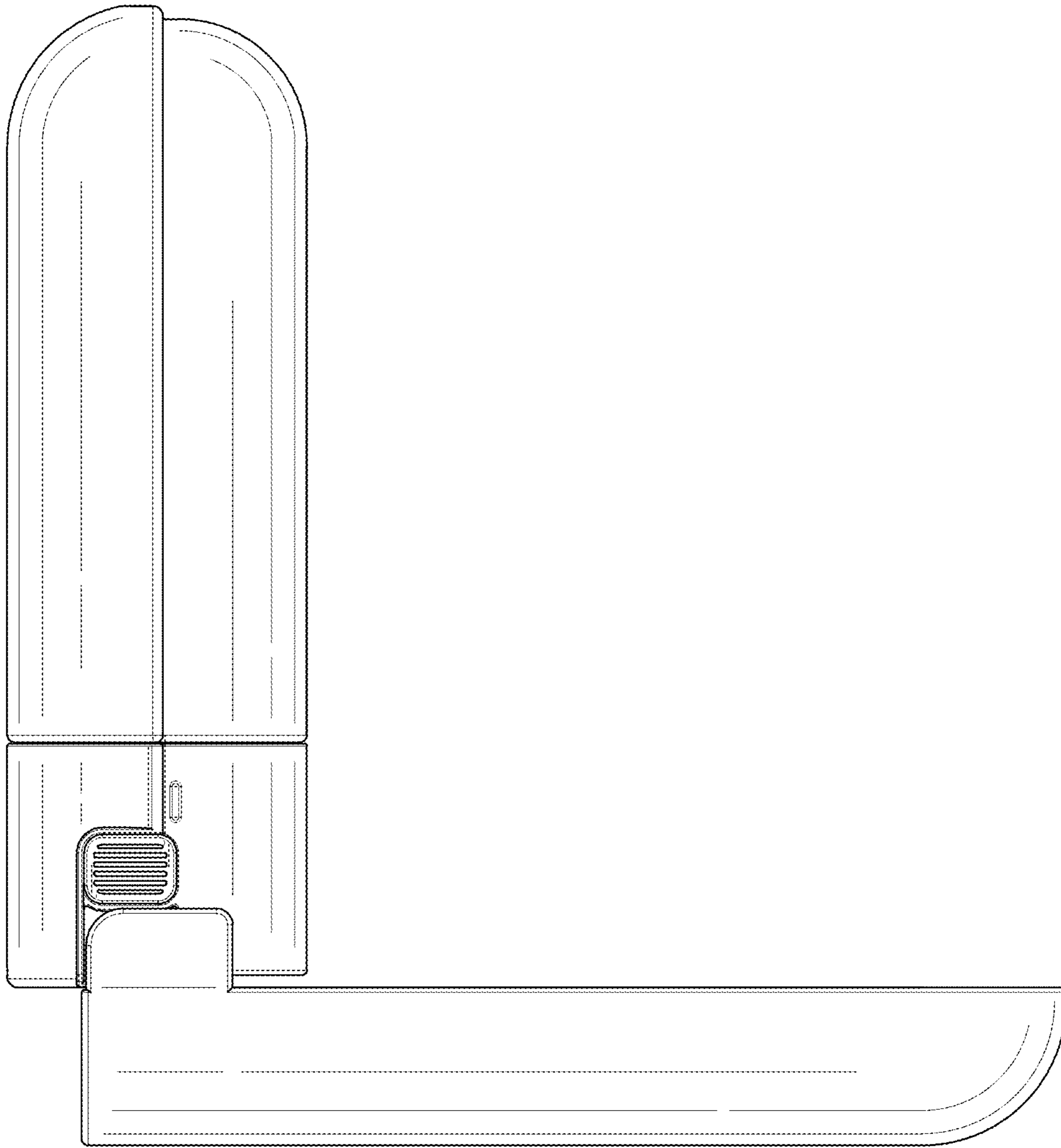

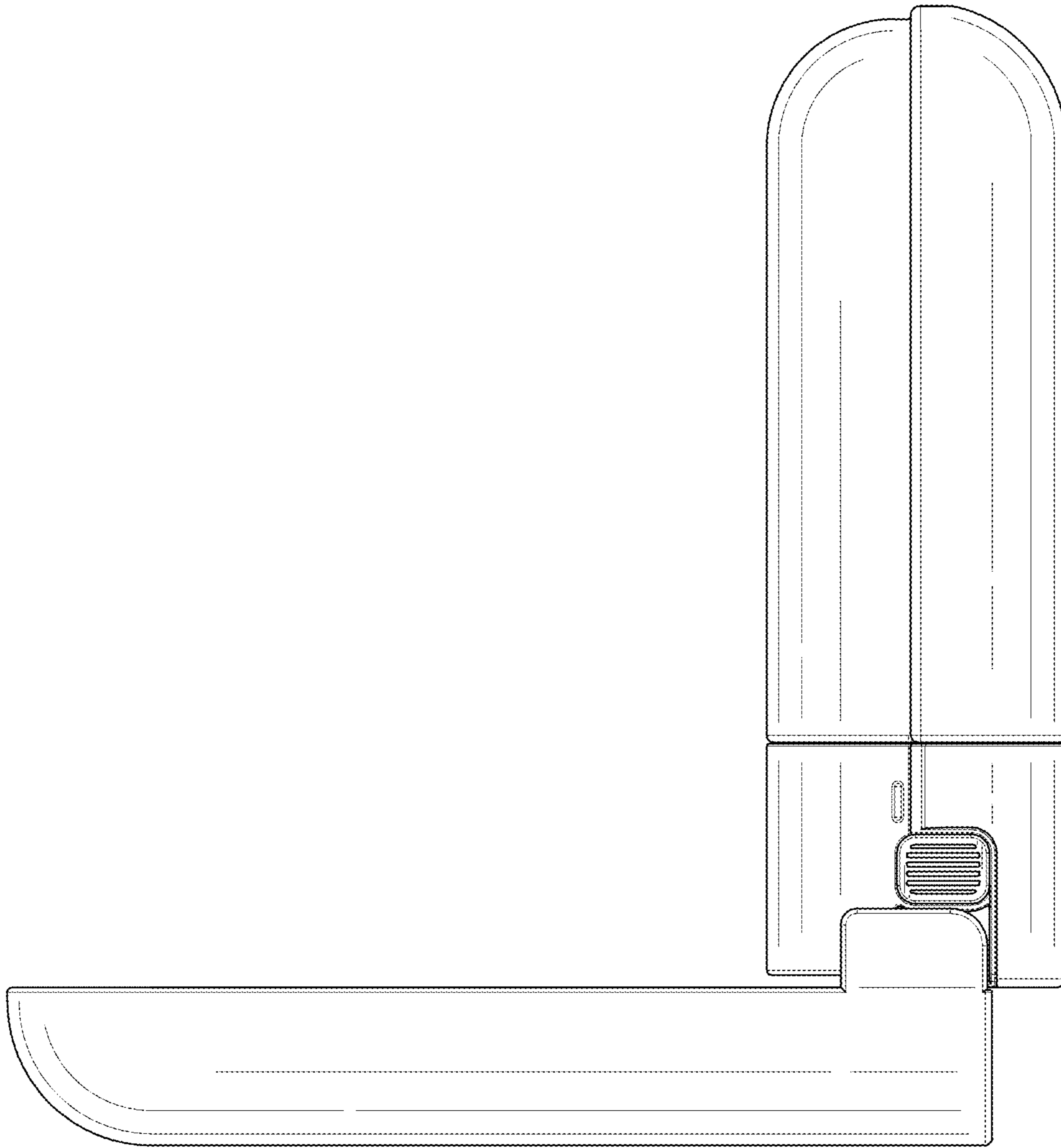

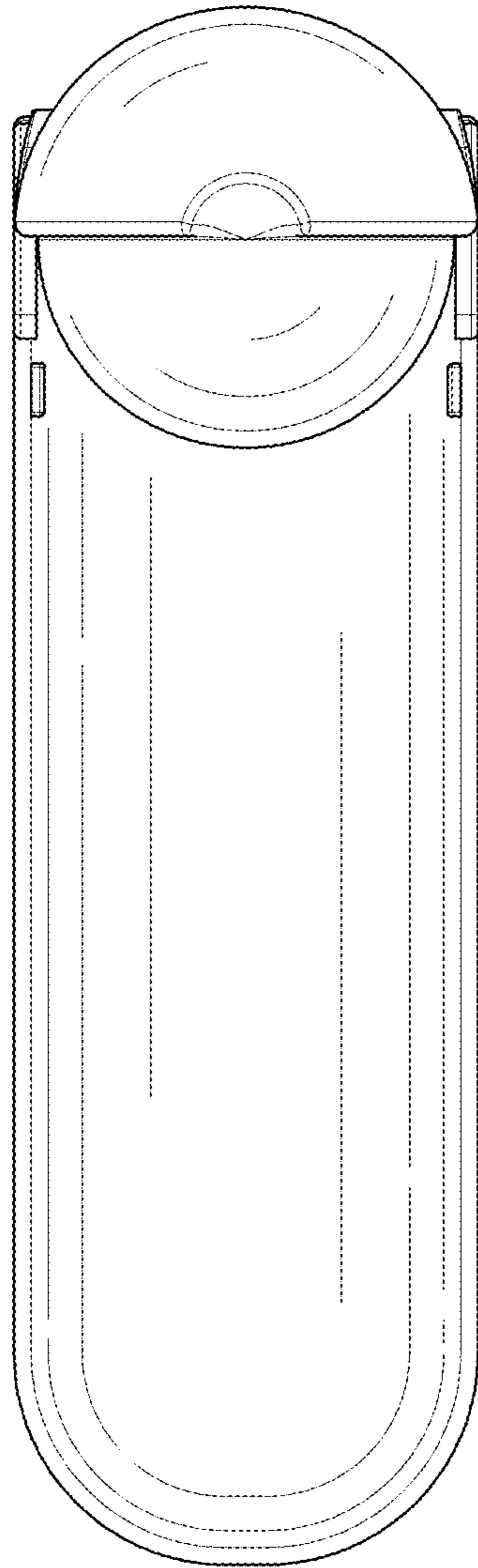

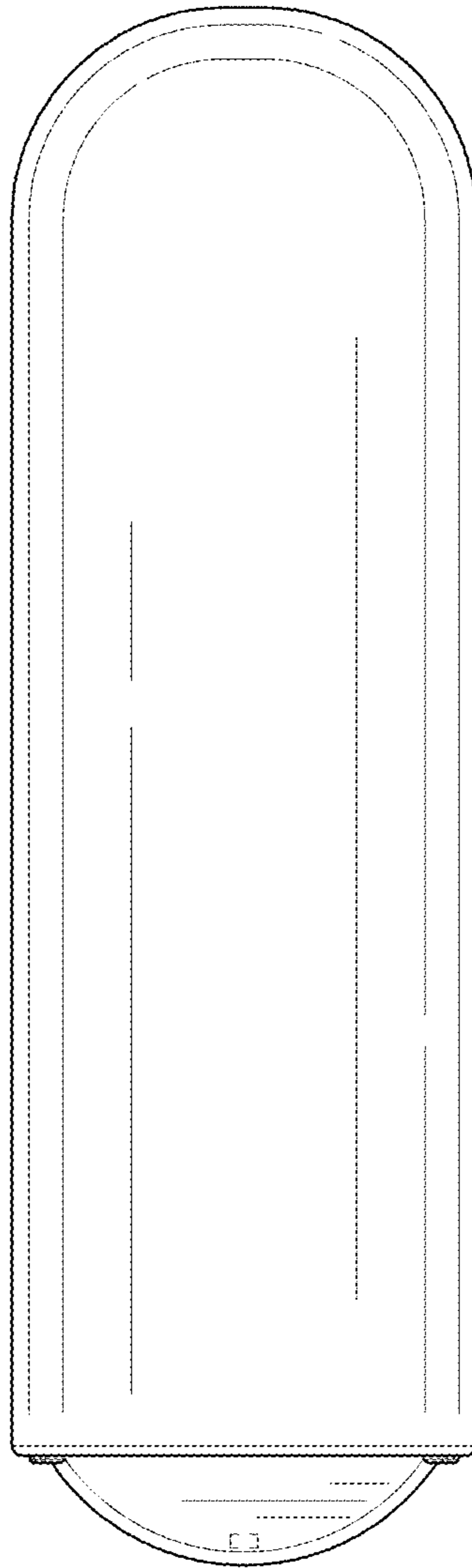

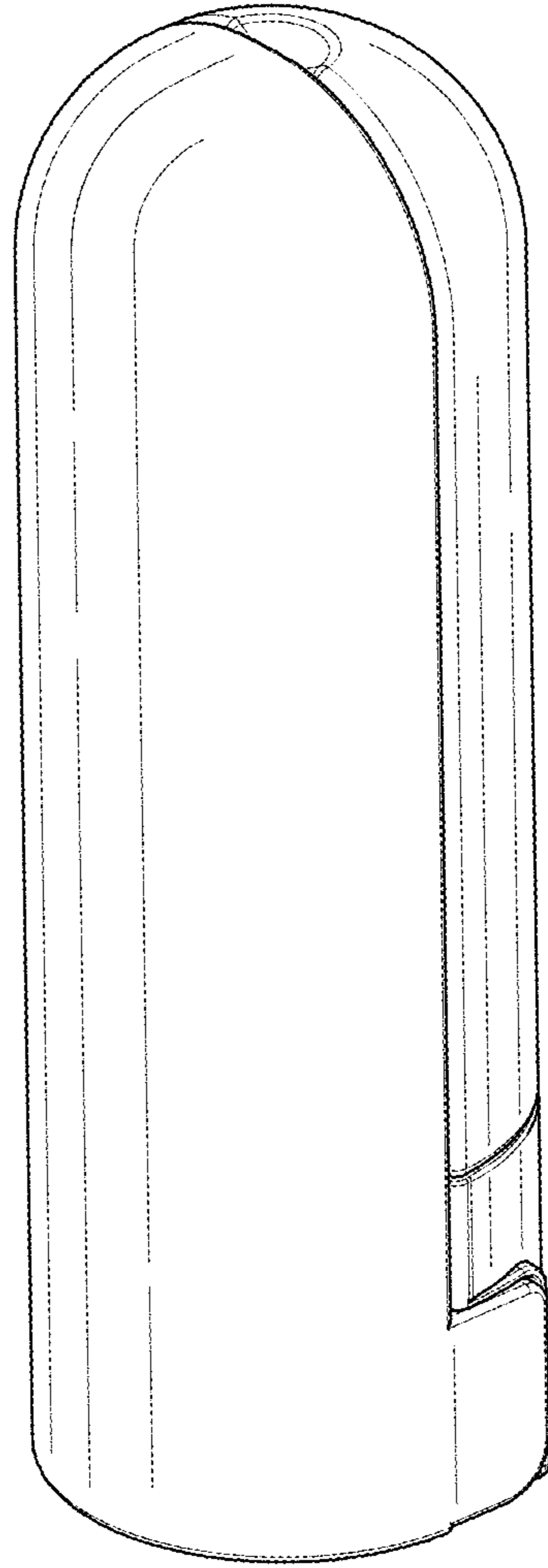
