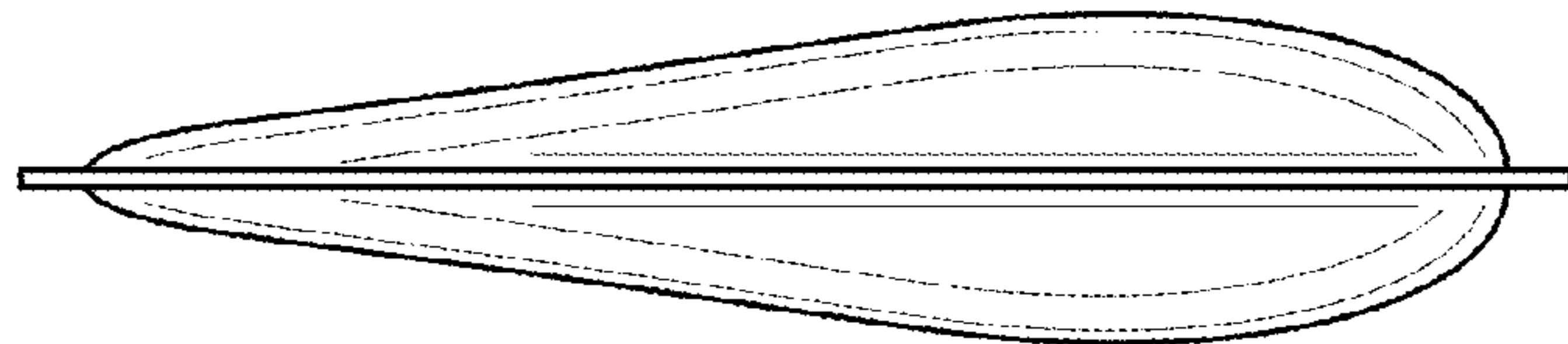
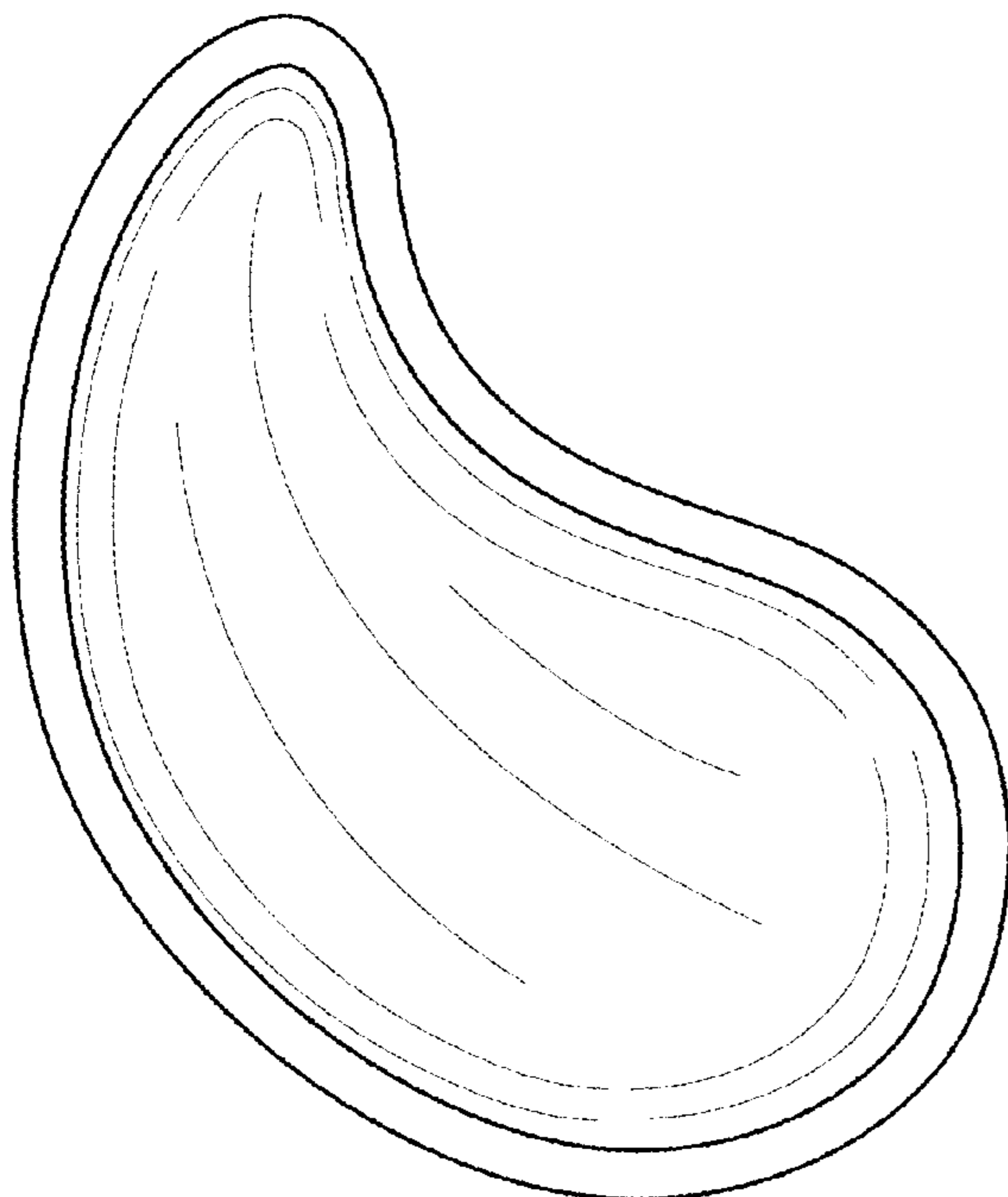
The ornamental design for a tea bag, as shown and described.

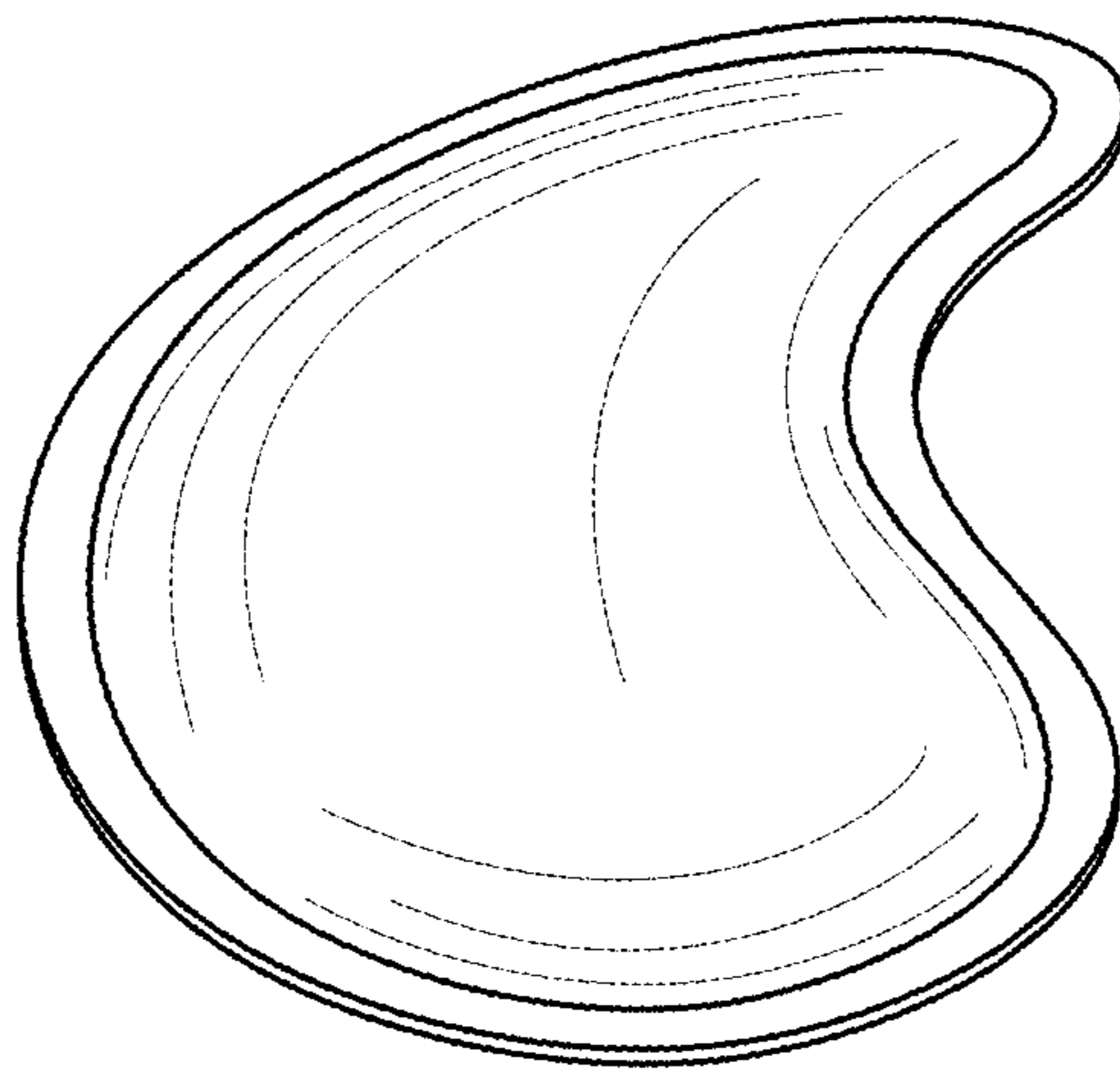

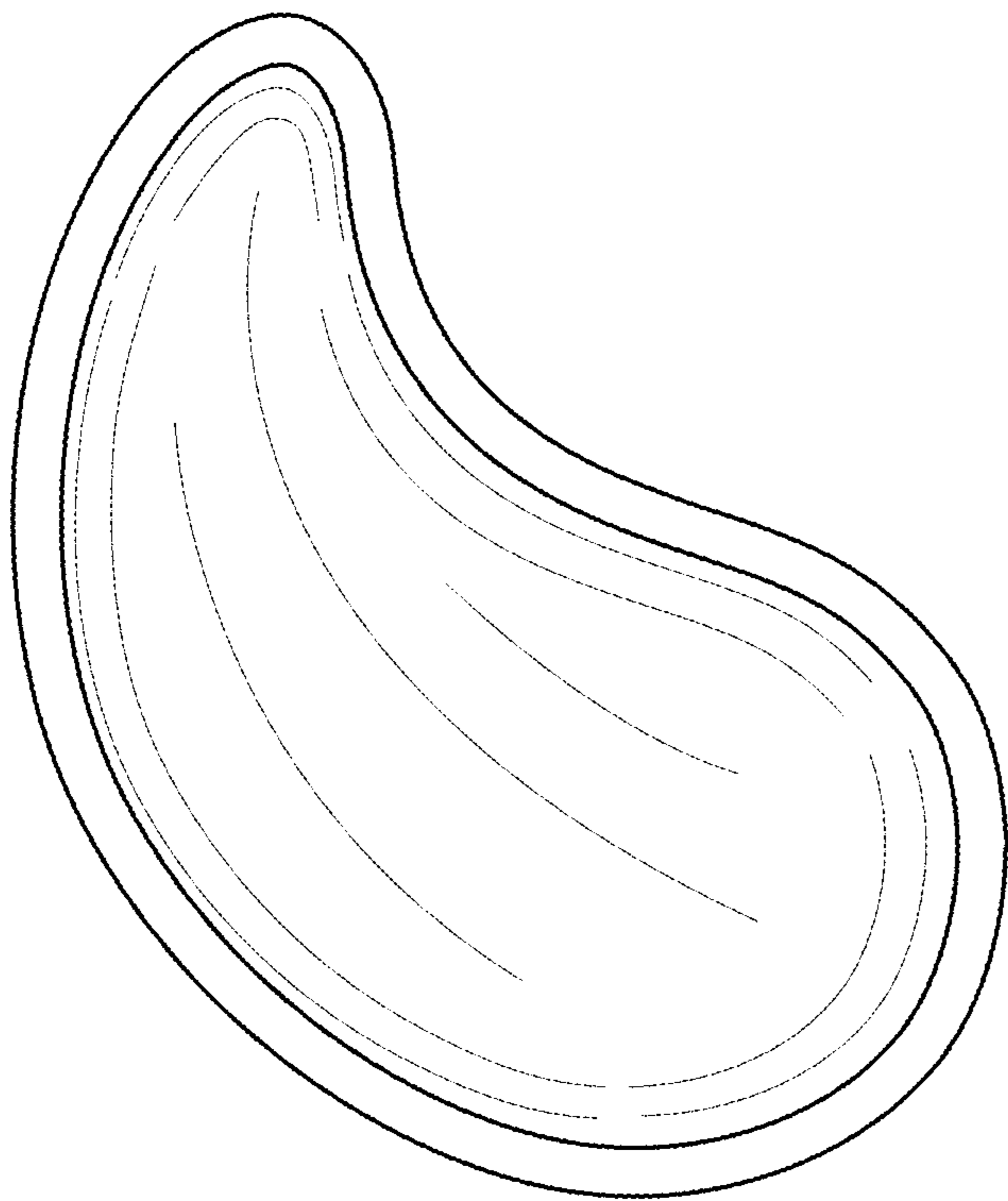

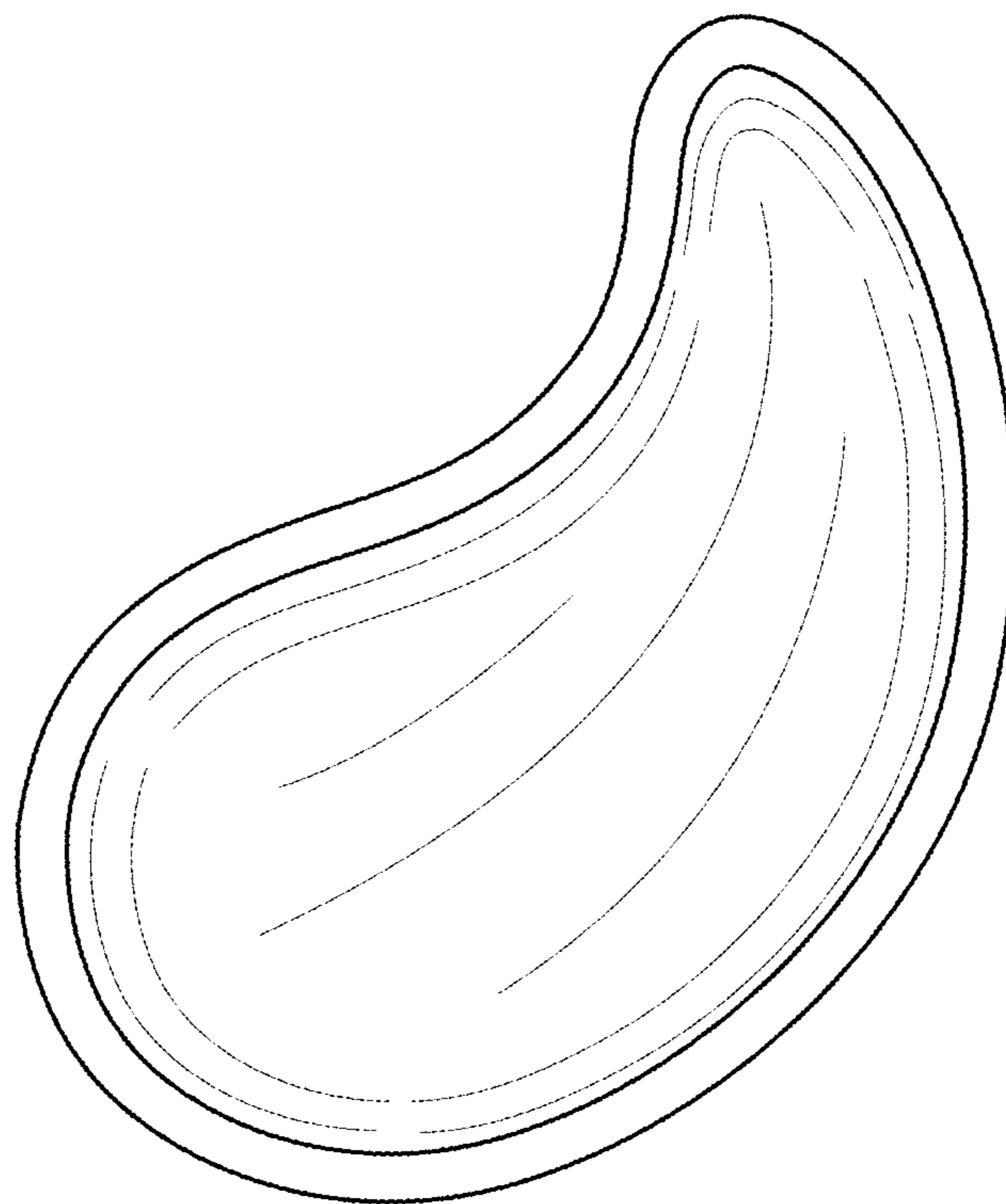

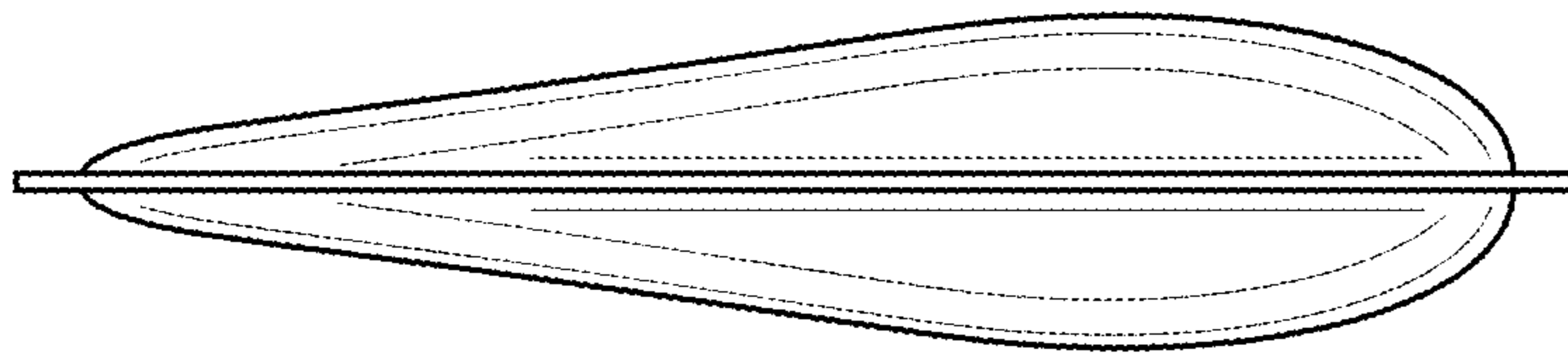

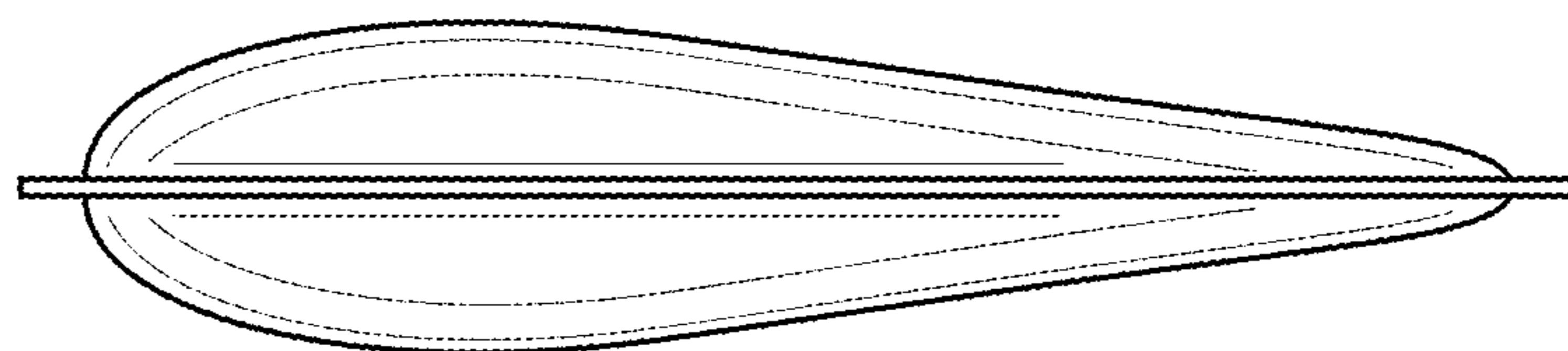
