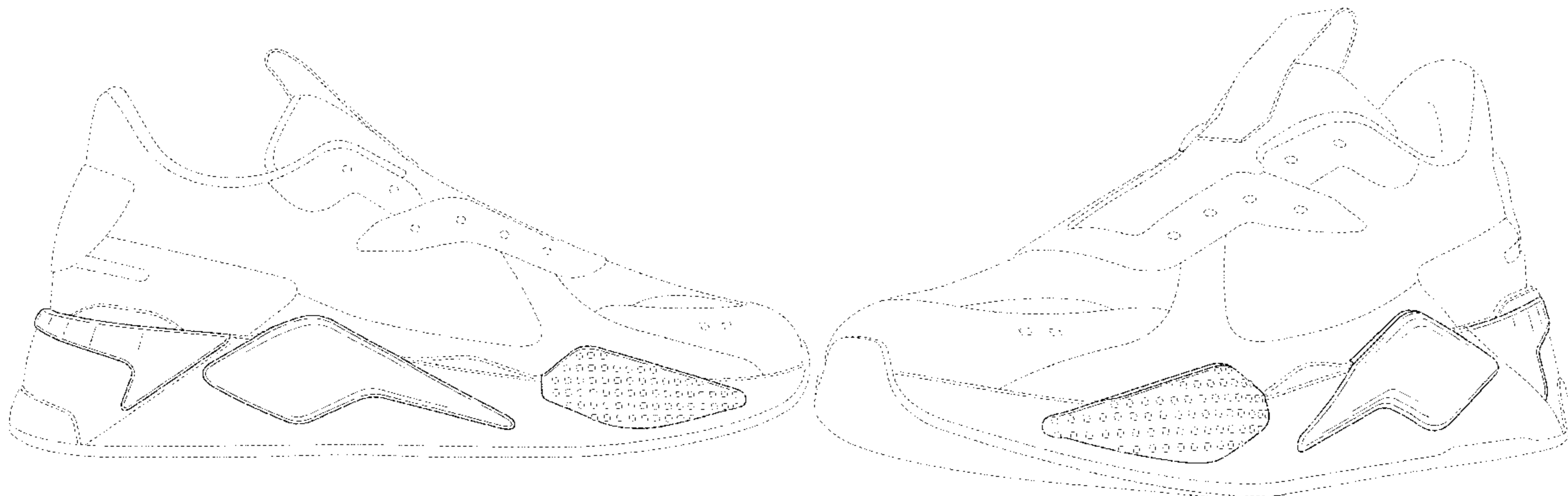
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a lateral side view of a shoe sole showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a medial side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a front-top perspective view thereof;
FIG. 6 is a bottom view thereof; and
FIG. 7 is a front-lateral perspective view thereof; and,
FIG. 8 is a top view thereof.
The broken lines on the shoe sole depict portions of the sole that form no part of the claimed design, while the other broken lines depict environmental structure that also forms no part of the claimed design.

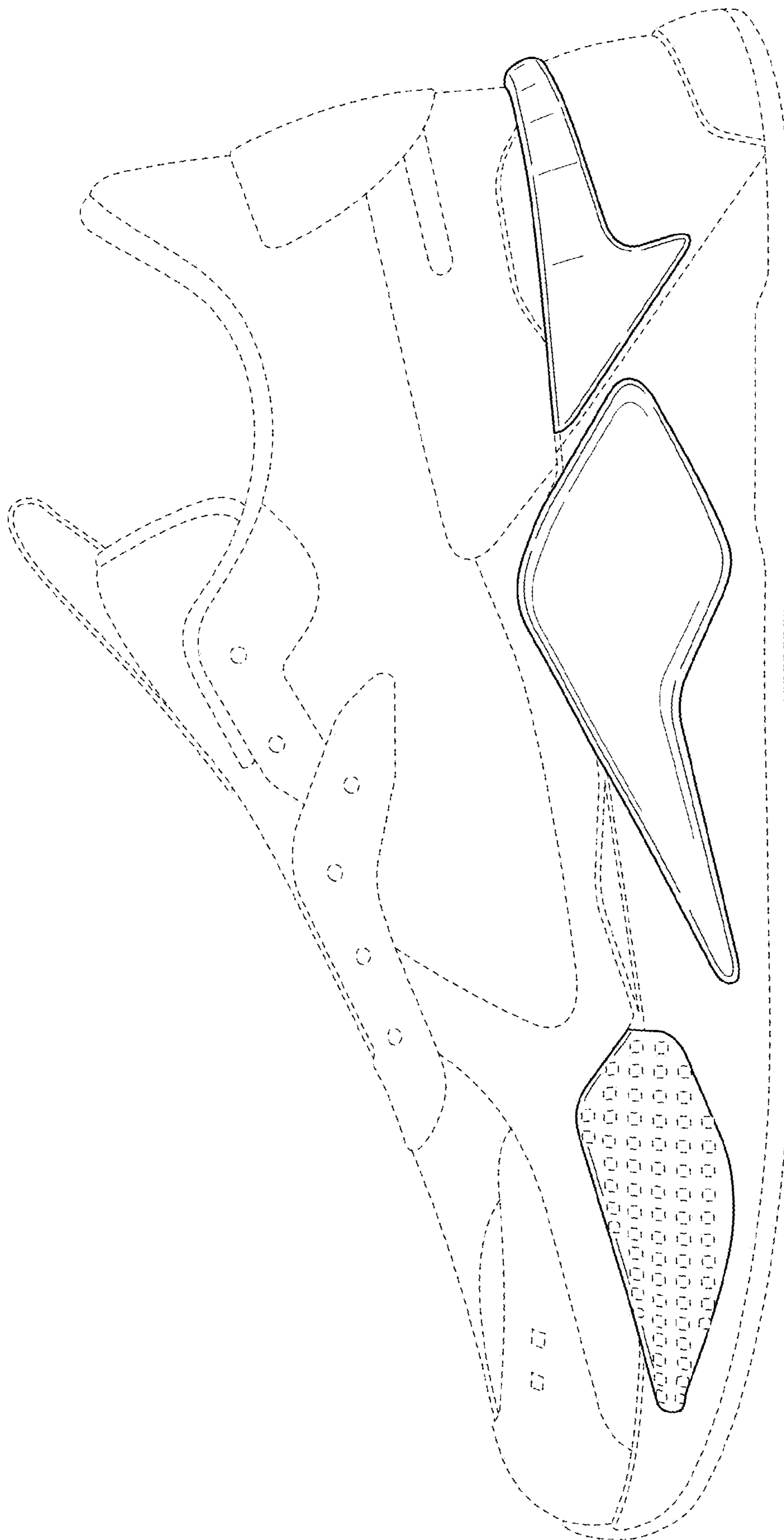

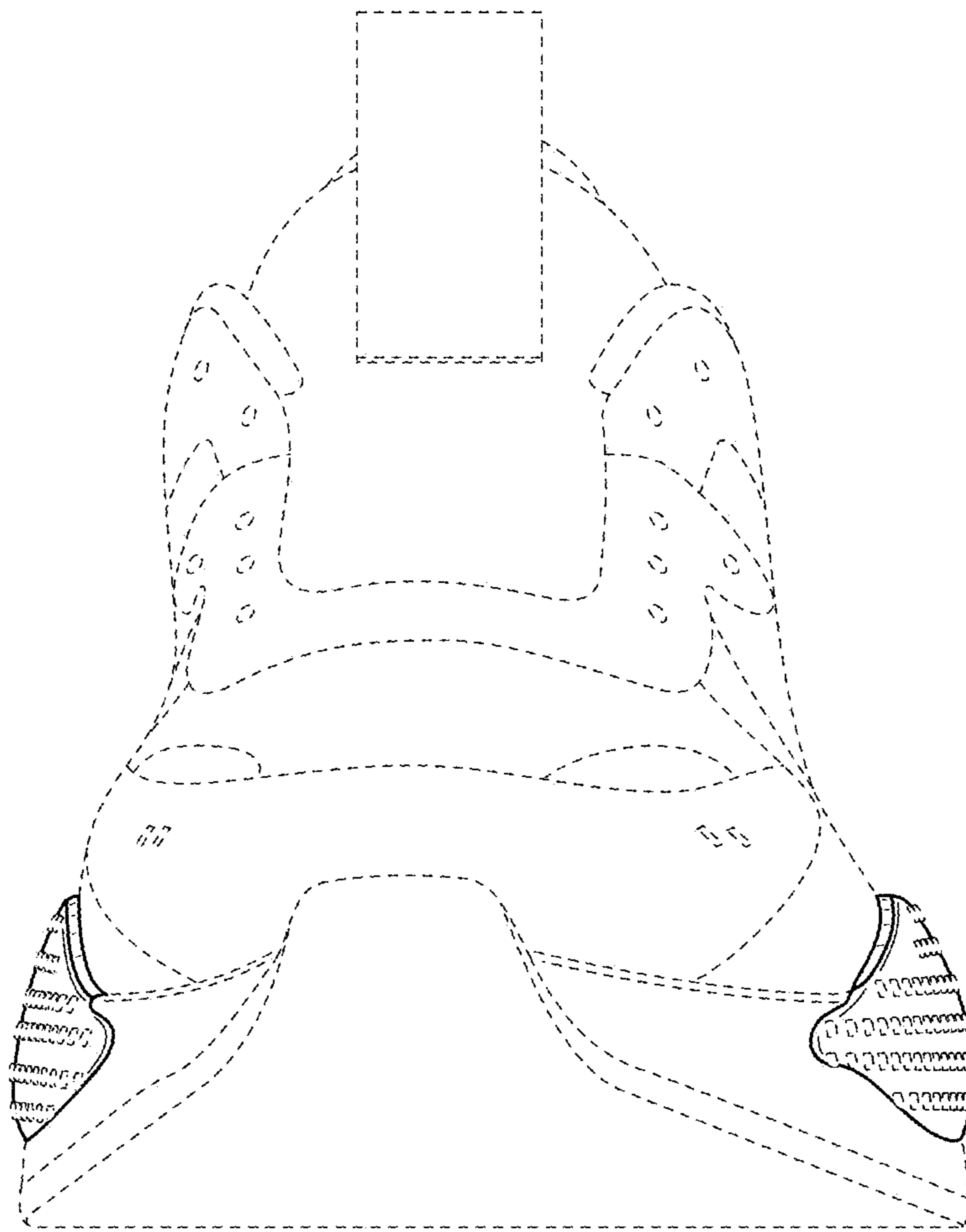

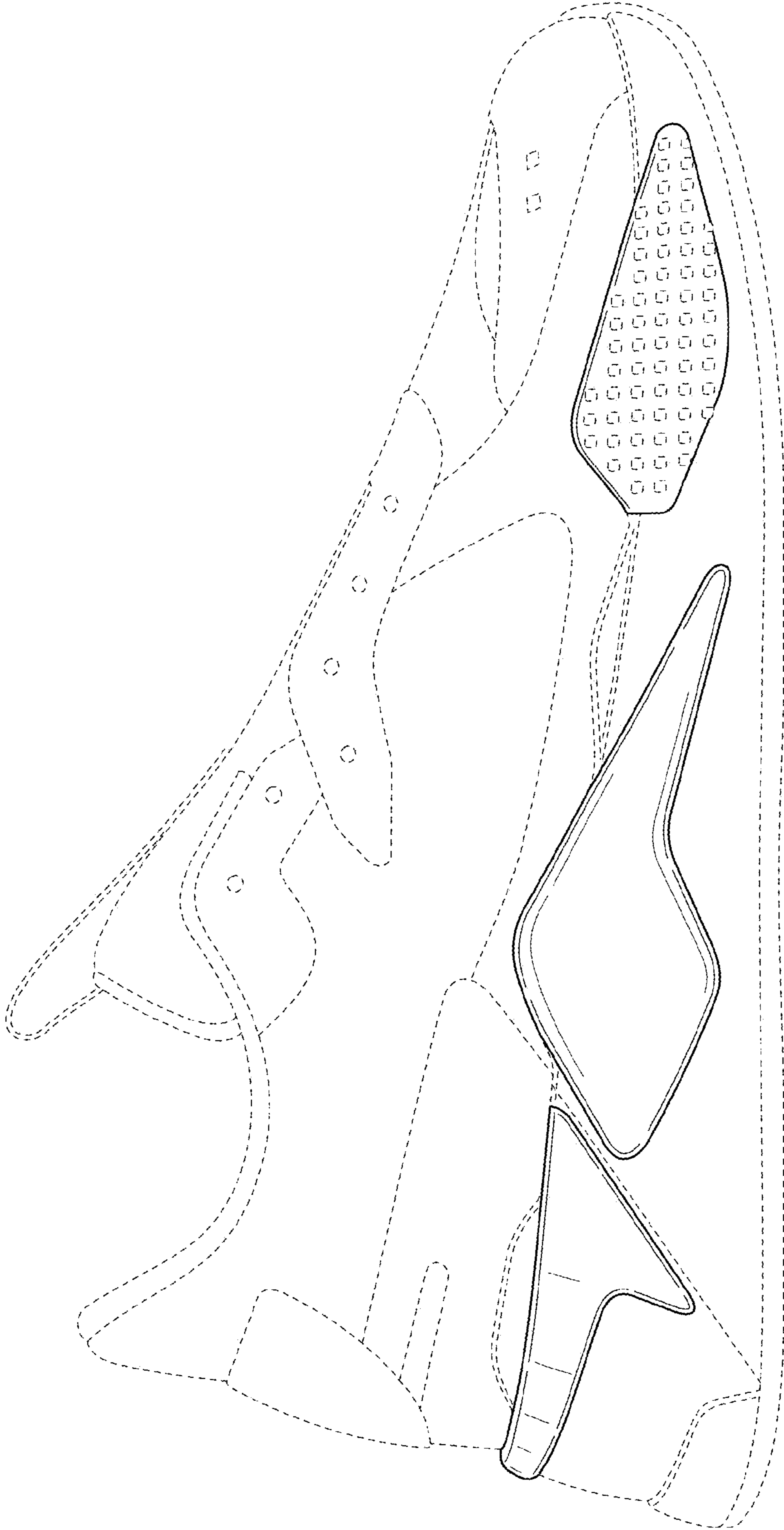

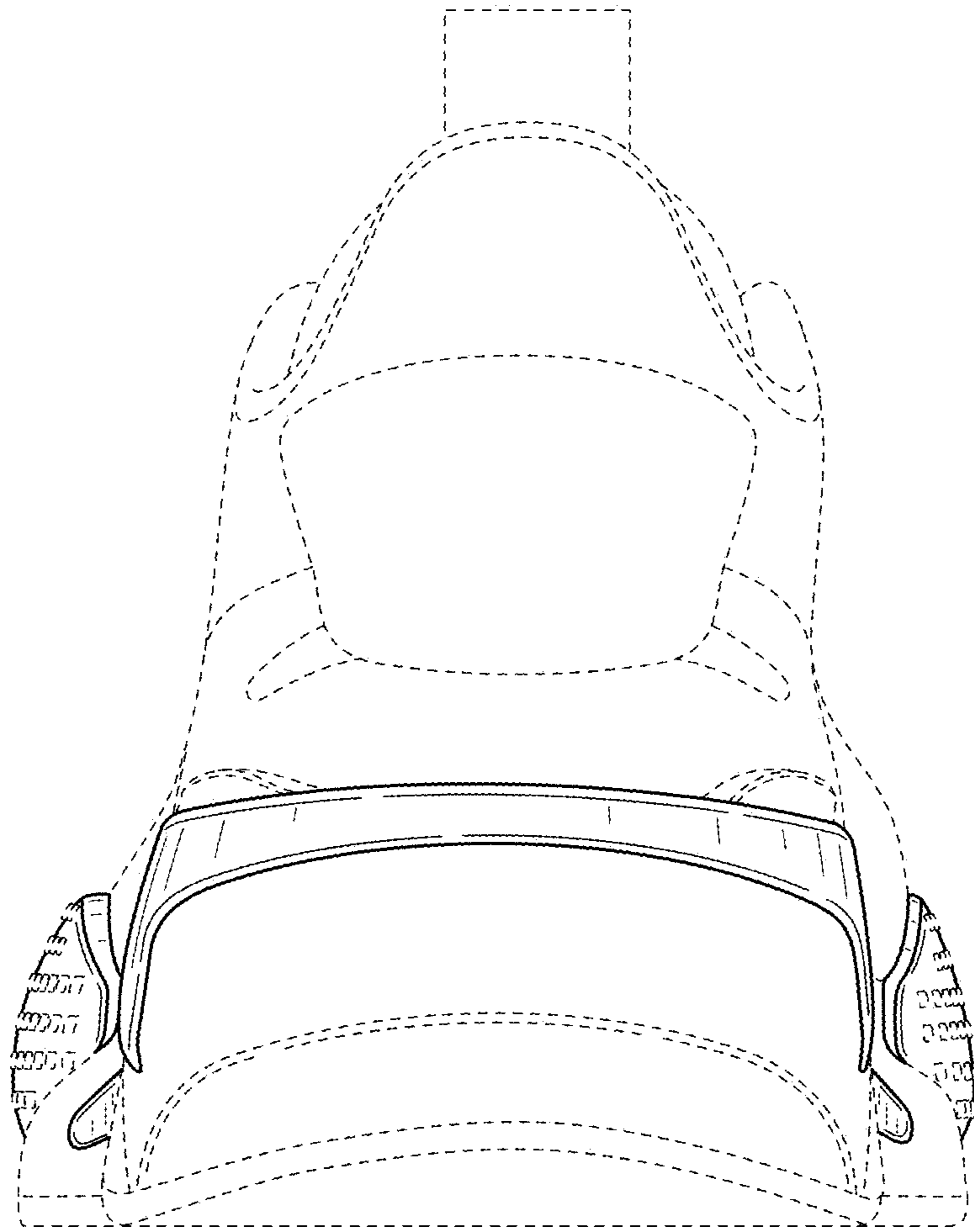

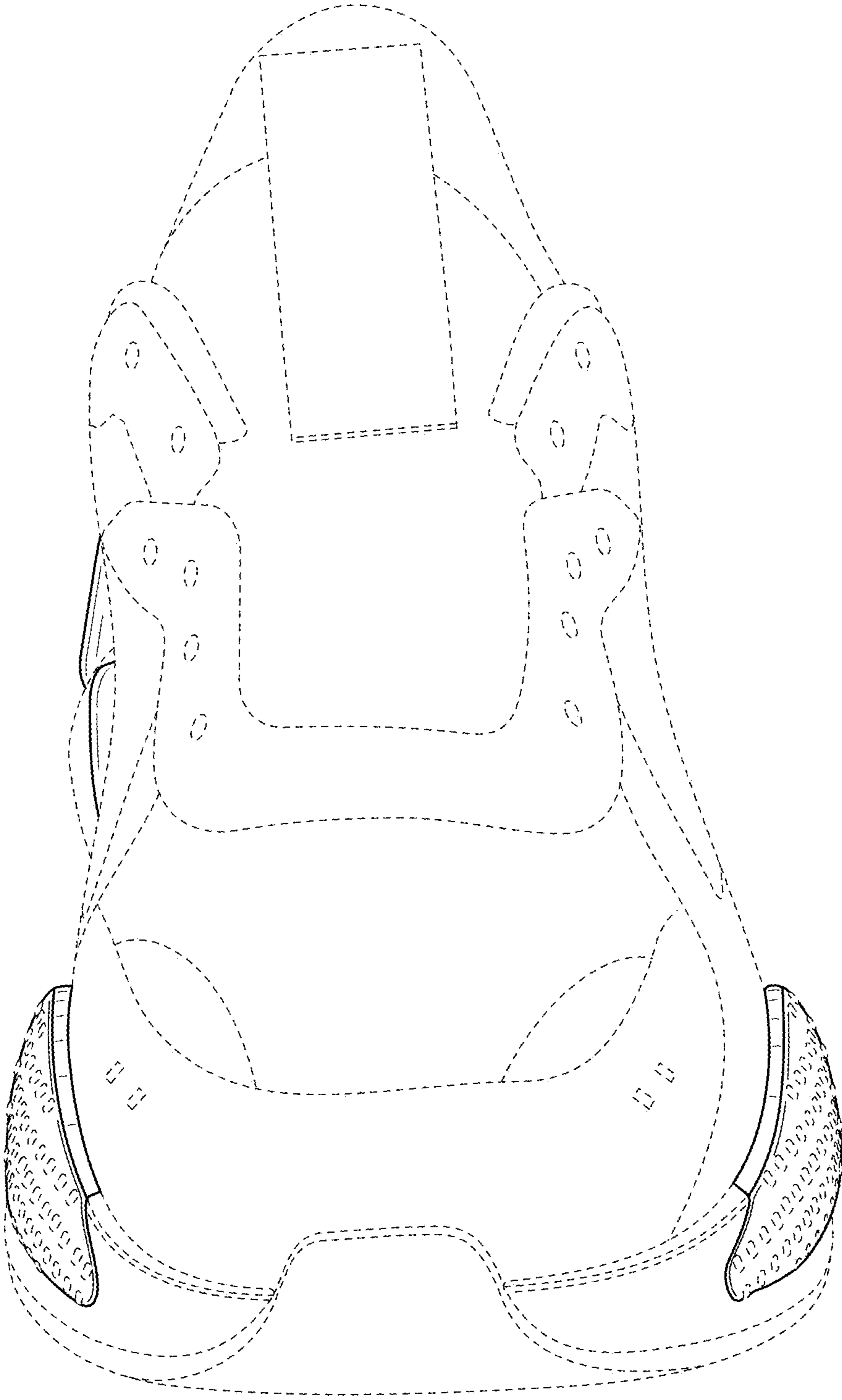

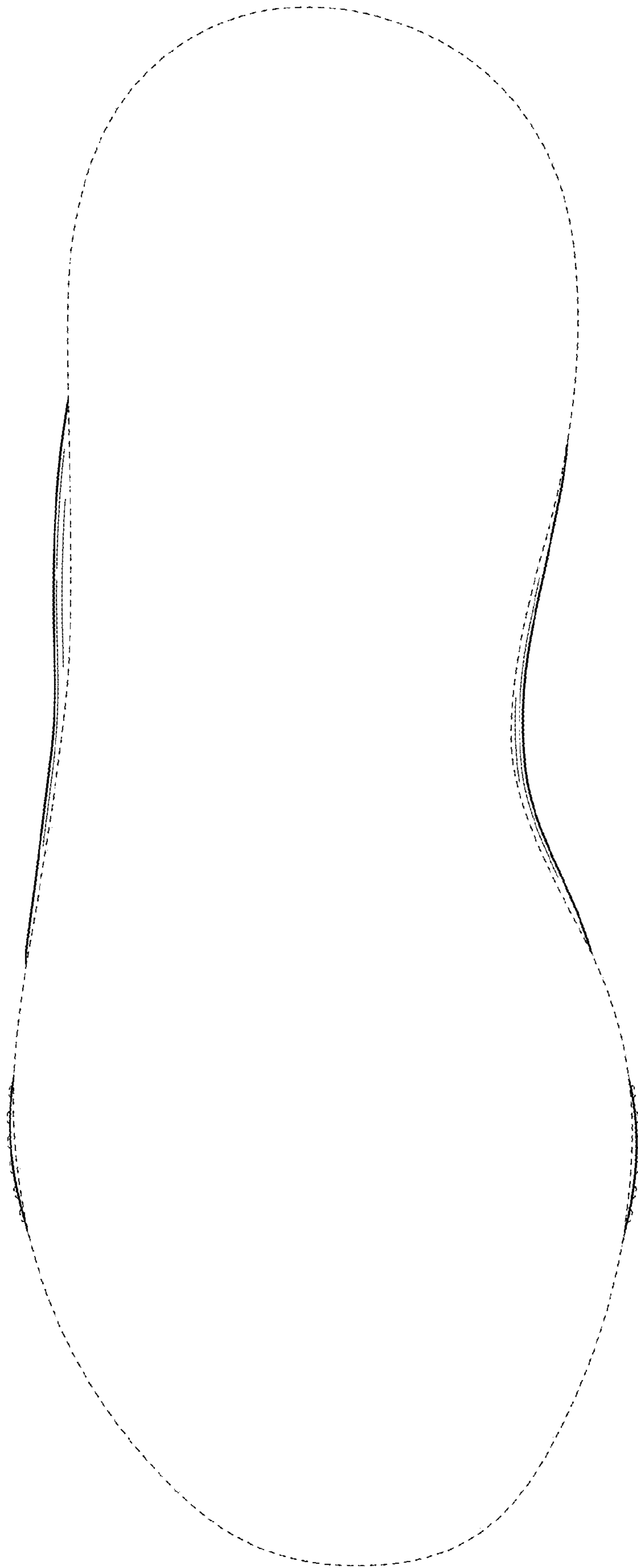

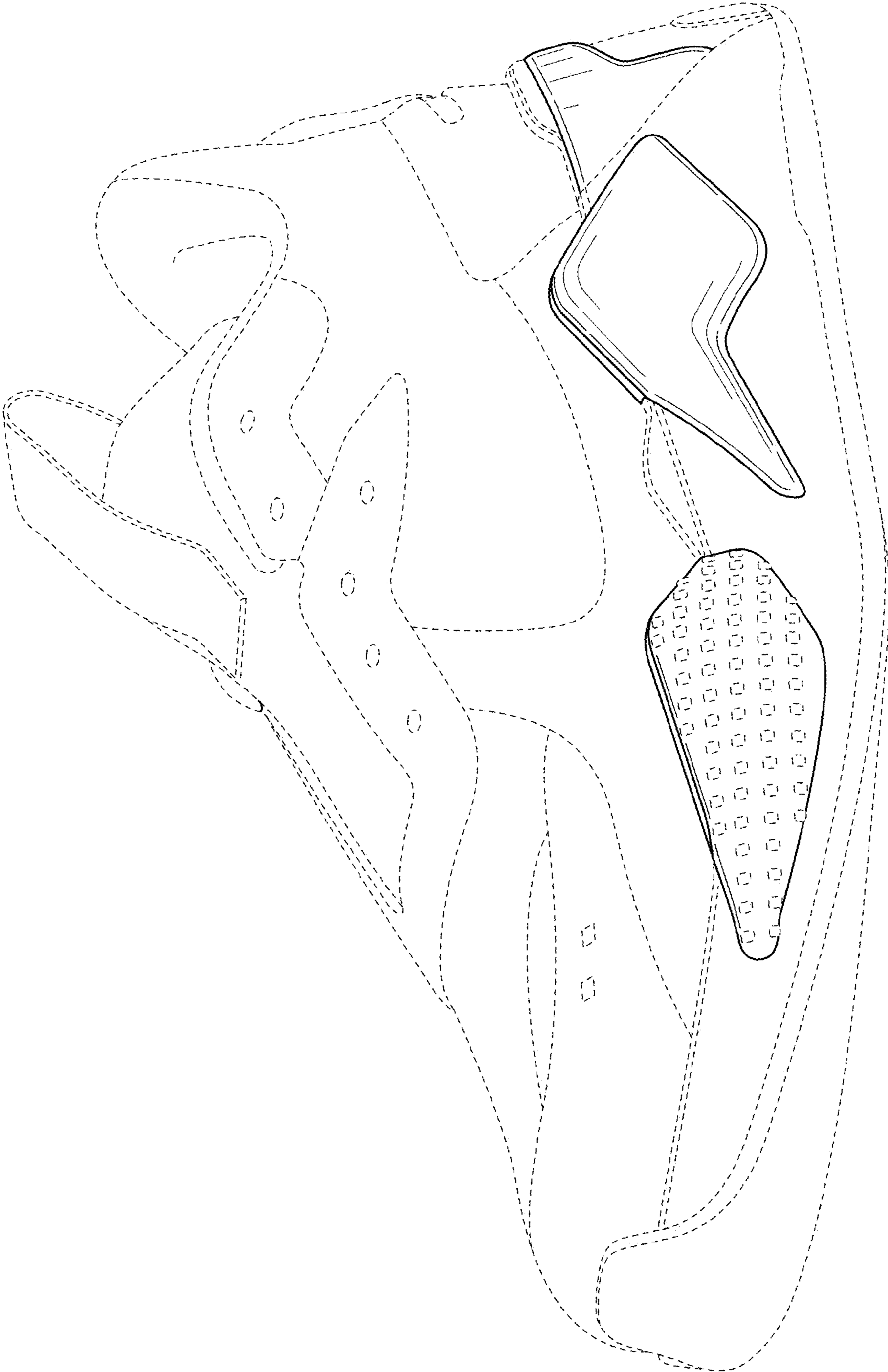

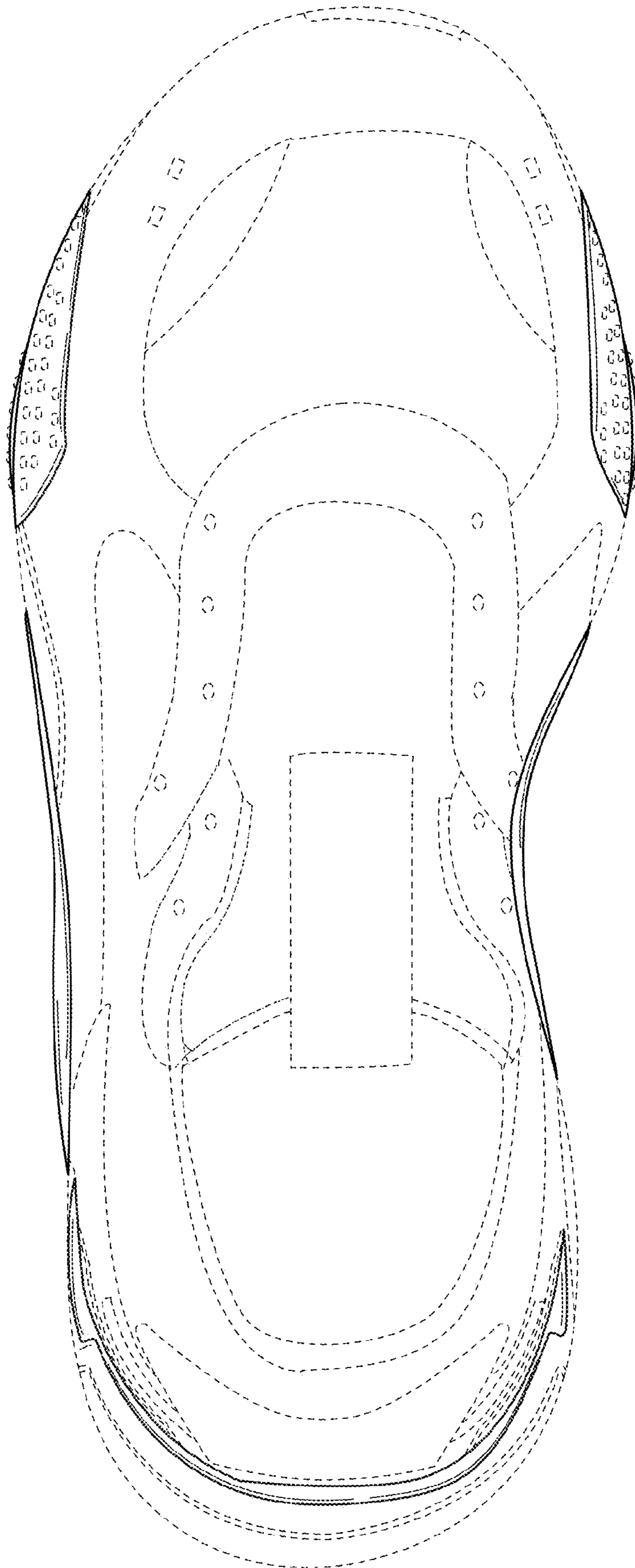
