I claim the ornamental design for a sole for footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sole for footwear in accordance with the new design.

FIG. 4 is left side view thereof.

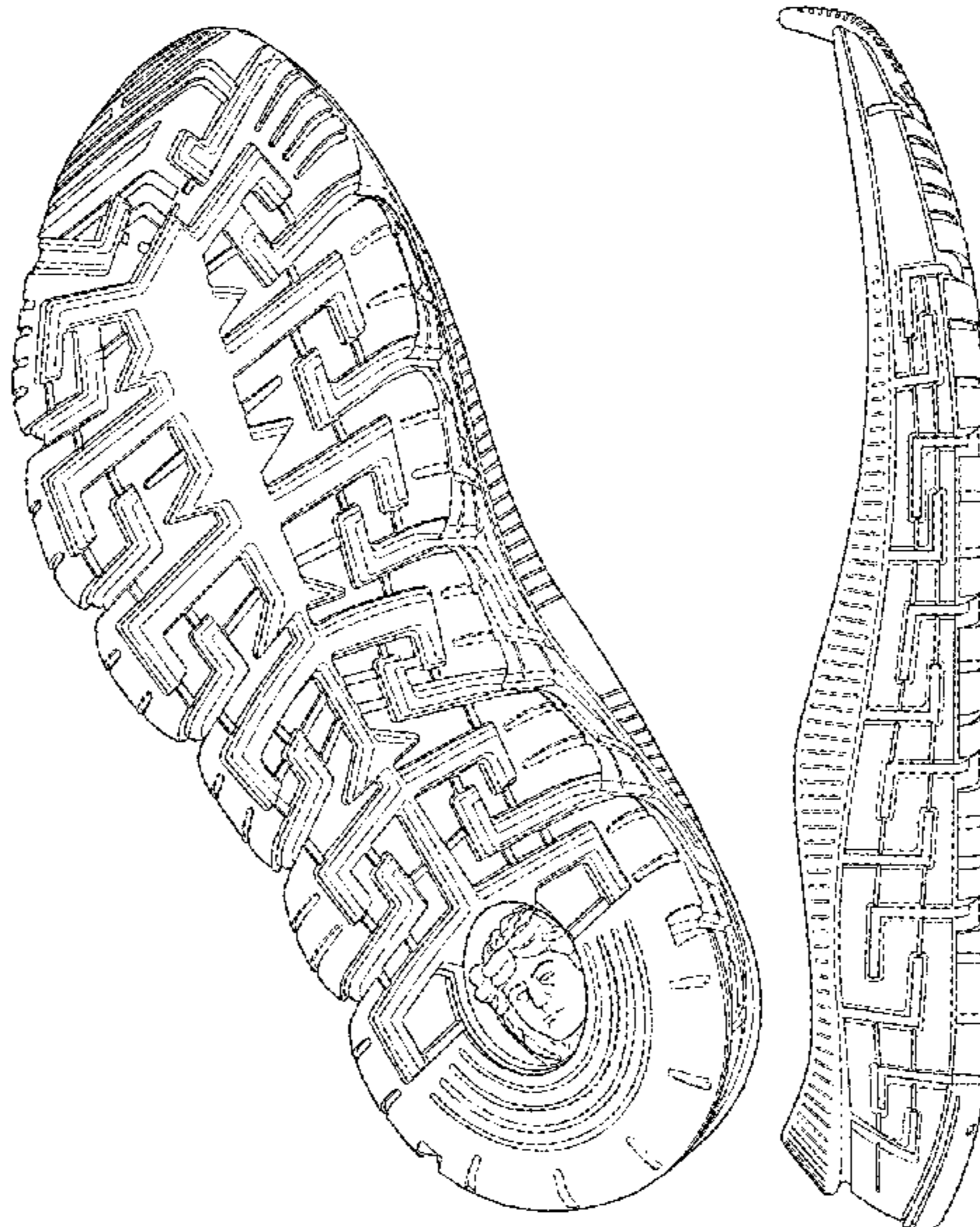
FIG. 5 is a right side view thereof.

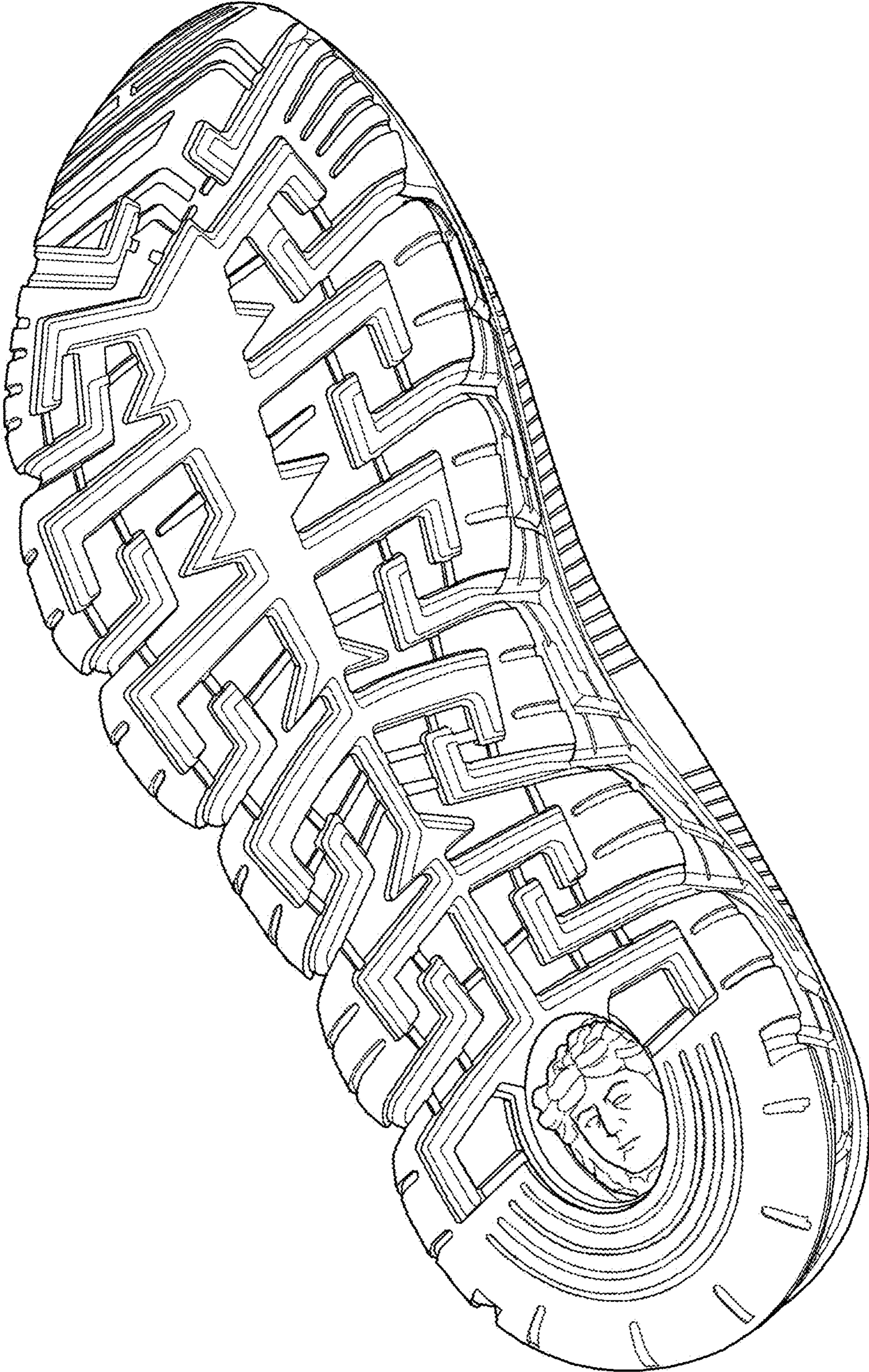

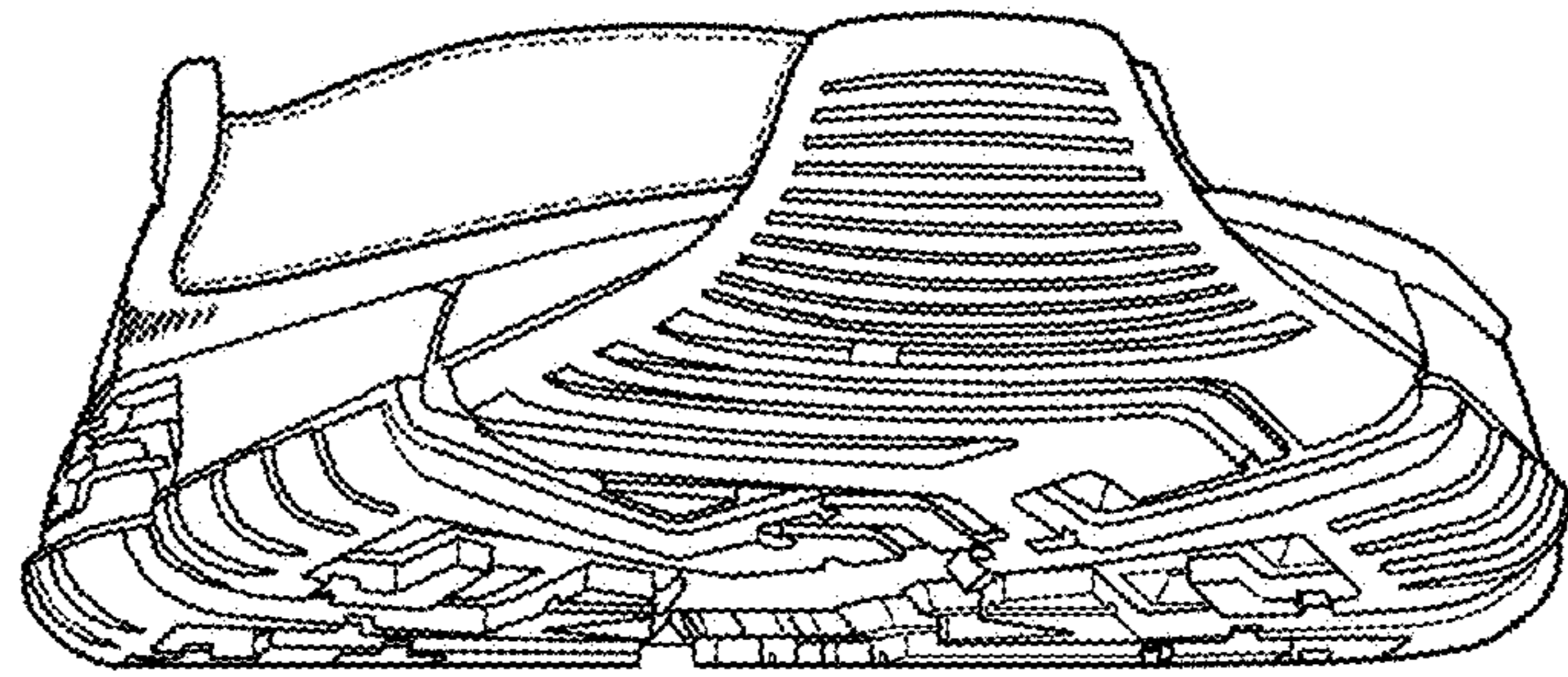

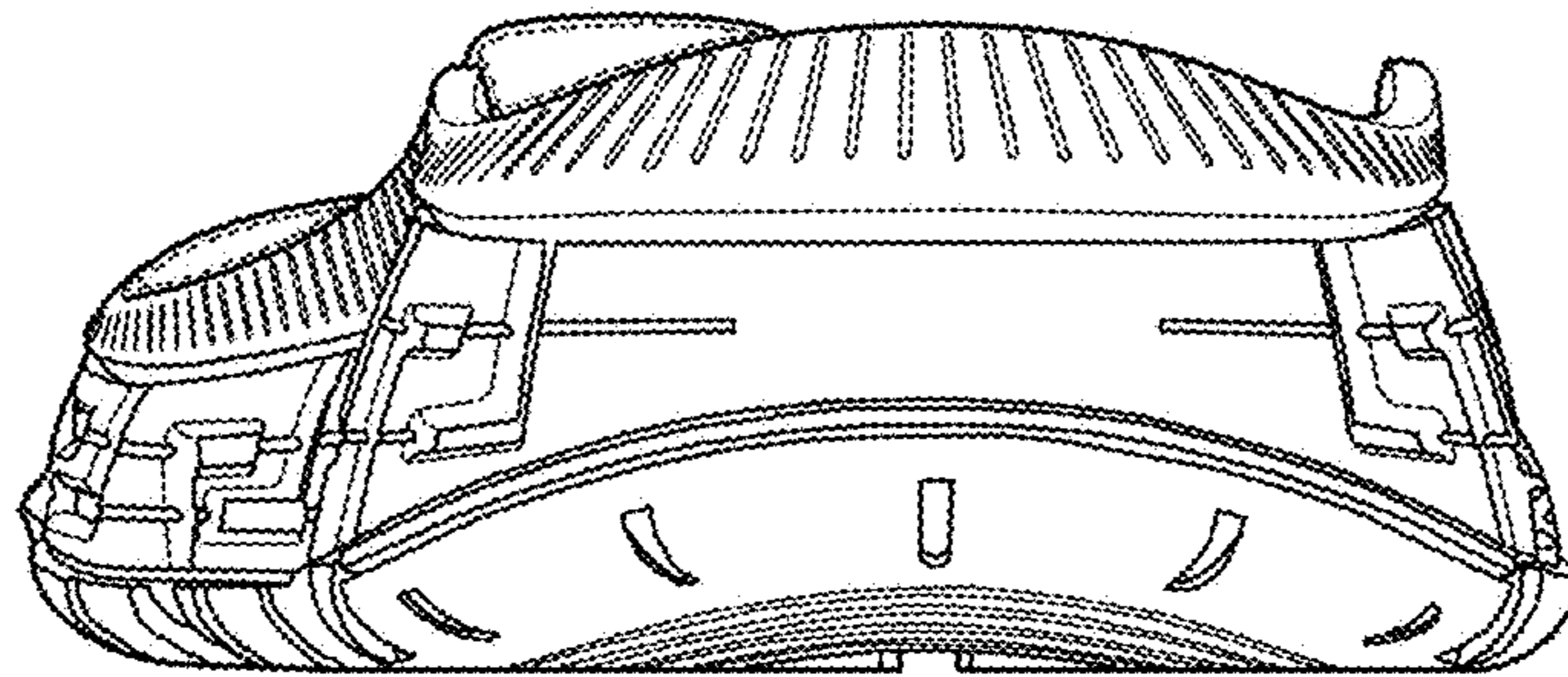

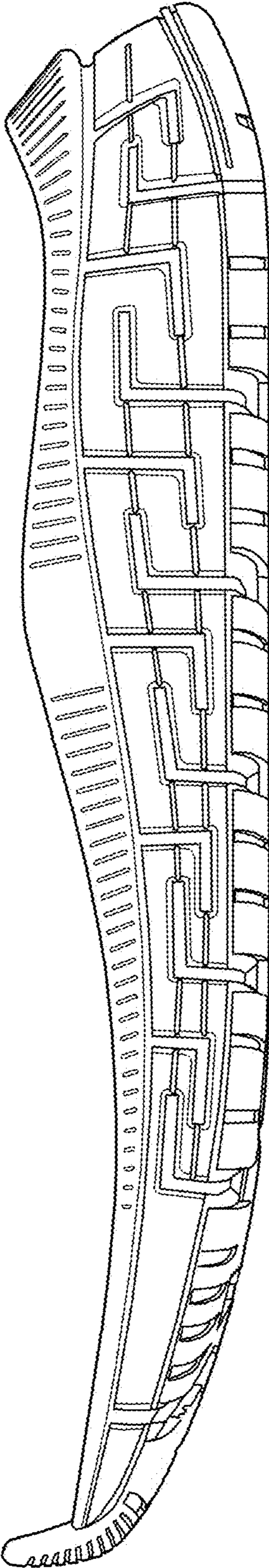

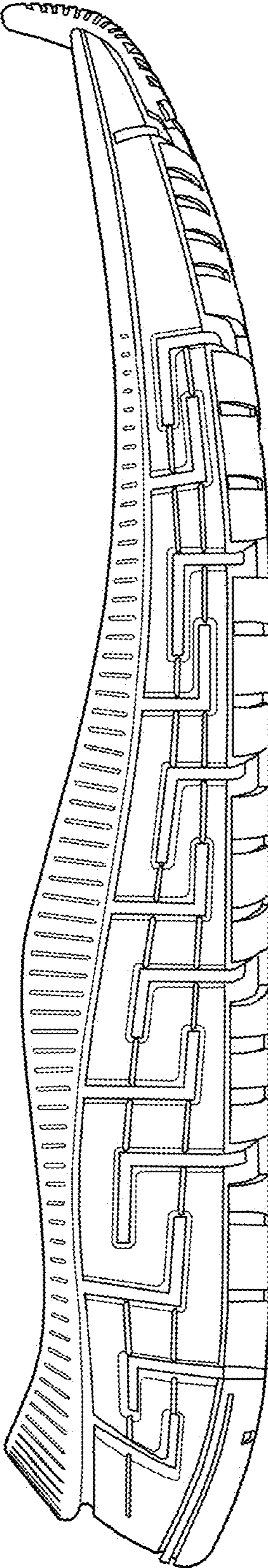

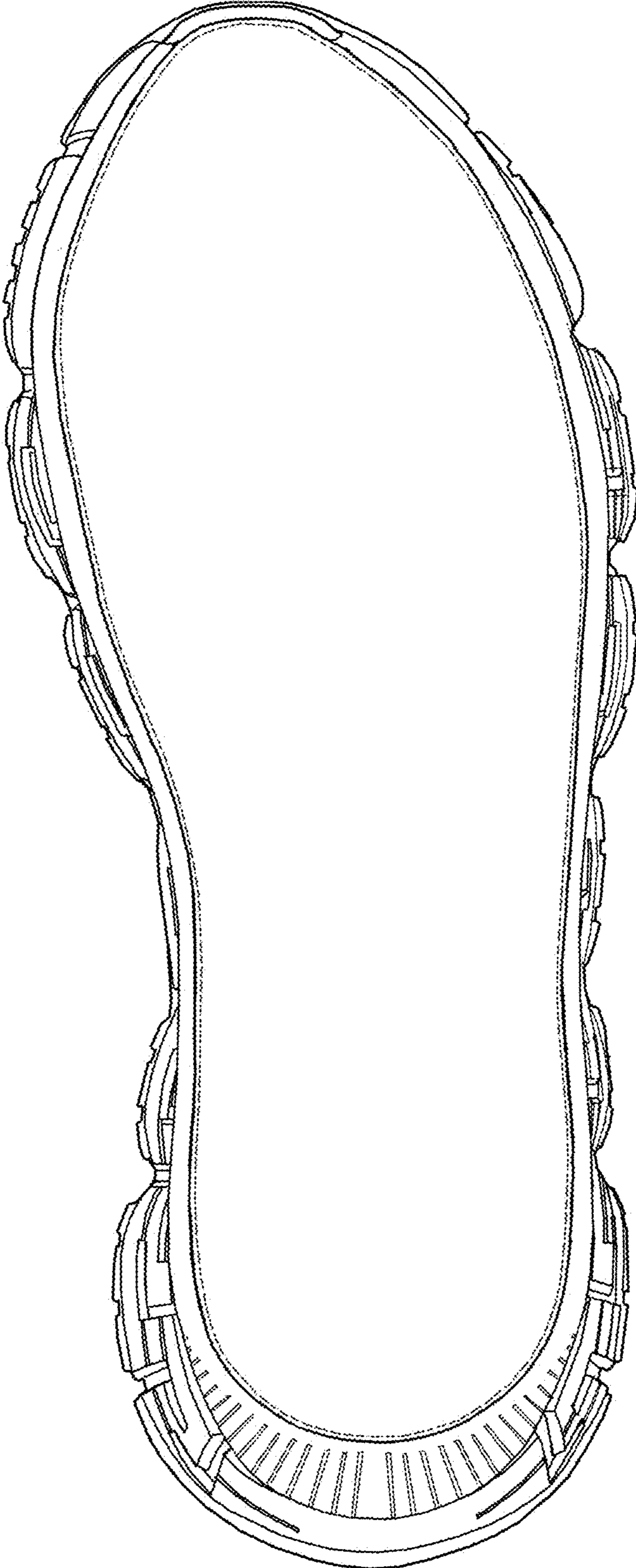

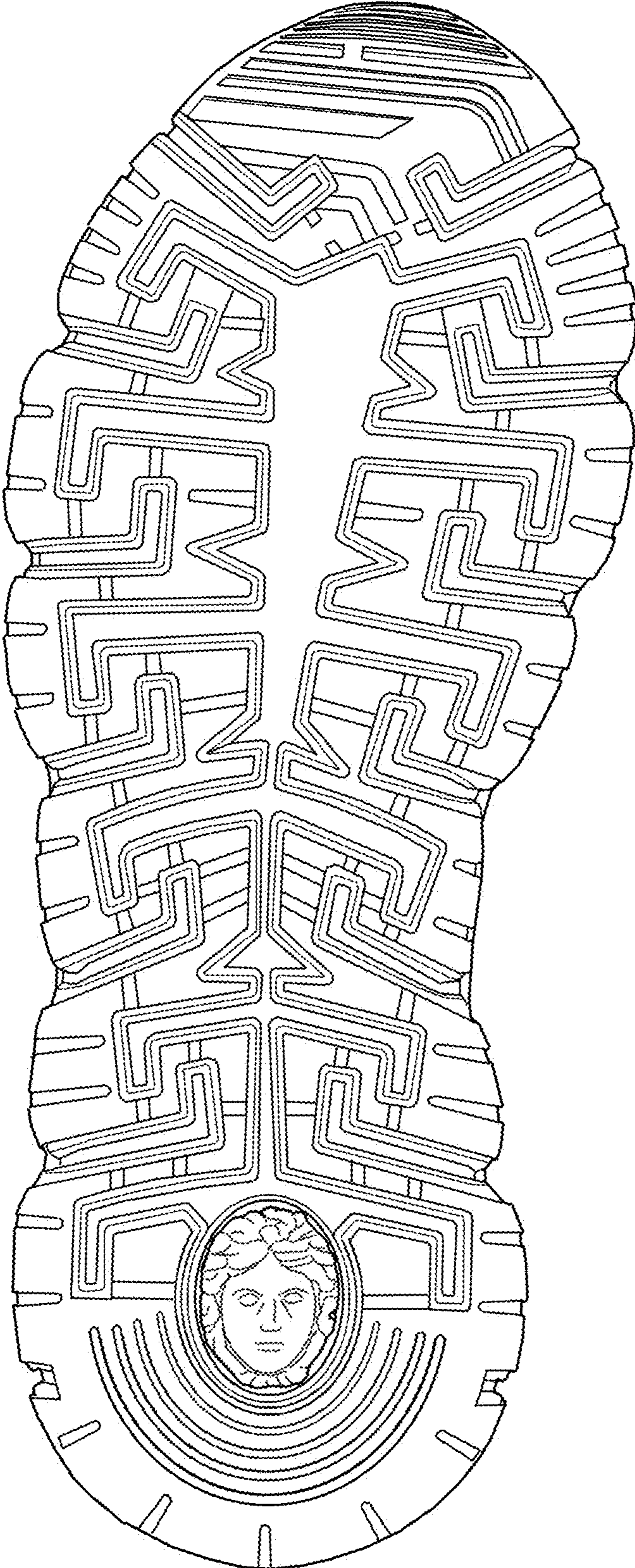
