(57) **CLAIM**

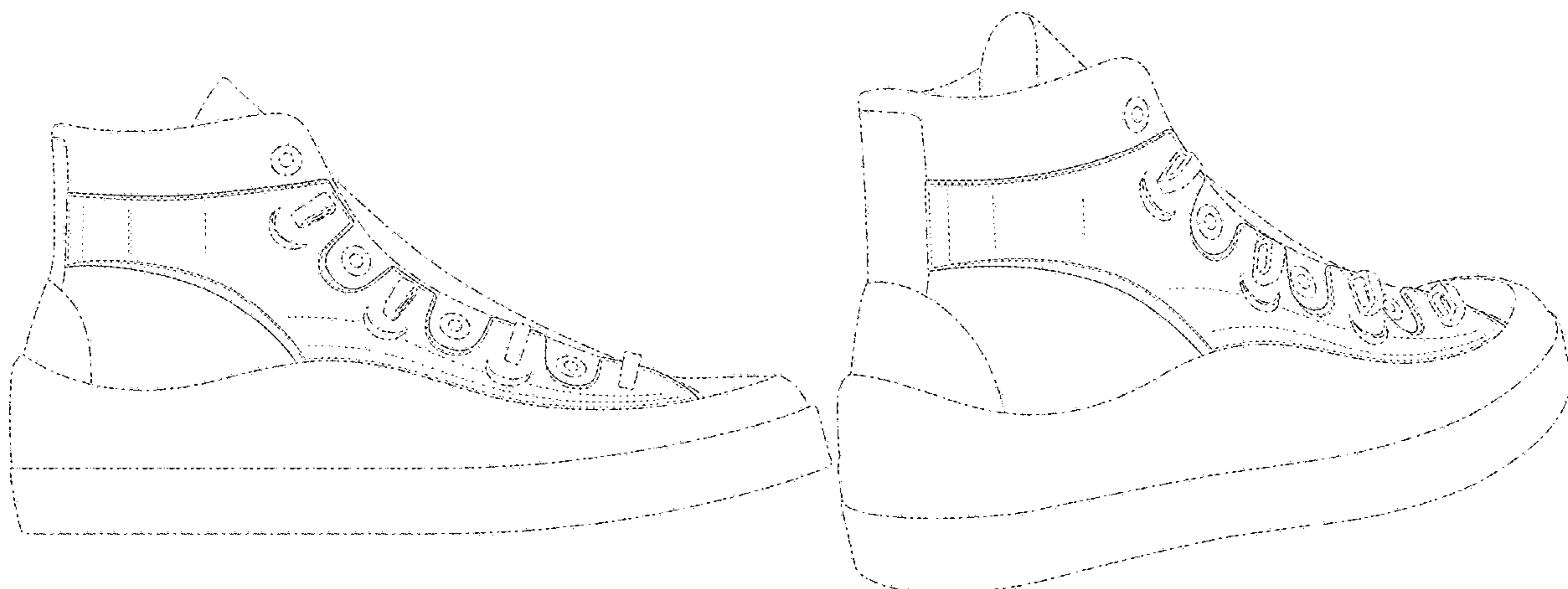
The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design;  
 FIG. 2 is a side view thereof;  
 FIG. 3 is a rear perspective view thereof;  
 FIG. 4 is a front perspective view of a shoe showing an alternative embodiment of our new design;  
 FIG. 5 is a side view thereof; and,  
 FIG. 6 is a rear perspective view thereof.

The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The oblique shade lines in FIGS. 4-6 represent a translucent or transparent appearance. The broken lines depicting the lacing elements form no part of the claimed design. The broken lines depicting the three quarter-moon-shaped regions form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

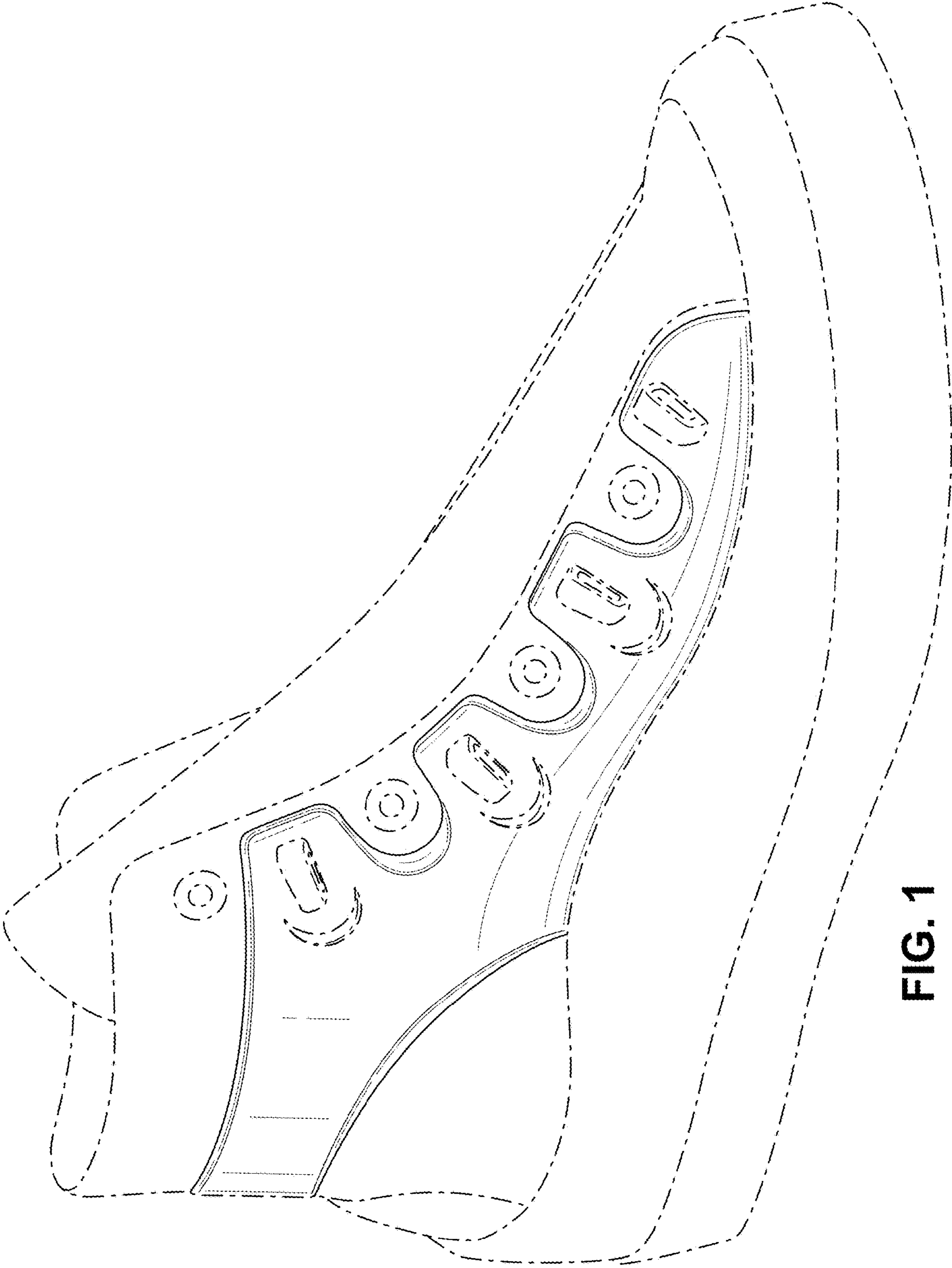

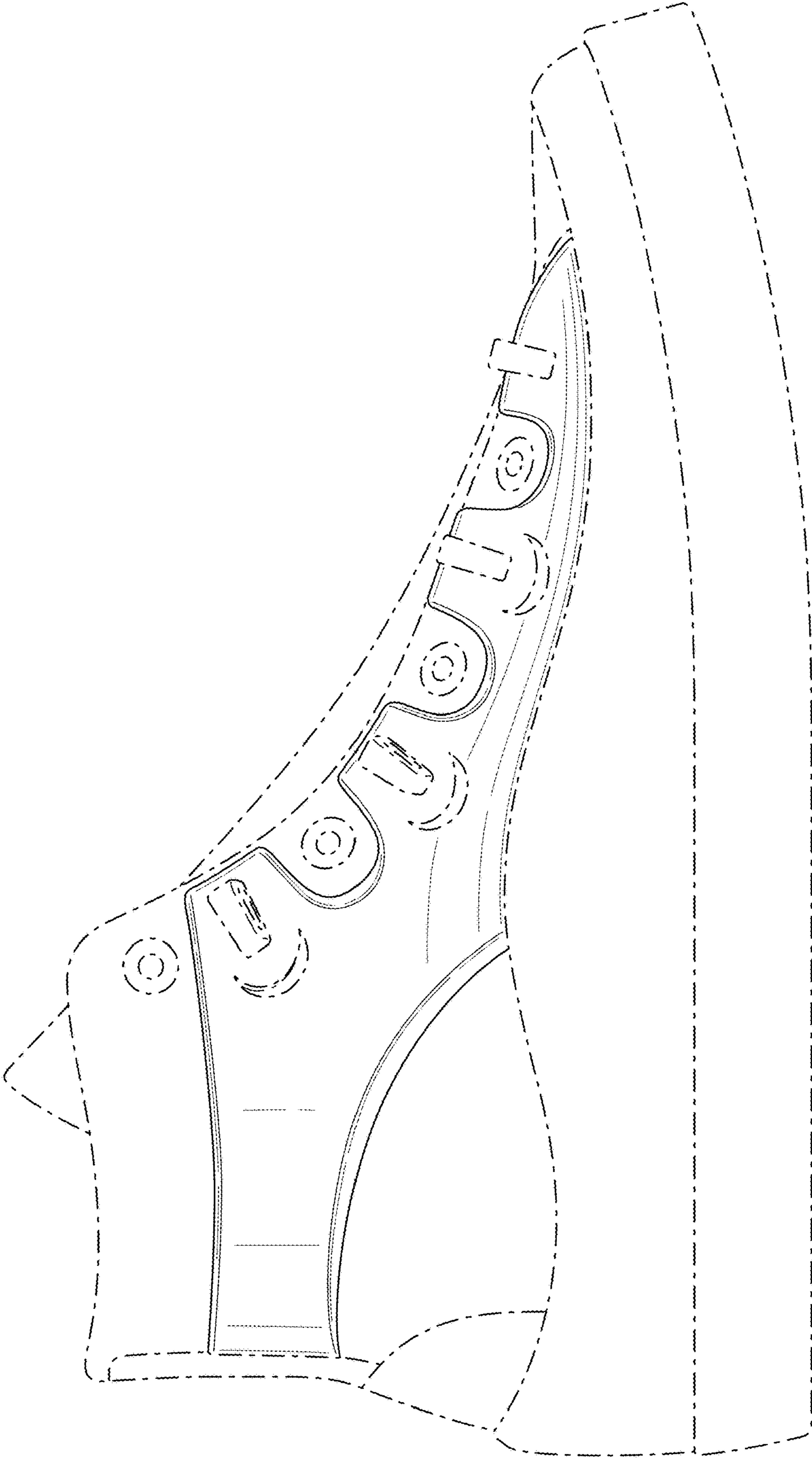

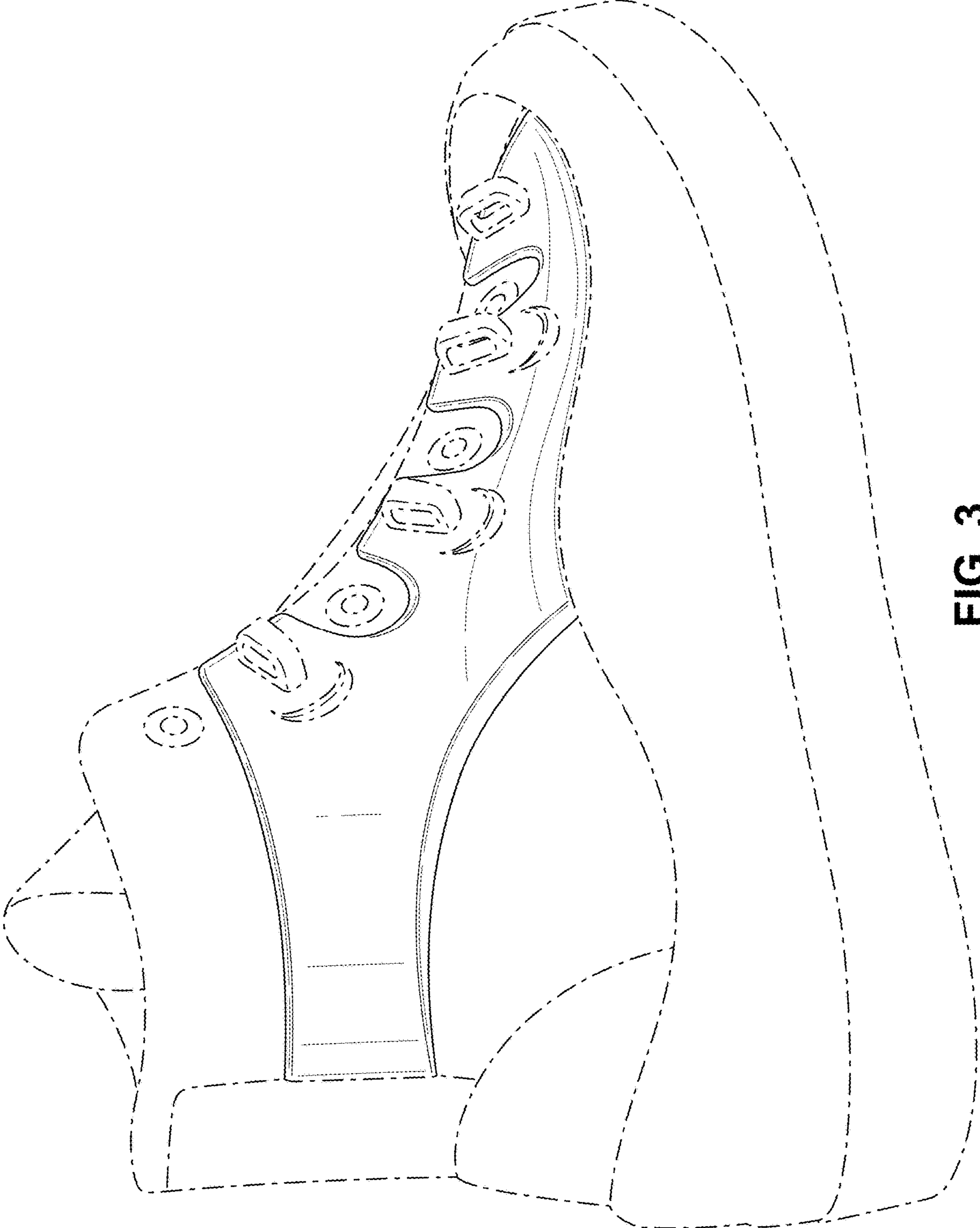

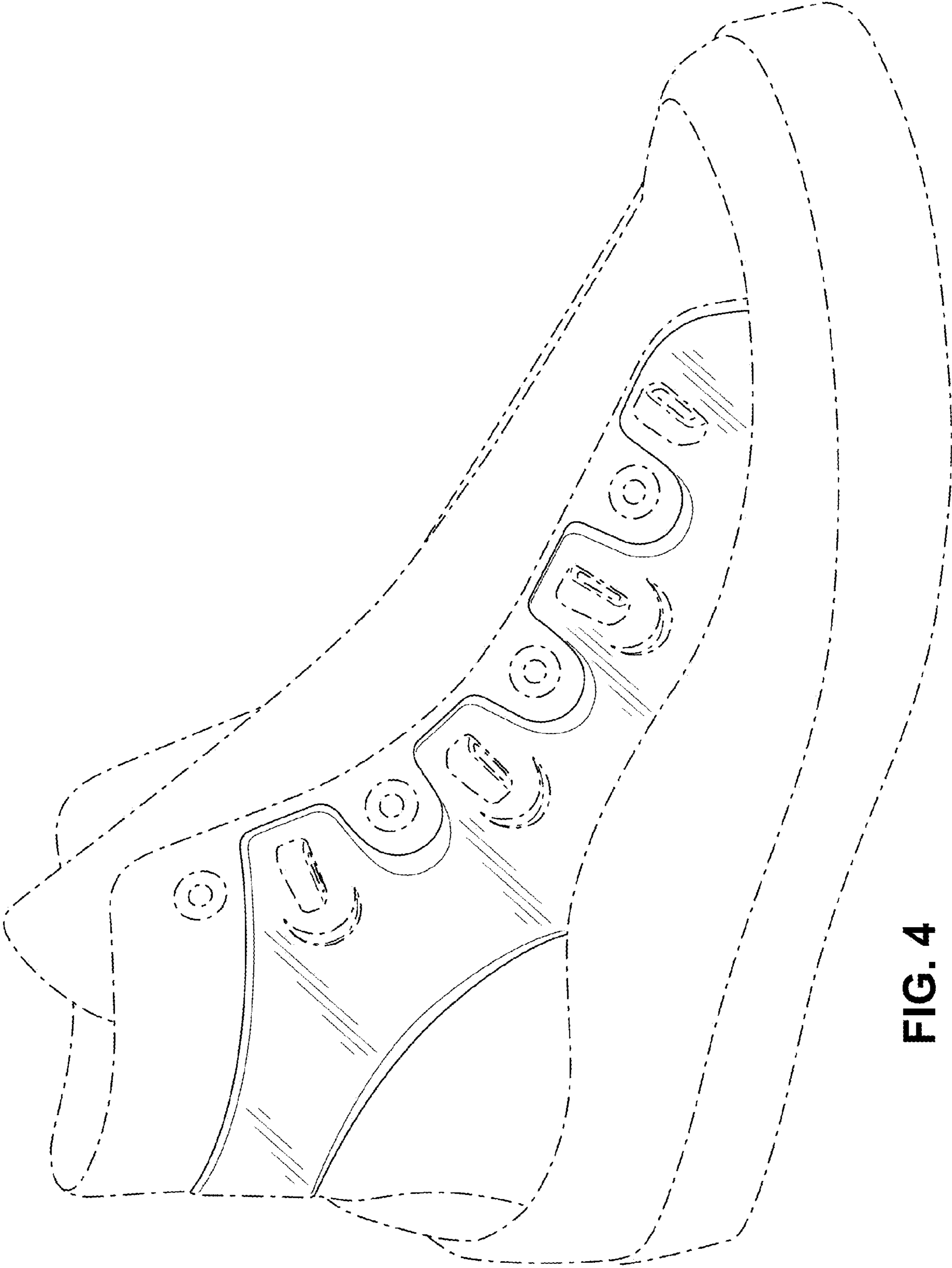

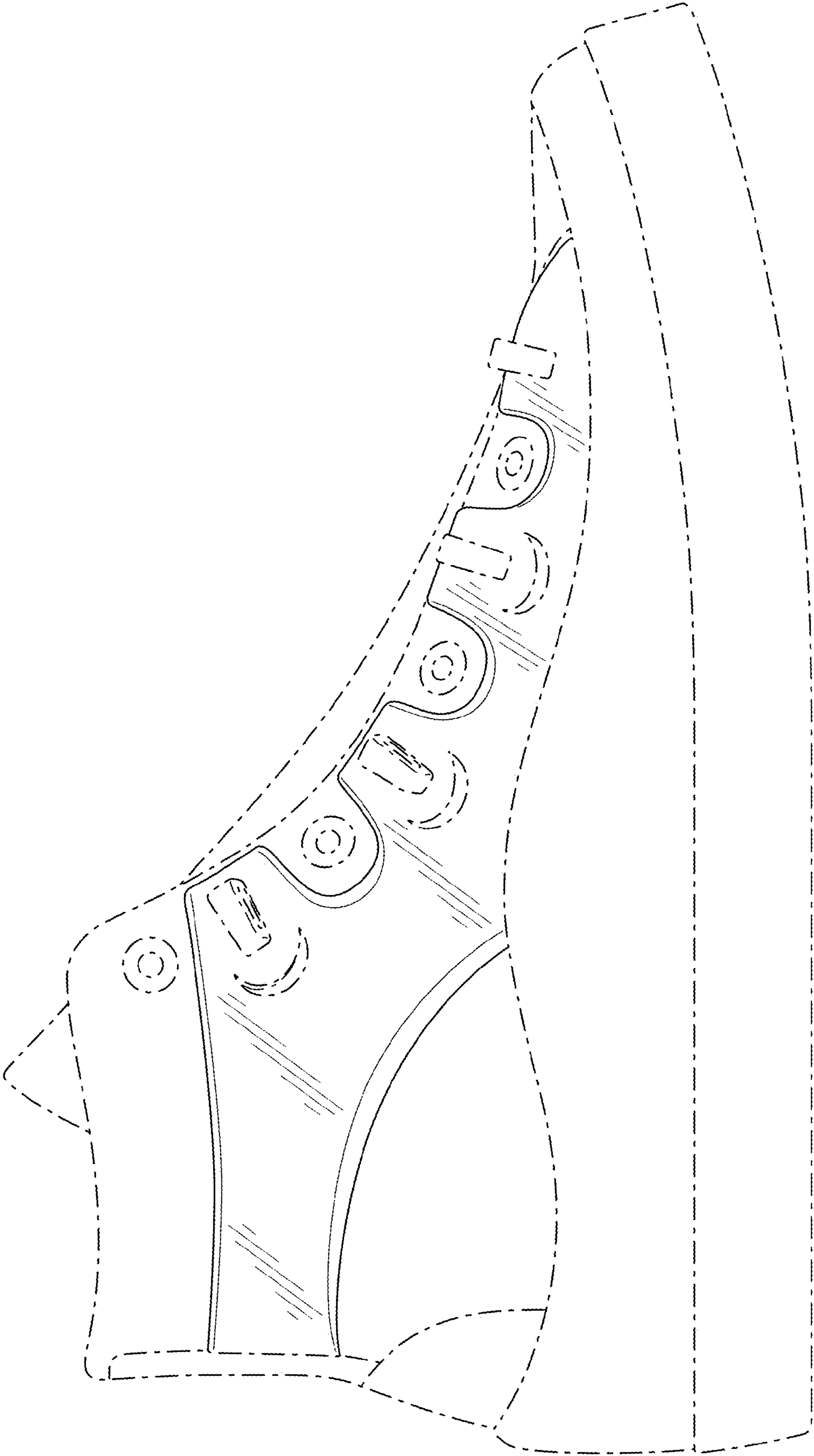

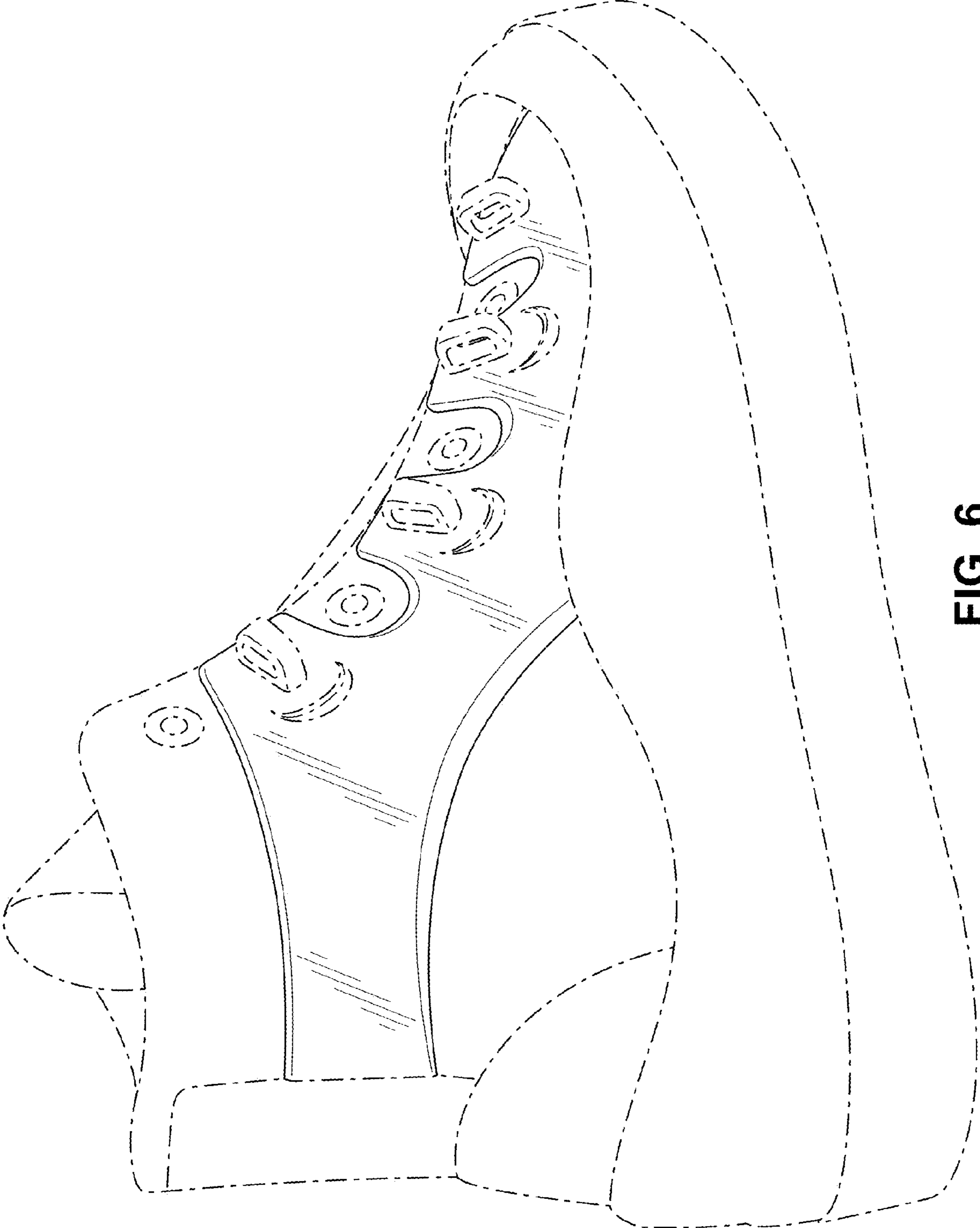
