The ornamental design for a bag with weave pattern, as shown and described.

DESCRIPTION

FIG. 15 is a front view of a third embodiment for a bag with weave pattern showing my new design;

FIG. 18 is left side view thereof with the disclaimed rear handle in a lowered position;

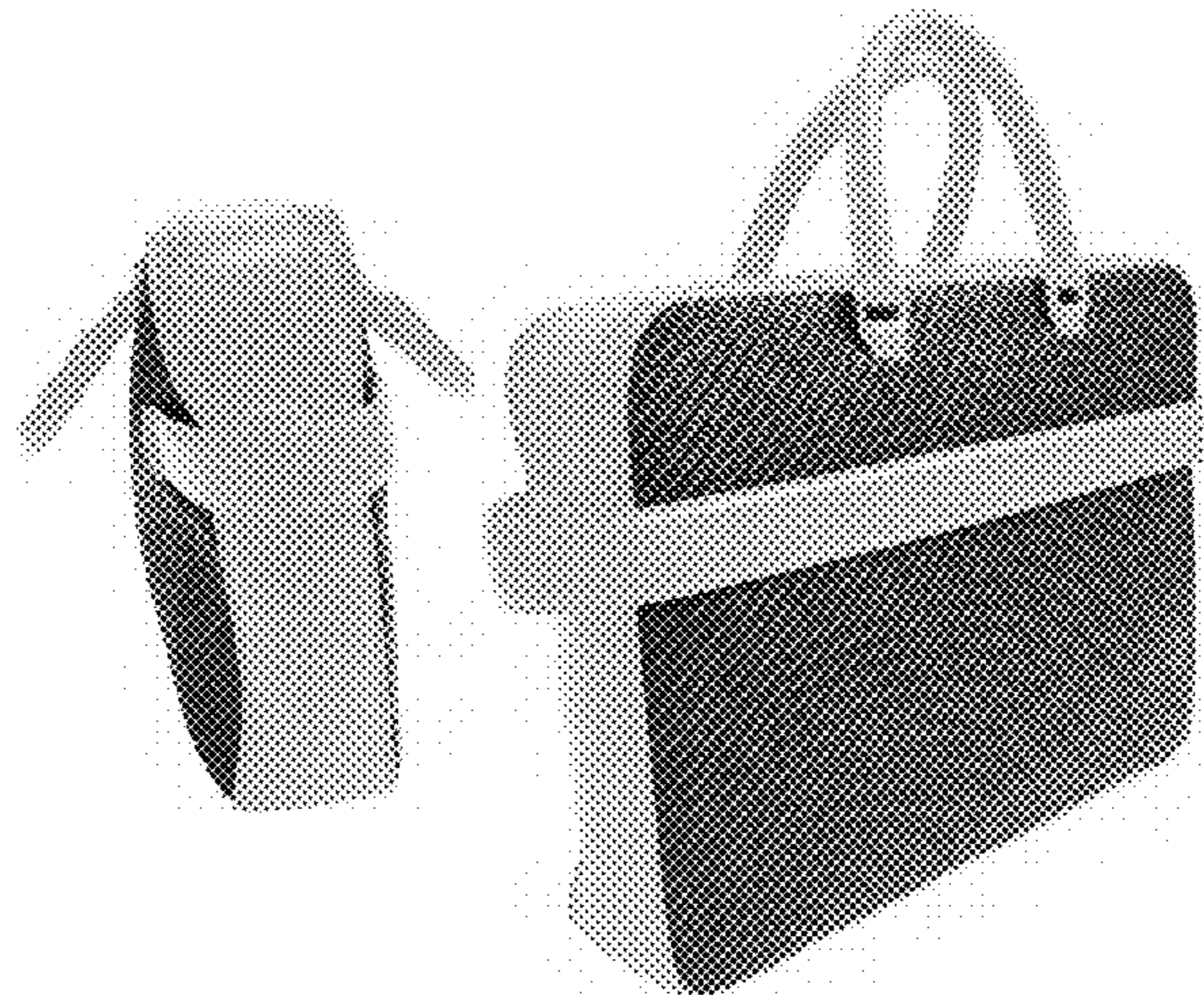
FIG. 19 is a right side view thereof with the disclaimed handles shown in a lowered position;

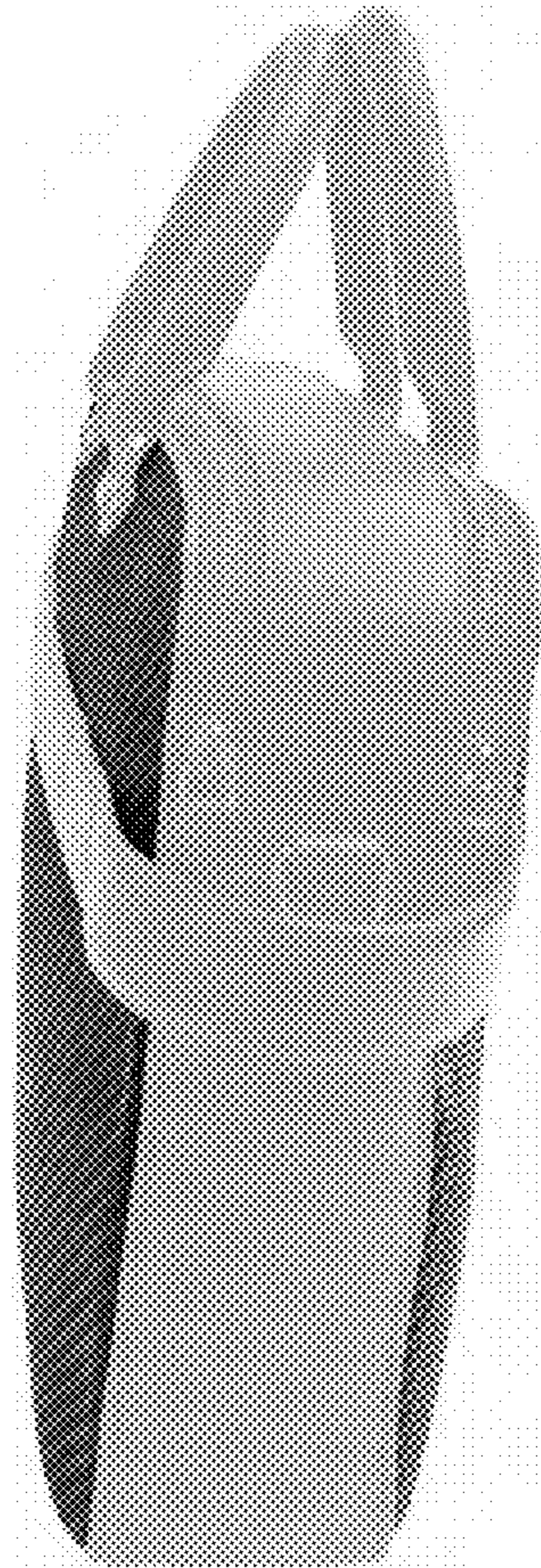

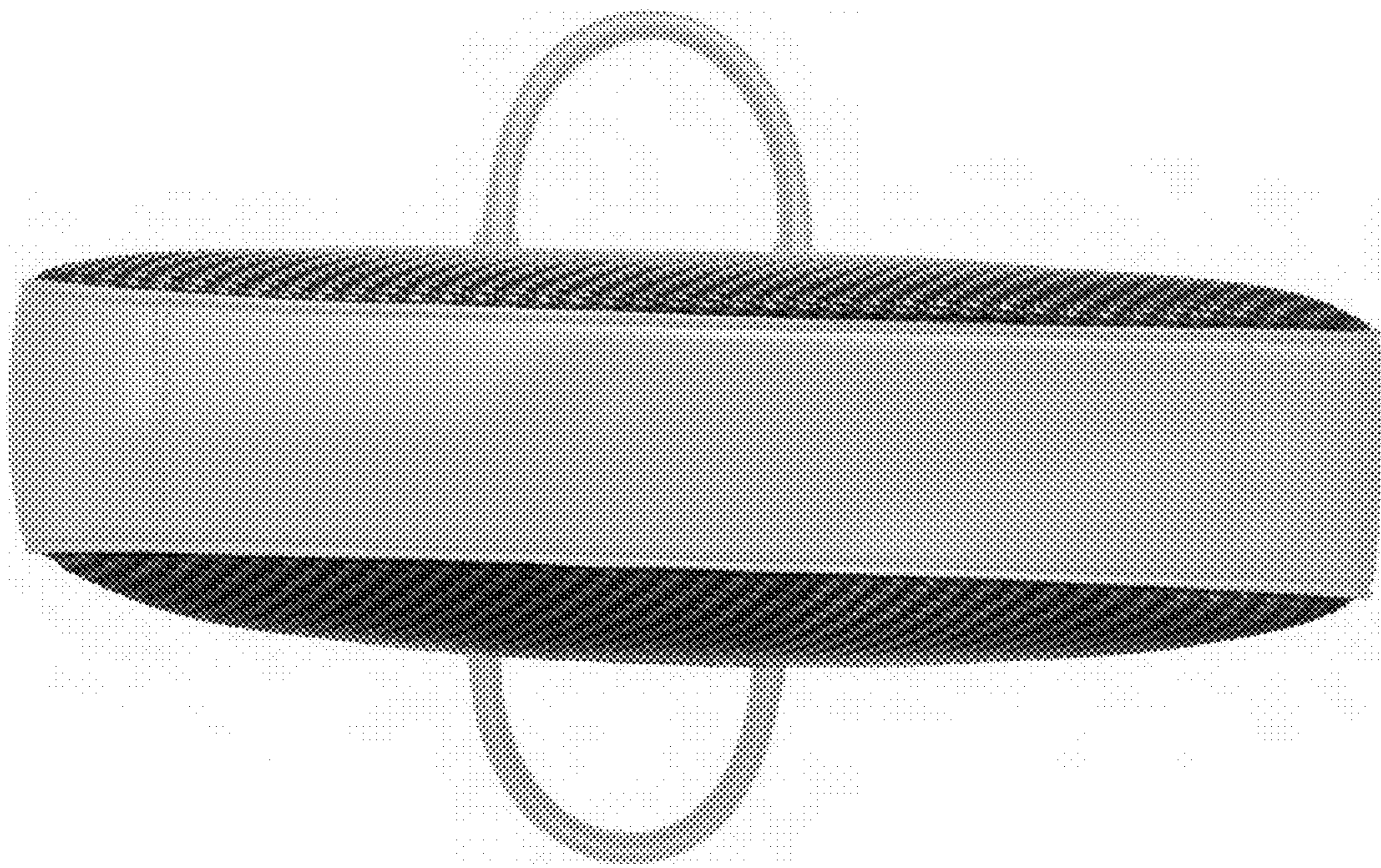

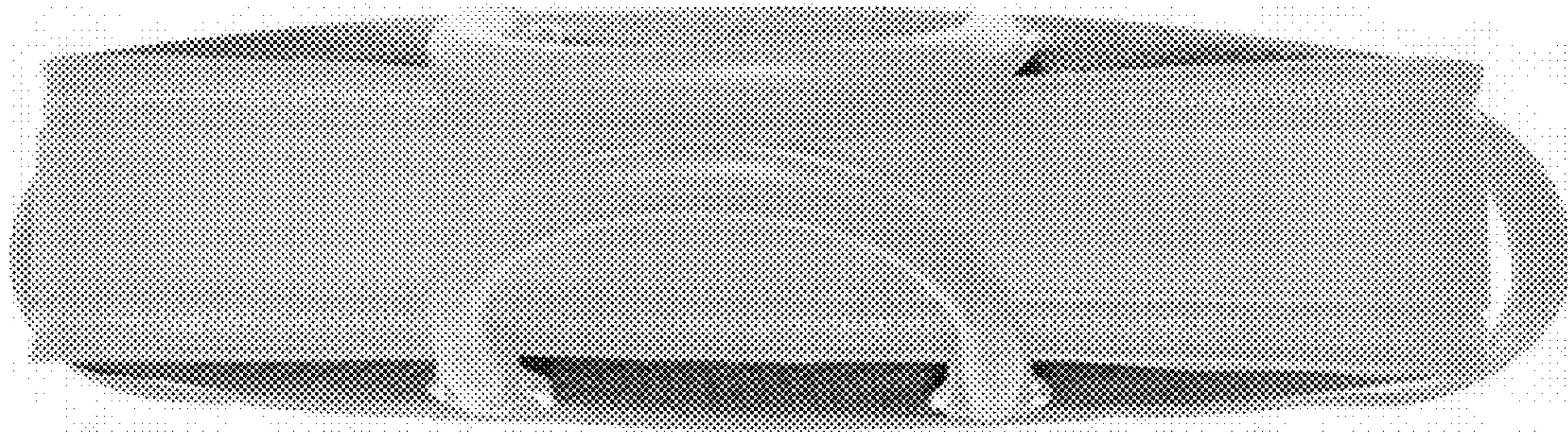

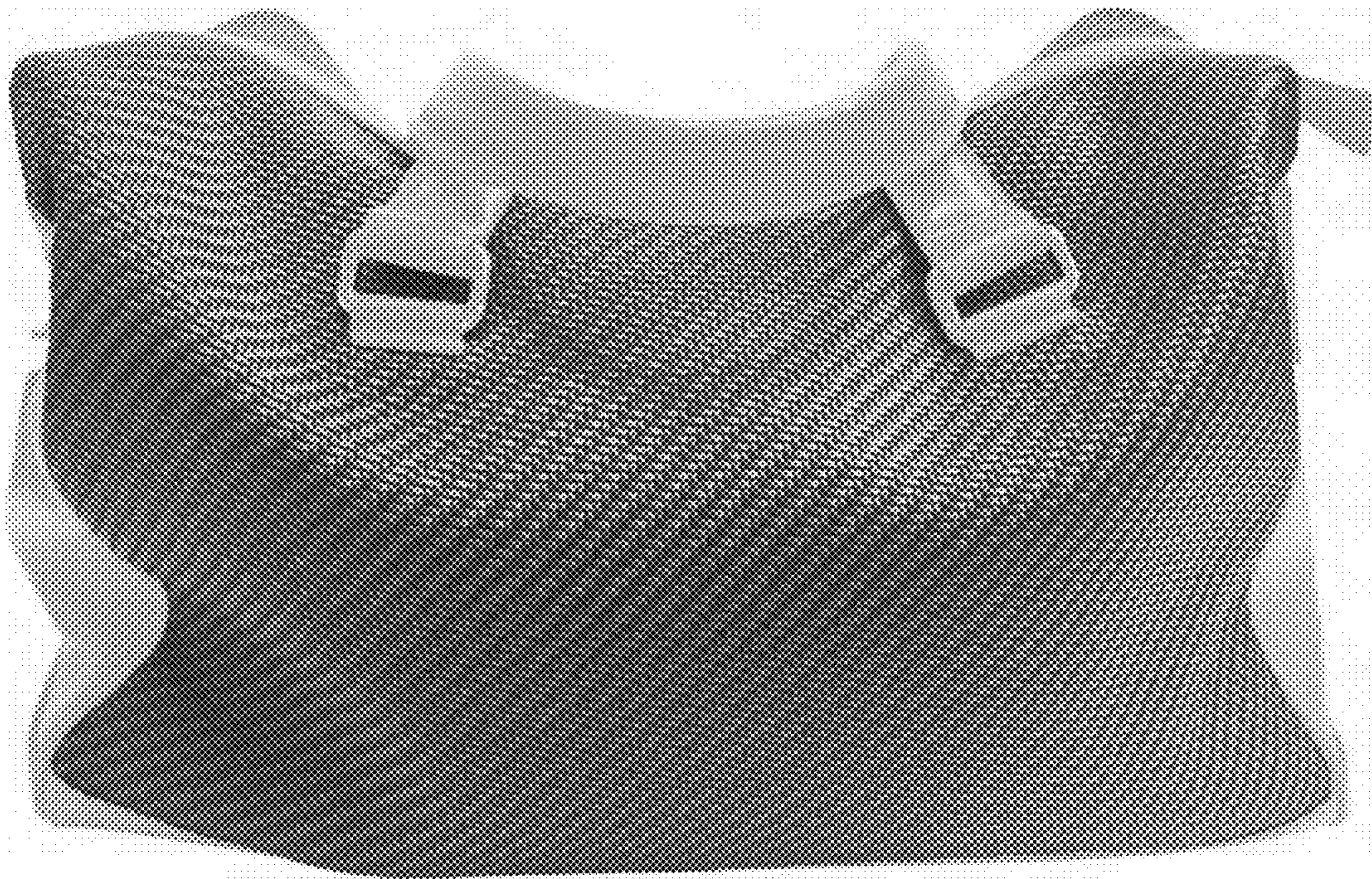

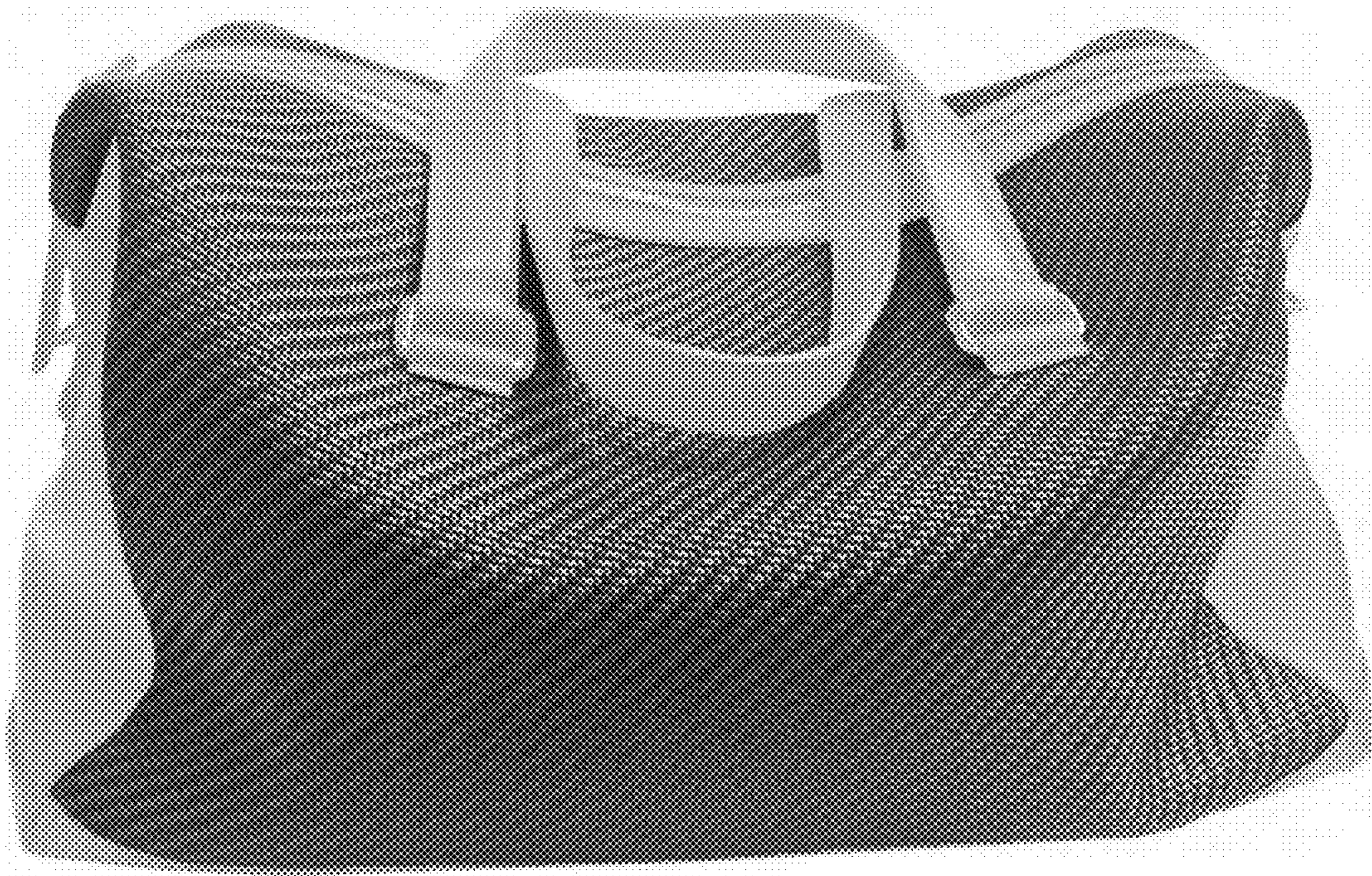

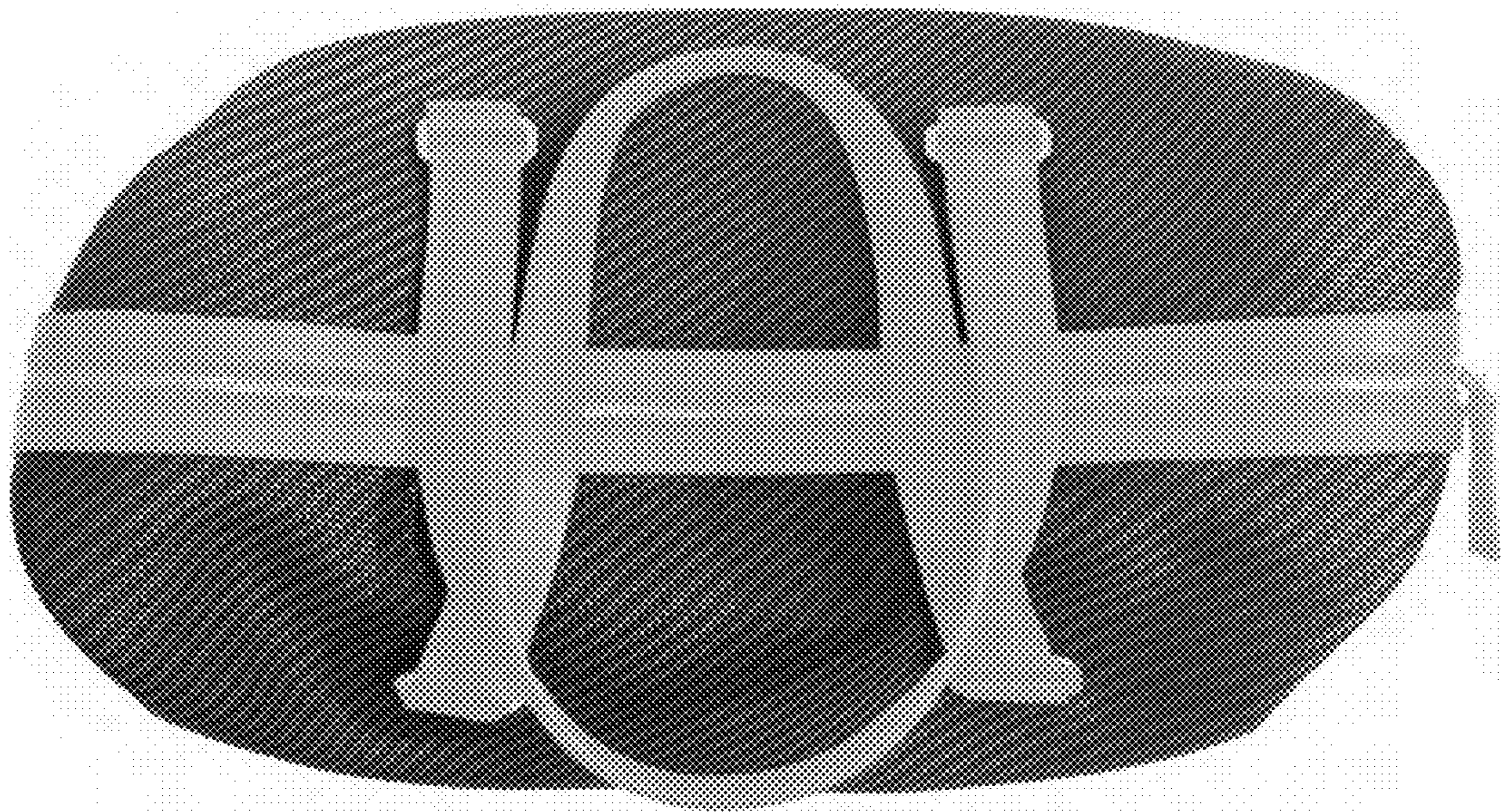

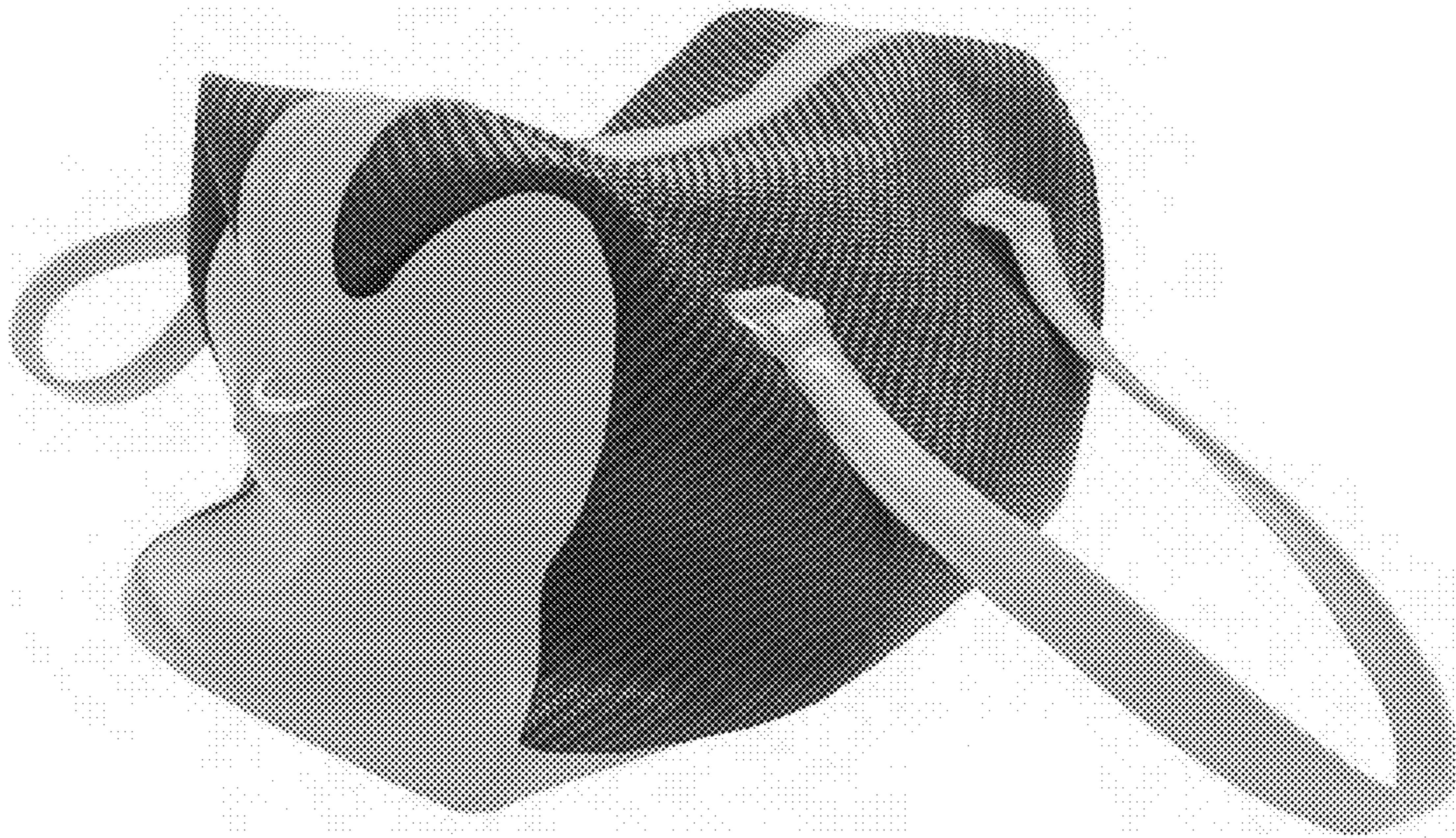

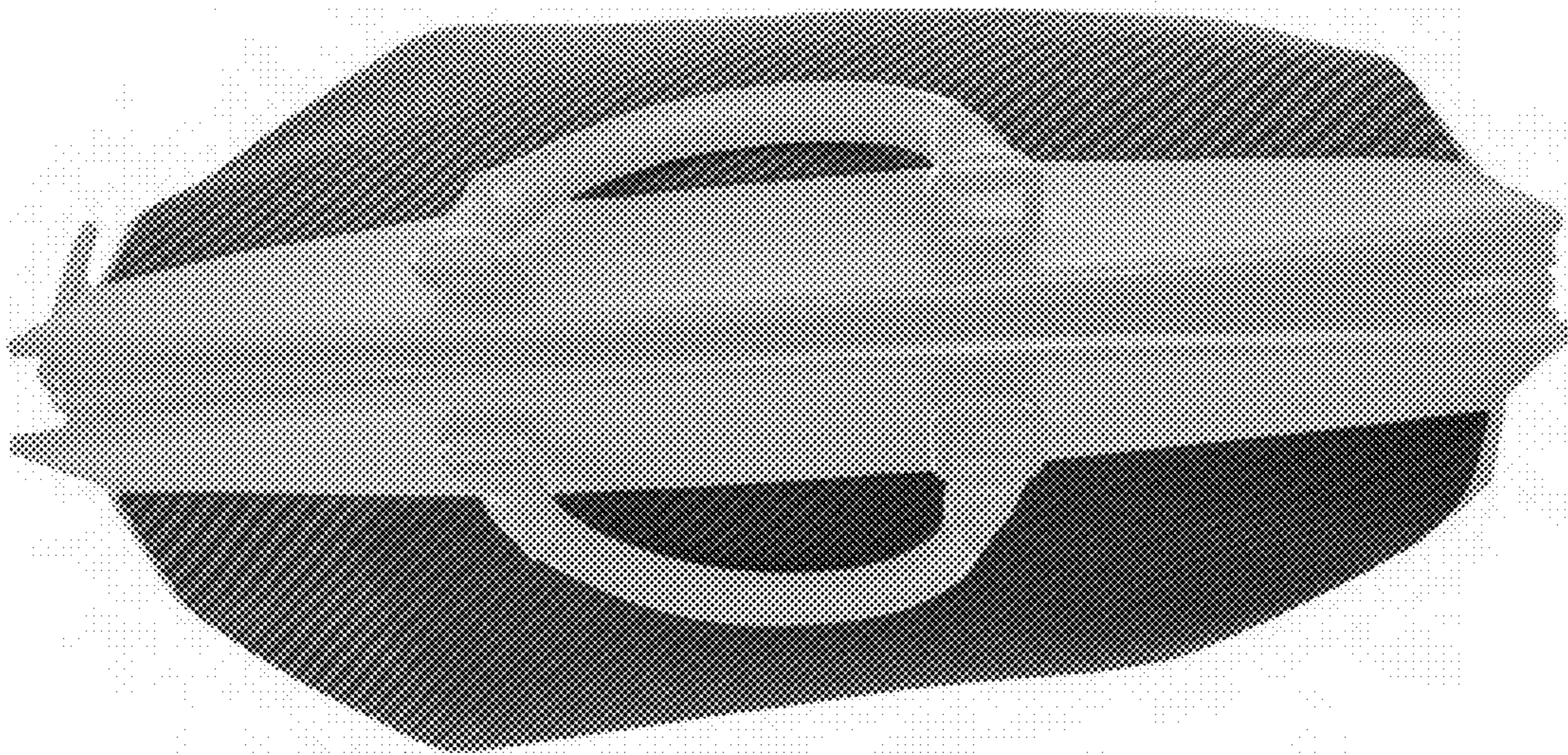

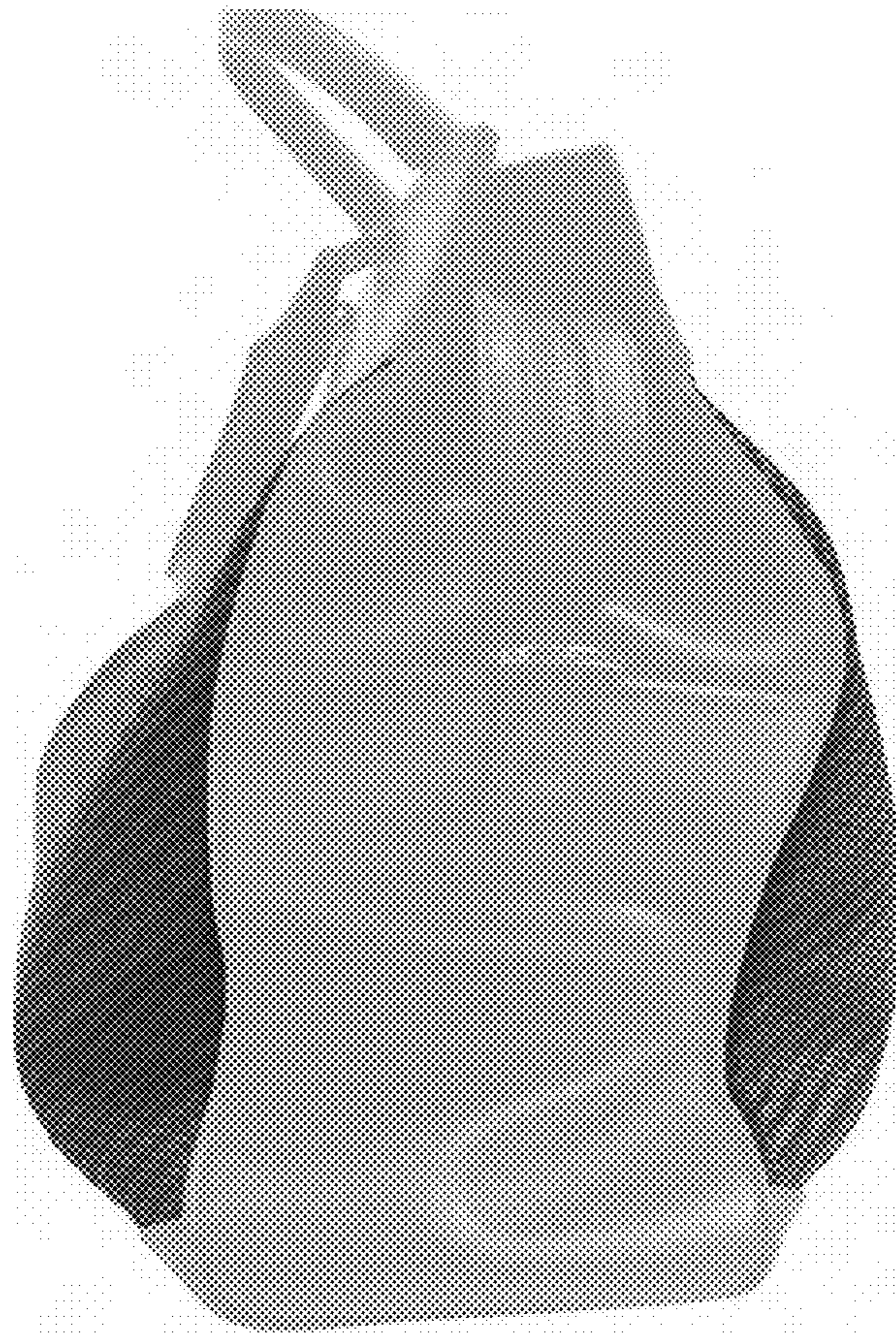

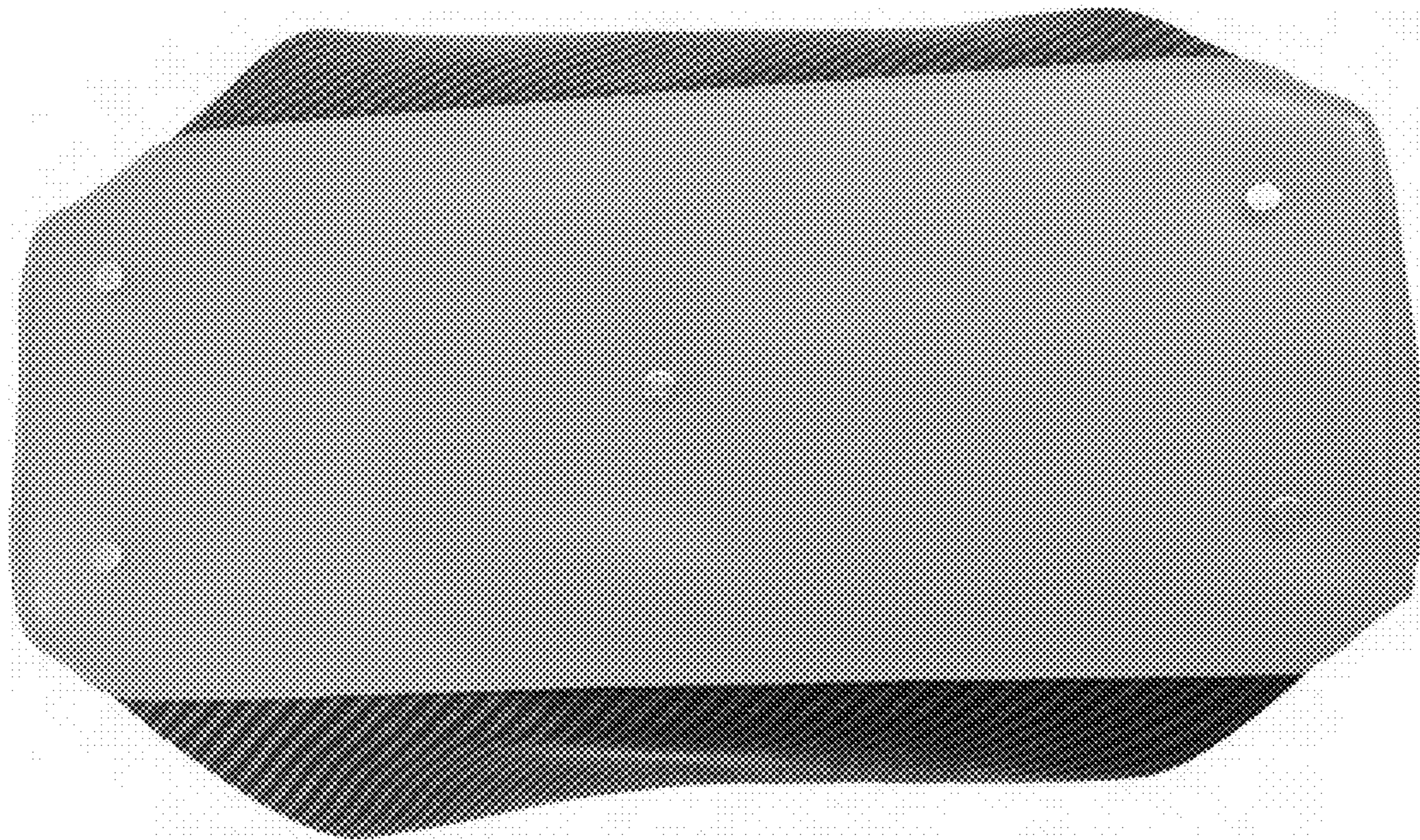
