**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of a pan showing my design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a cross section view taken from line 3-3 of FIG. 2;

FIG. 4 is a rear elevational view thereof; and,

FIG. 5 is an enlarged detail view of portion 5 shown in FIG. 3.

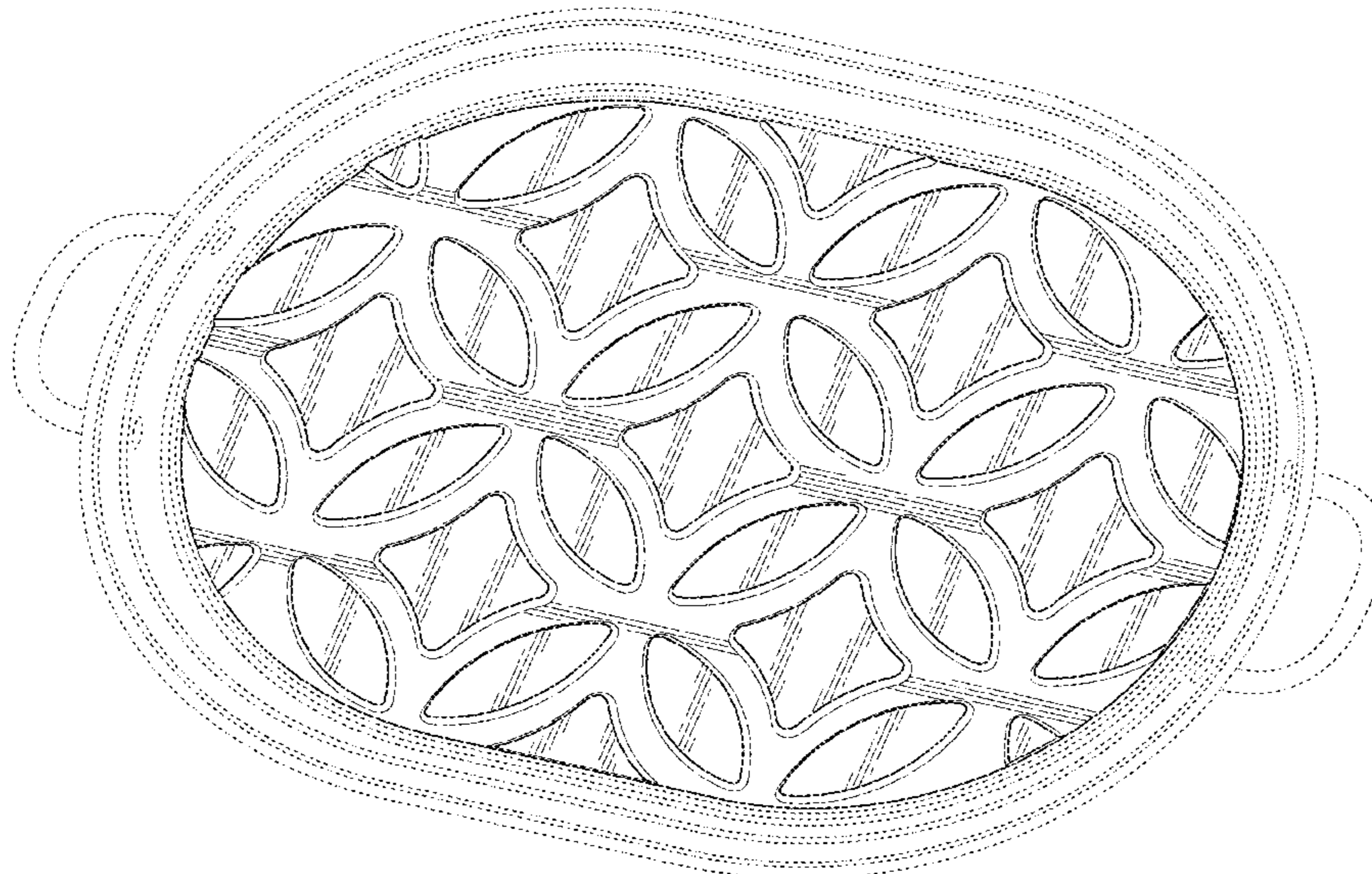

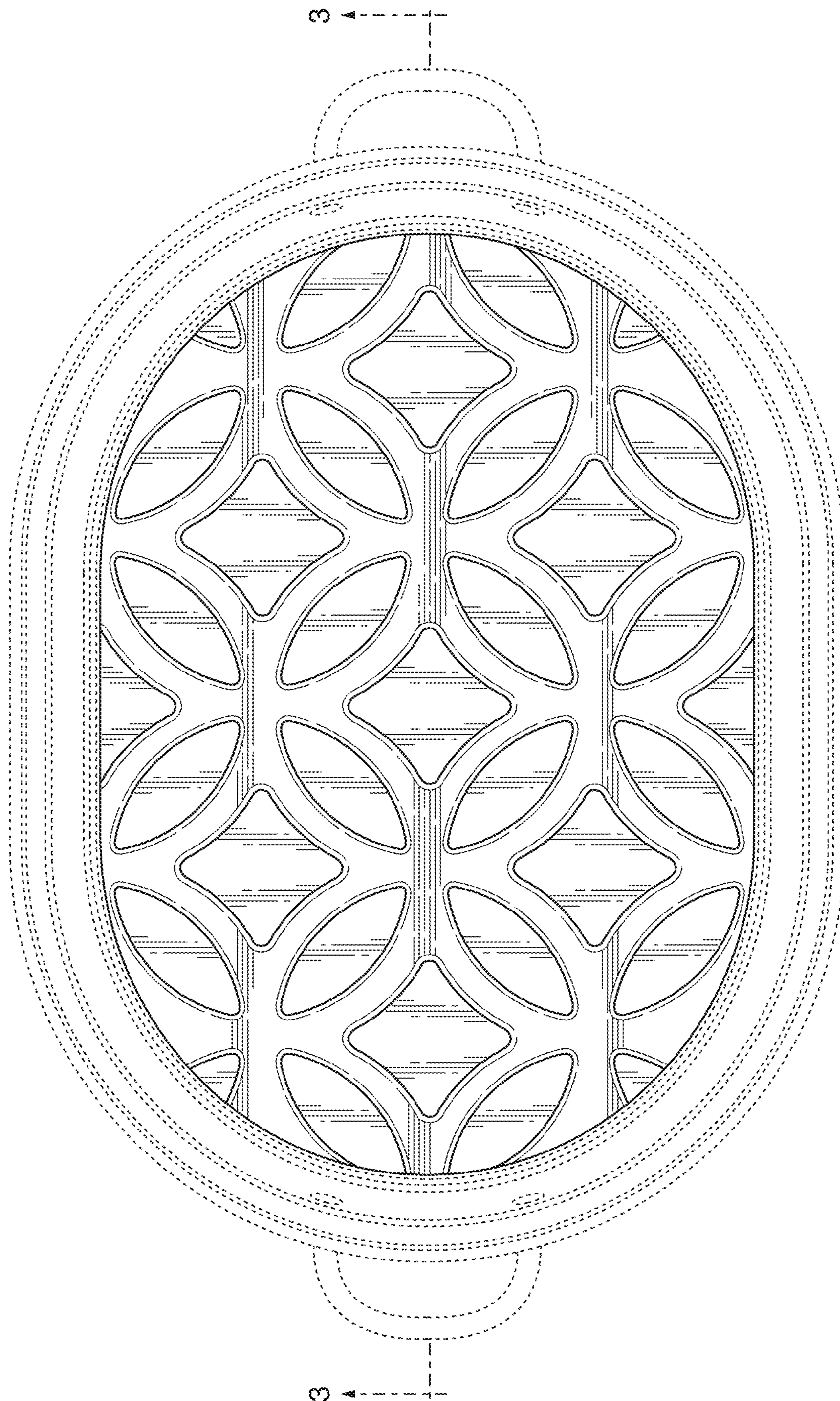

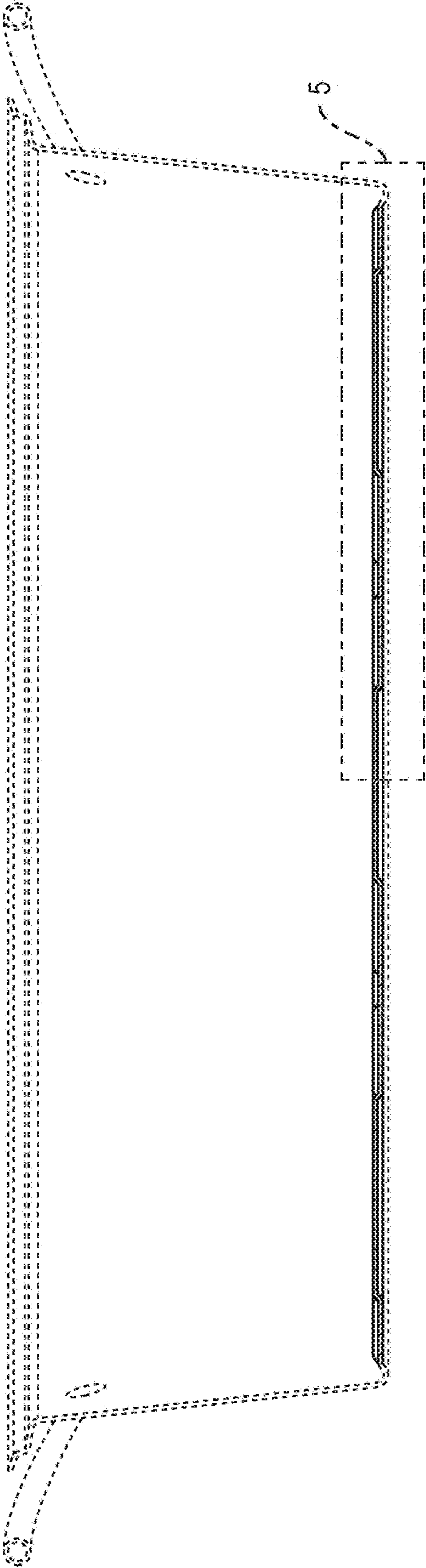

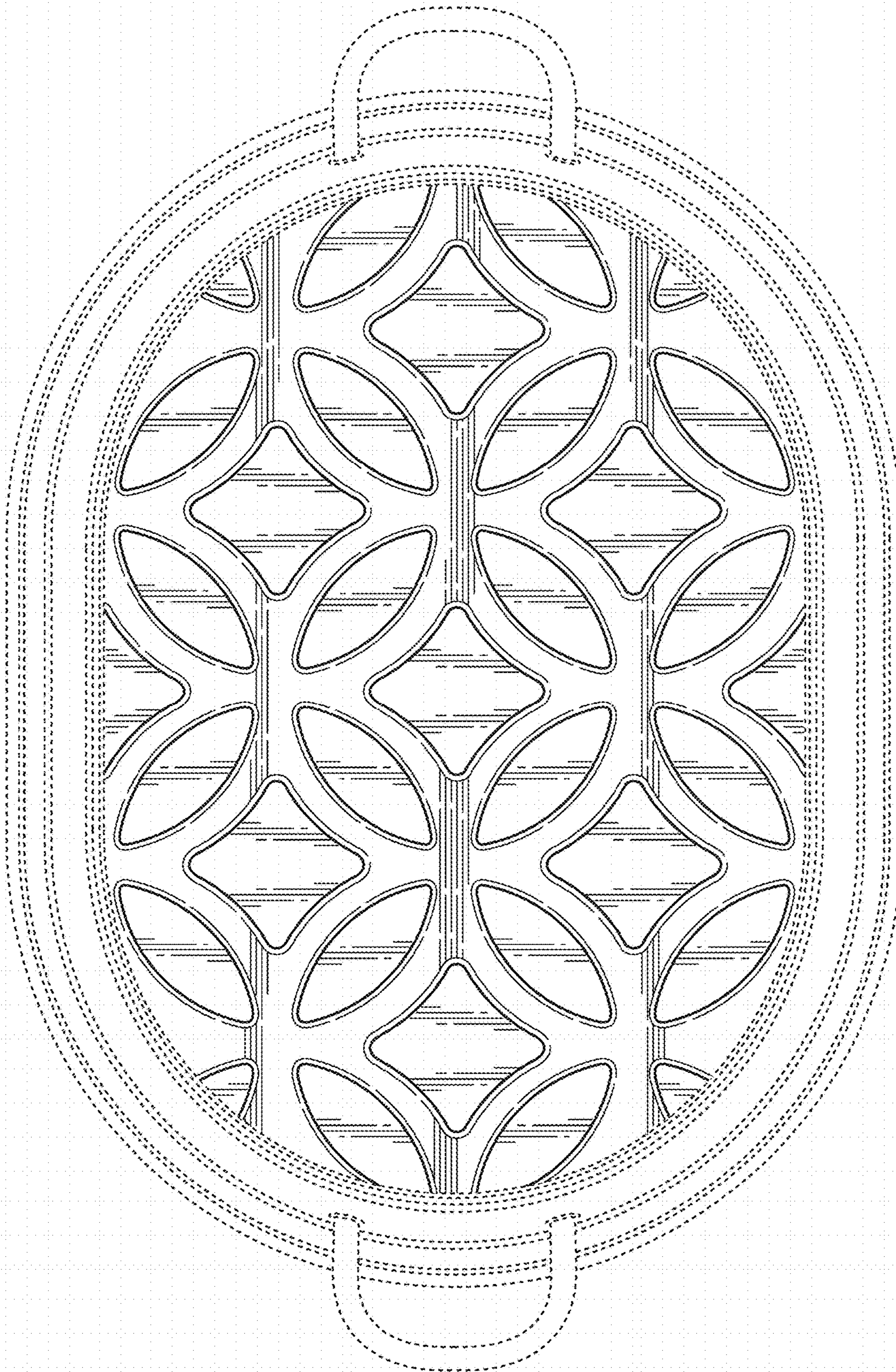

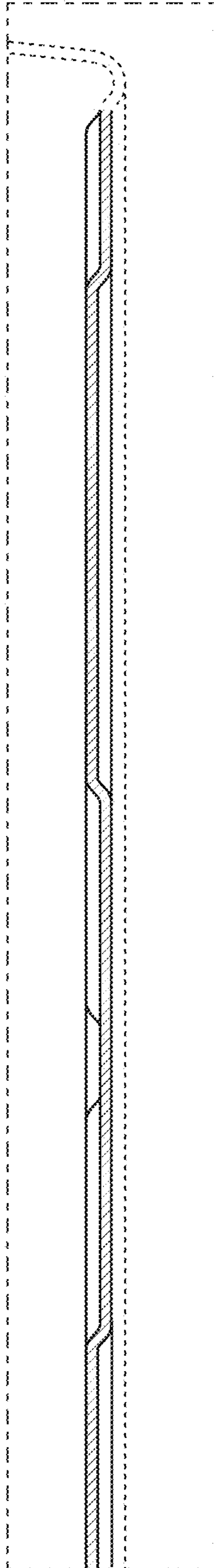
