The ornamental design for a water bottle, as shown and described.

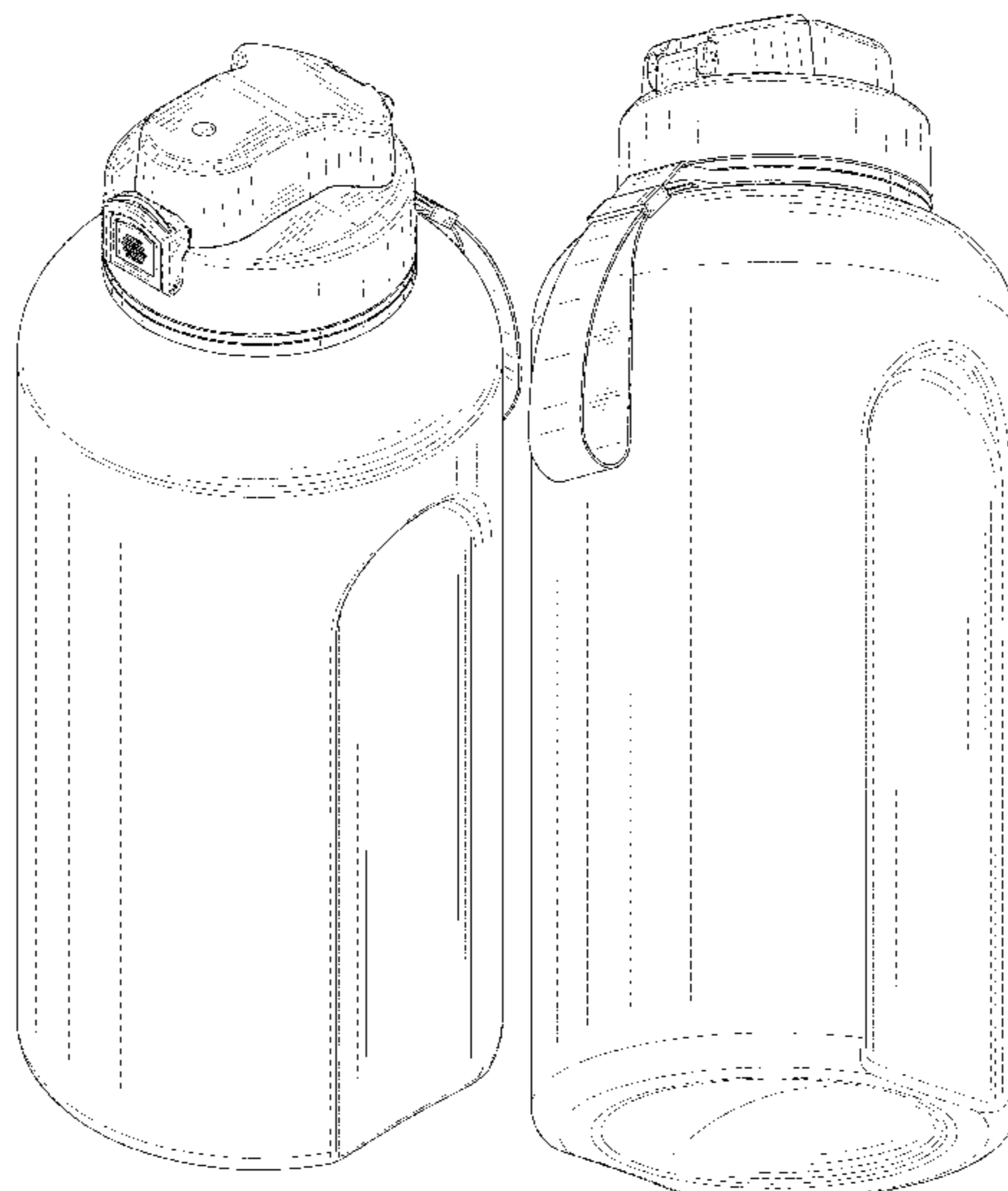

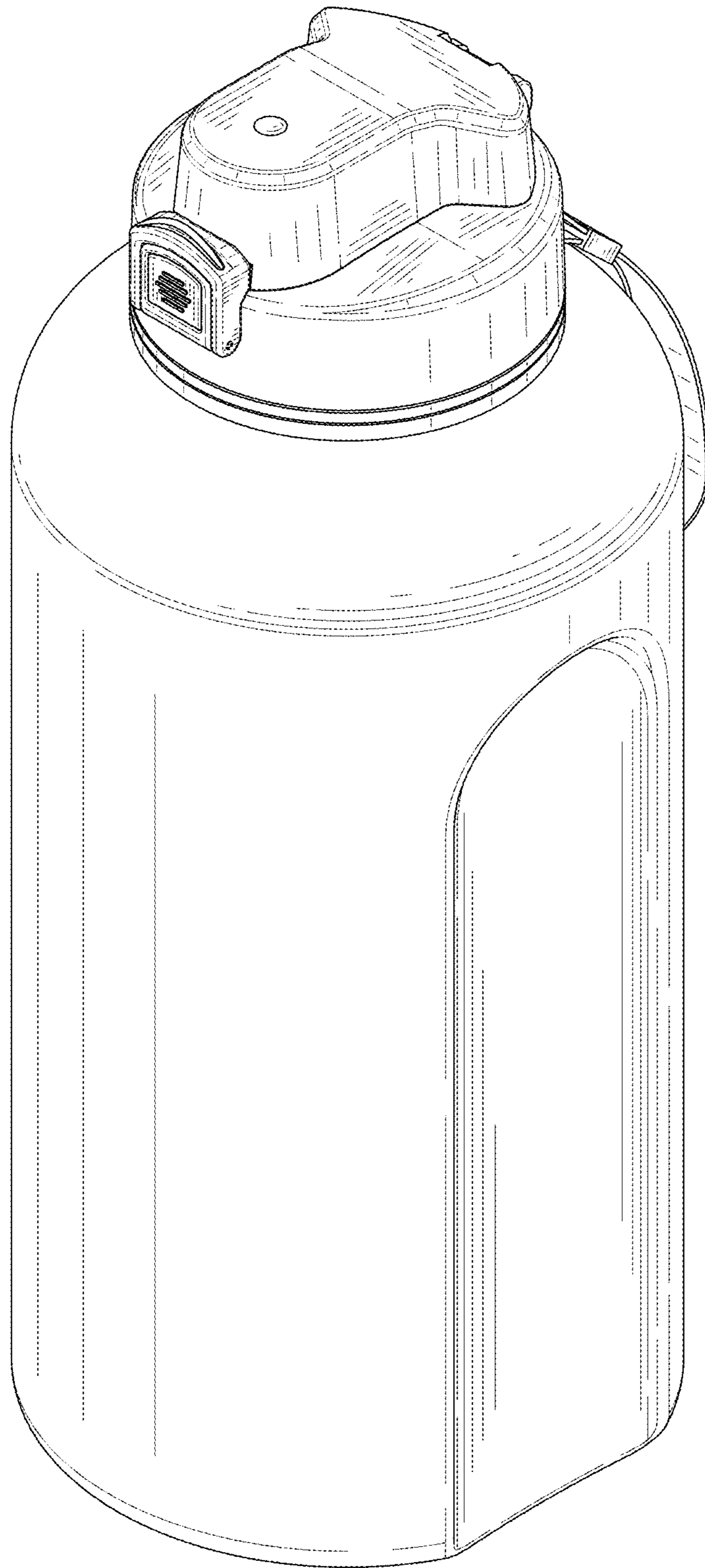

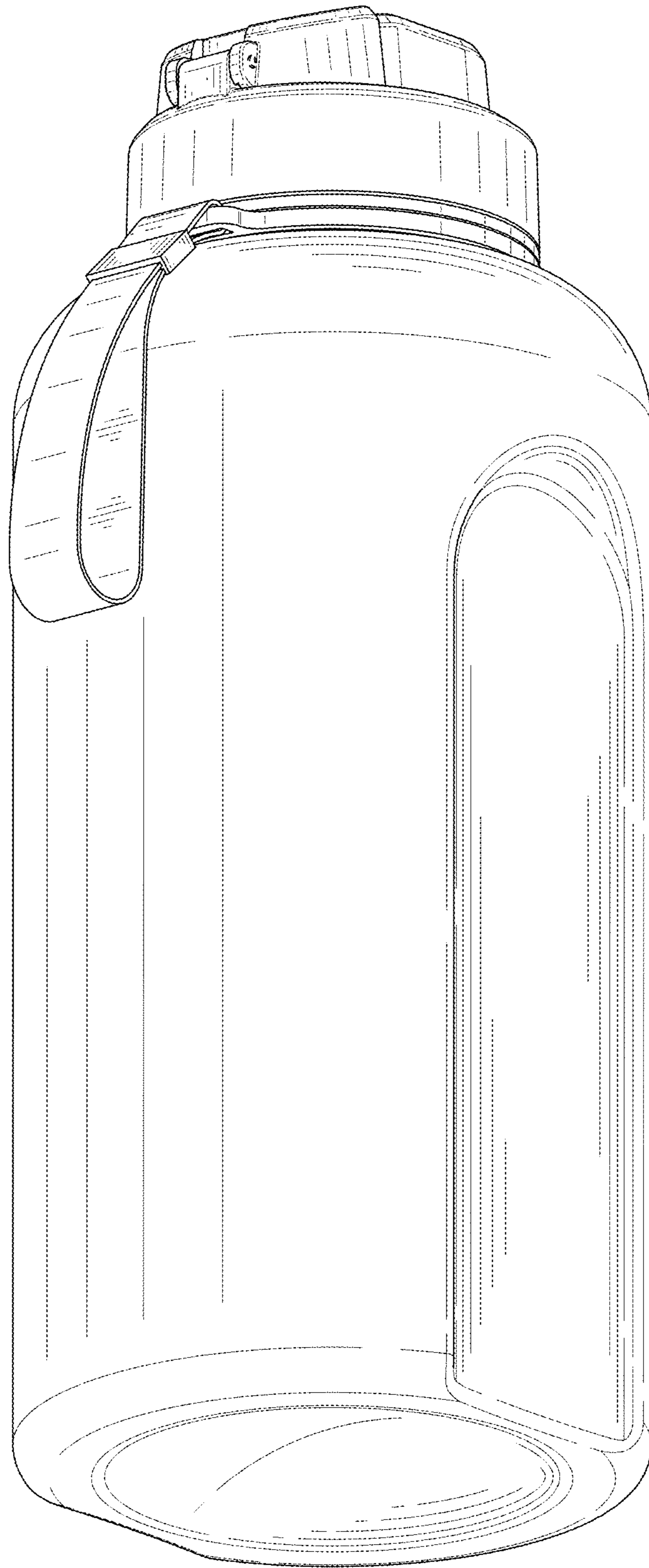

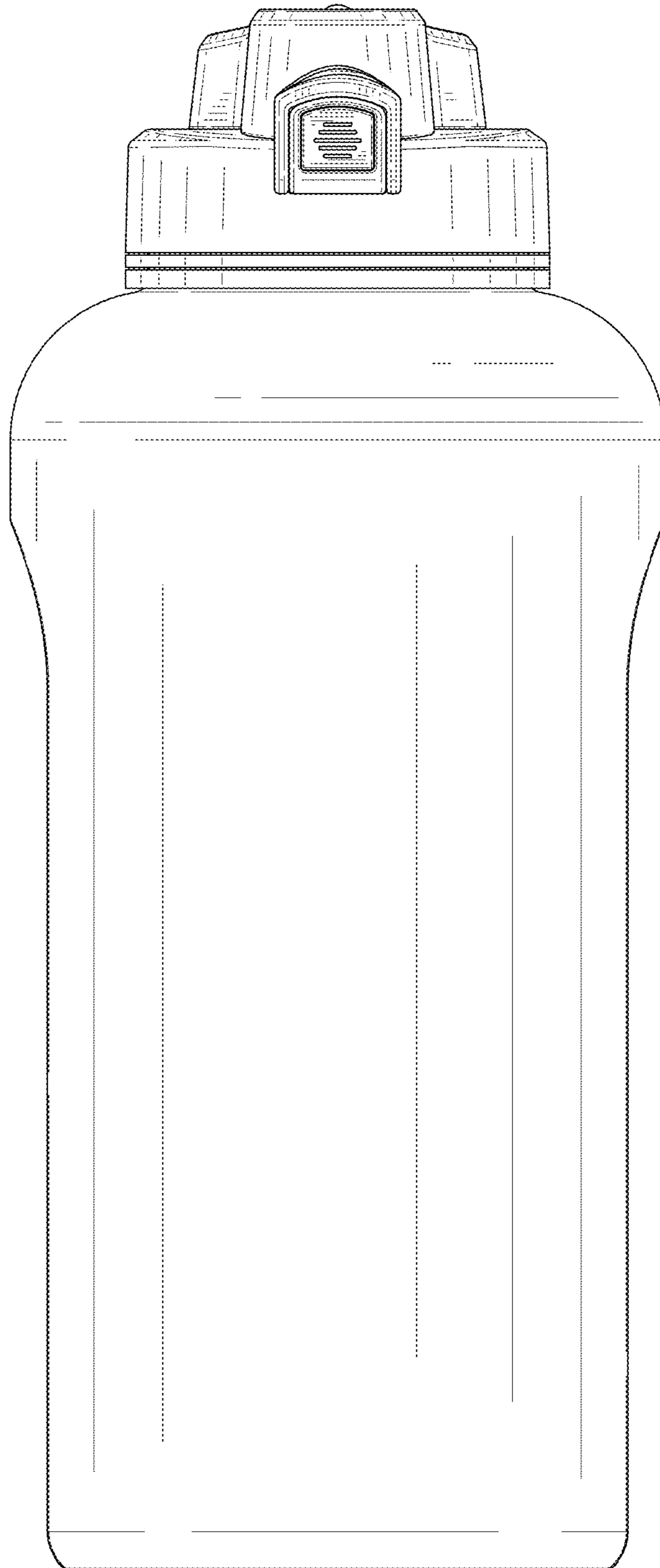

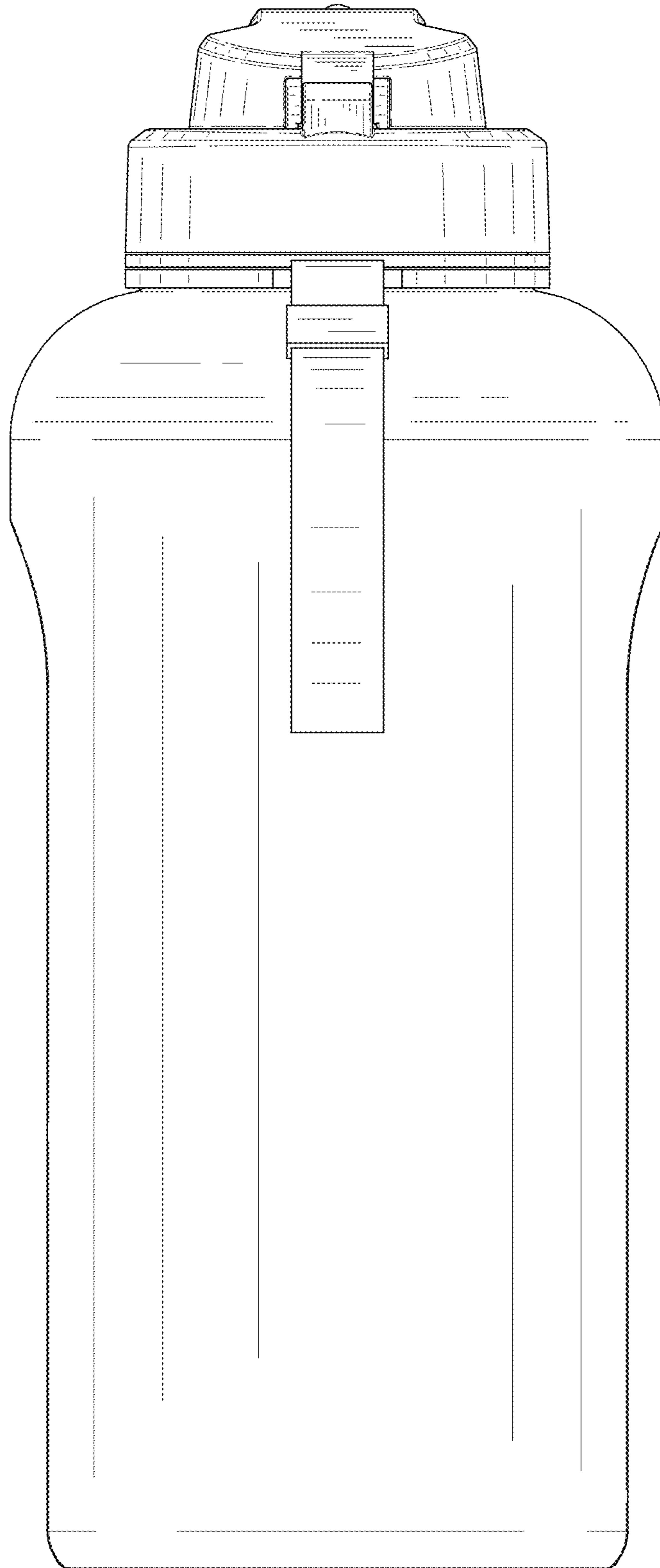

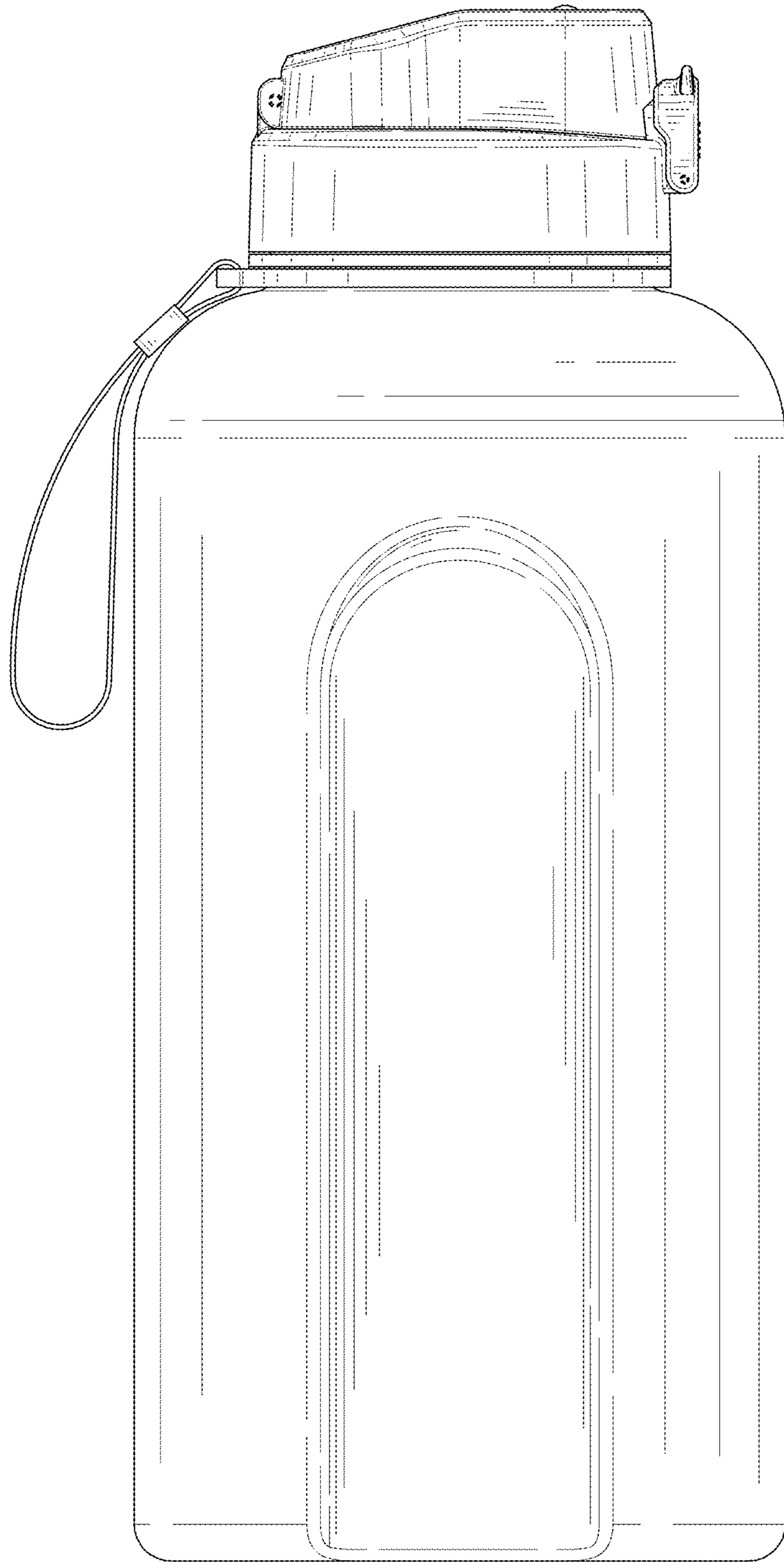

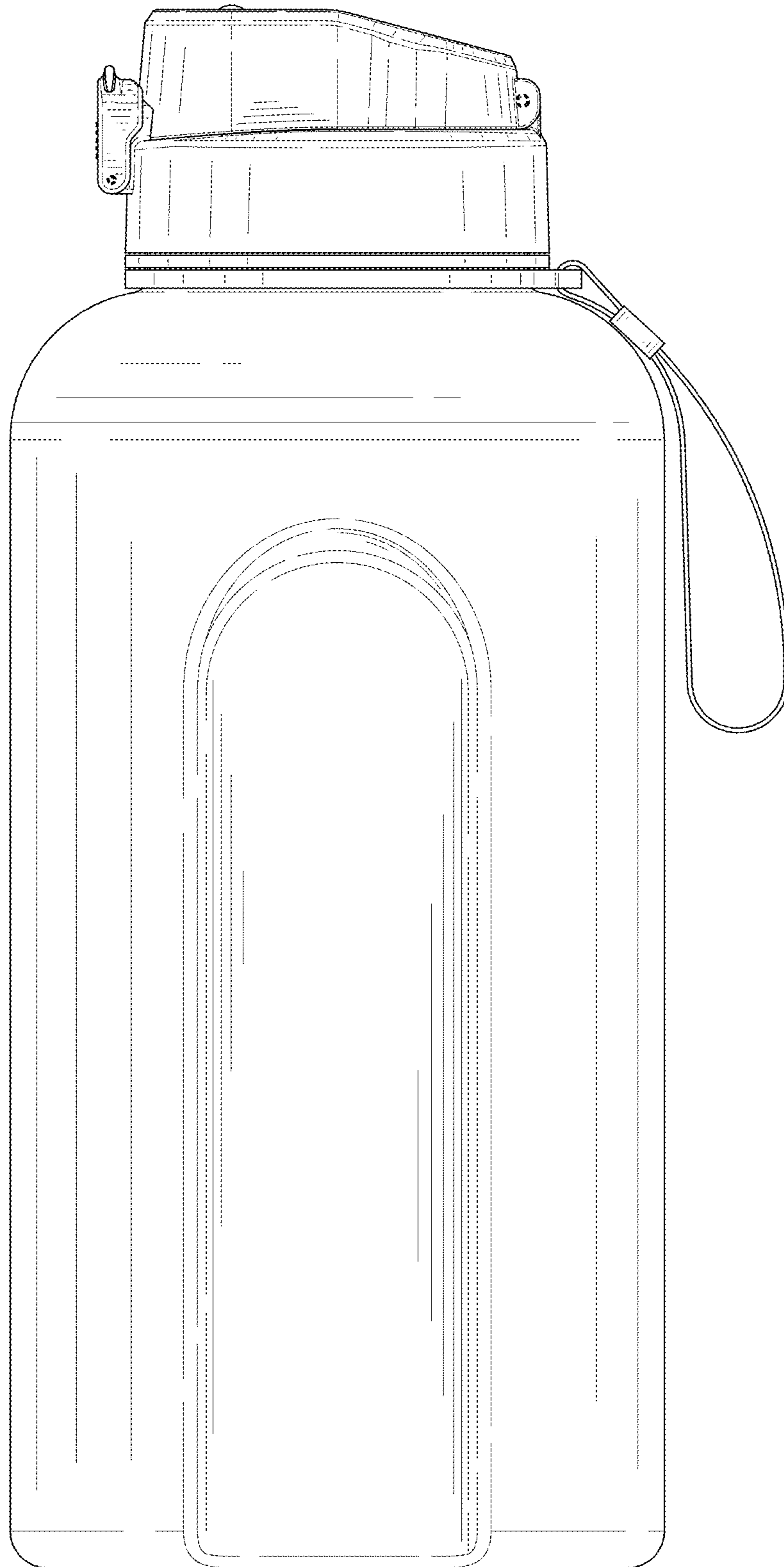

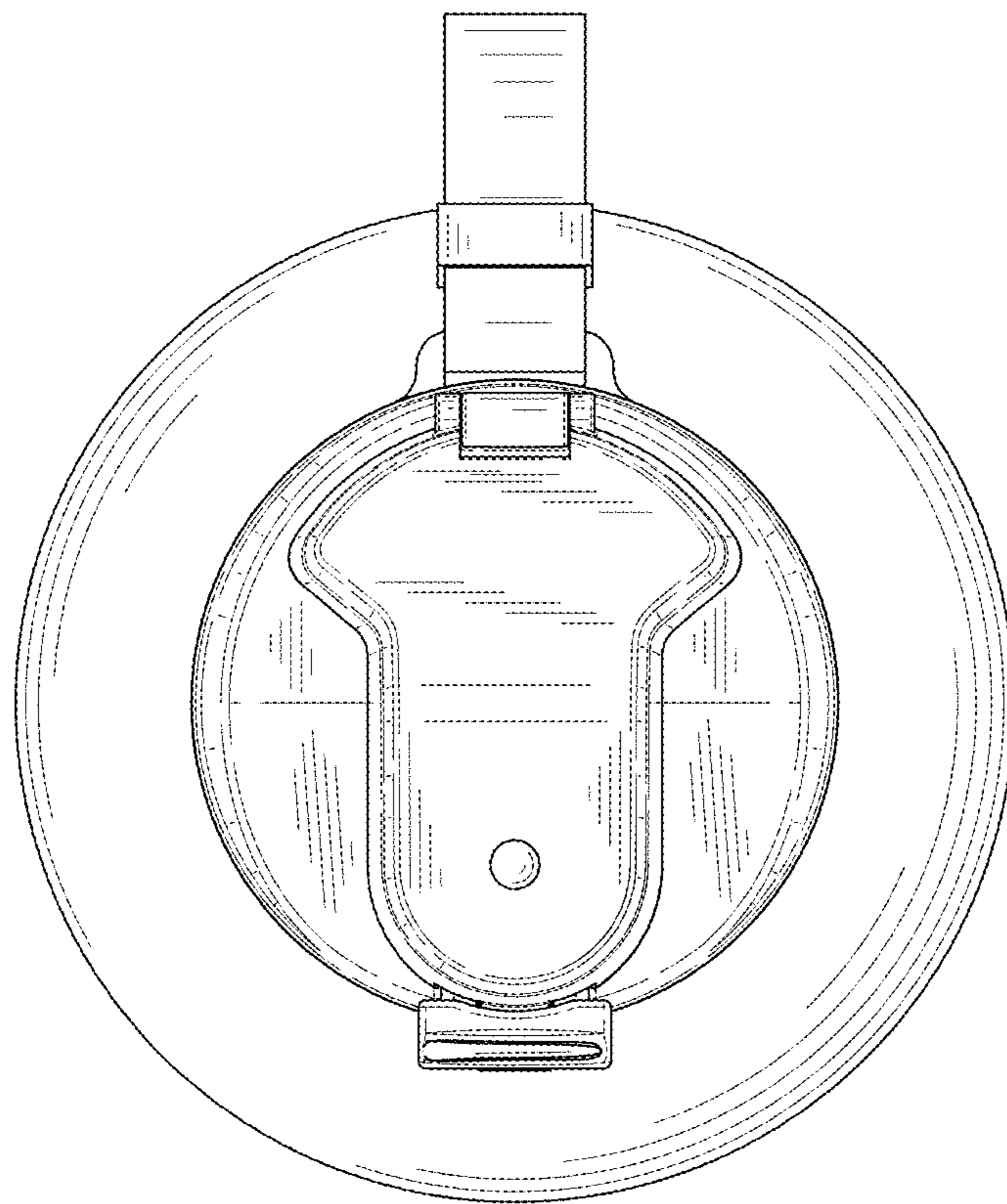

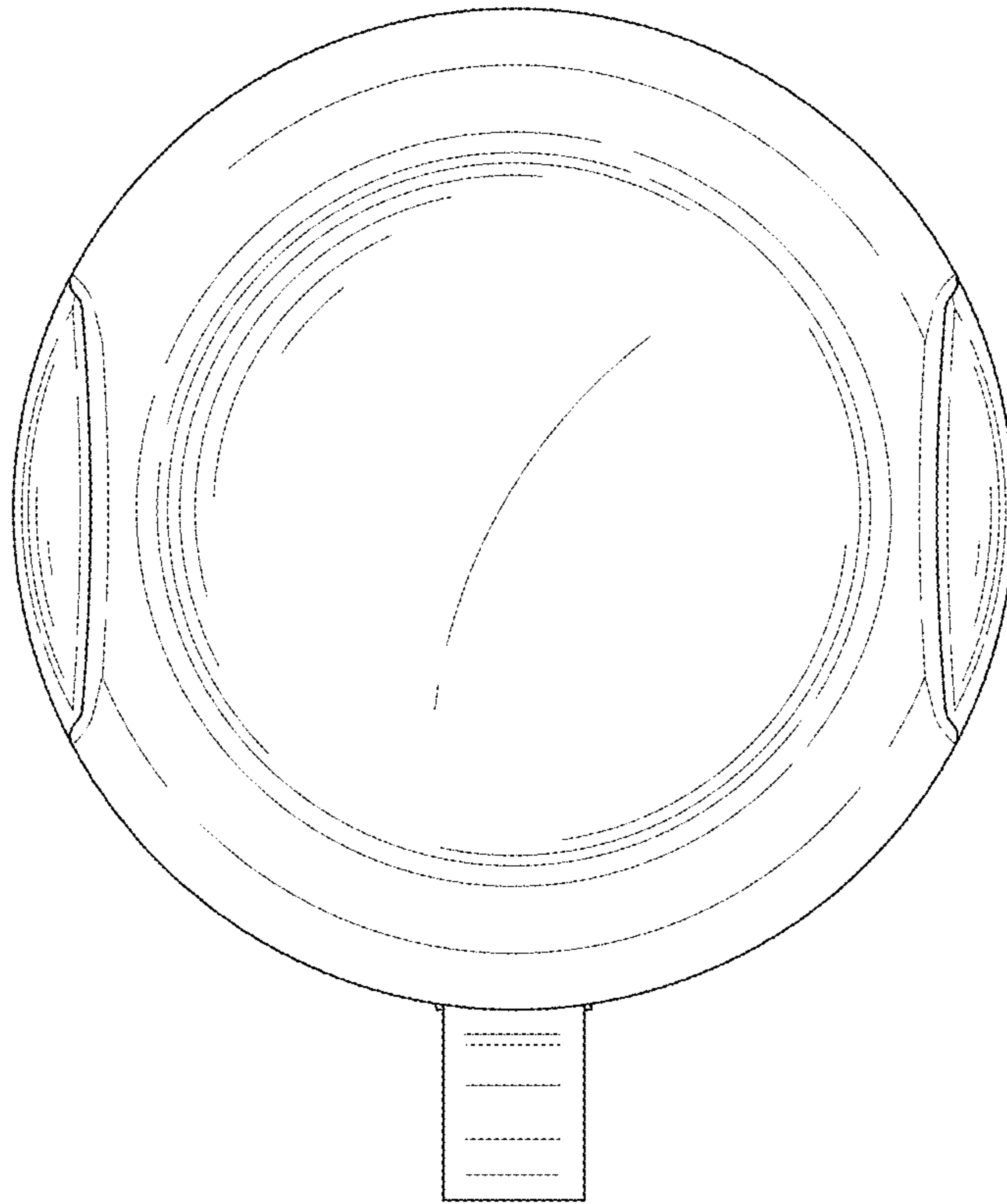
