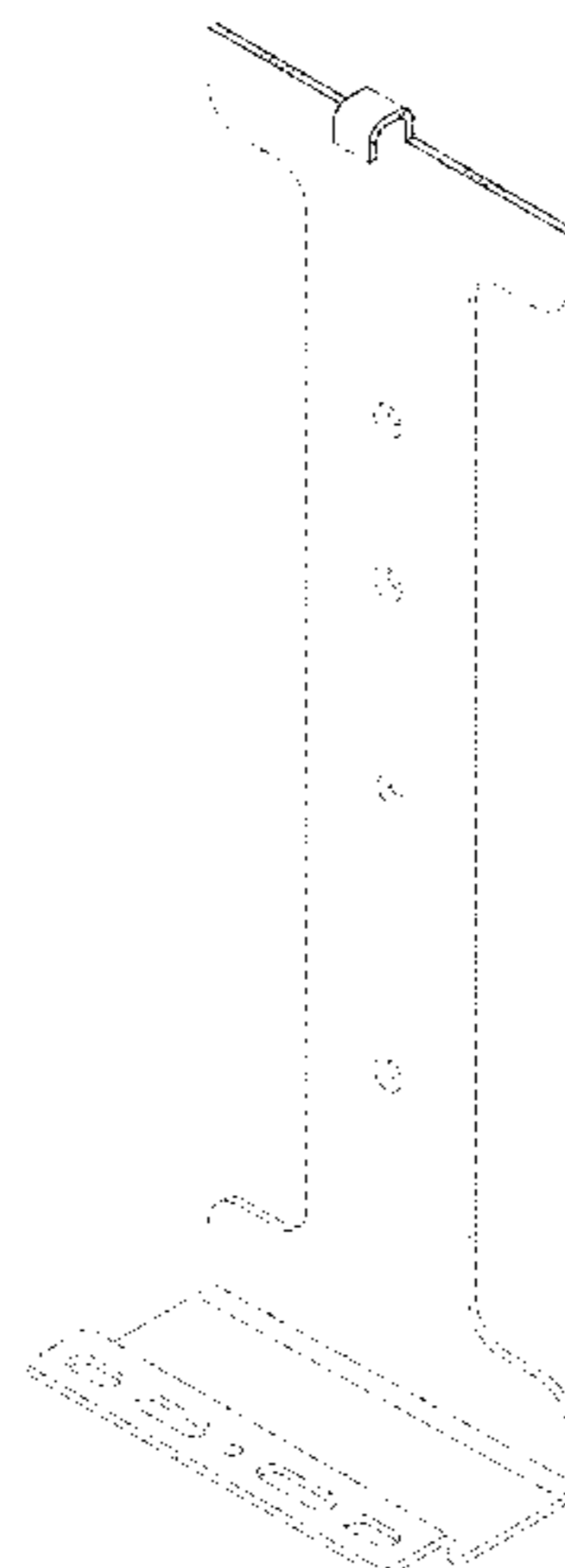
The ornamental design for a mounting apparatus, as shown and described.

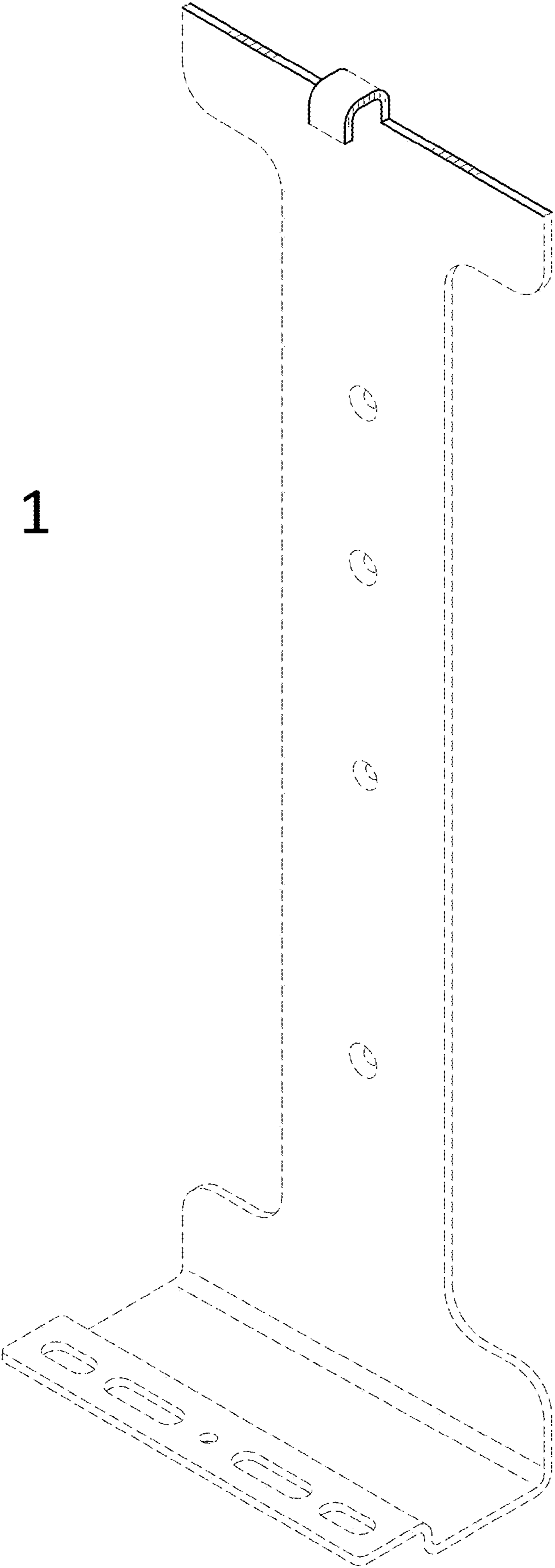

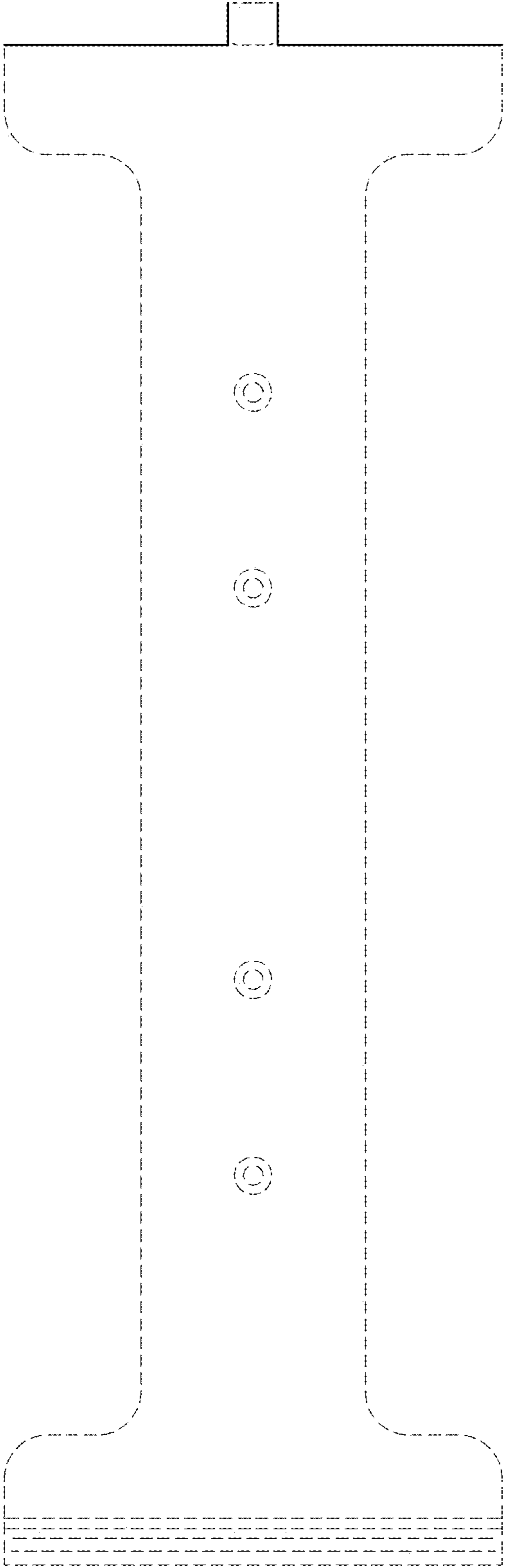

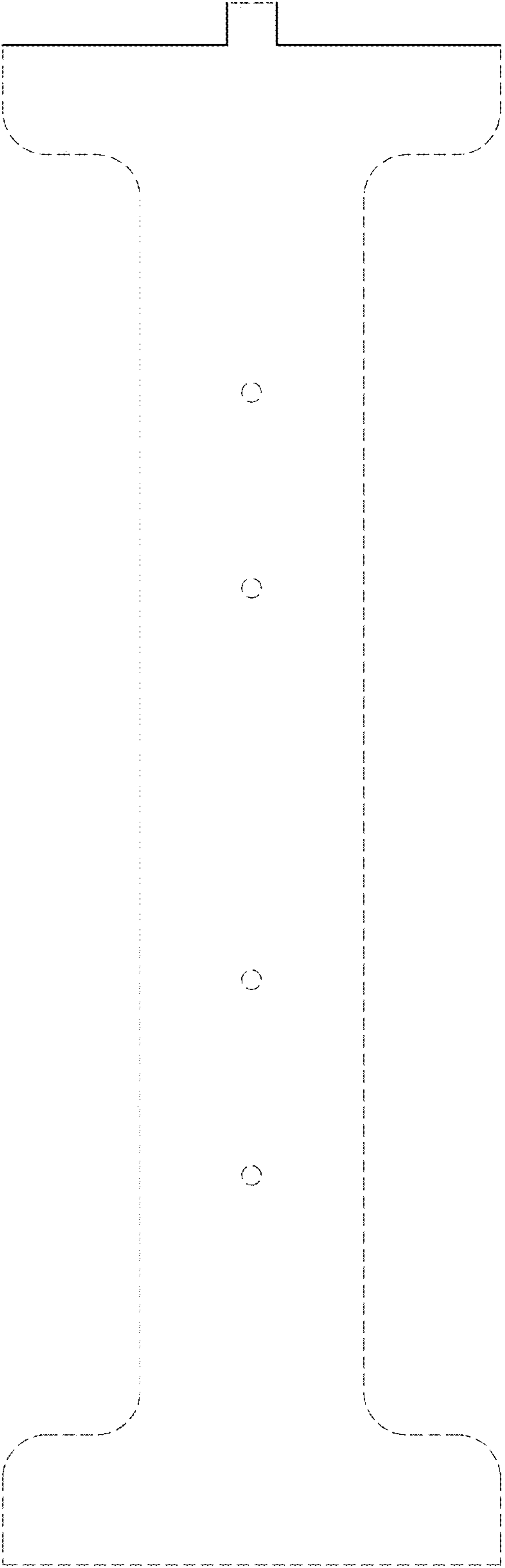

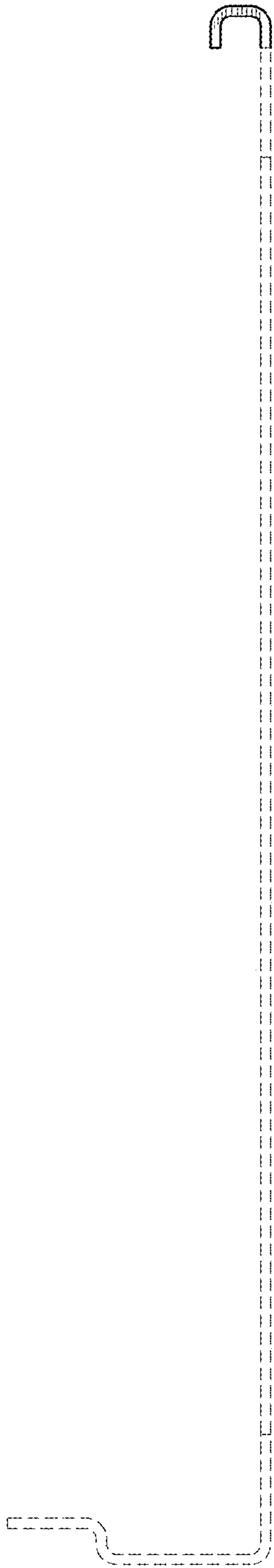

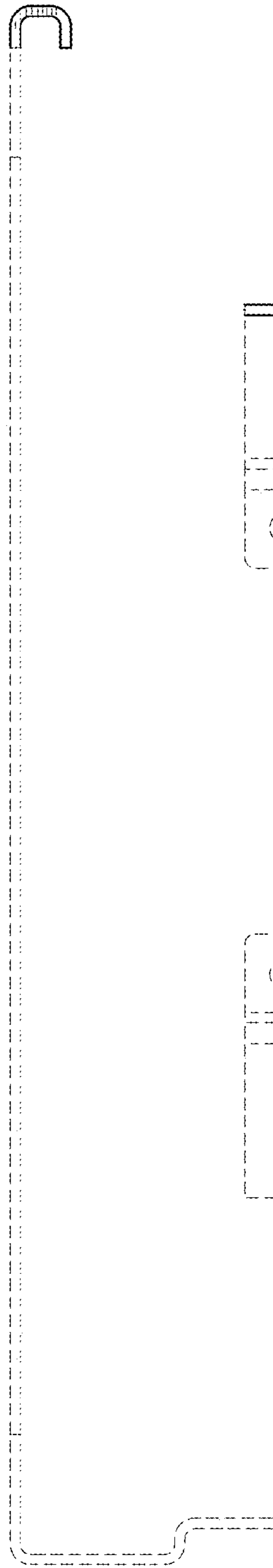

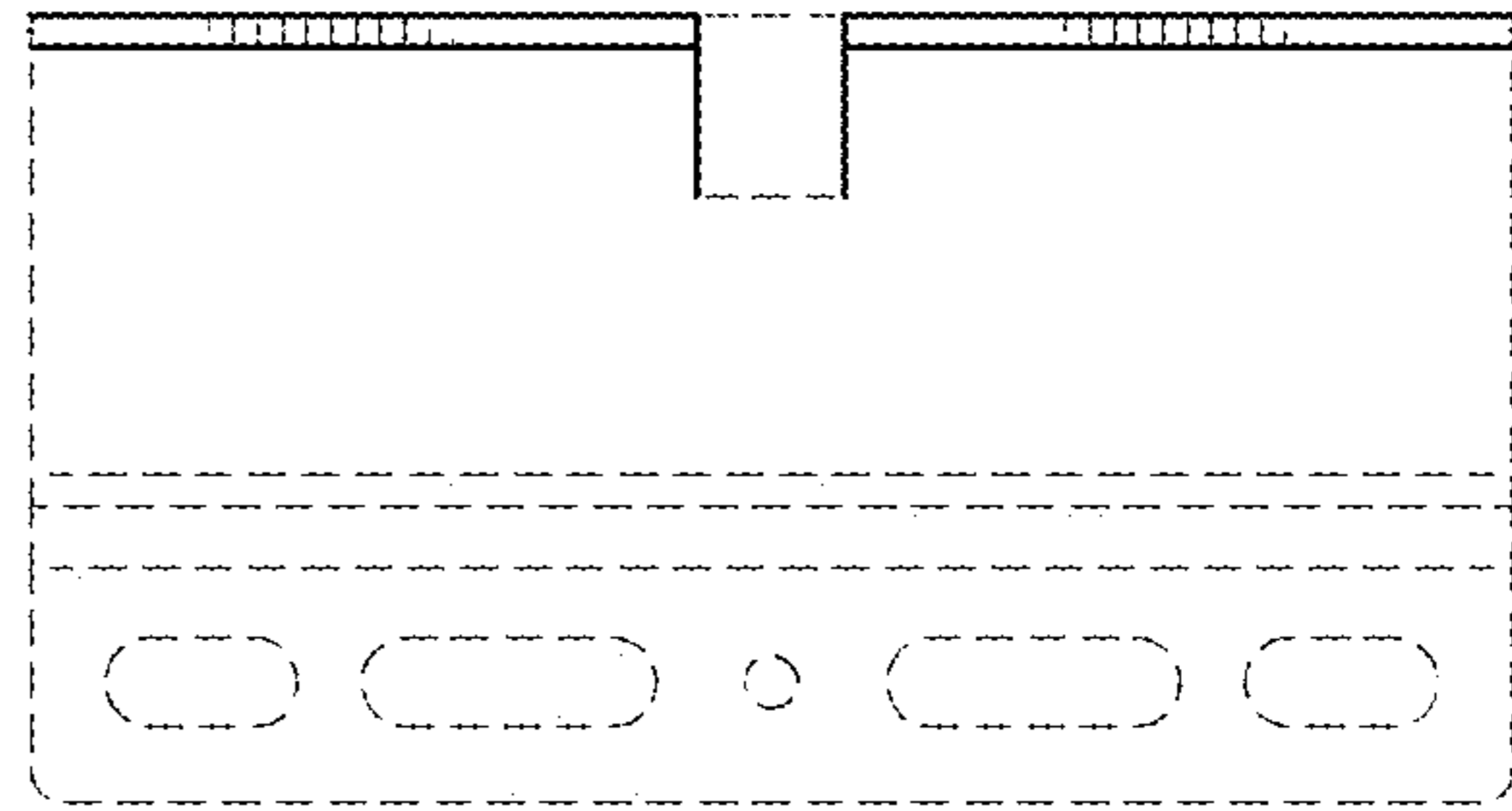

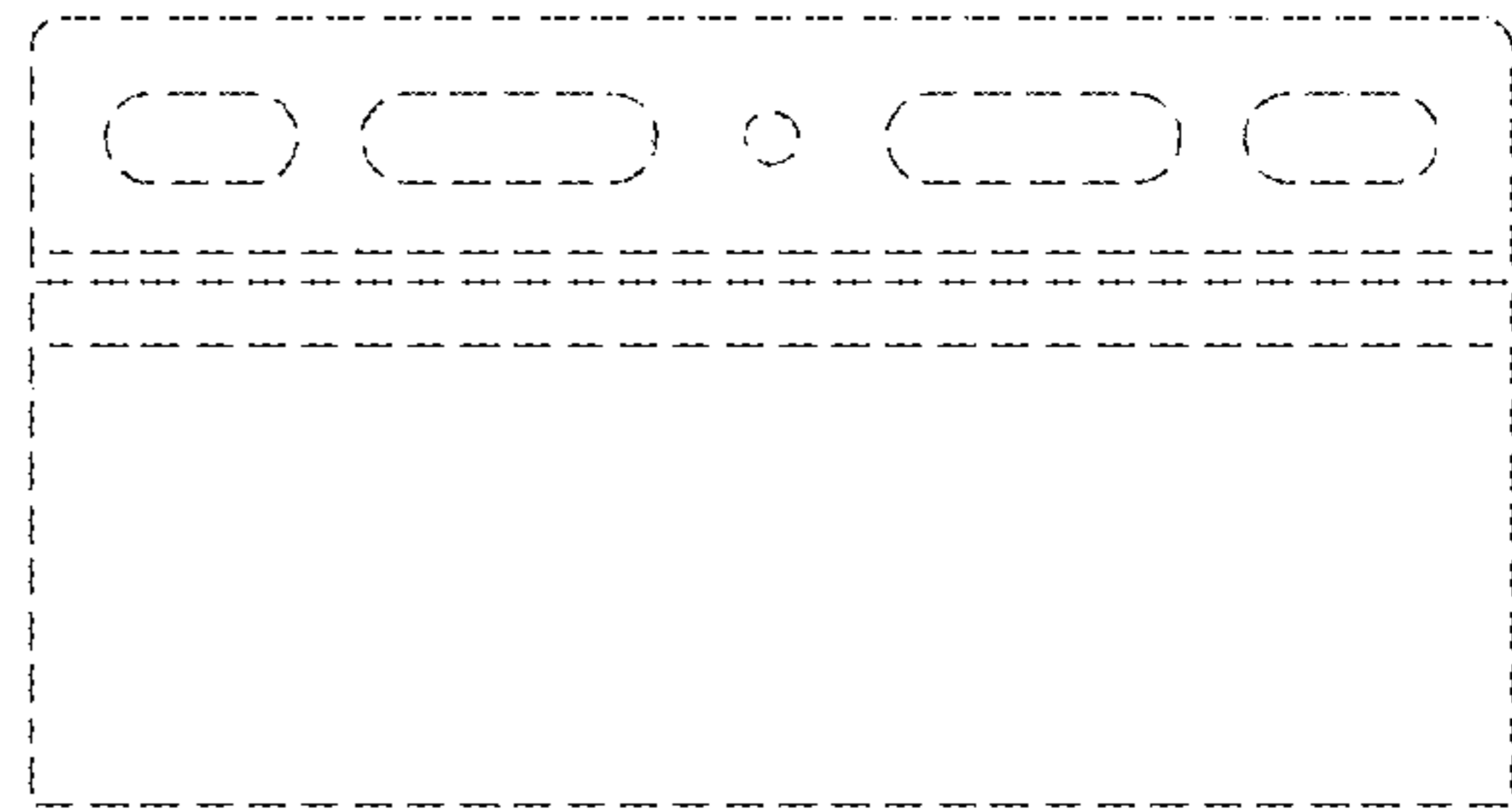
