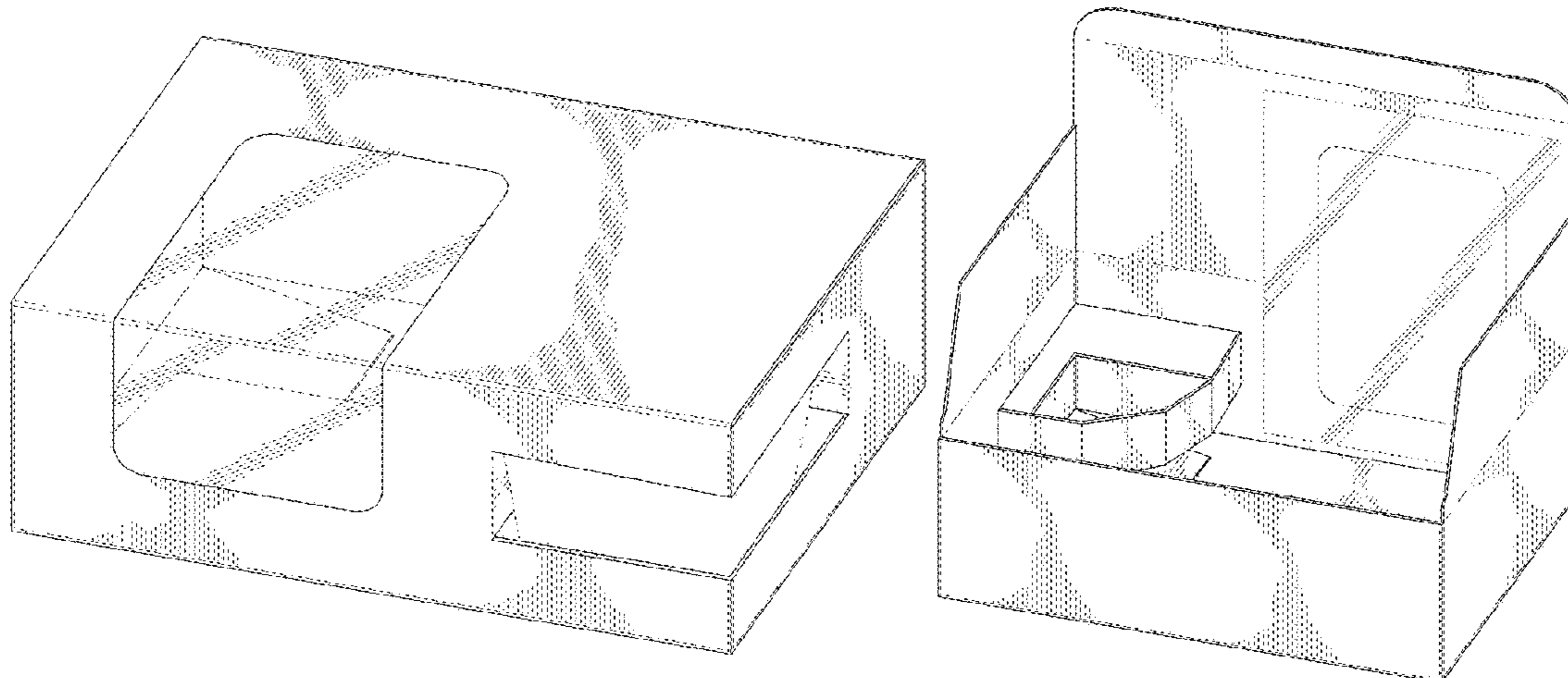


FIG. 29 is a rear elevation view thereof;

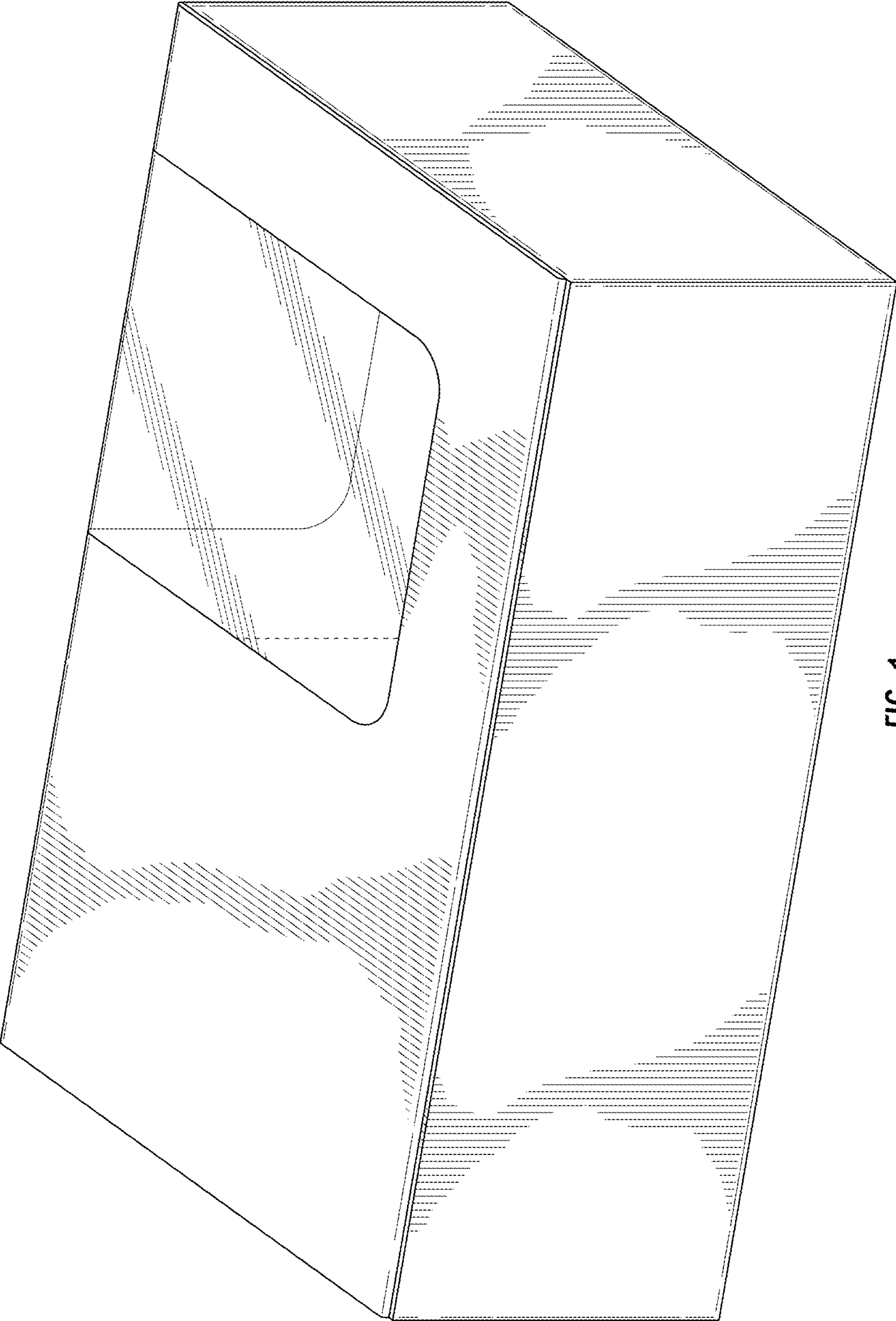

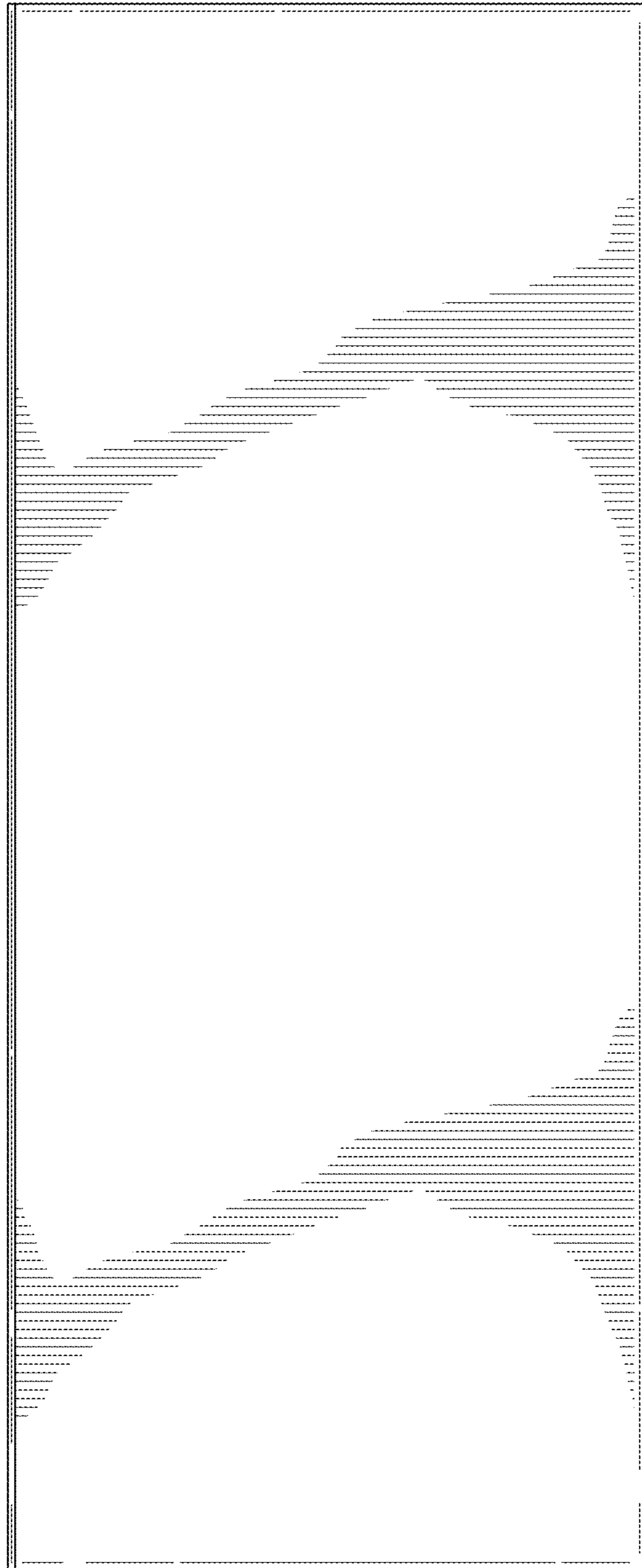

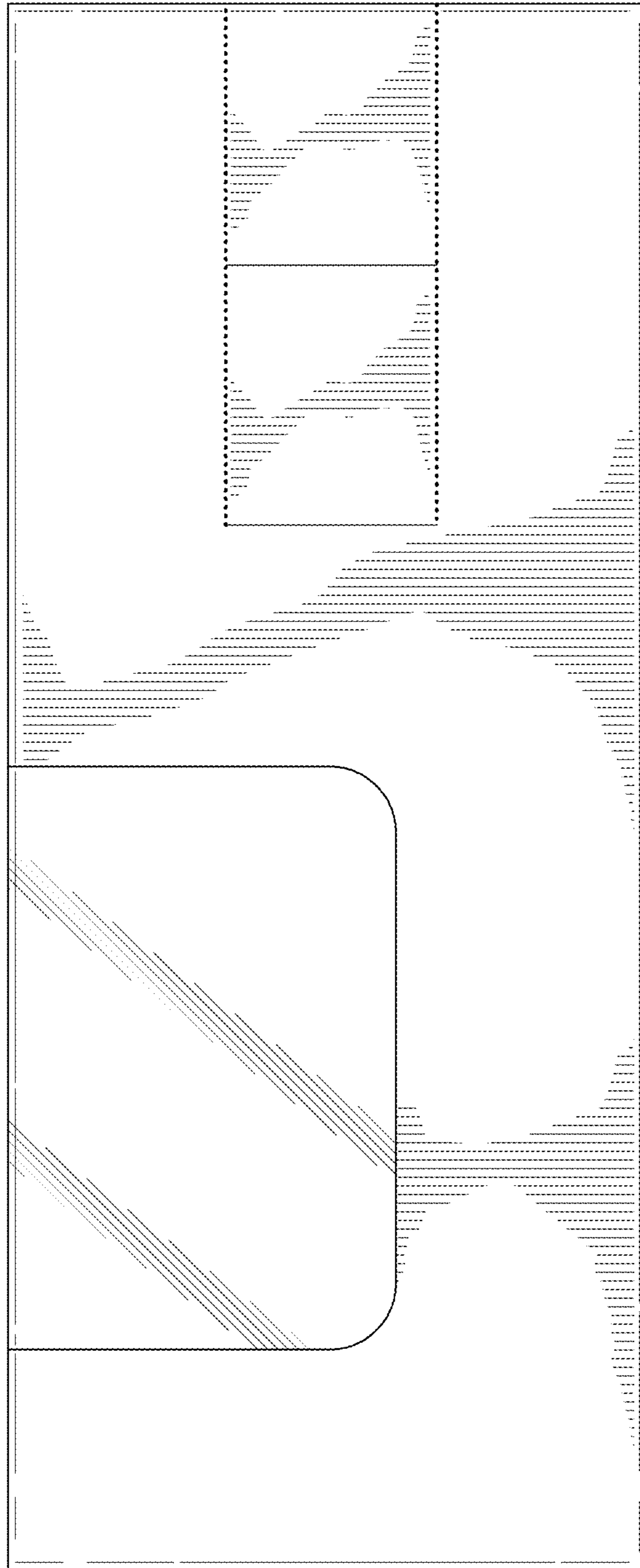

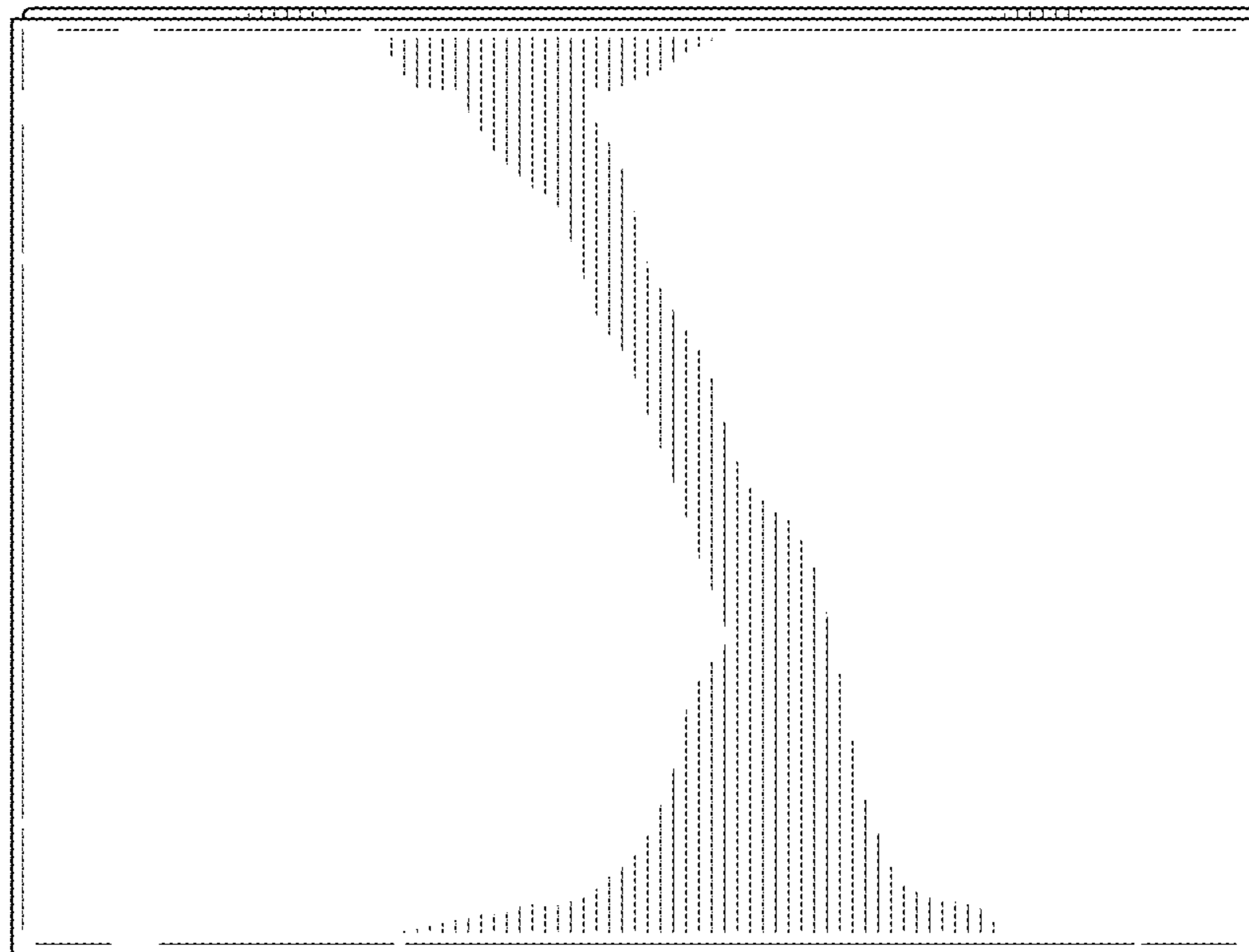

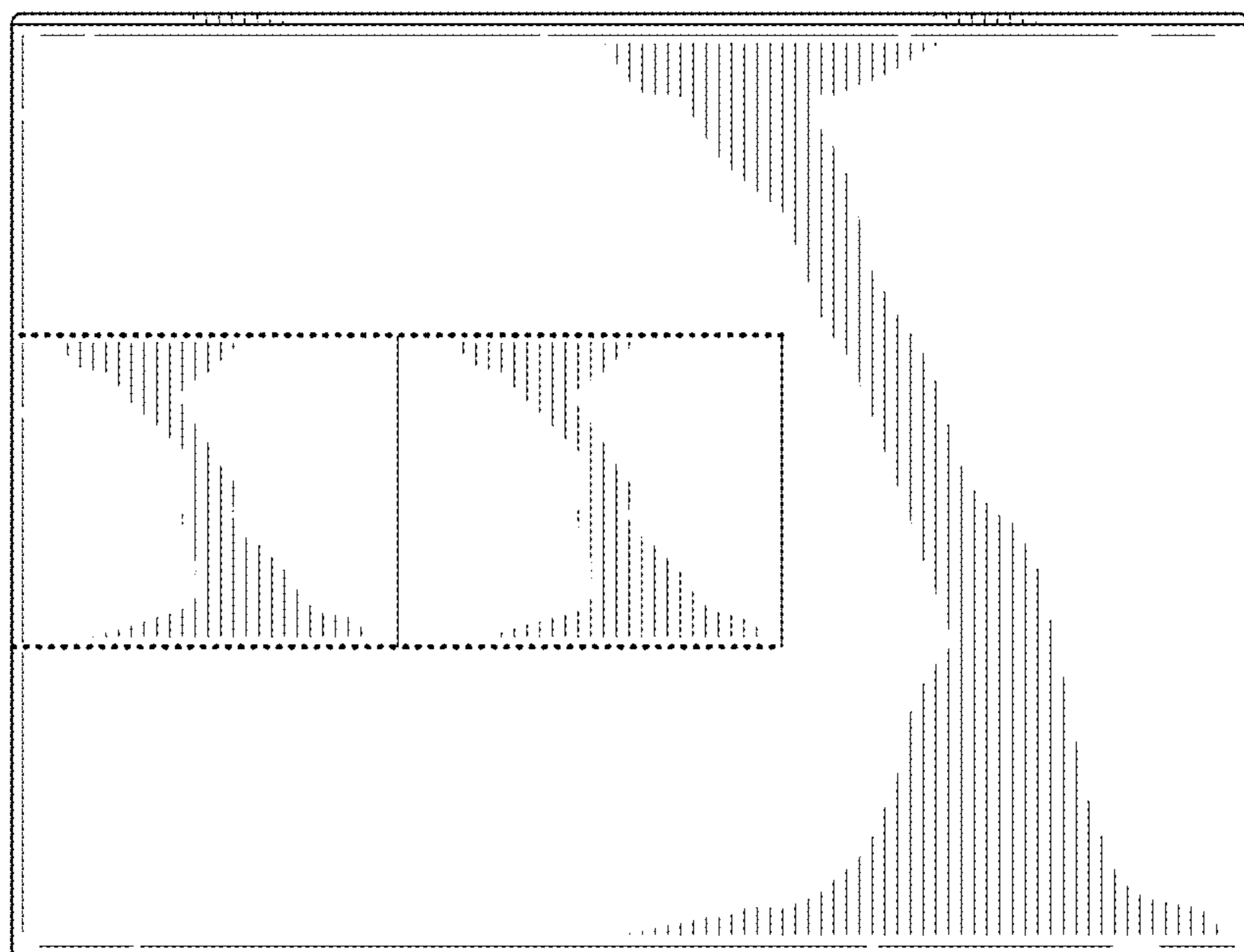

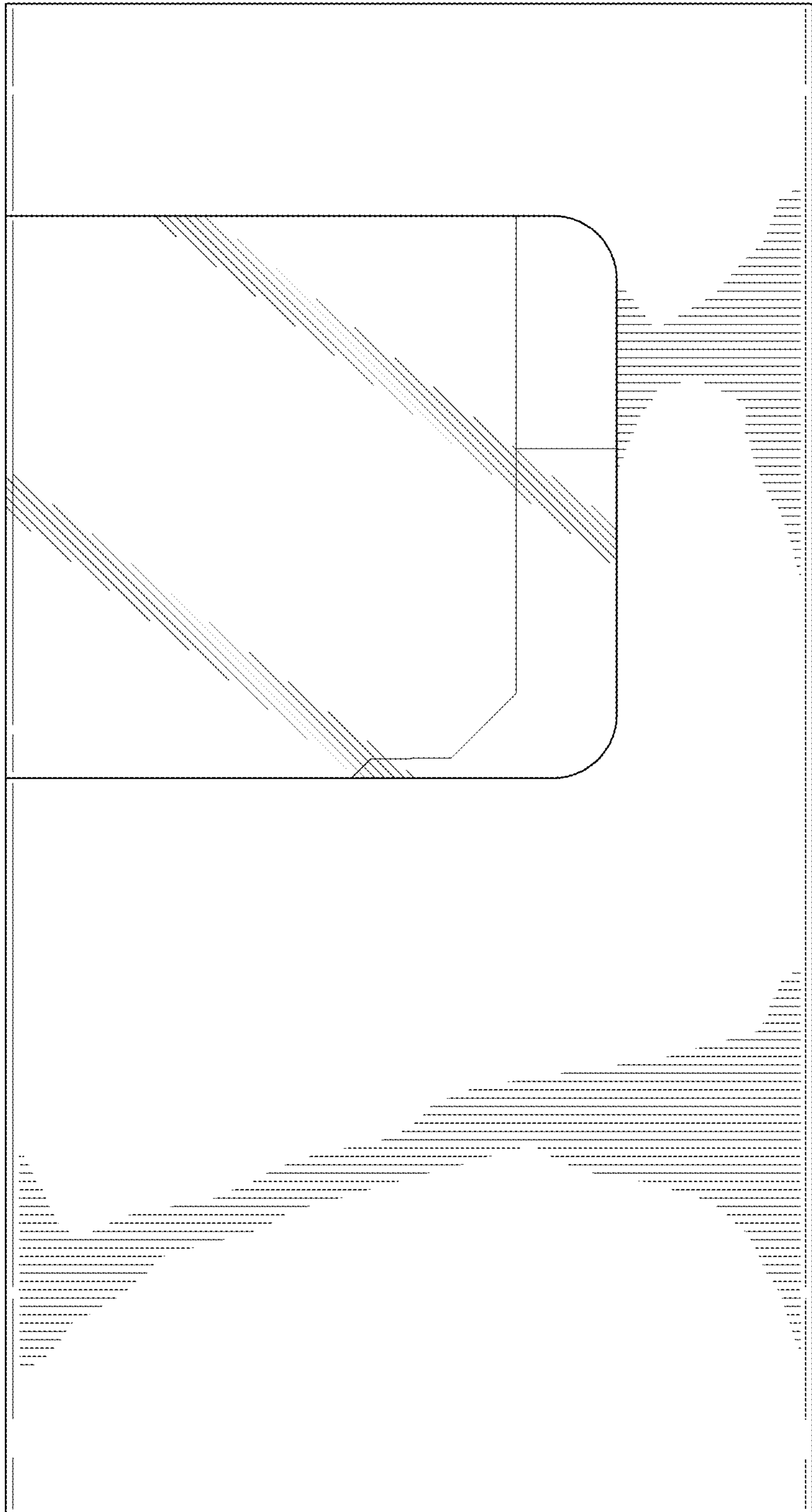

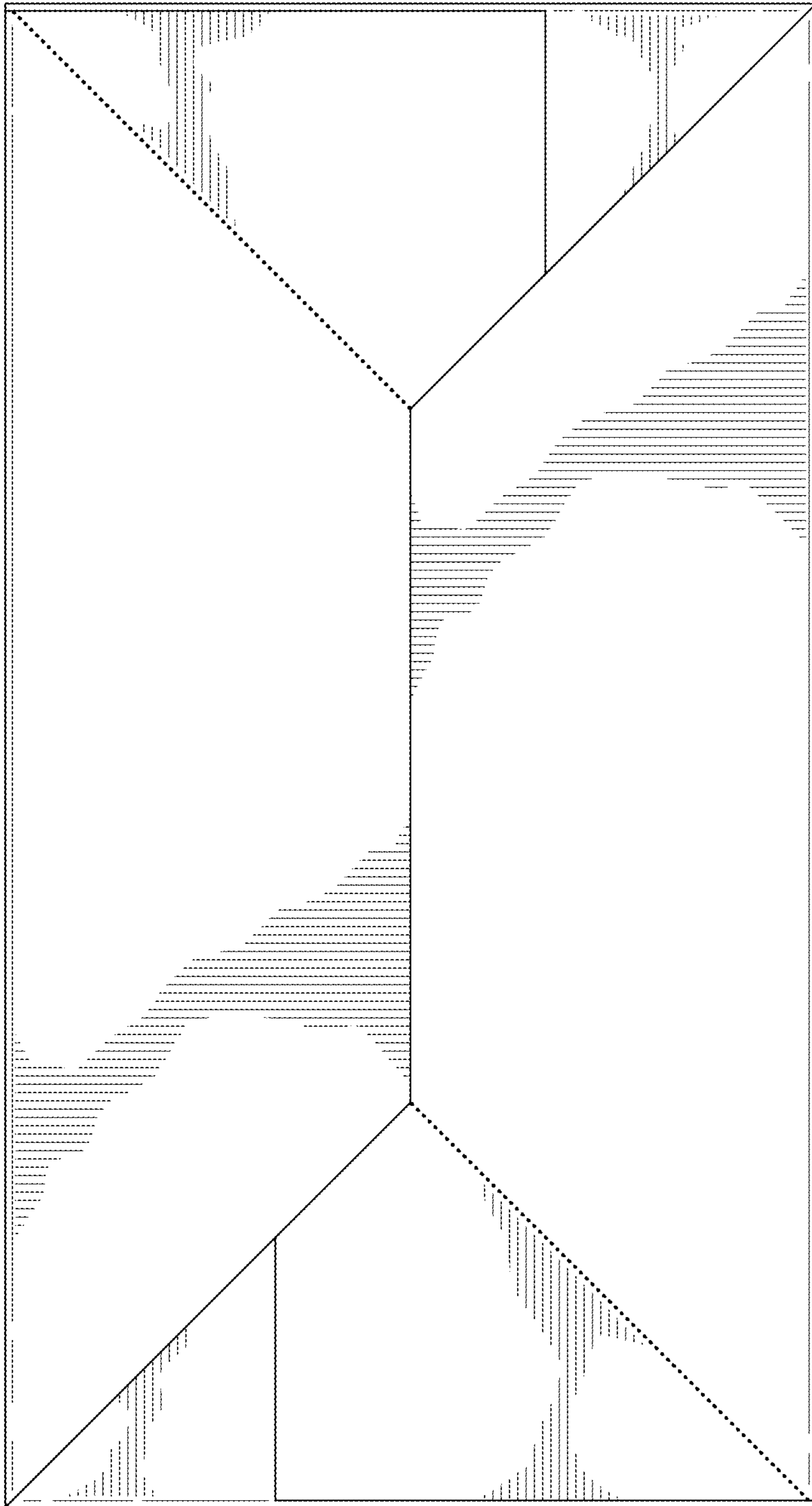

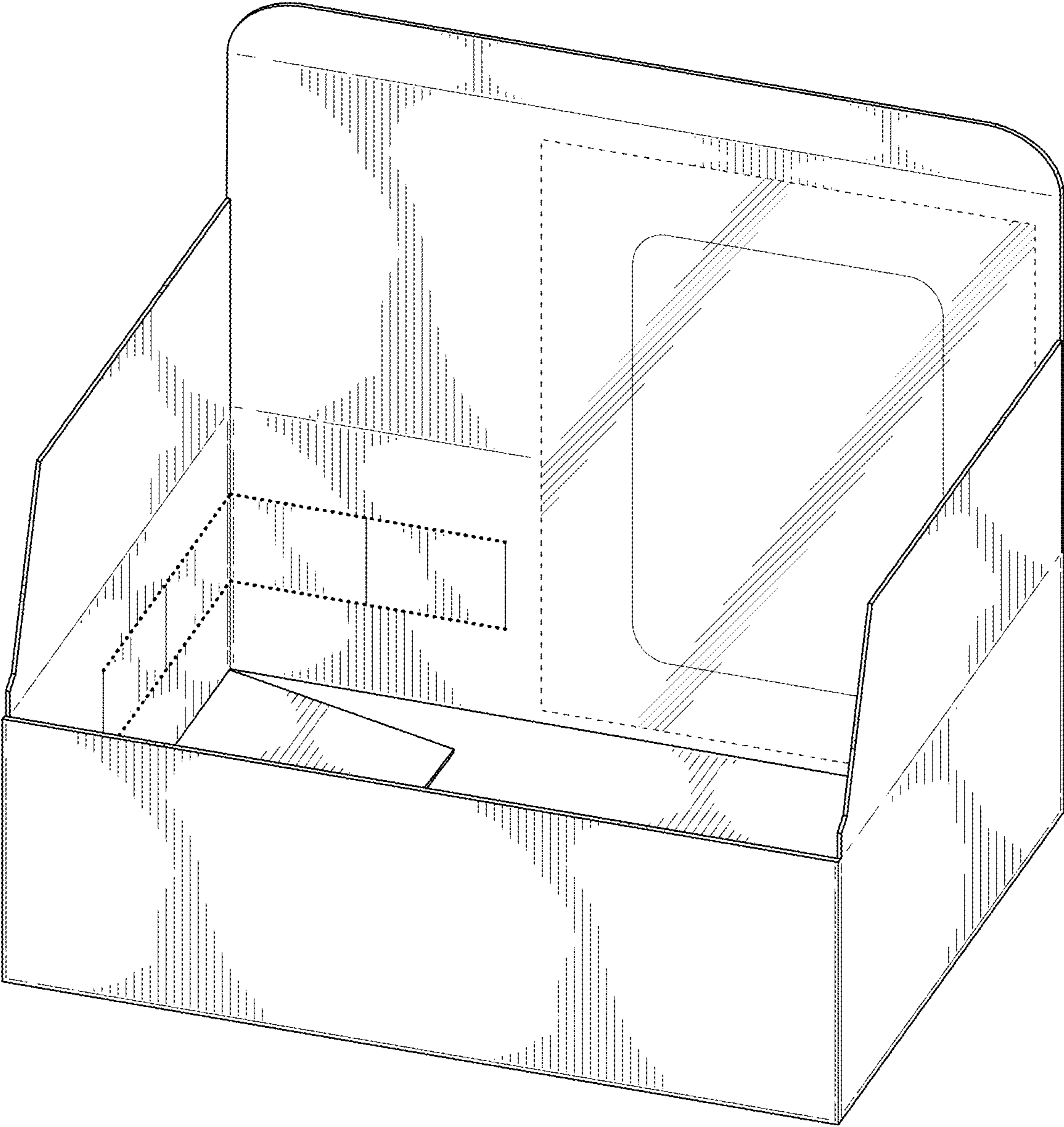

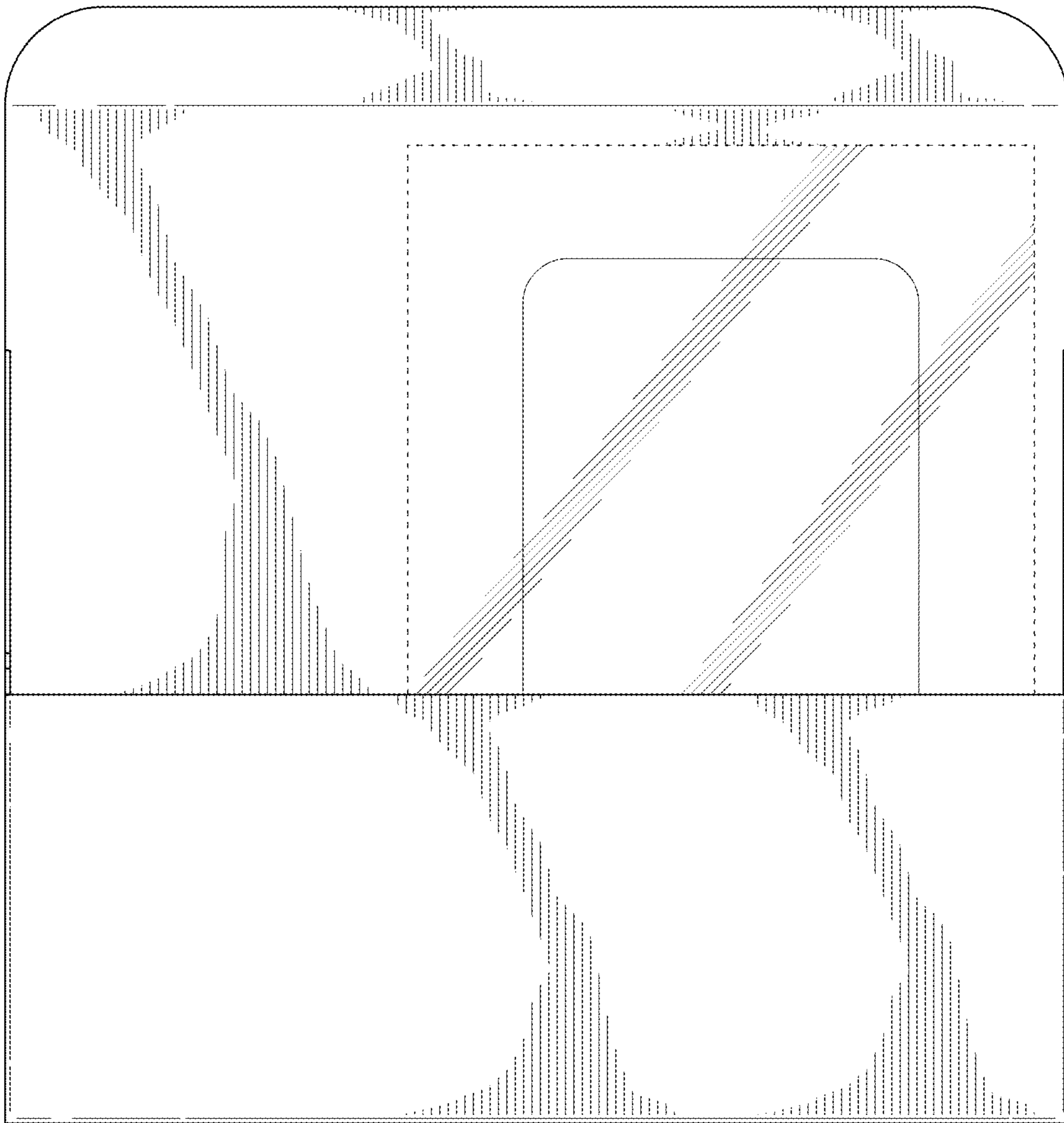

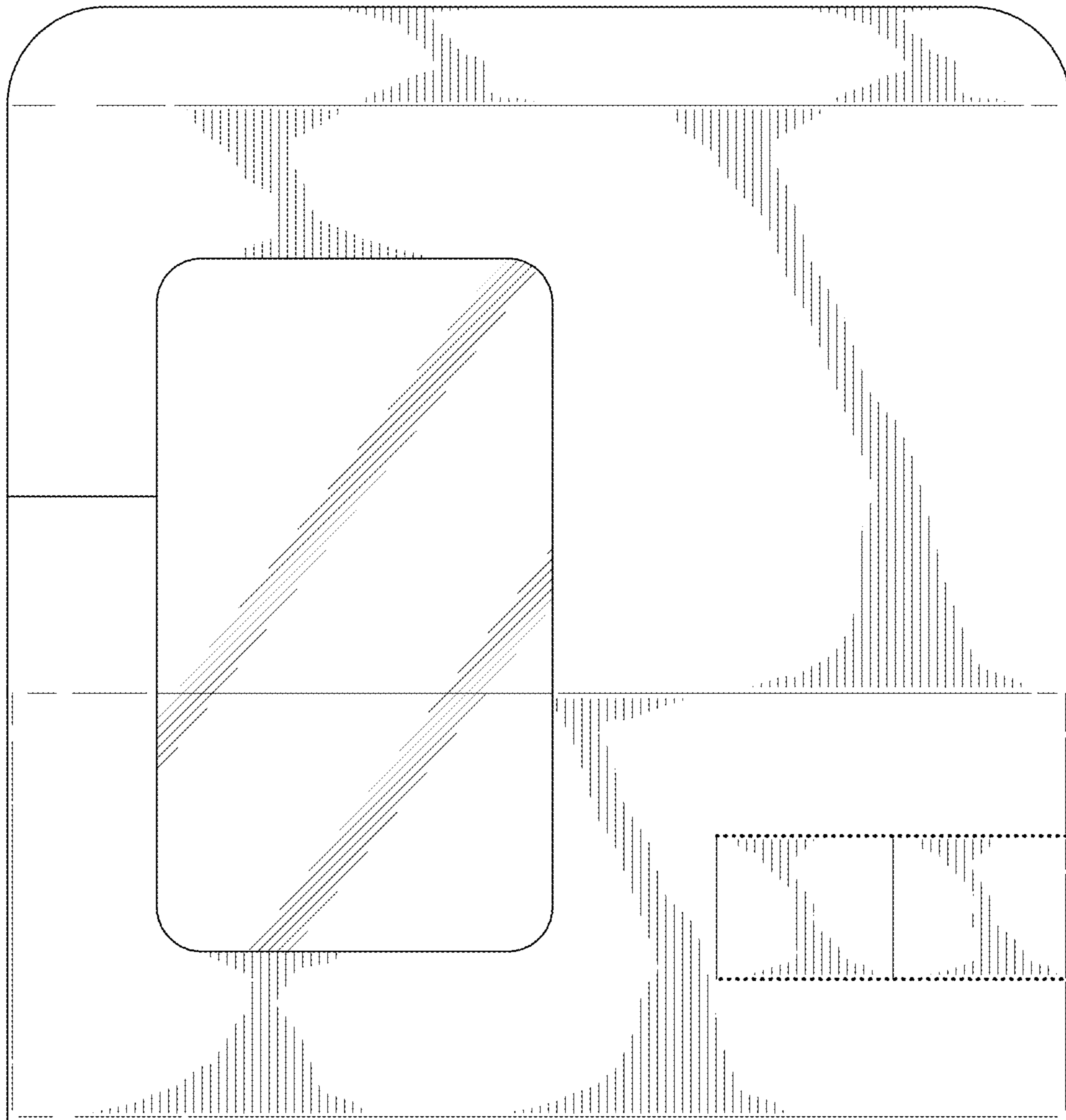

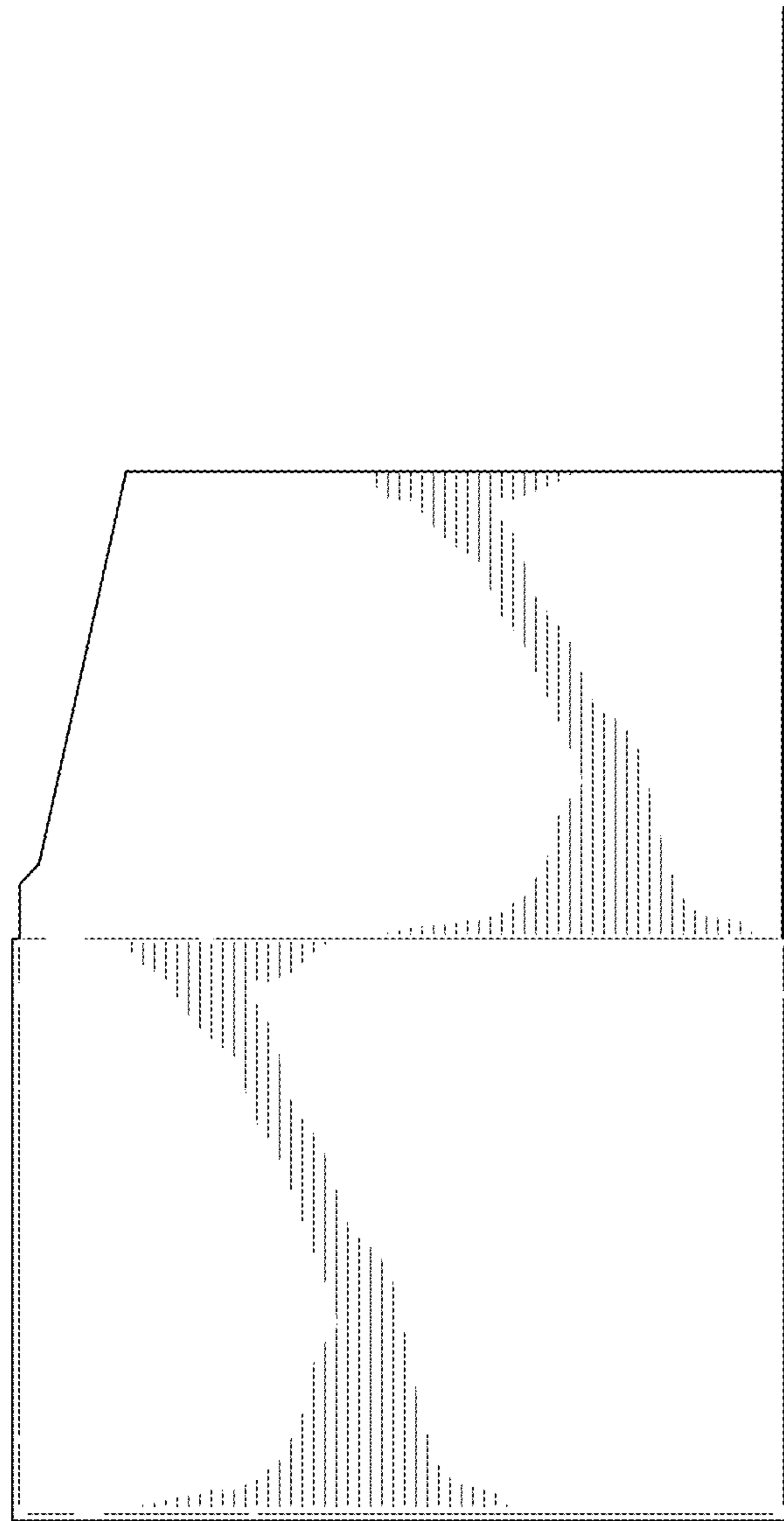

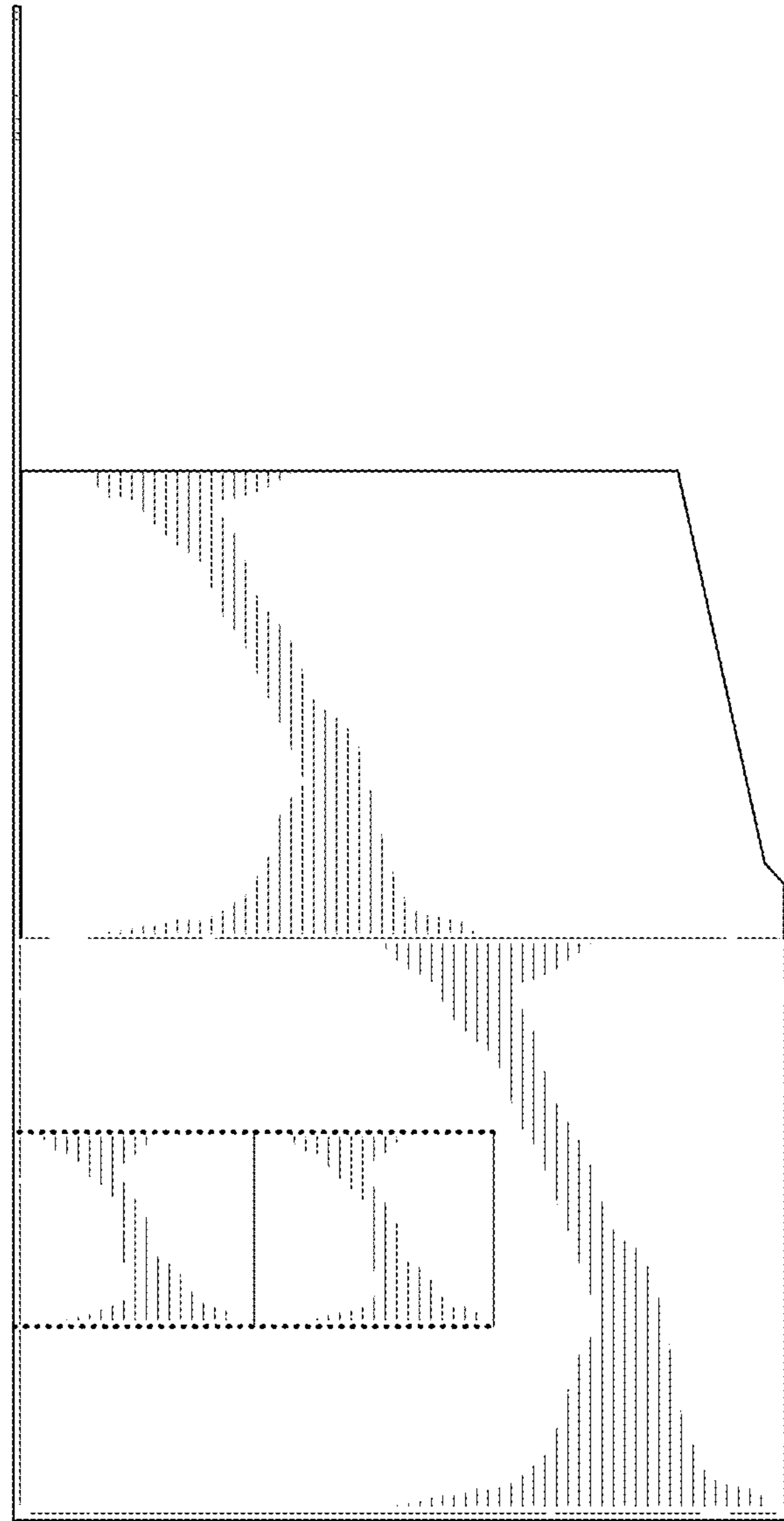

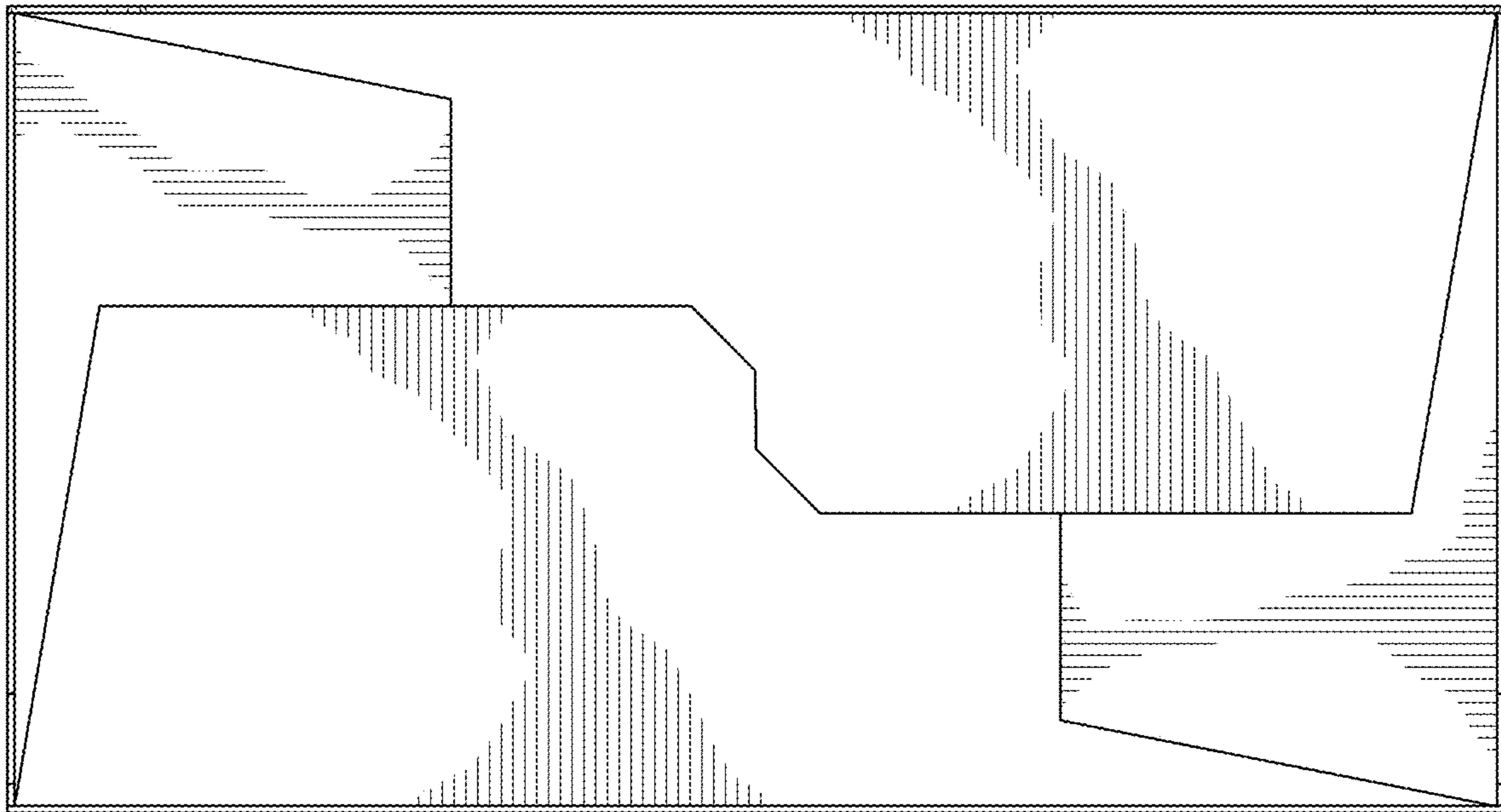

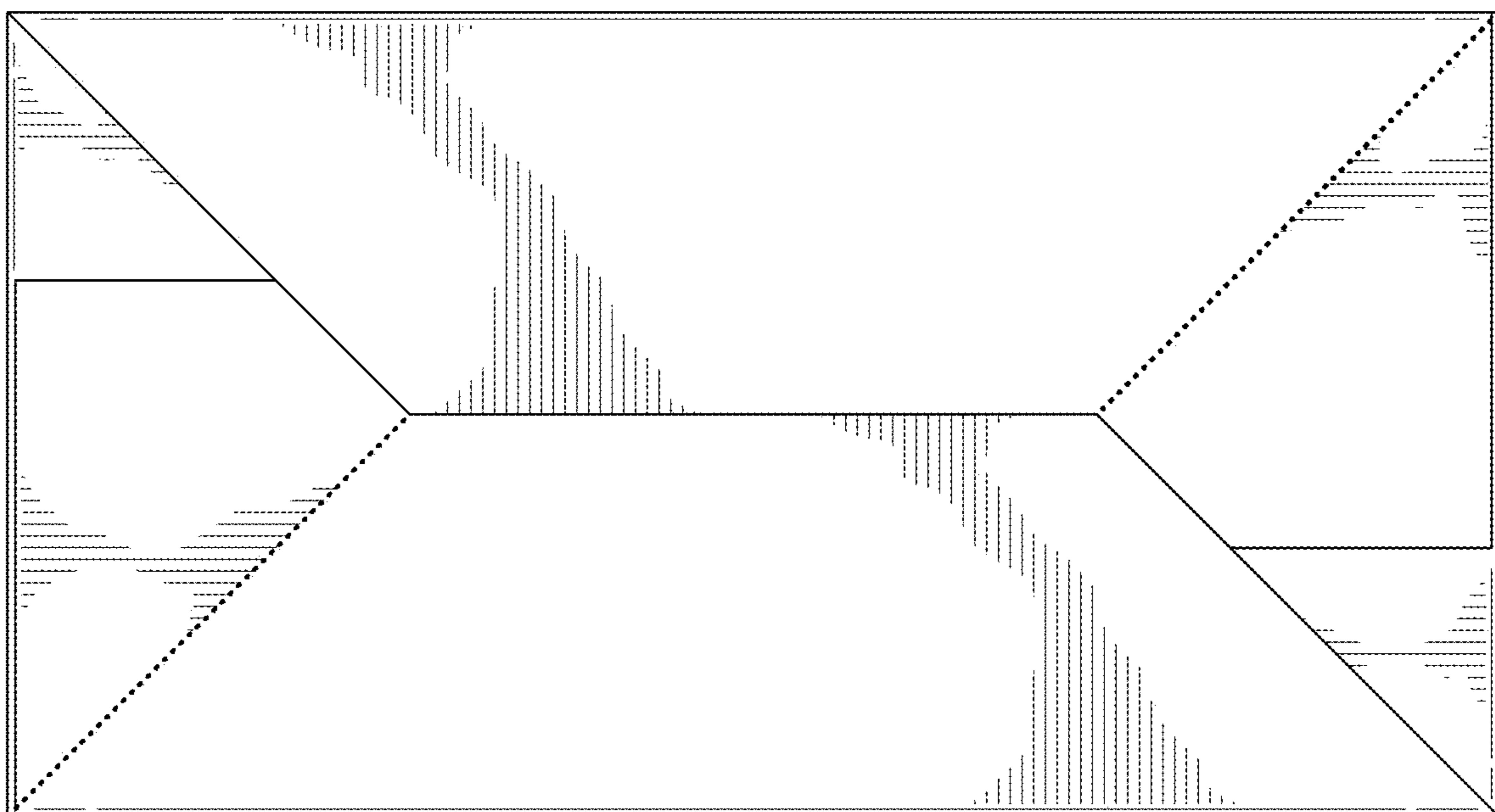

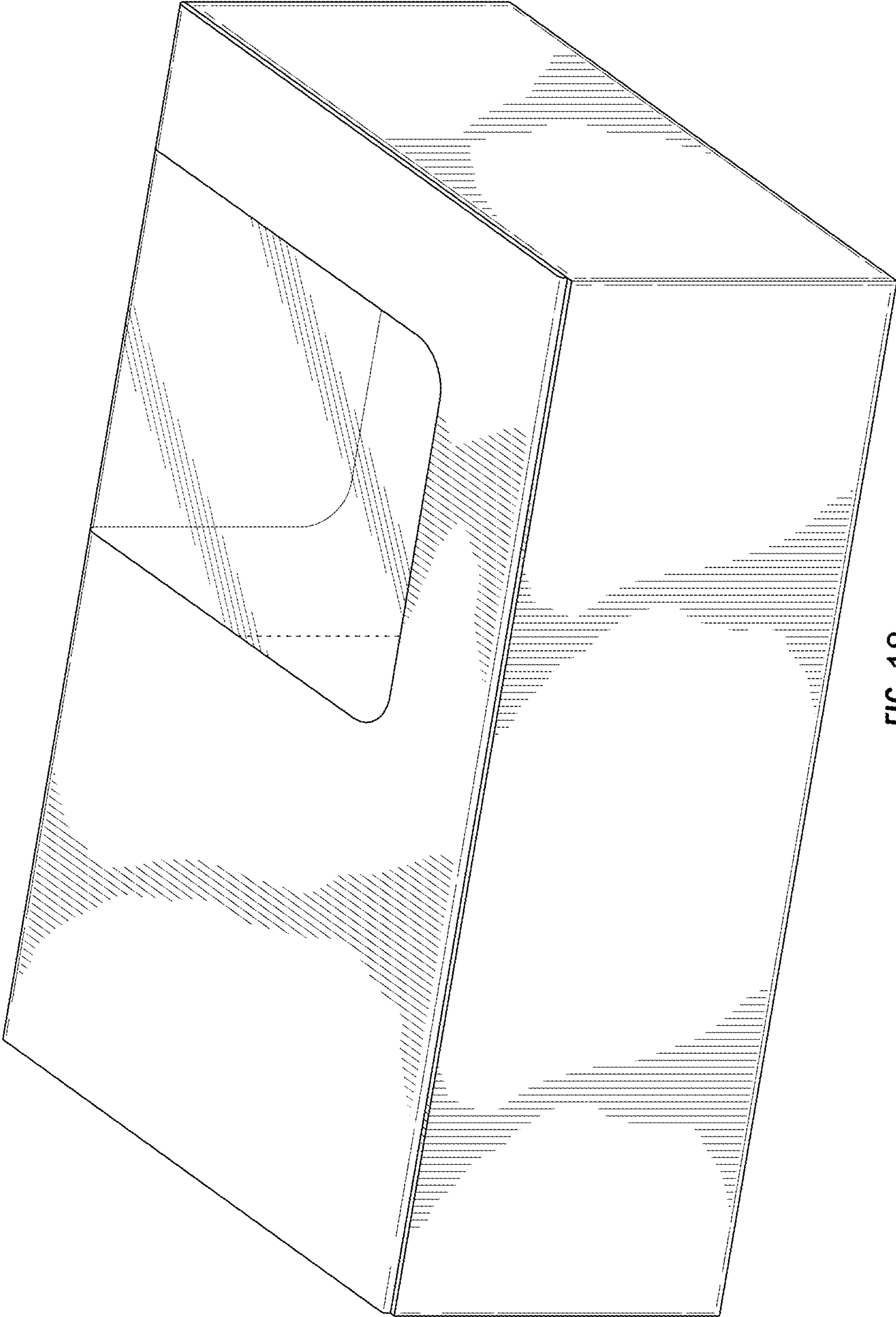

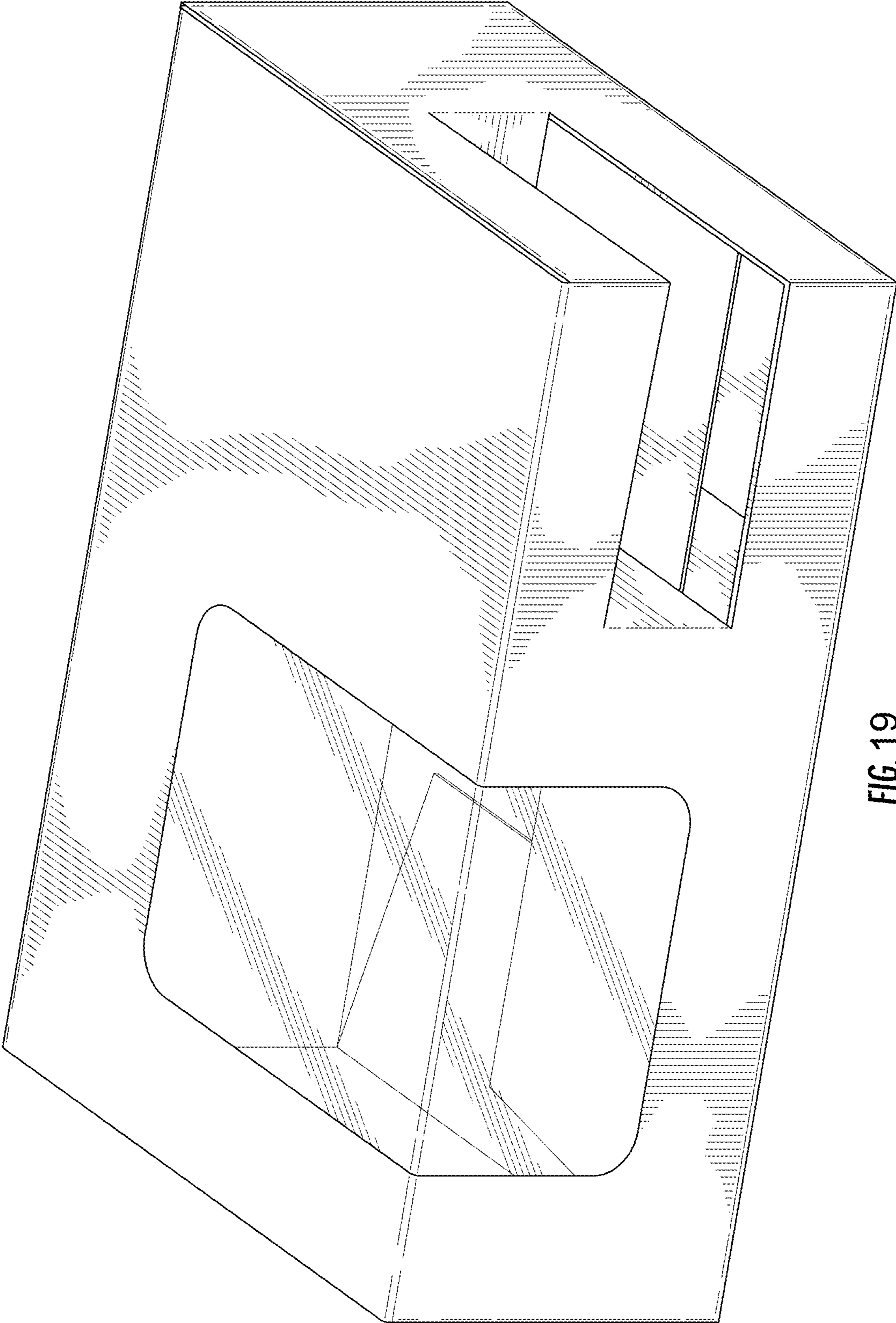

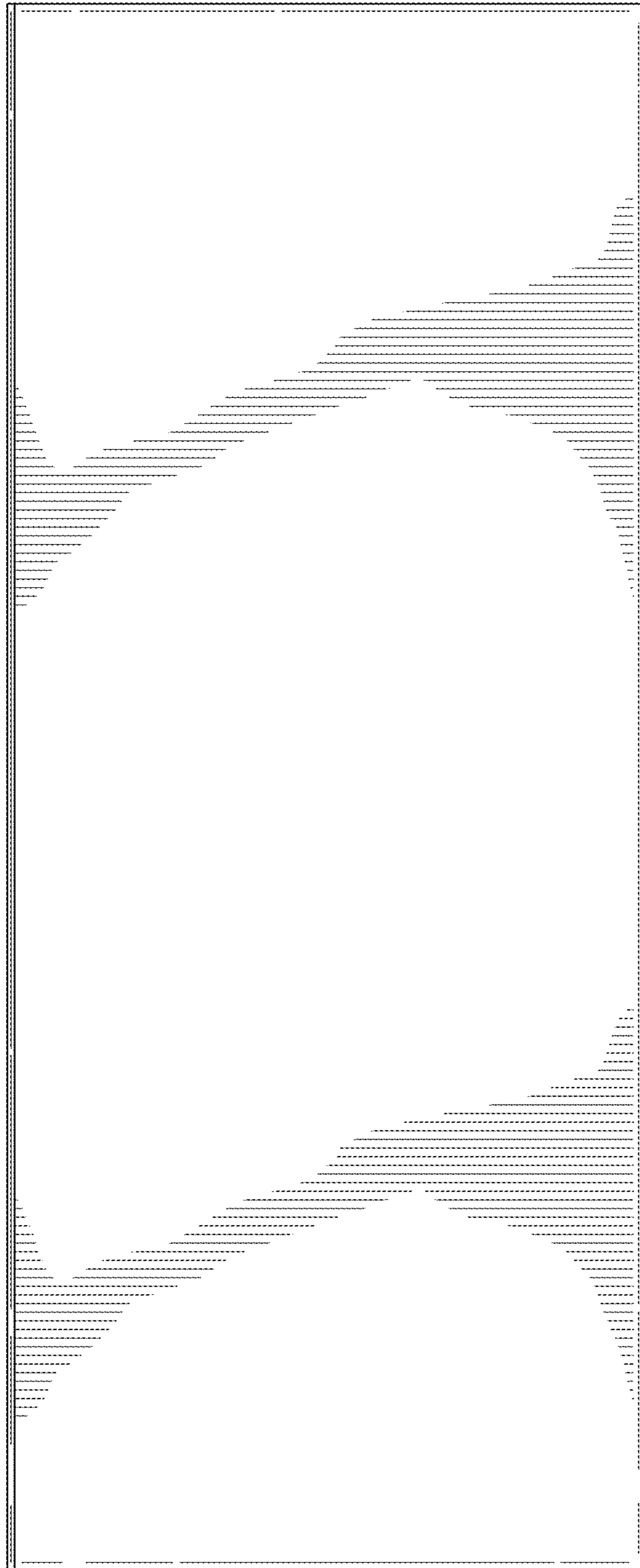

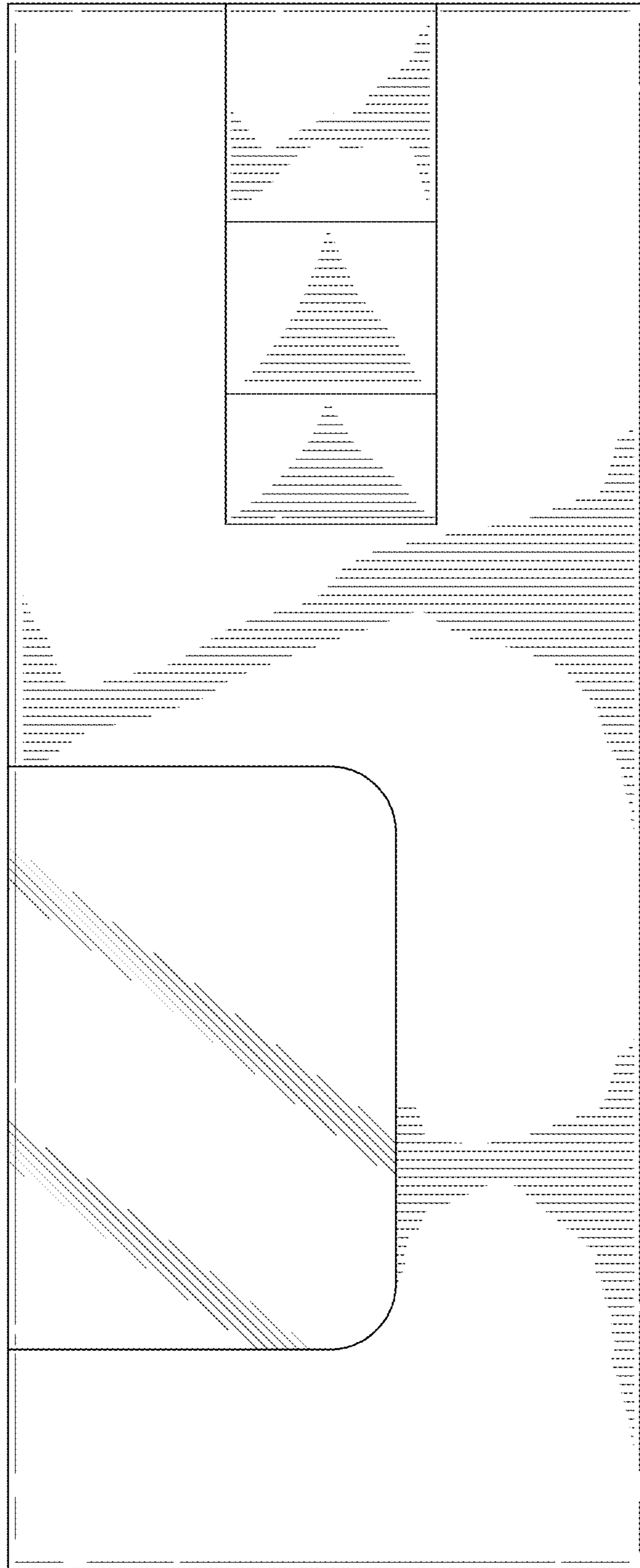

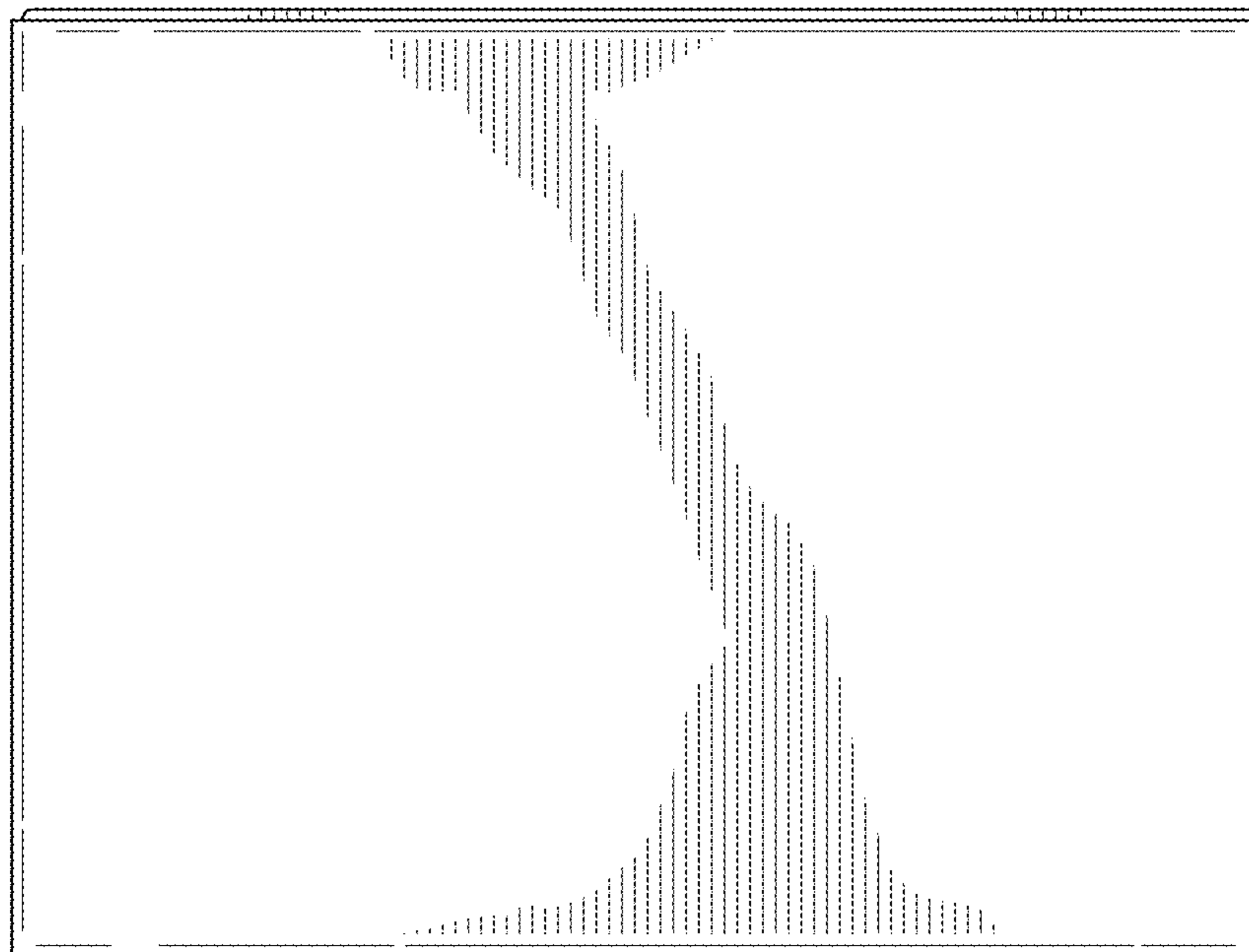

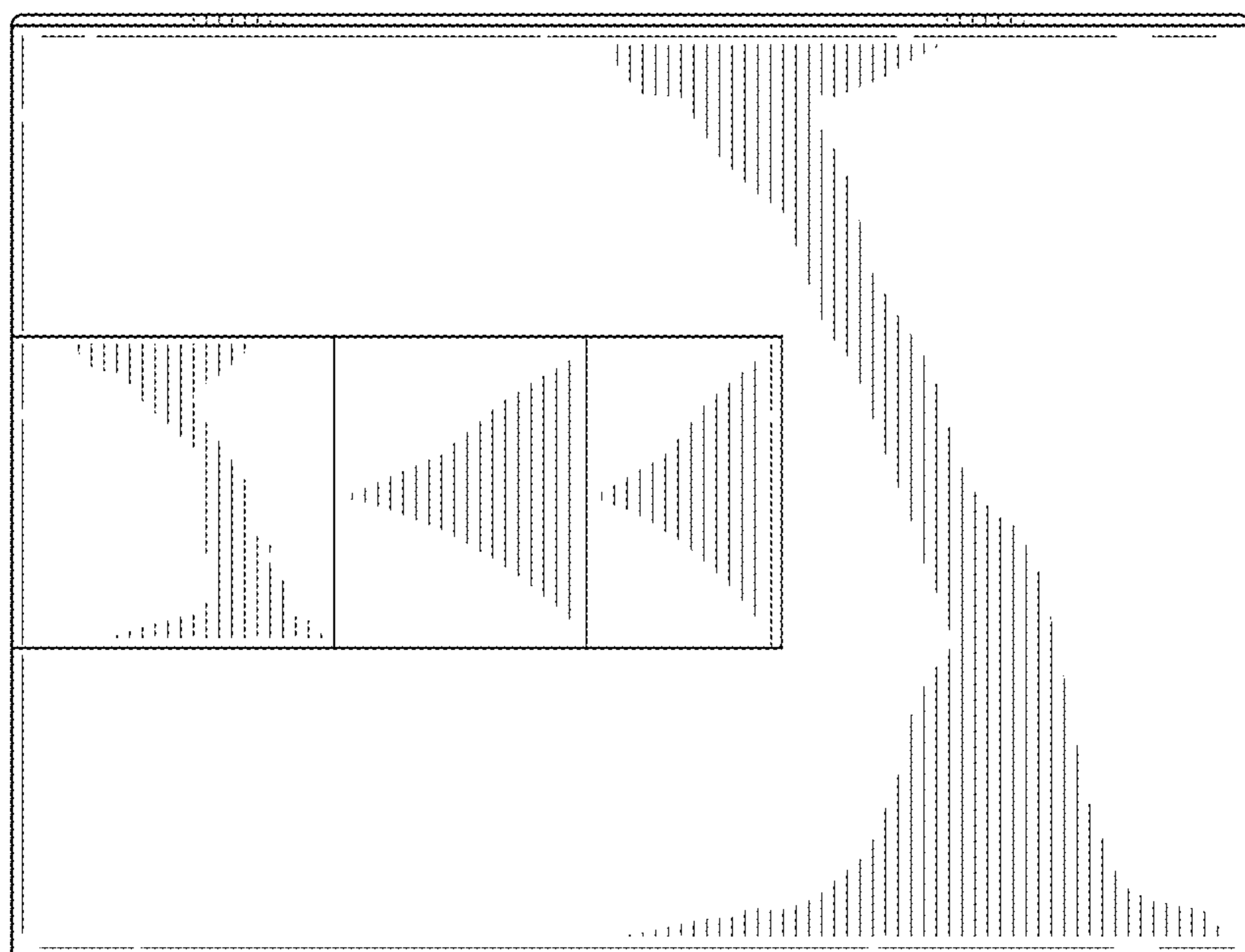

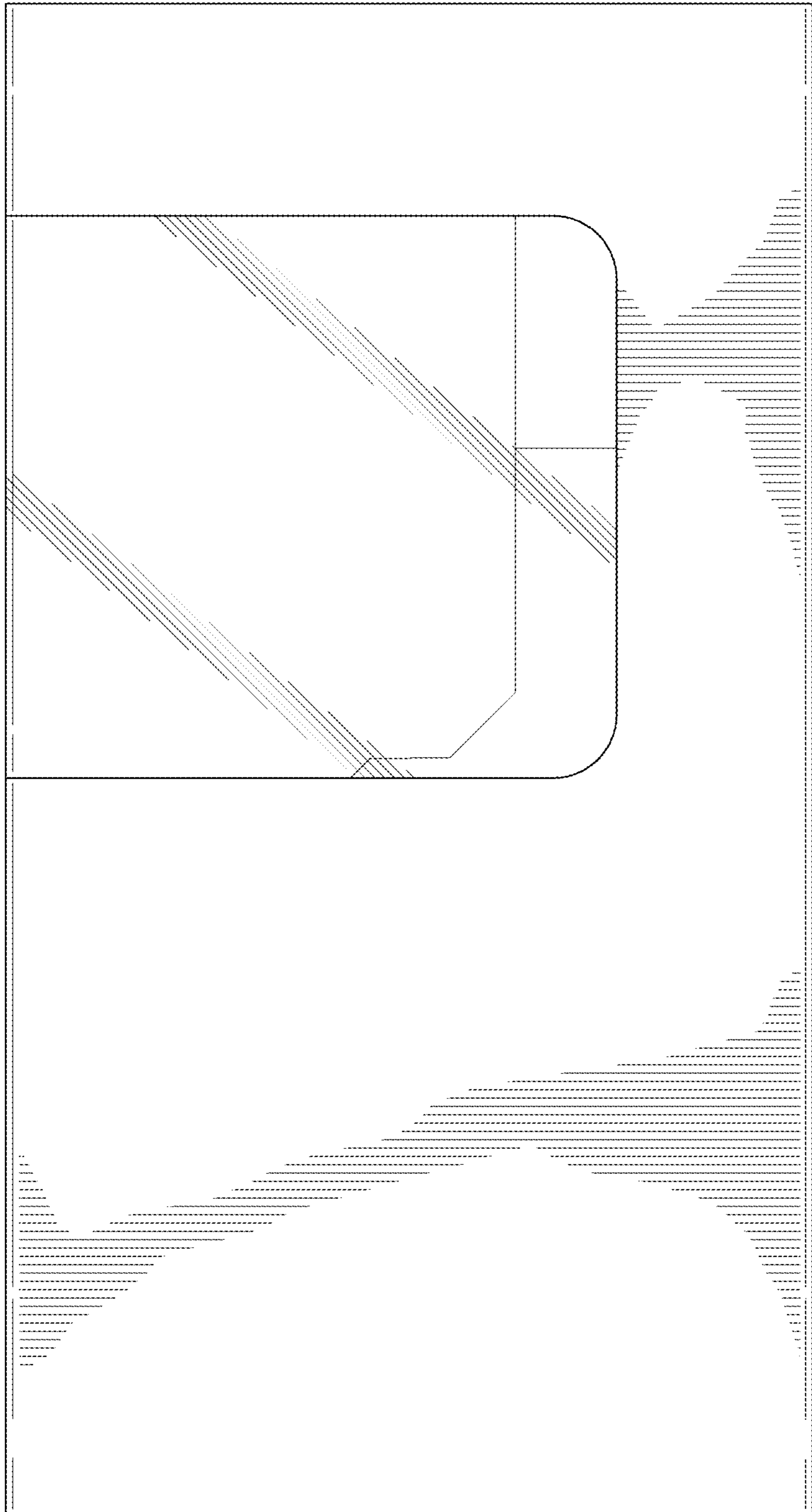

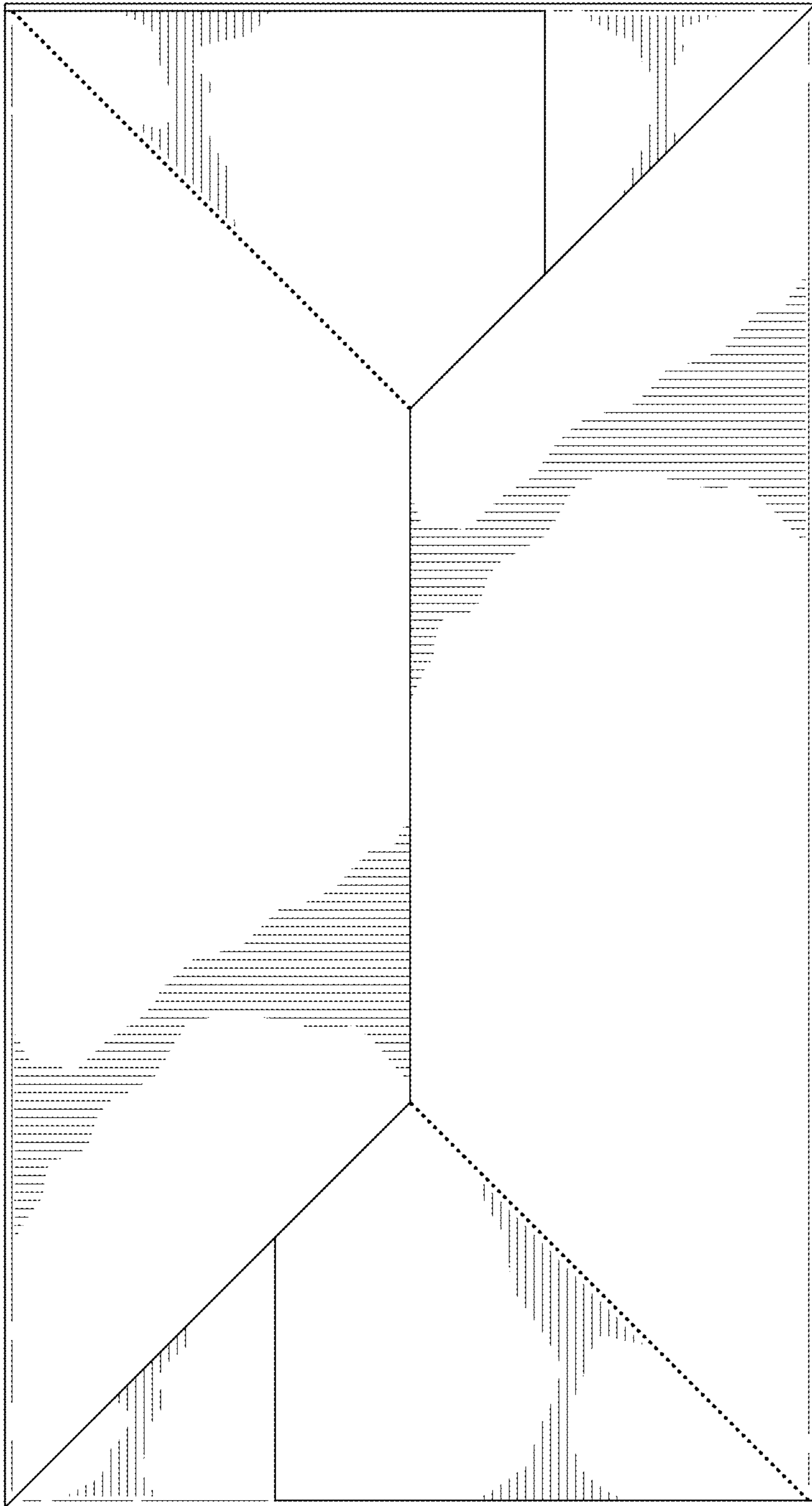

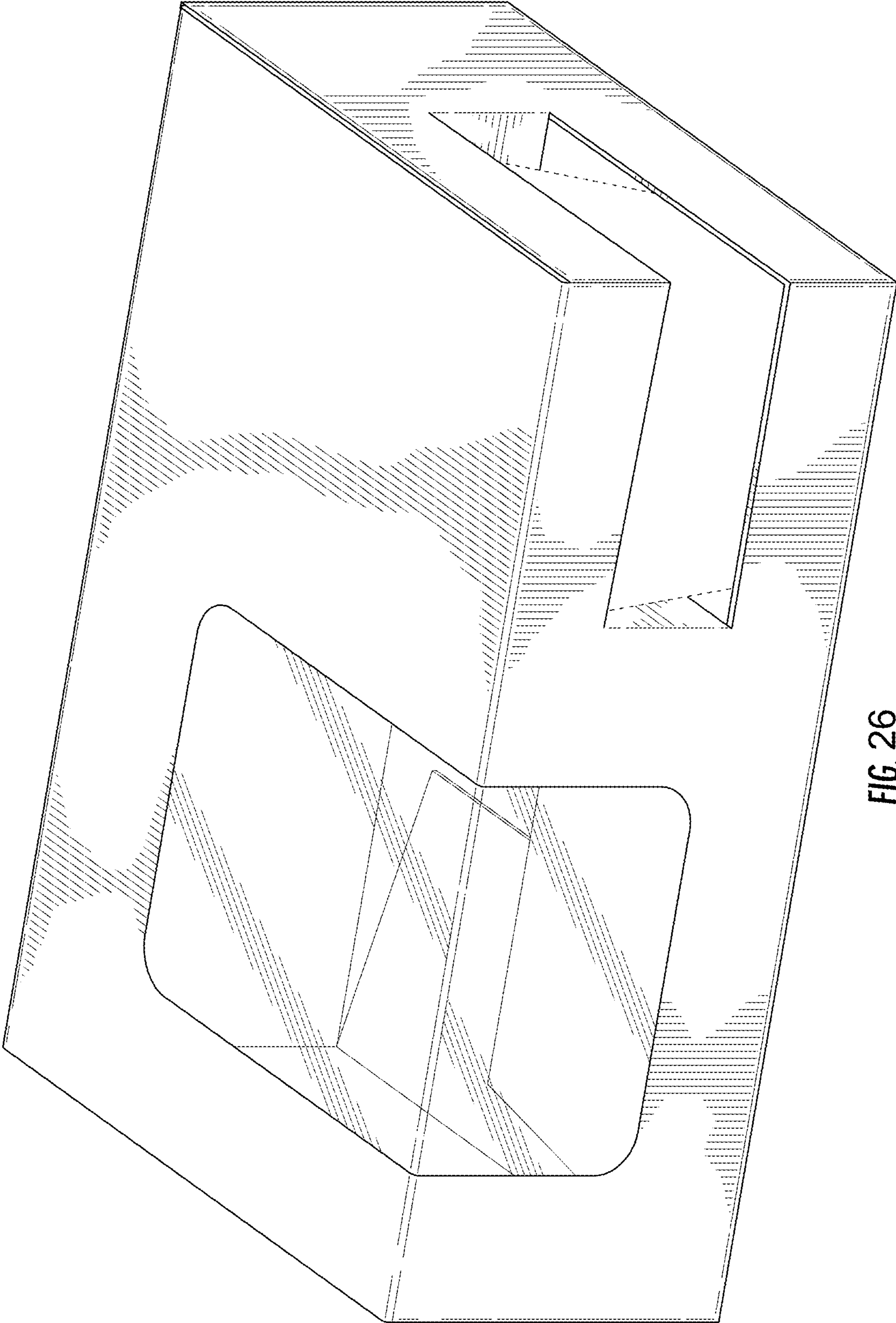

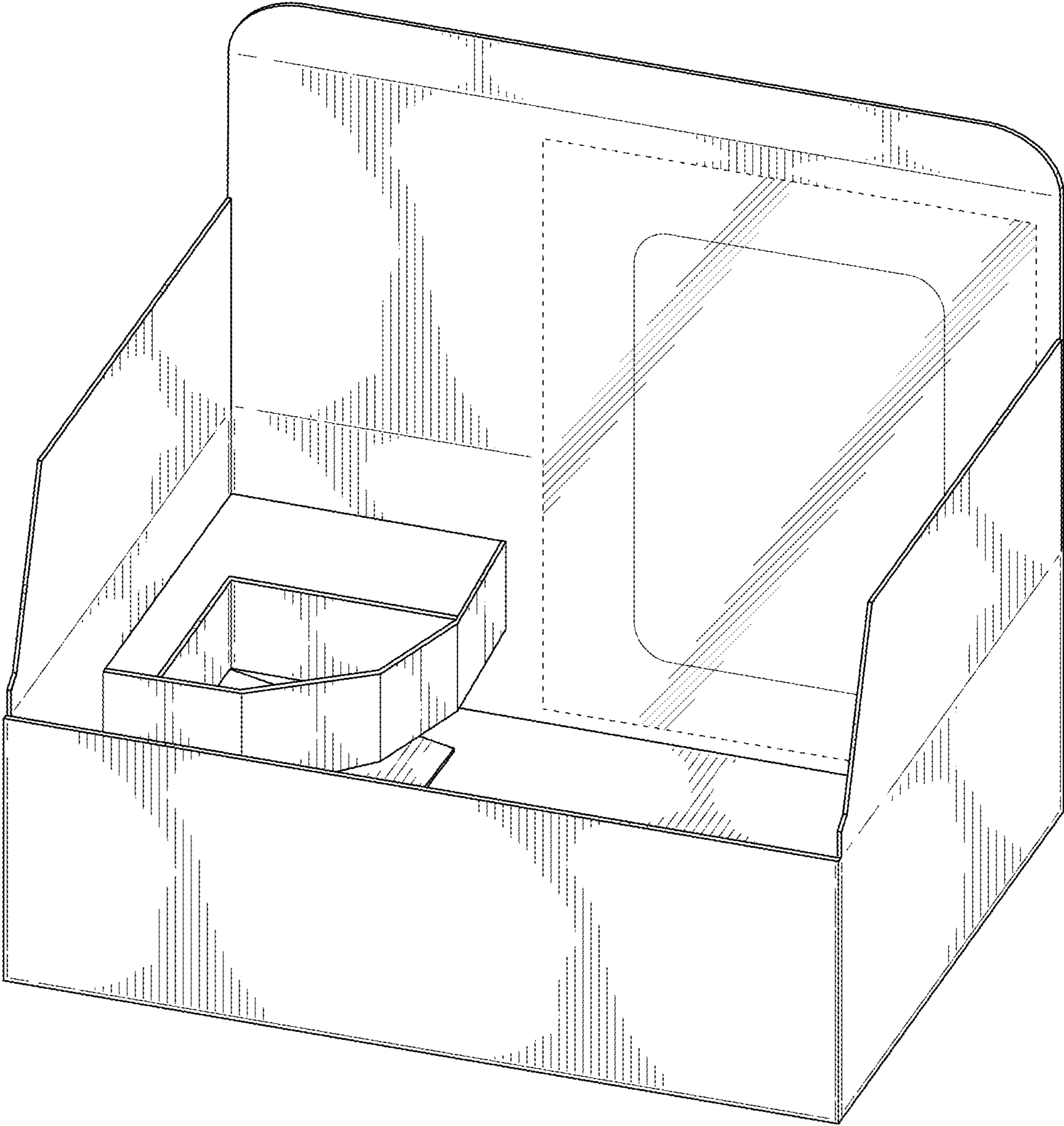

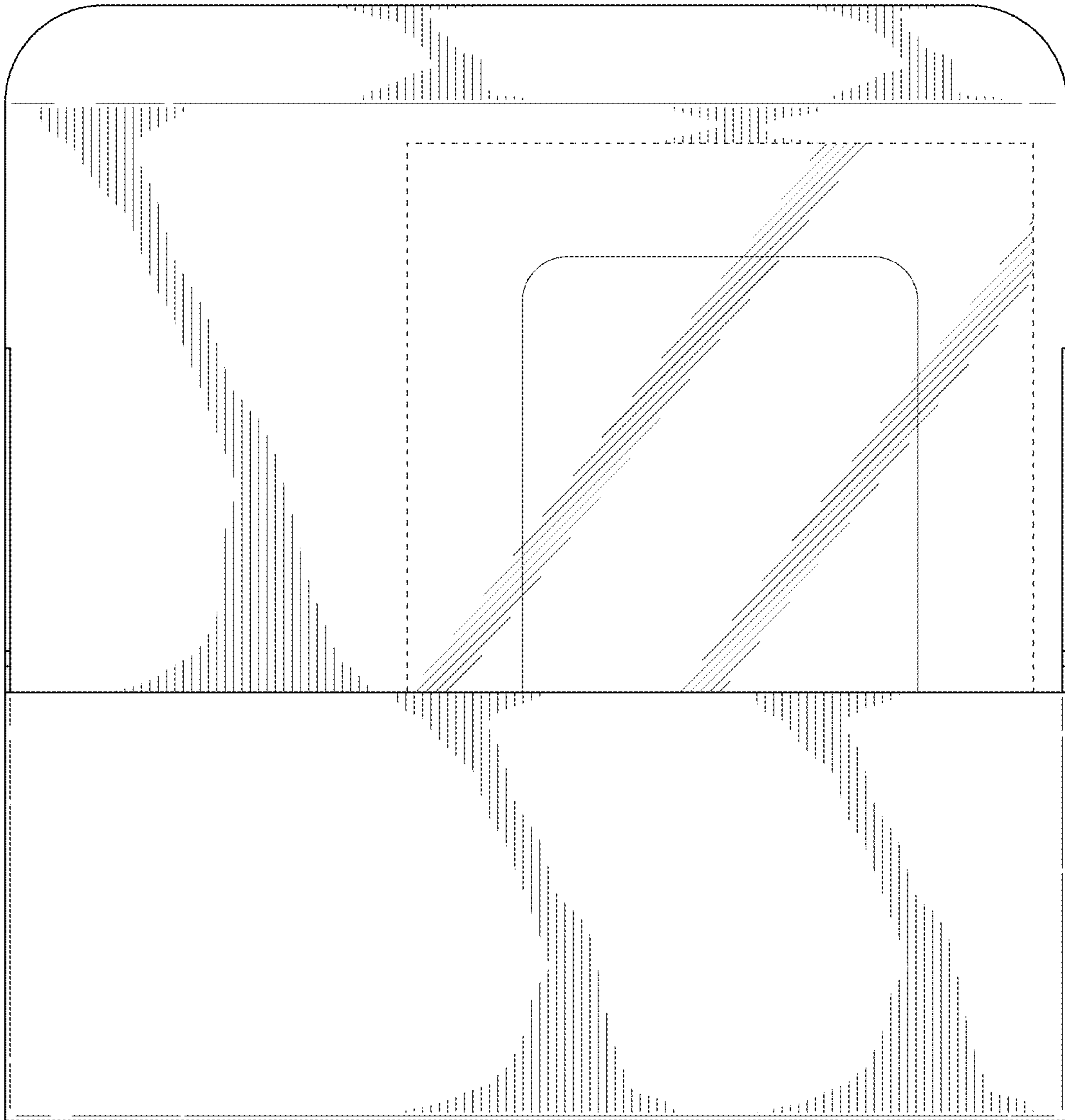

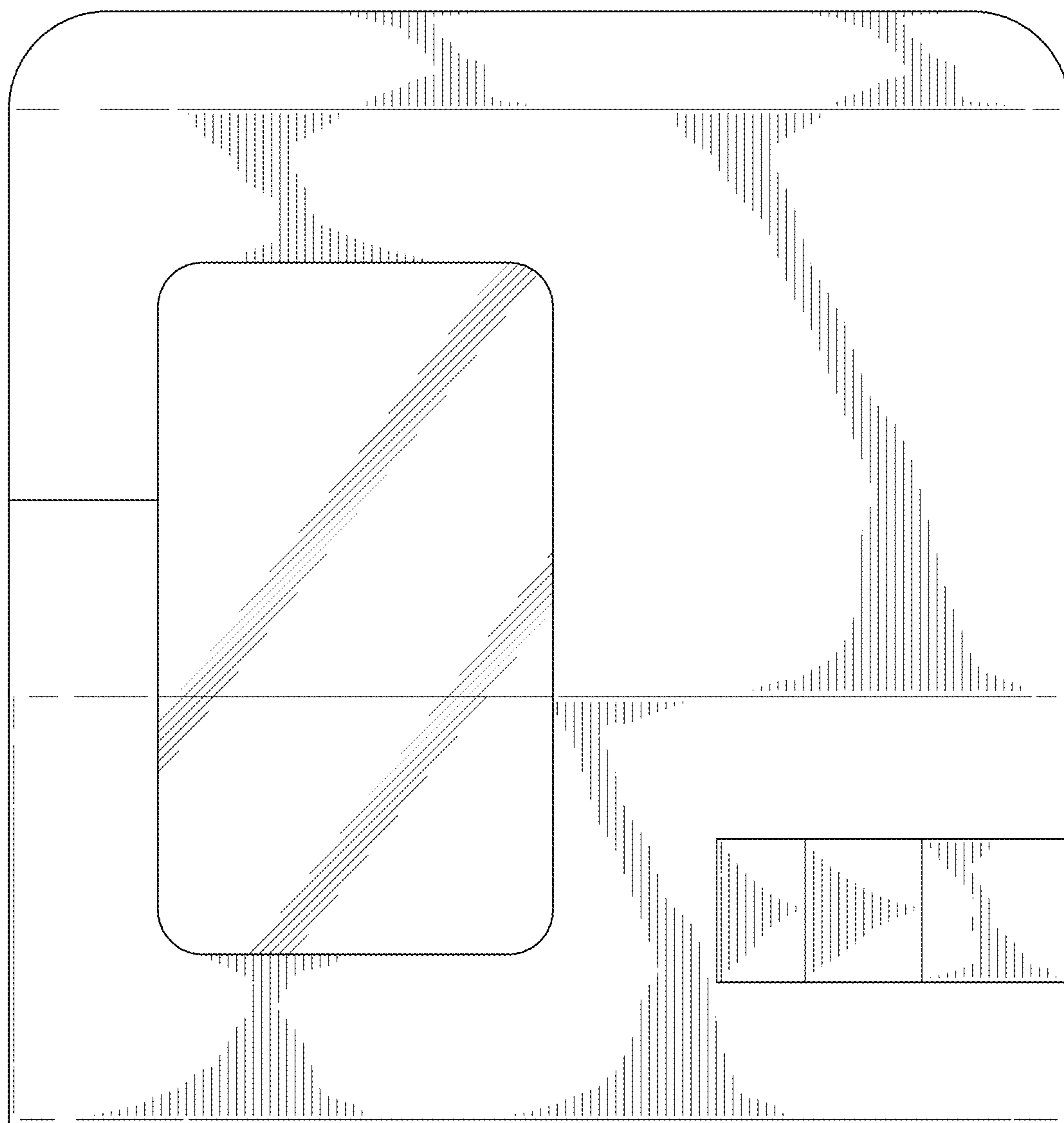

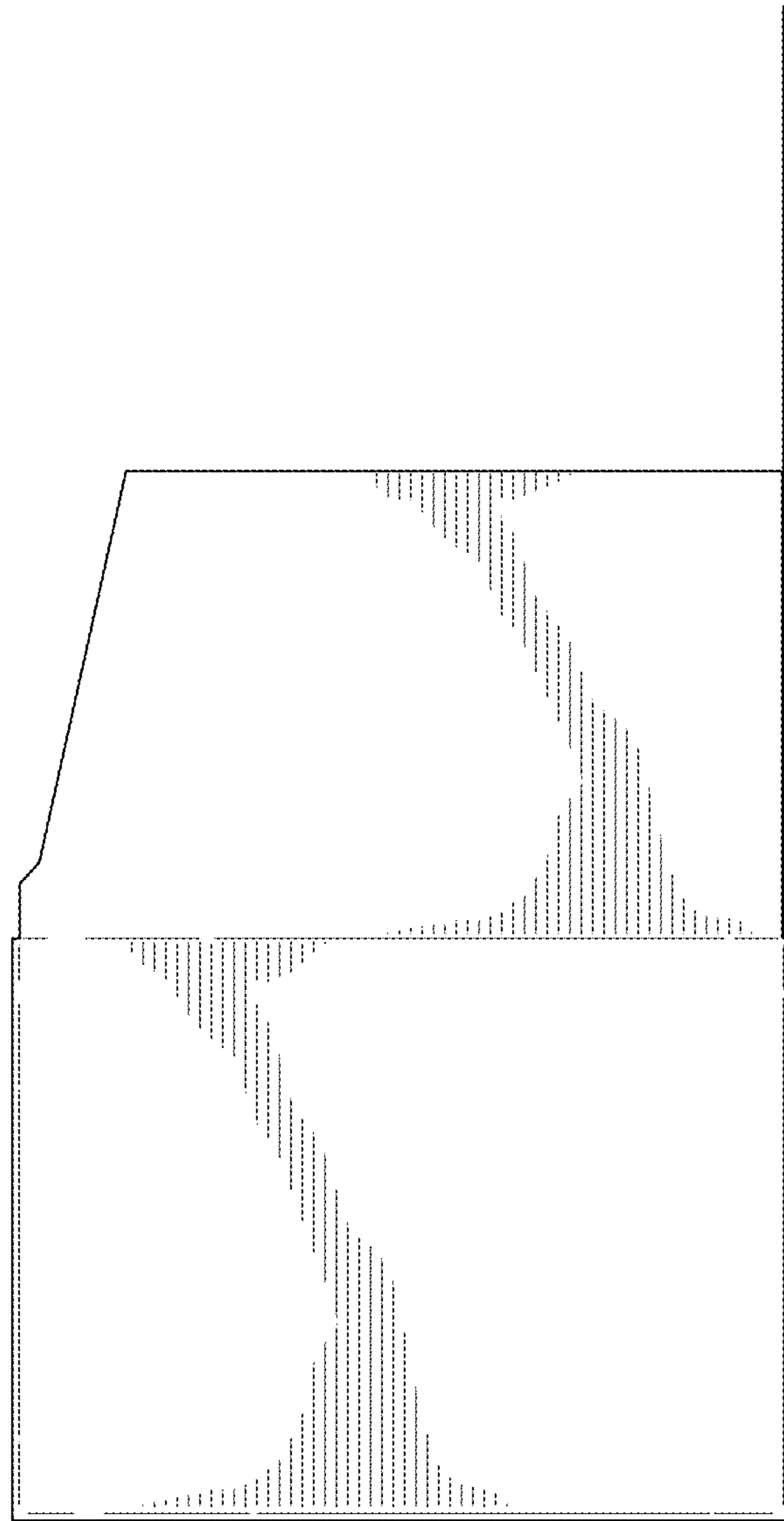

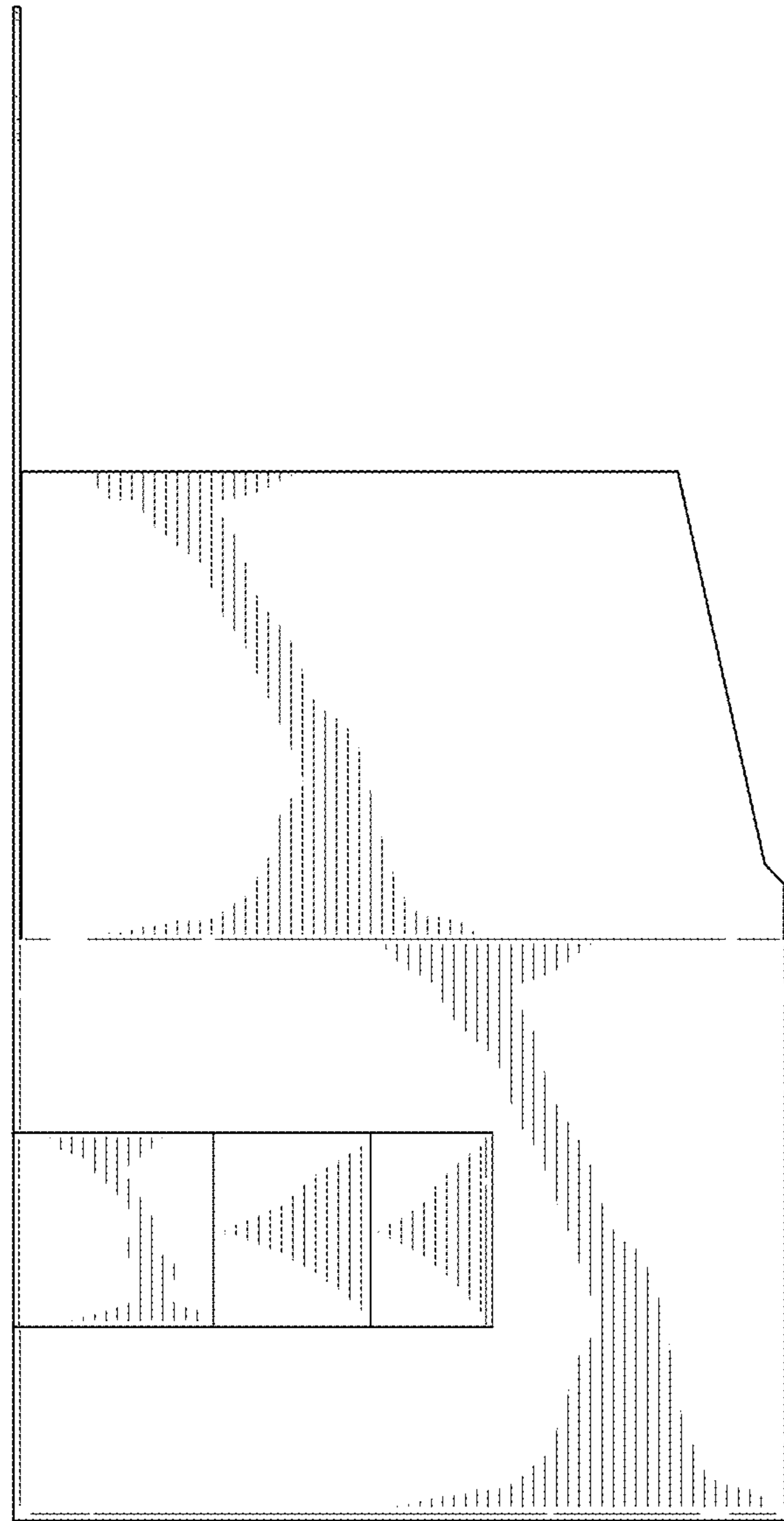

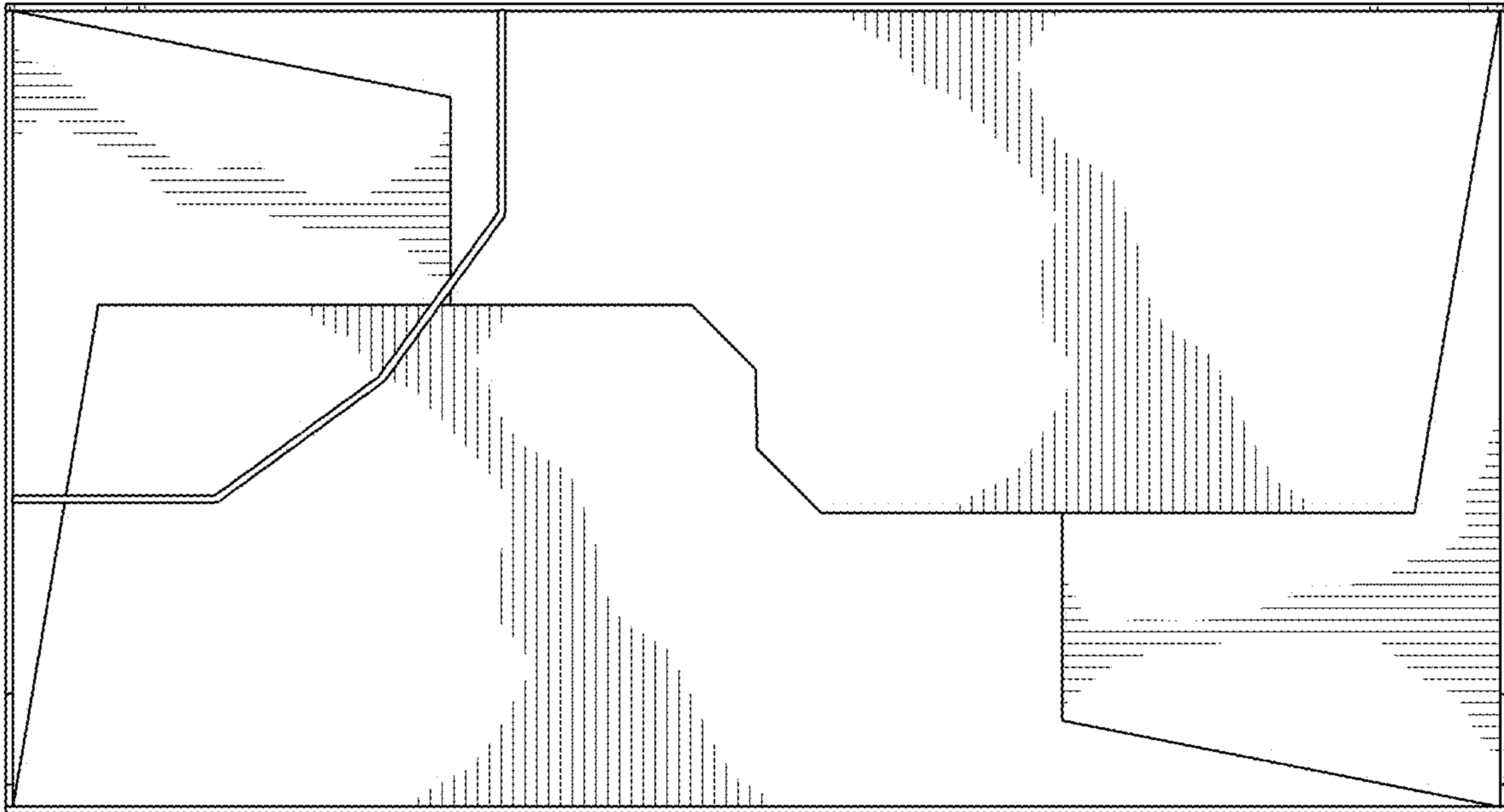

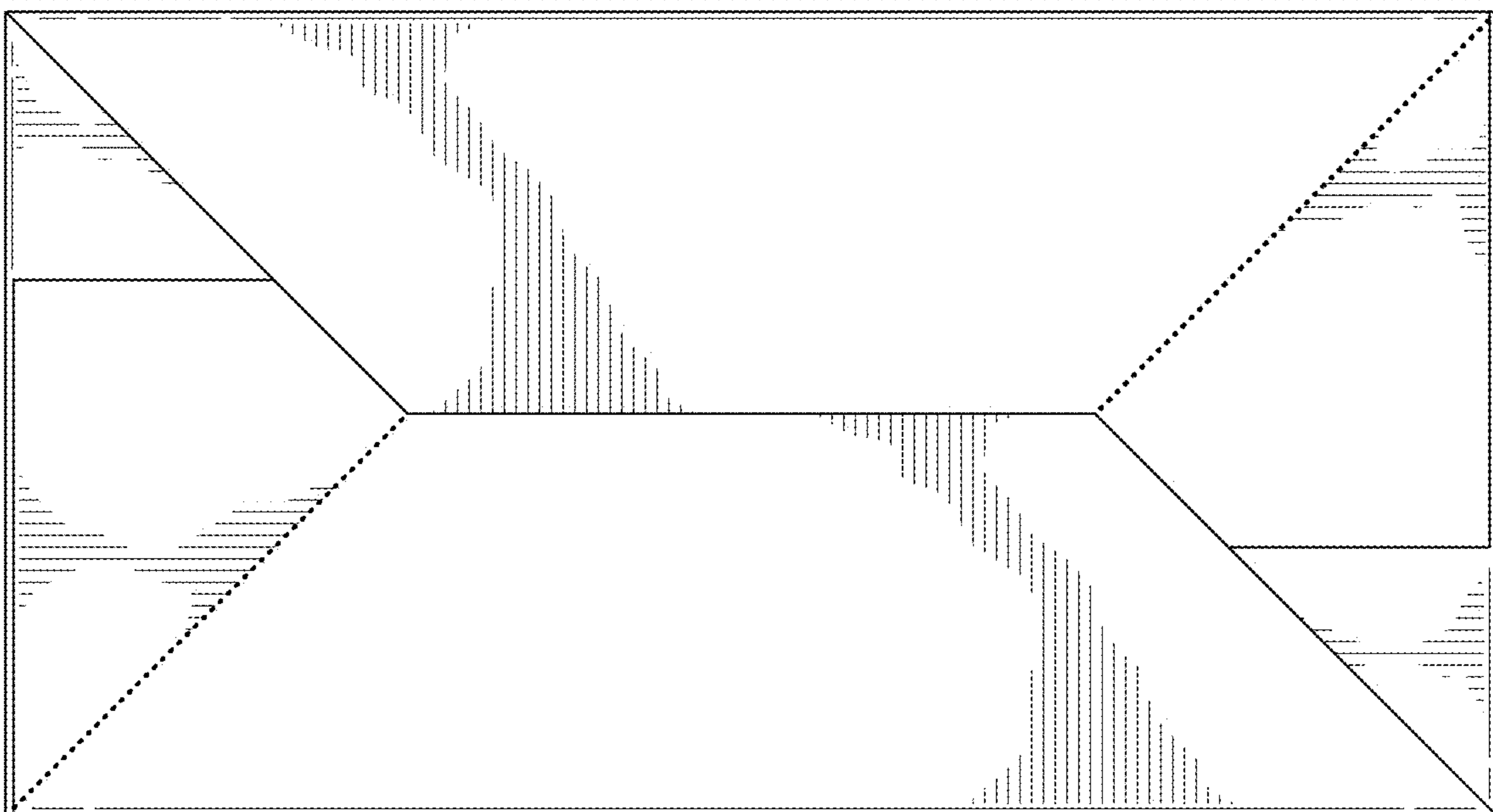

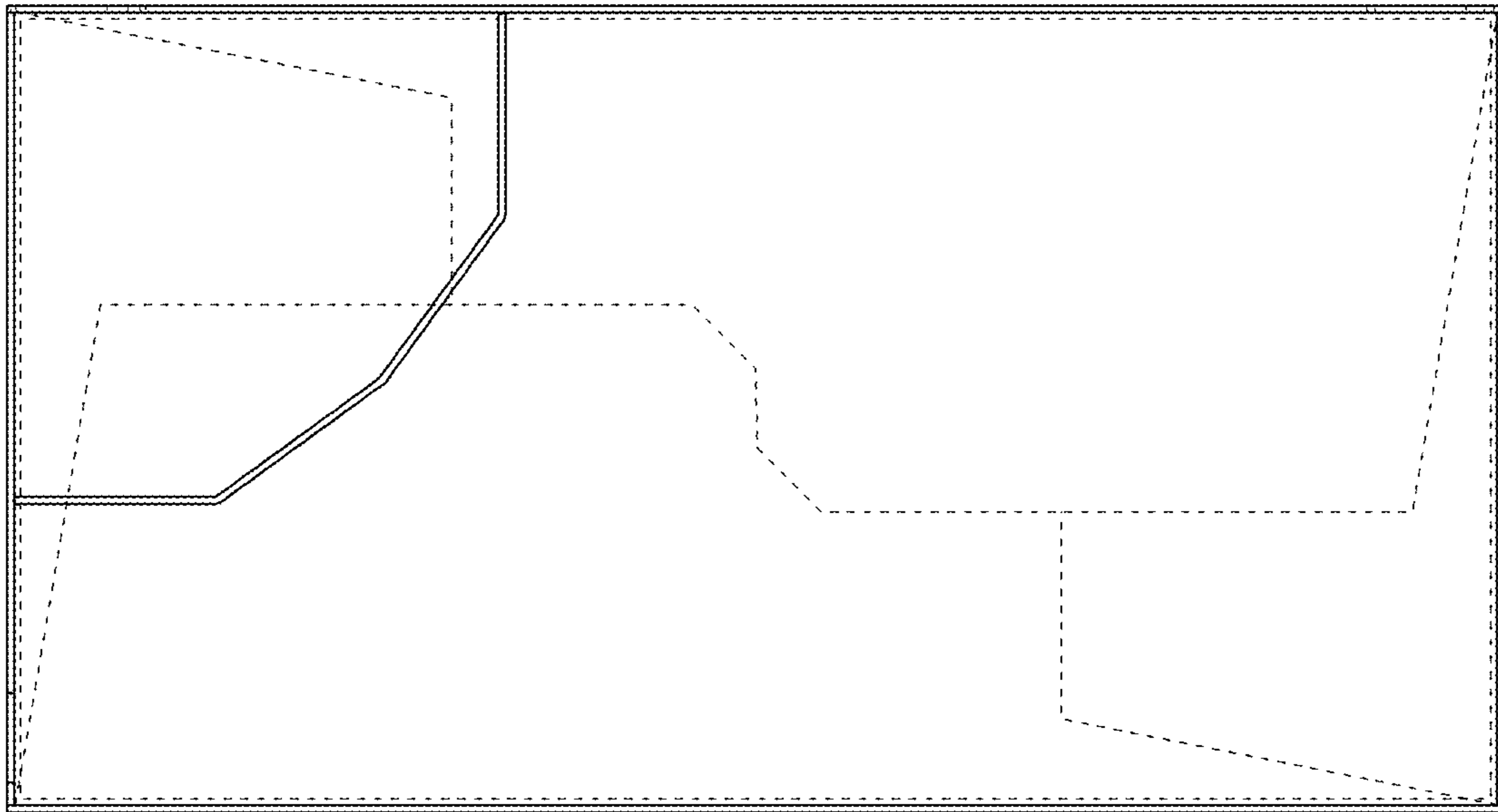

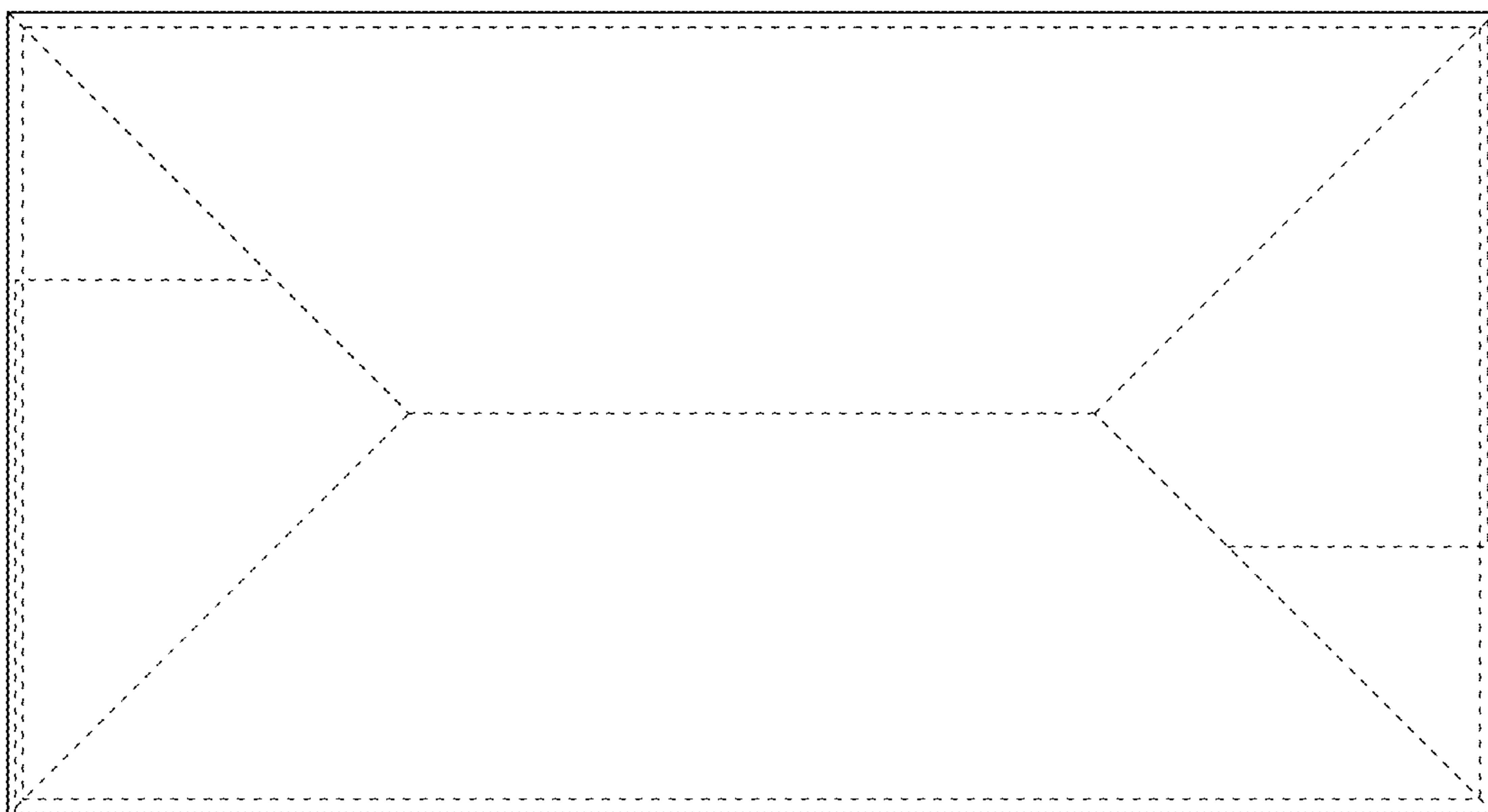

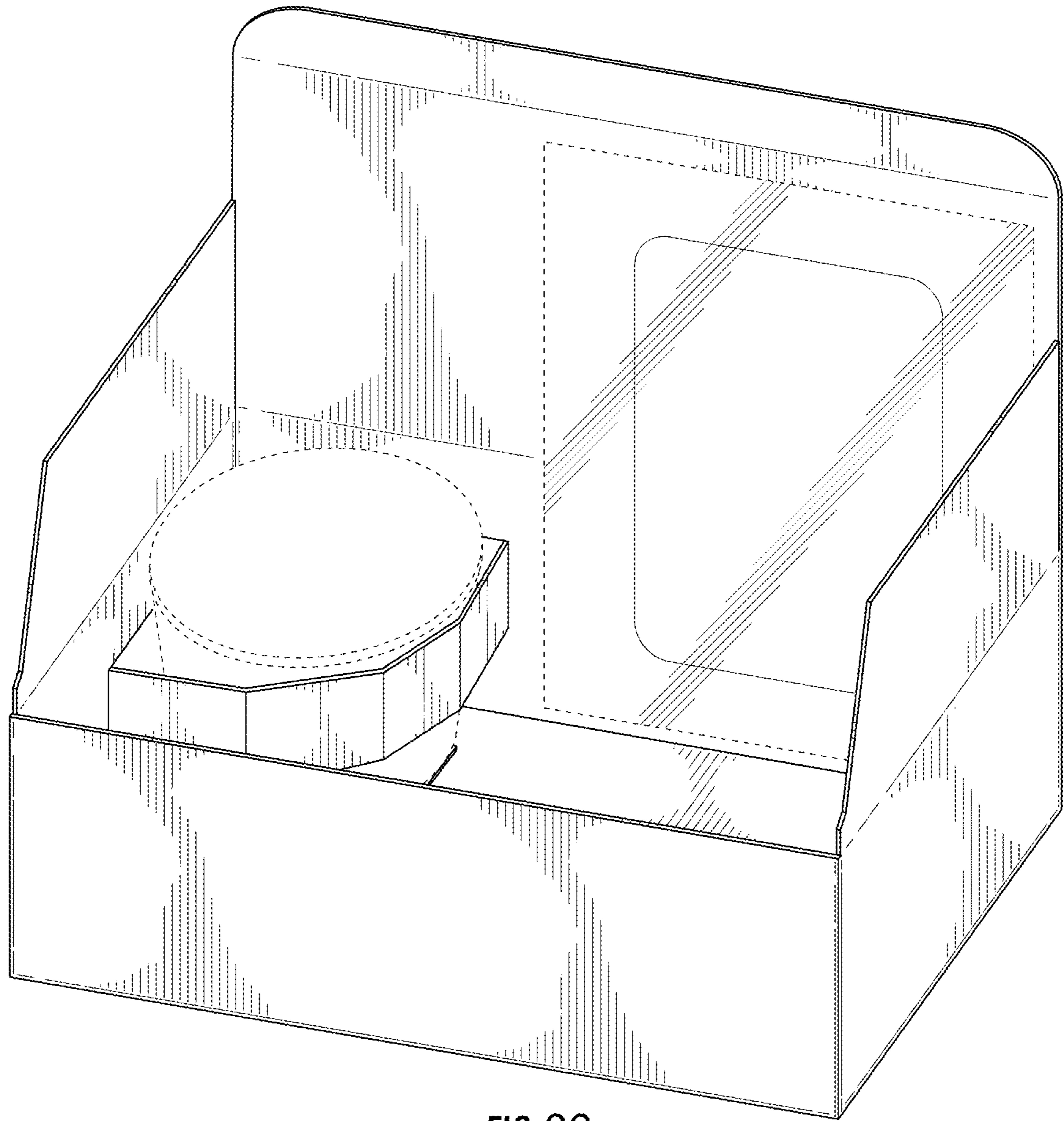
