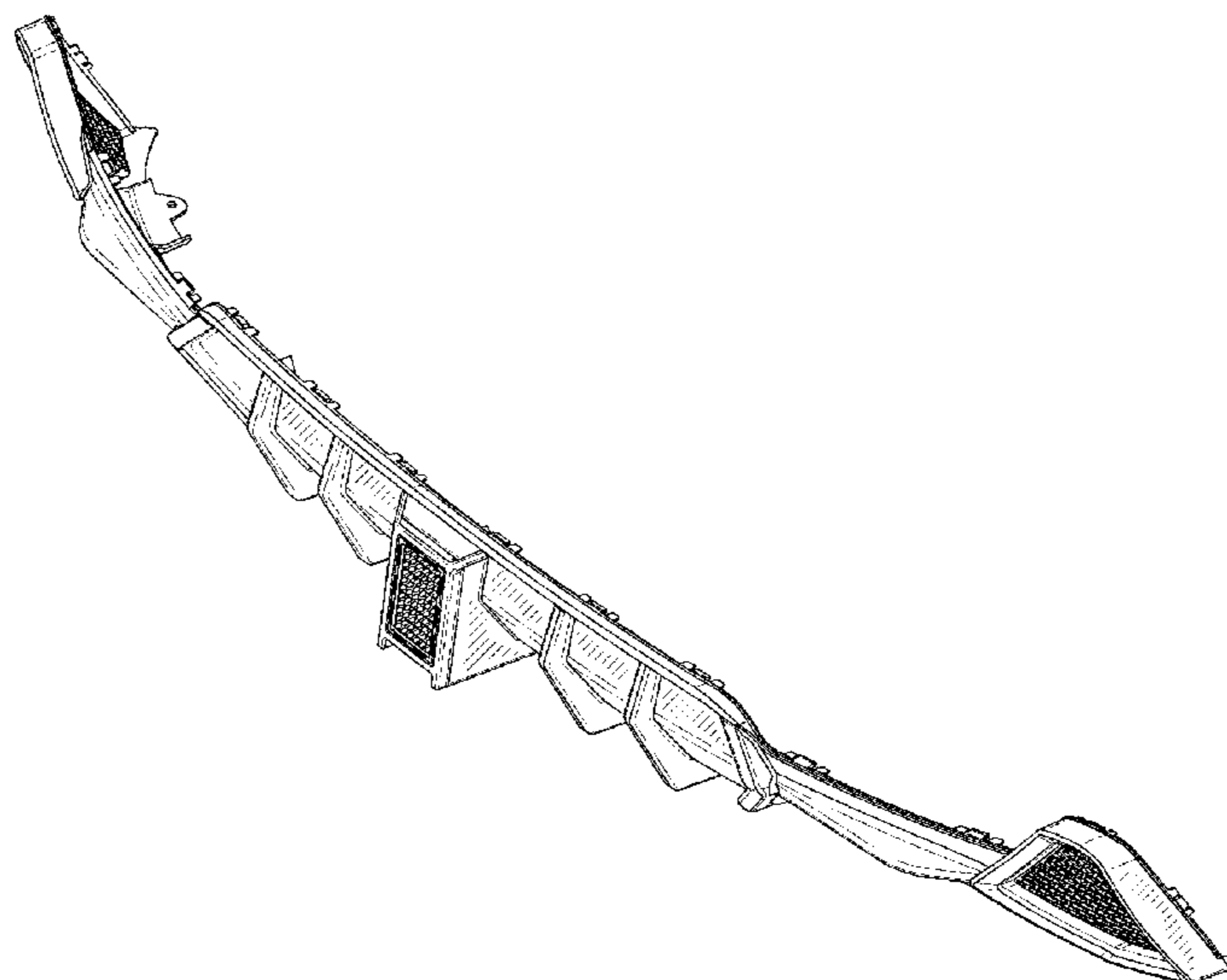
(57) **CLAIM**

I claim the ornamental design for a car rear diffuser, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view of a car rear diffuser embodying my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;

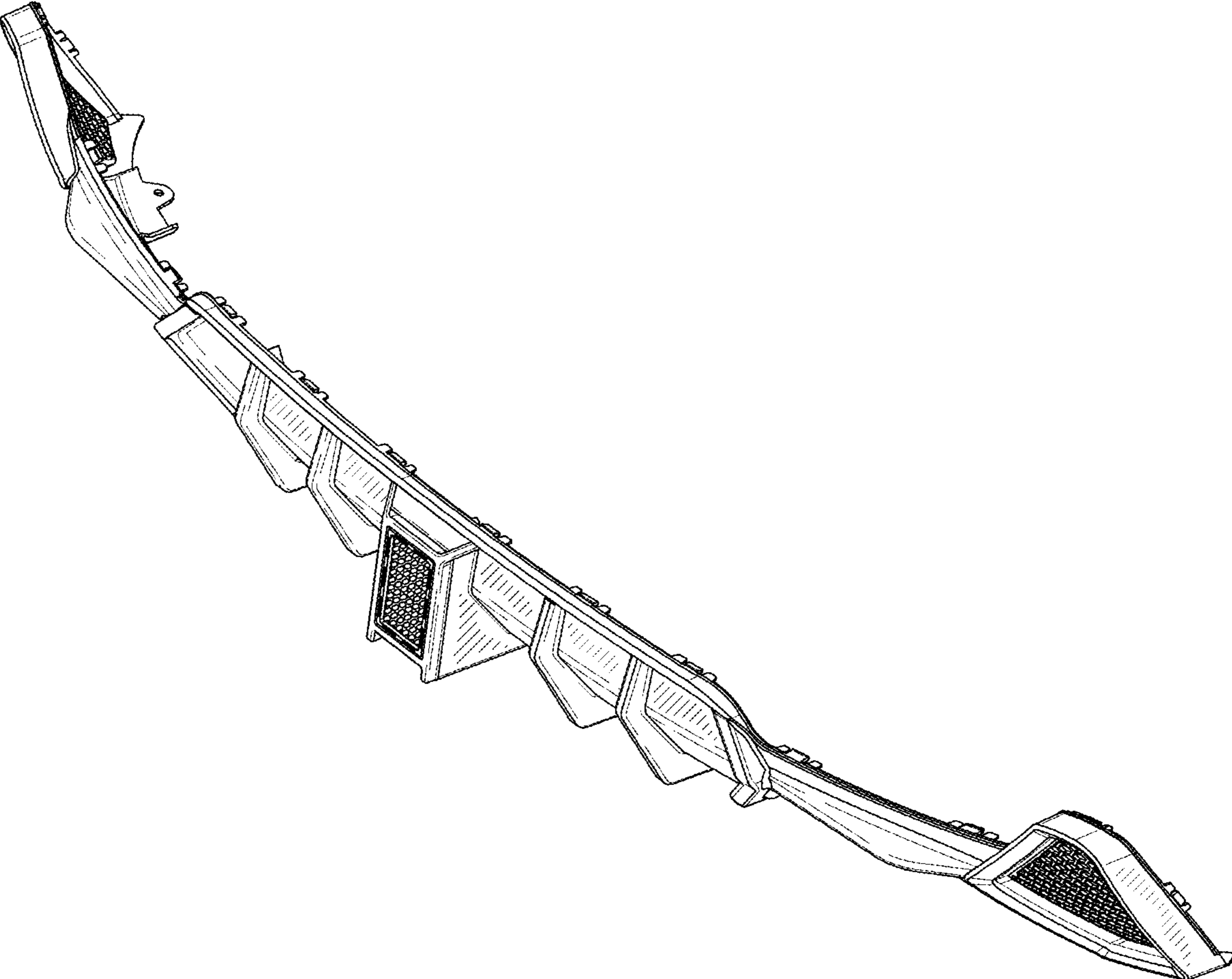

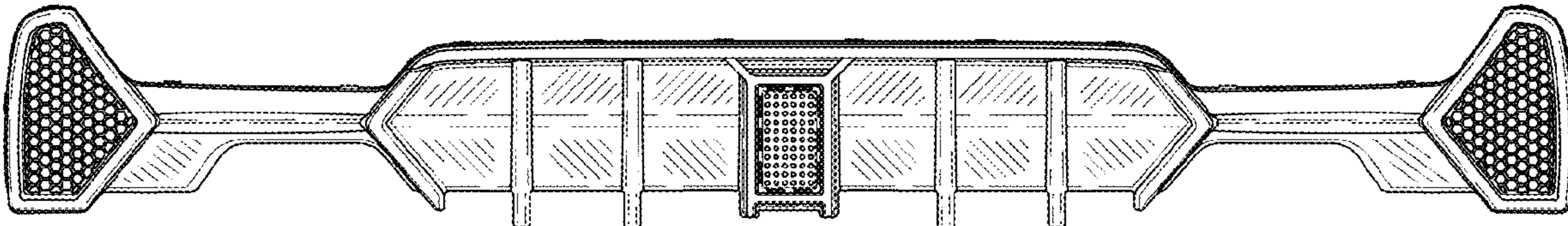

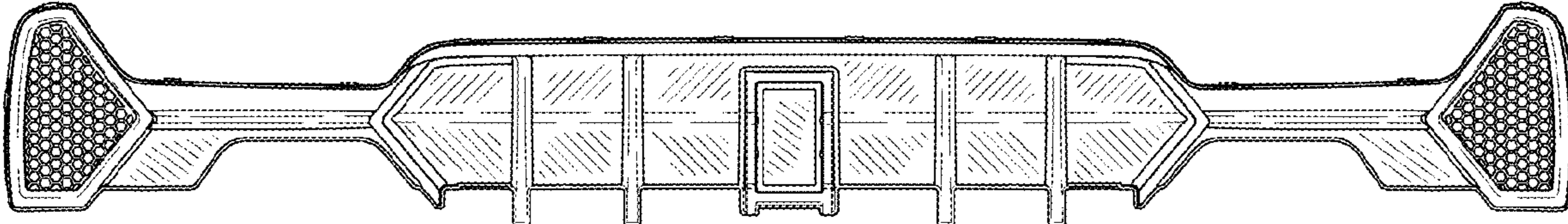

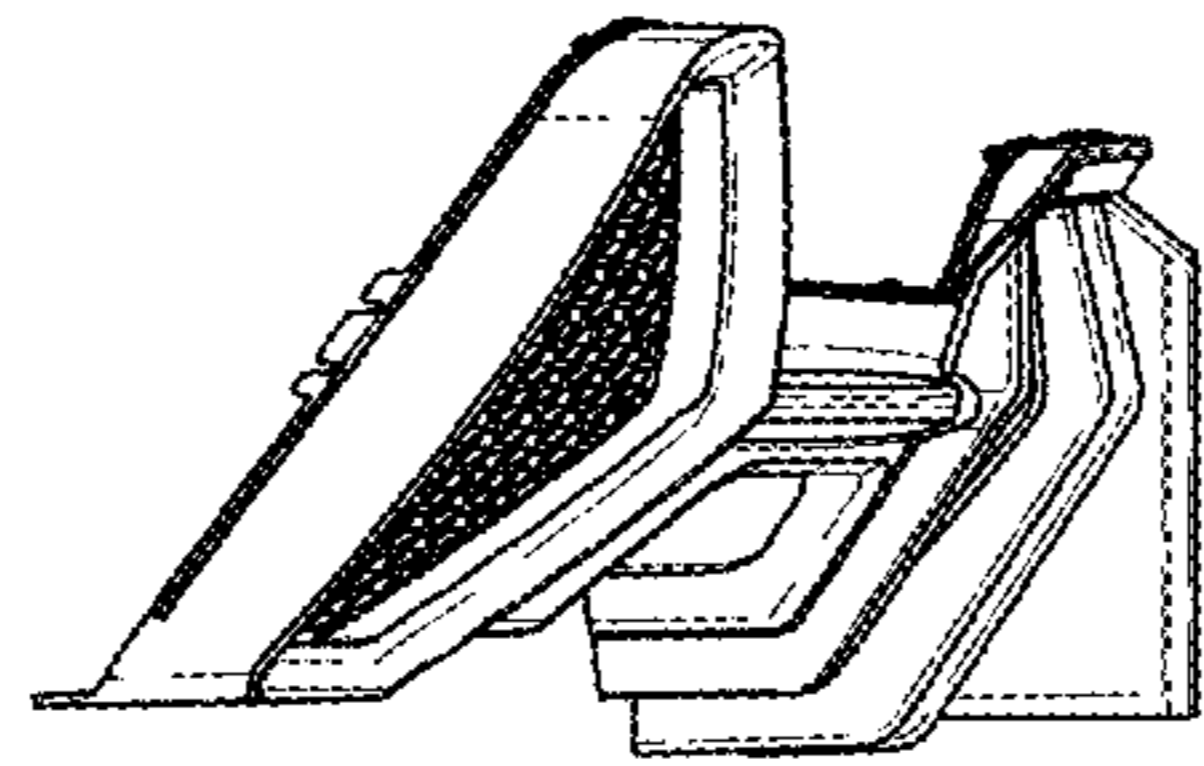

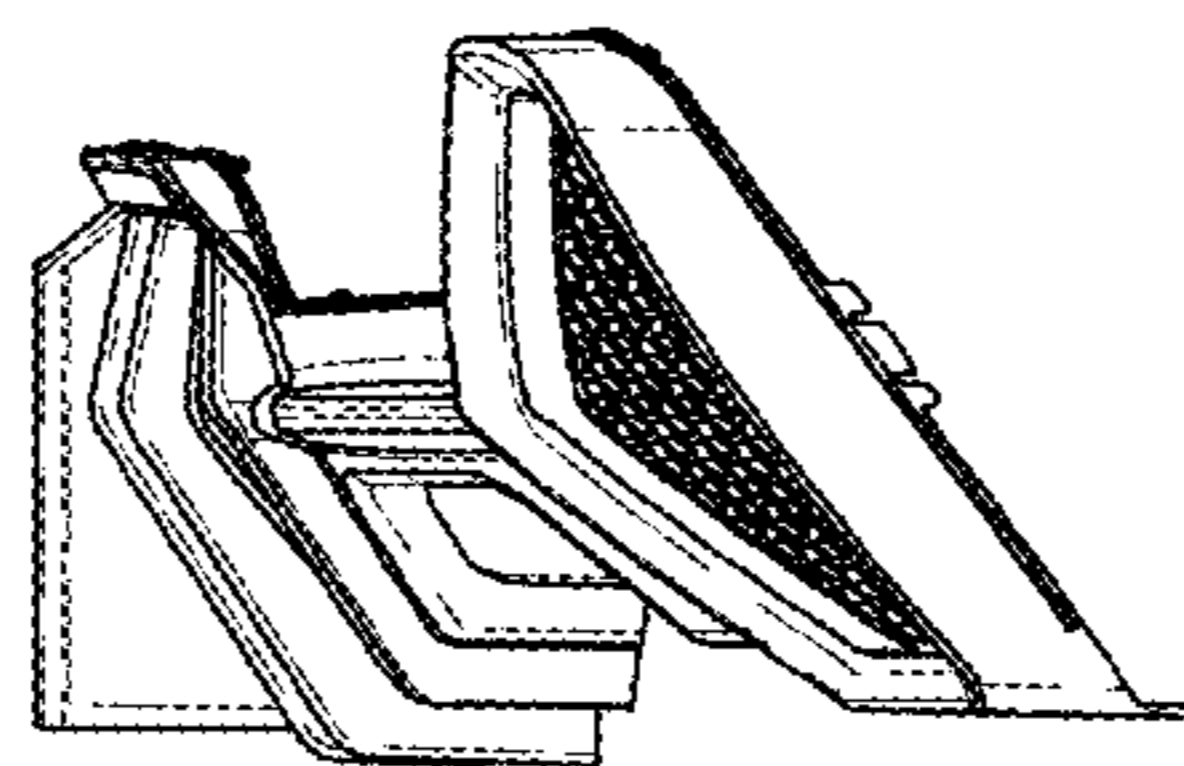

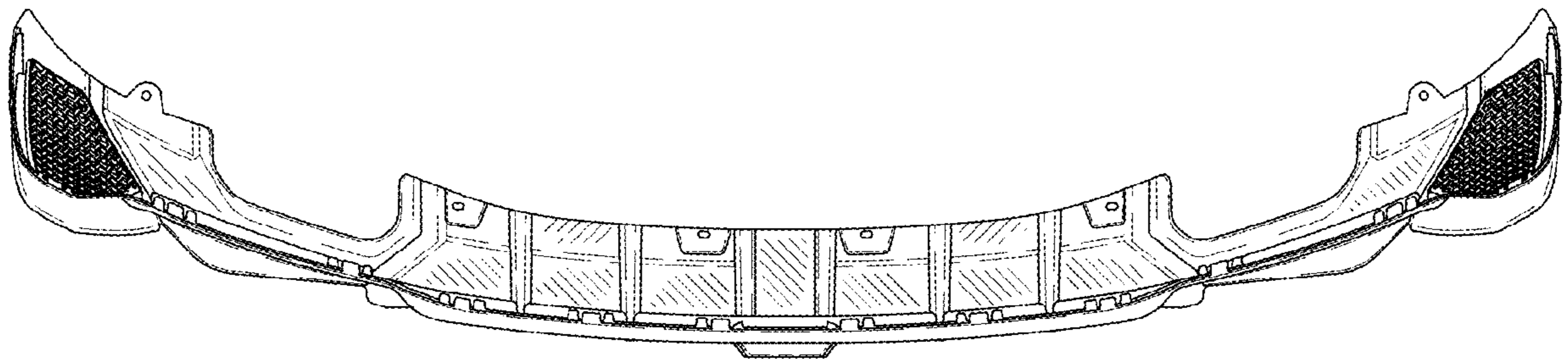

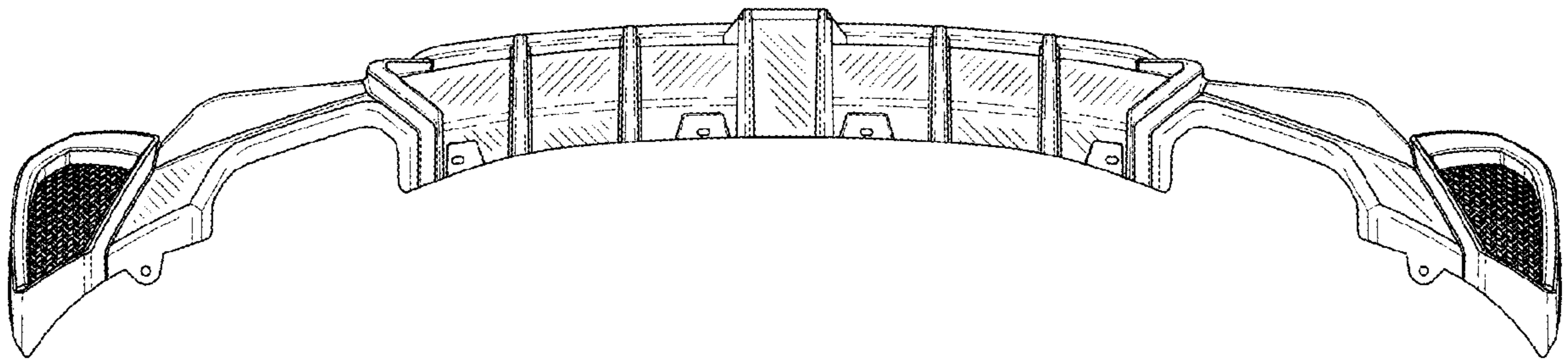
