(57) **CLAIM**

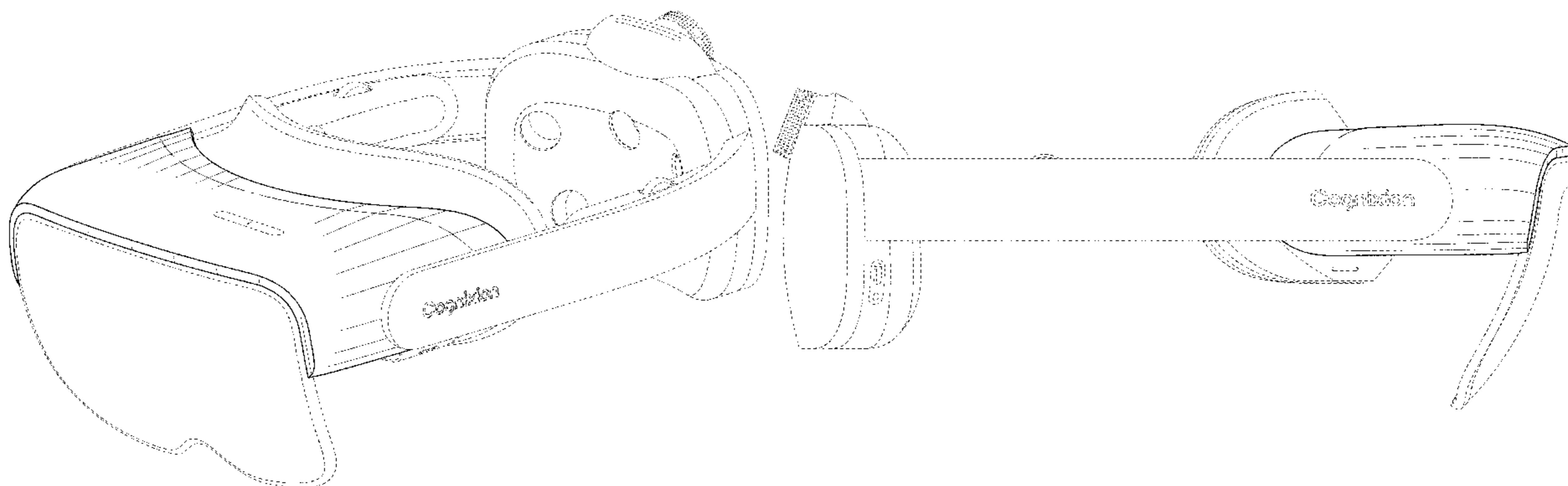
The ornamental design for a brain-computer interface (BCI) headset, as shown and described.

DESCRIPTION

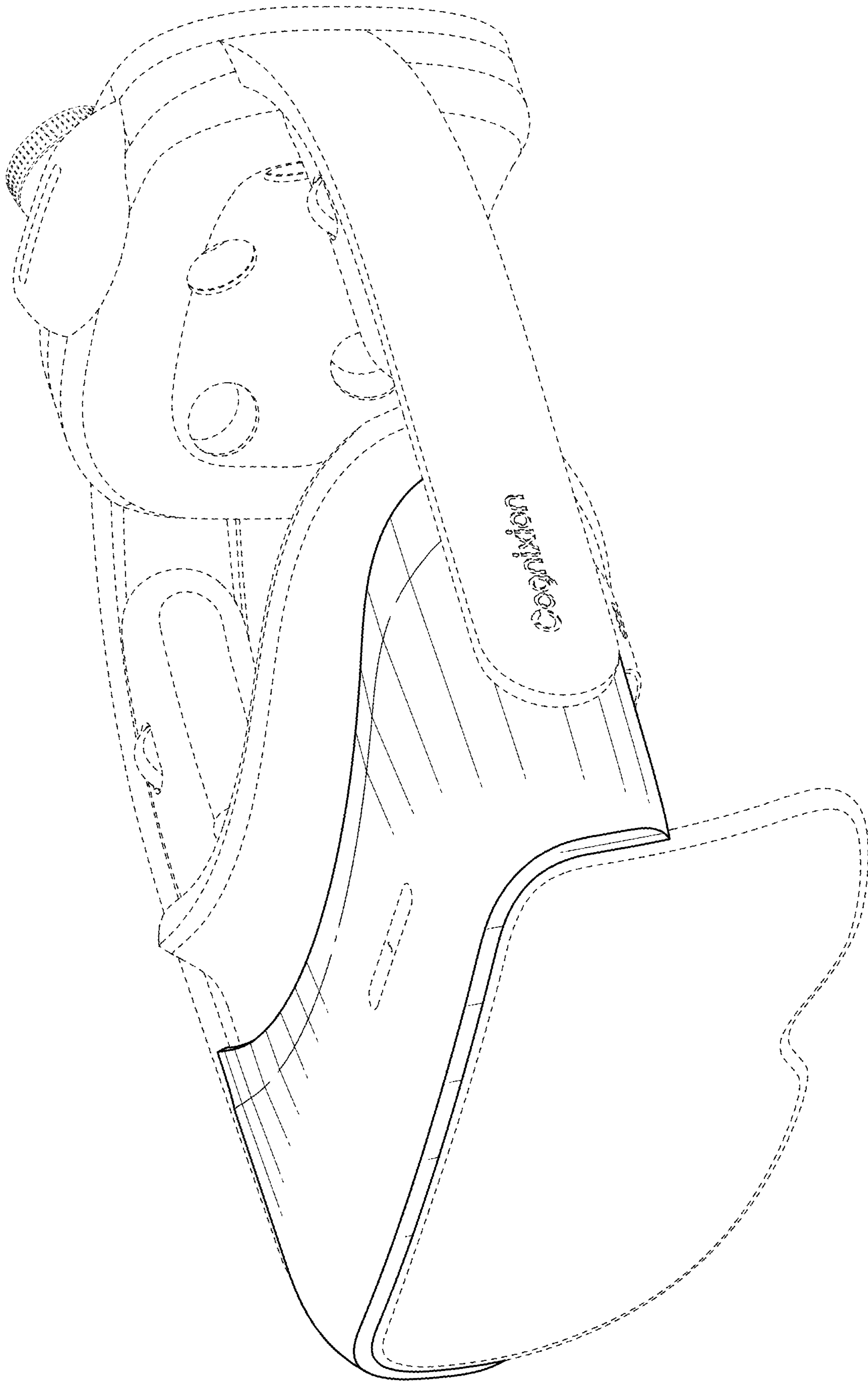

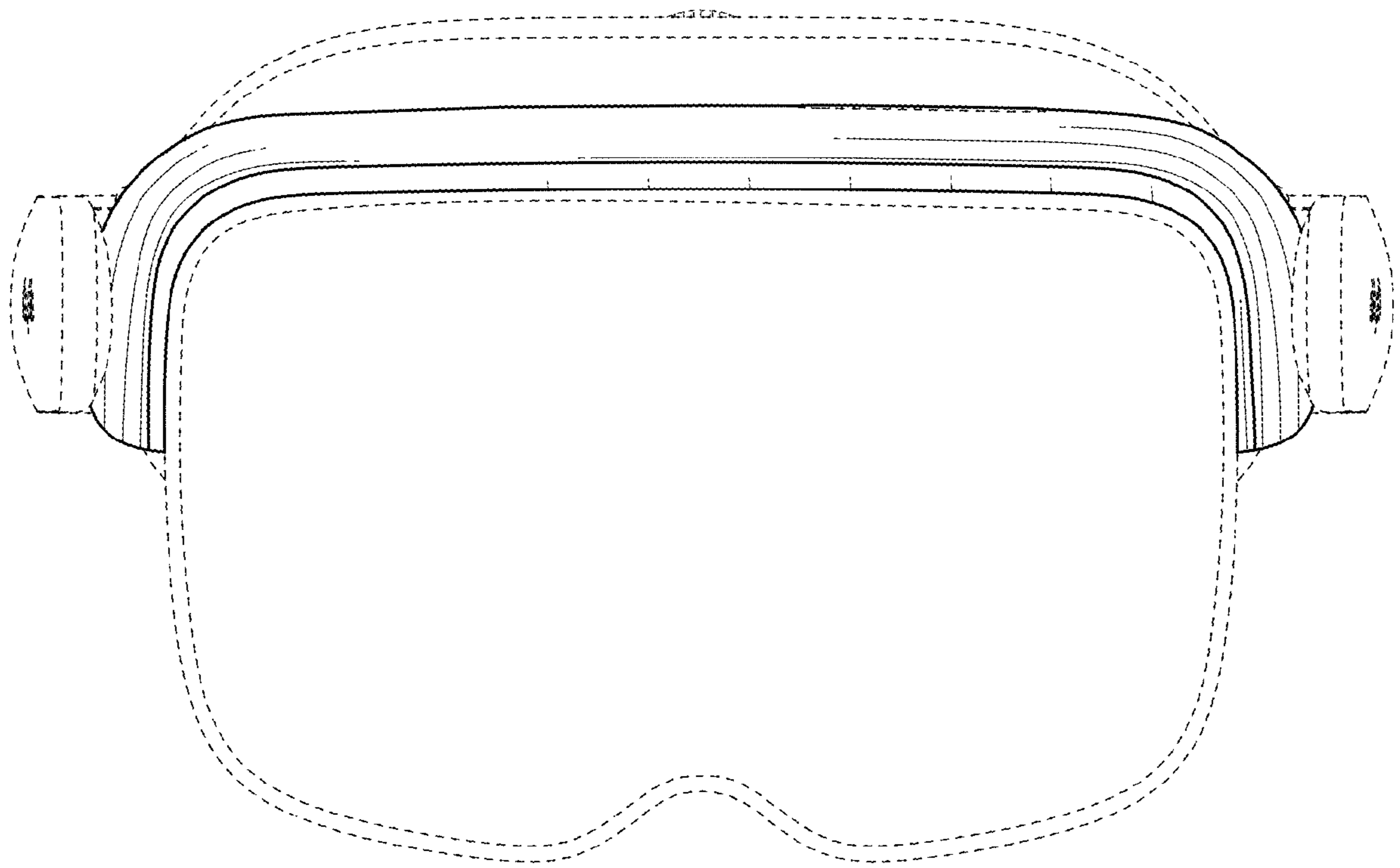

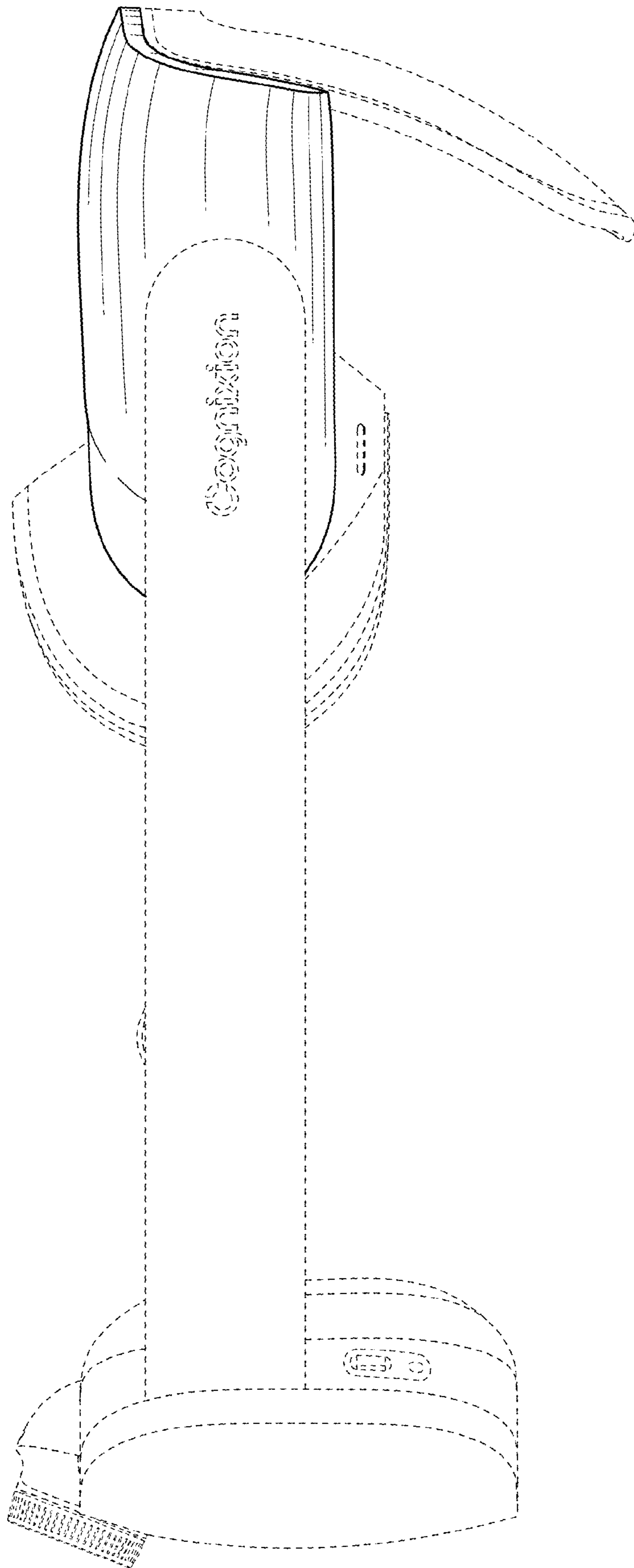

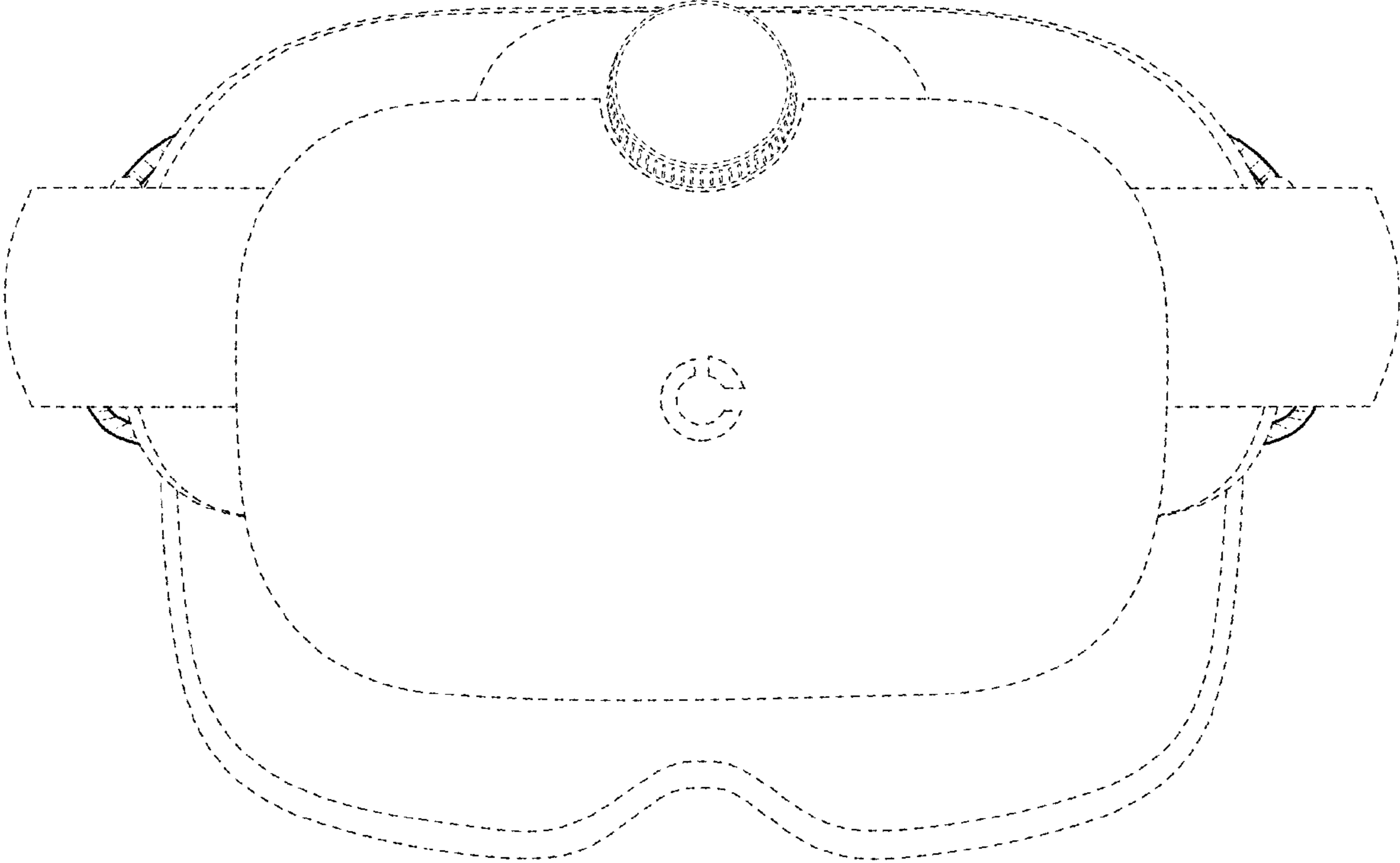

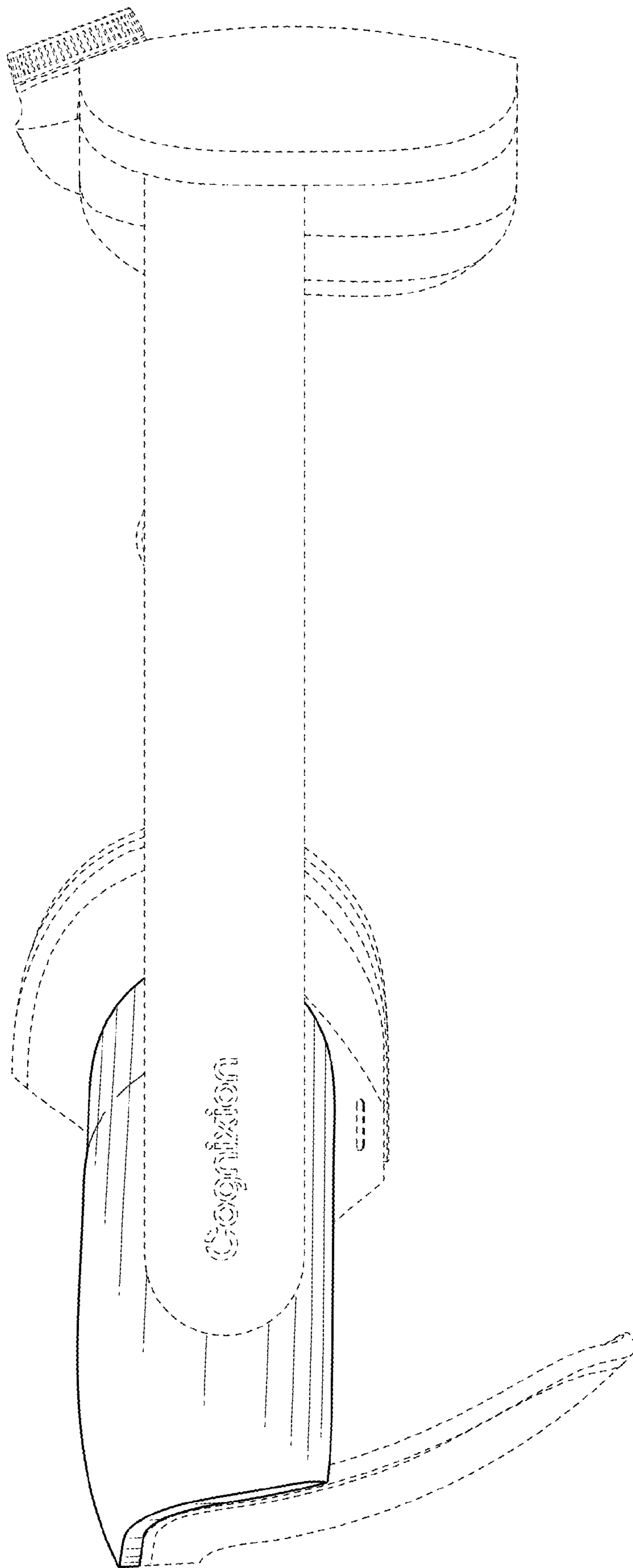

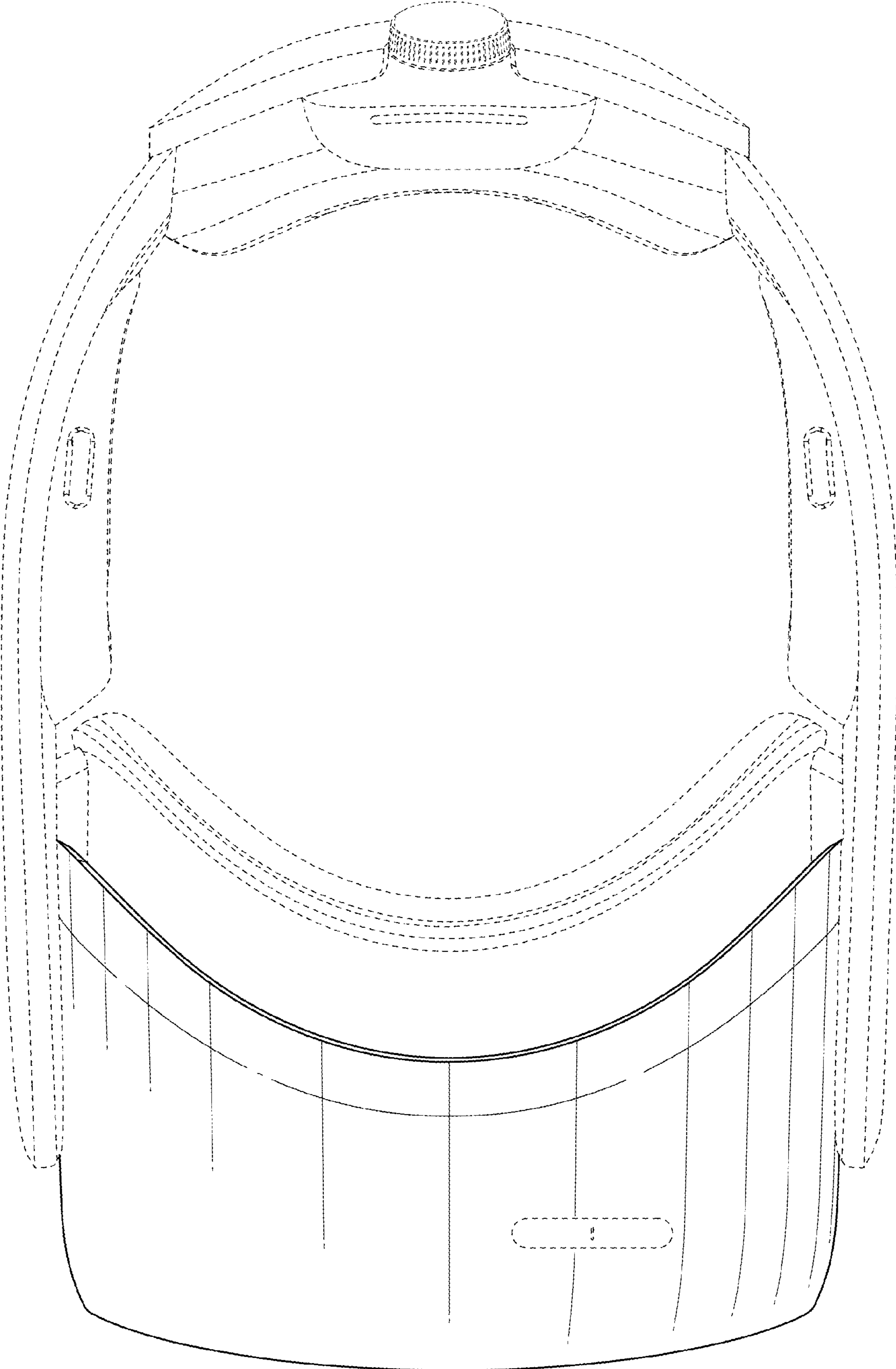

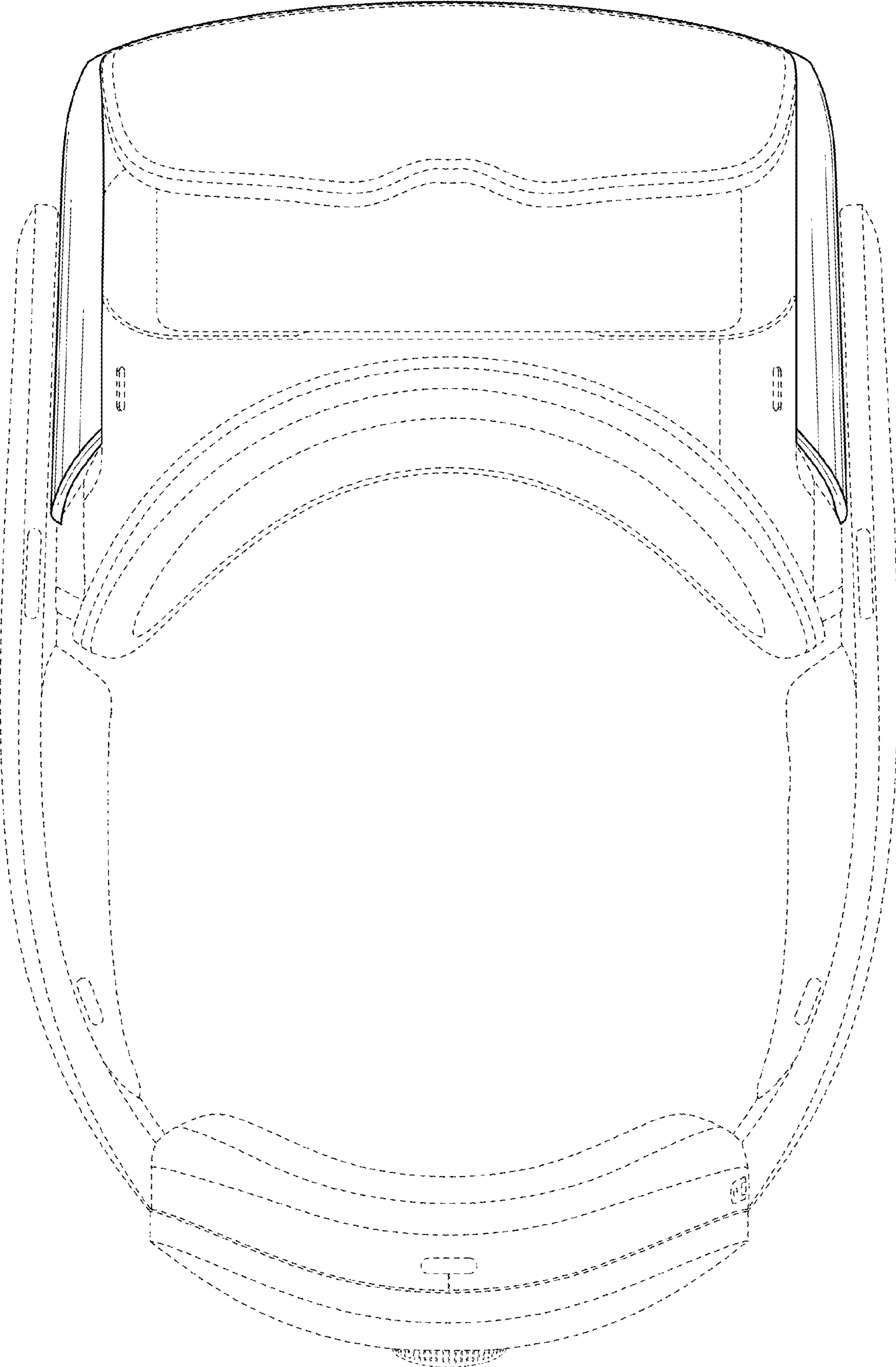

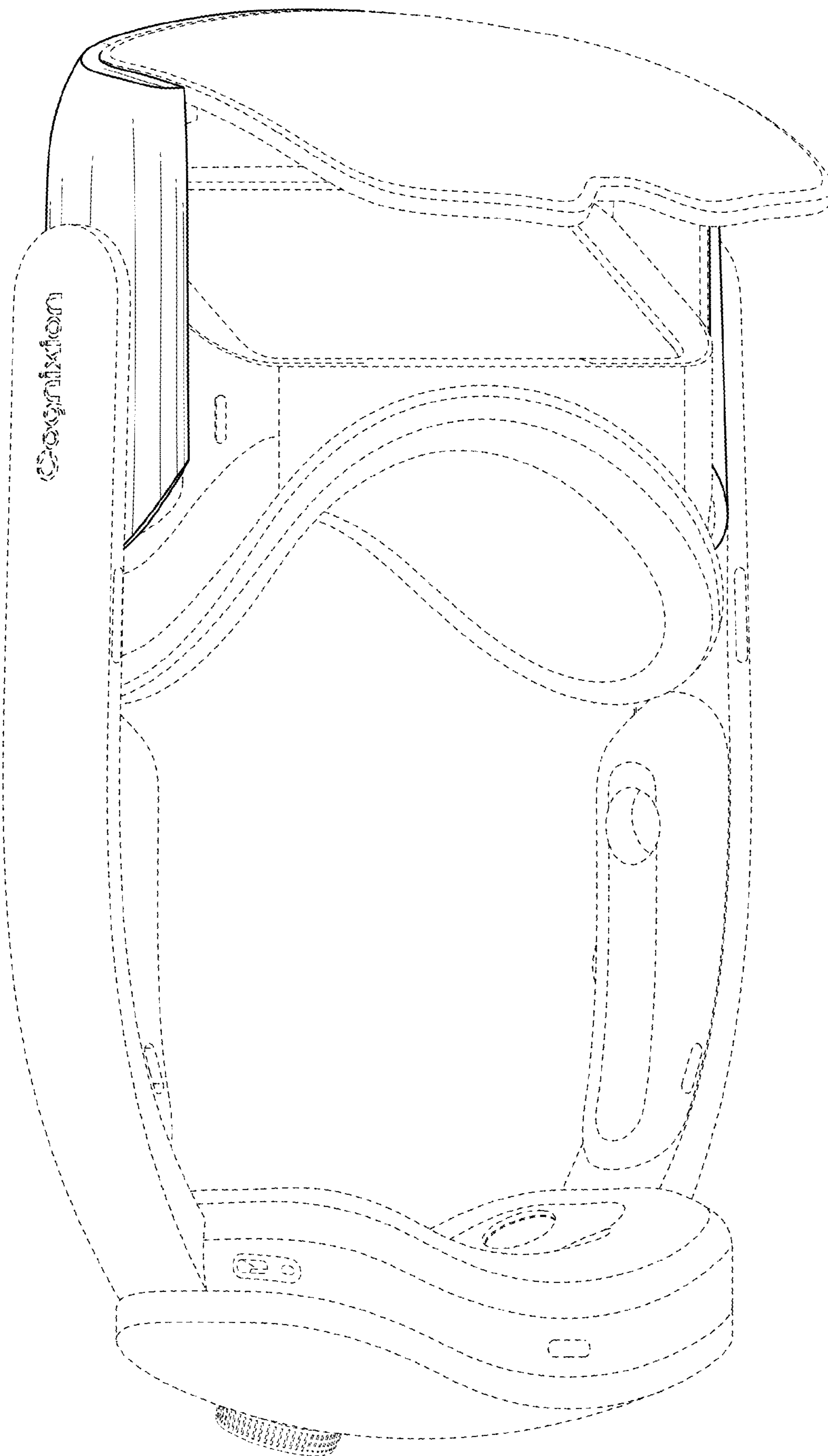

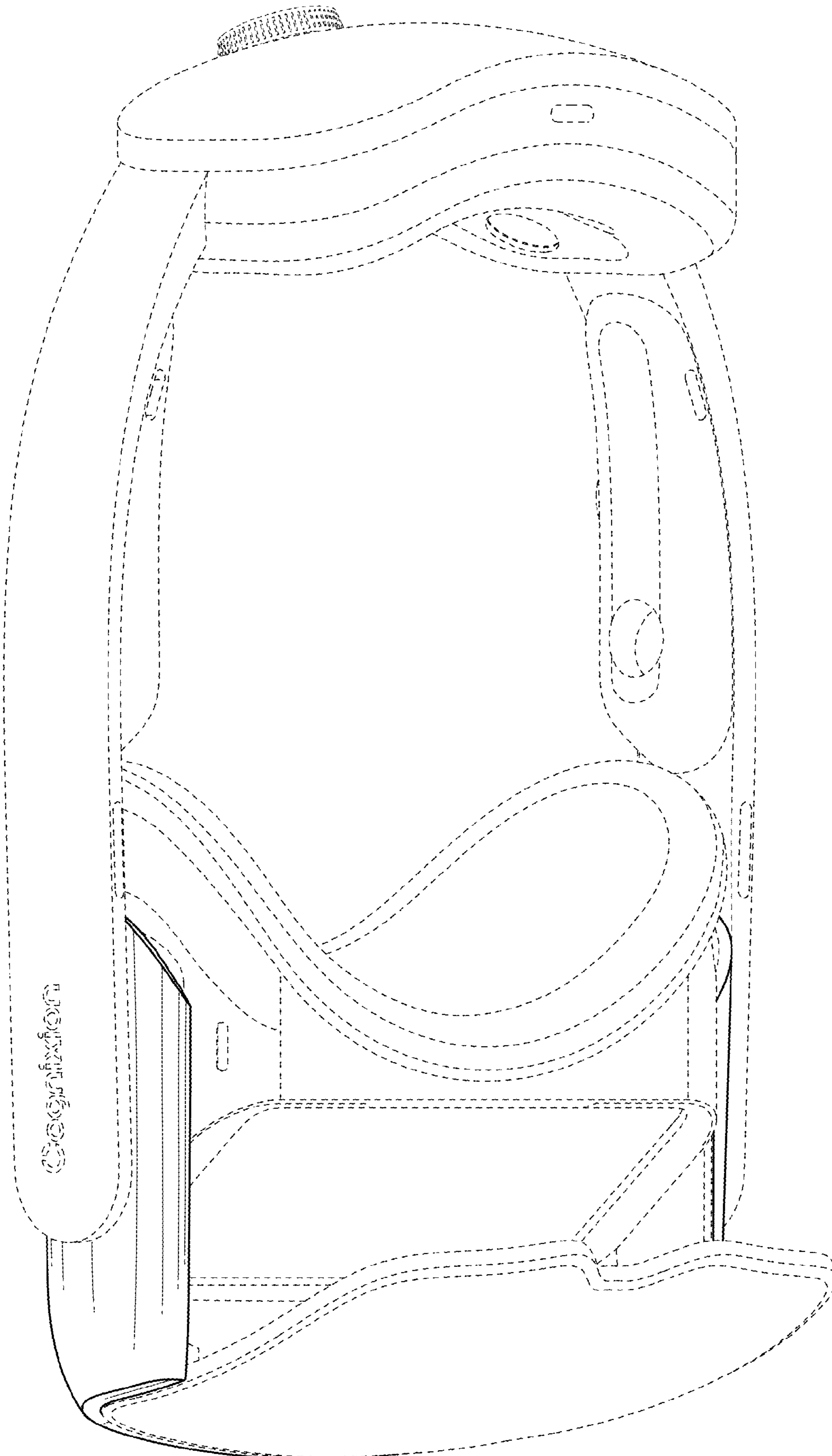

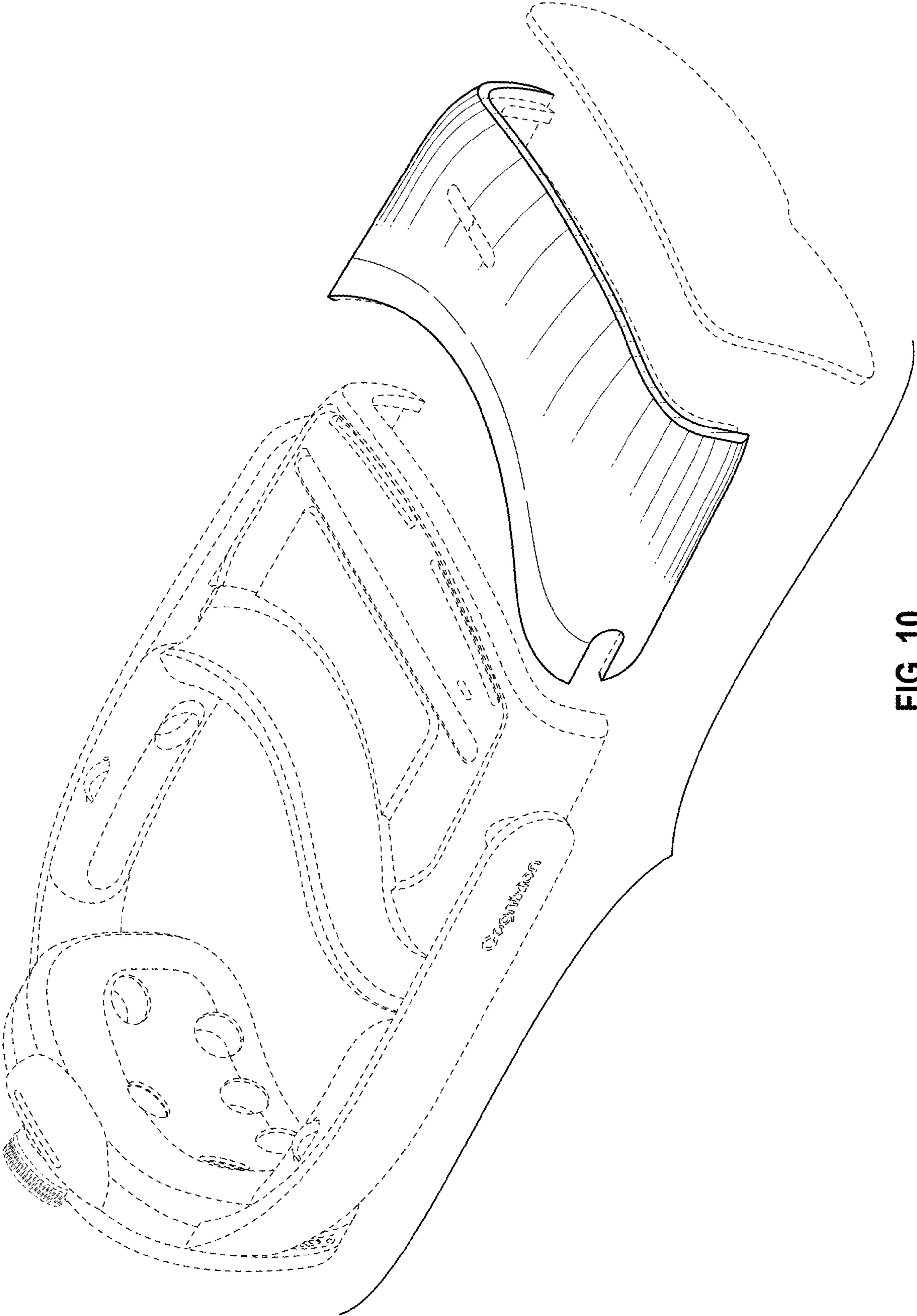

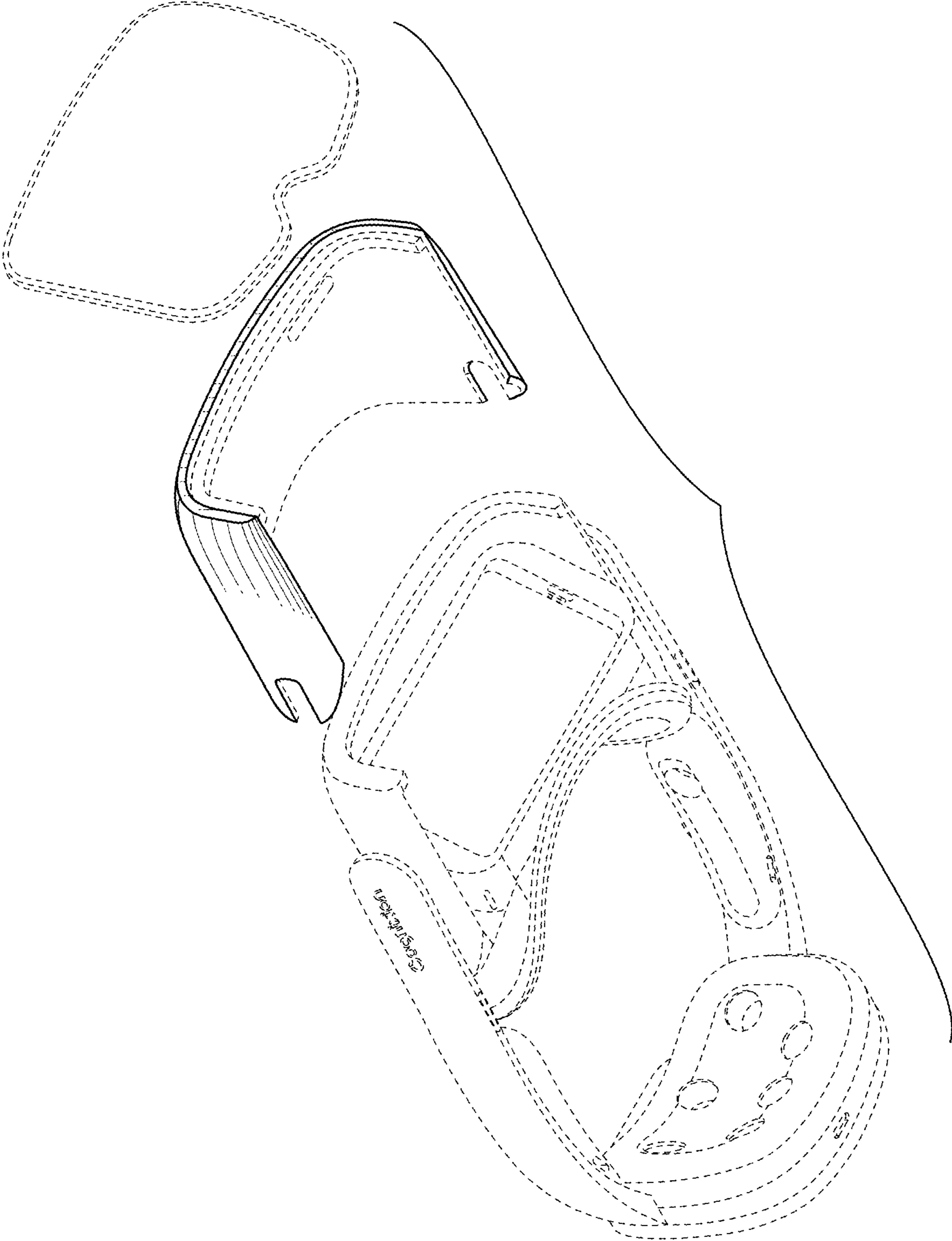
