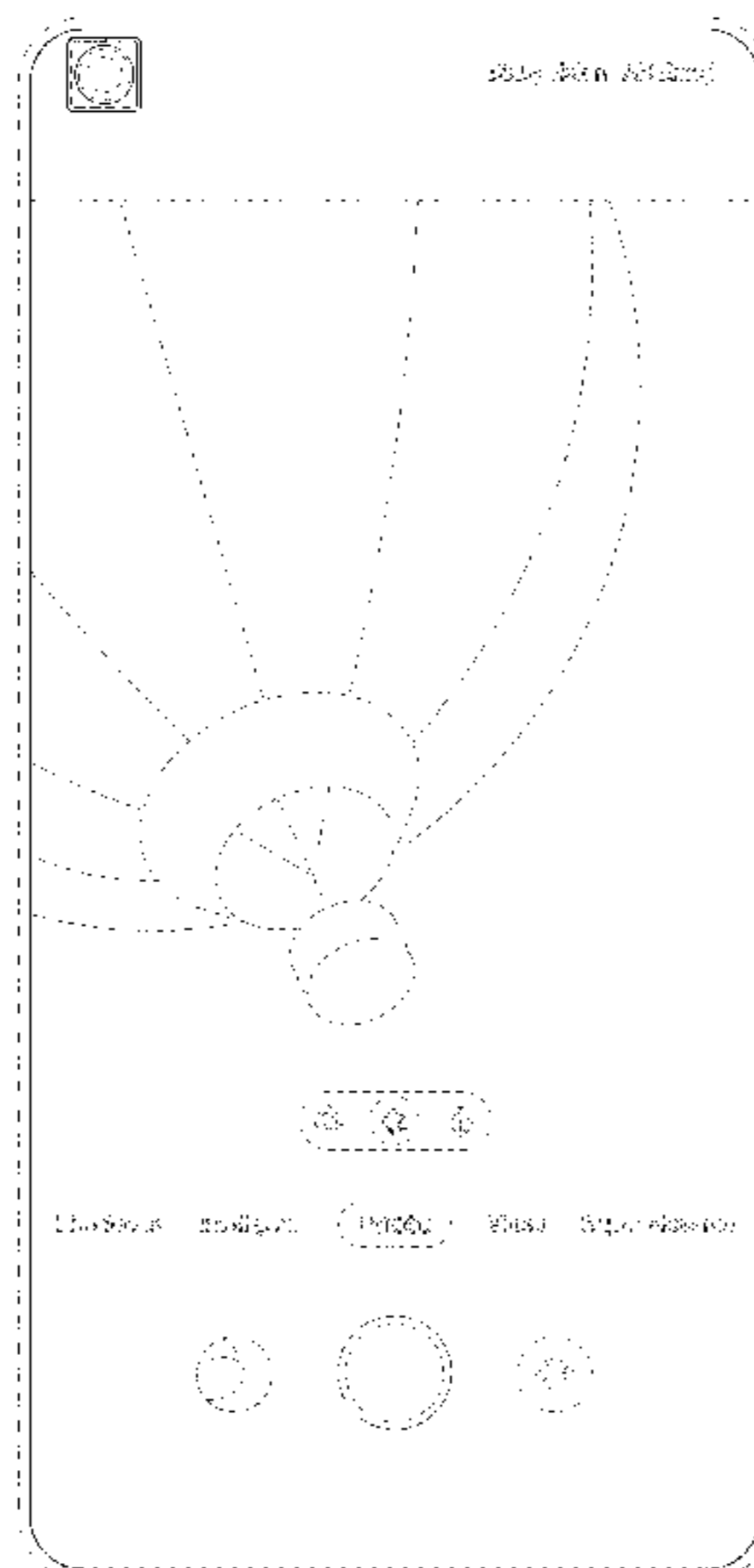
FIG. 12 is a front view of a twelfth embodiment thereof.

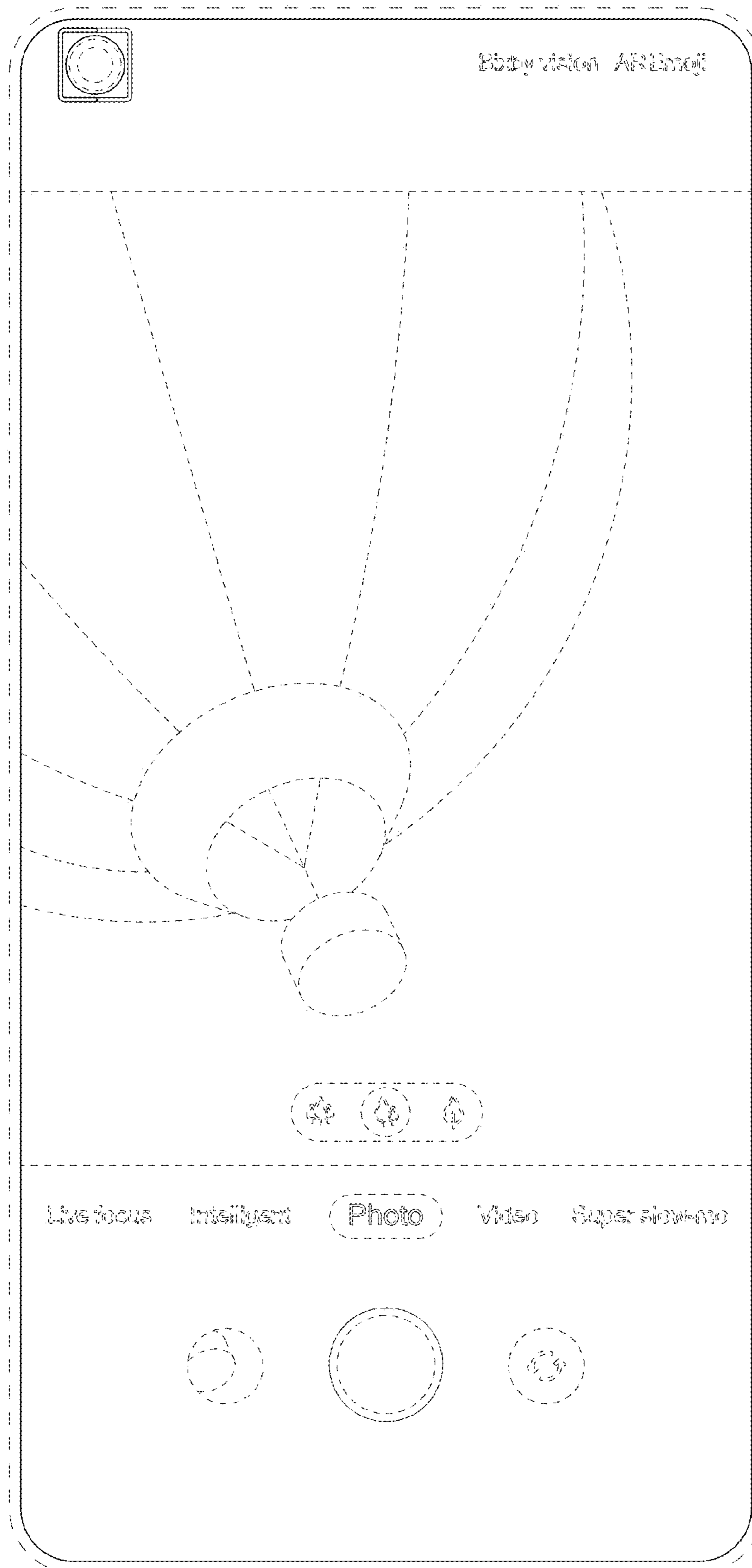

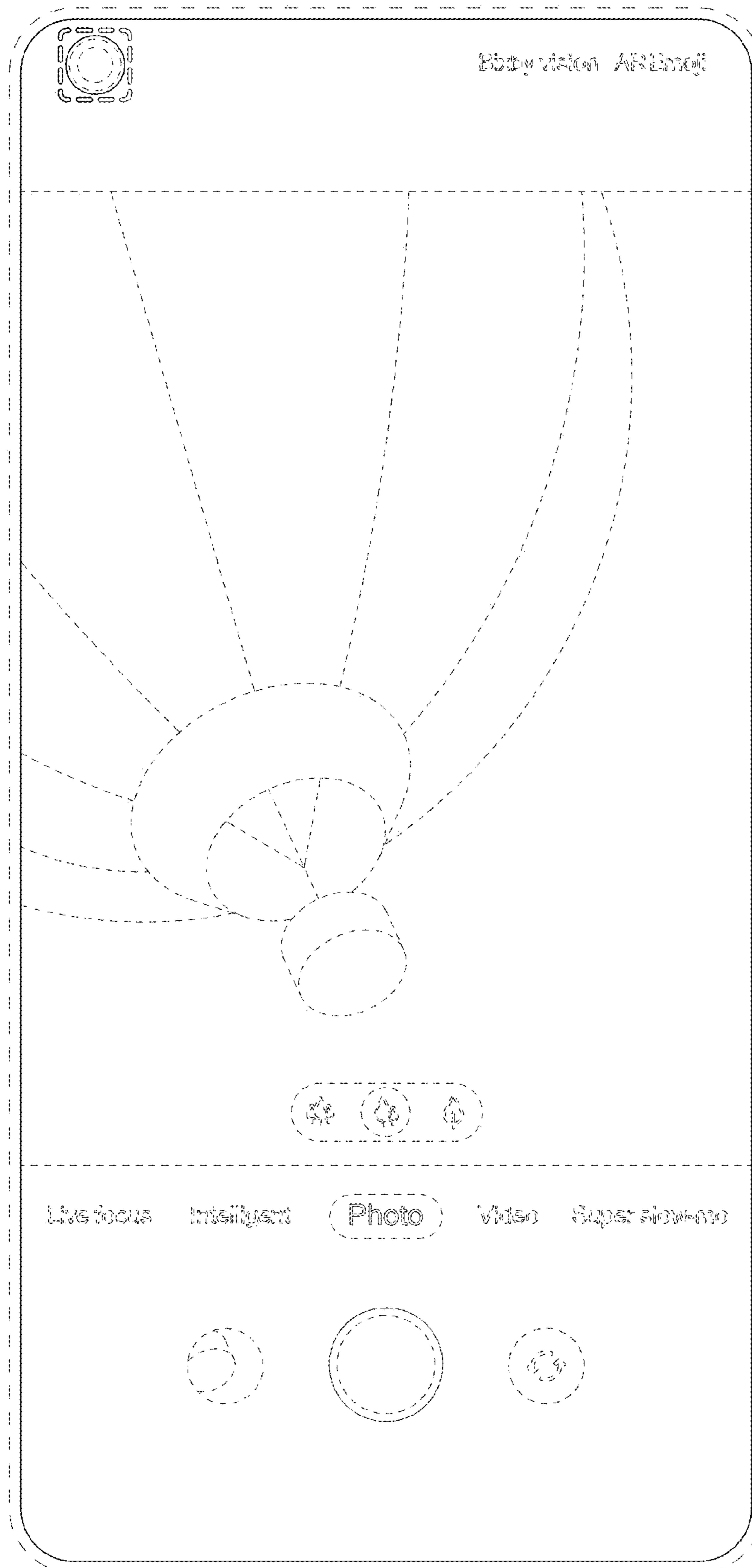

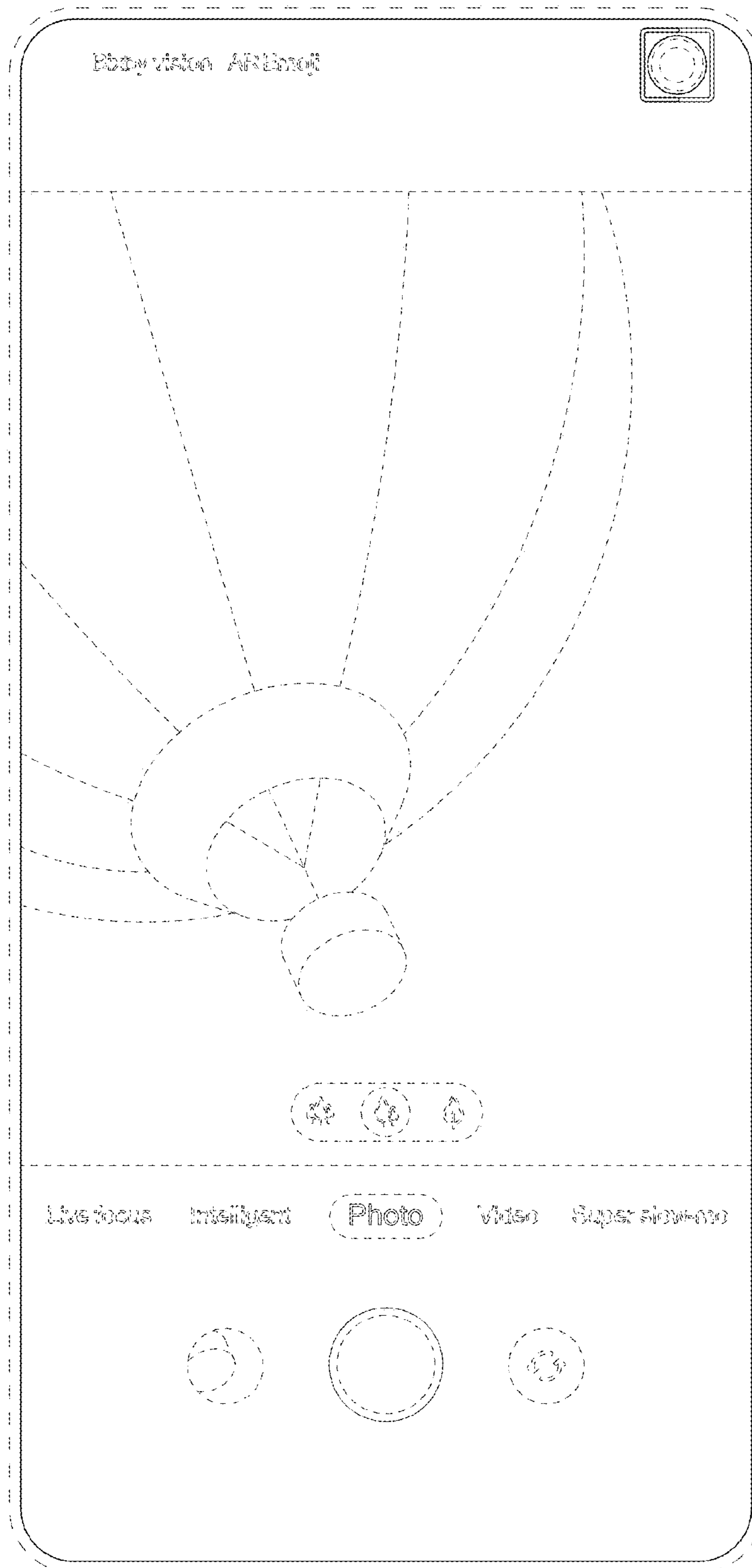

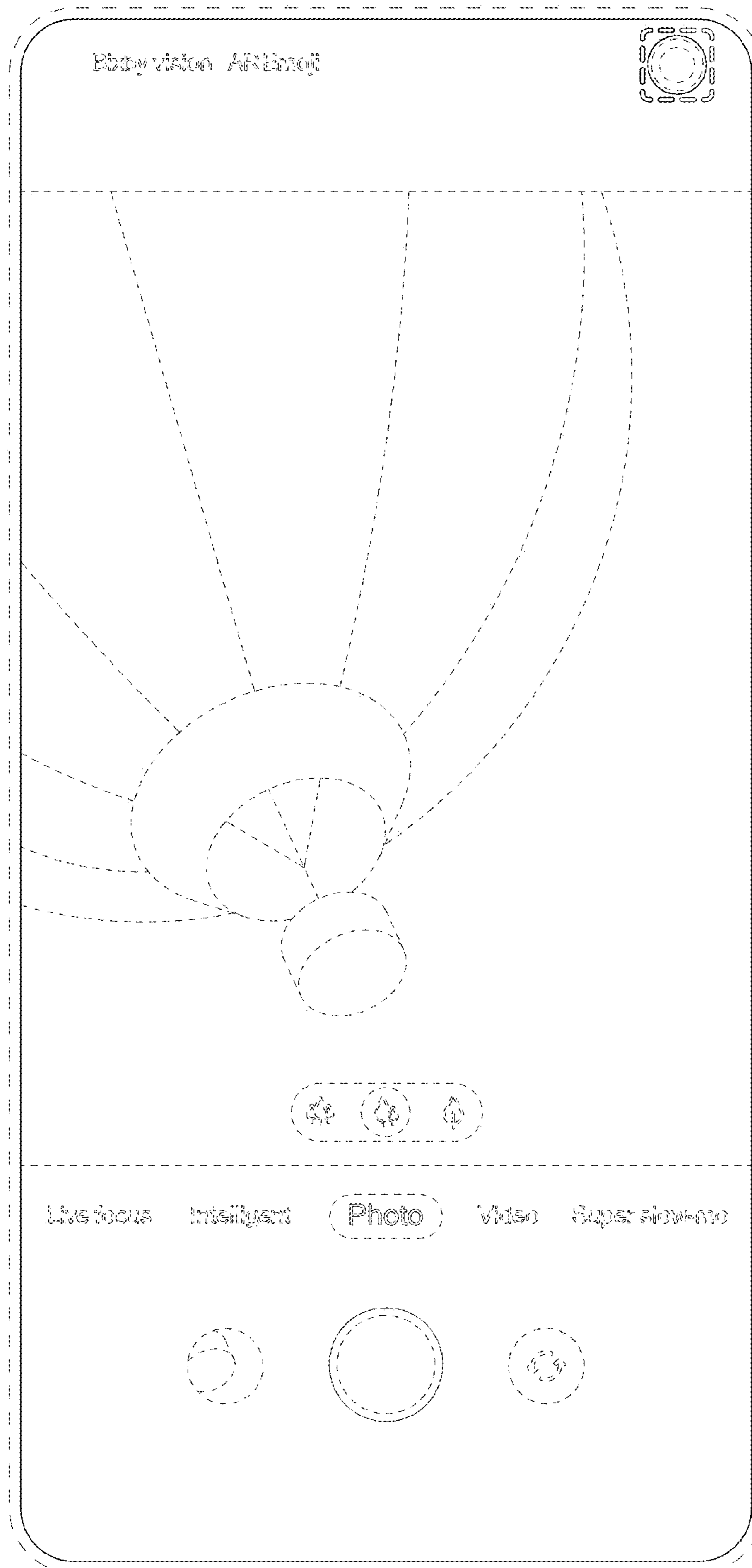

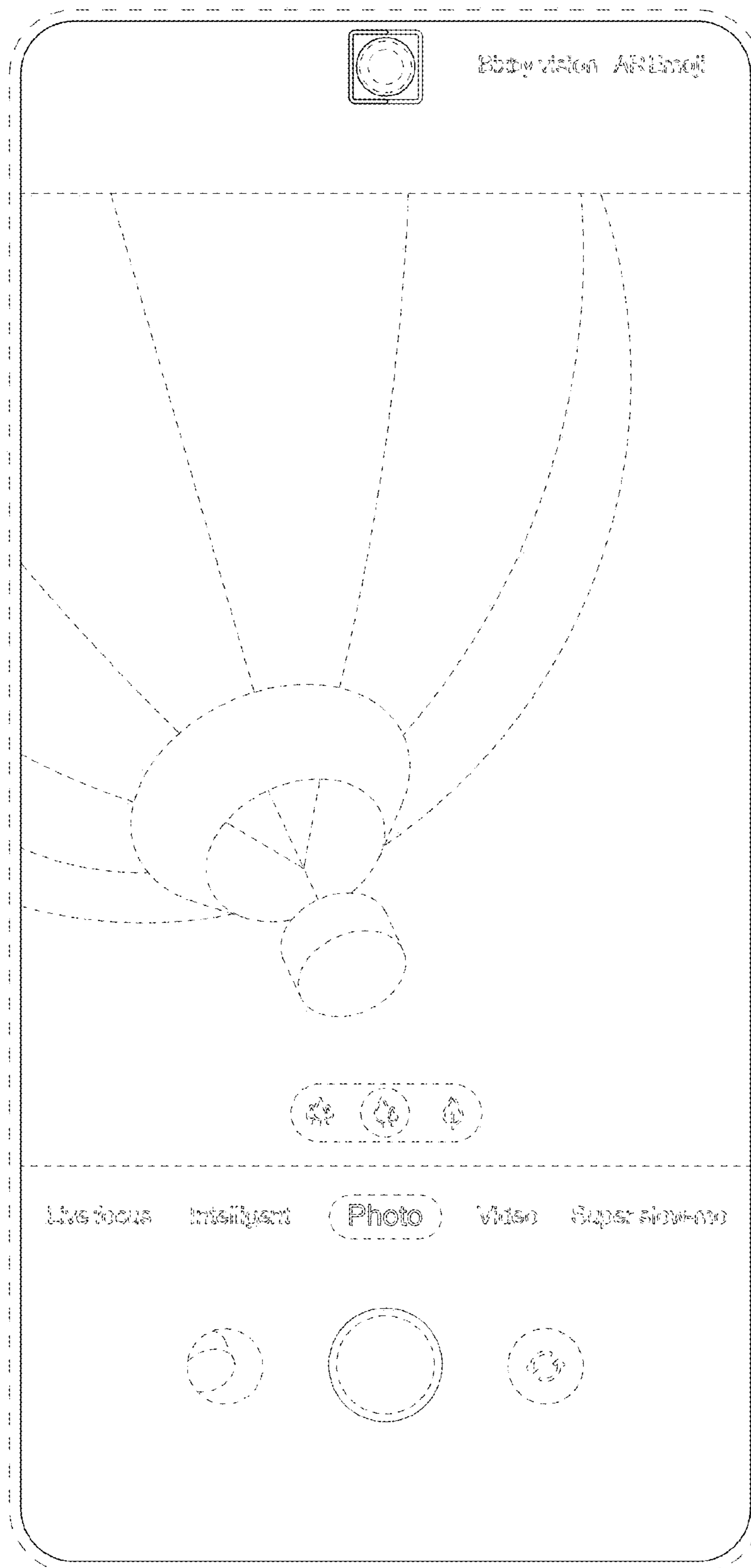

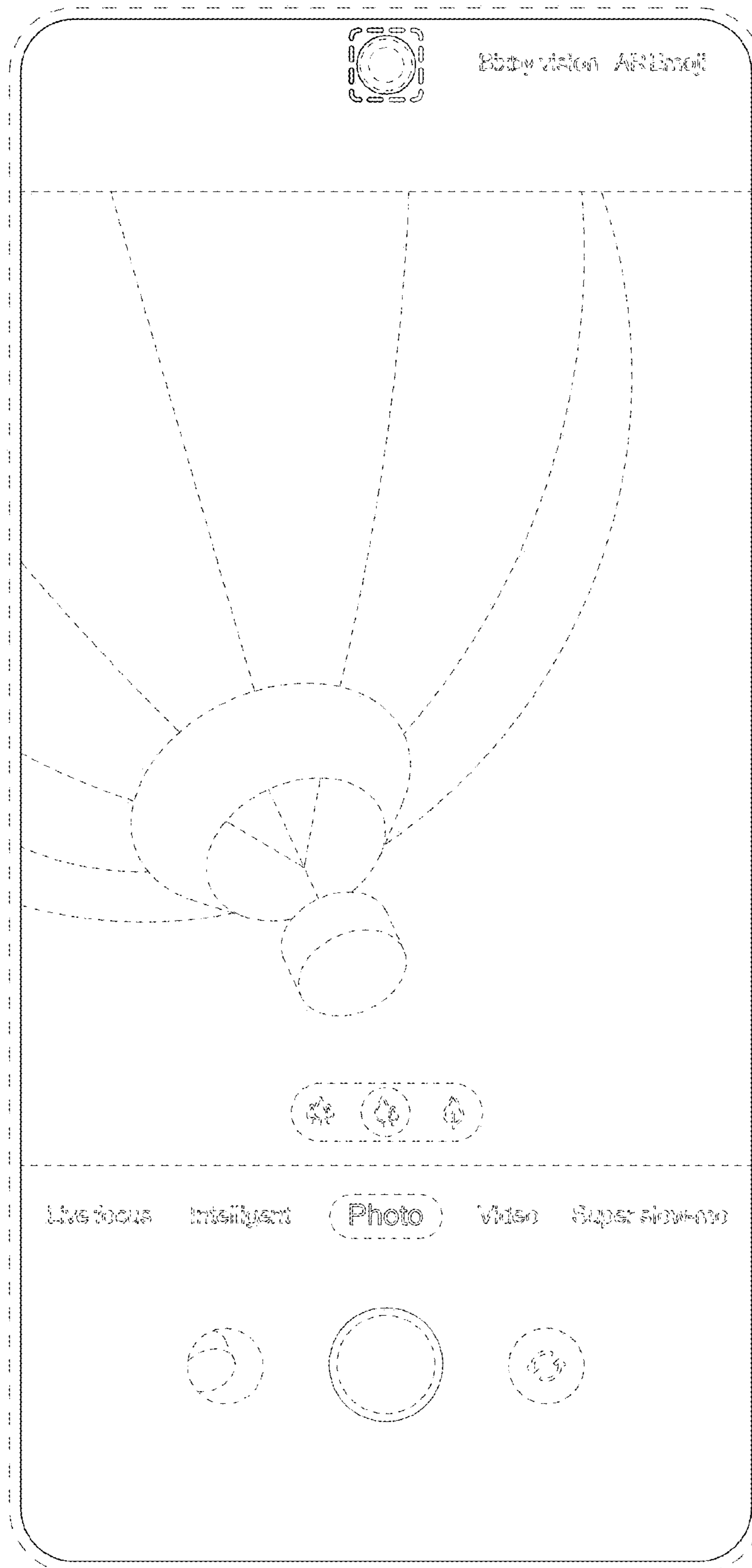

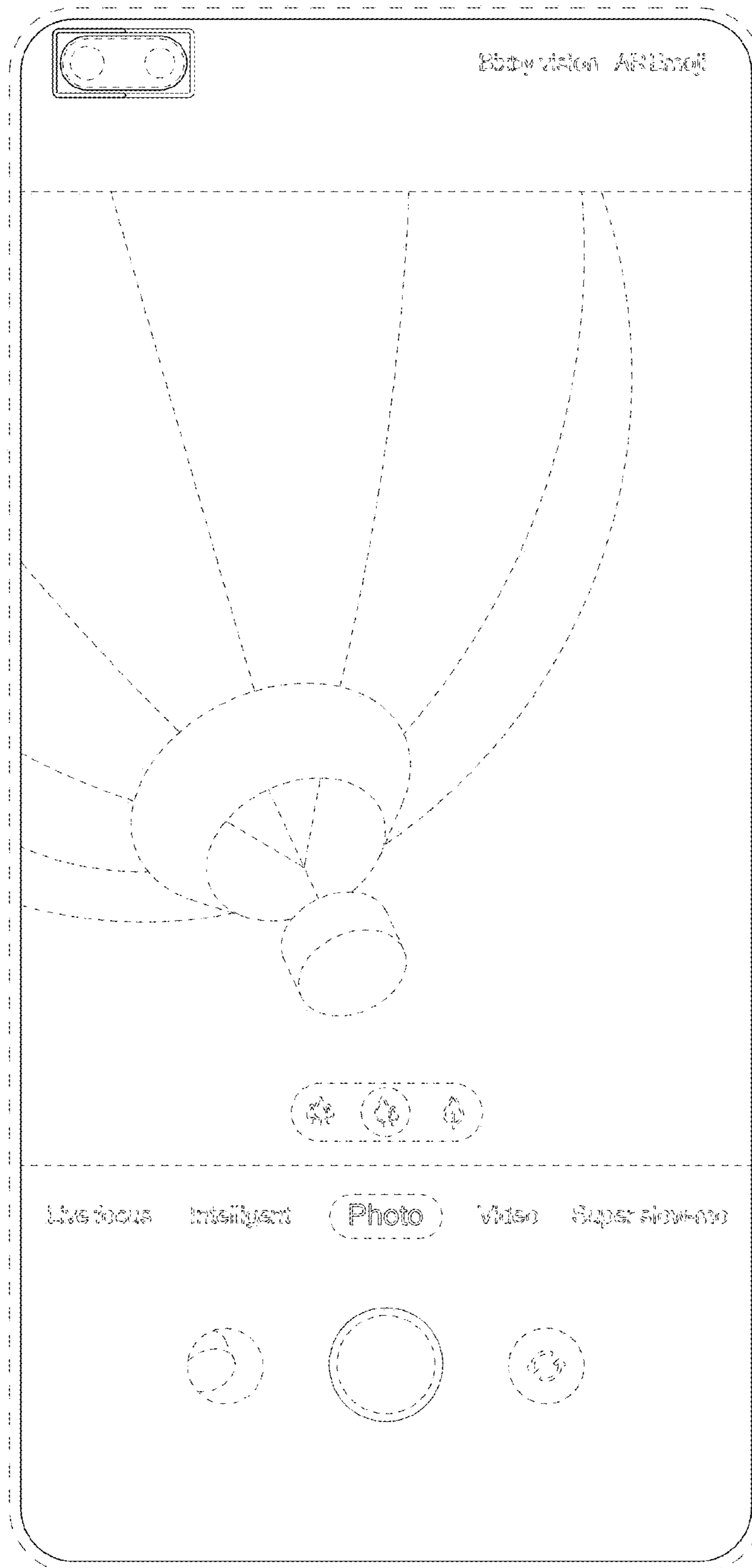

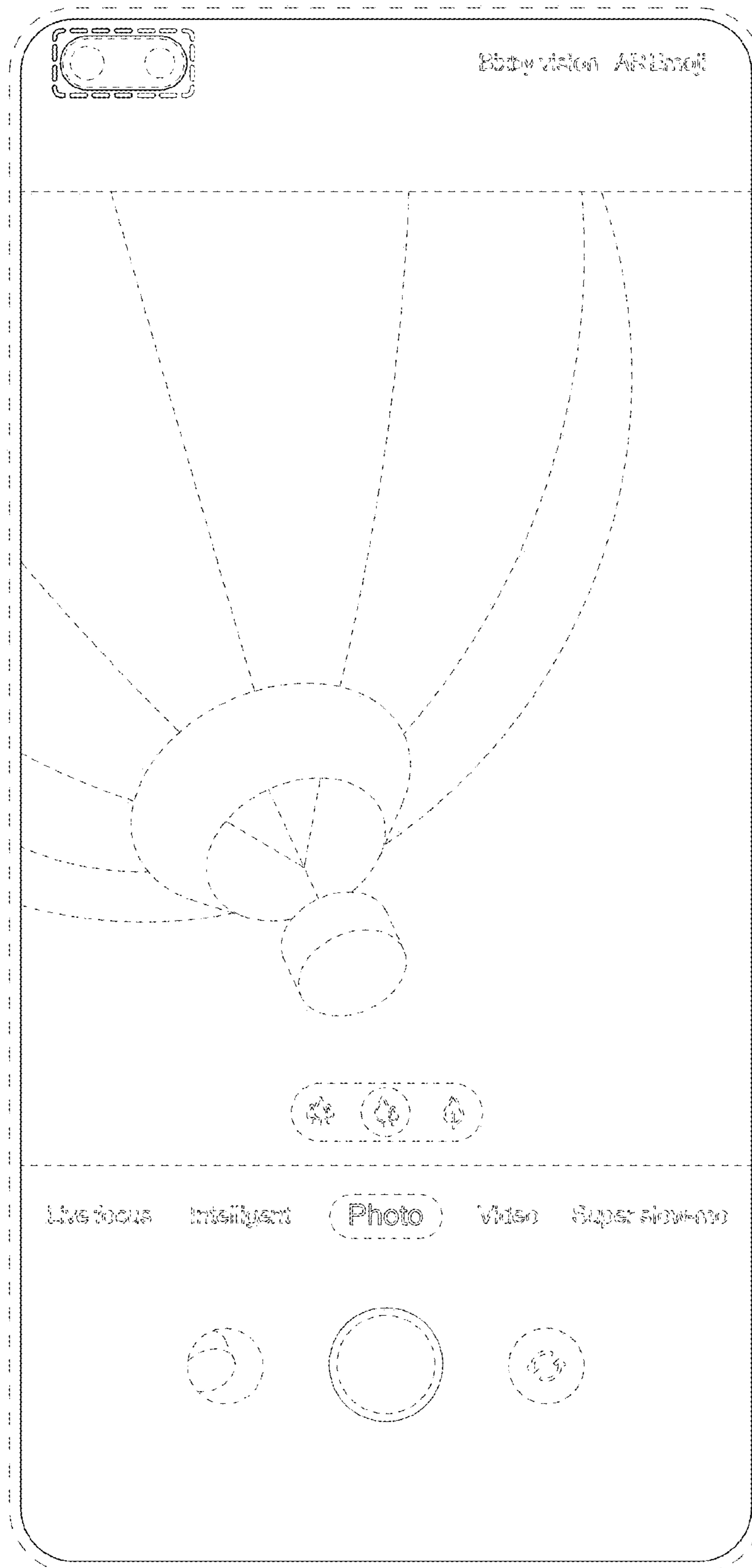

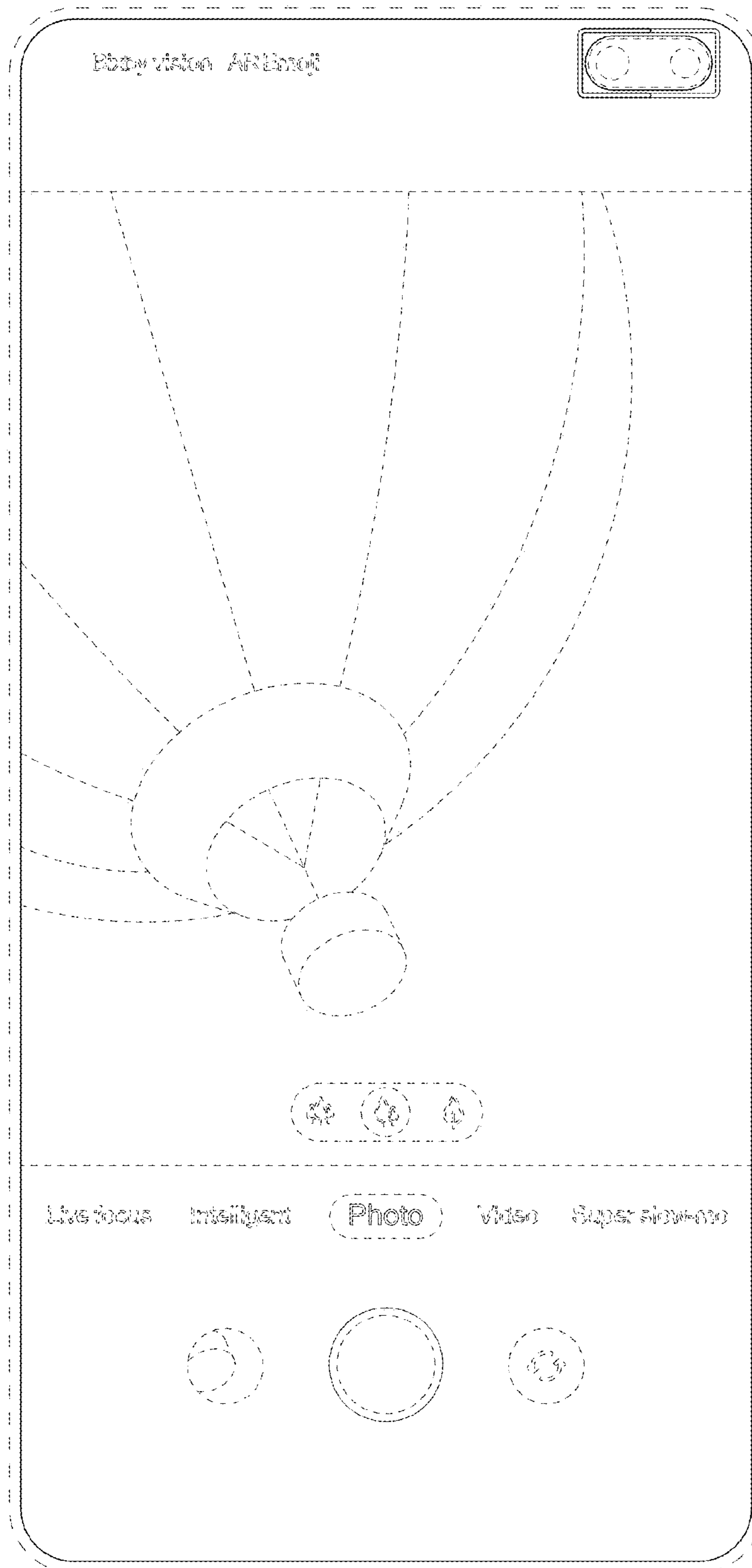

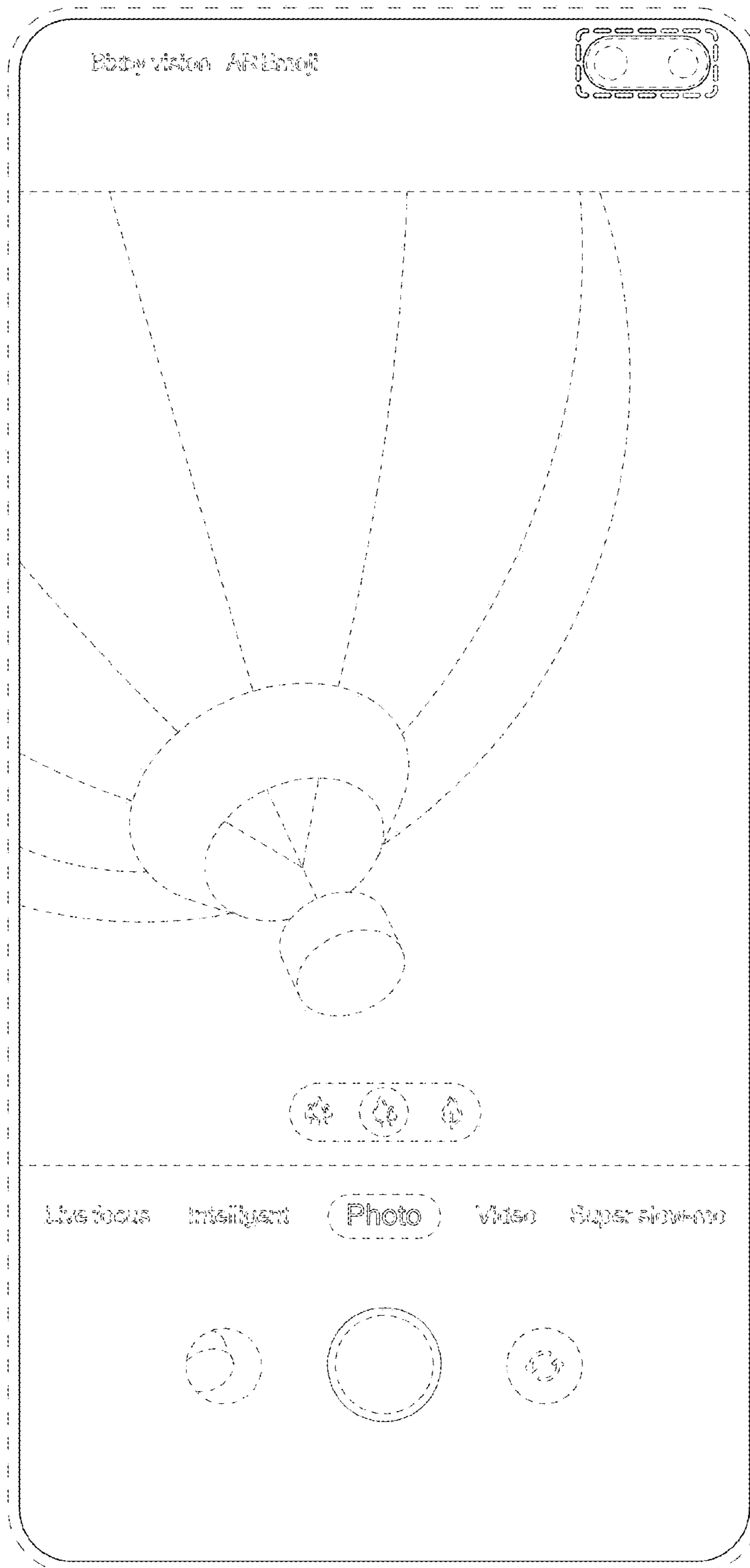

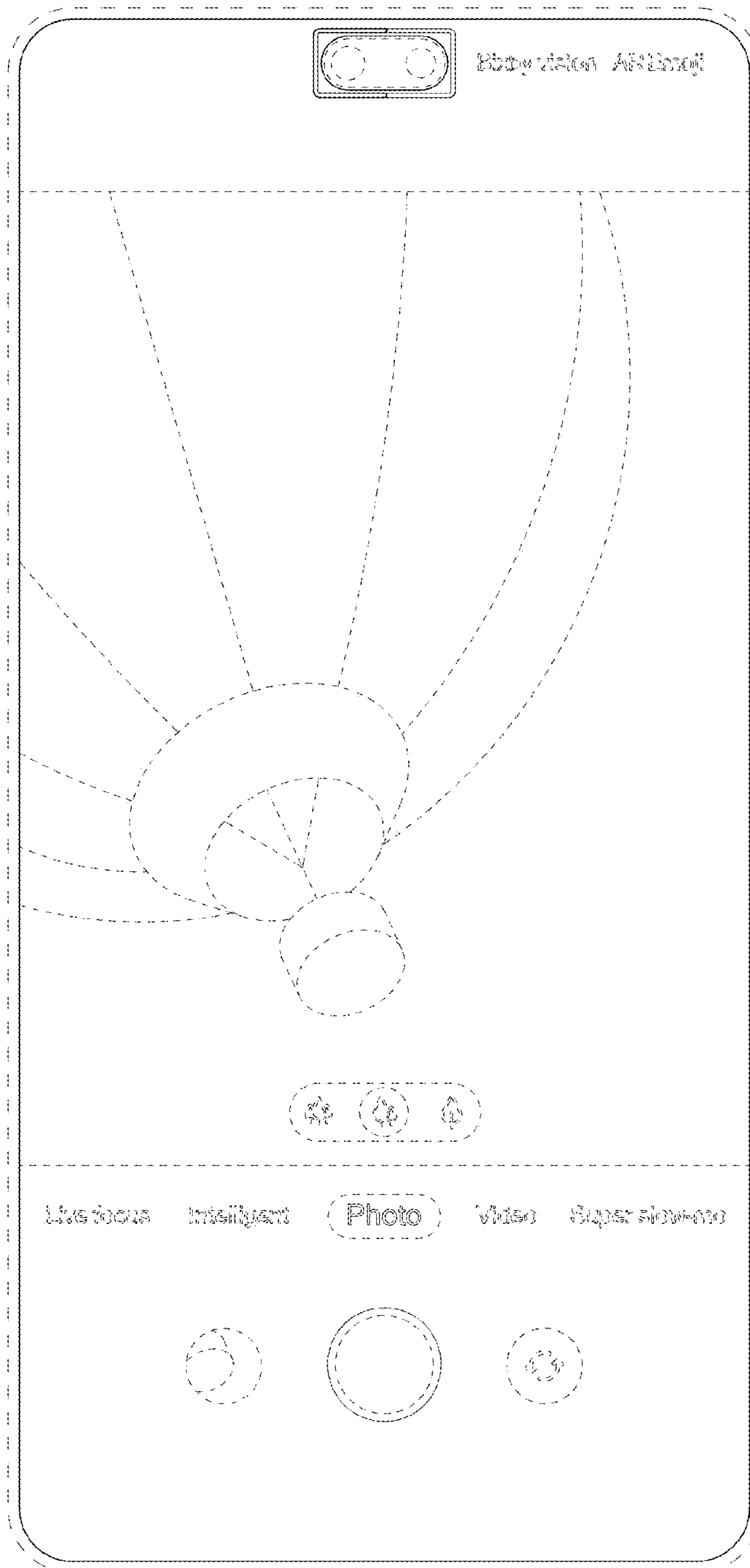
