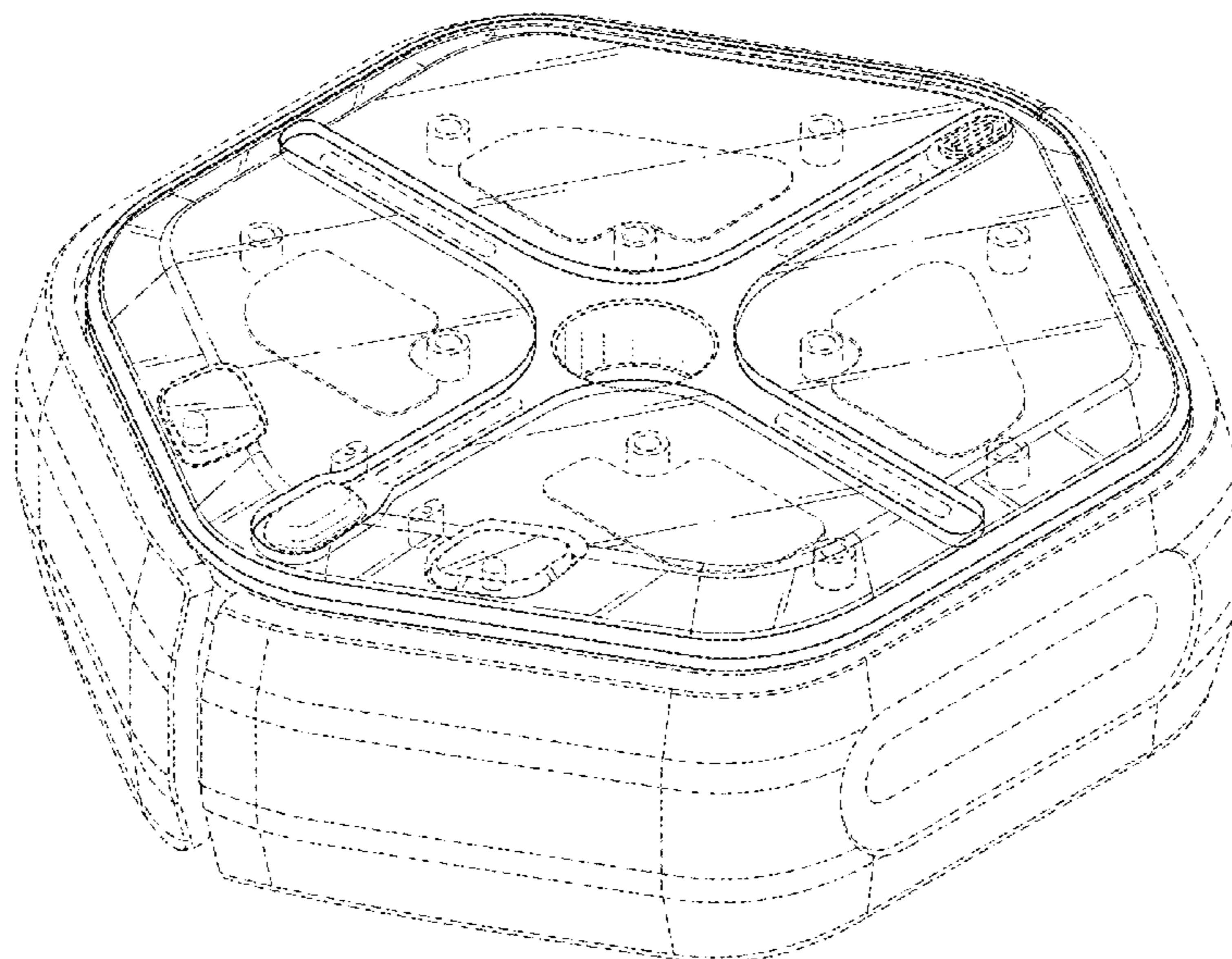
(57) **CLAIM**

The ornamental design for a cover for a programmable robot, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-left-isometric view of my cover for a programmable robot including a body in phantom; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left-side view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The features shown in dashed lines represent unclaimed portions of the cover for a programmable robot and form no part of the claimed design.

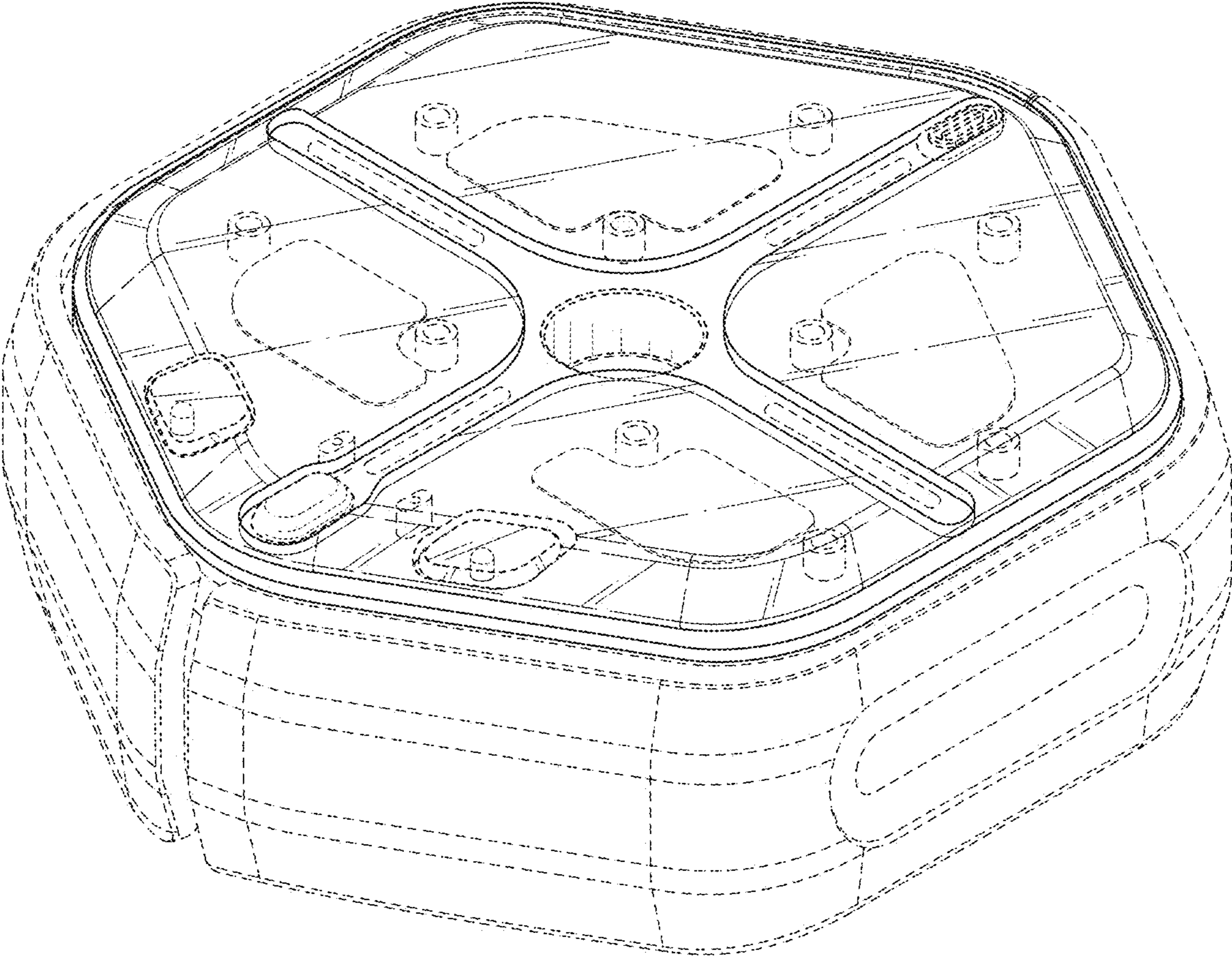

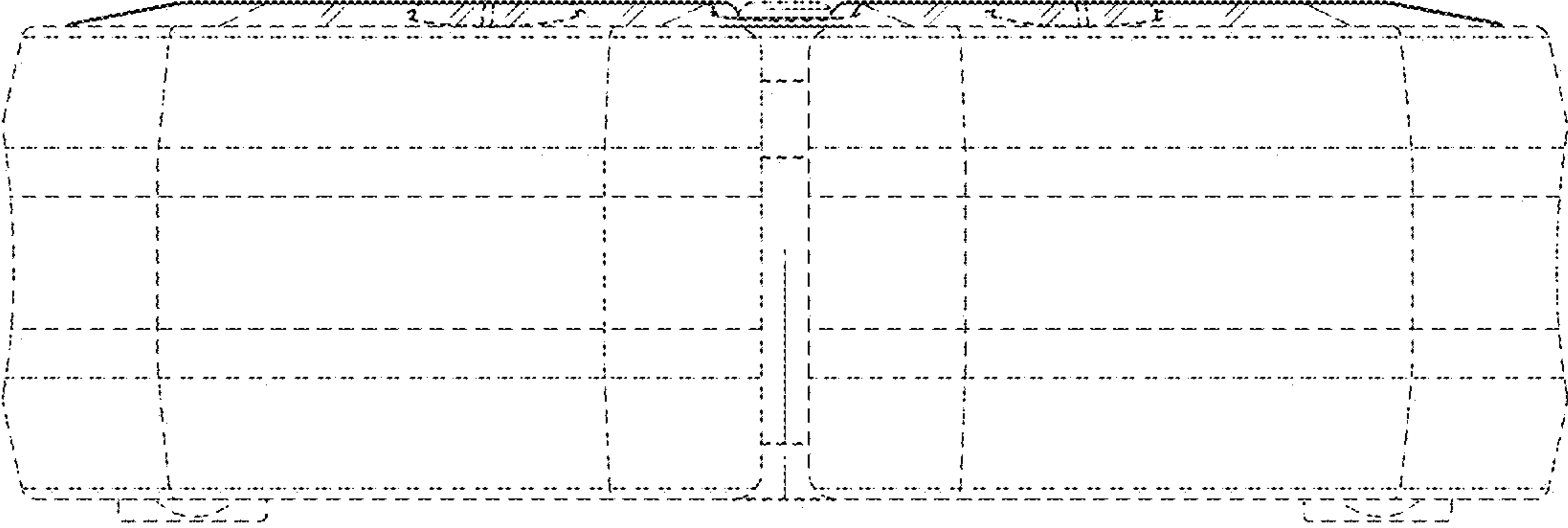

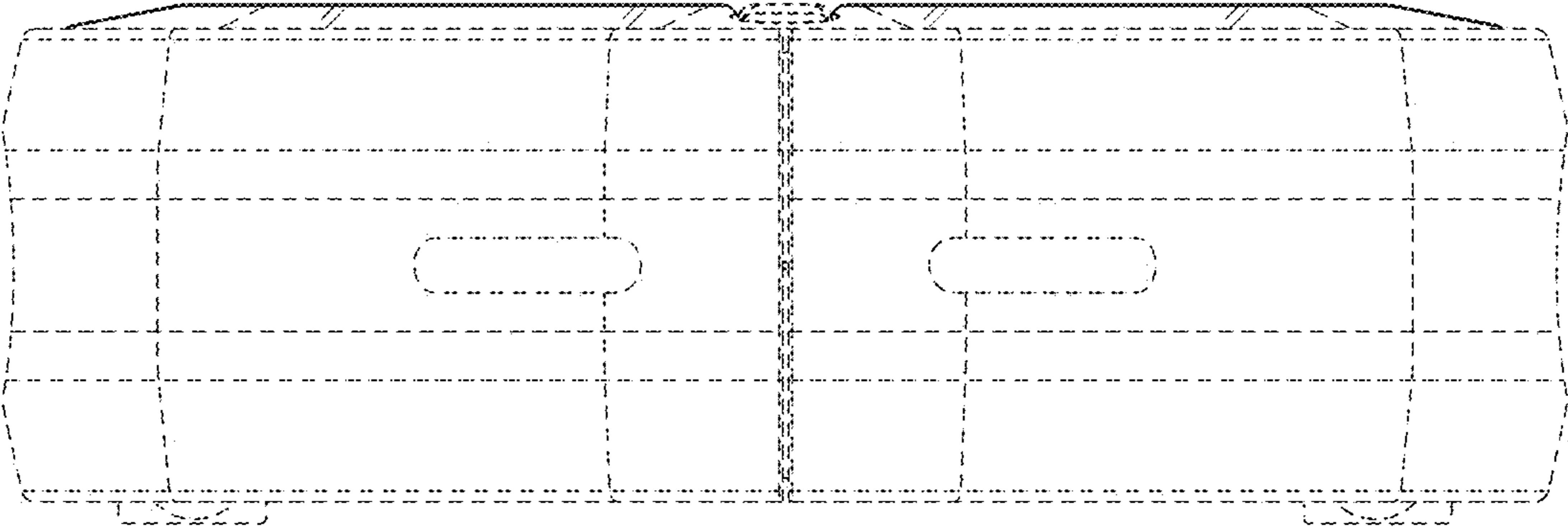

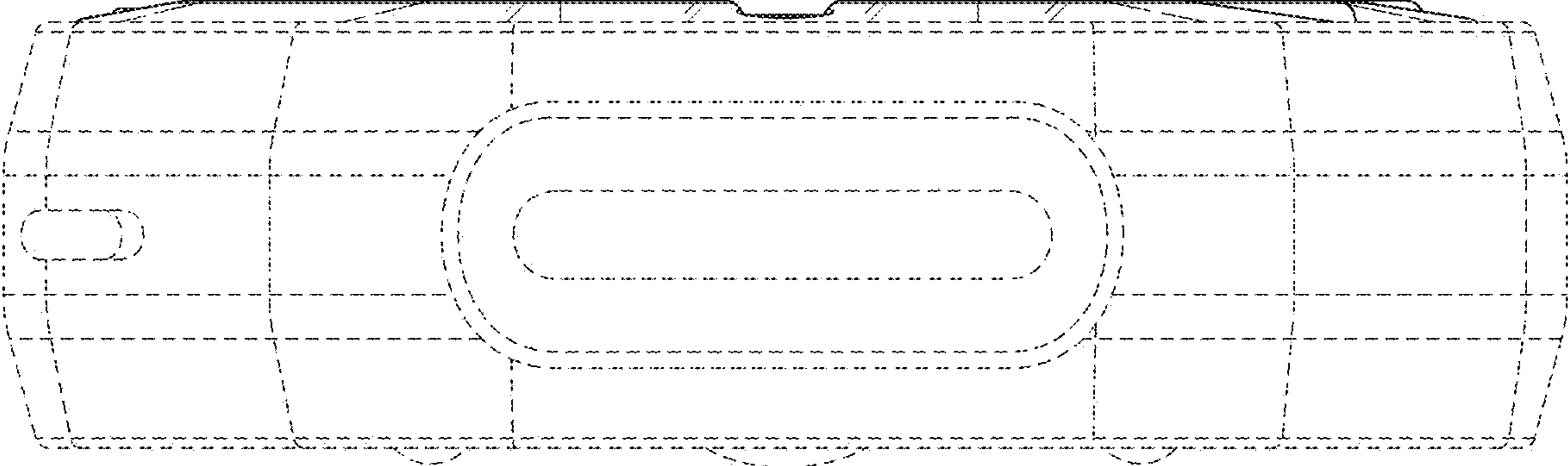

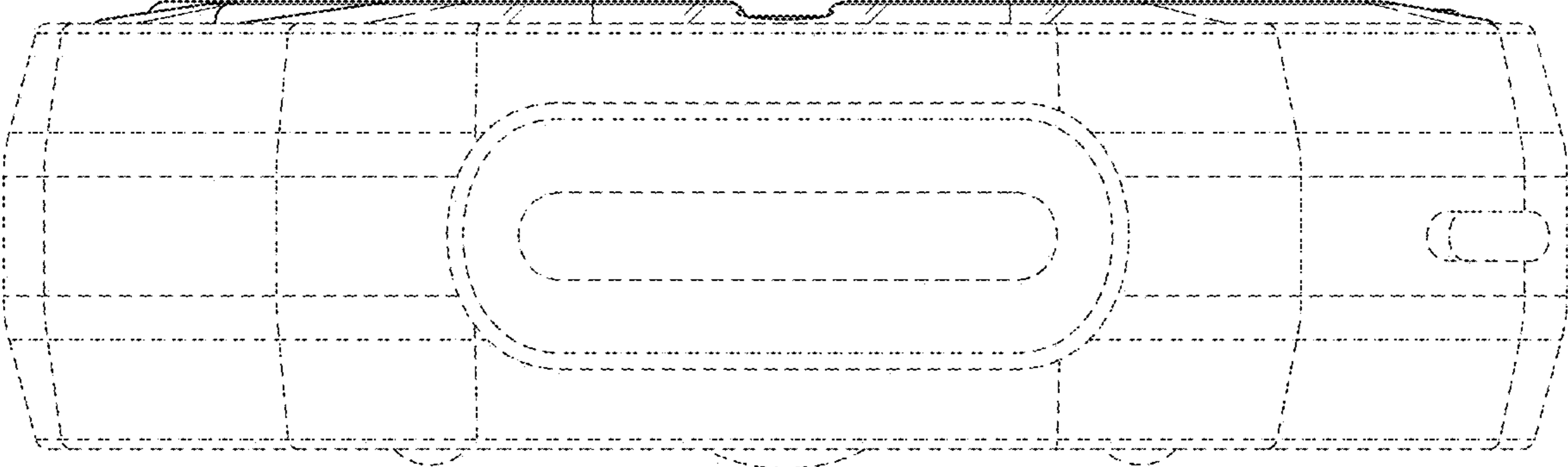

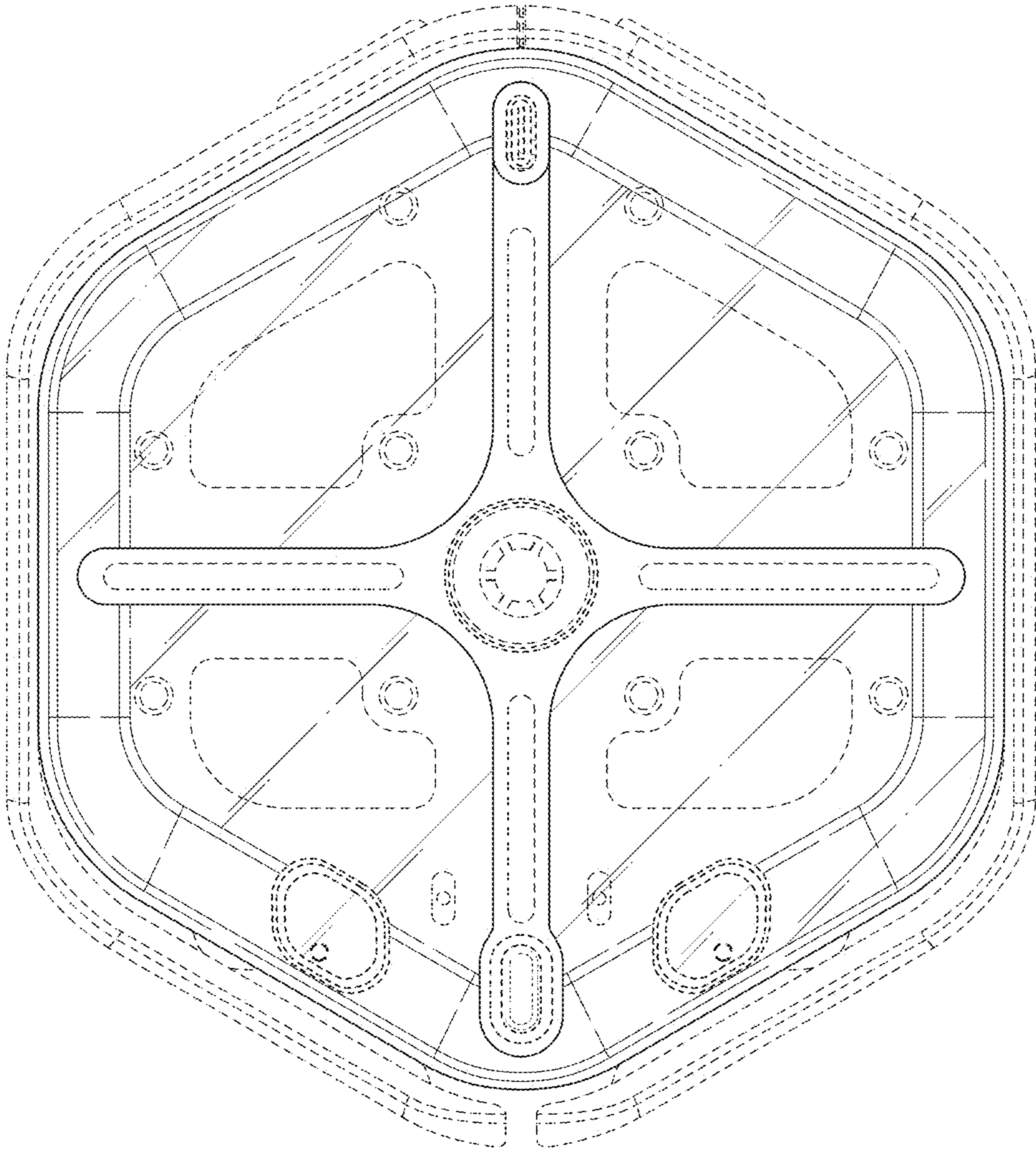

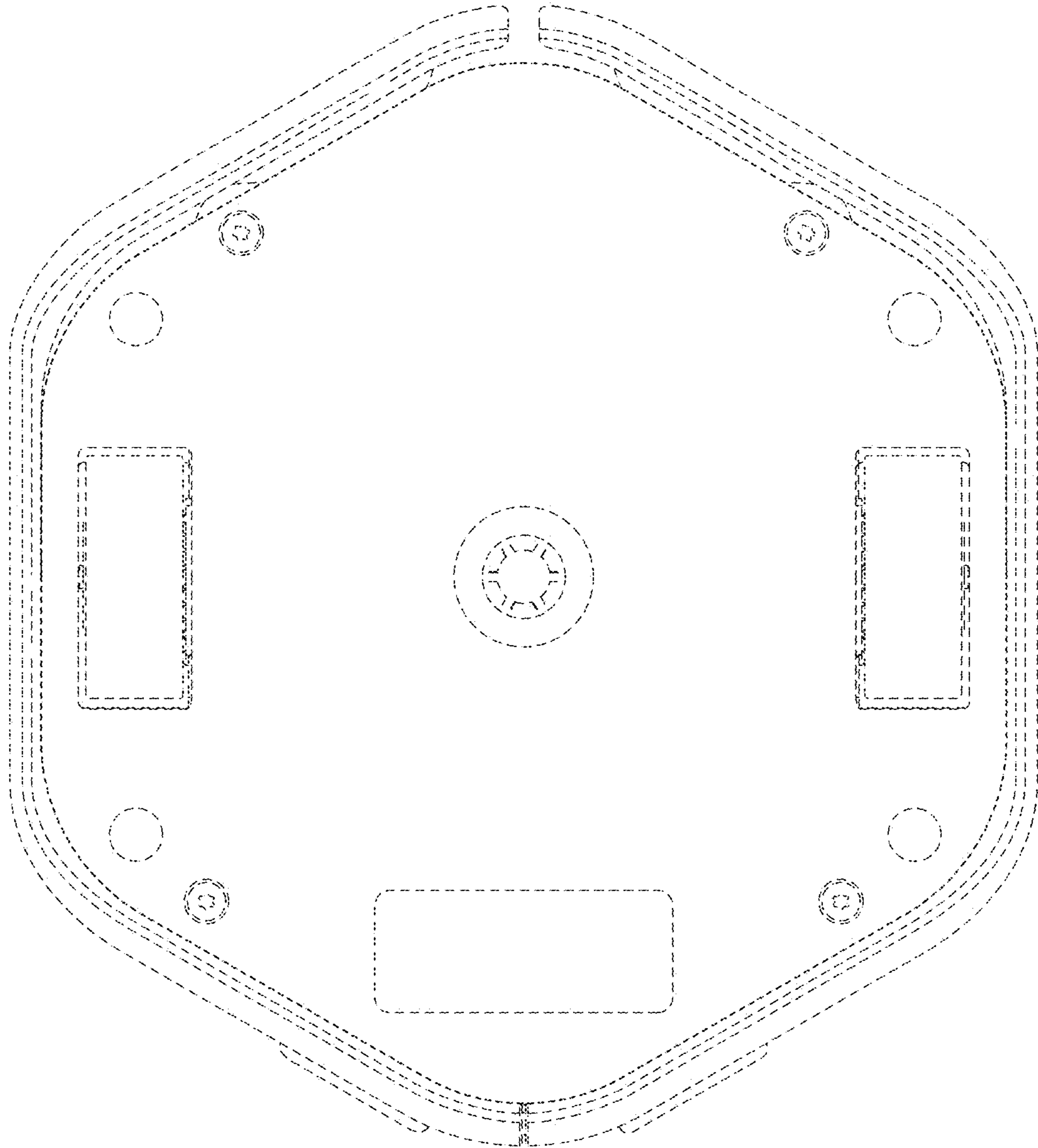
