FIG. 3 is a front elevational view of the musical toy of FIG. 1.

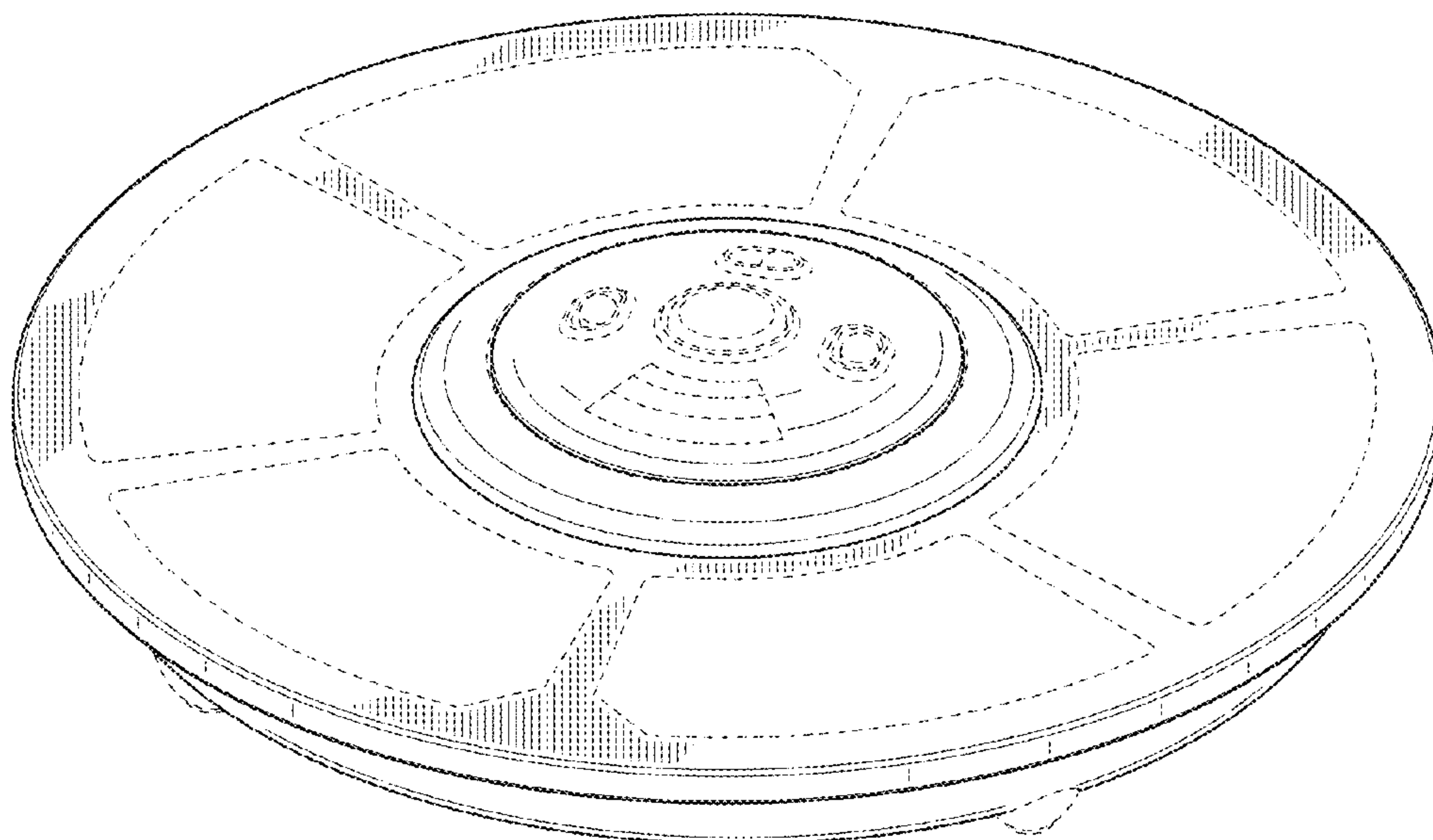
FIG. 4 is a back elevational view of the musical toy of FIG. 1.

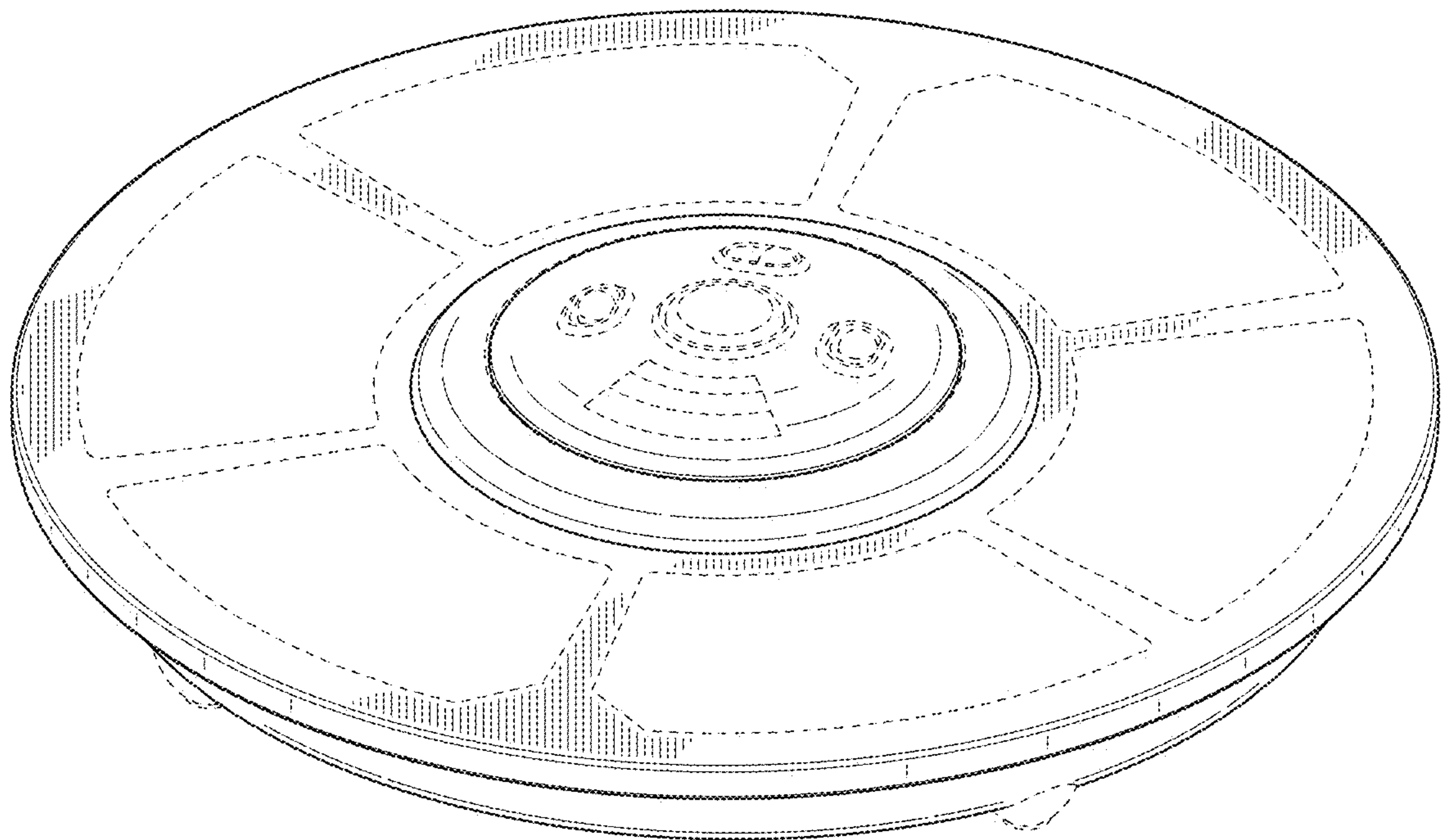

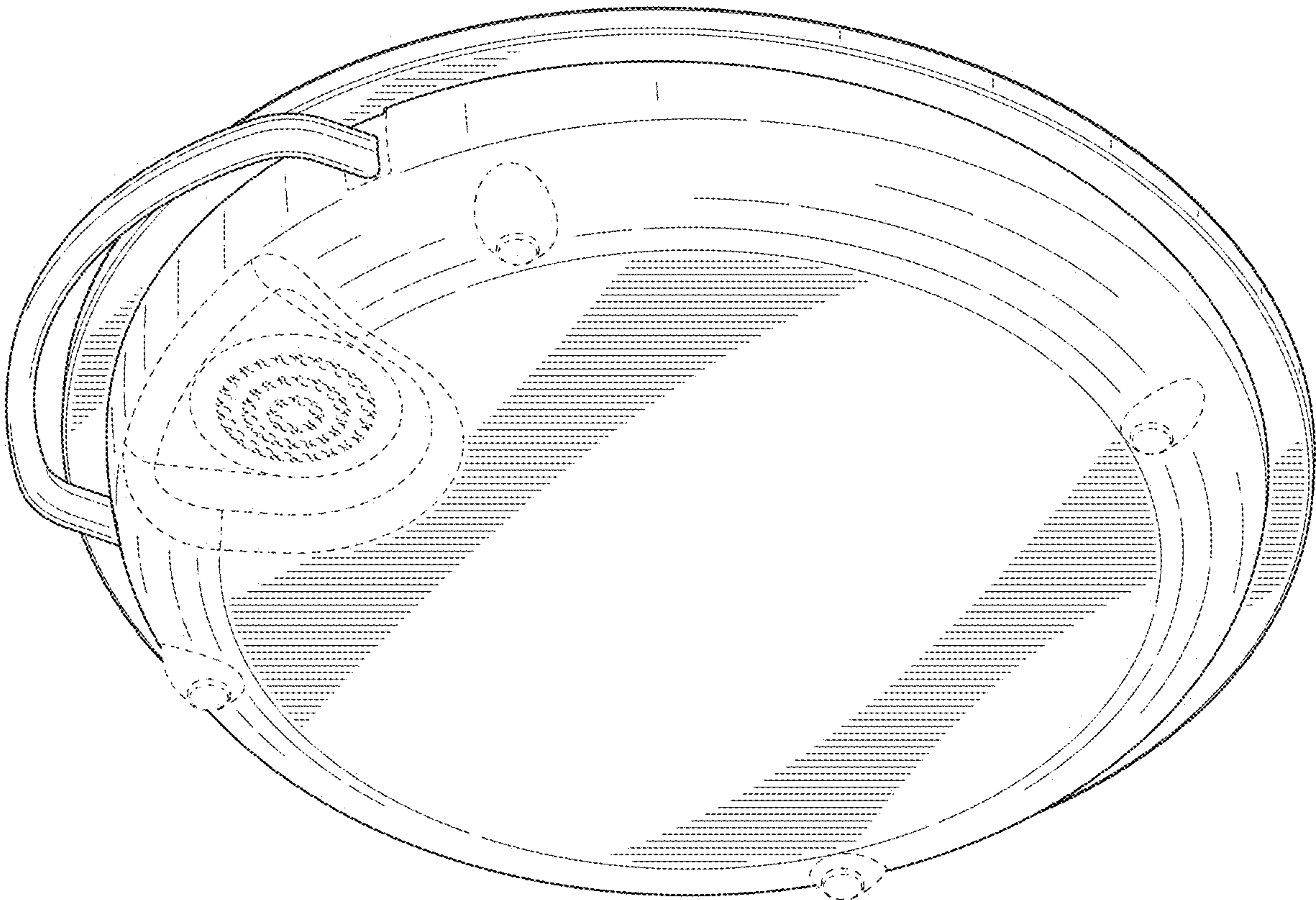

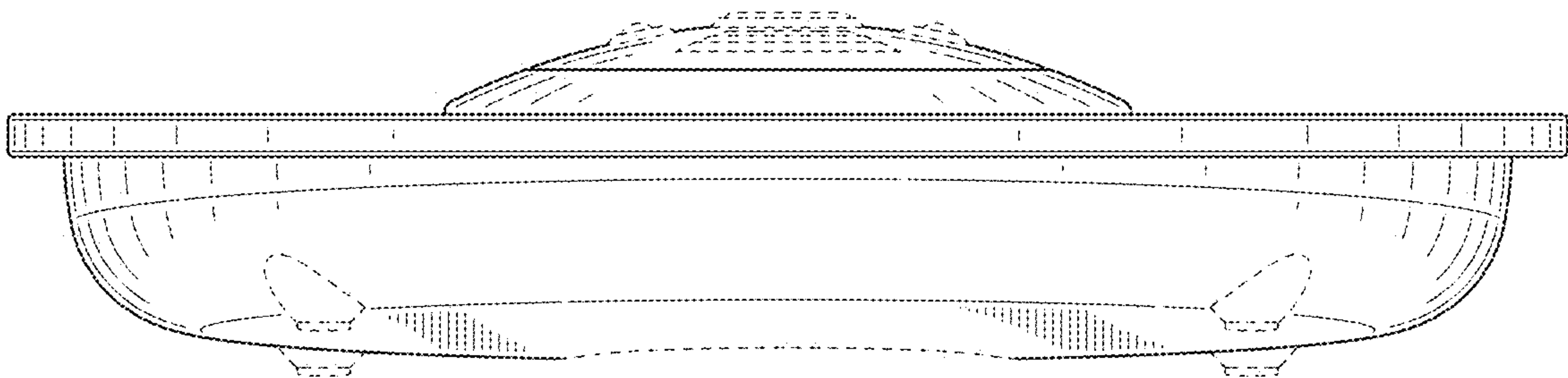

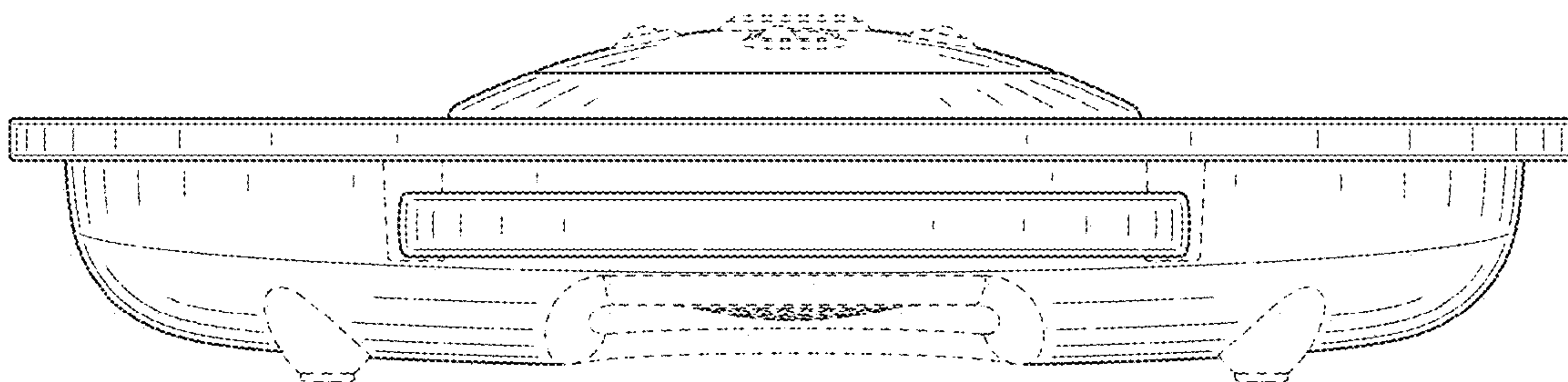

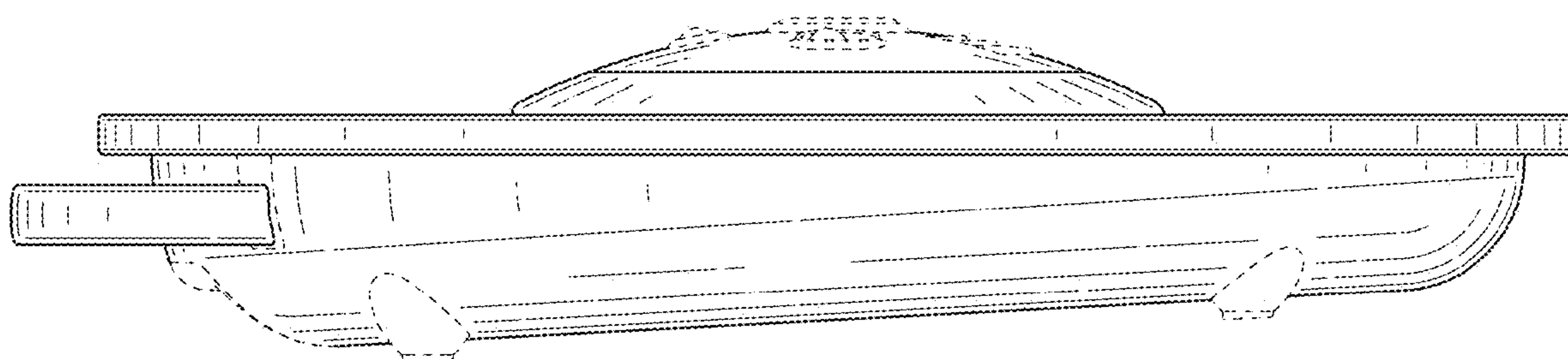

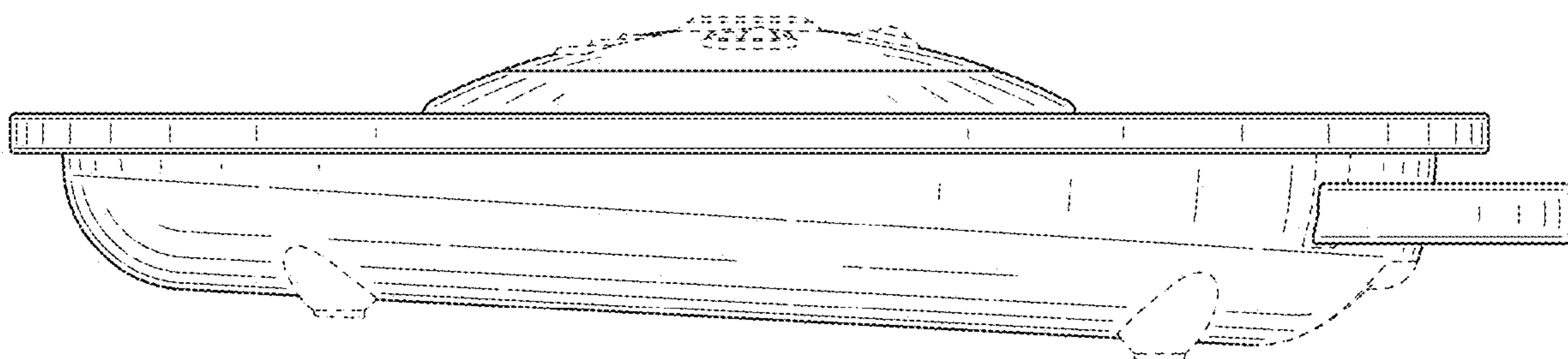

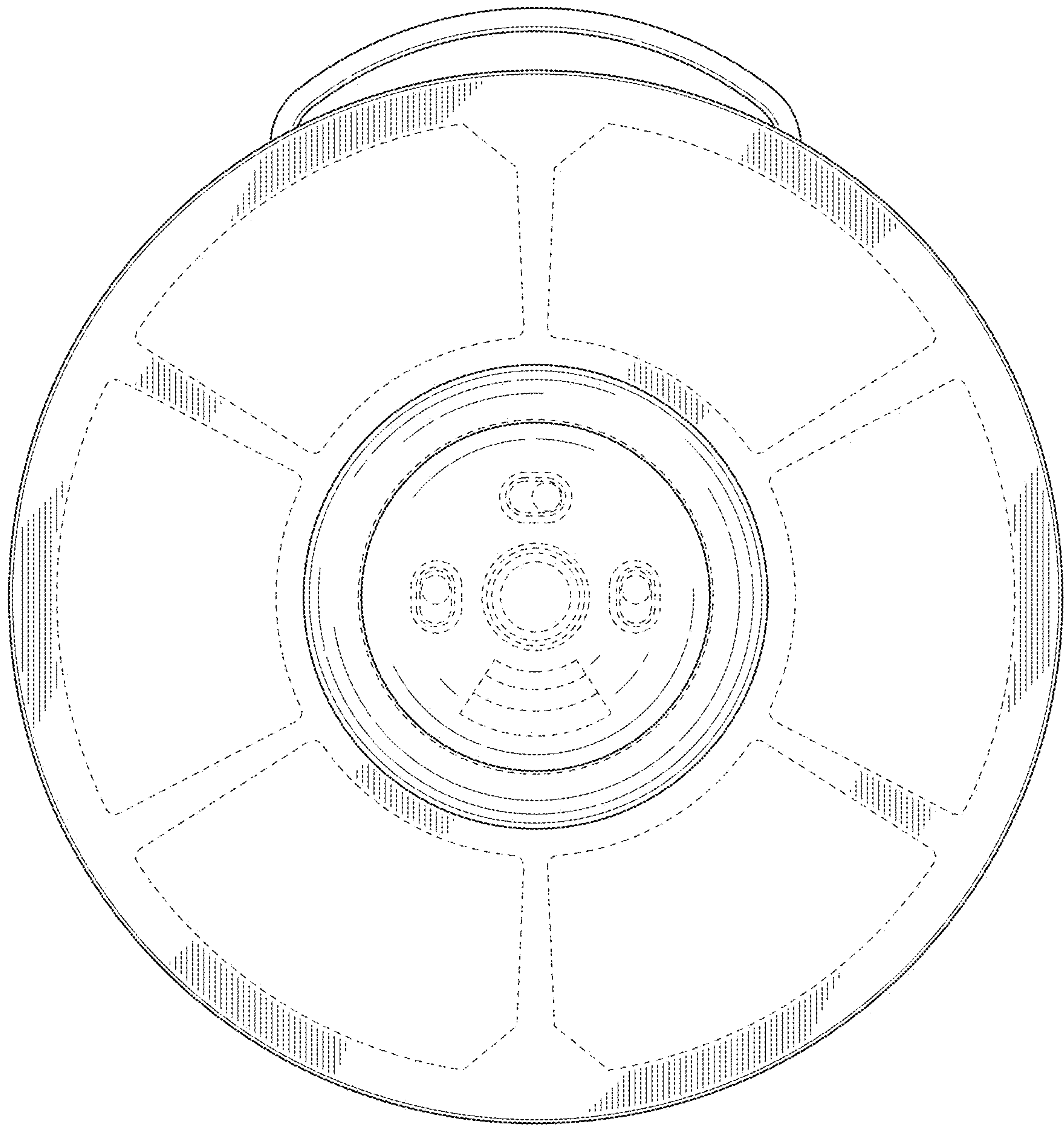

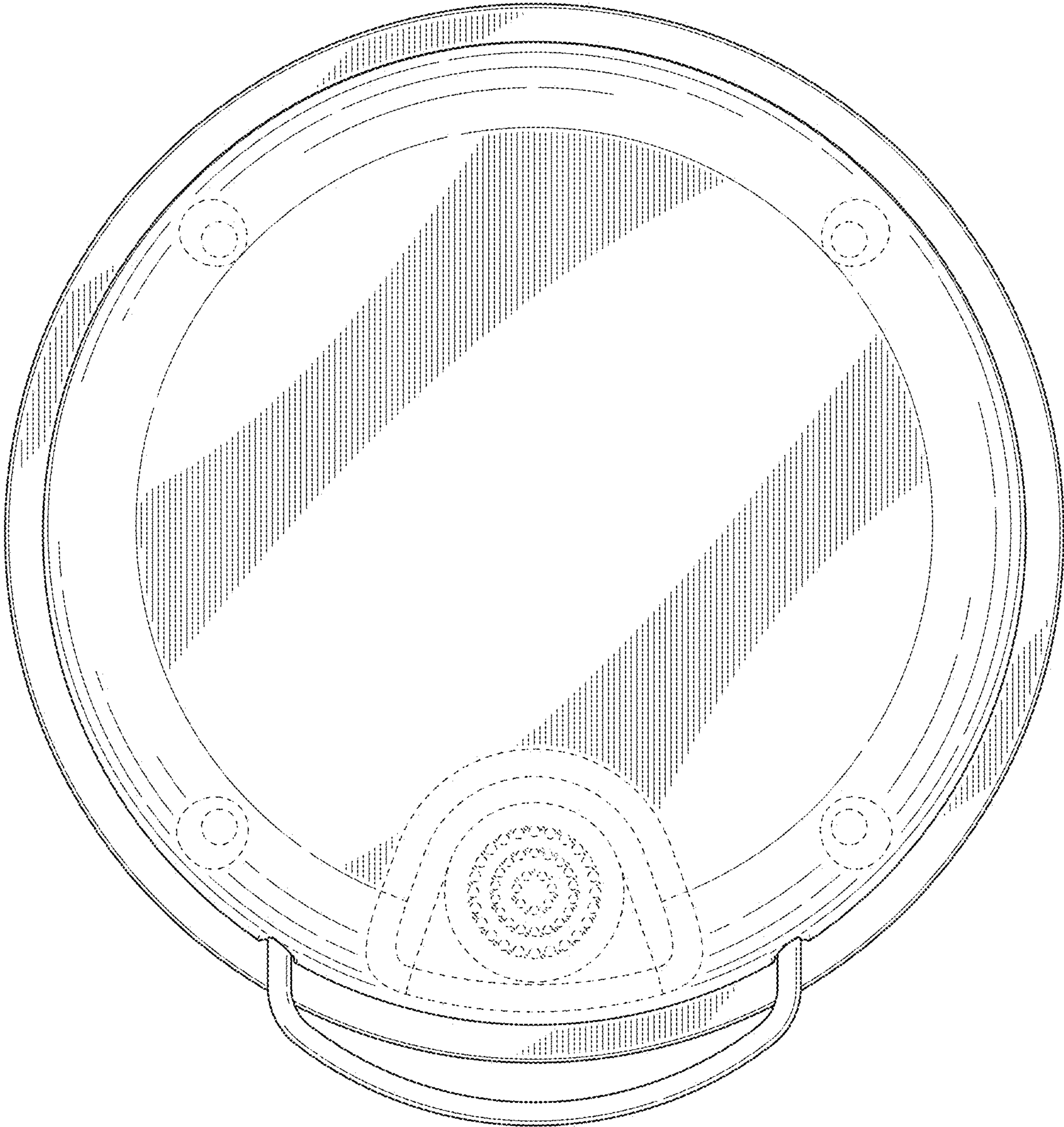
