(57) **CLAIM**

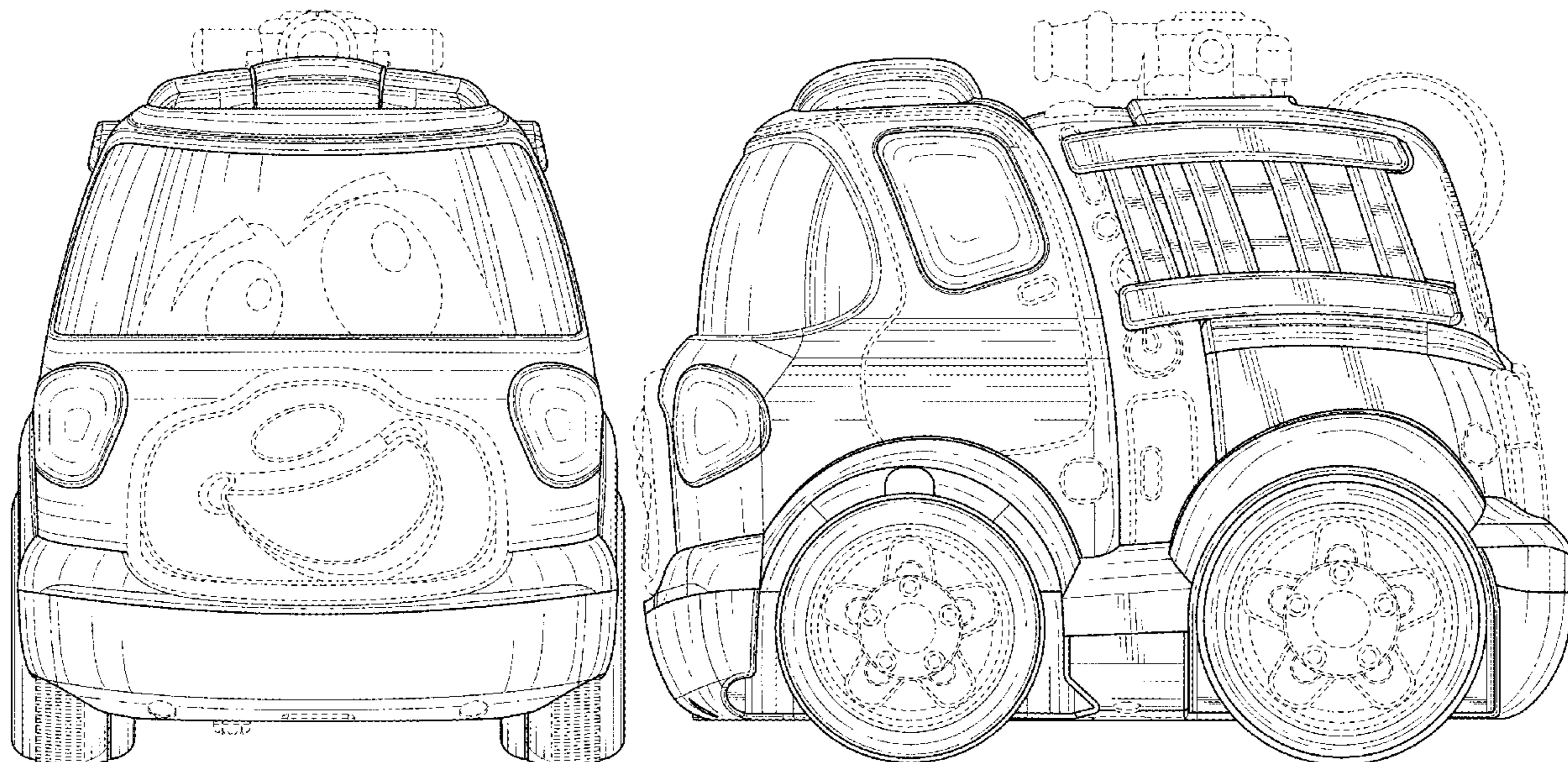
The ornamental design for a fire truck toy, as shown and described.

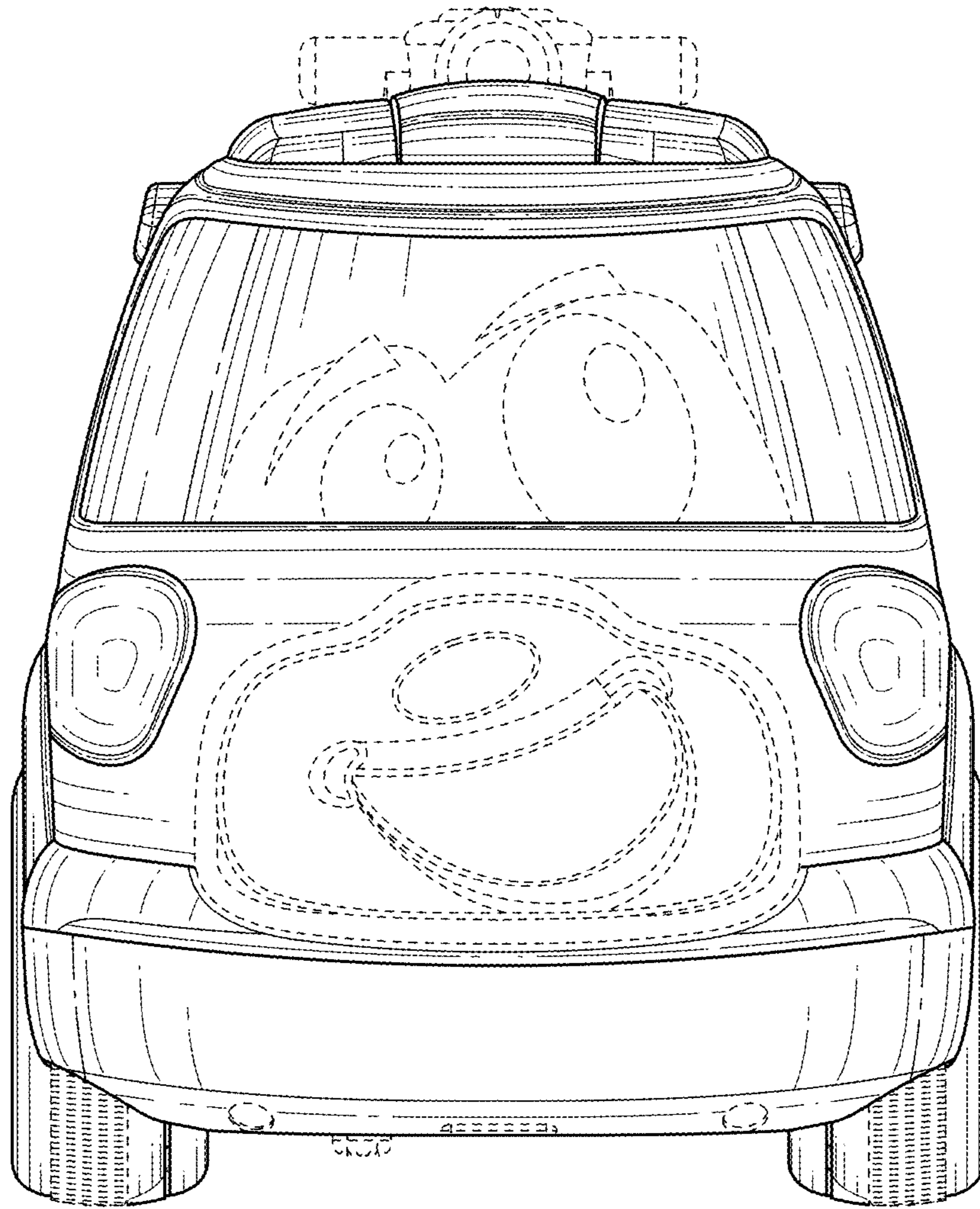

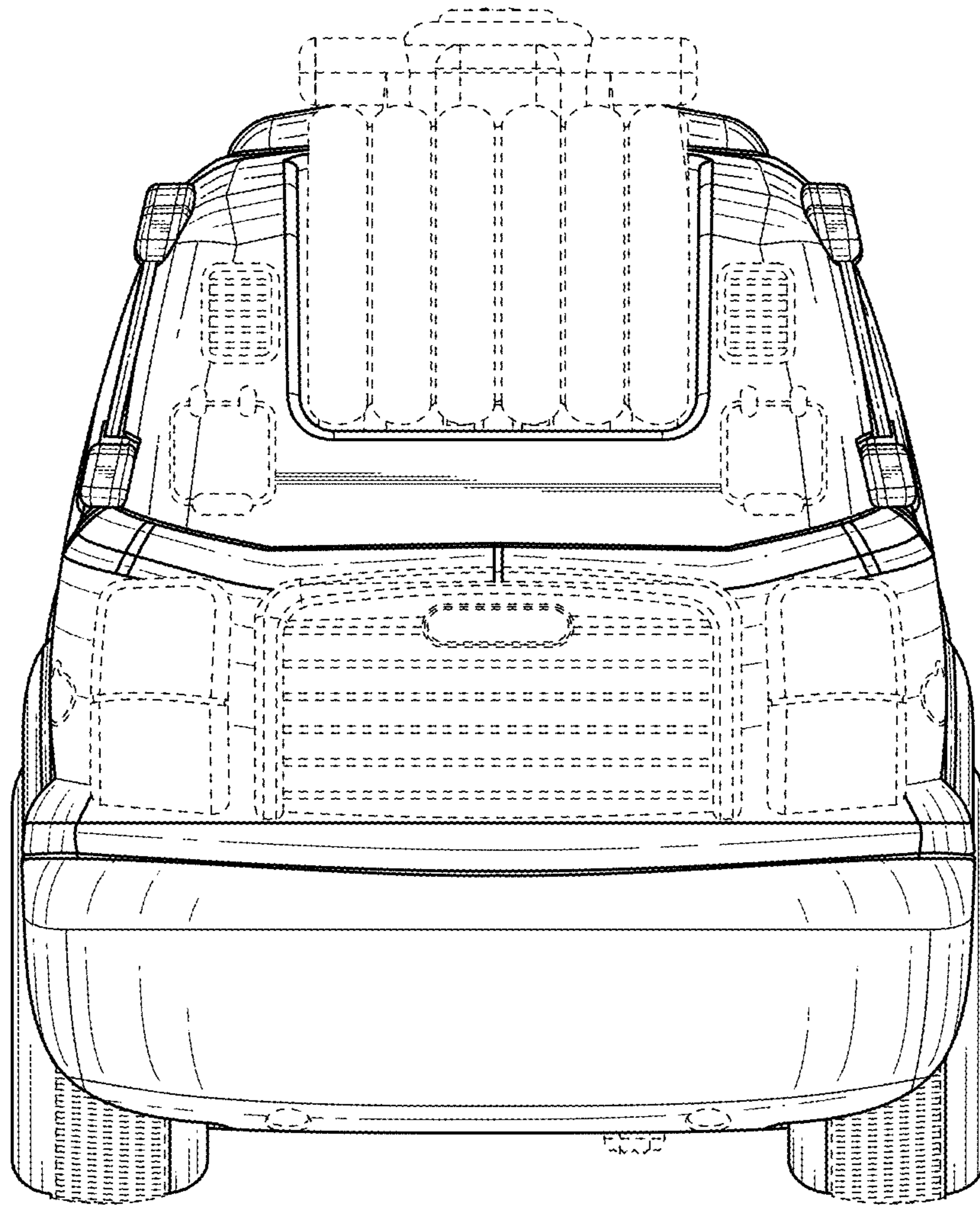

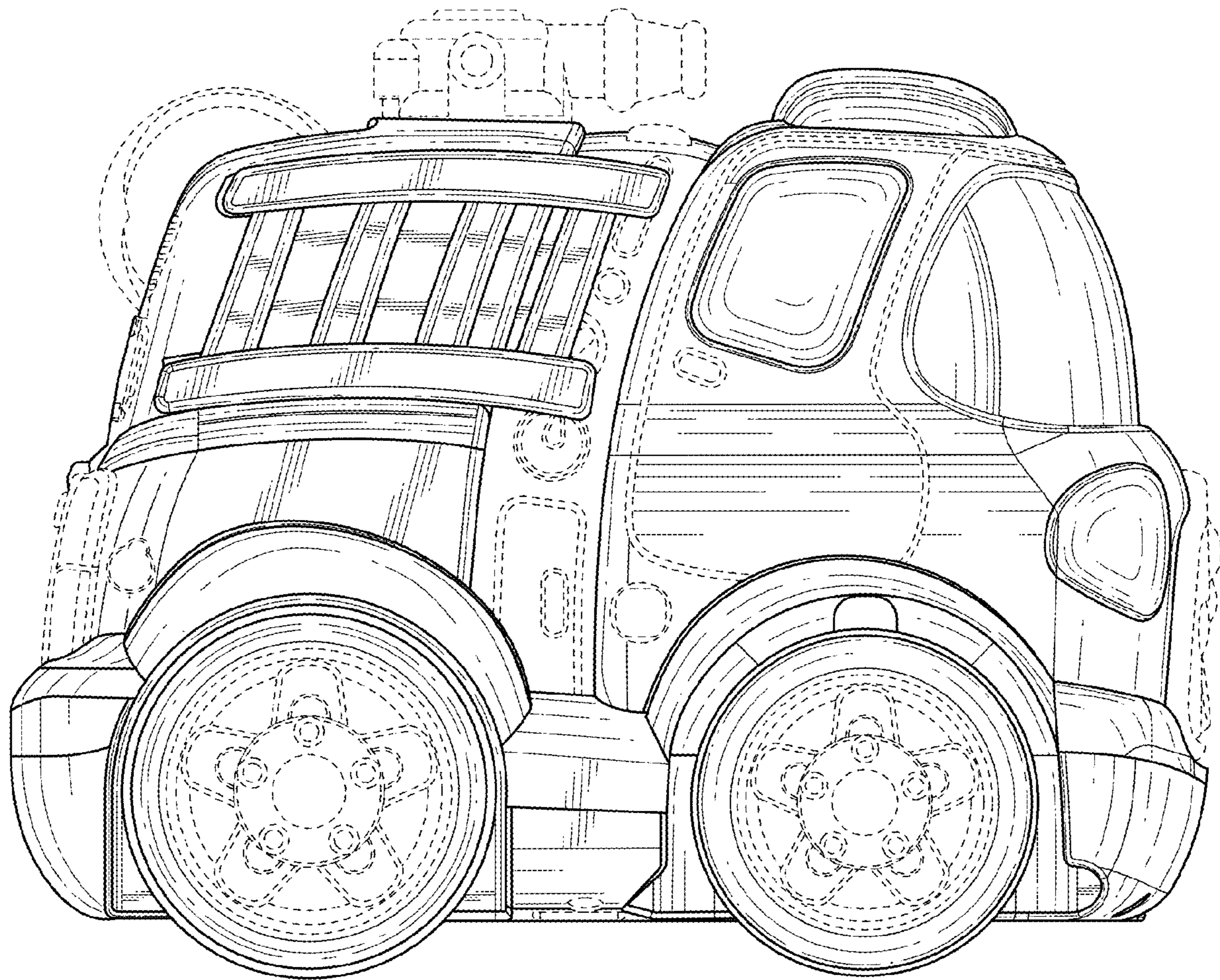

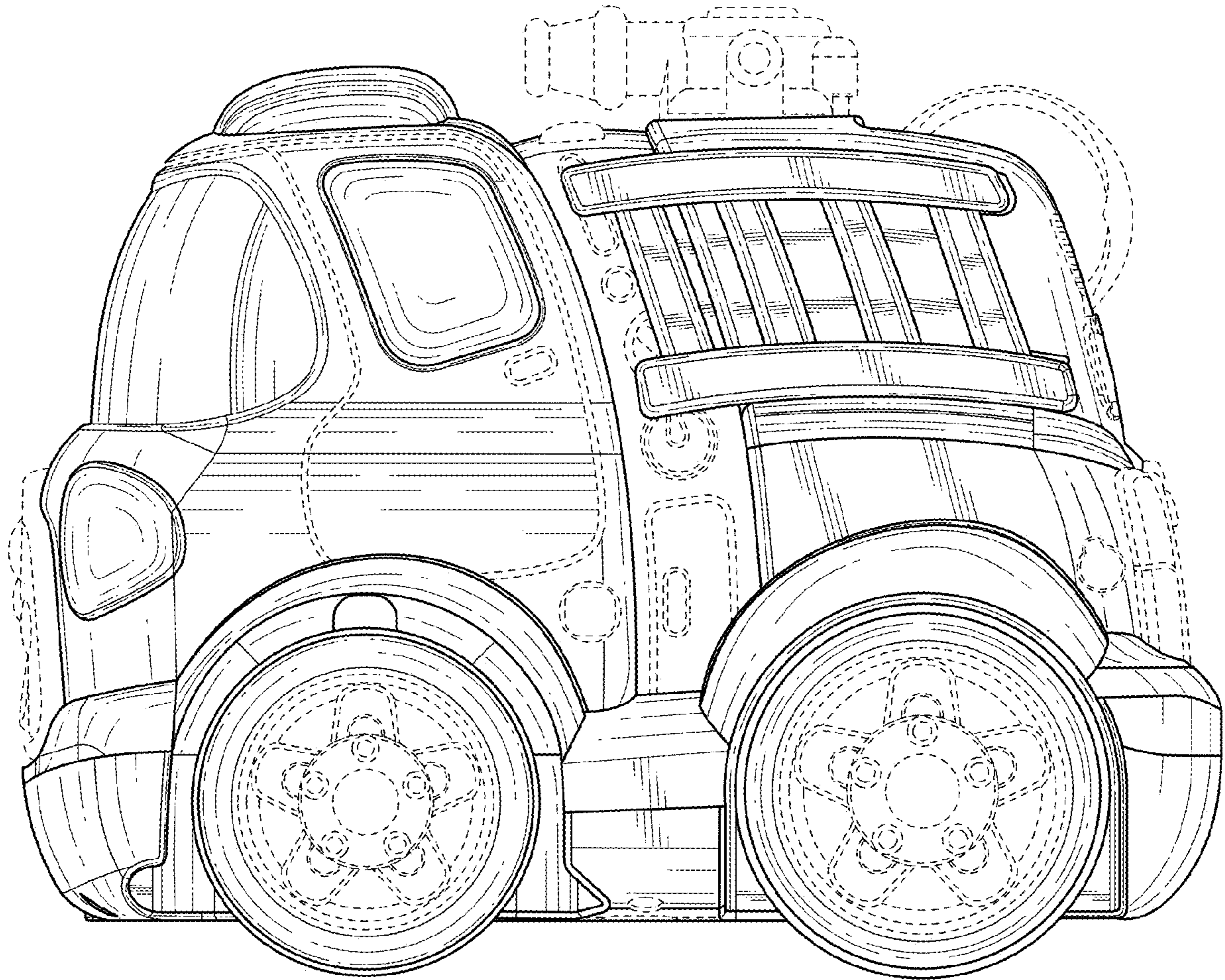

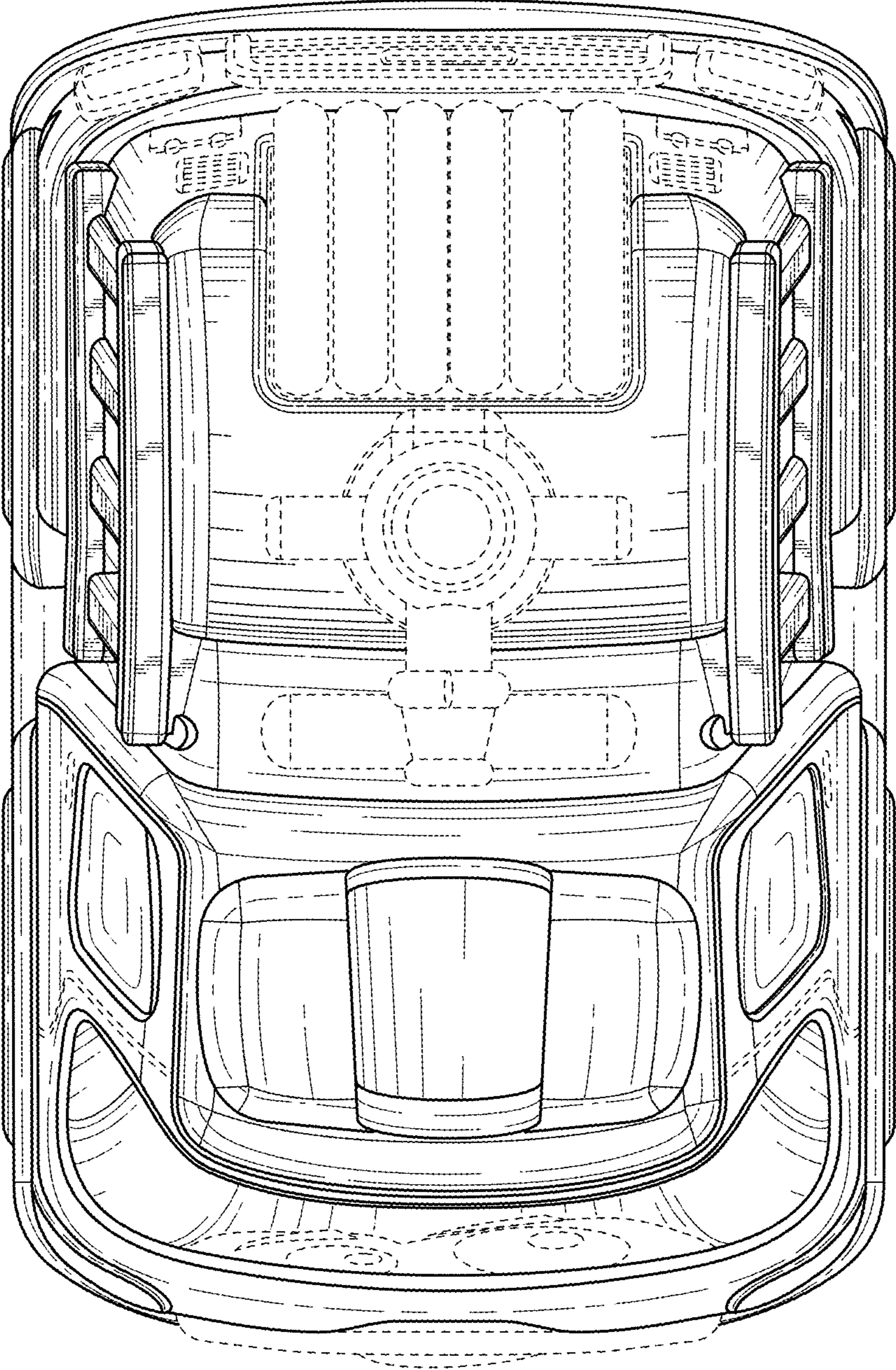

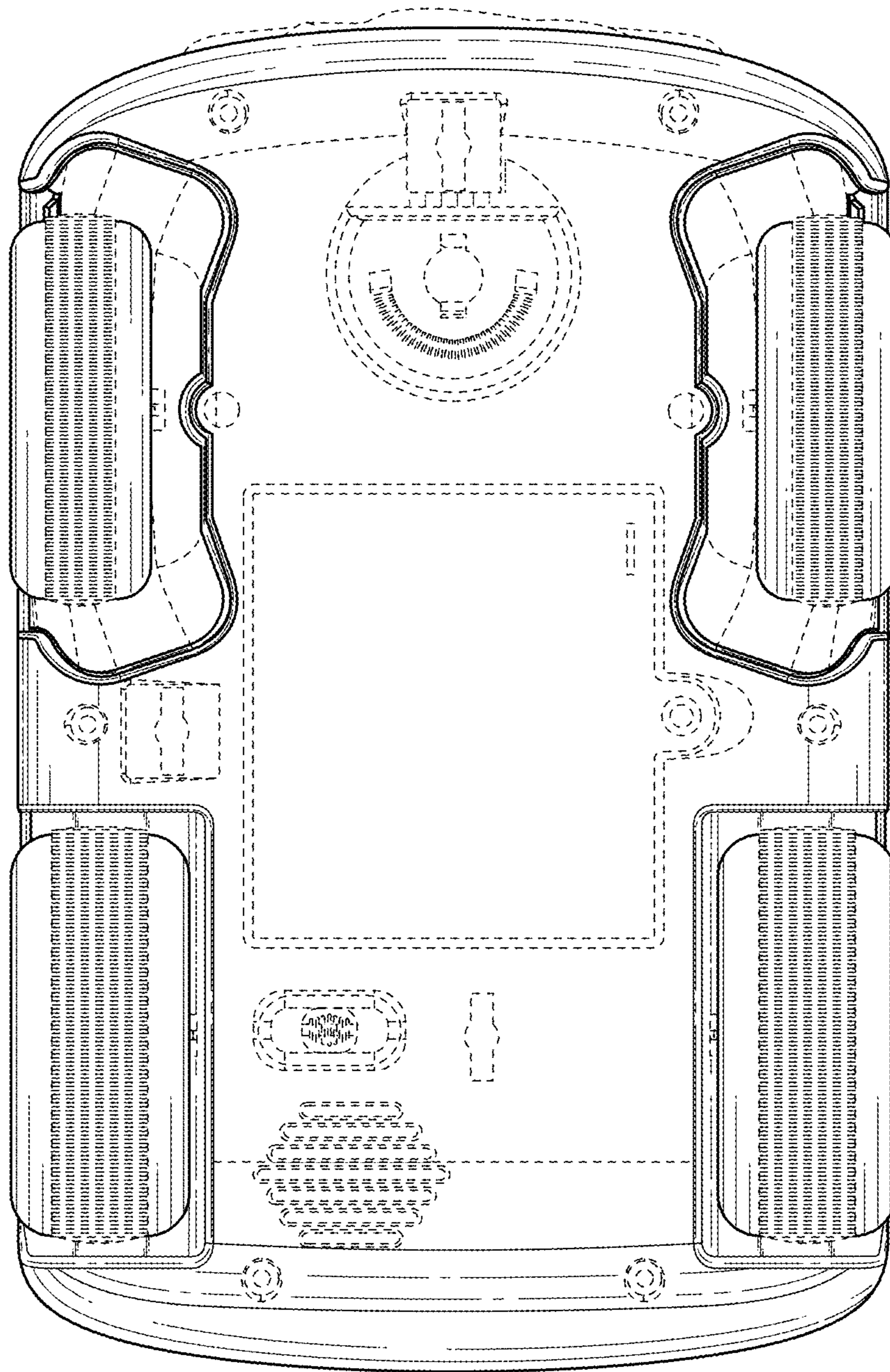
