(57) **CLAIM**

I claim the ornamental design for a weight plate for free-weight exercise equipment, as shown and described.

FIG. 5 shows a right side view thereof.

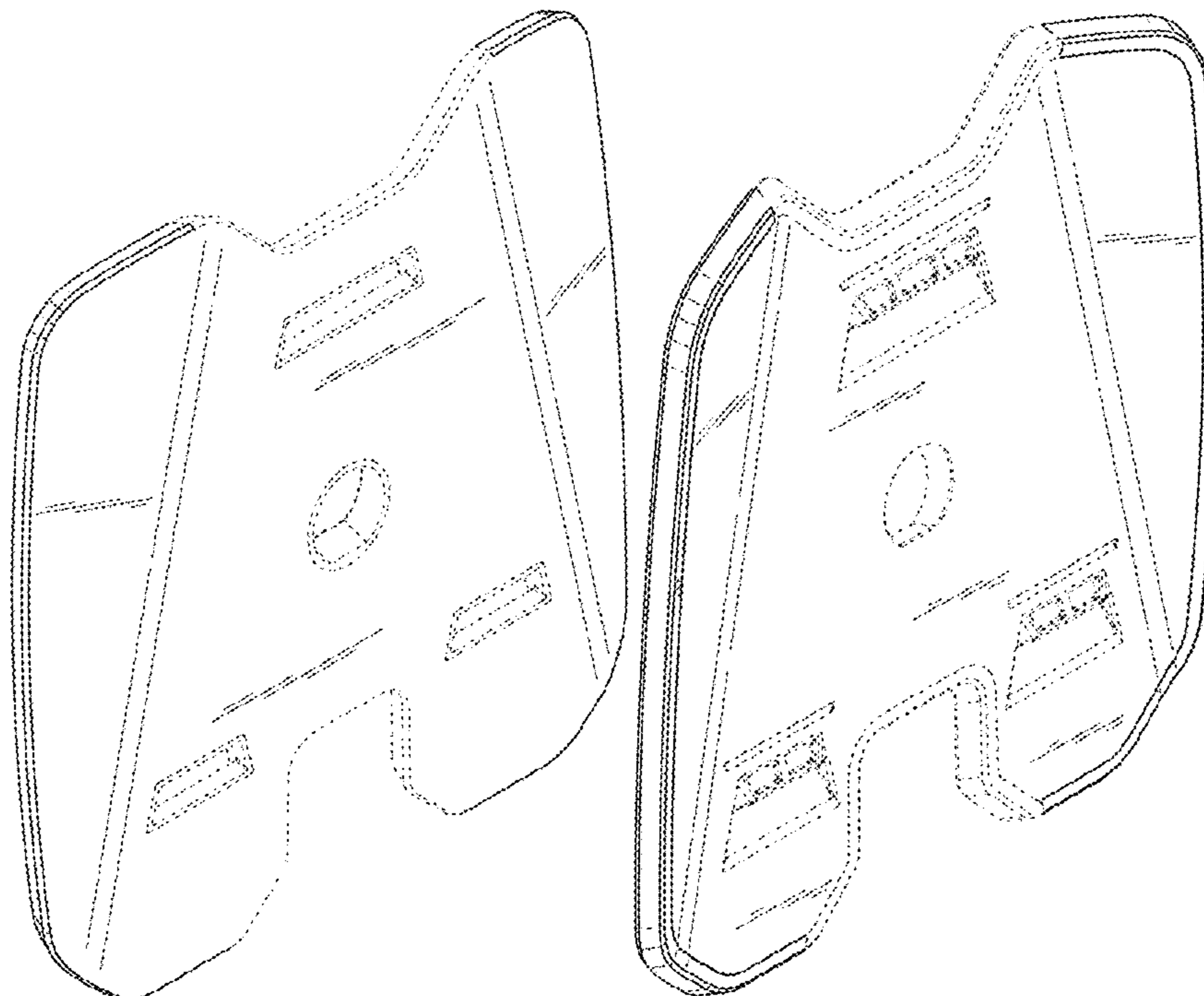
FIG. 6 shows a left side view thereof.

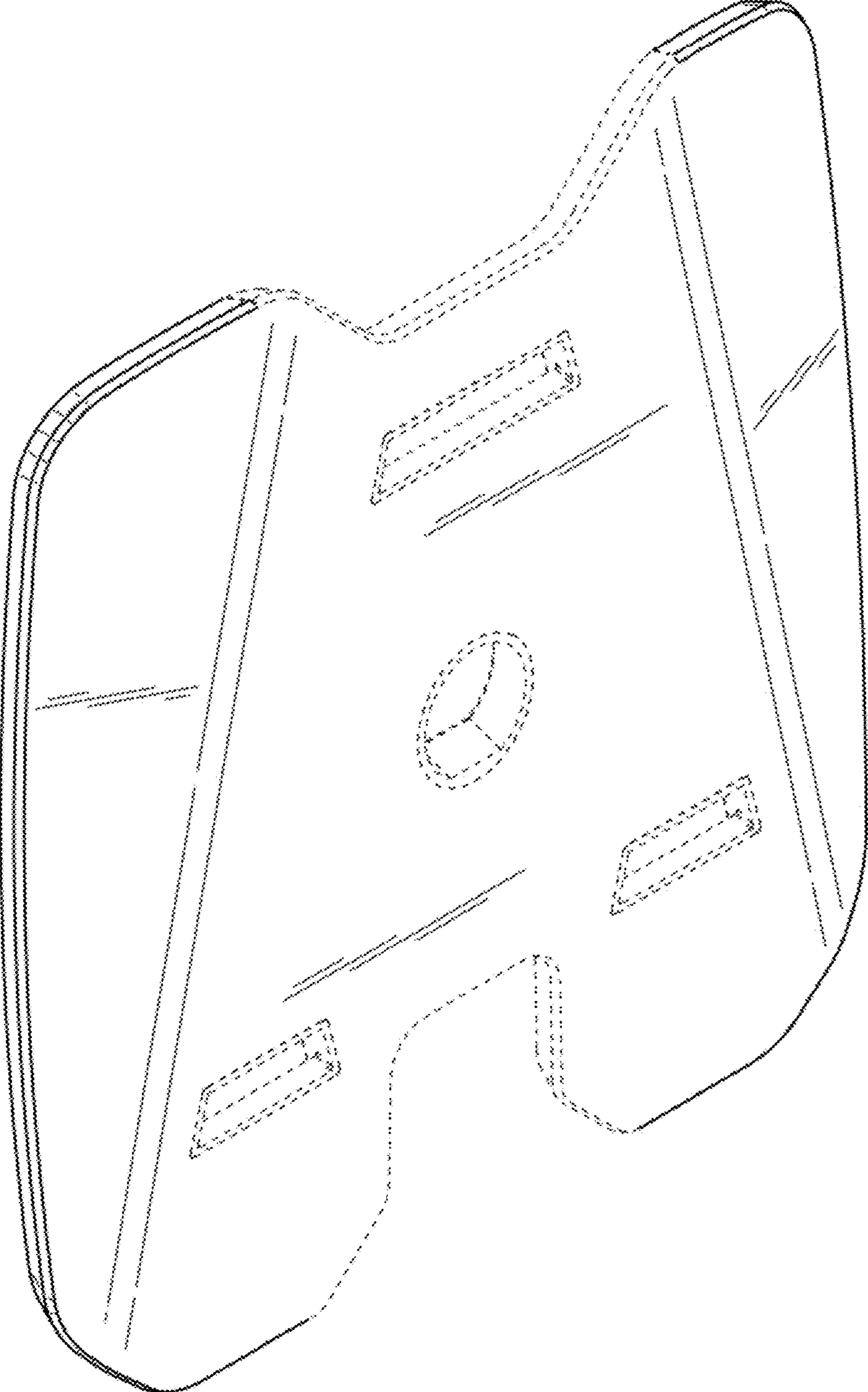

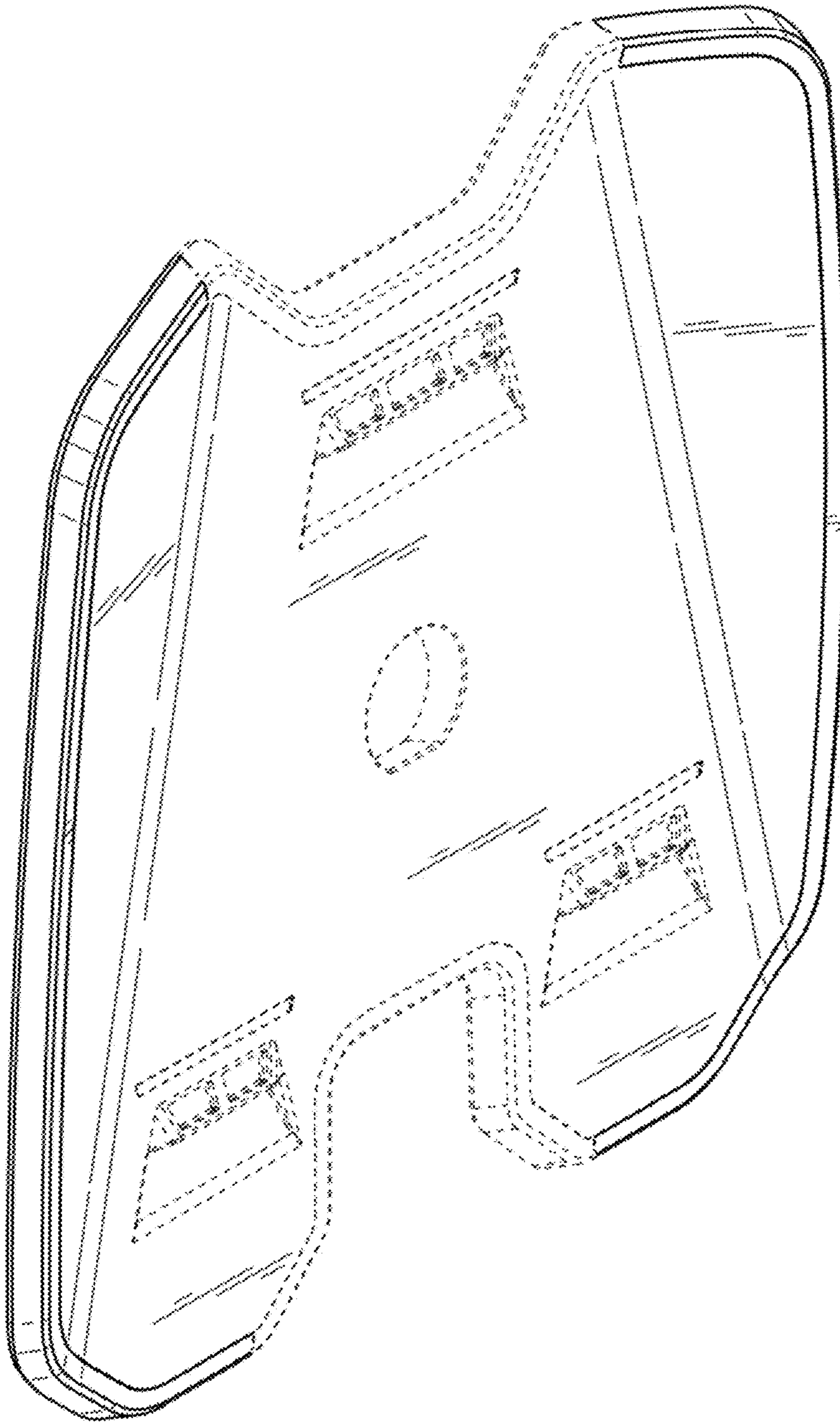

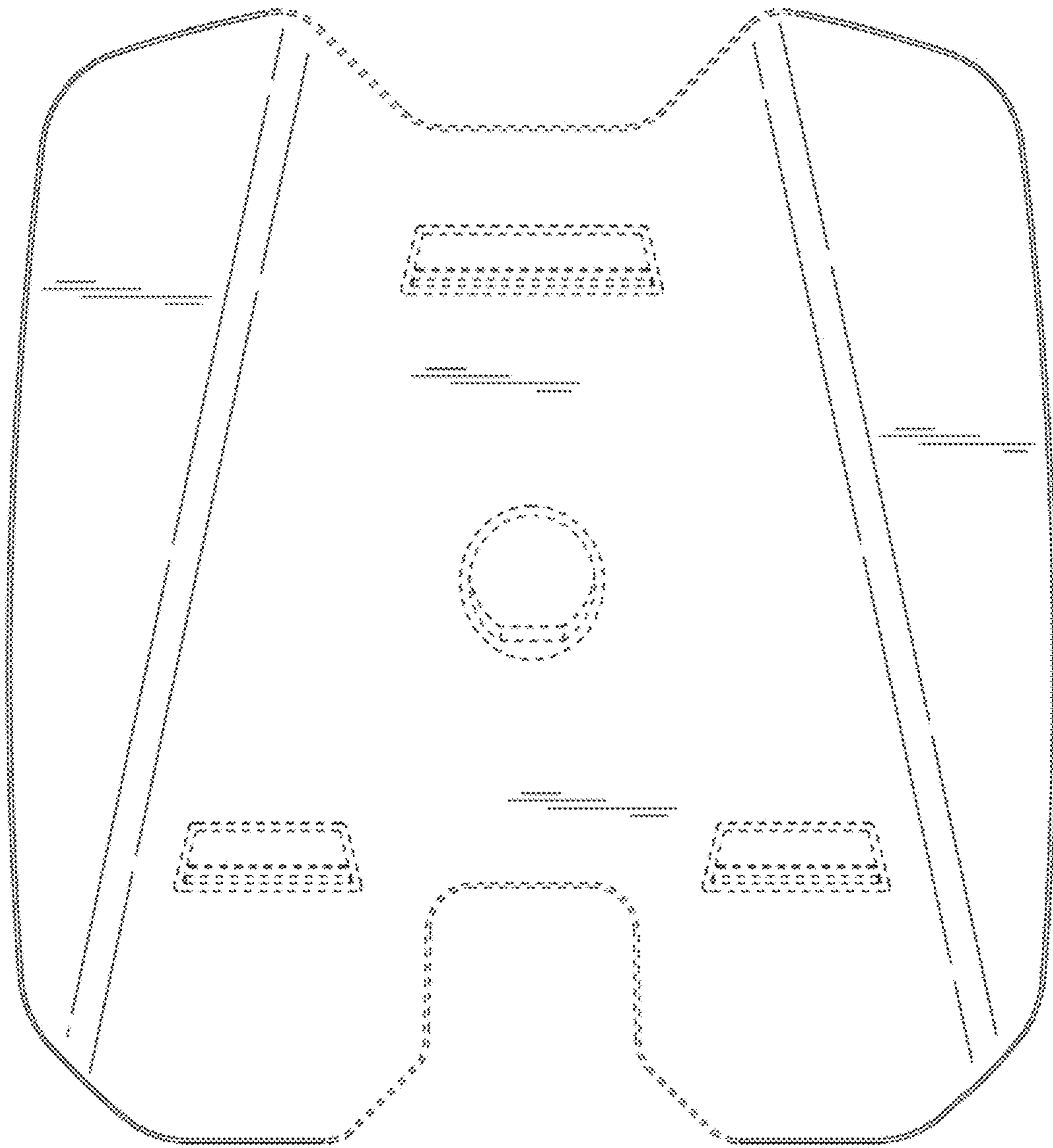

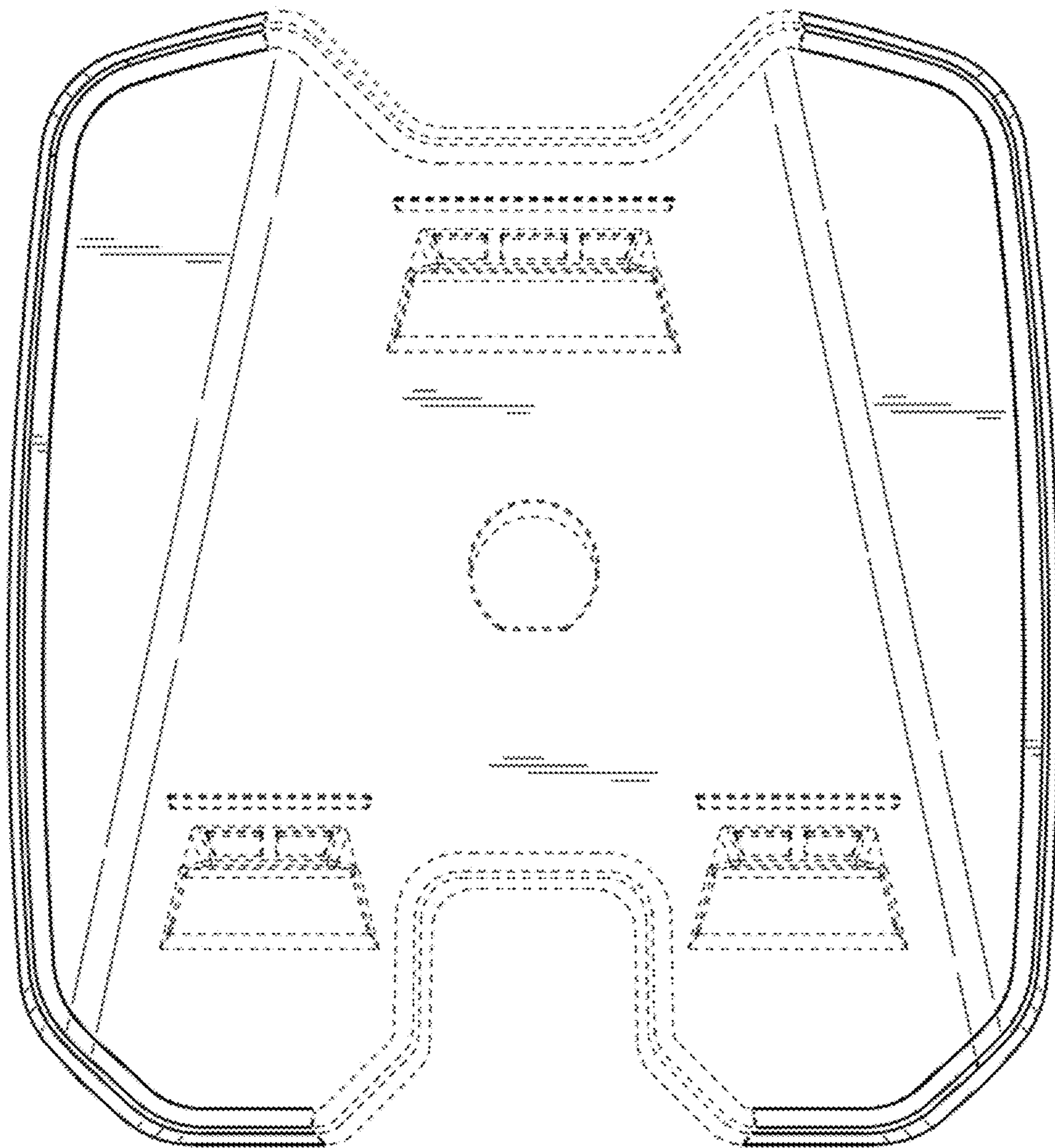

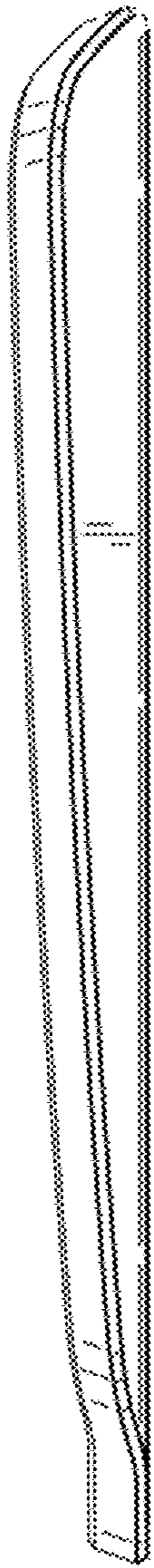

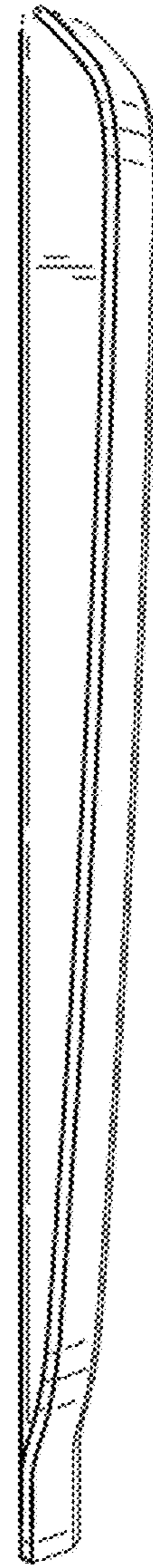

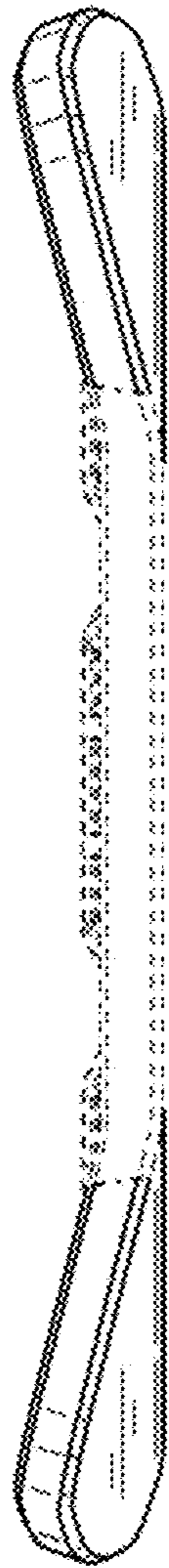

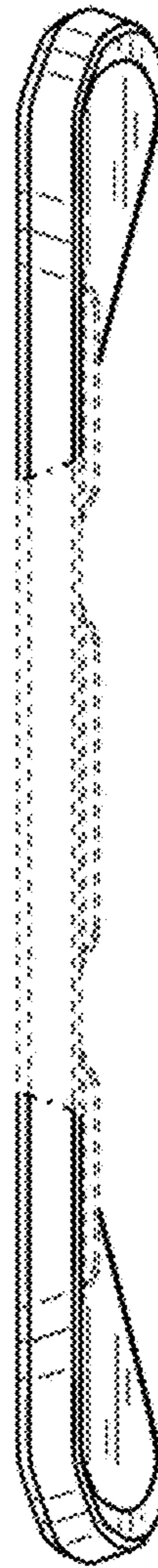
