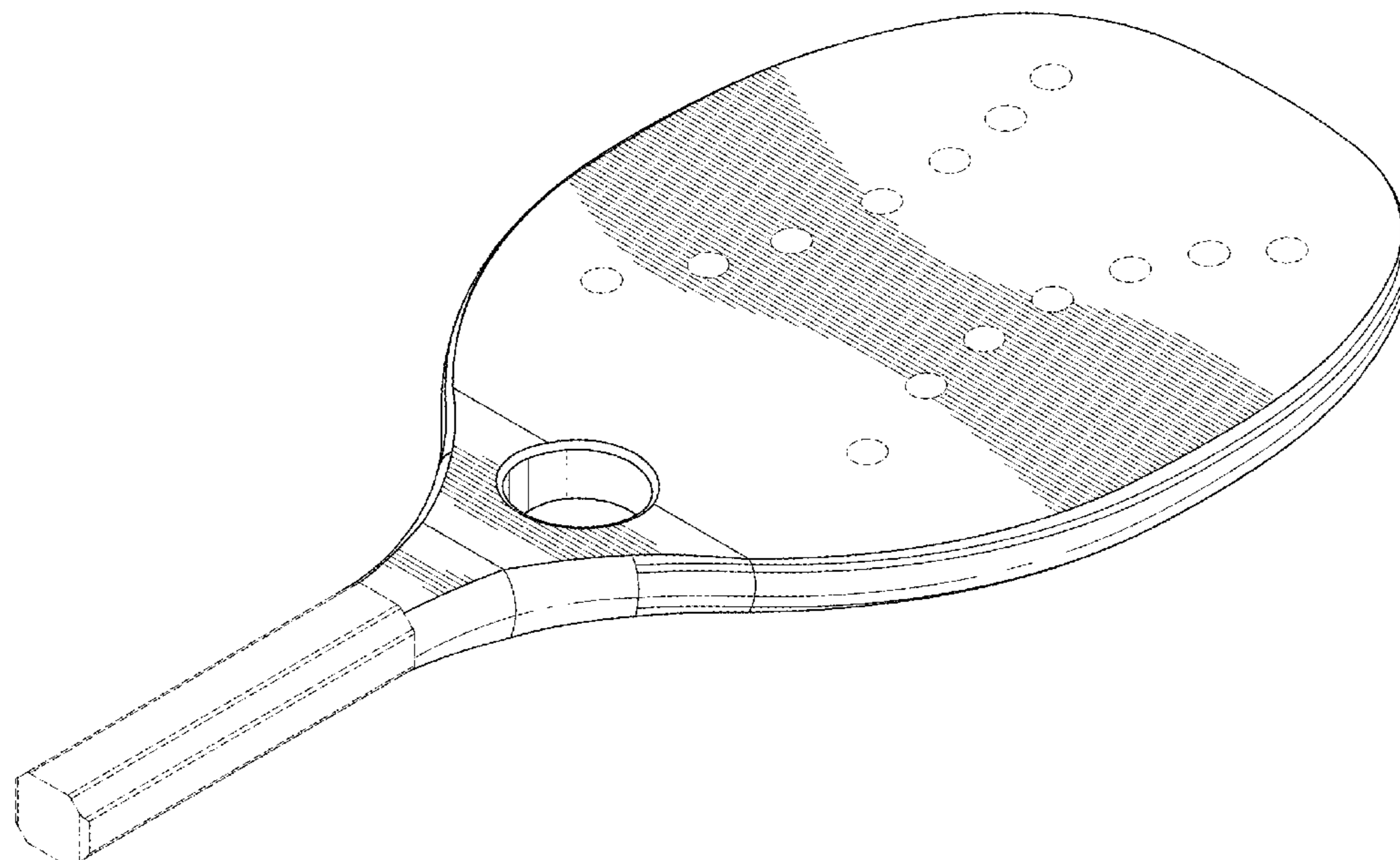
(57) **CLAIM**

The ornamental design for a beach tennis paddle with circular neck hole, as shown and described.

DESCRIPTION

FIG. 1 is an elevated, perspective view of a paddle showing top view of my new design;

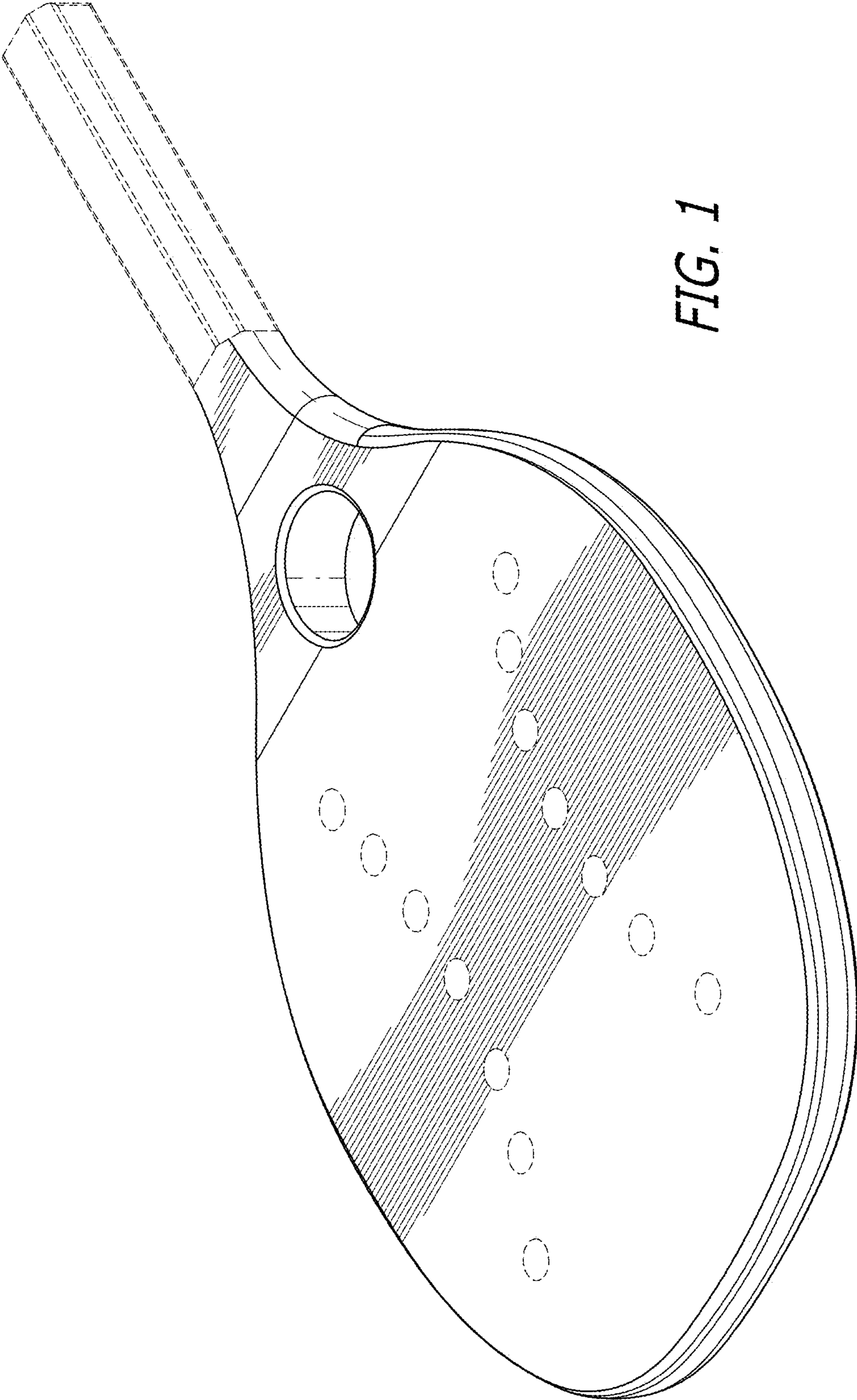

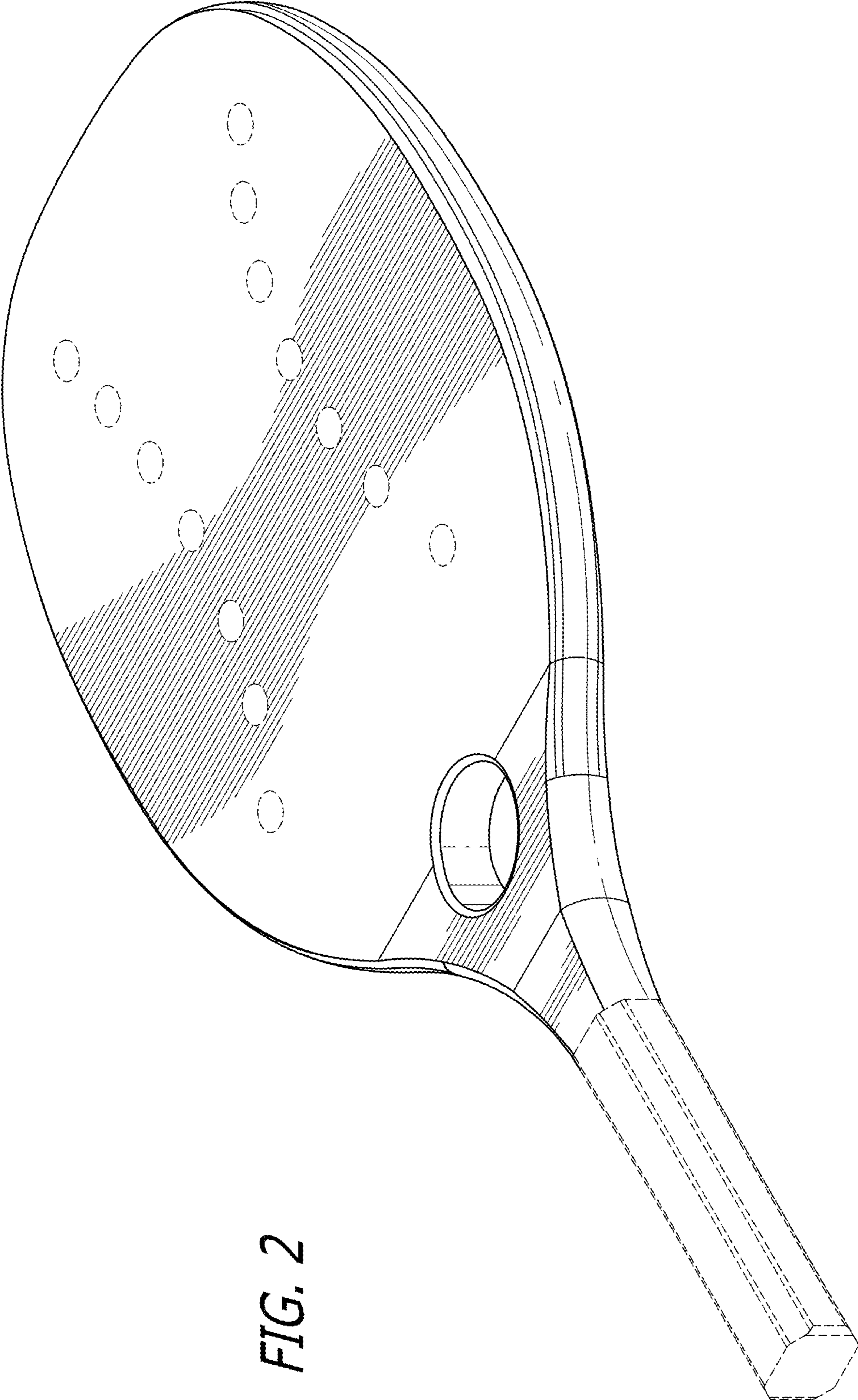

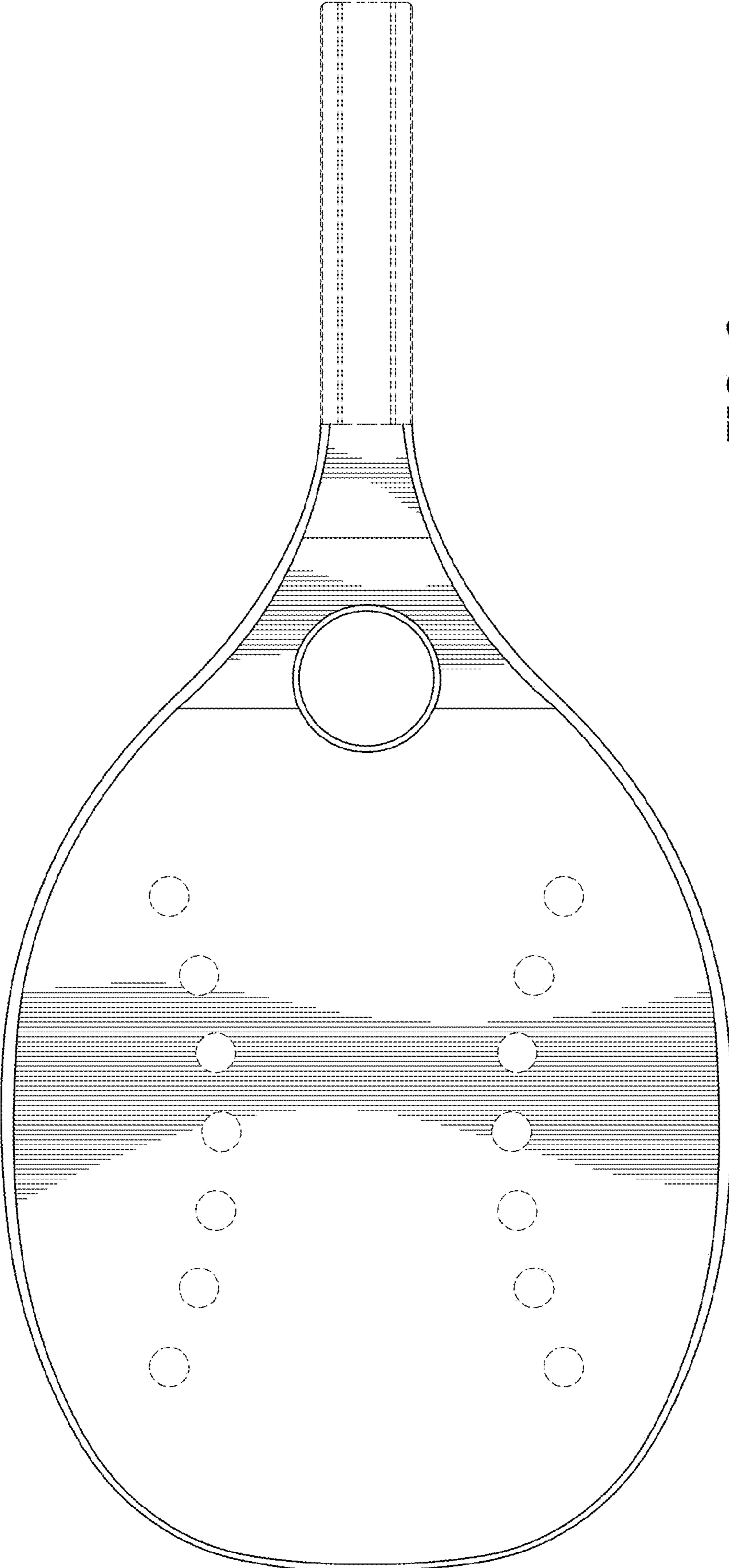

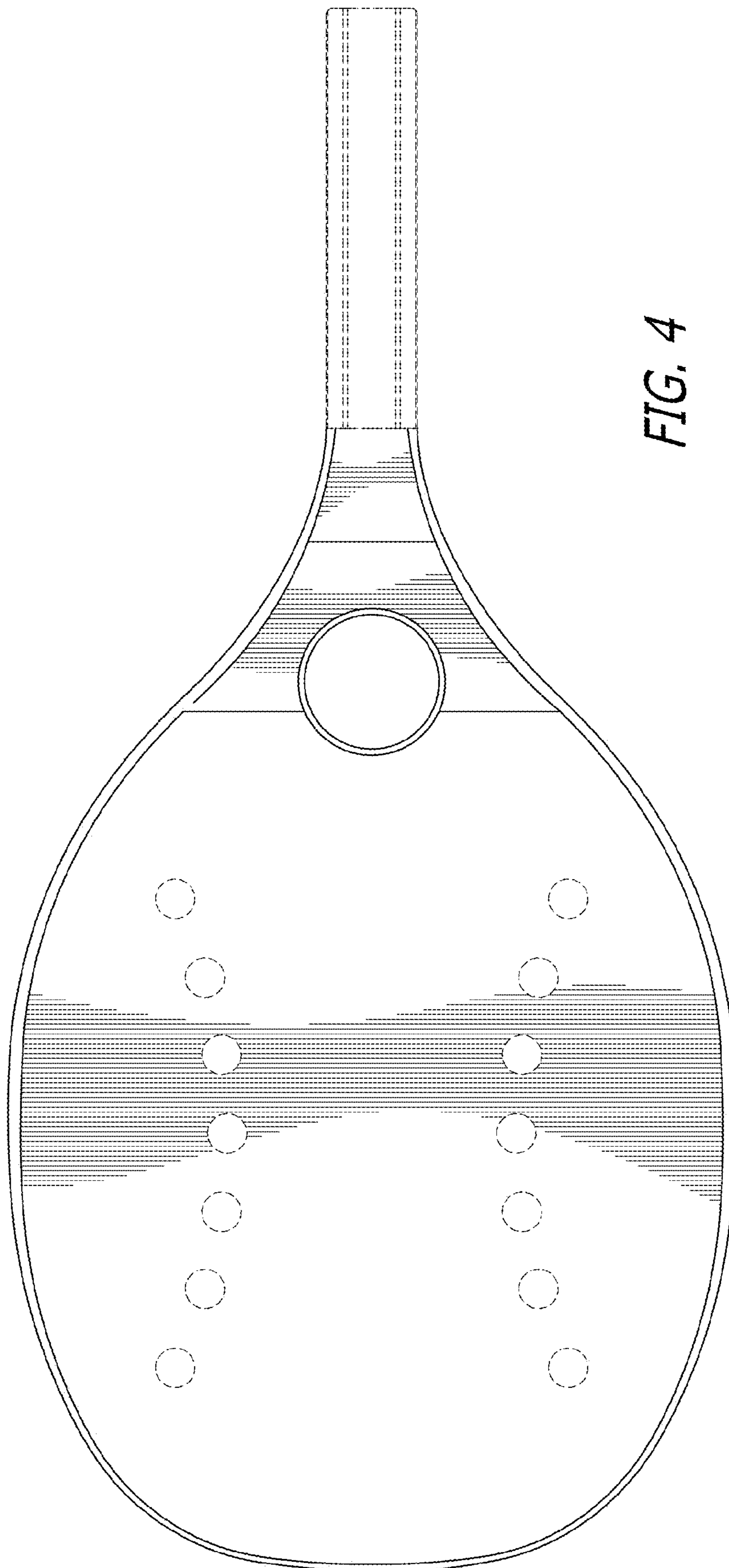

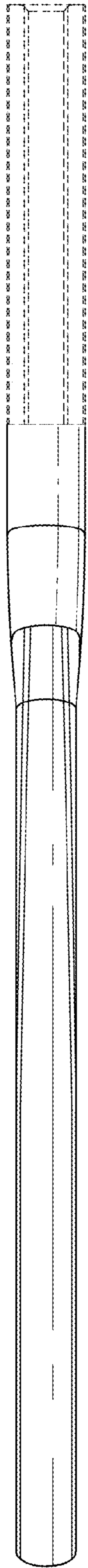

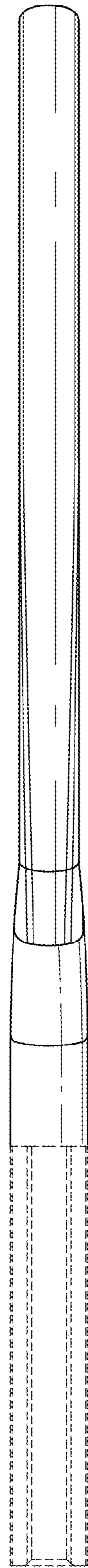

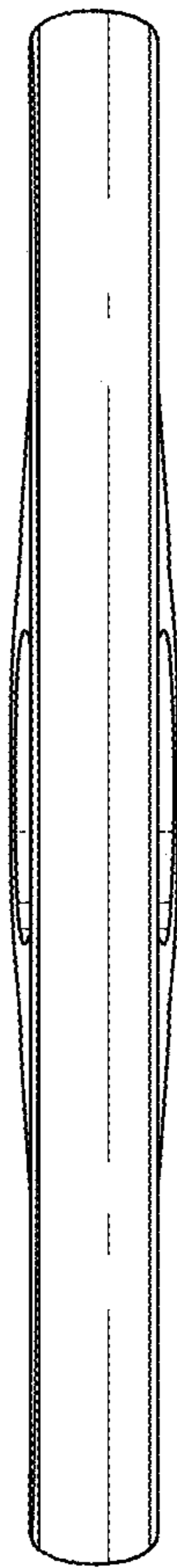
