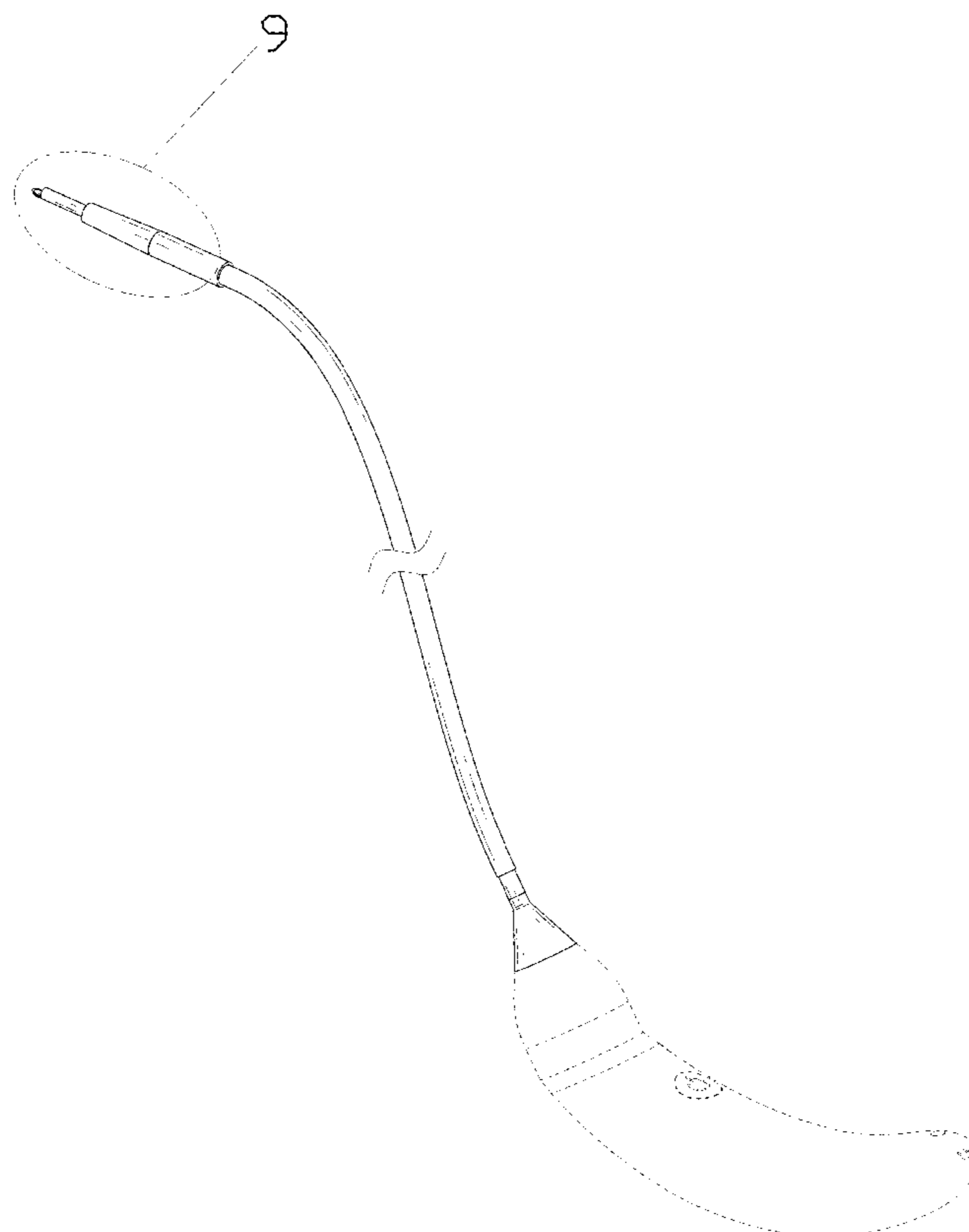
(57) **CLAIM**

The ornamental design for an ear cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an ear cleaner showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is an enlarged view of portion 9 shown in FIG. 1; and,
FIG. 10 is an enlarged view of portion 10 shown in FIG. 2.
The ear cleaner is shown with a symbolic break in its length and the appearance of any portion of the ear cleaner between the break lines form no part of the claimed design. The broken lines in the drawings depict portions of the ear cleaner that form no part of the claimed design.

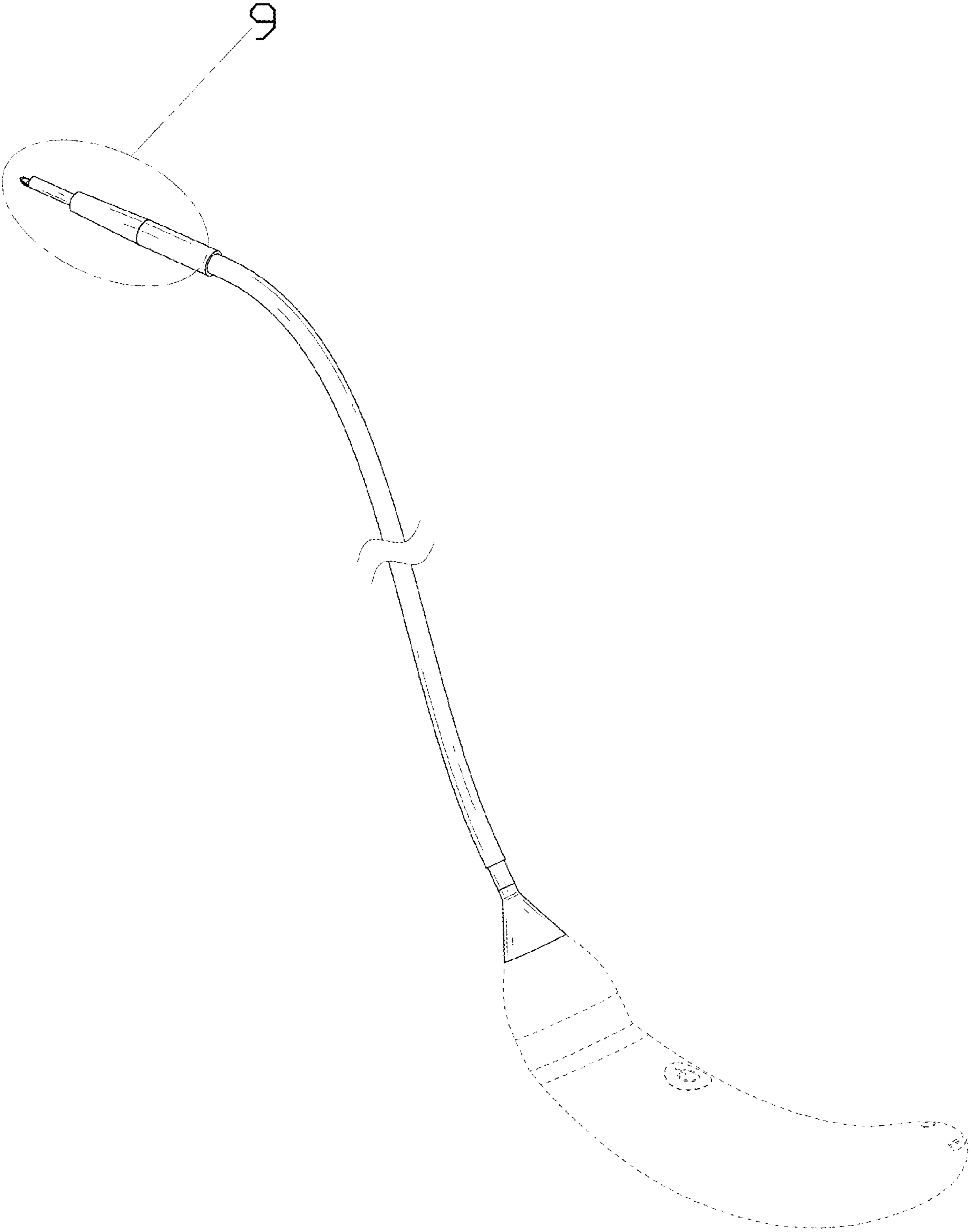

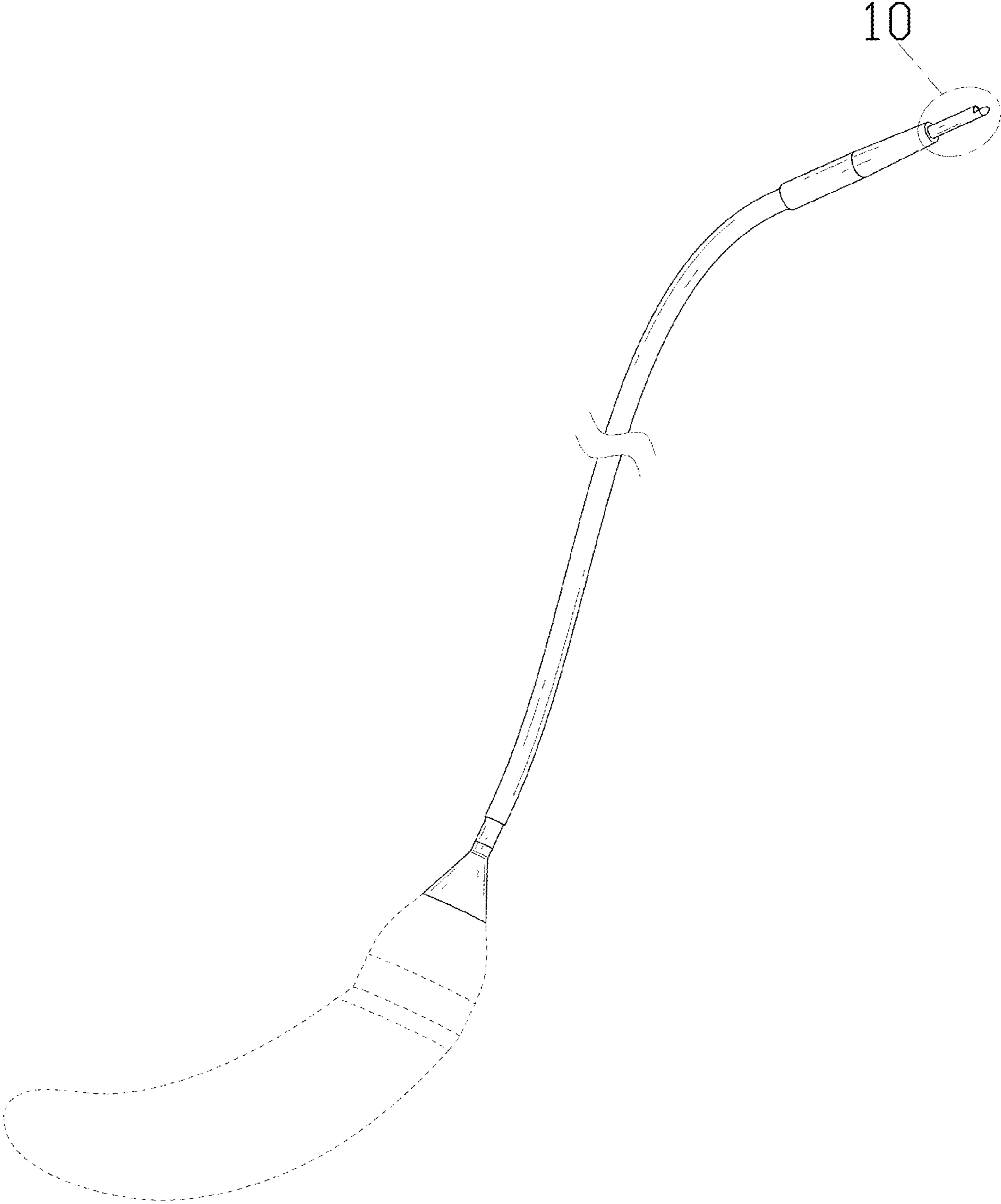

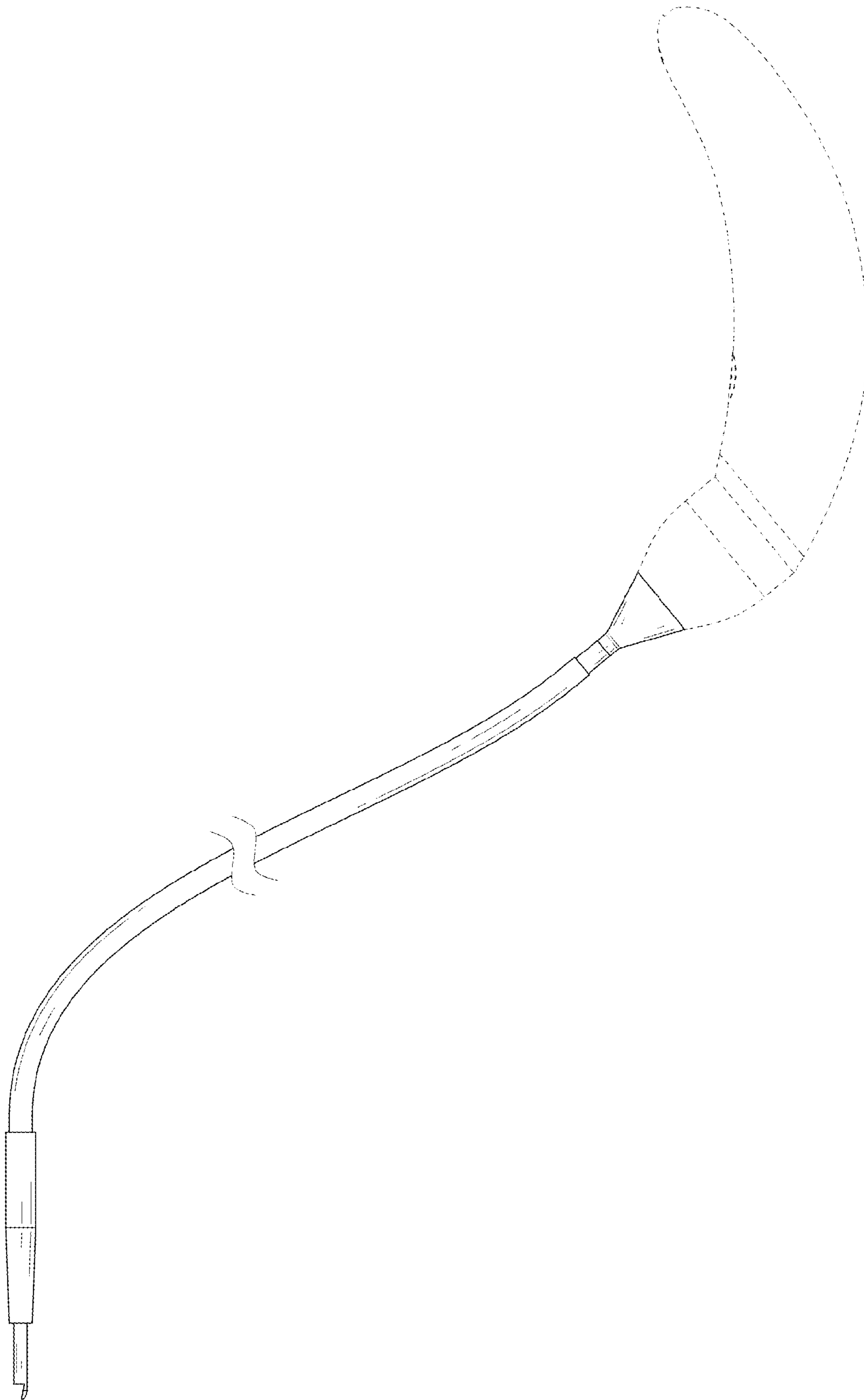

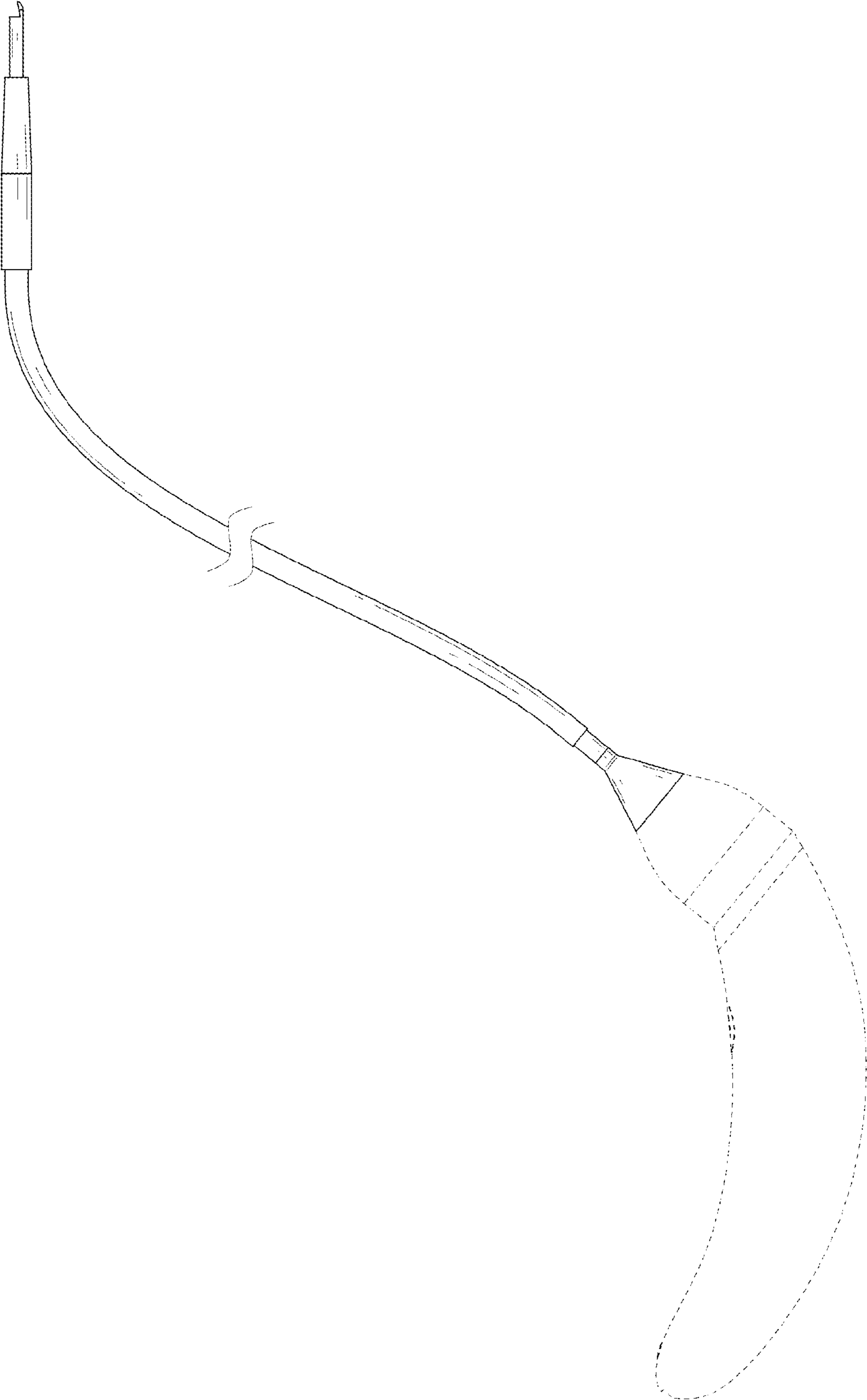

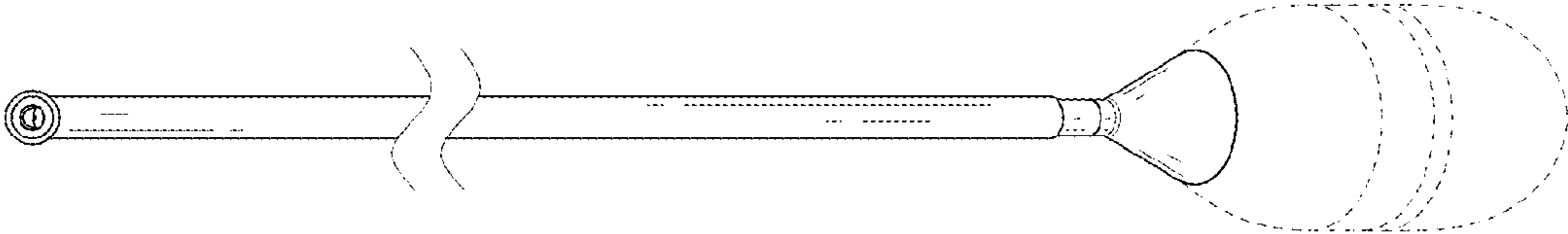

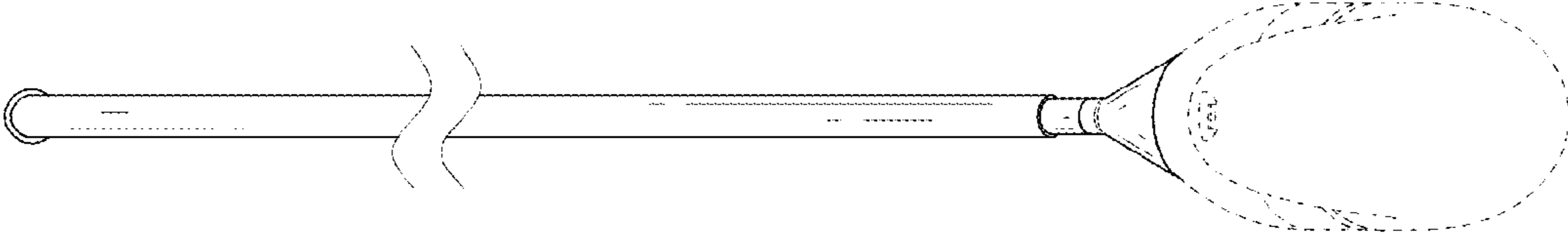

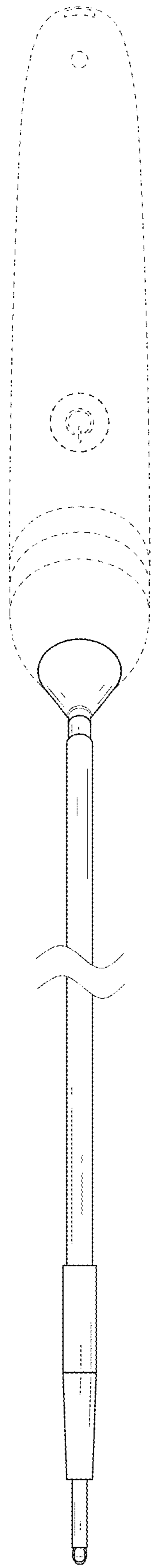

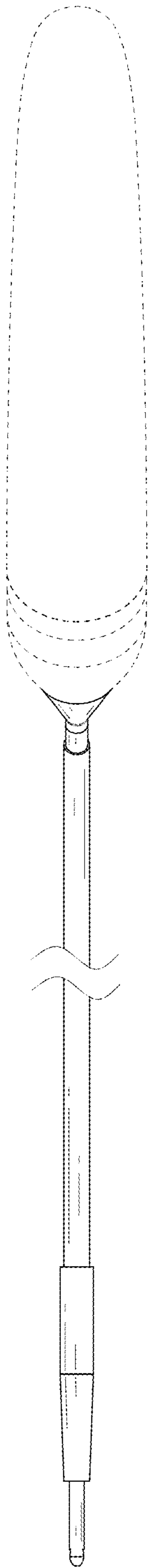

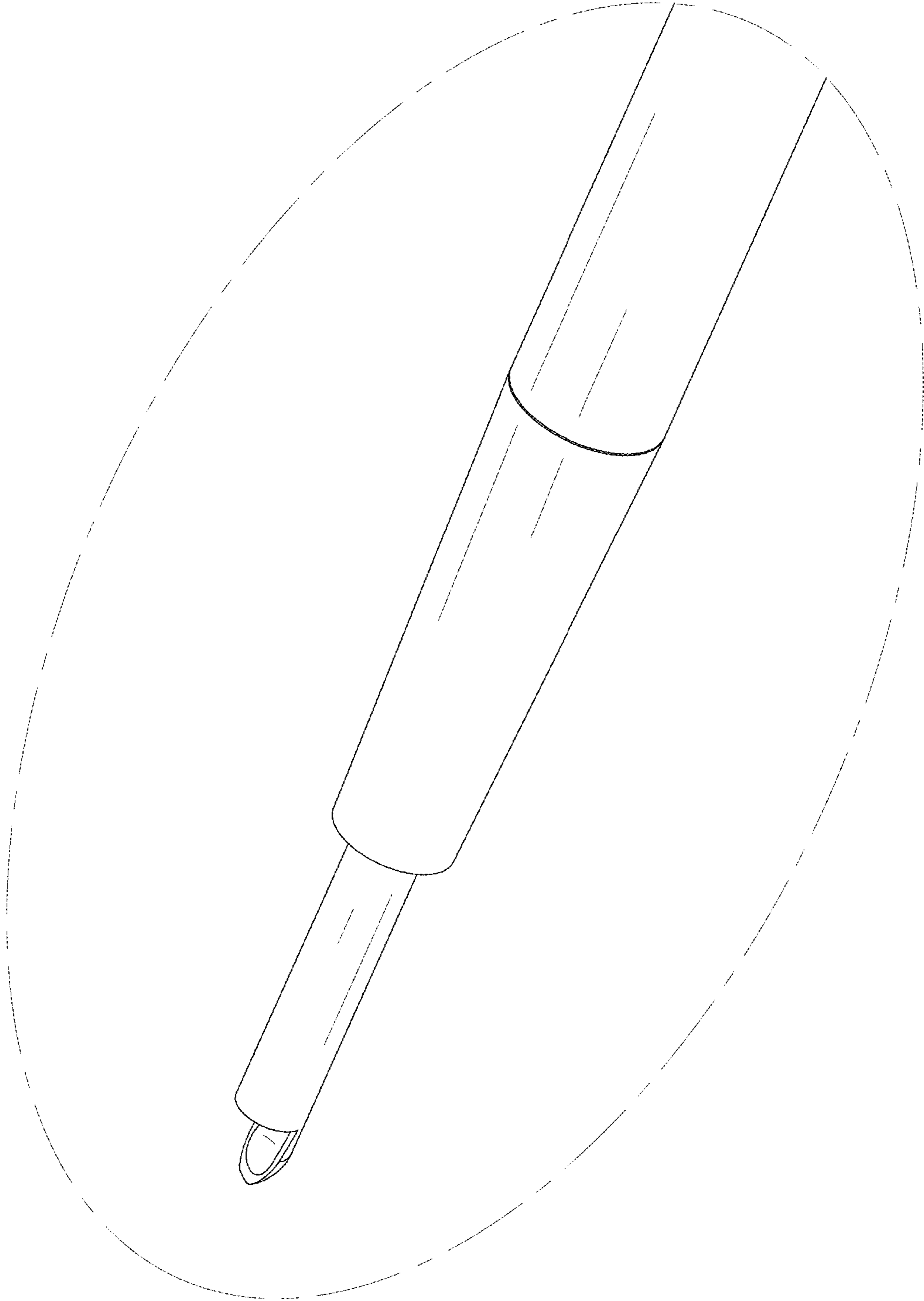

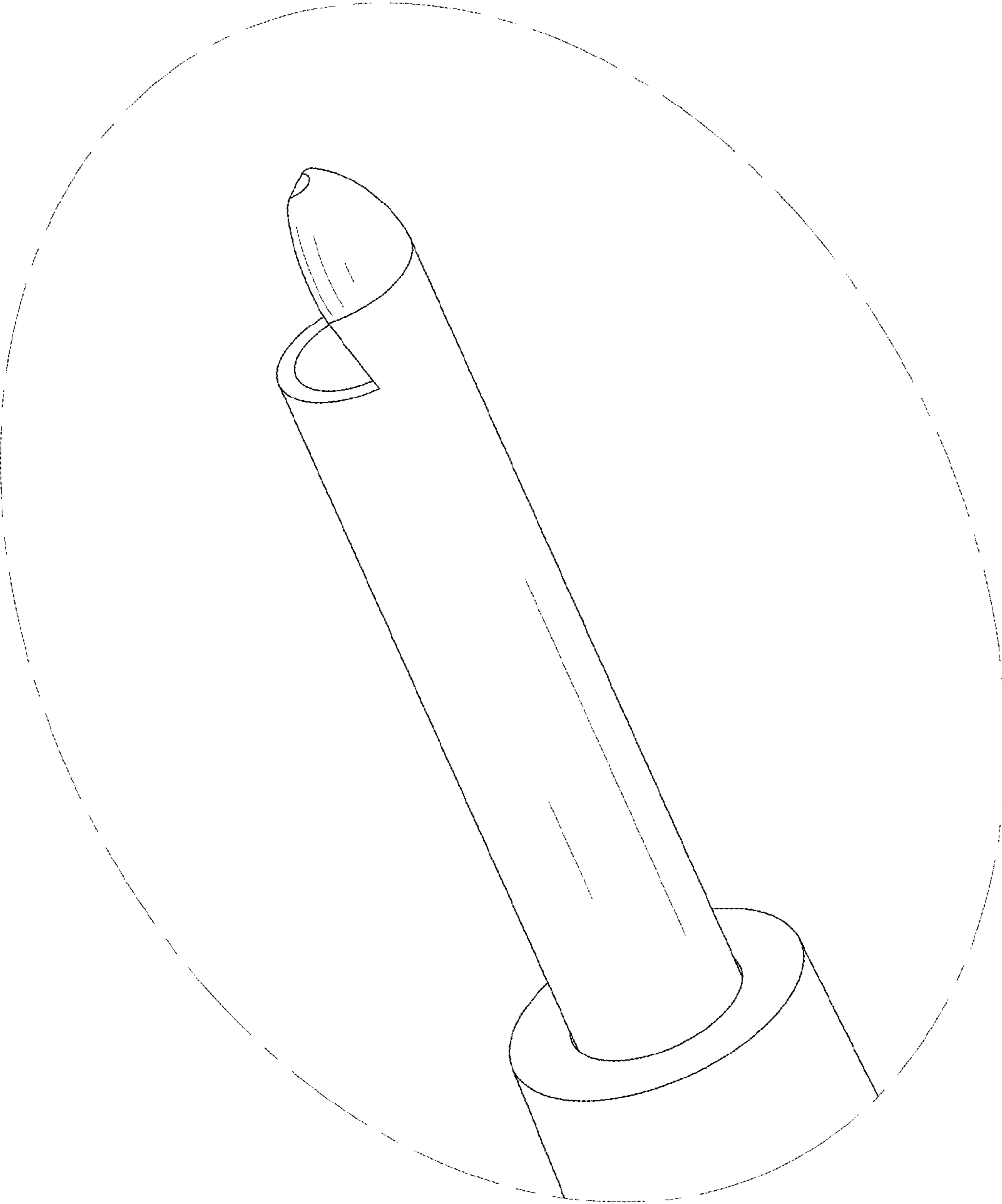
