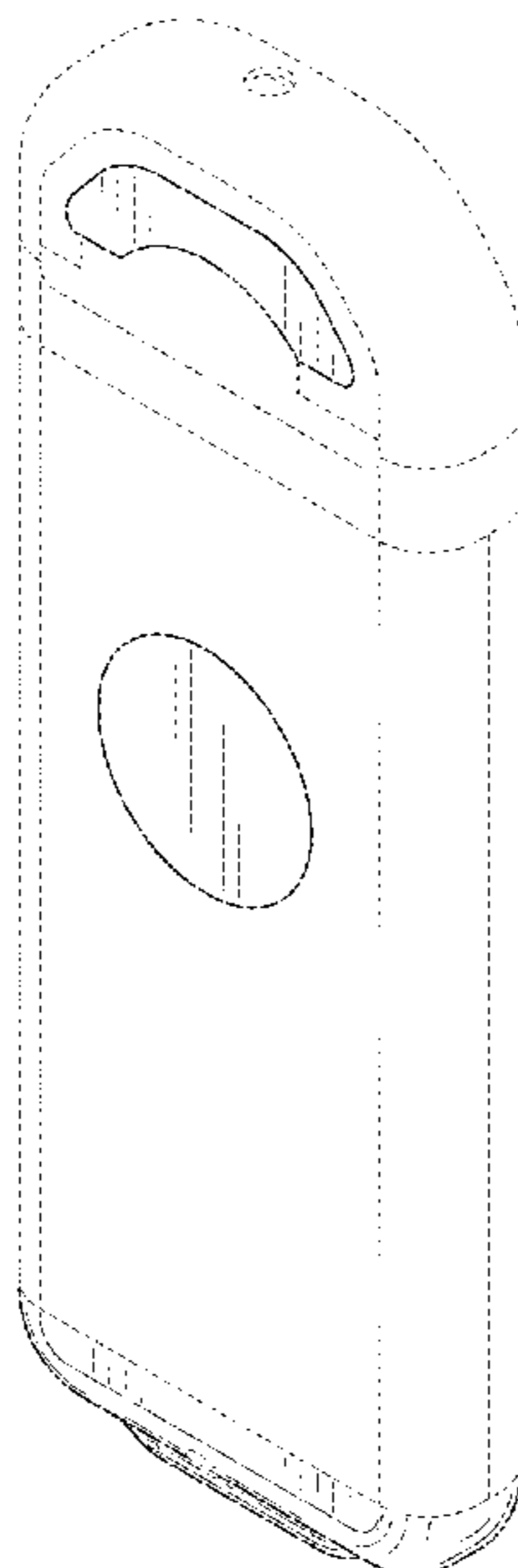
(57) **CLAIM**

We claim the ornamental design for a tibial implantable neurostimulator with suture loop, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tibial implantable neurostimulator with suture loop.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a left side elevation view thereof.
FIG. 5 is a right side elevation view thereof.
FIG. 6 is a top plan view thereof.
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a rear perspective view thereof.
Items shown in broken lines depict environment and portions of the tibial implantable neurostimulator with suture loop that form no part of the claimed invention.

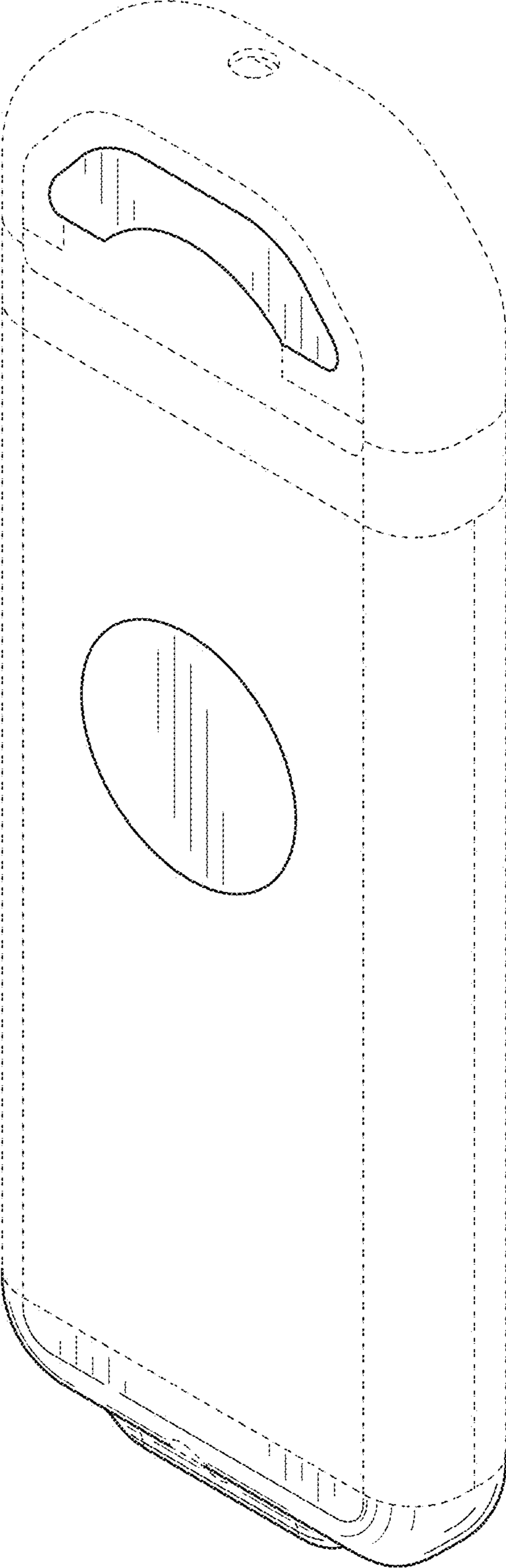

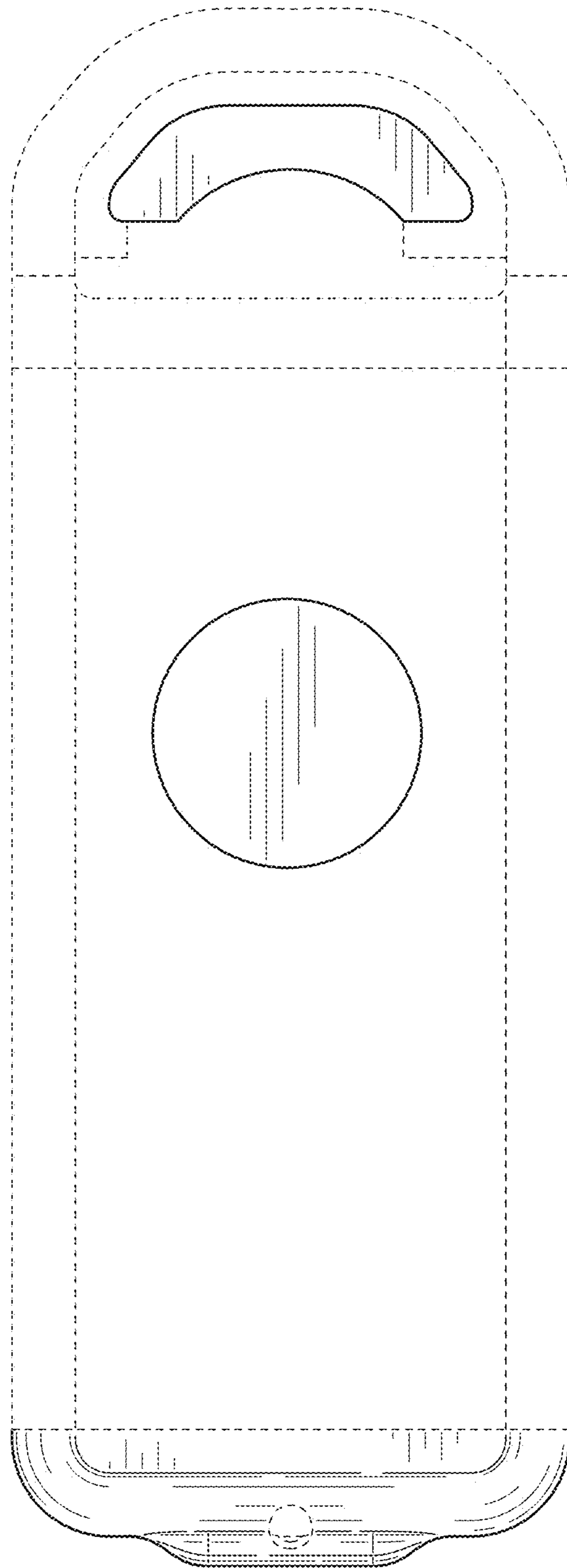

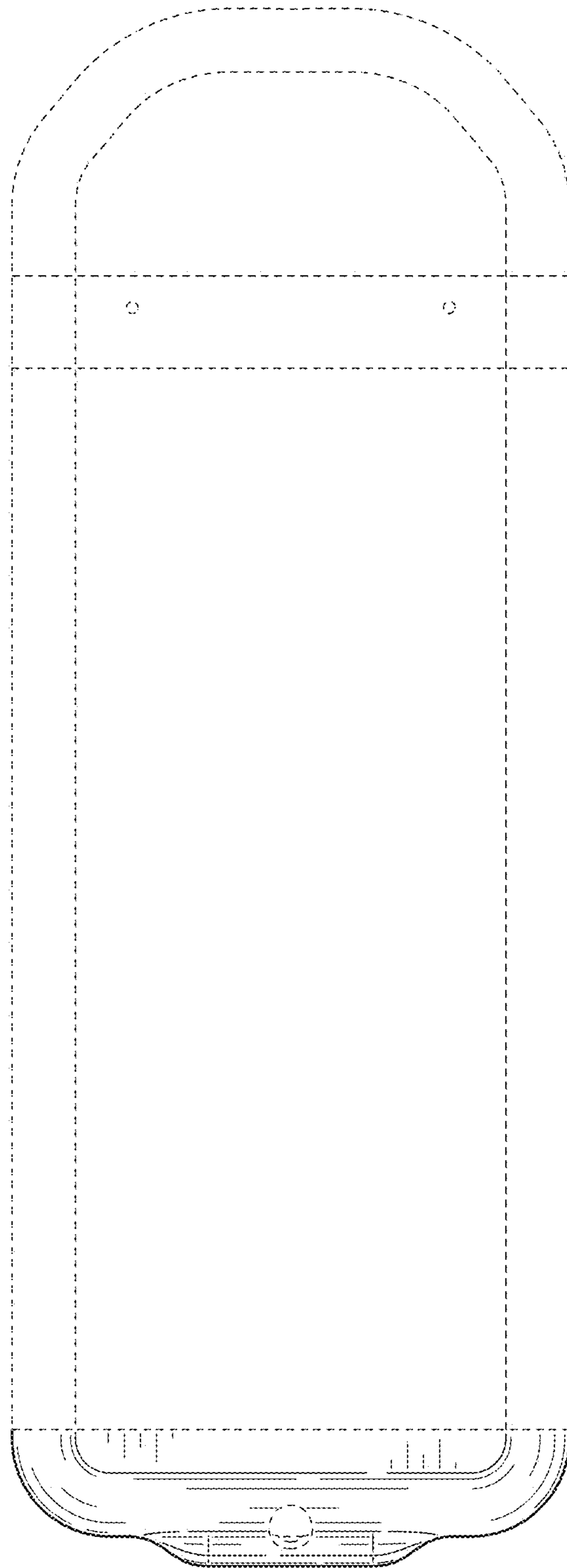

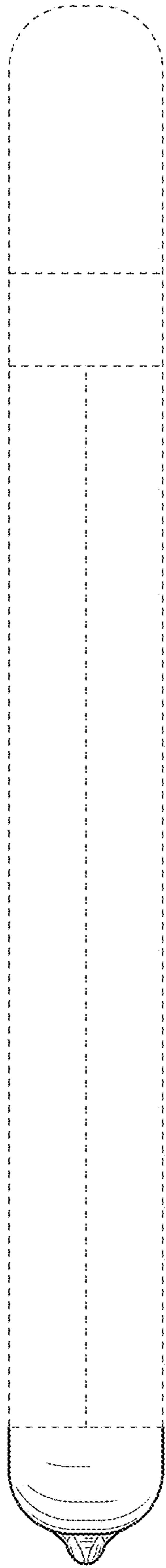

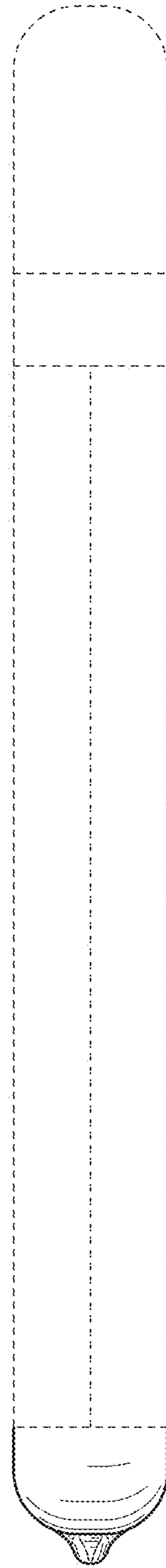

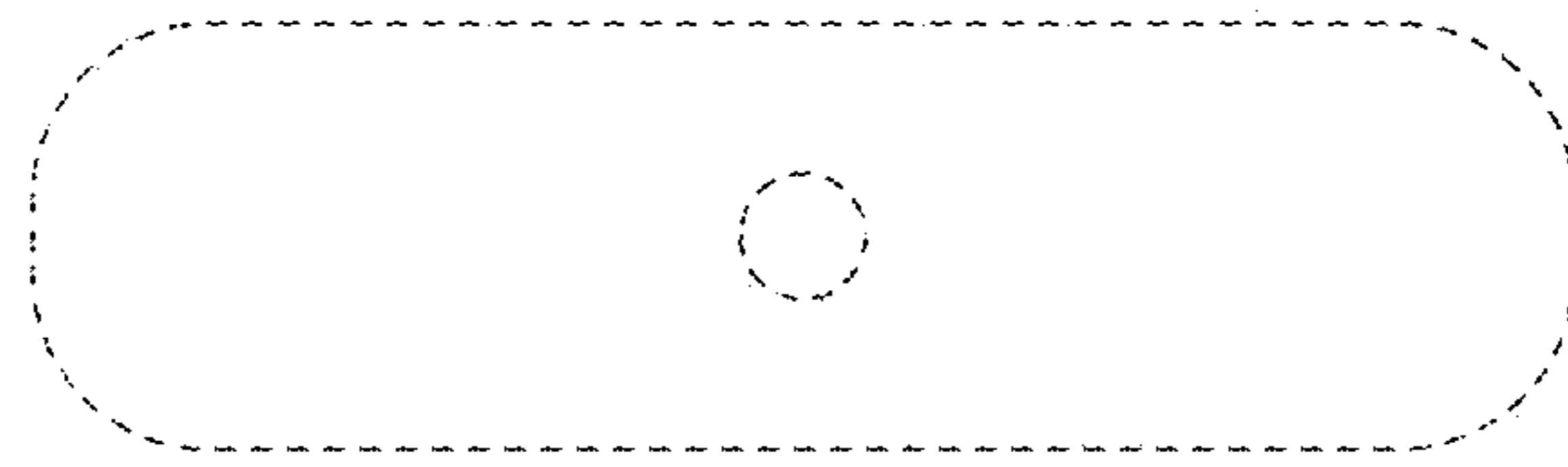

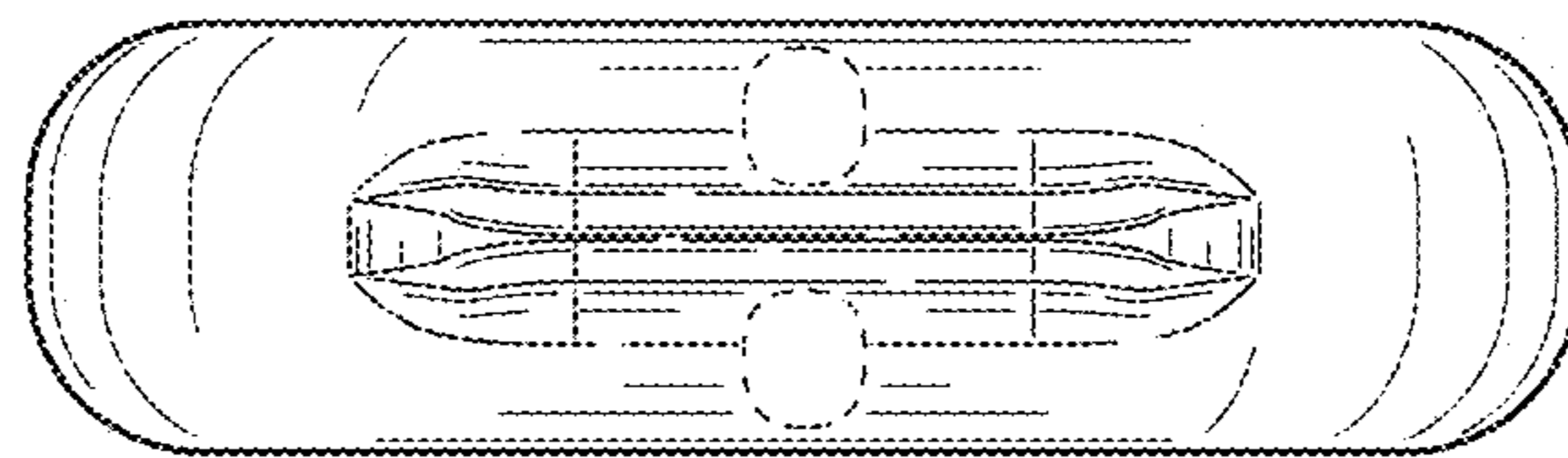

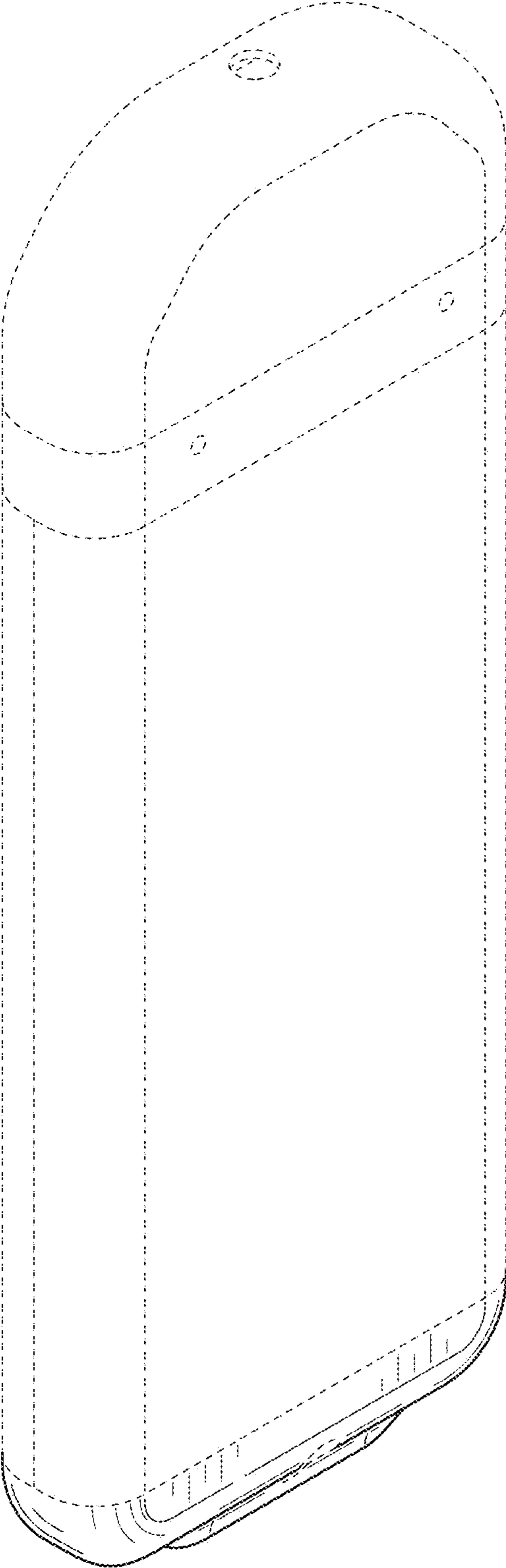
