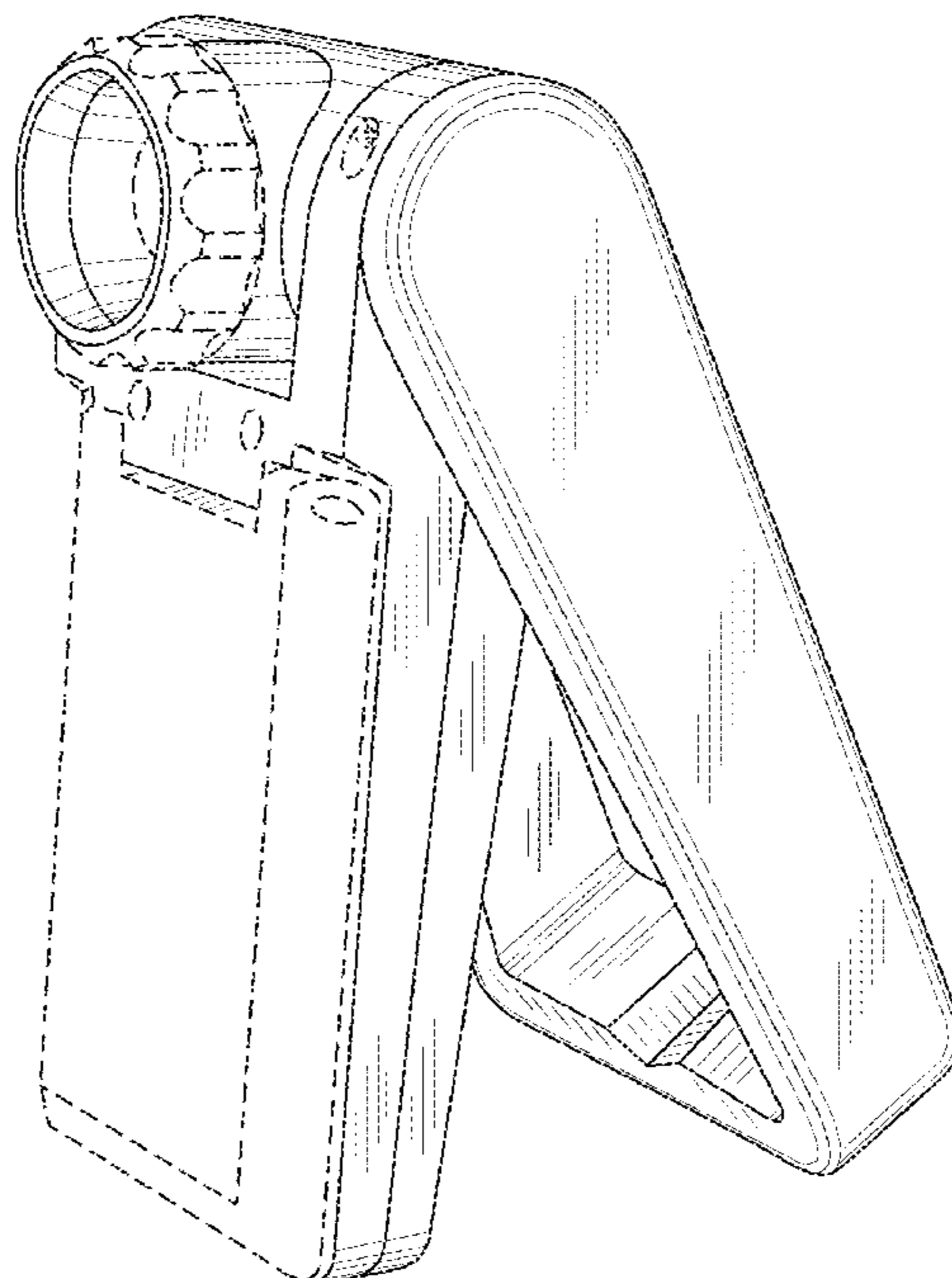
(57) **CLAIM**

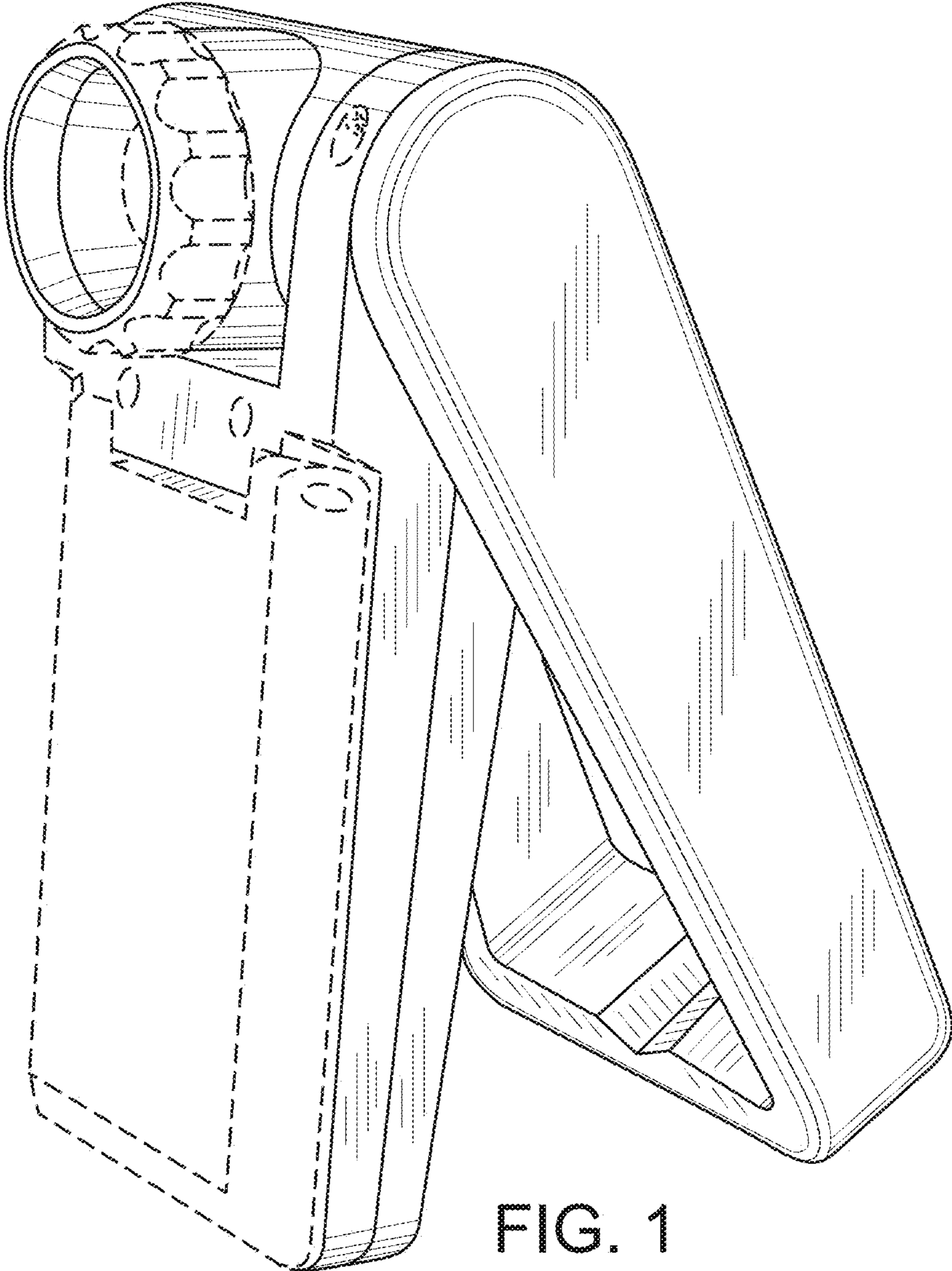
We claim the ornamental design for a flip light, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the light in an opened position;
FIG. 2 is a rear perspective view of FIG. 1, again in an opened position;
FIG. 3 is a front perspective view of FIG. 1 in a closed position;
FIG. 4 is a rear elevation view of FIG. 1 in a closed position;
FIG. 5 is a side elevation view of FIG. 1 in a closed position, taken from the right side;
FIG. 6 is a side elevation view of FIG. 1 in a closed position, taken from the left side;
FIG. 7 is a top plan view of FIG. 1 in a closed position; and, FIG. 8 is a bottom view of FIG. 1 in a closed position.
The broken lines show portions of the flip light which form no part of the claimed design.

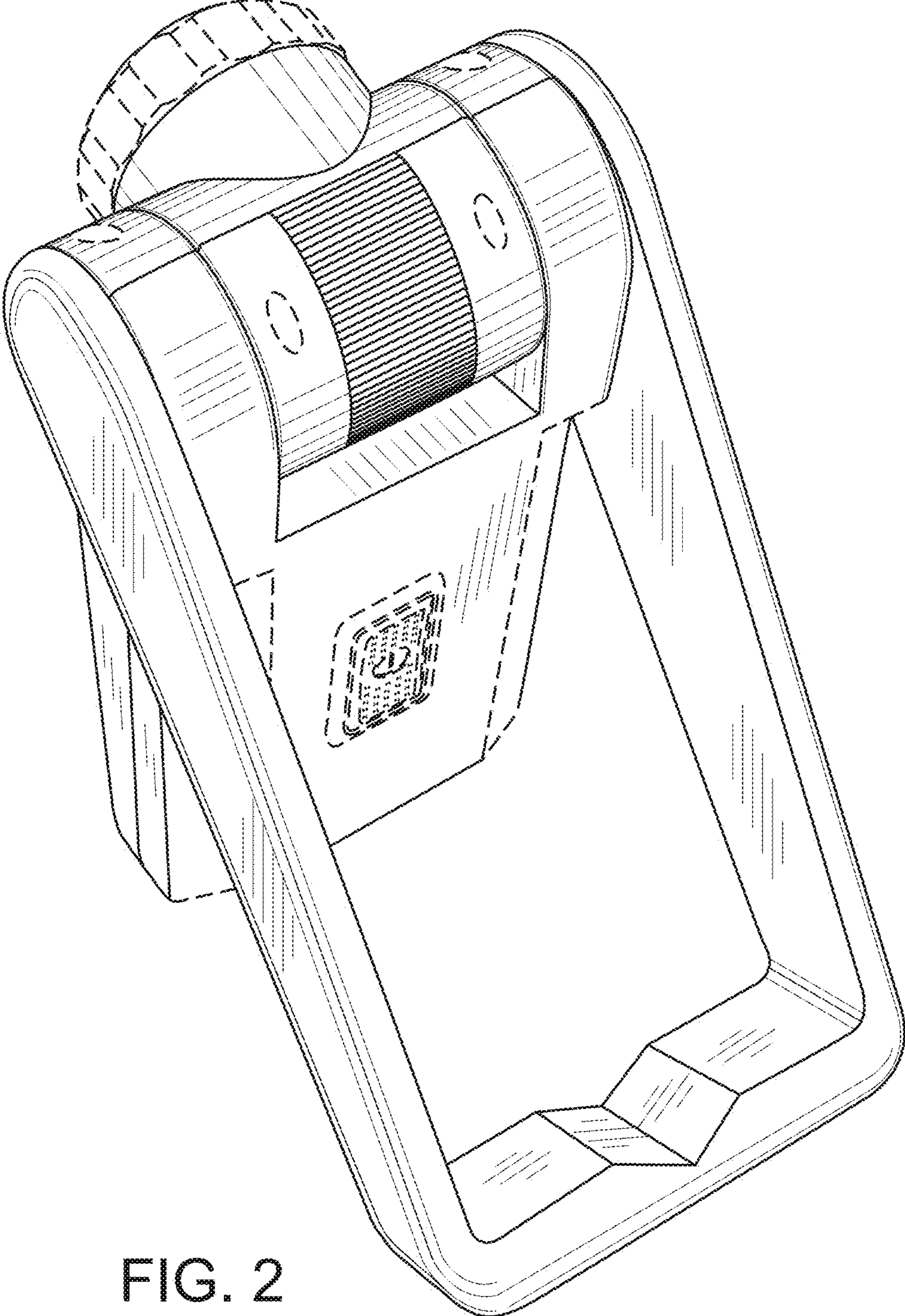

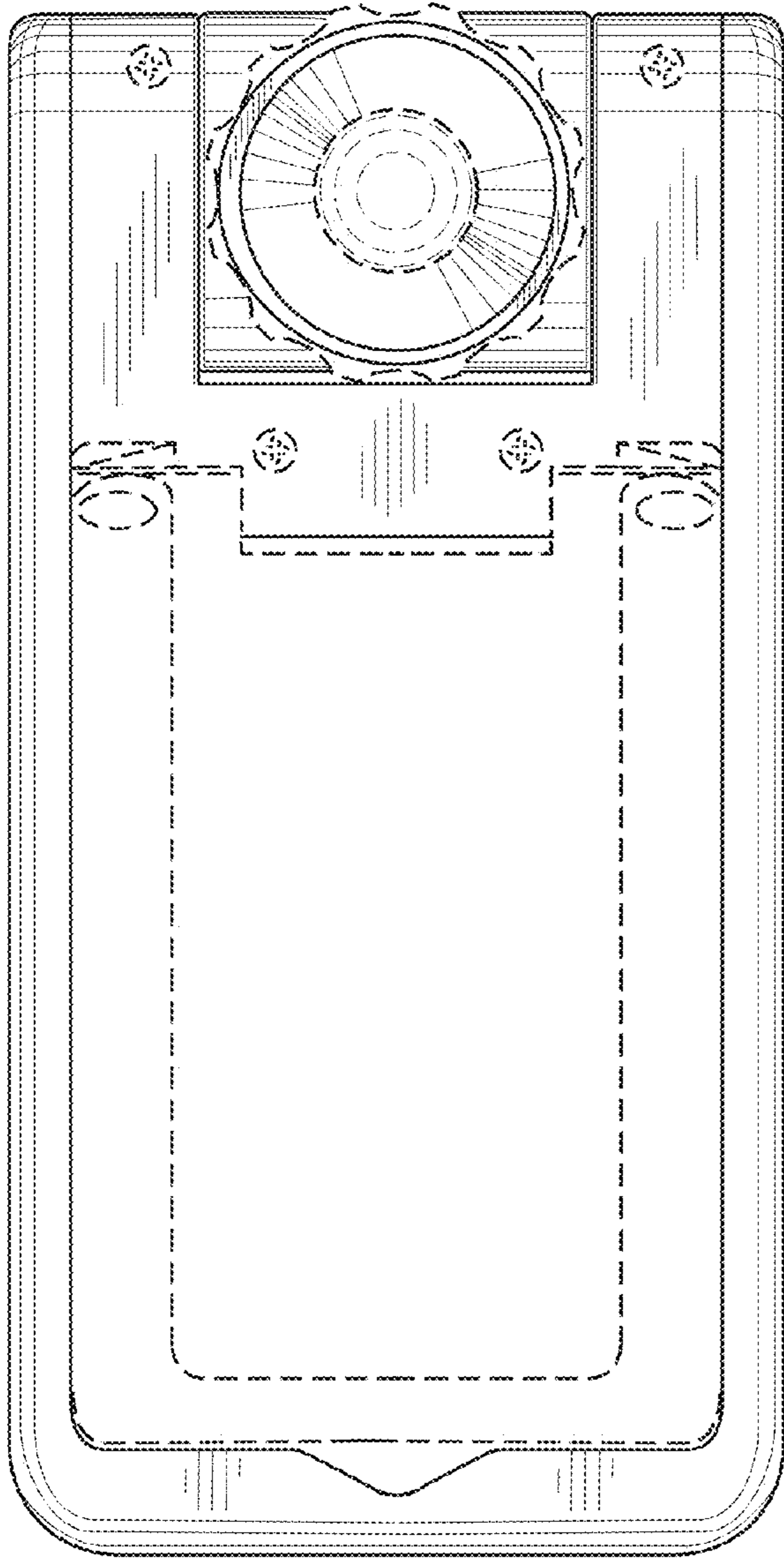

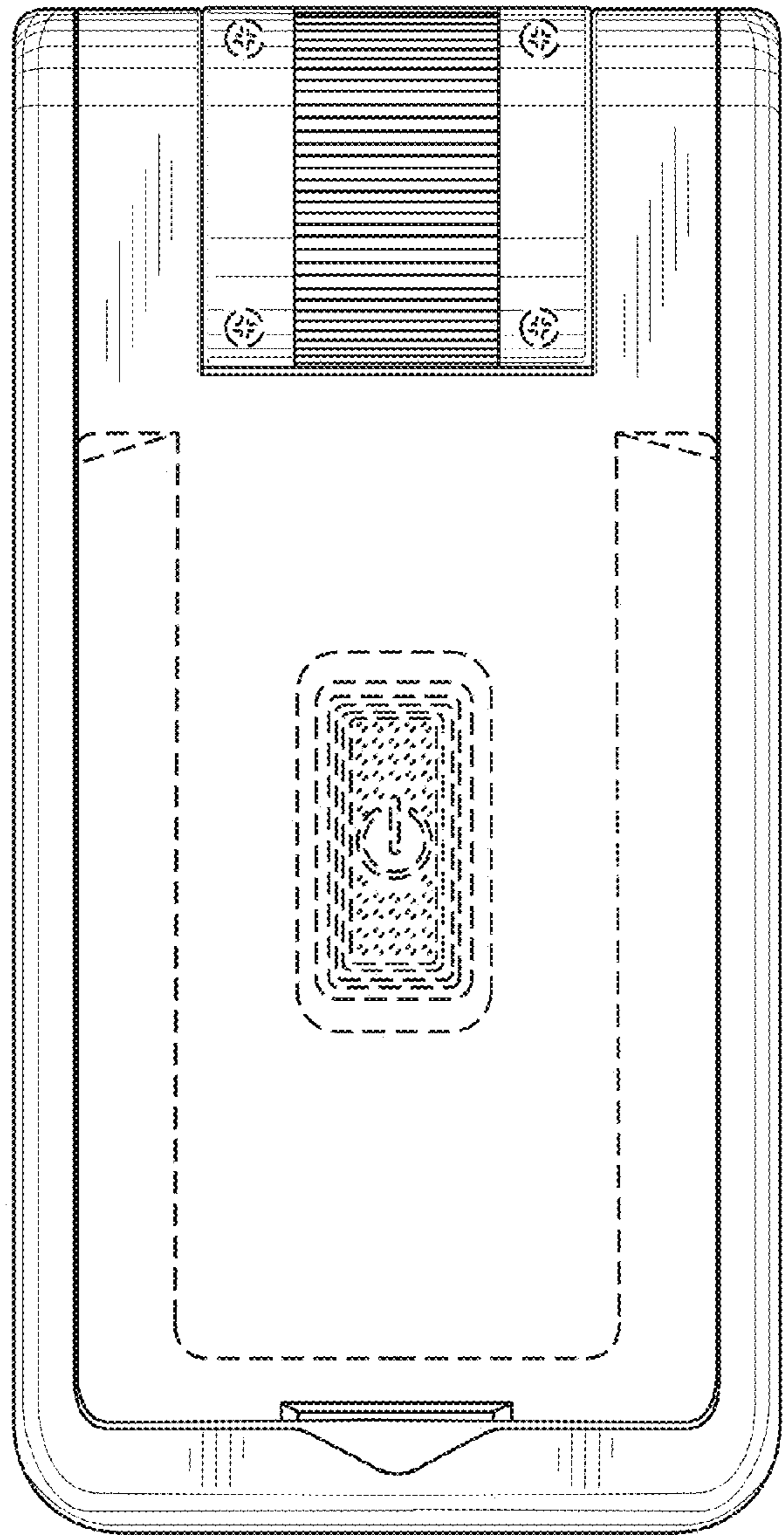

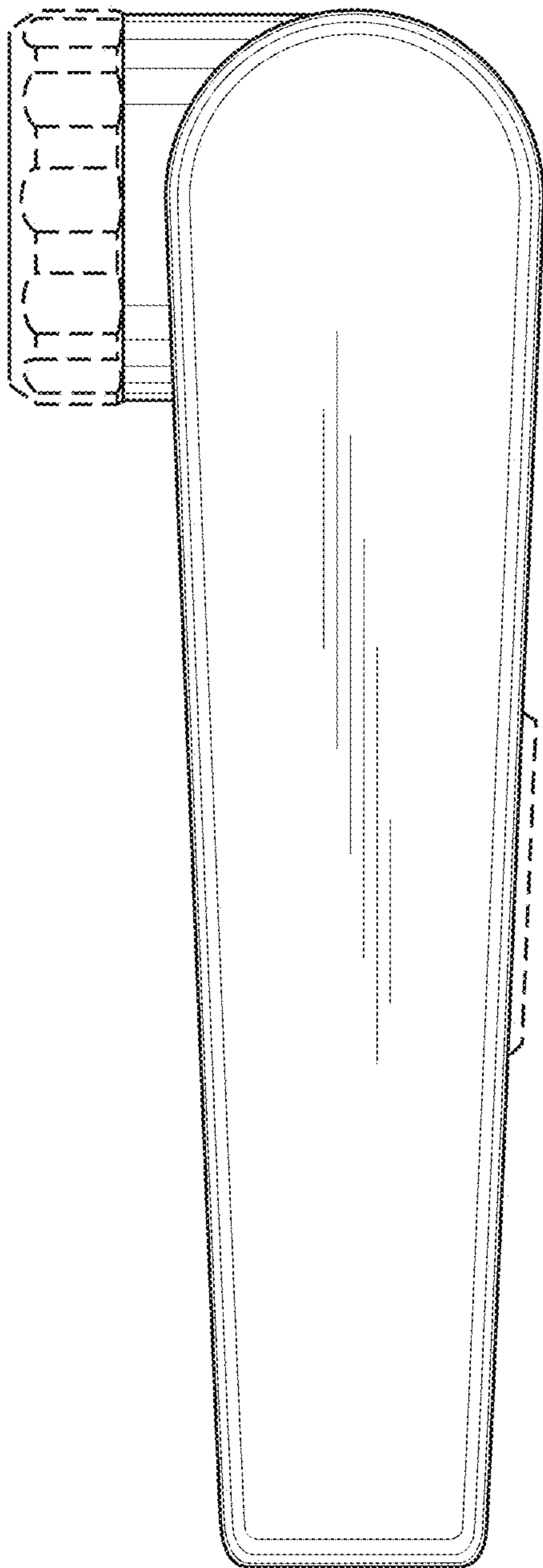

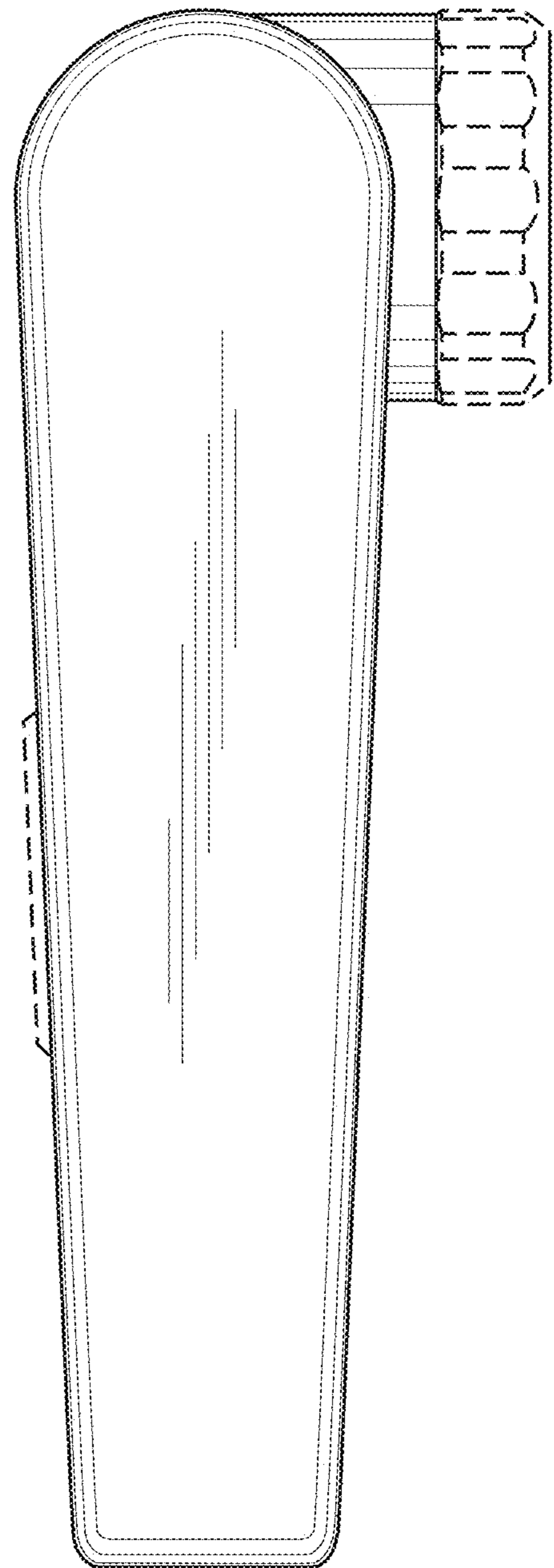

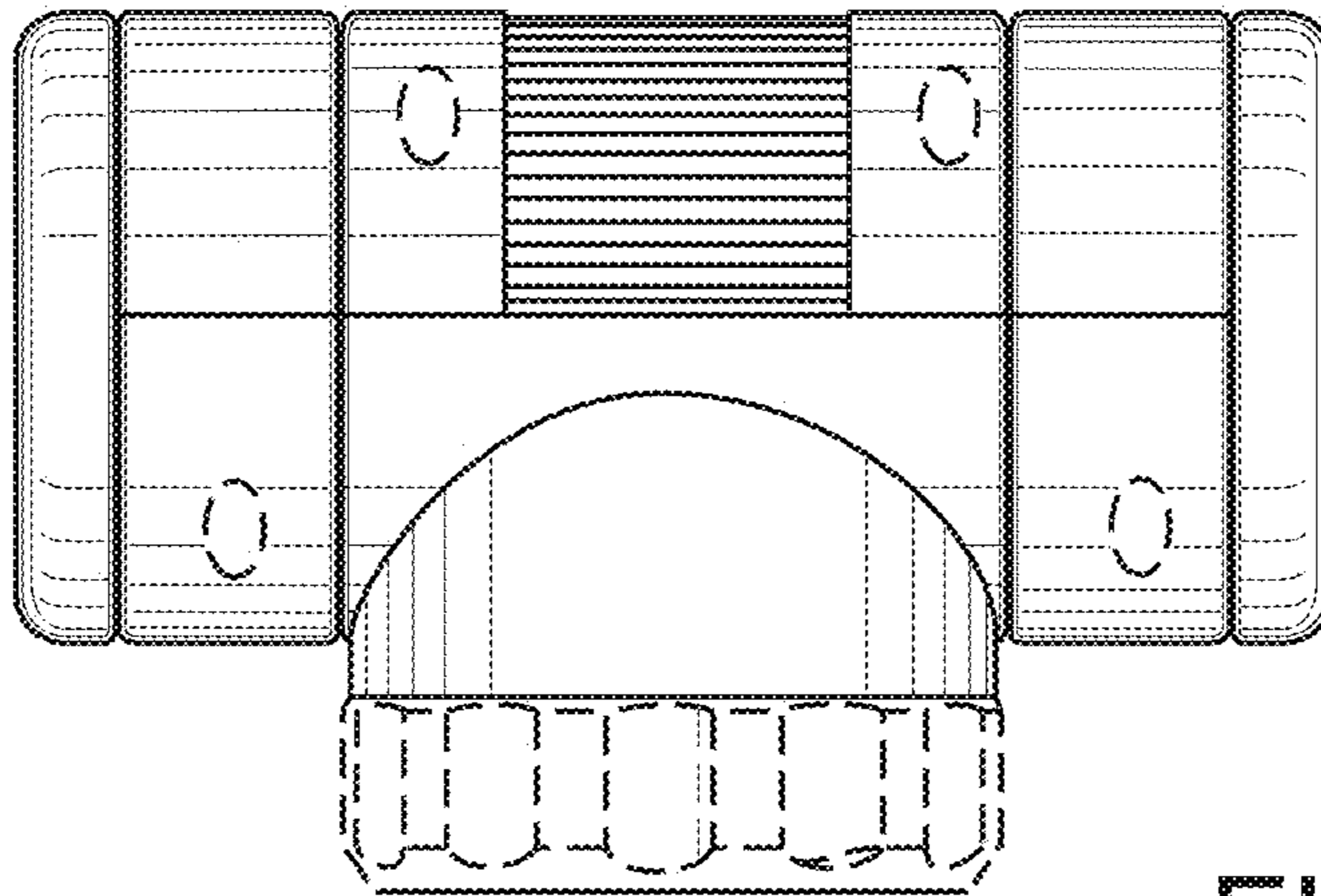

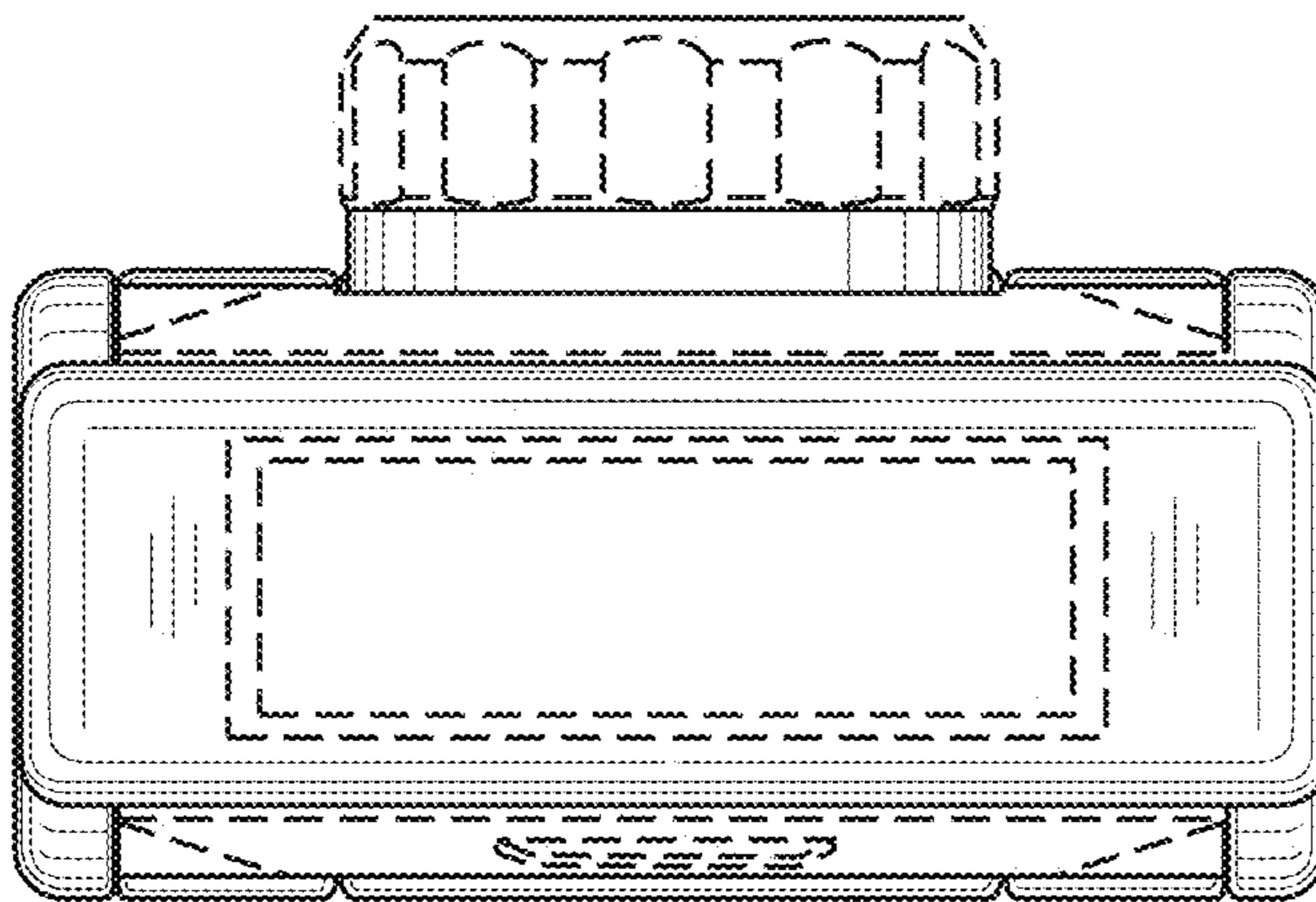
