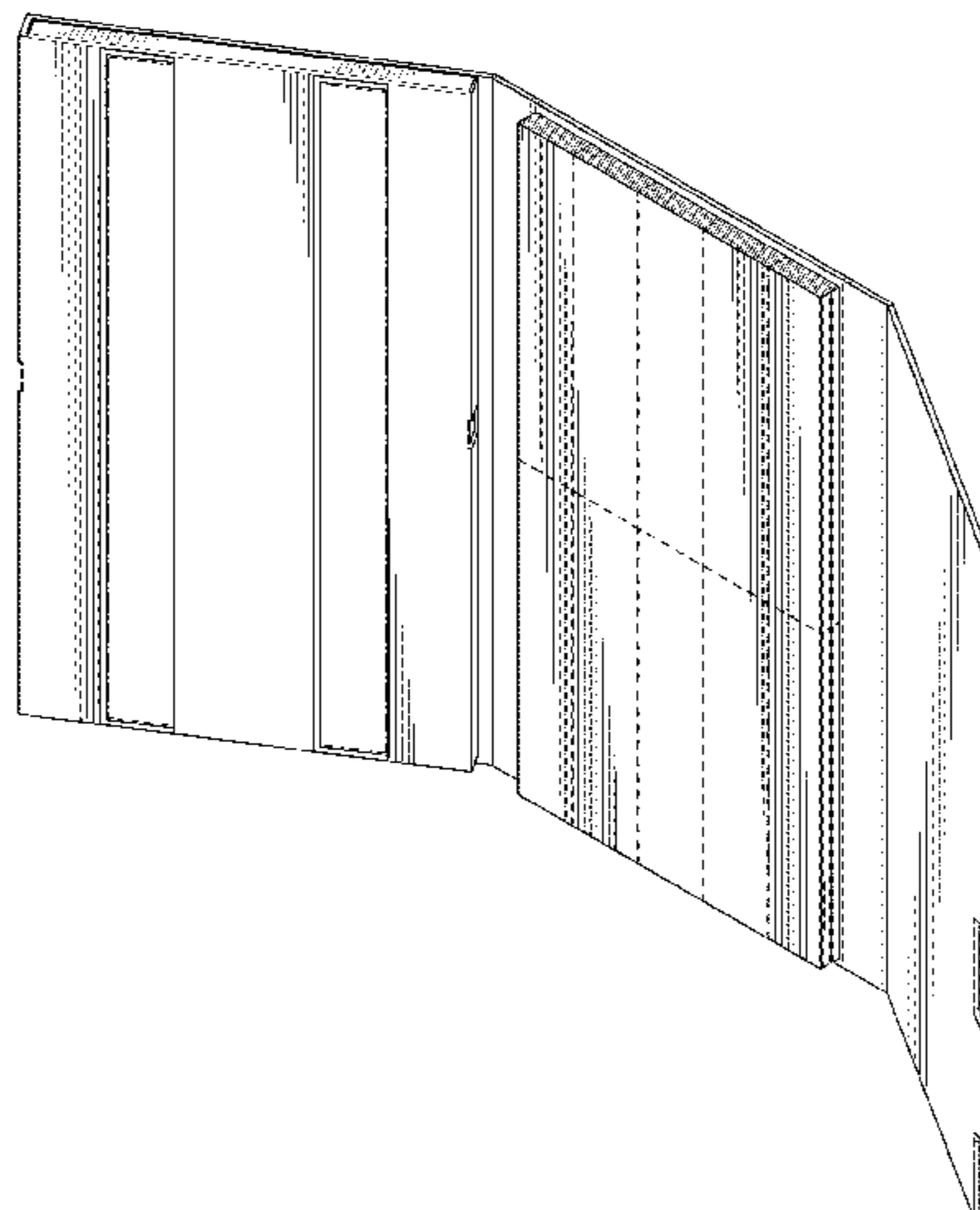


FIG. 24 is a rear perspective view of the rolling paper booklet of FIG. 22;

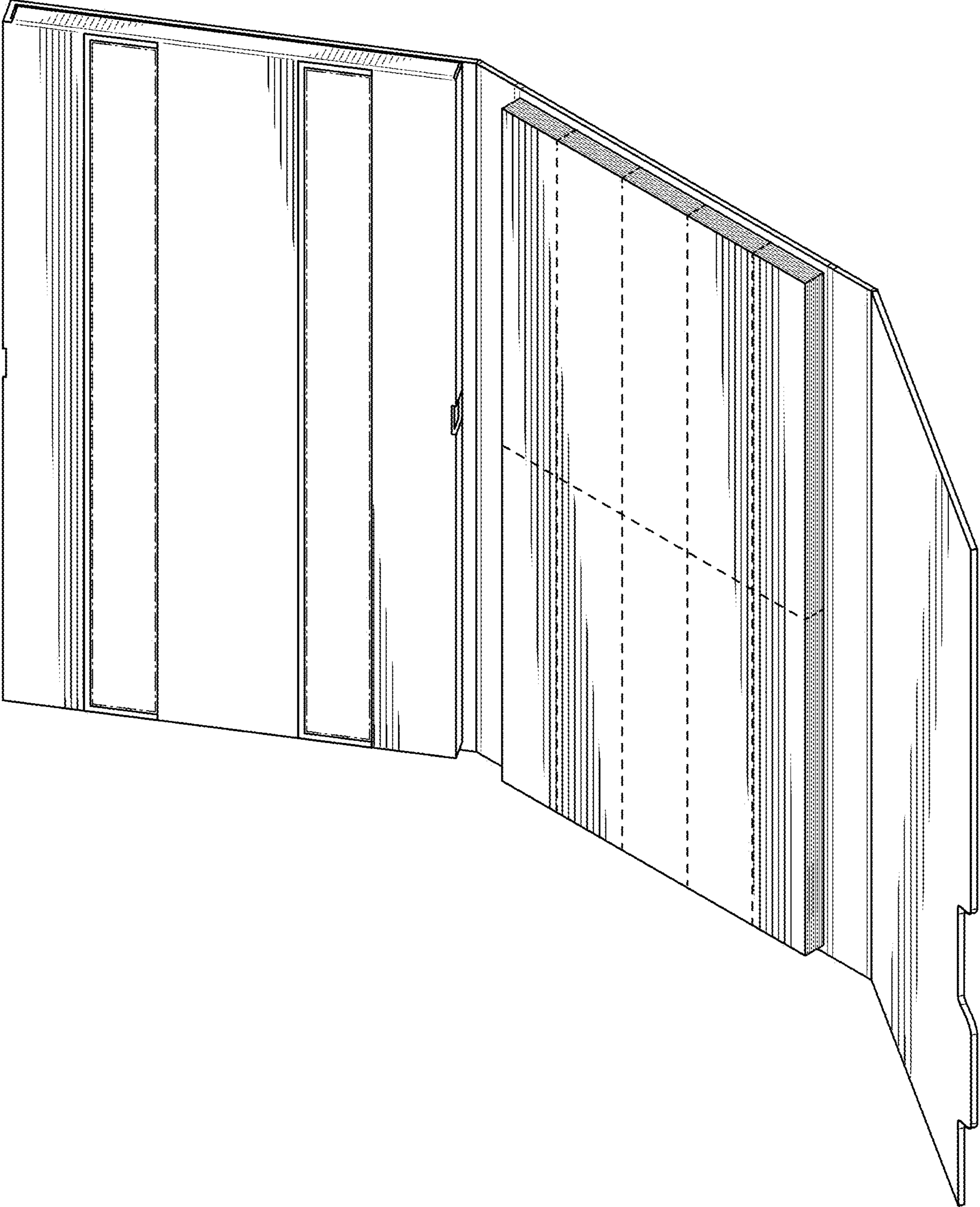

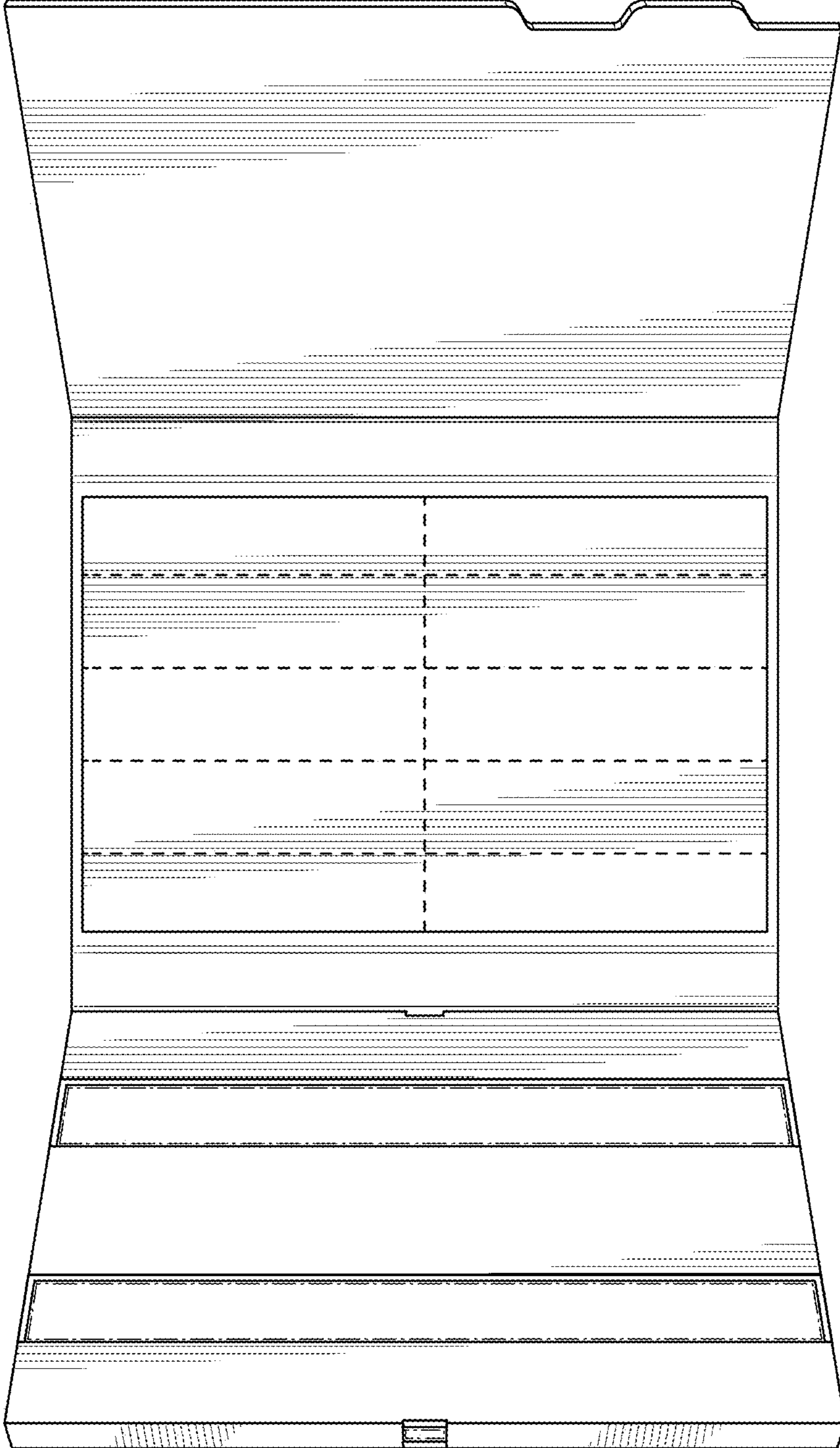

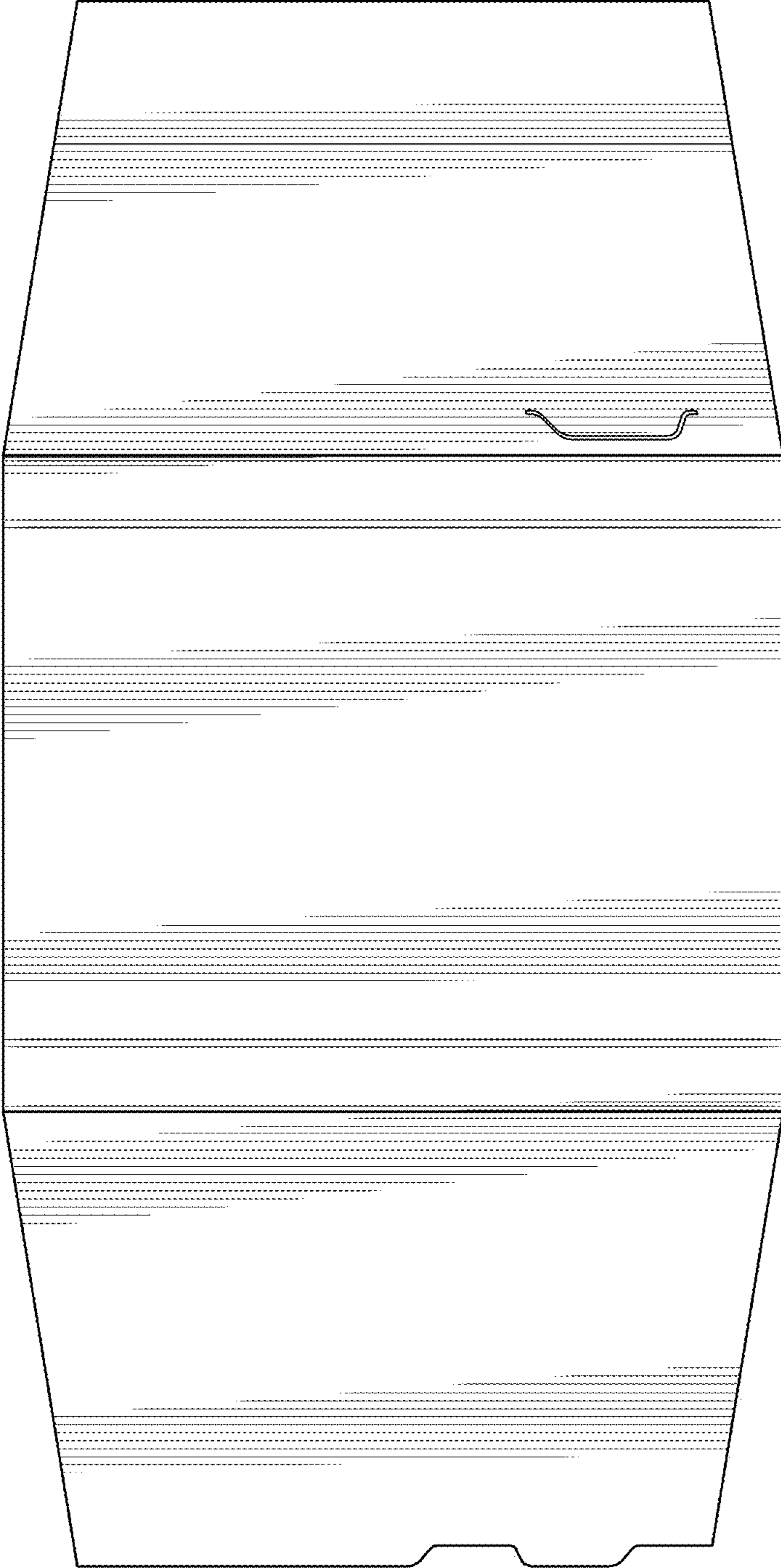

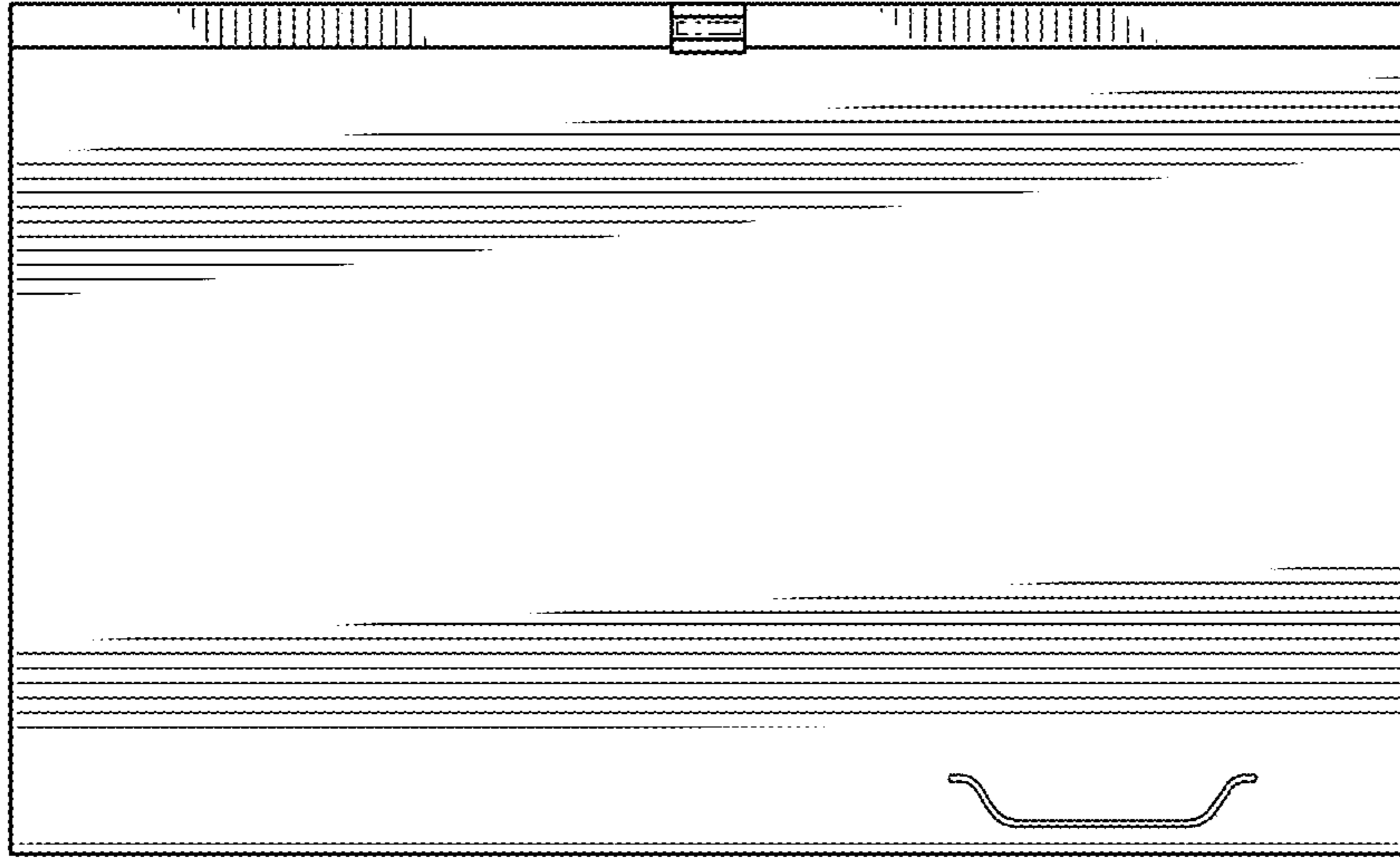

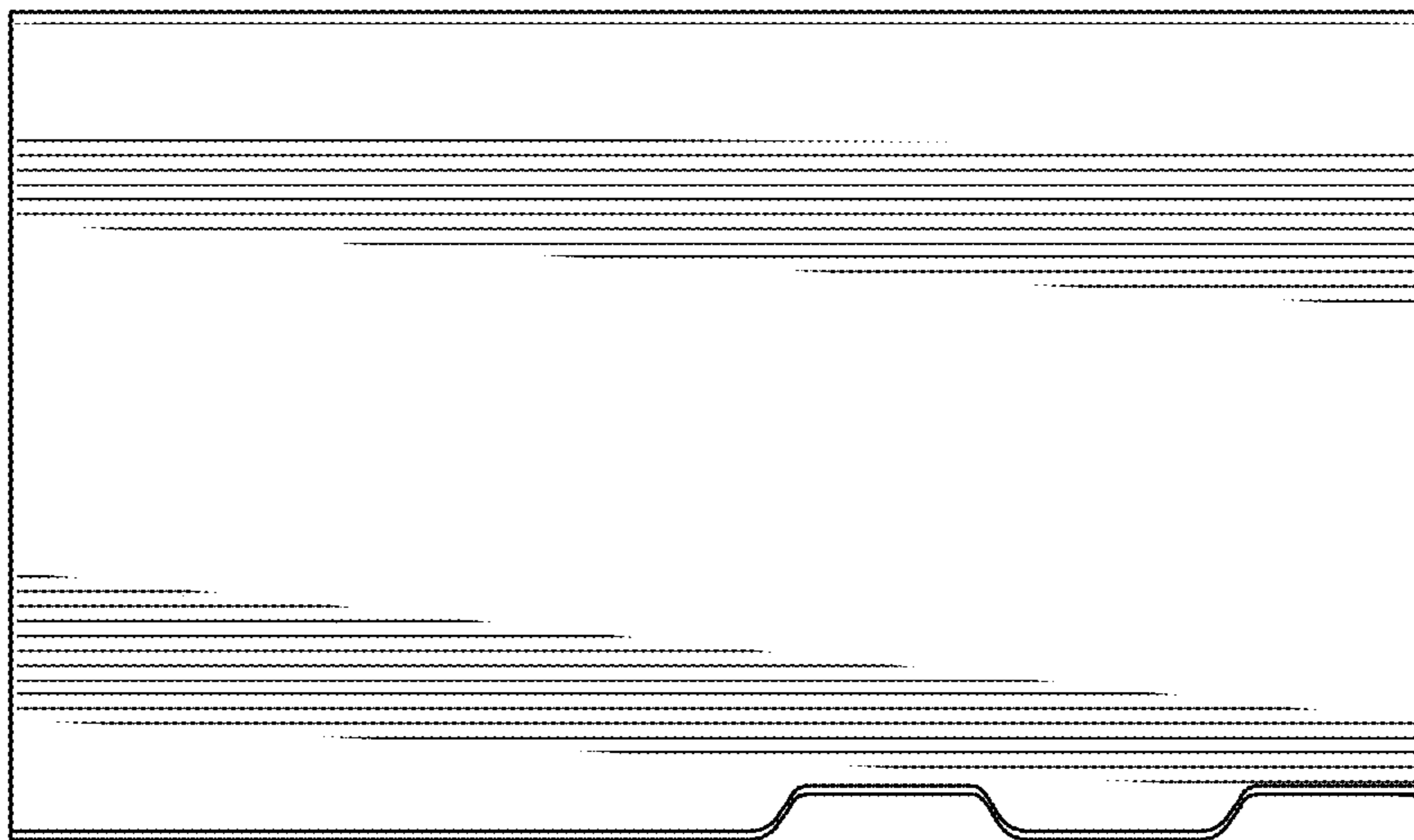

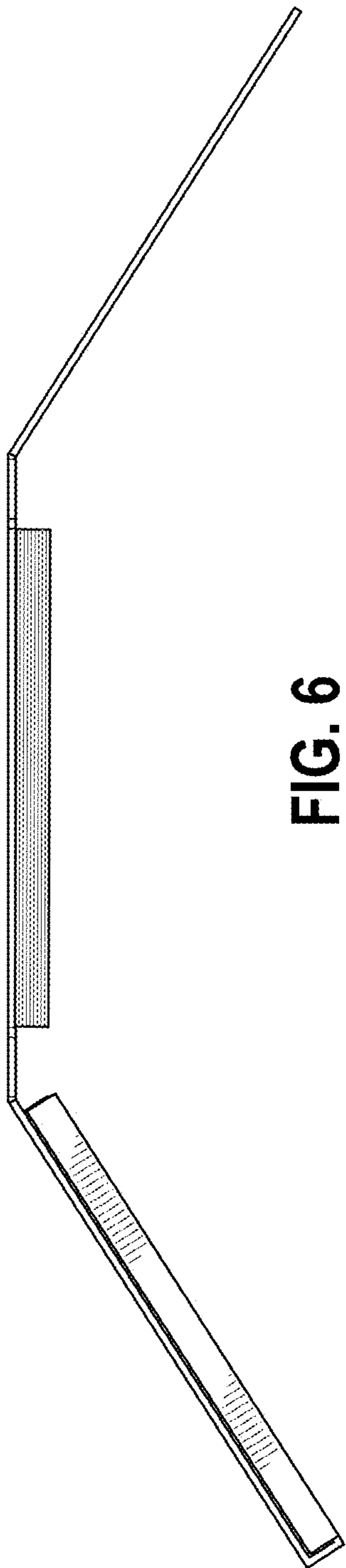

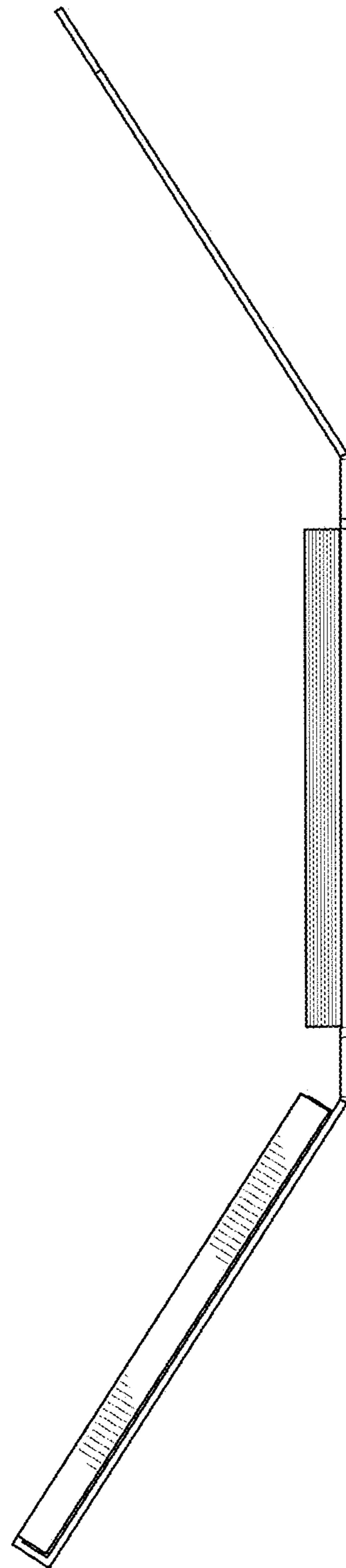

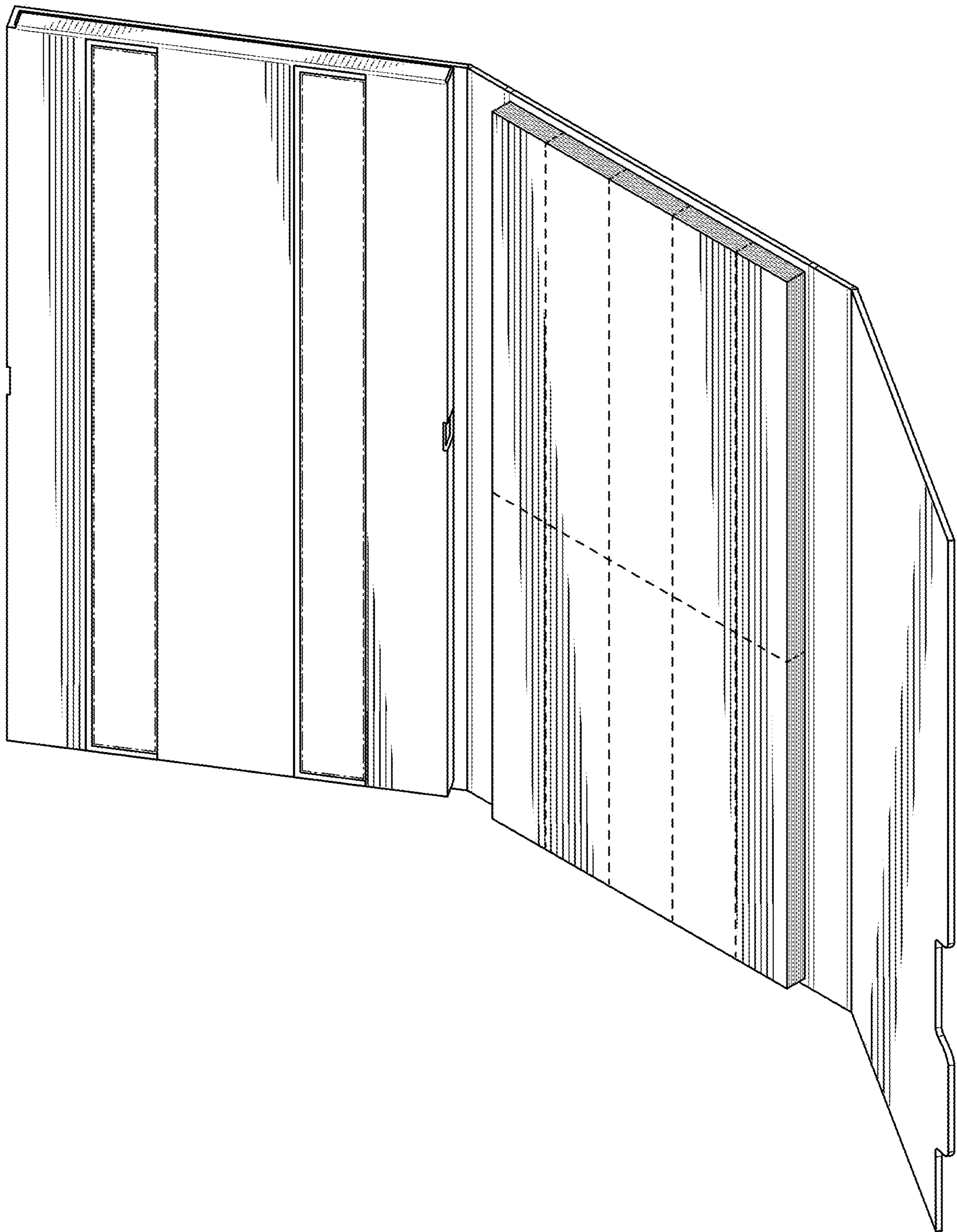

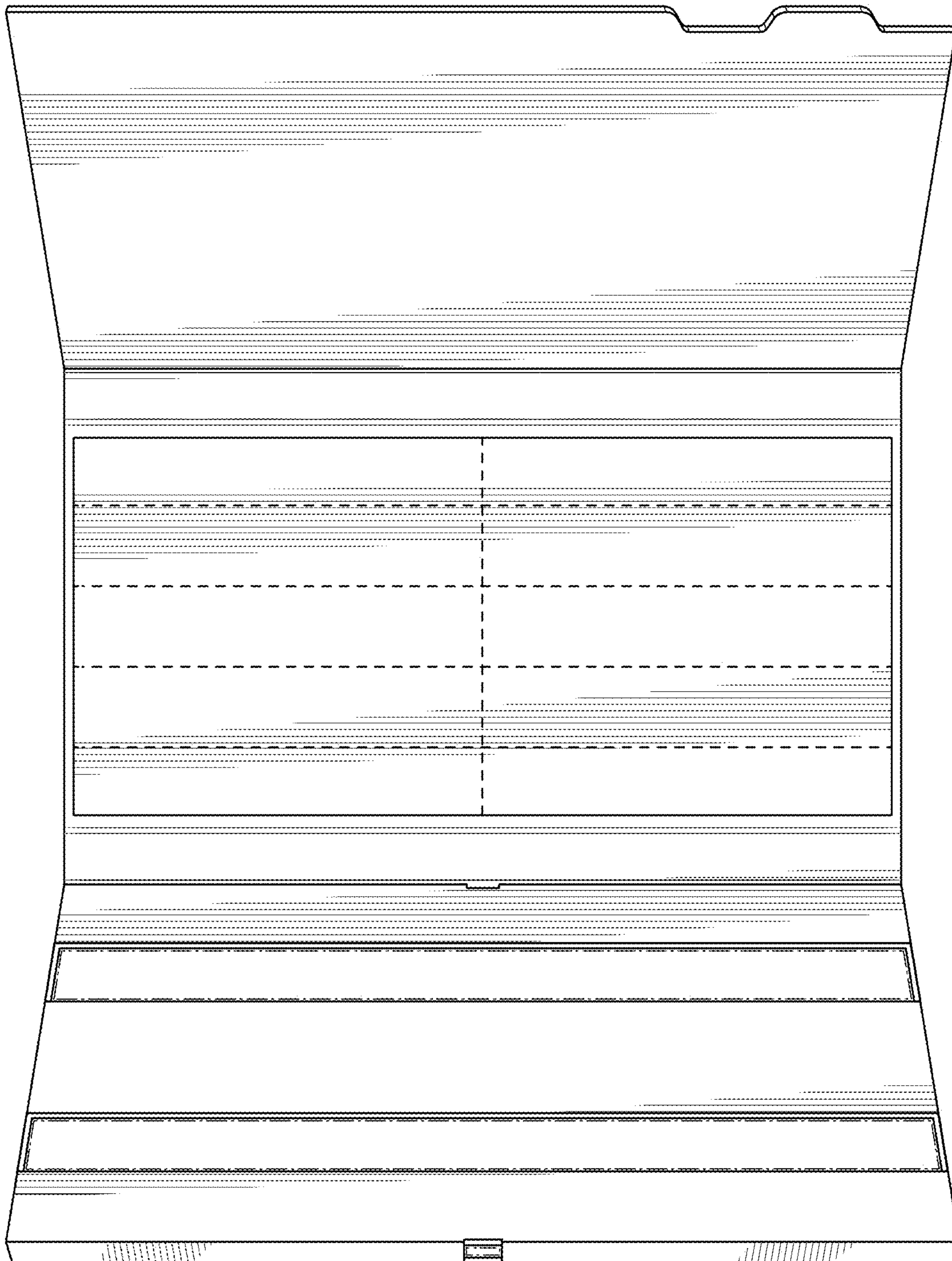

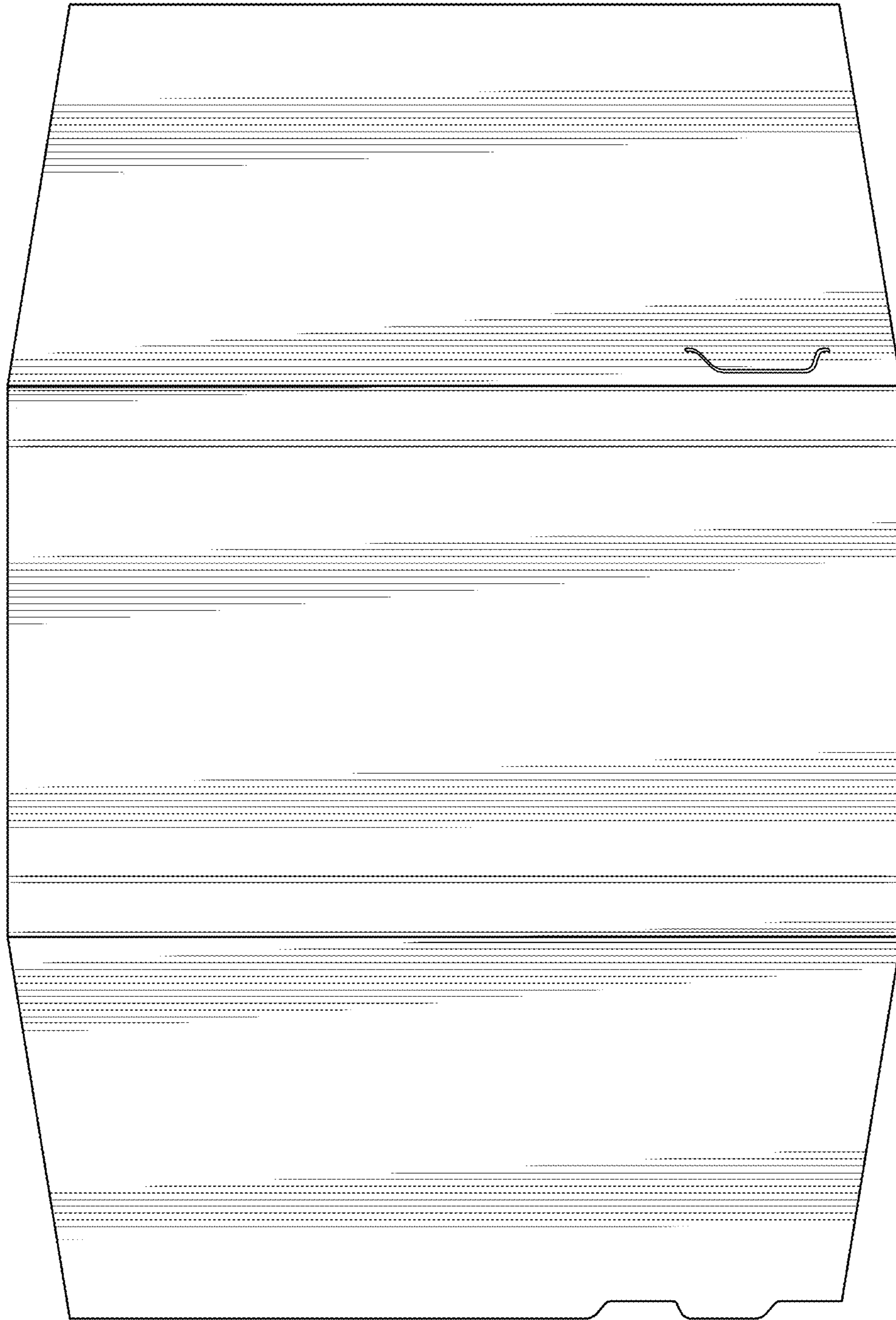

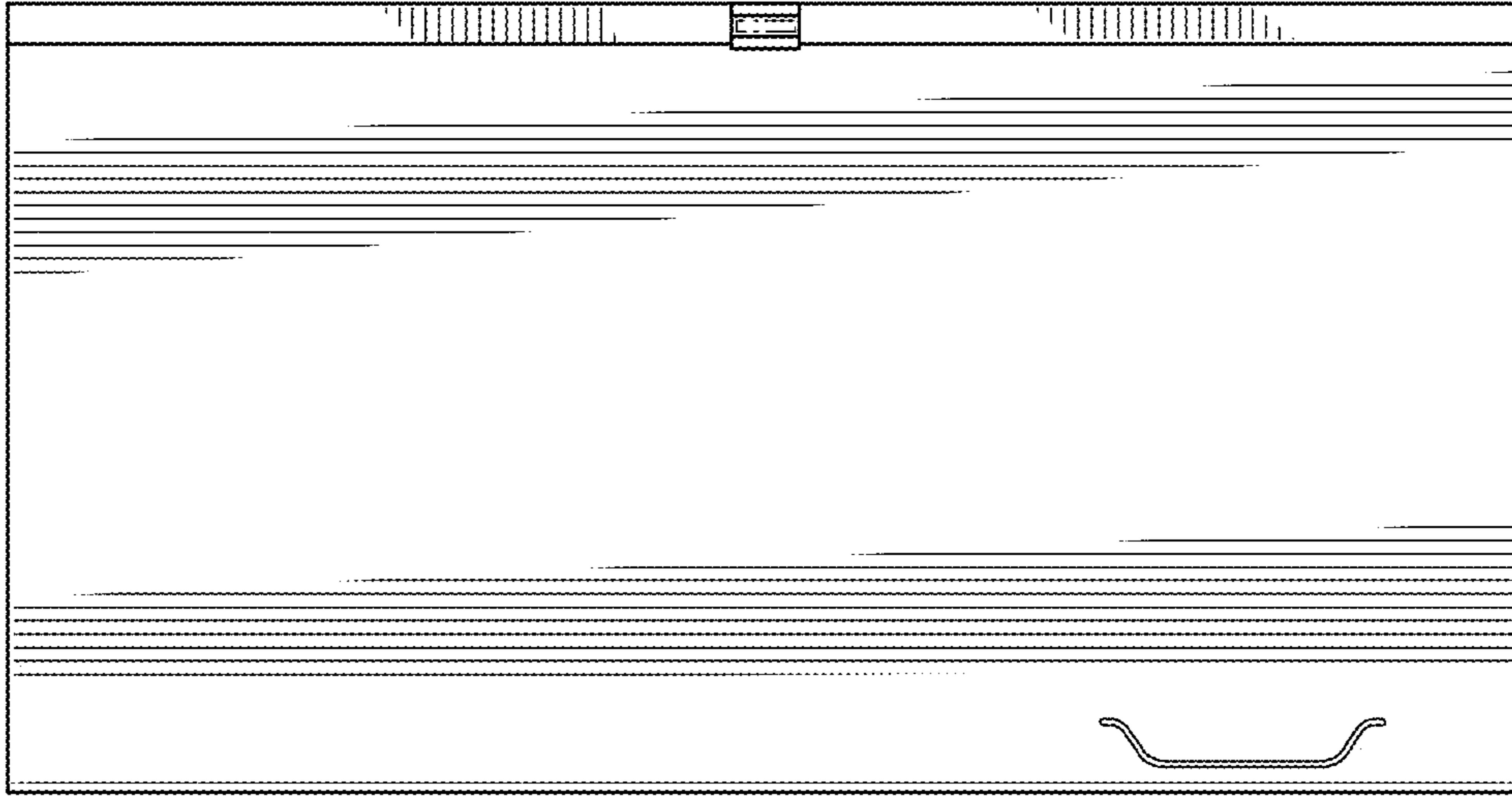

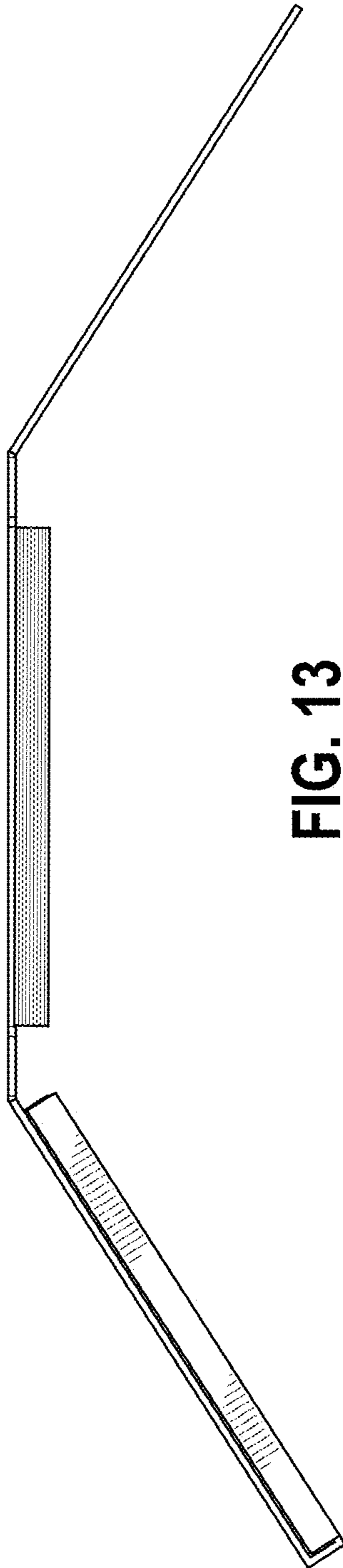

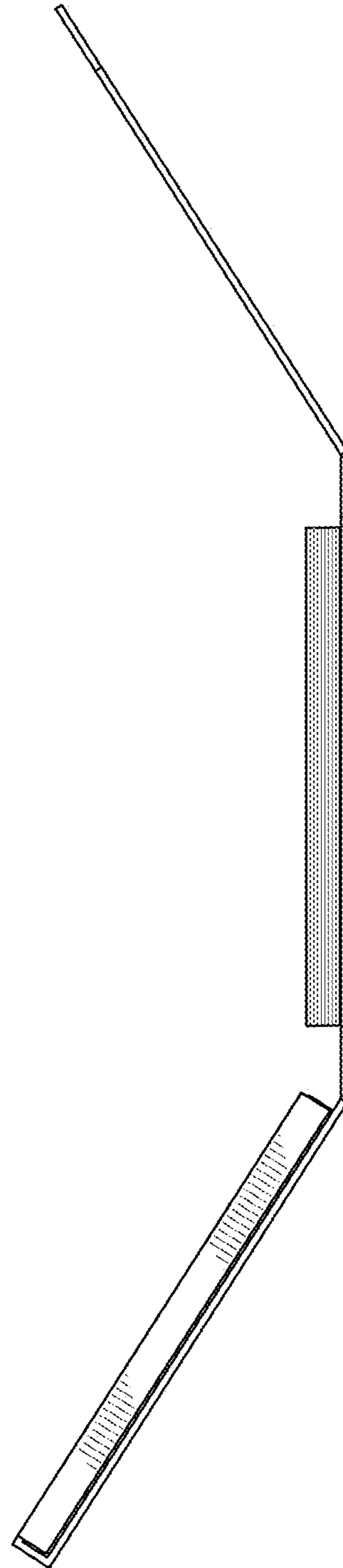

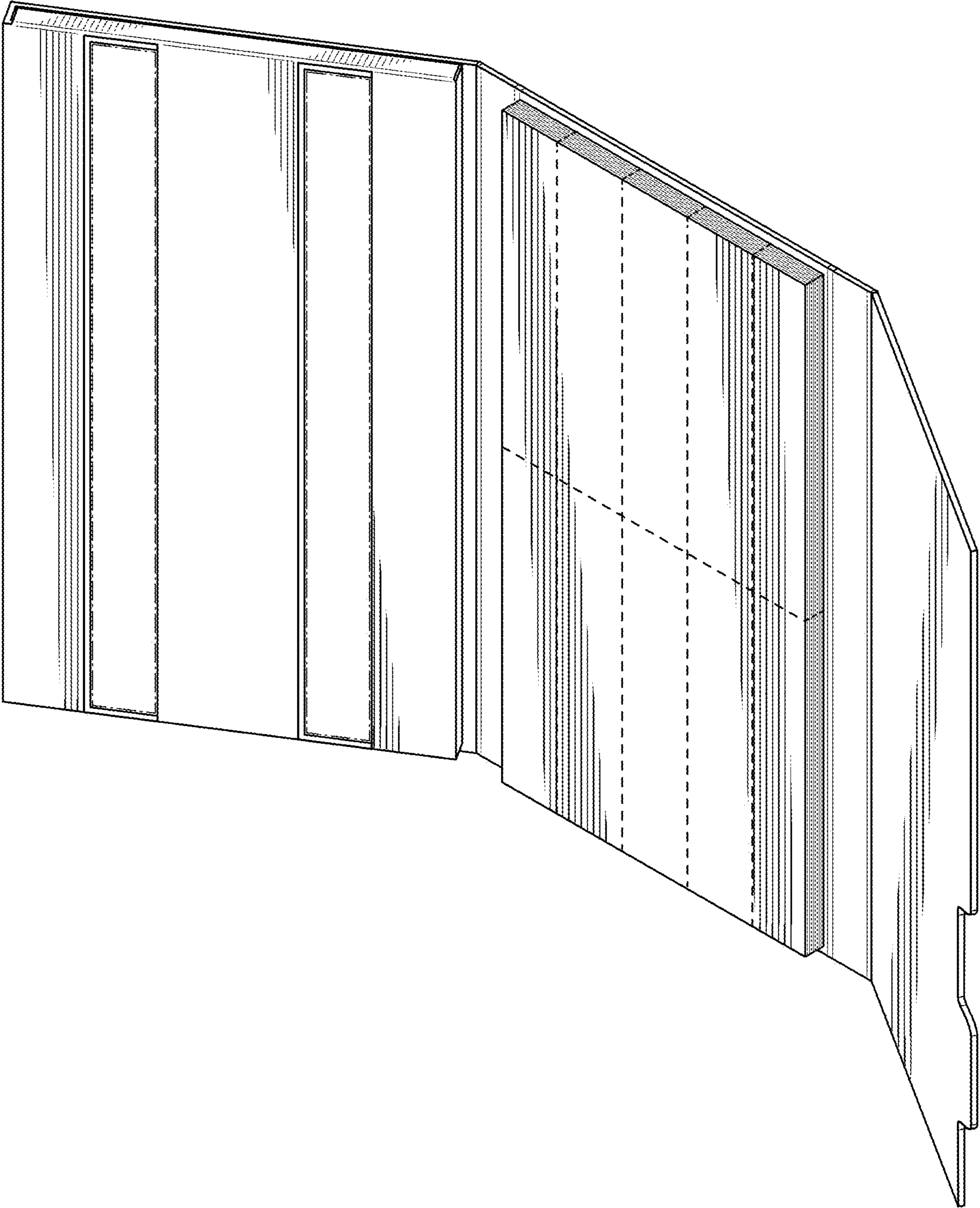

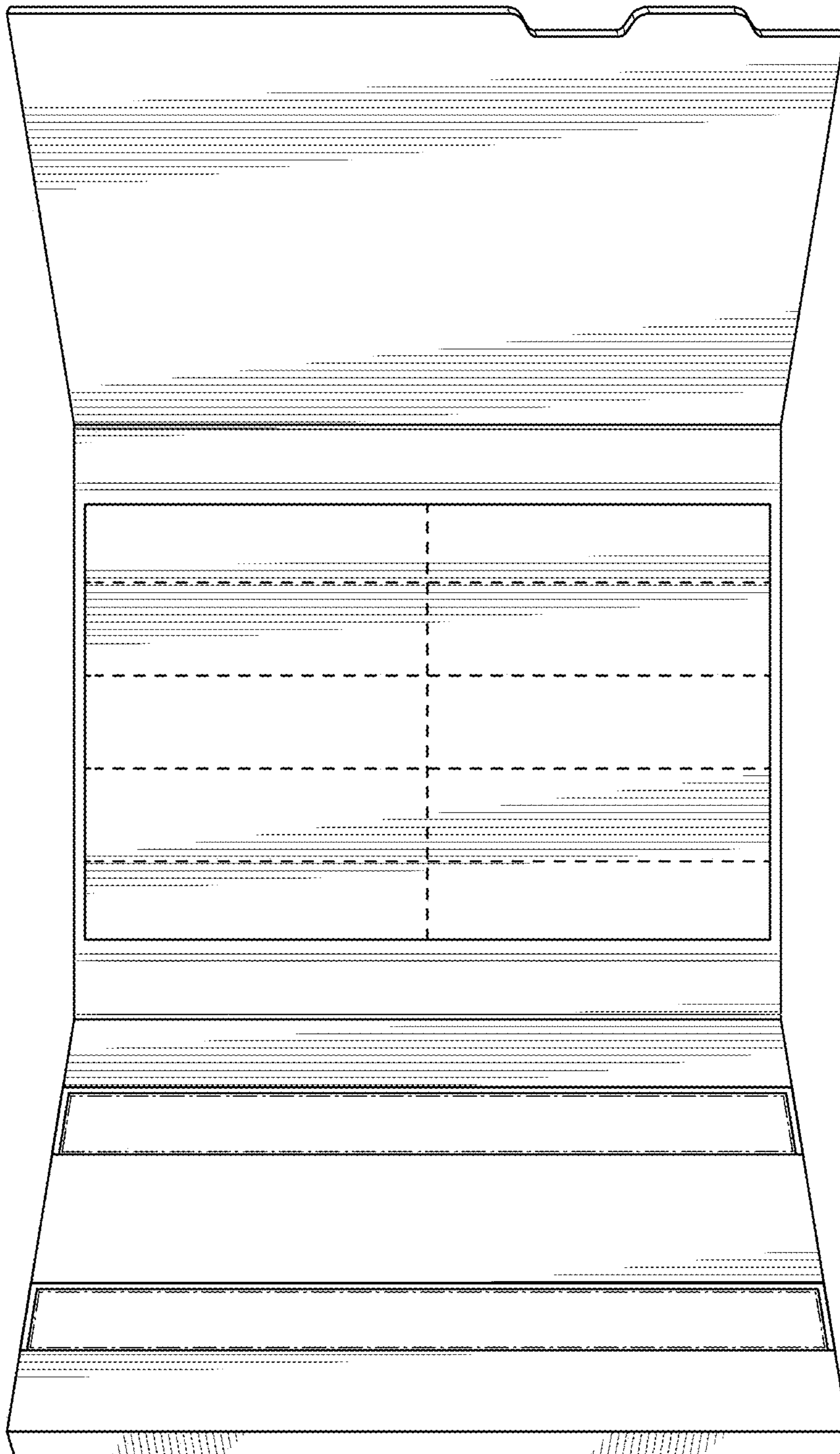

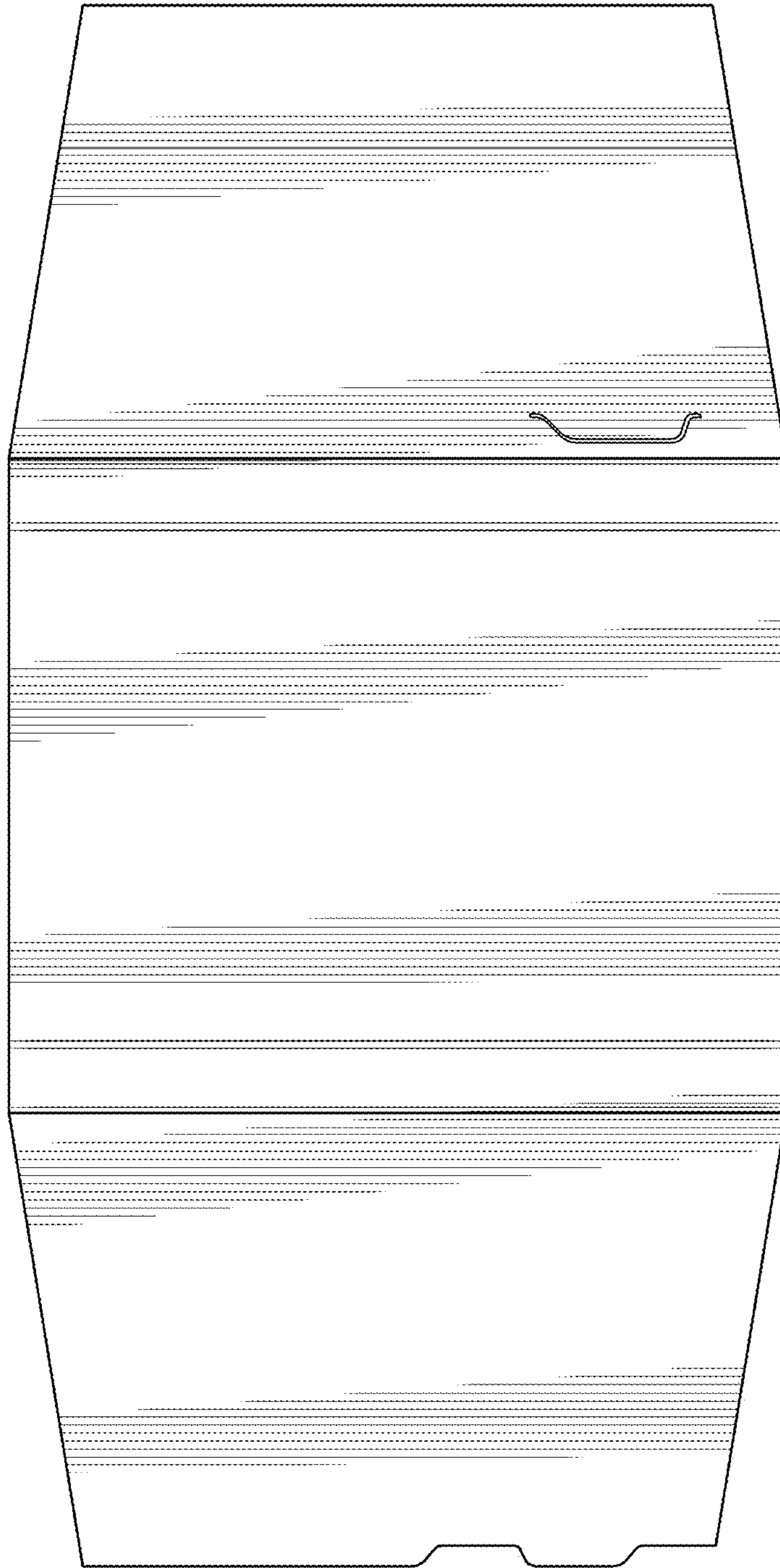

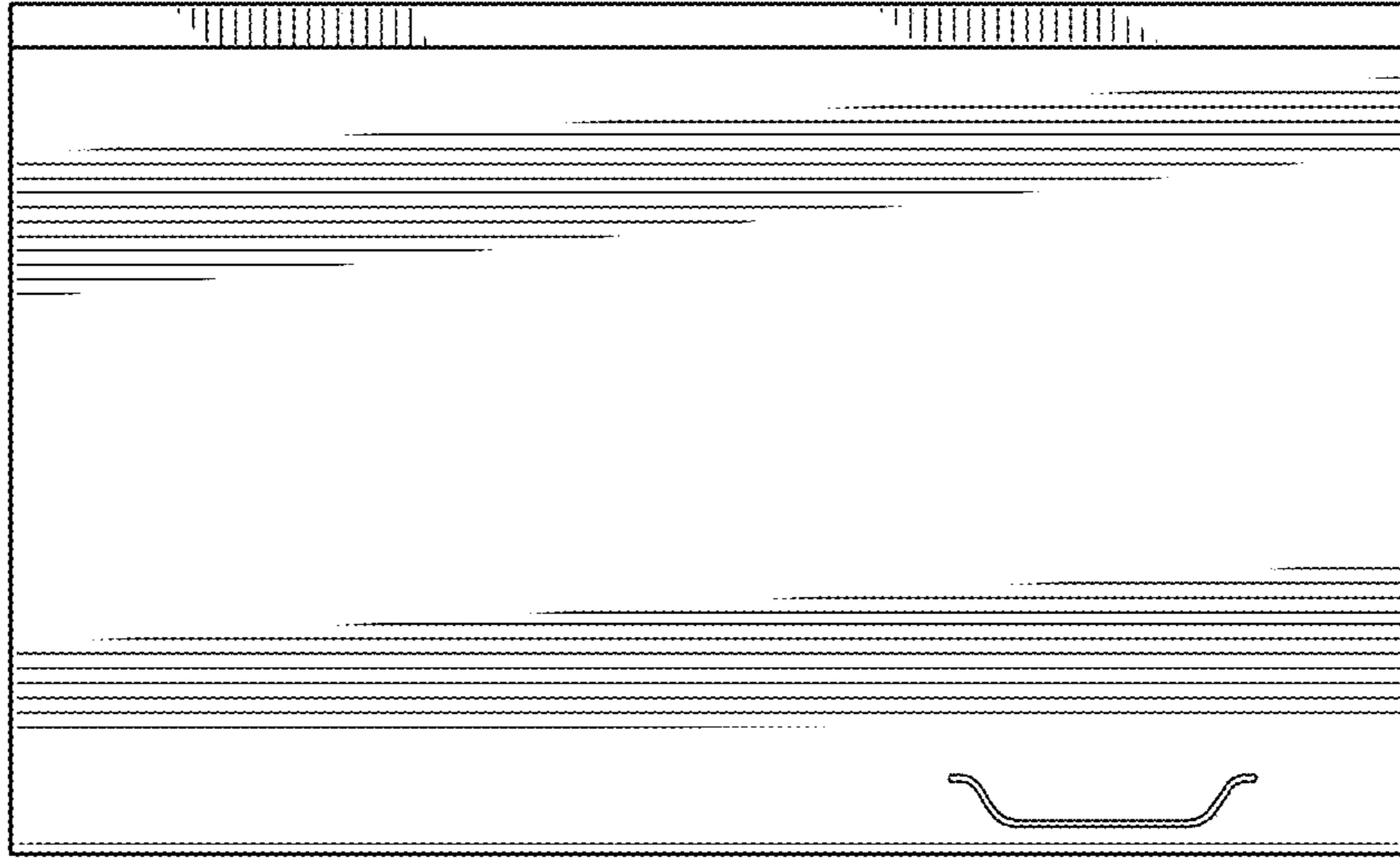

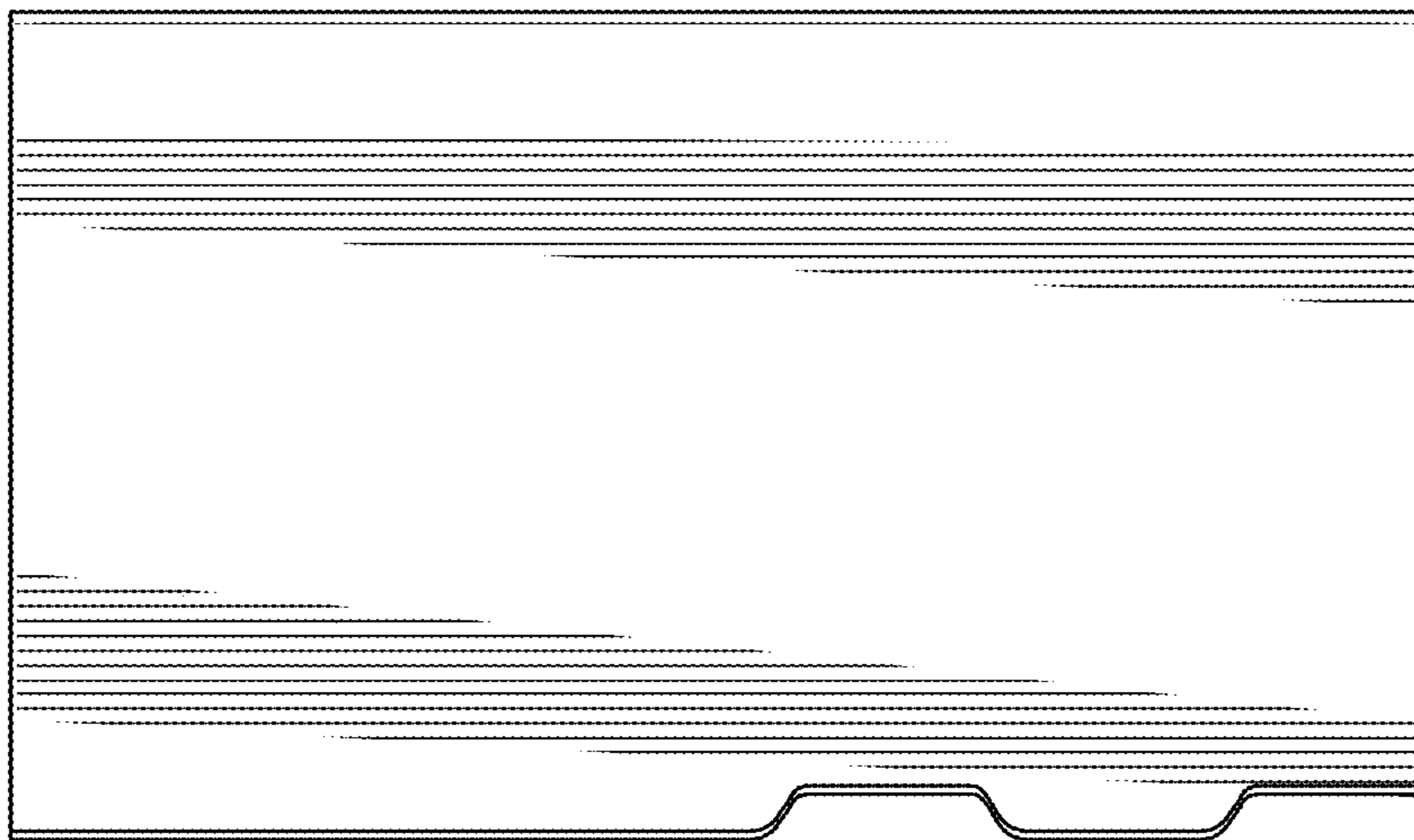

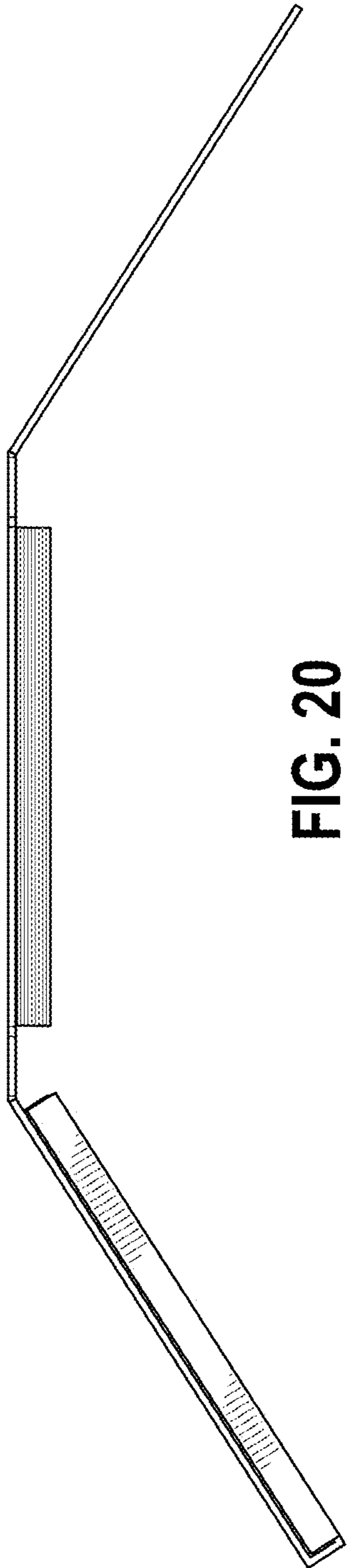

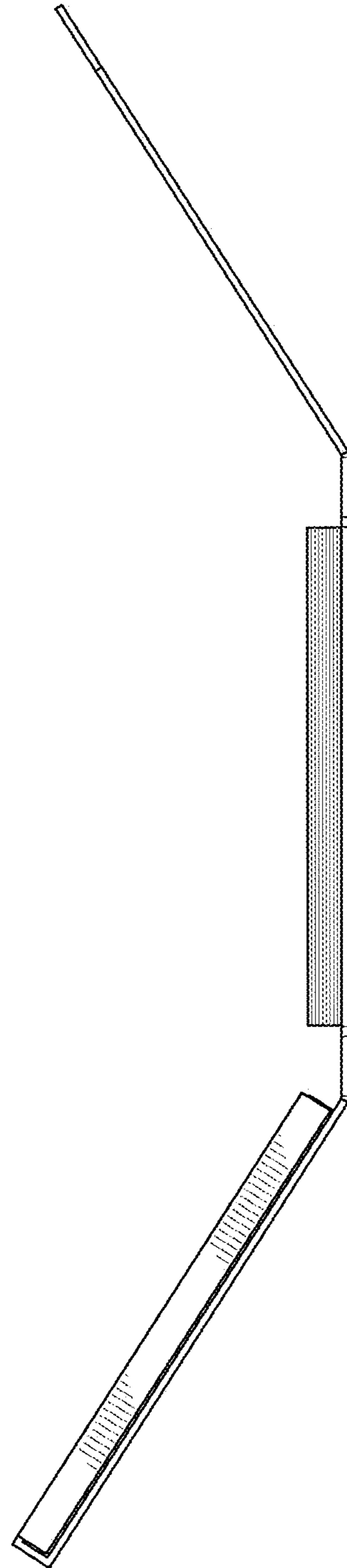

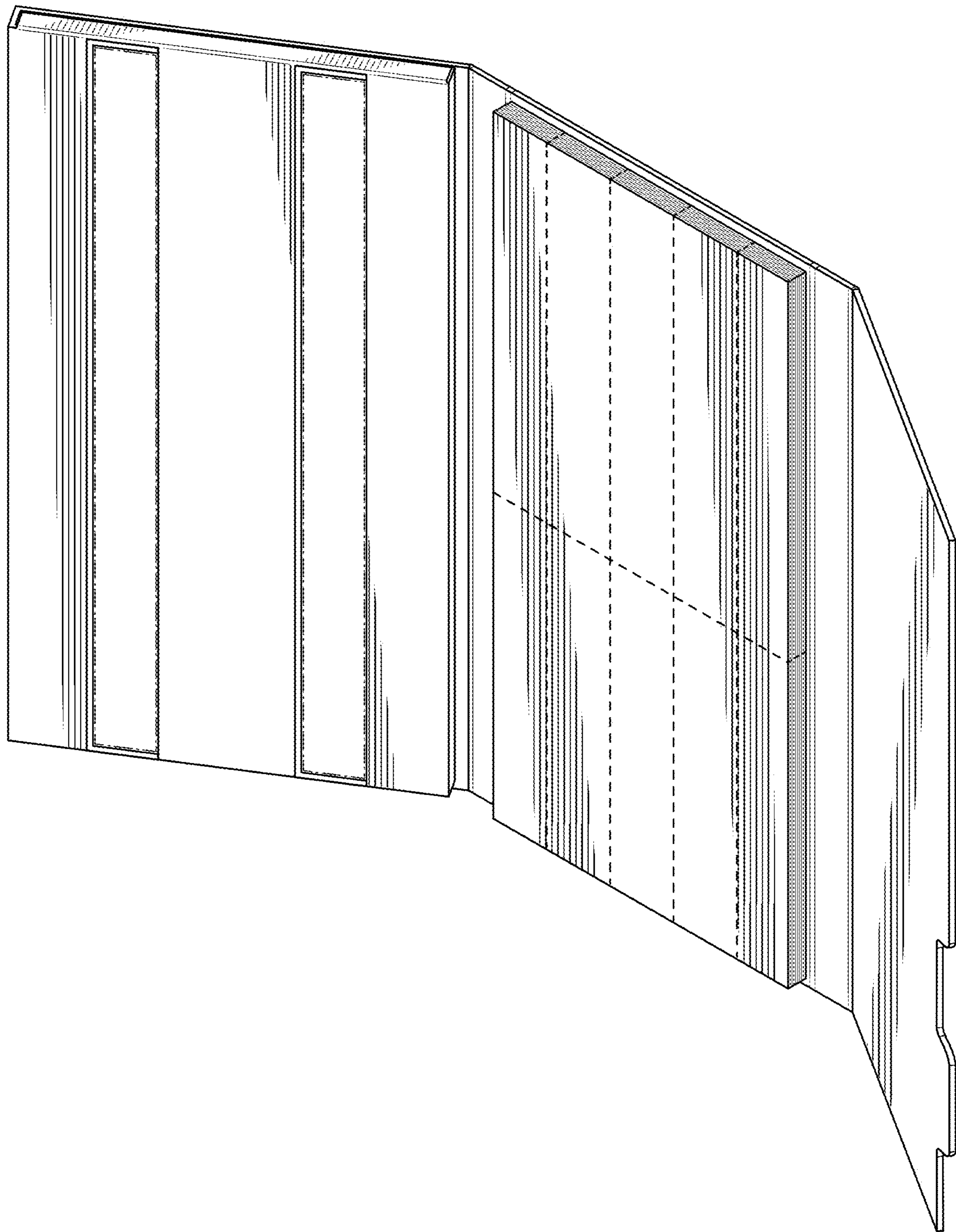

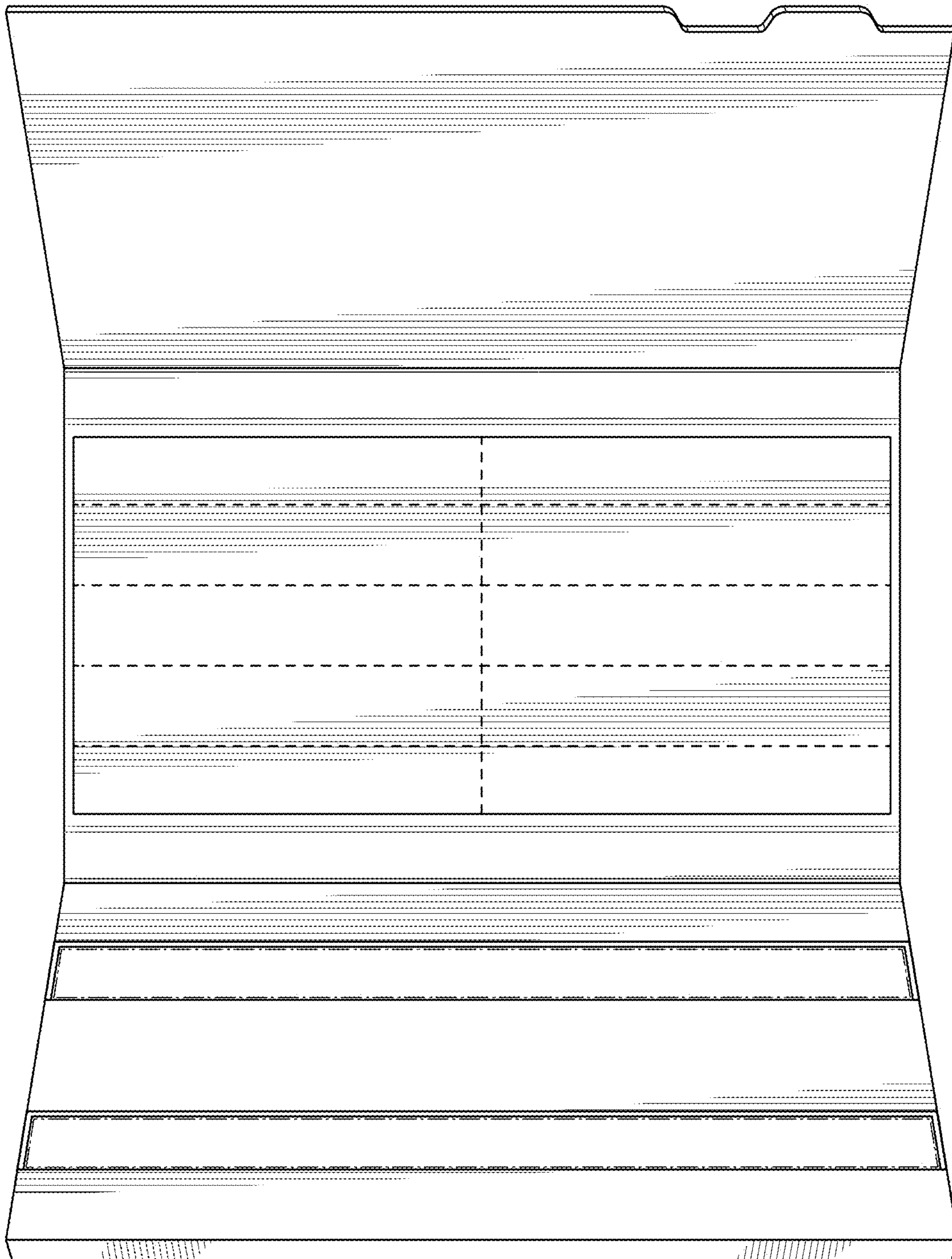

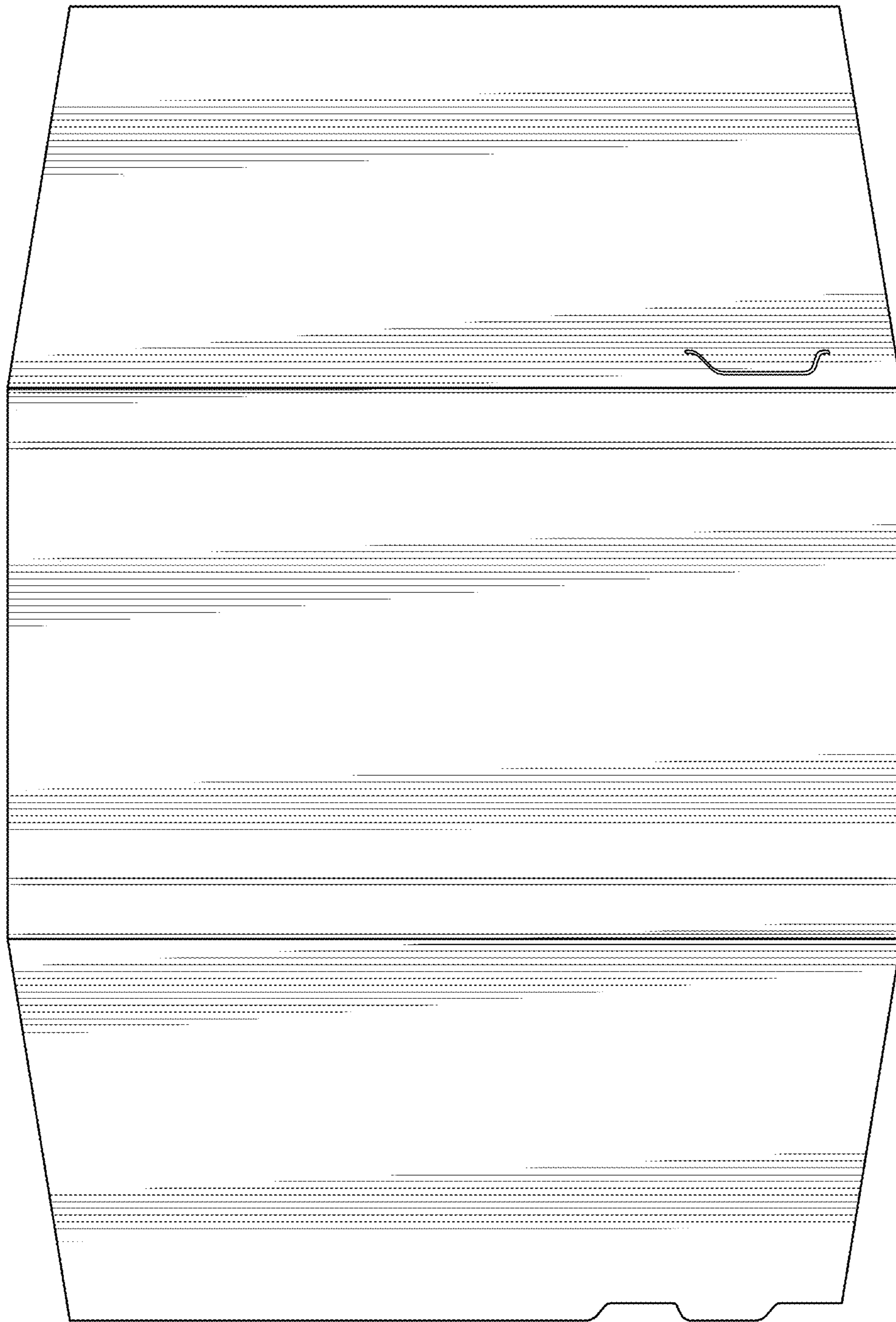

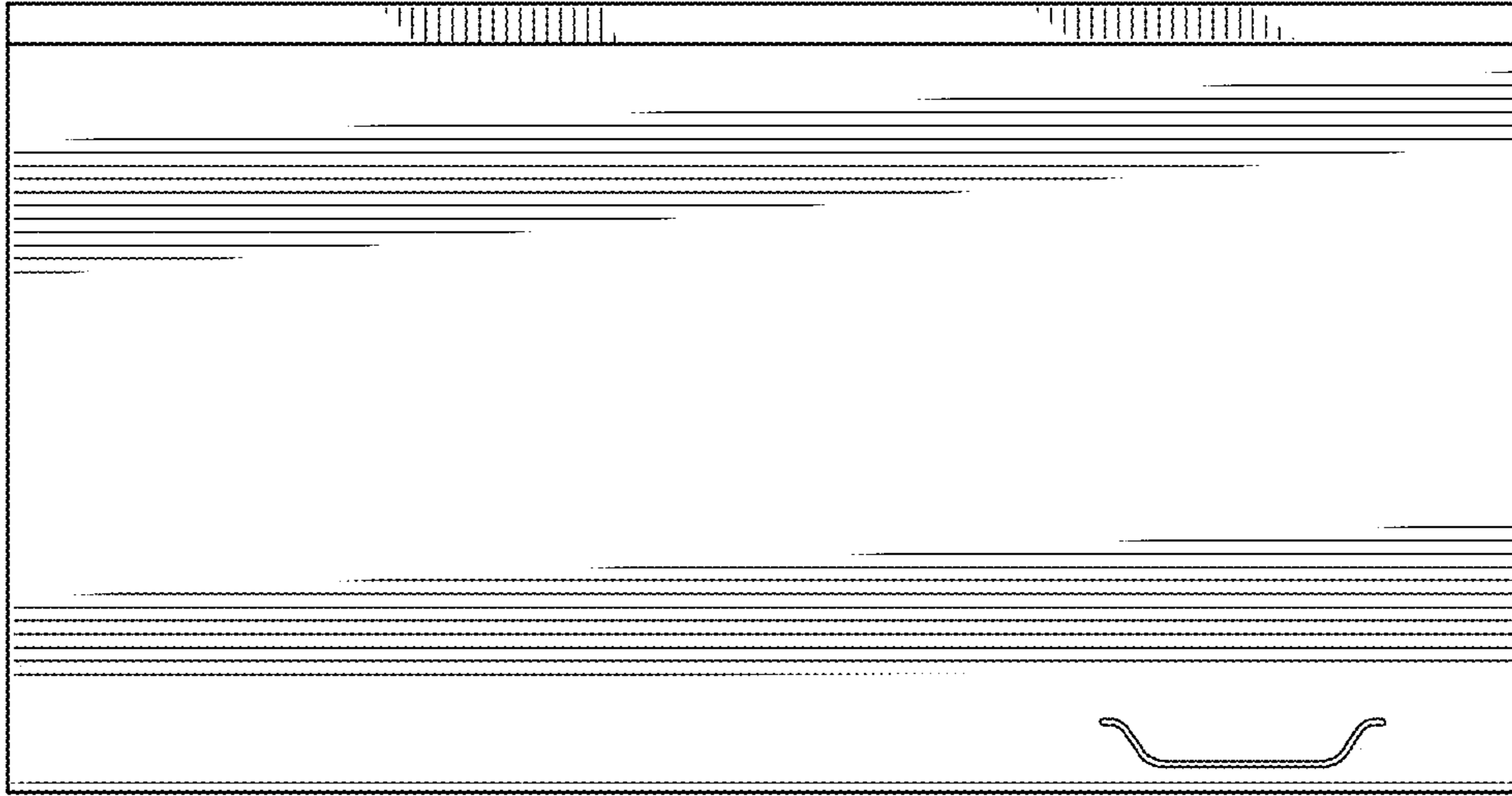

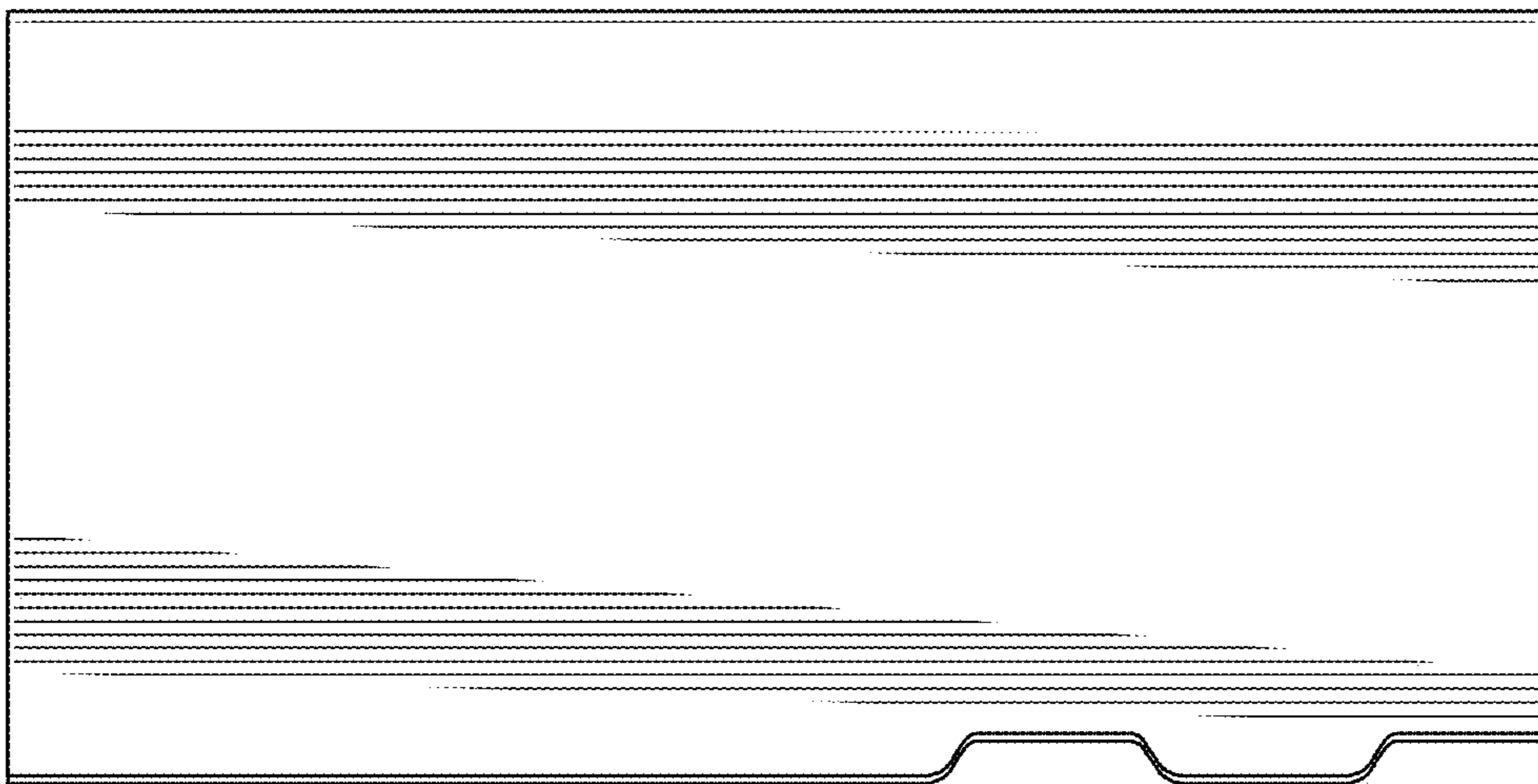
