(57) **CLAIM**

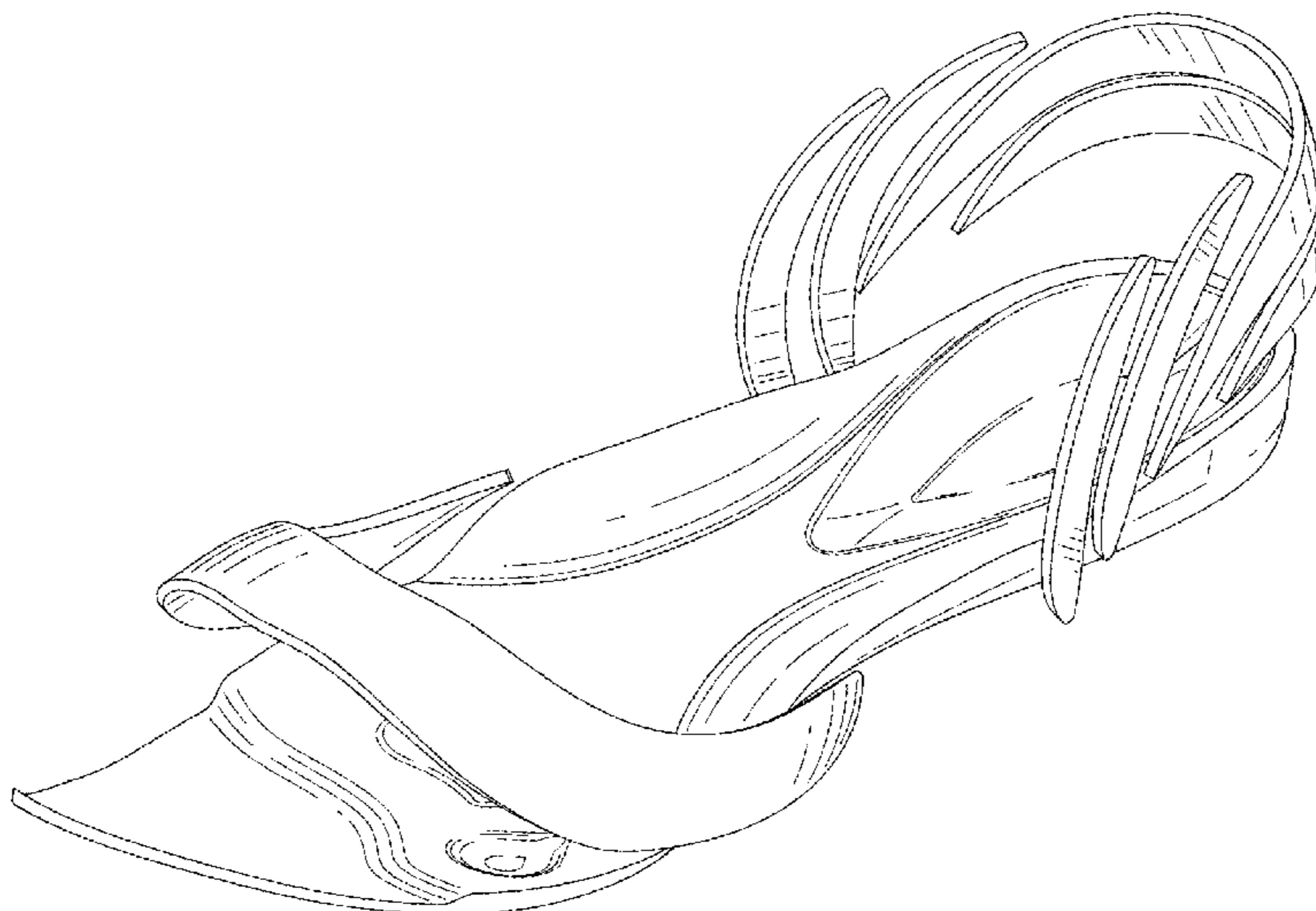
The ornamental design for a cushion for a flat heel shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side isometric view of a cushion for a flat heel shoe showing our new design; FIG. 2 is a bottom, rear, left side isometric view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a top, front, right side isometric exploded view thereof, shown with a flat heel shoe in broken lines for environment.

The portions of a shoe shown in FIG. 9 in broken lines do not constitute part of the claimed design.

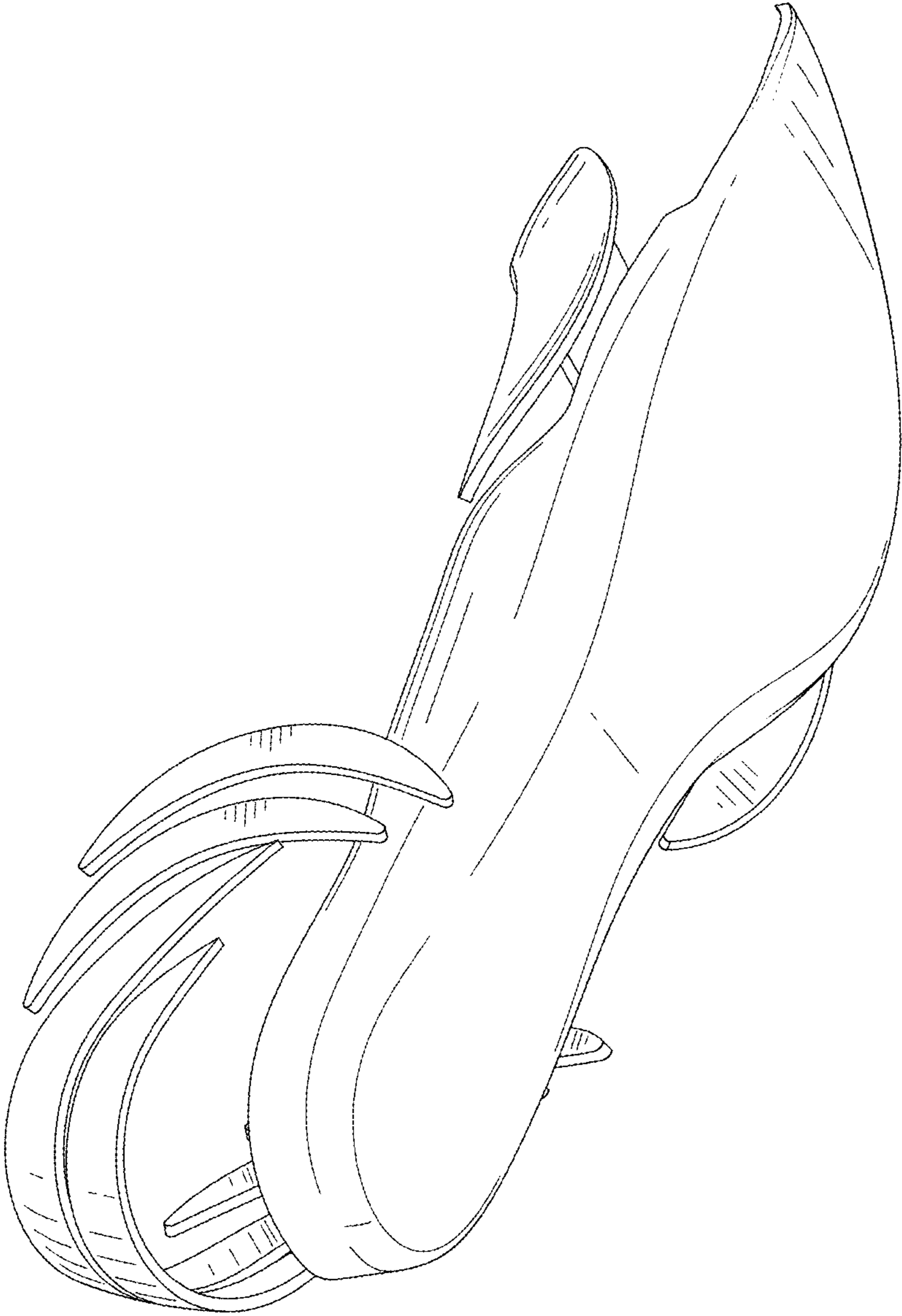

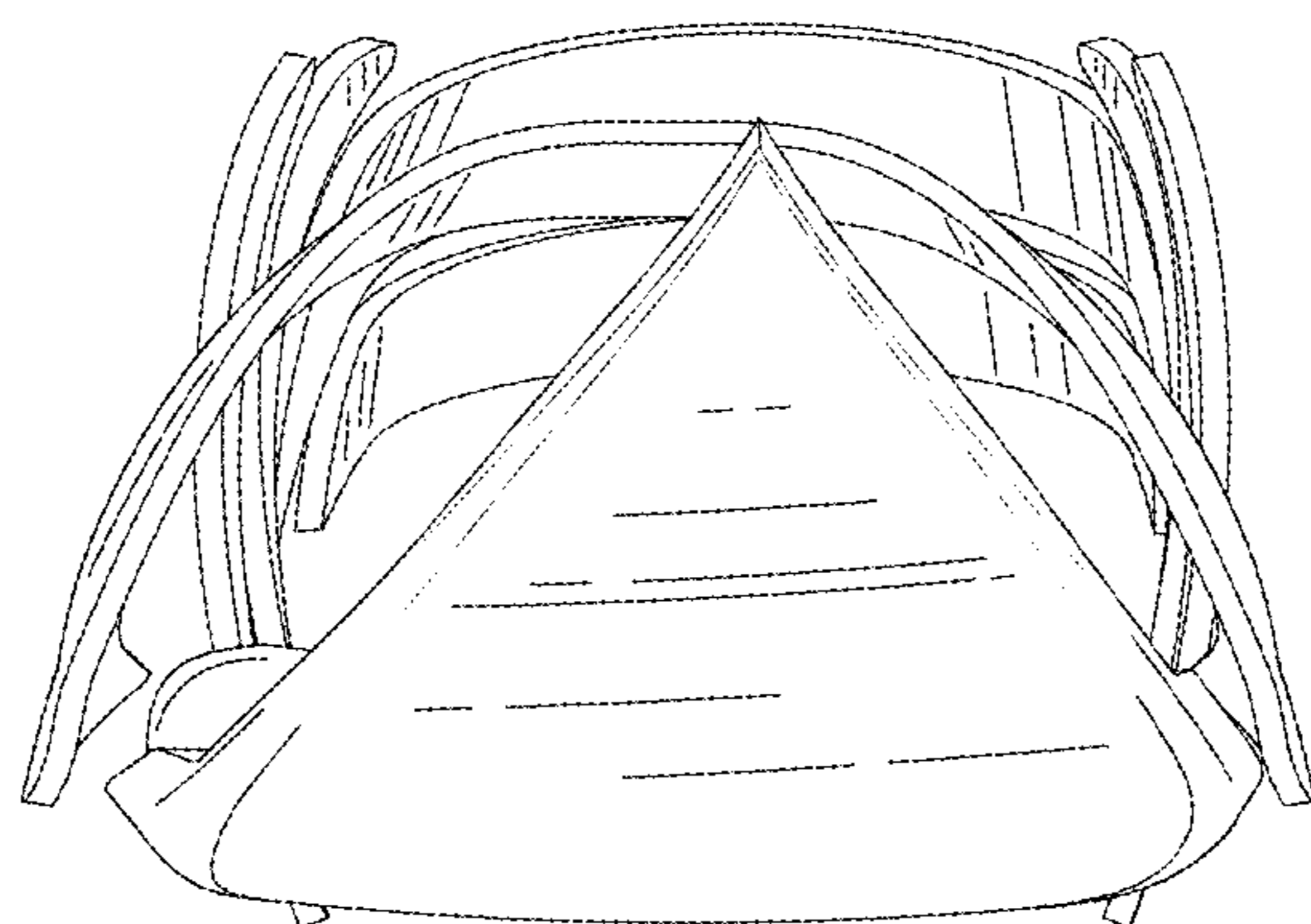

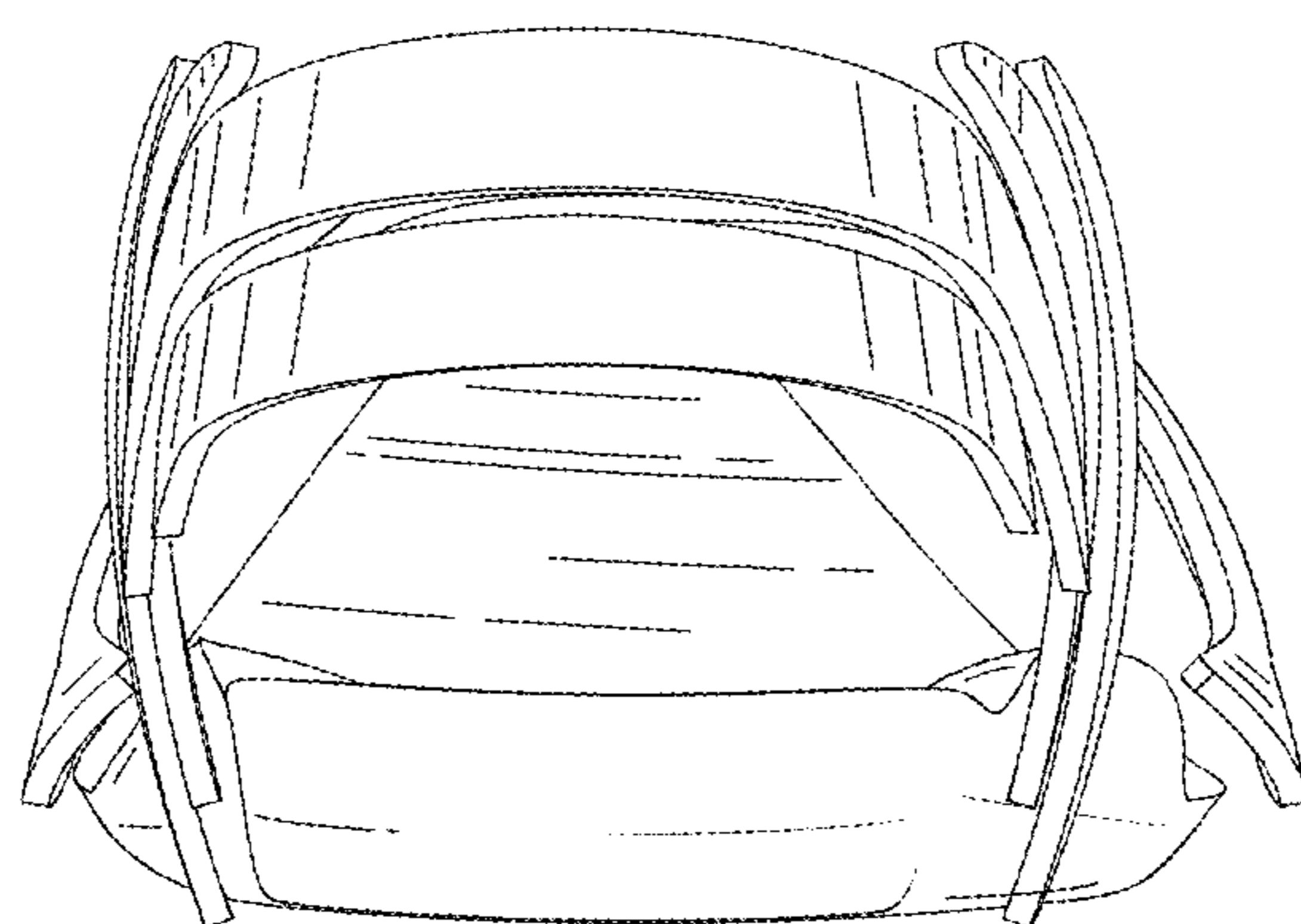

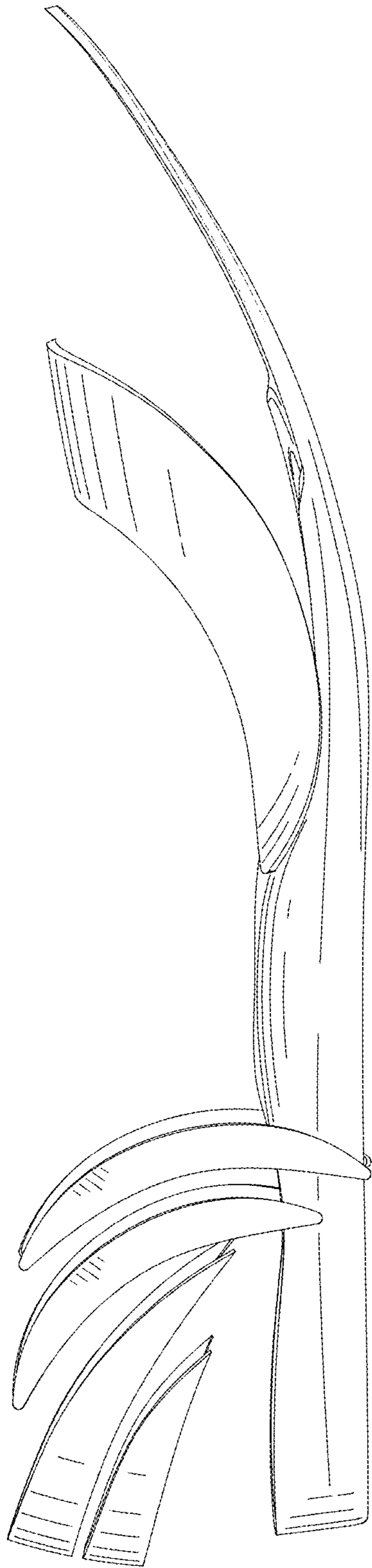

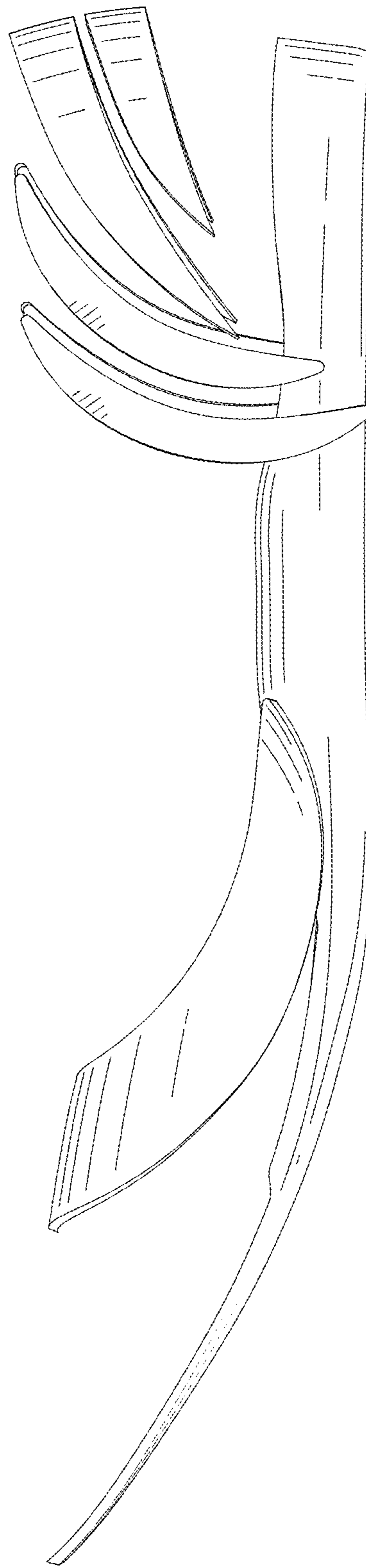

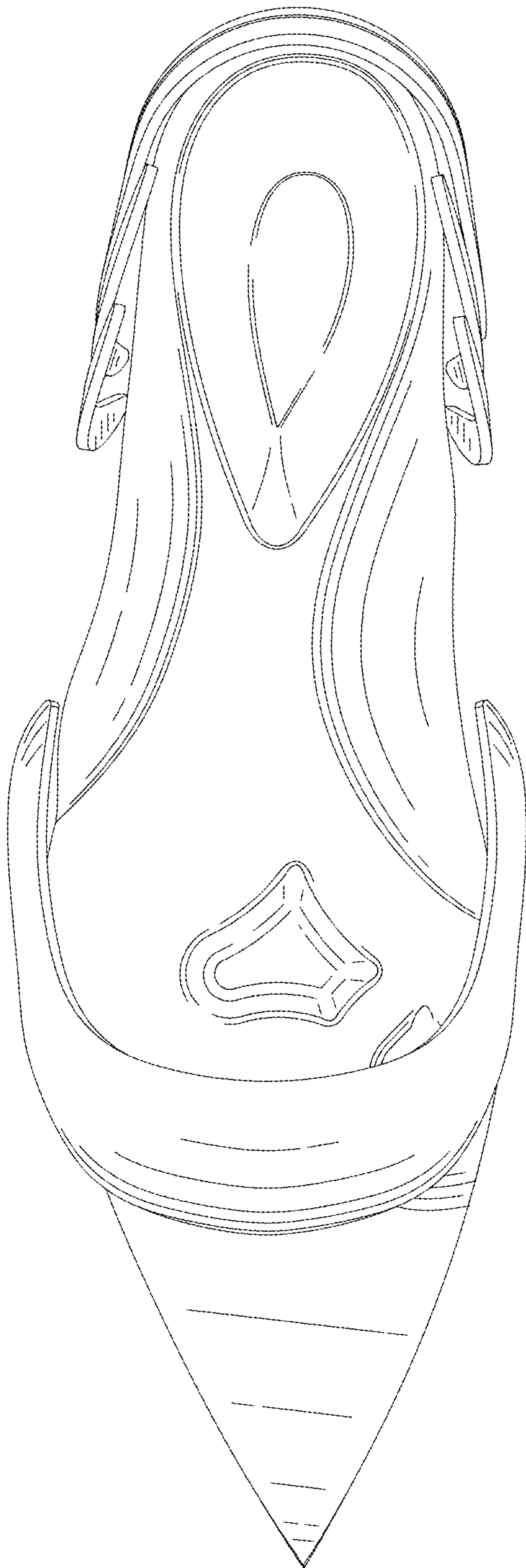

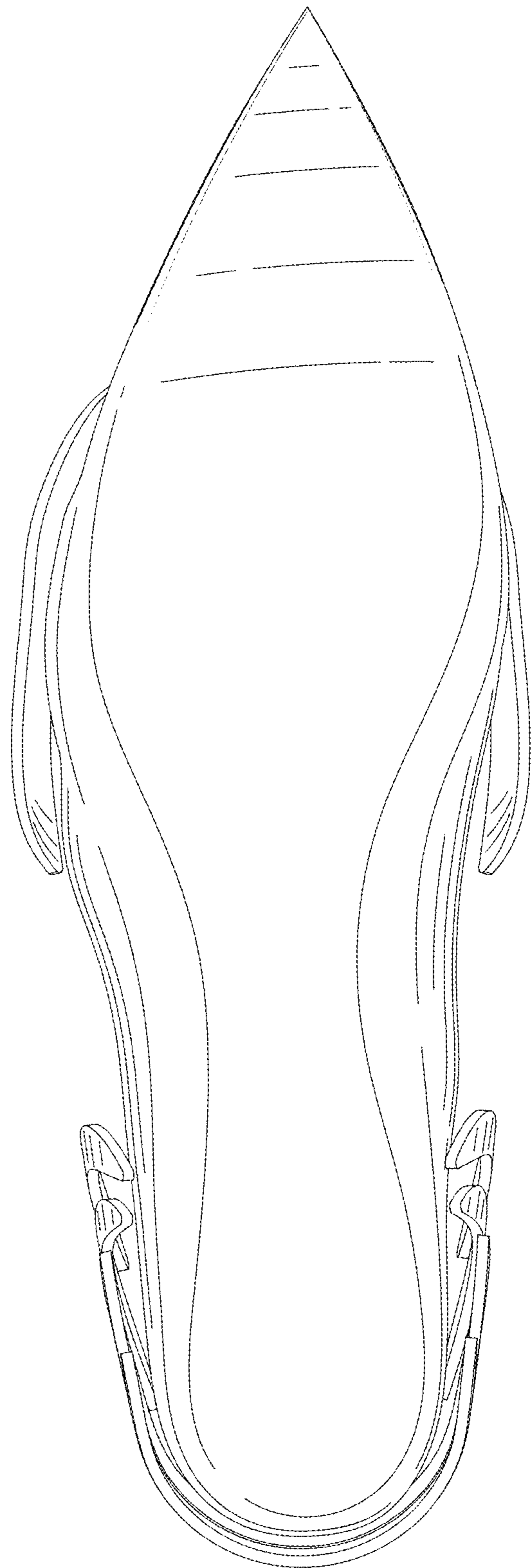

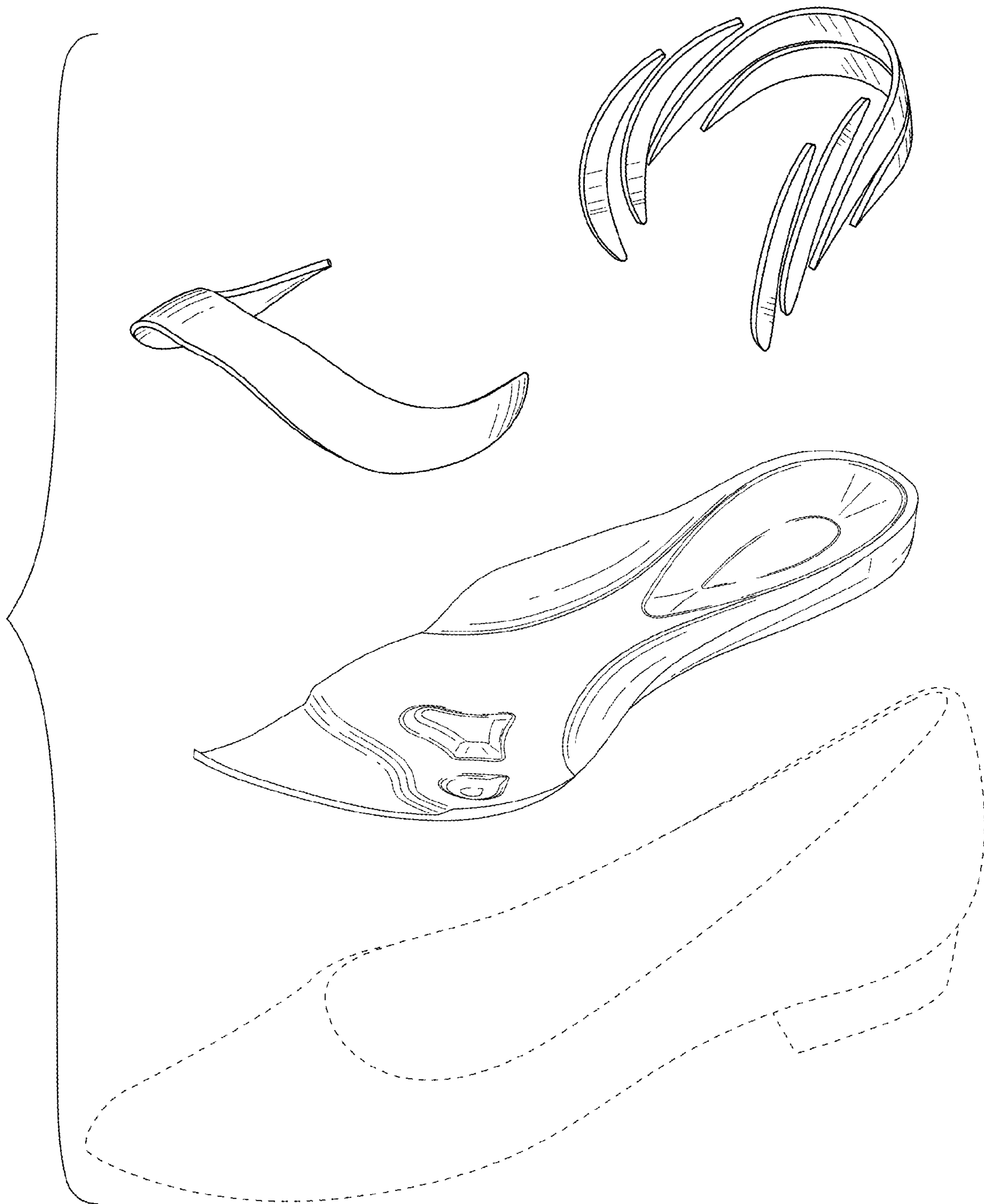
