**DESCRIPTION**

FIG. 1 is a front-left-top perspective view of an item storage bag showing my new design;

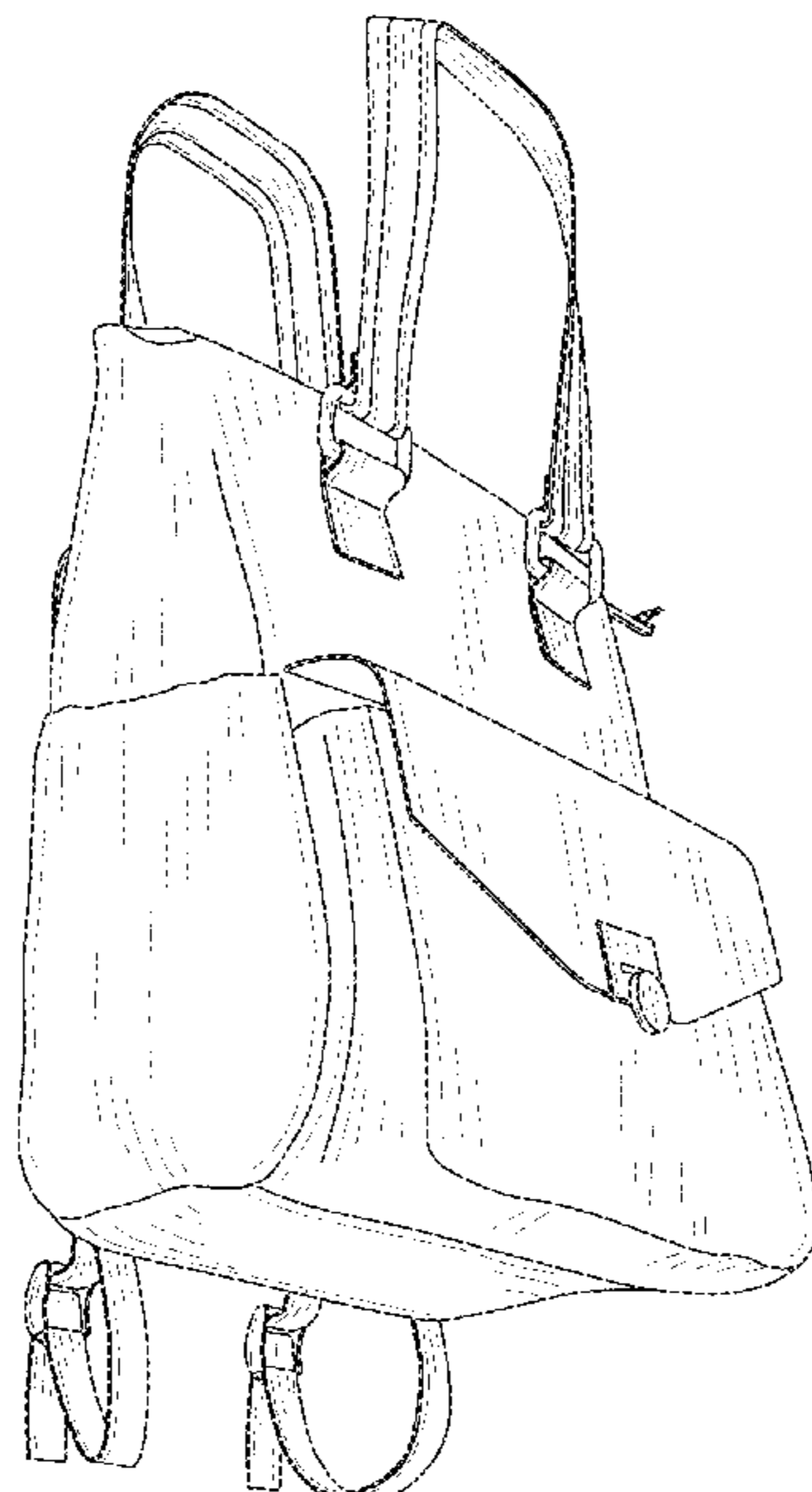

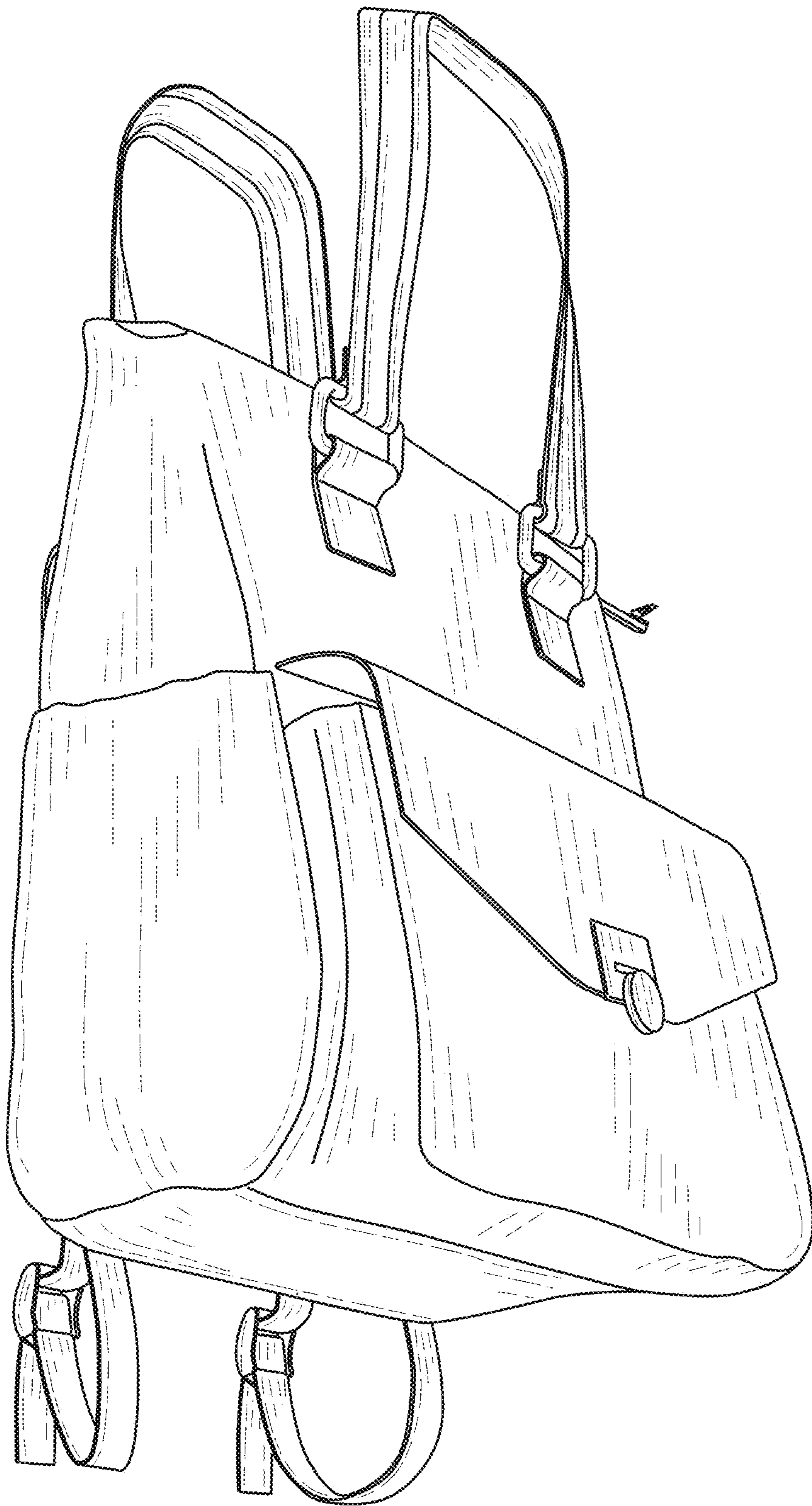

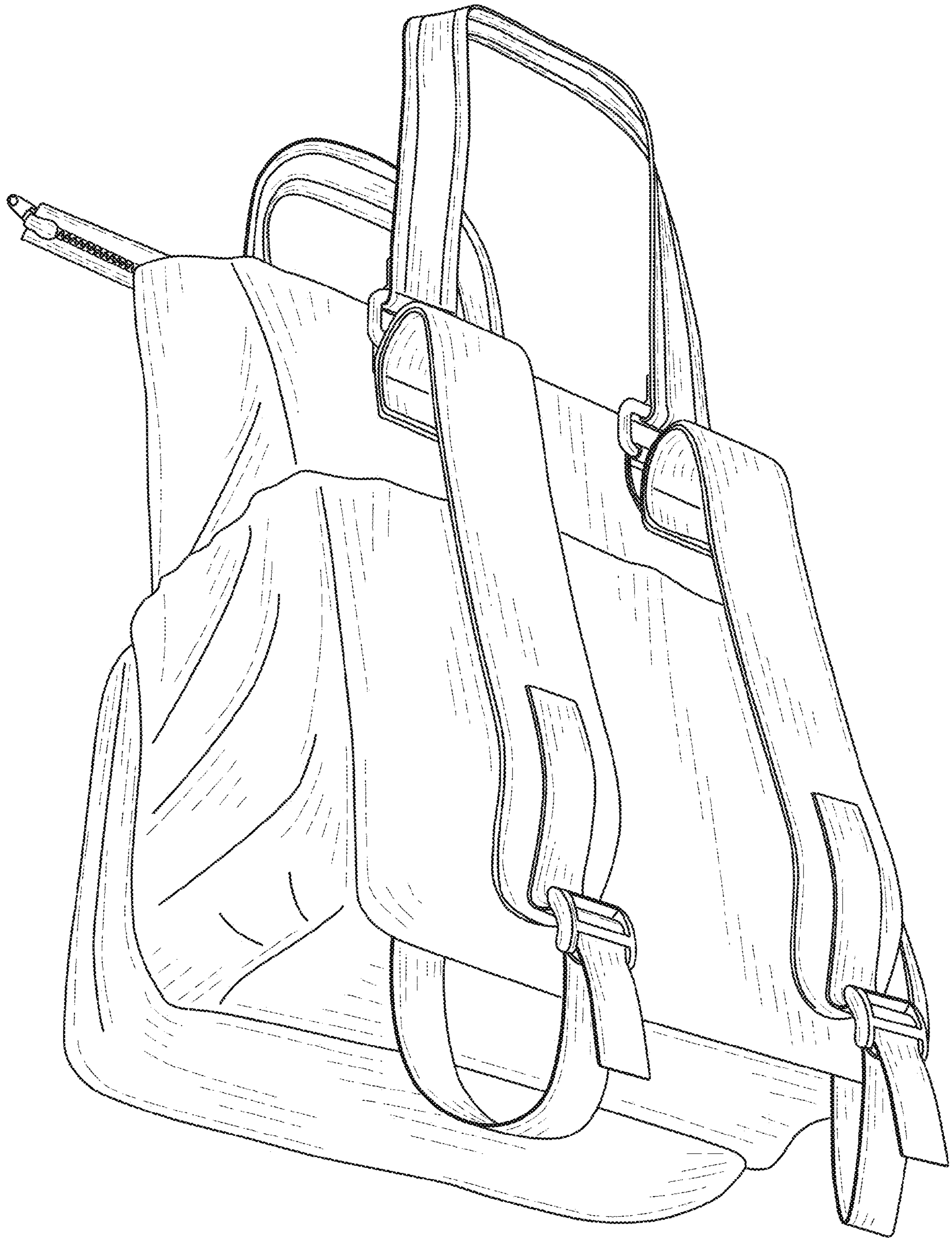

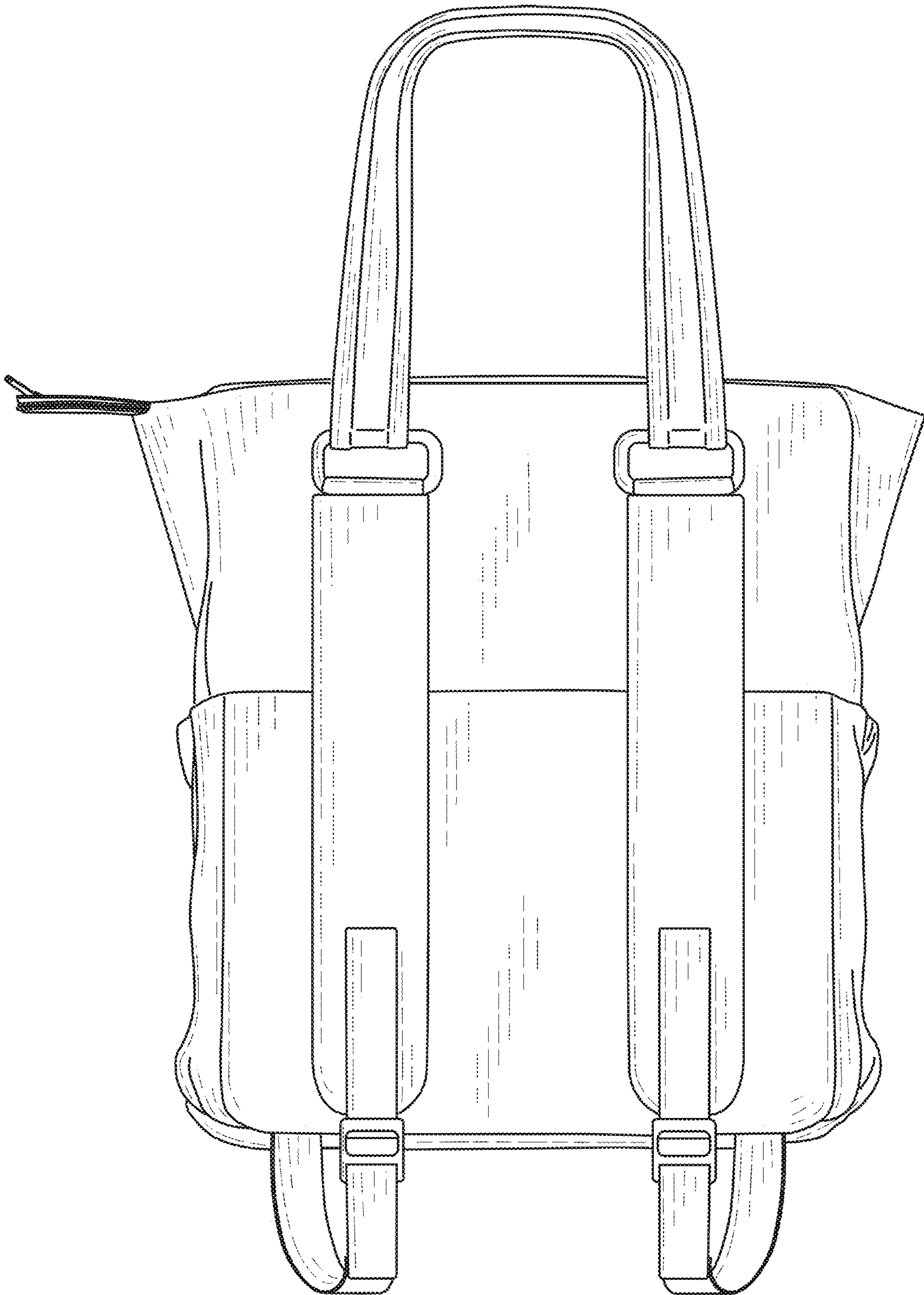

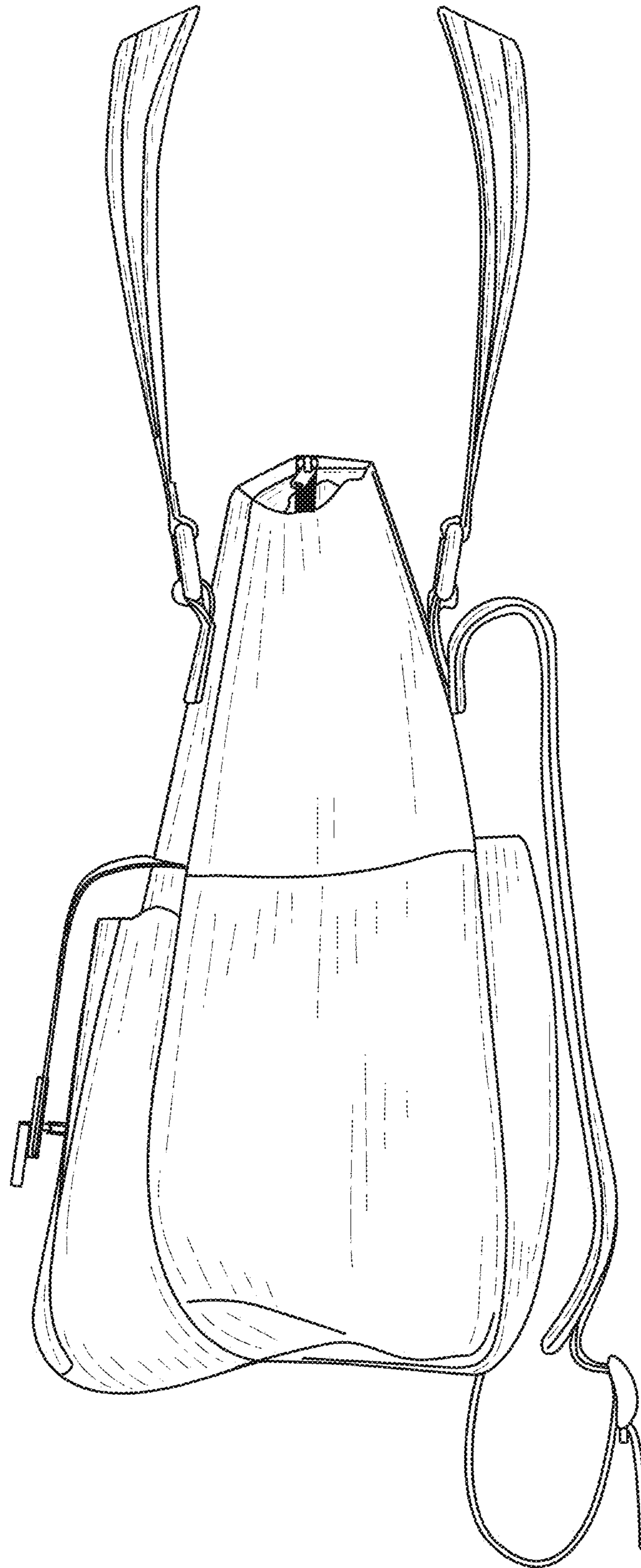

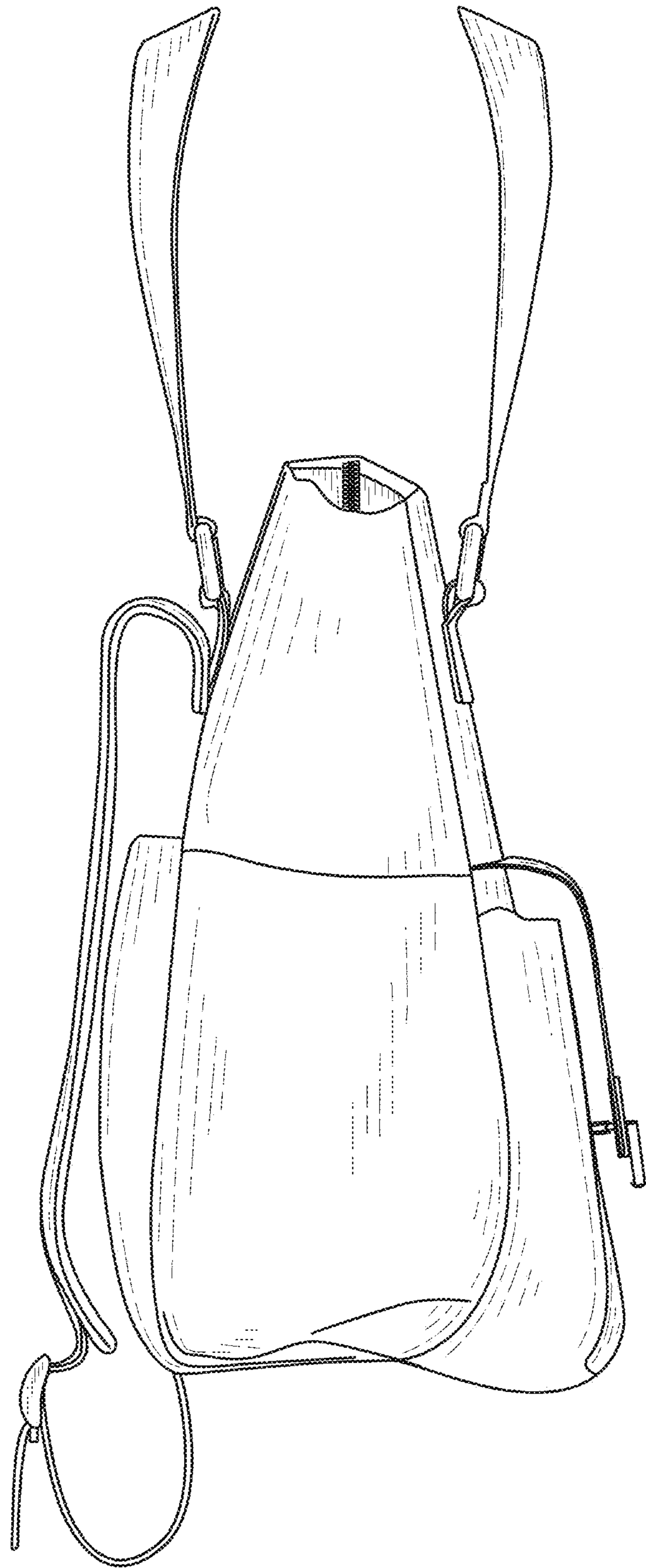

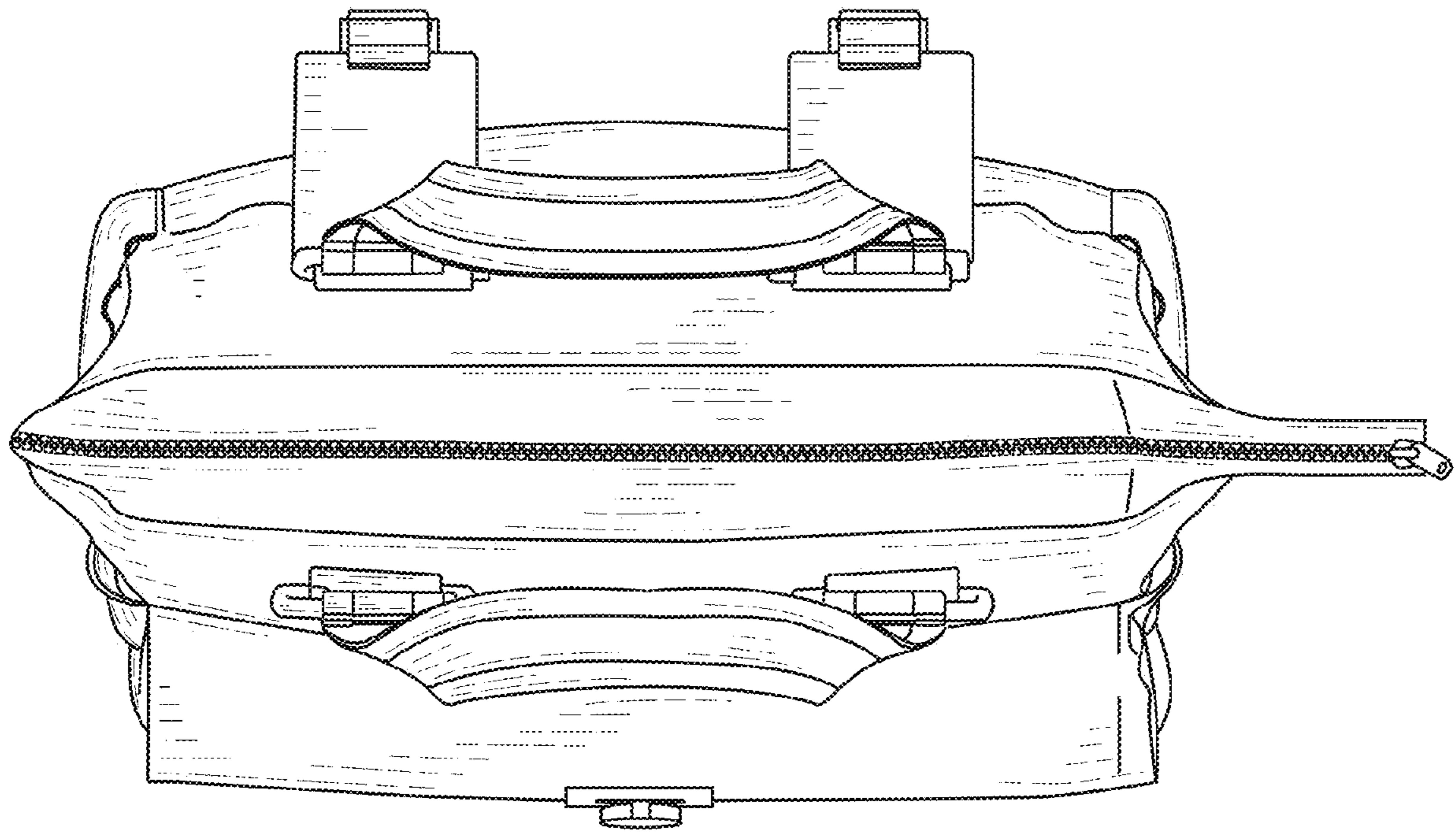

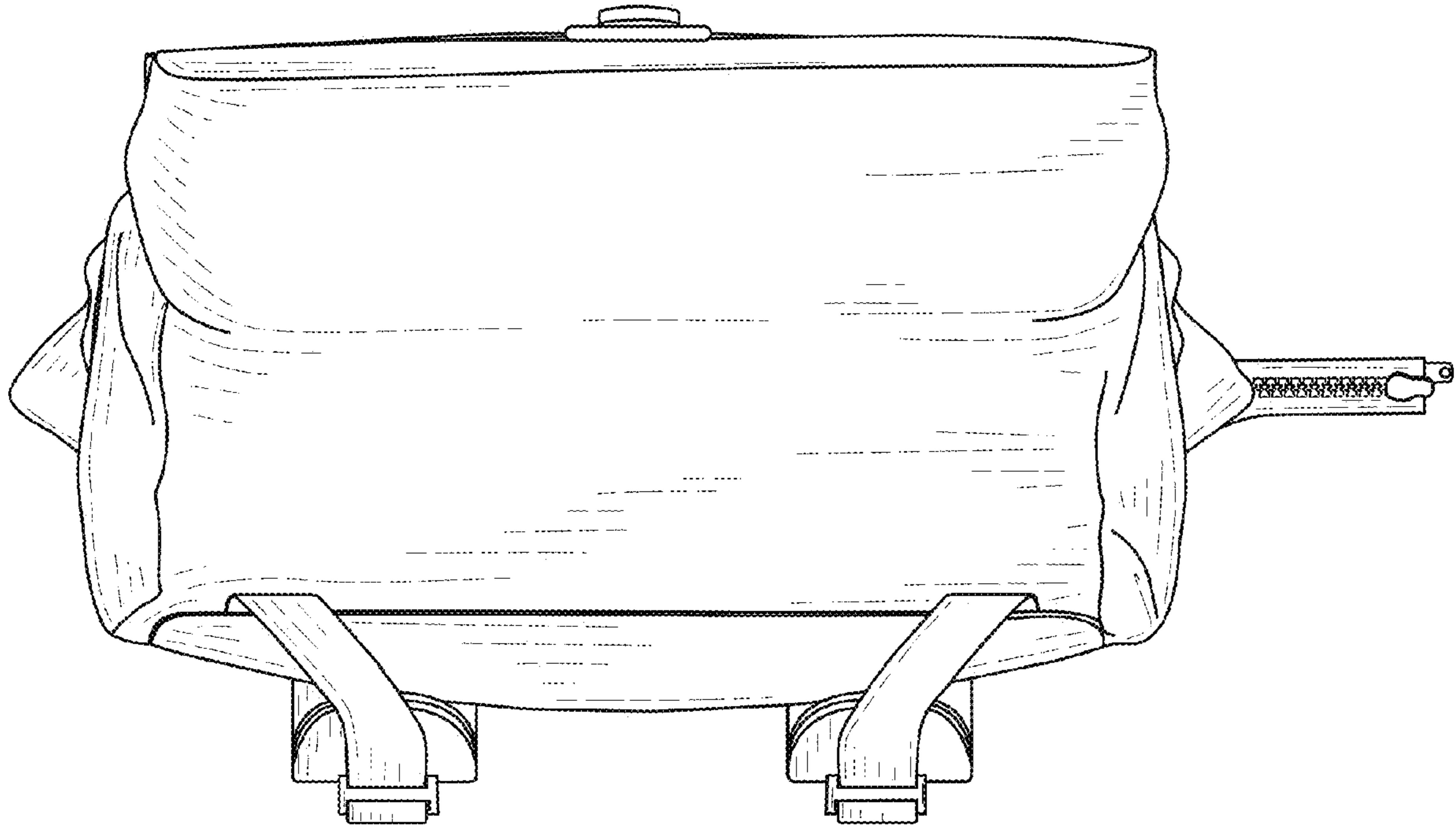
