DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a luggage;

FIG. 2 is a front view of the embodiment of the luggage of FIG. 1;

FIG. 3 is a rear view of the embodiment of the luggage of FIG. 1;

FIG. 4 is a right side view of the embodiment of the luggage of FIG. 1;

FIG. 5 is a left side view of the embodiment of the luggage of FIG. 1;

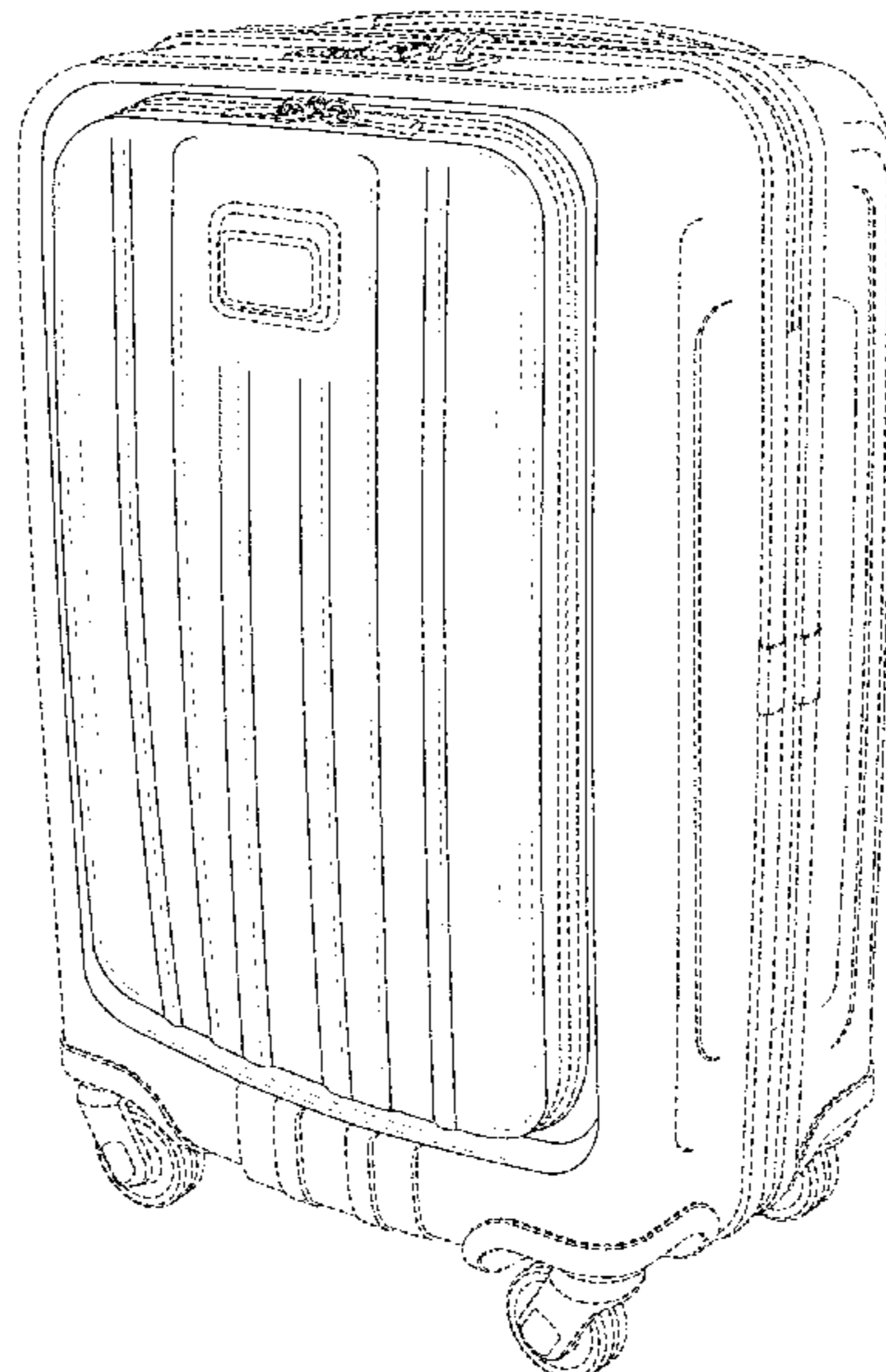
FIG. 6 is a top view of the embodiment of the luggage of FIG. 1; and,

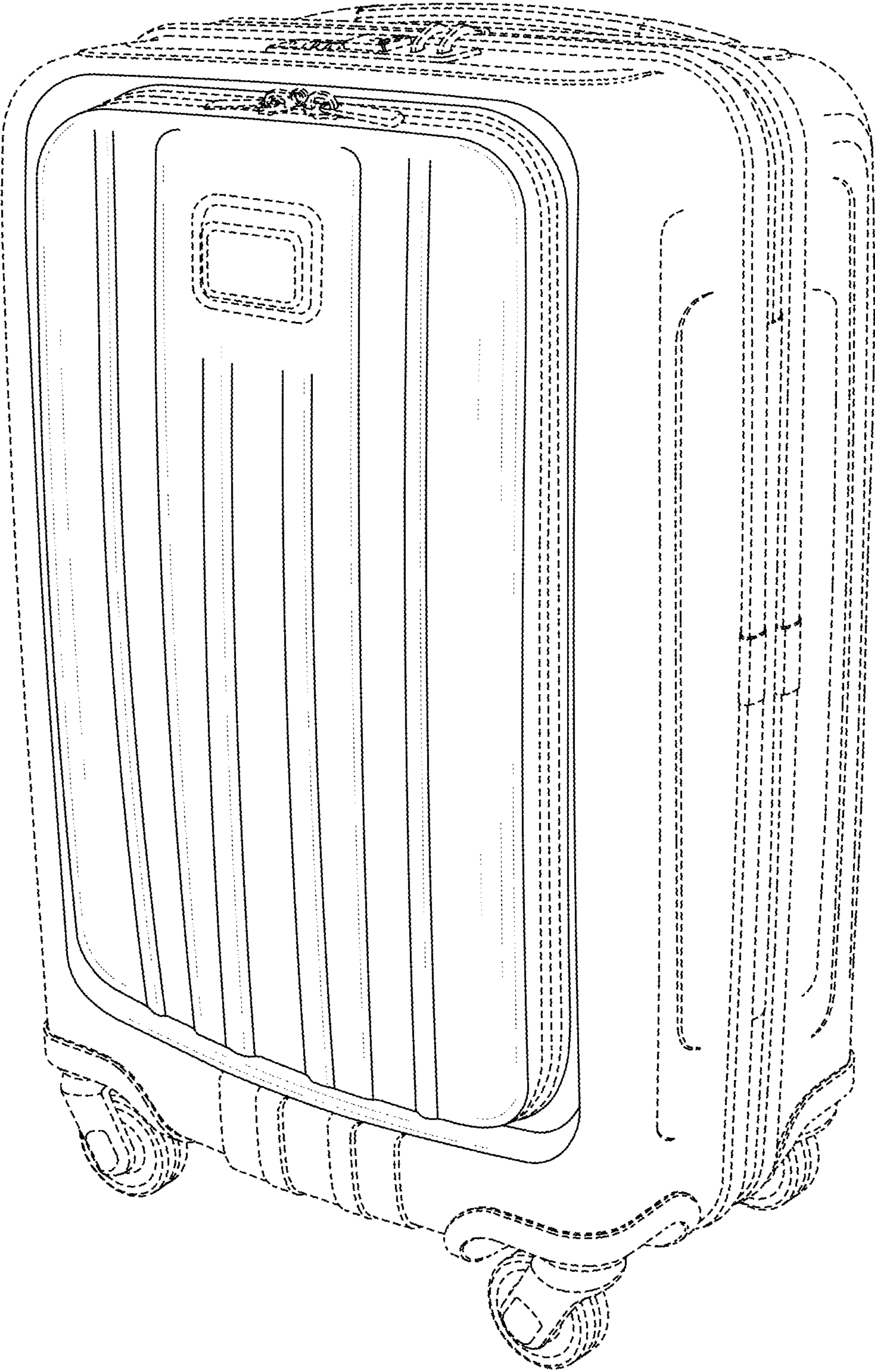

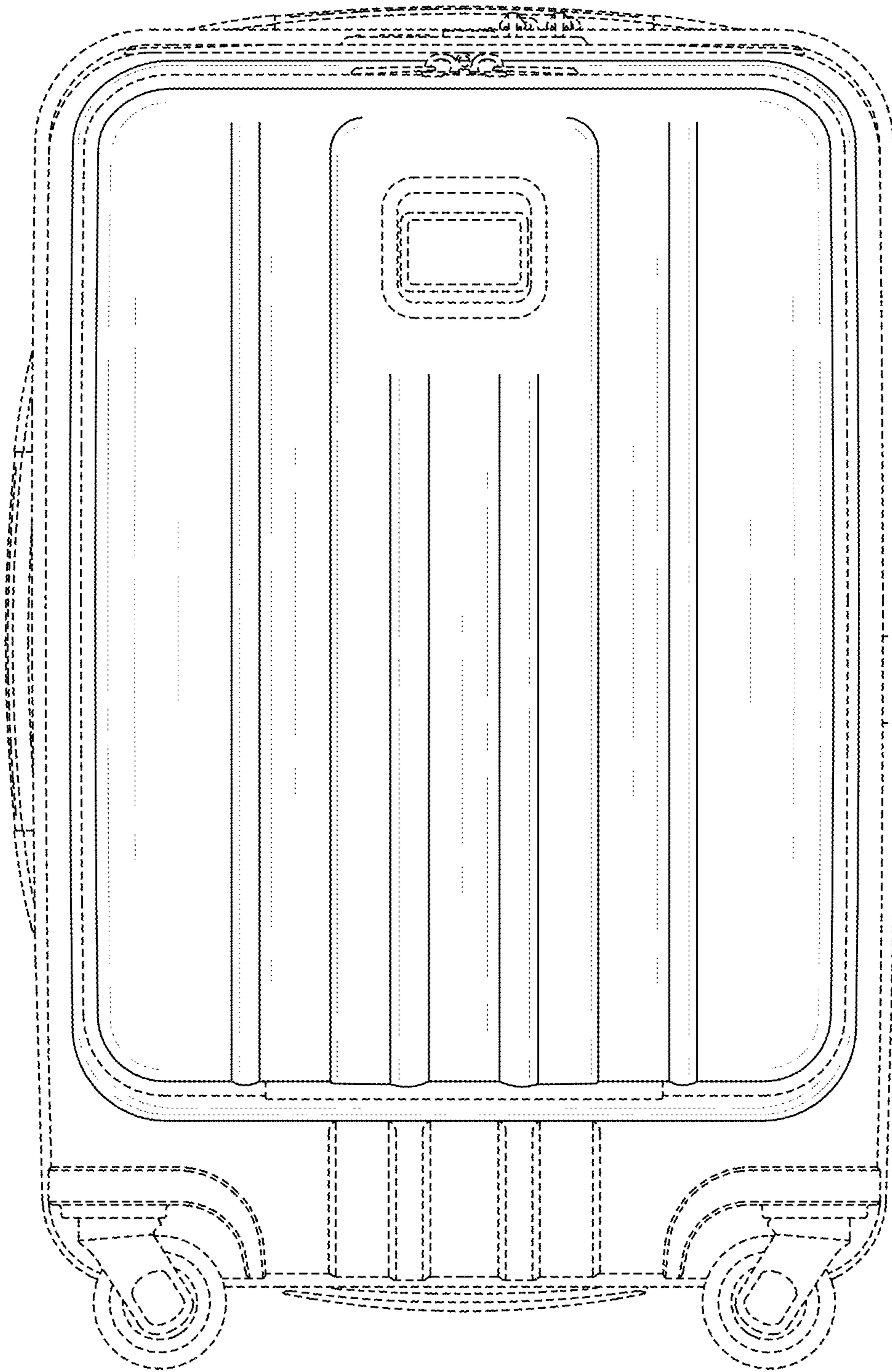

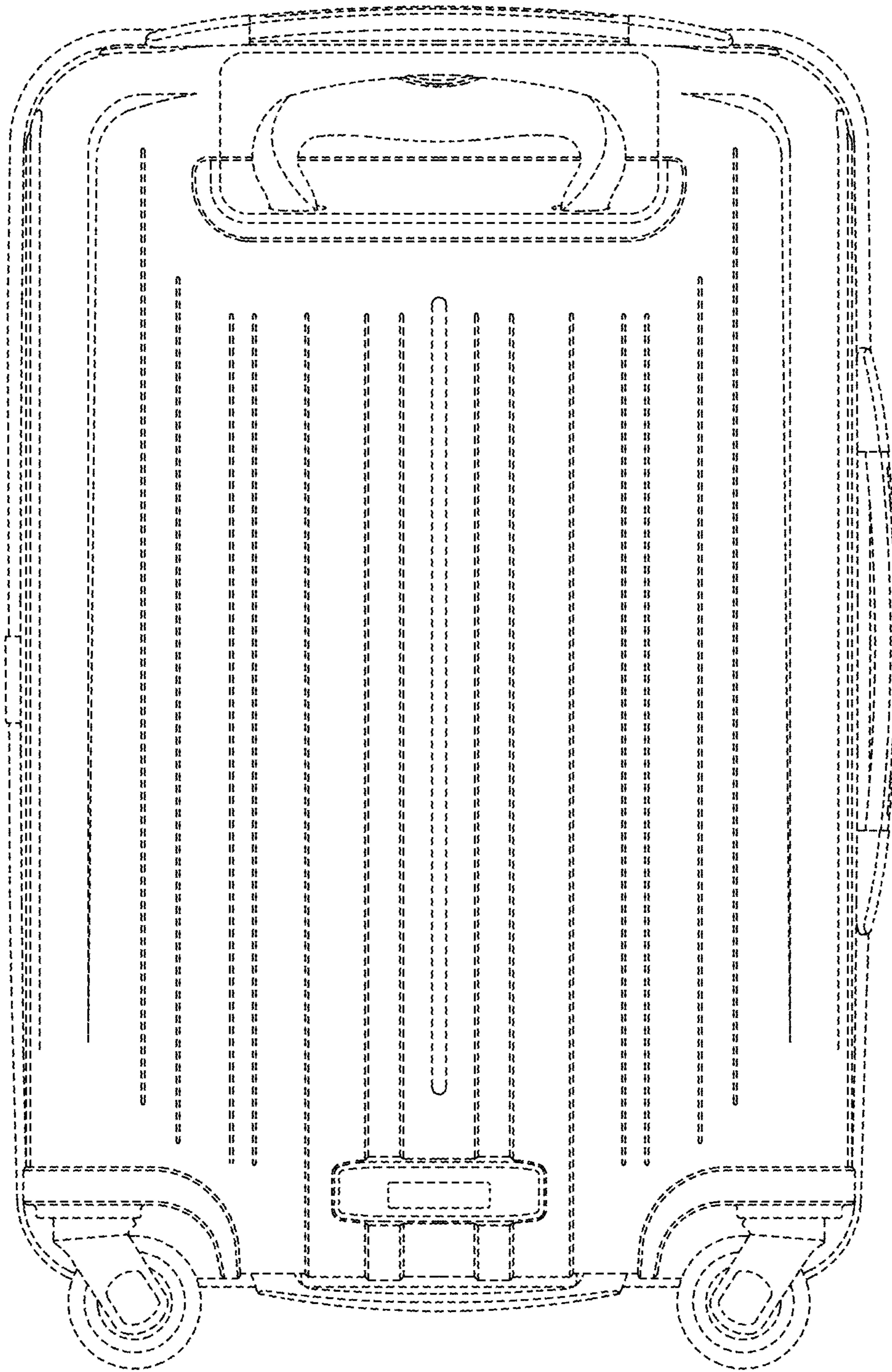

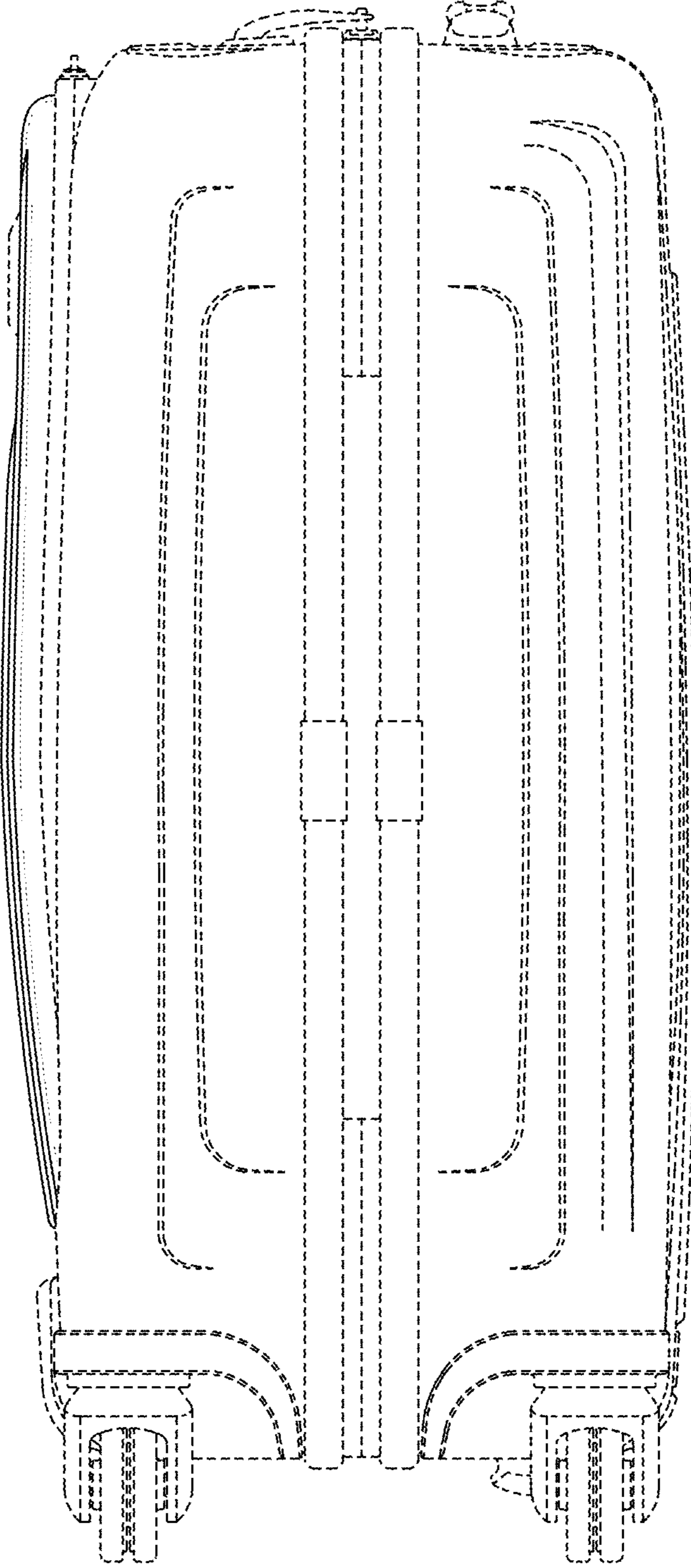

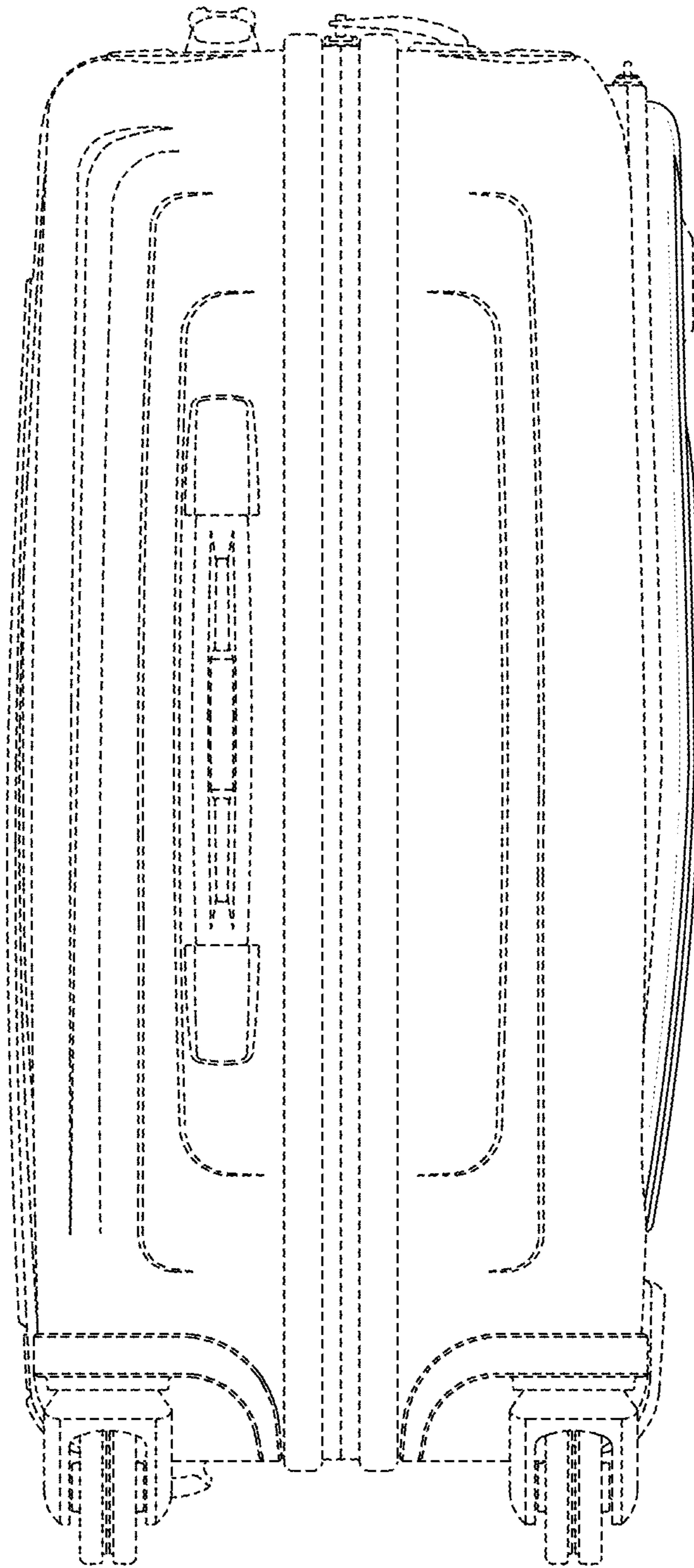

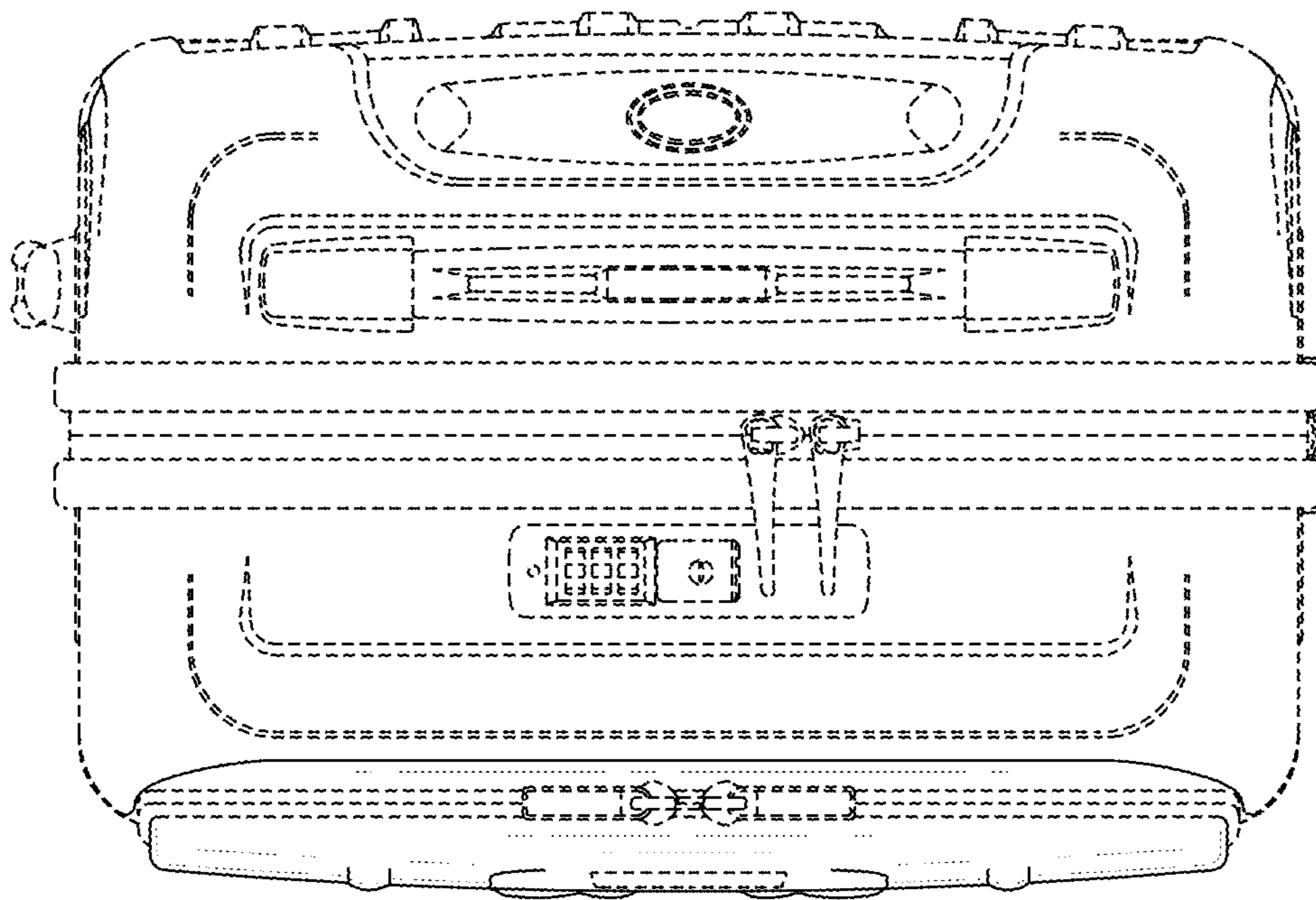

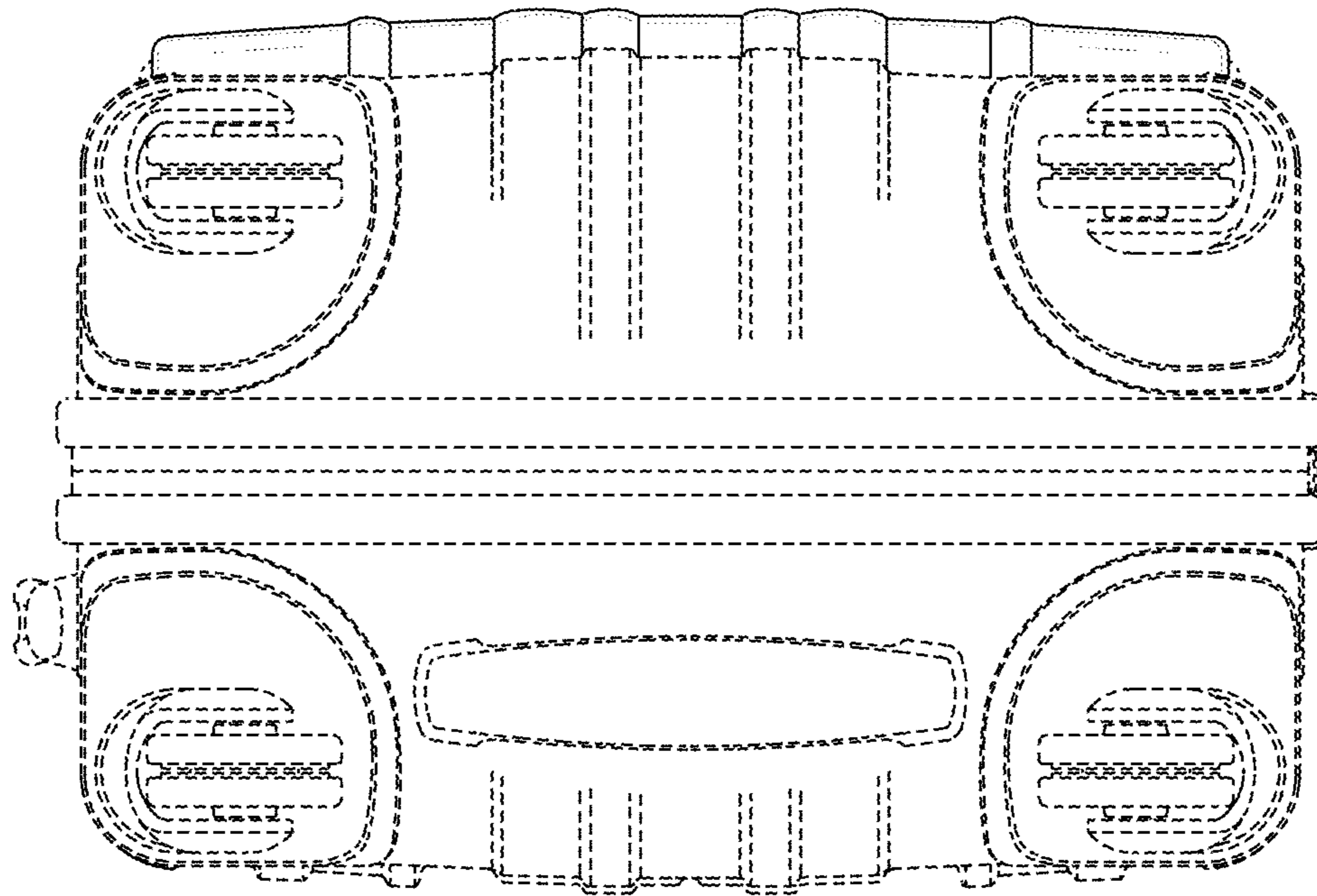
