FIG. 1 is a perspective view of the flower stand showing my new design.

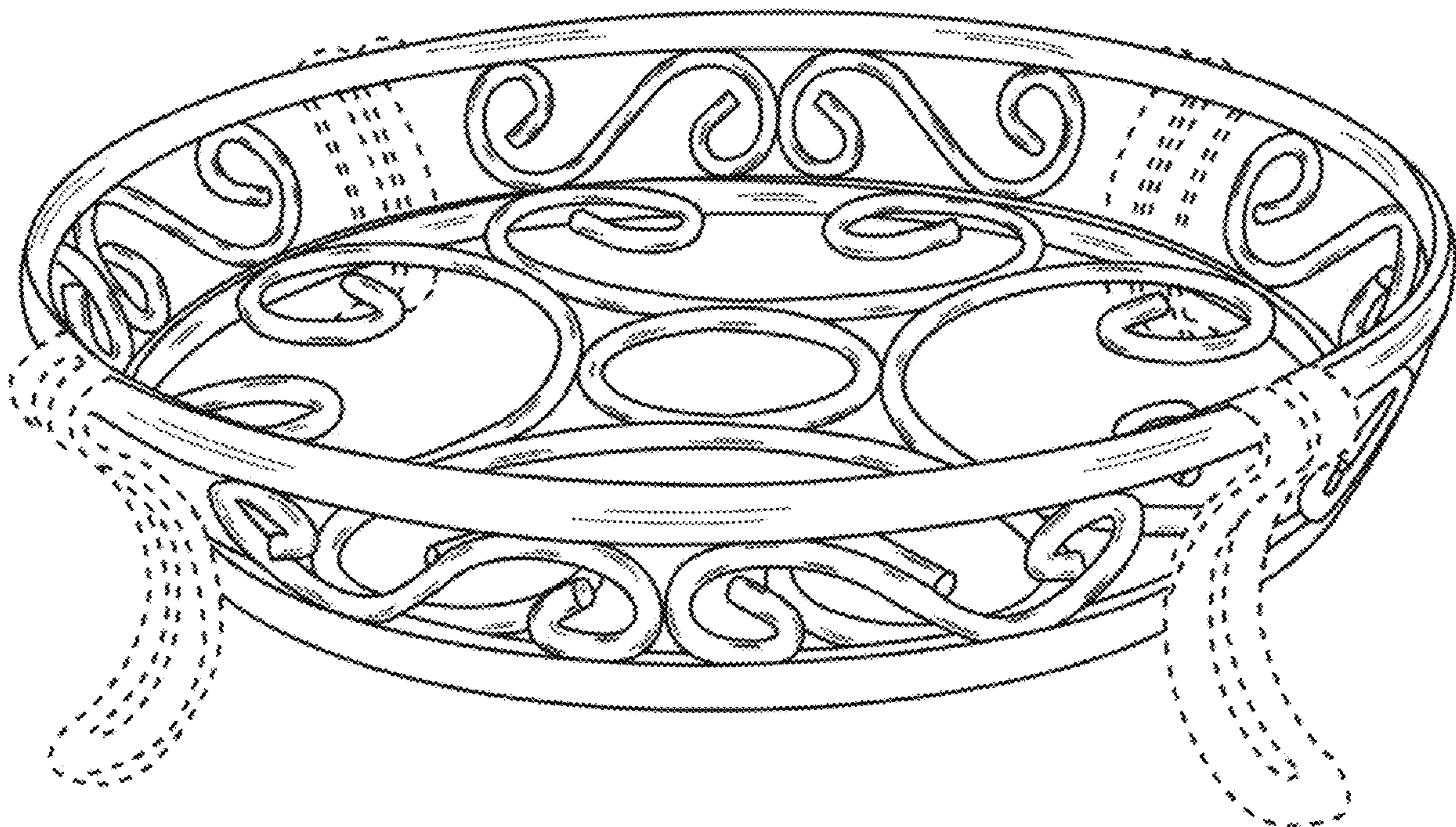
FIG. 2 is a front, rear, left side, or right side elevational view thereof;

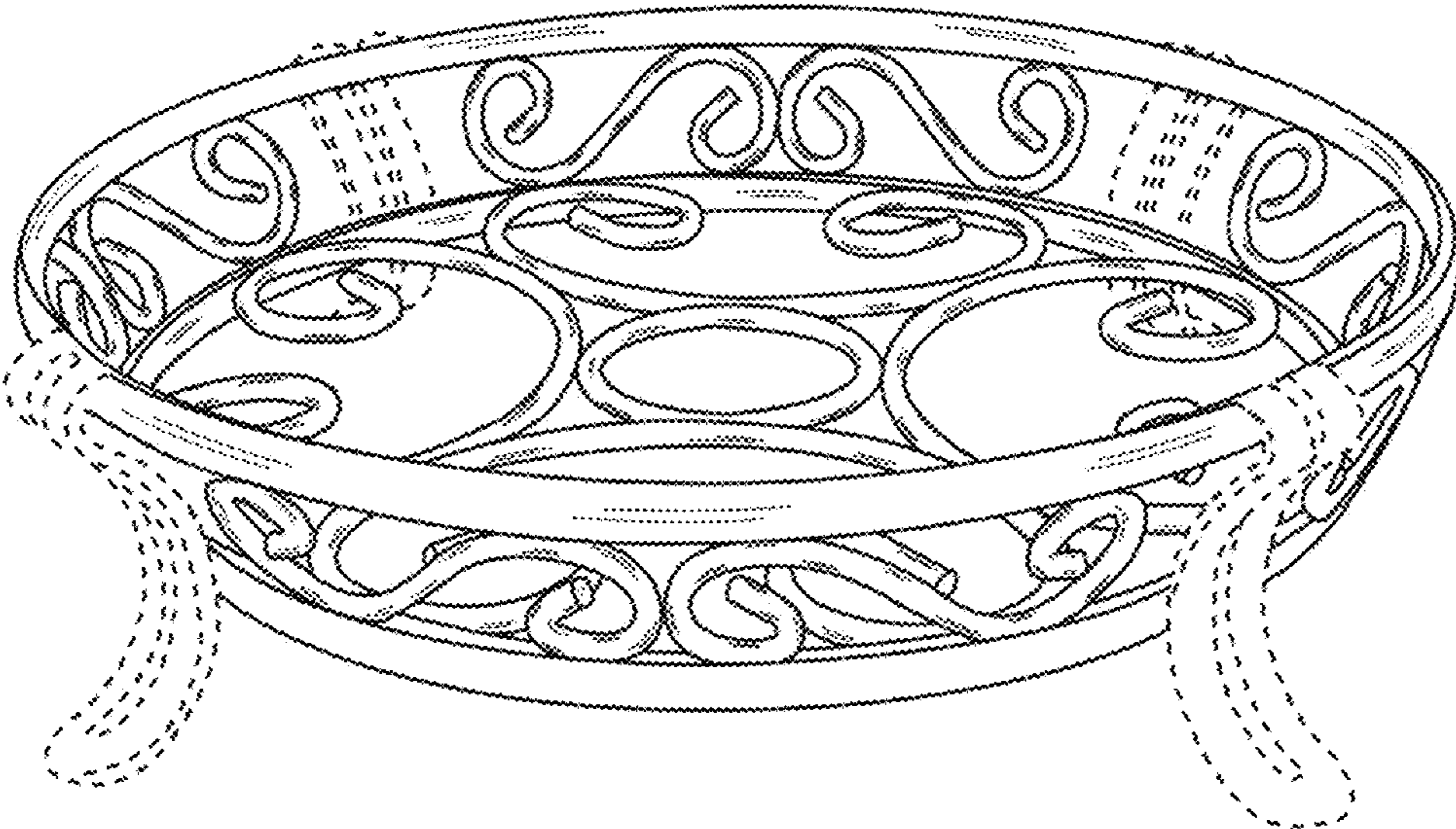

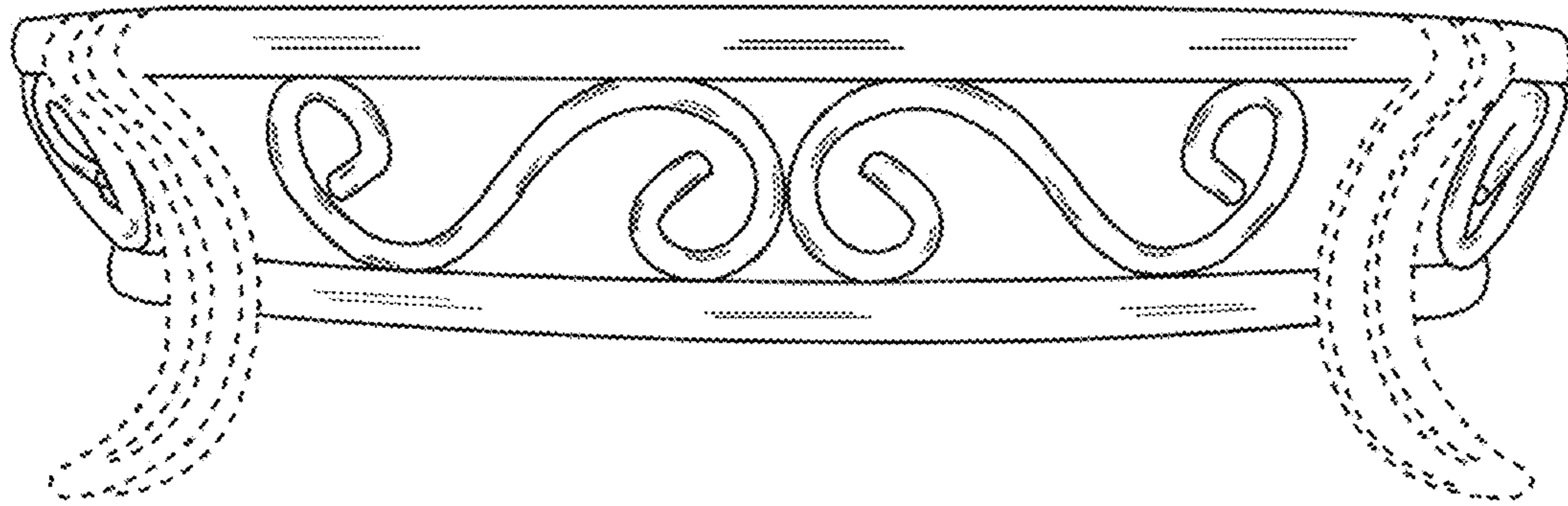

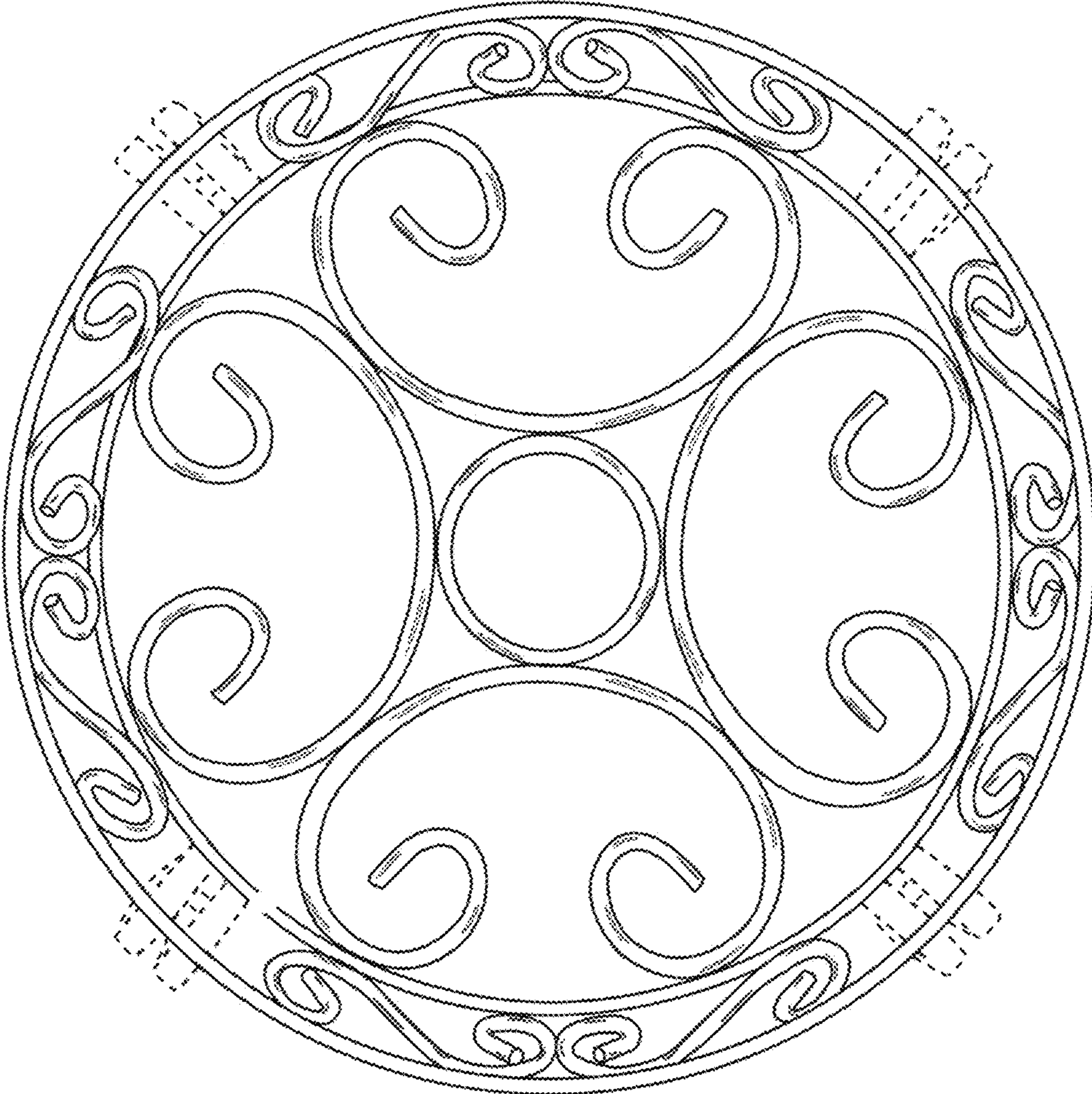

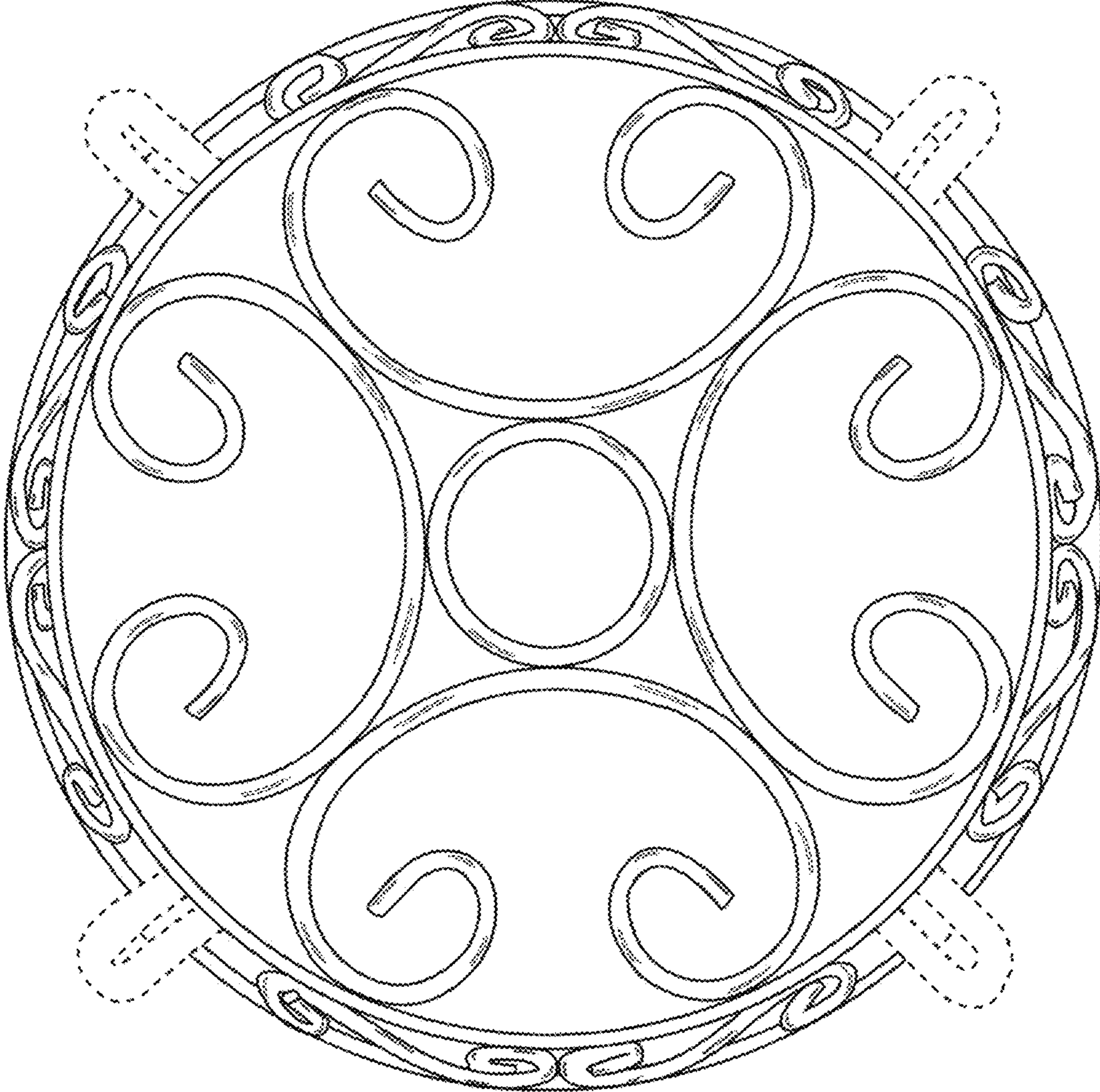
