(57) **CLAIM**

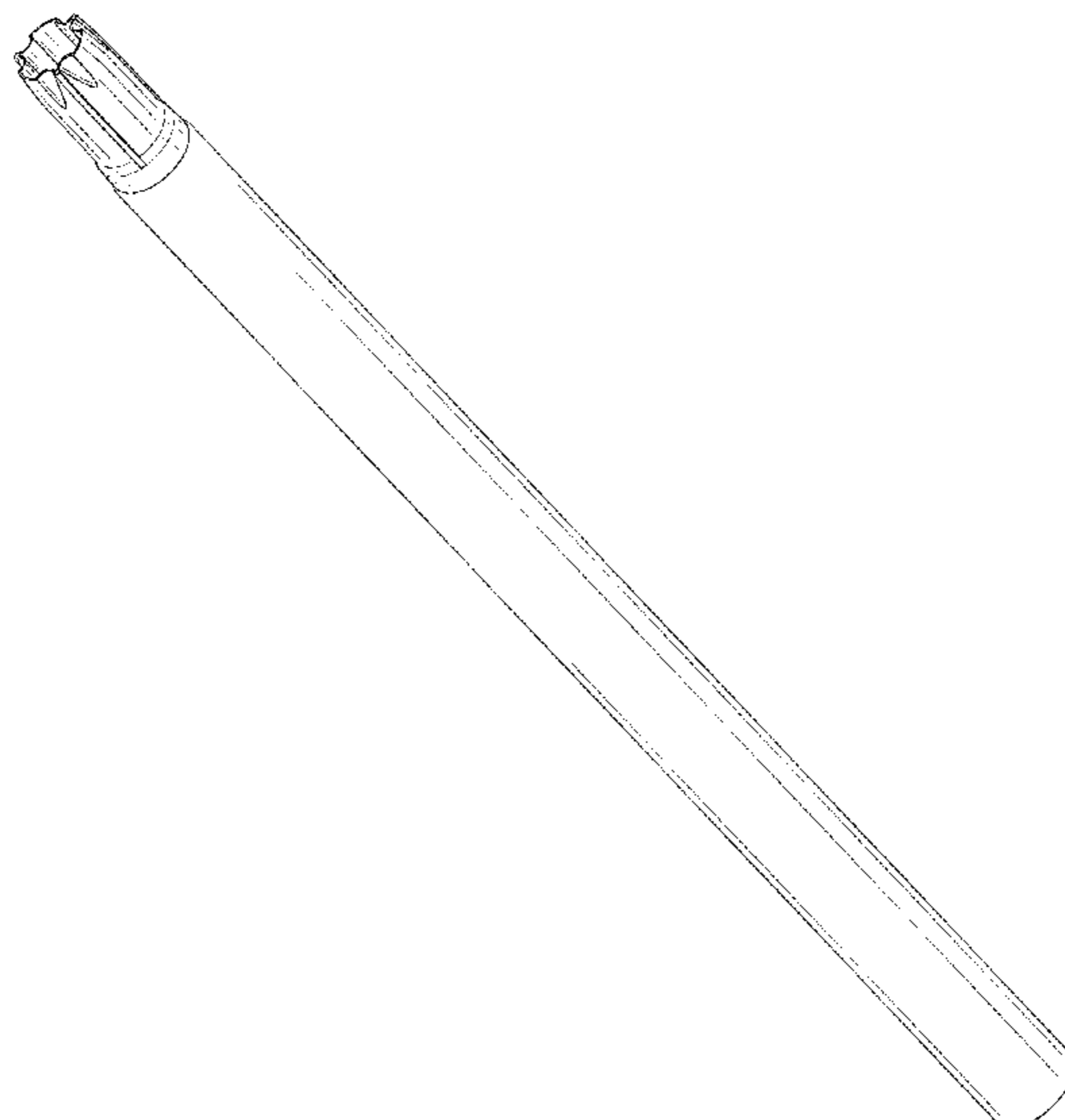
The ornamental design for a rod of a garment rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a rod of a garment rack showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof;  
FIG. 8 is a perspective view of the rod of the garment rack, shown in use attached to another rod of the garment rack;  
FIG. 9 is a perspective view of the rod of the garment rack, shown in use assembled within the garment rack;  
FIG. 10 is a front view thereof;  
FIG. 11 is a rear view thereof;  
FIG. 12 is a left side view thereof;  
FIG. 13 is a right side view thereof;  
FIG. 14 is a top view thereof; and,  
FIG. 15 is a bottom view thereof.

The broken line portions of the rod of the garment rack in FIG. 7 represent unclaimed portions of the claimed design and form no part thereof. The broken lines of the another rod of the garment rack in FIG. 8 and the garment rack in FIGS. 9-15 illustrate unclaimed environment and forms no part of the claimed design.

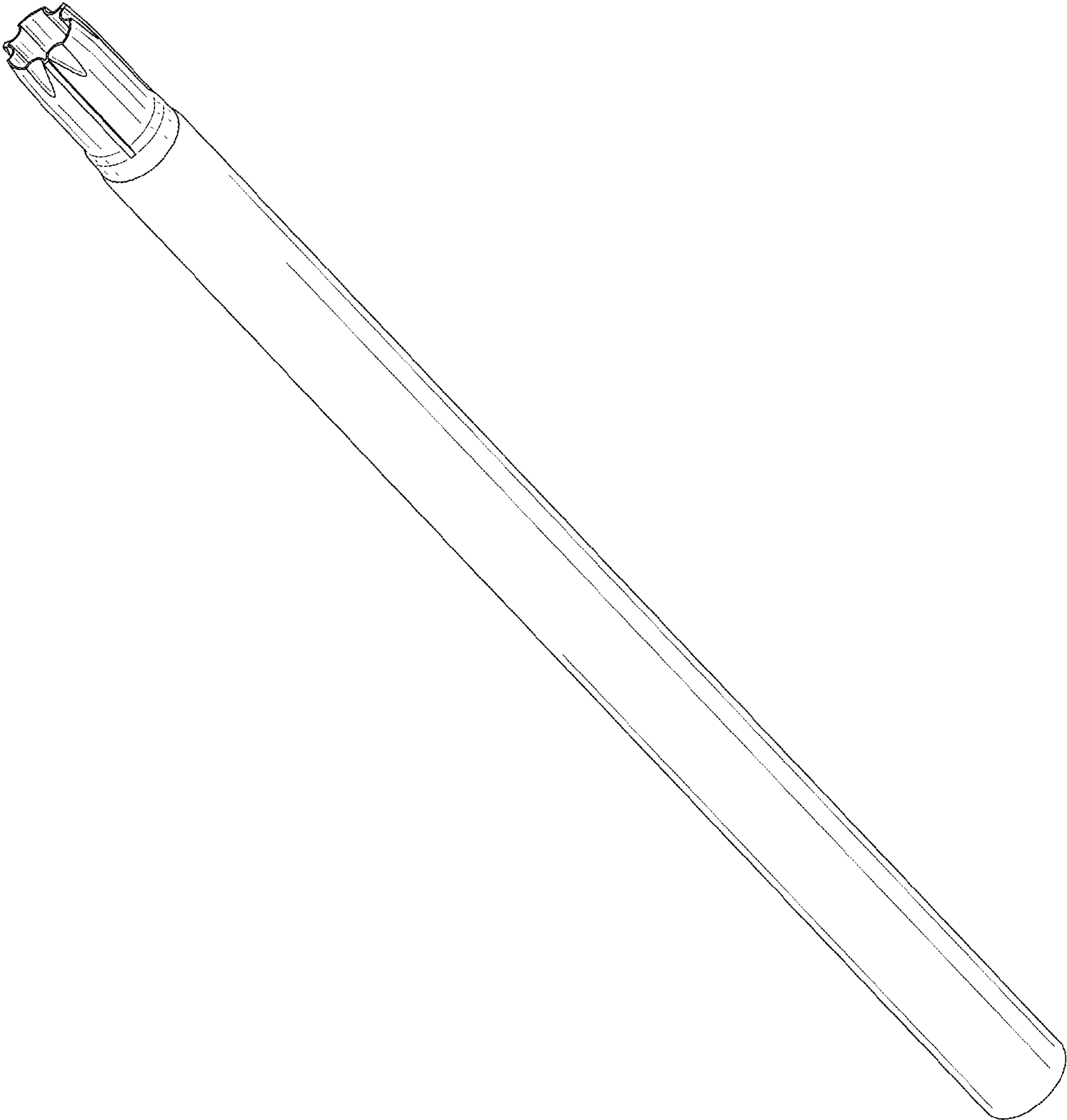

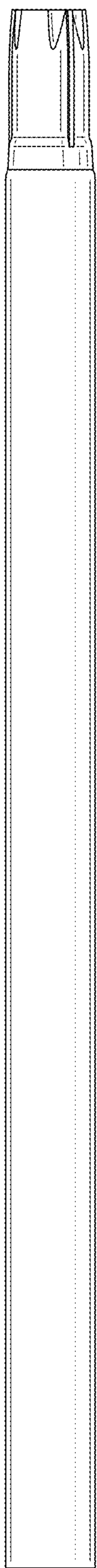

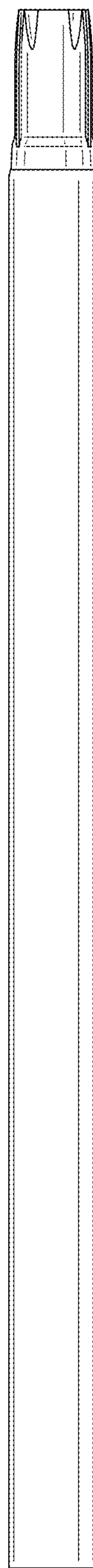

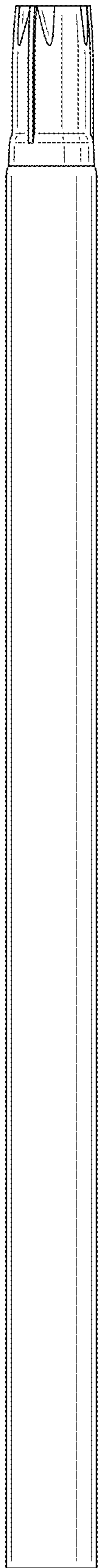

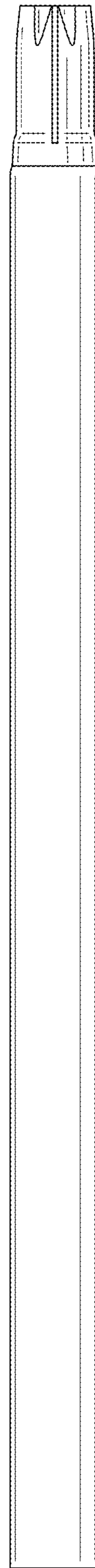

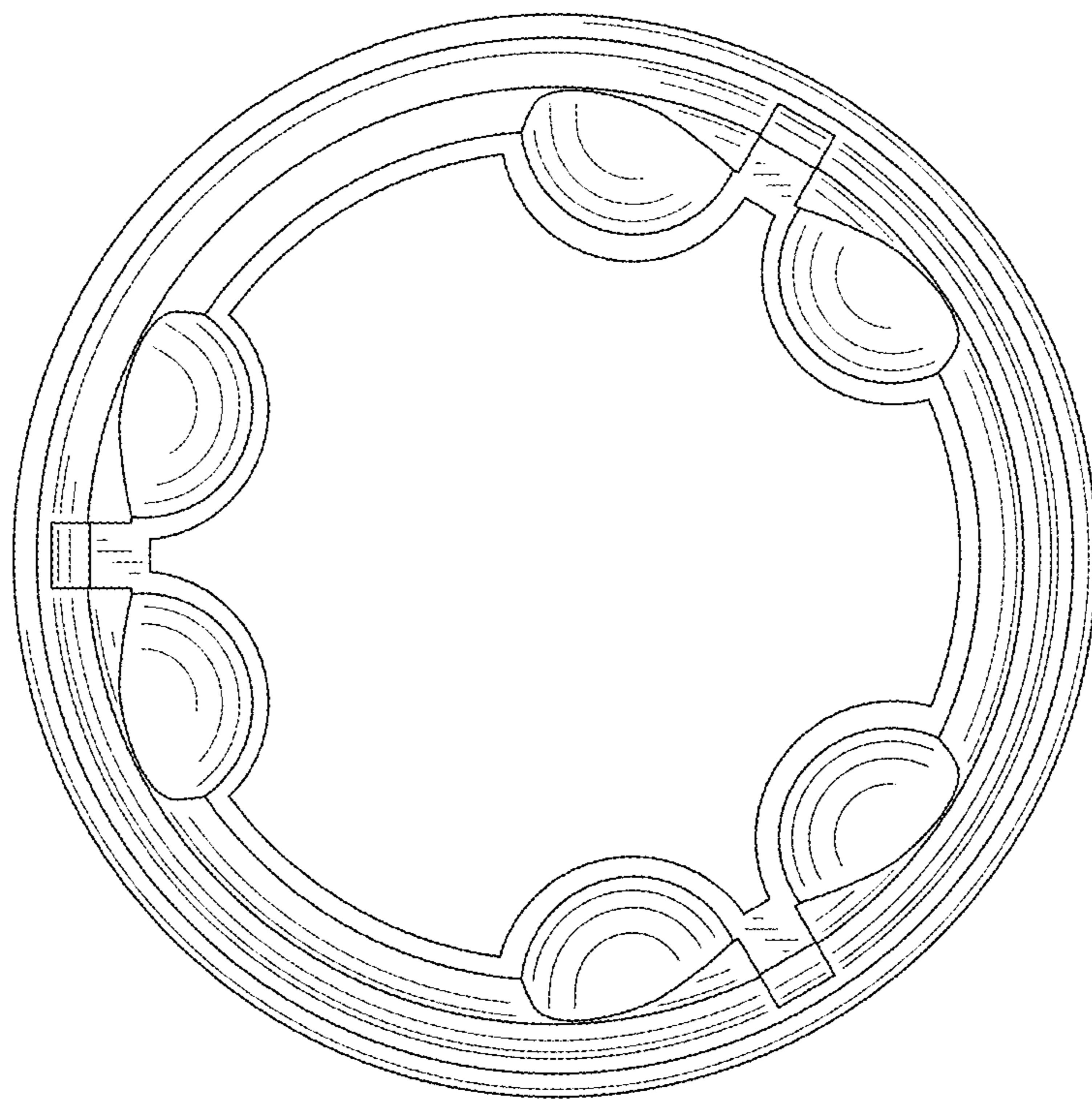

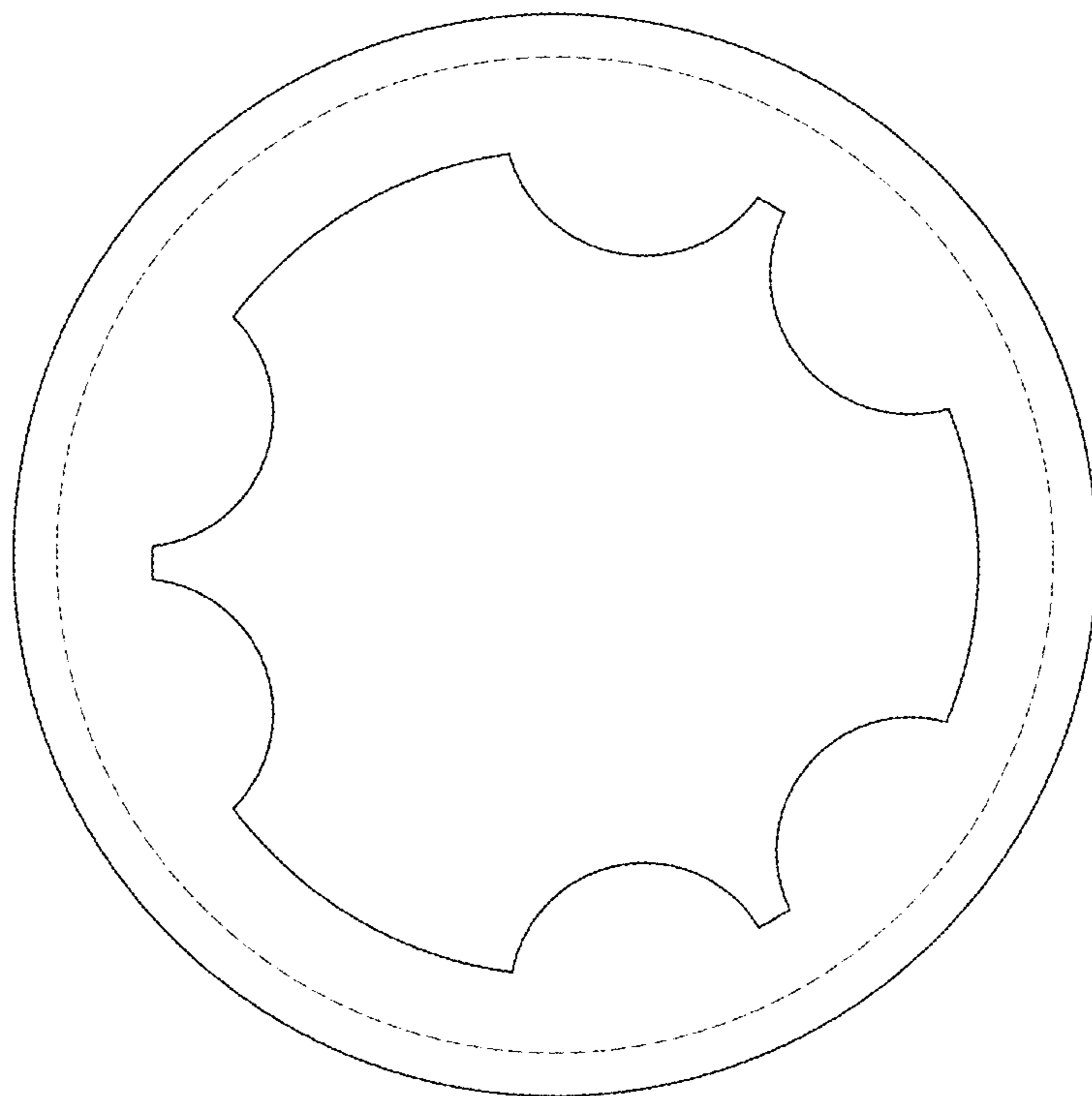

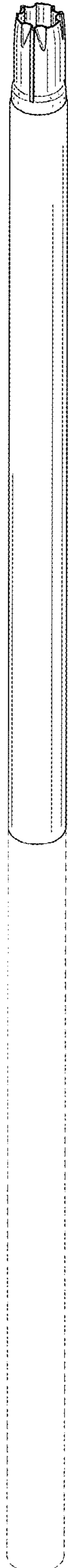

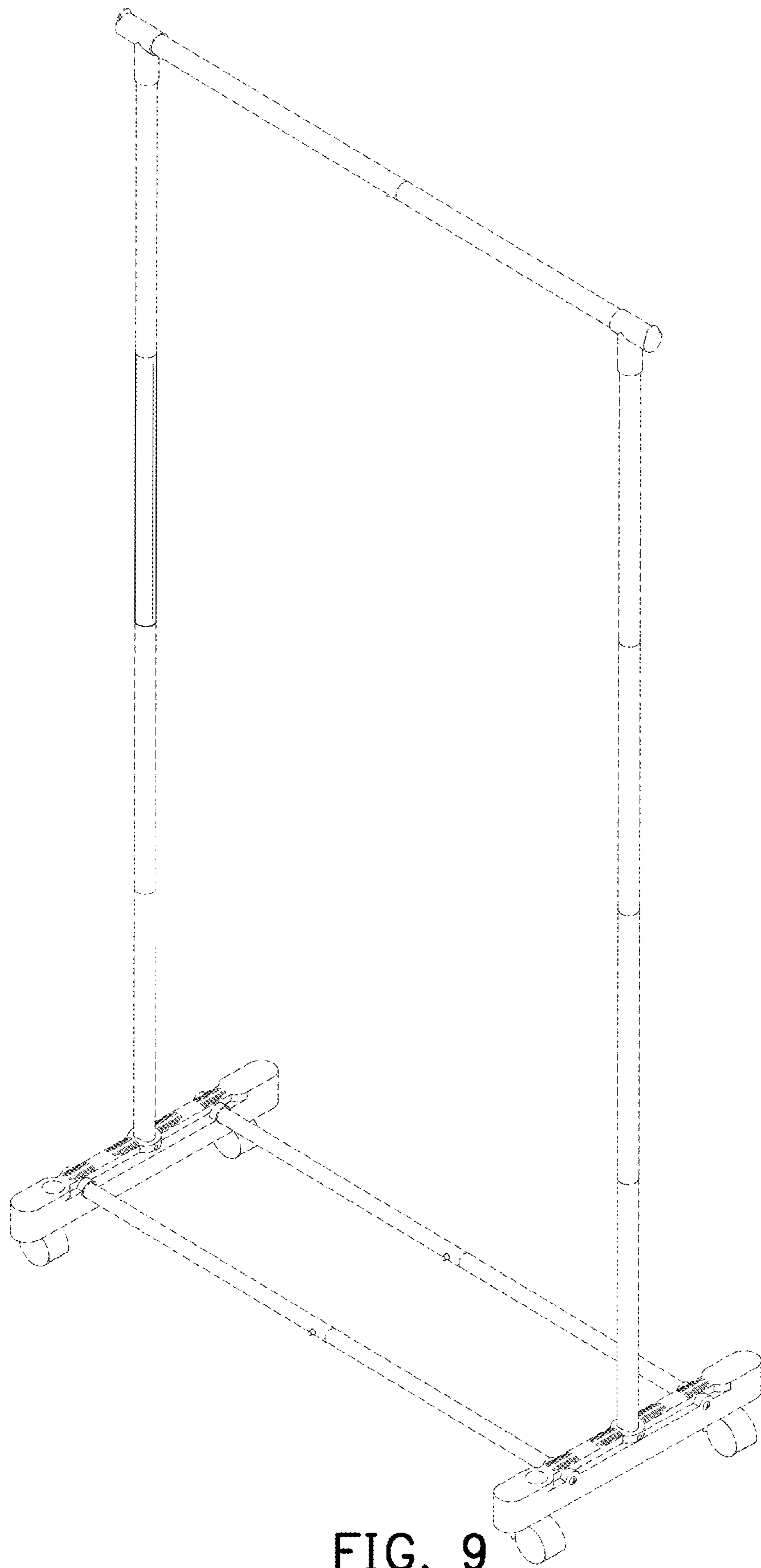

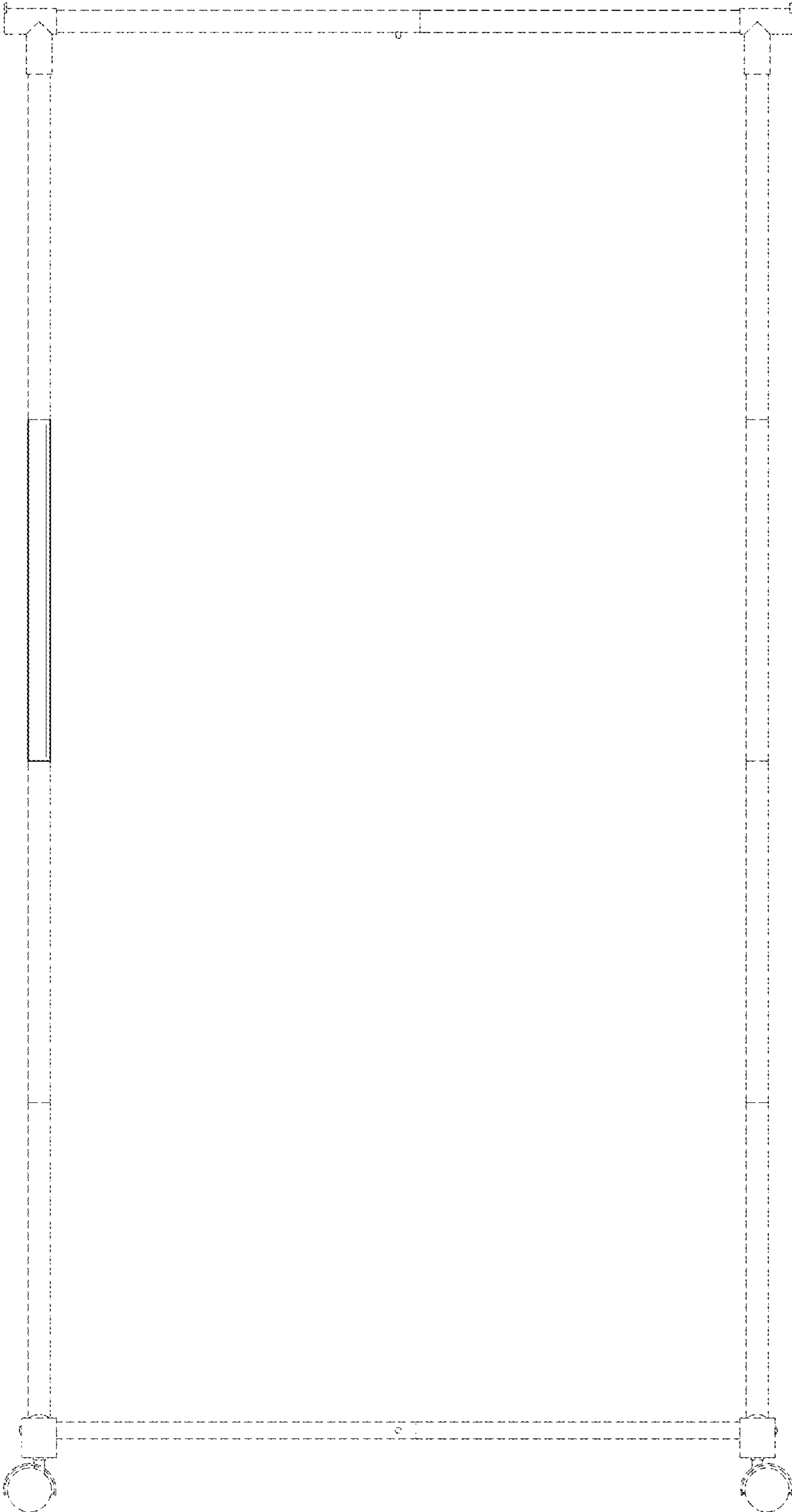

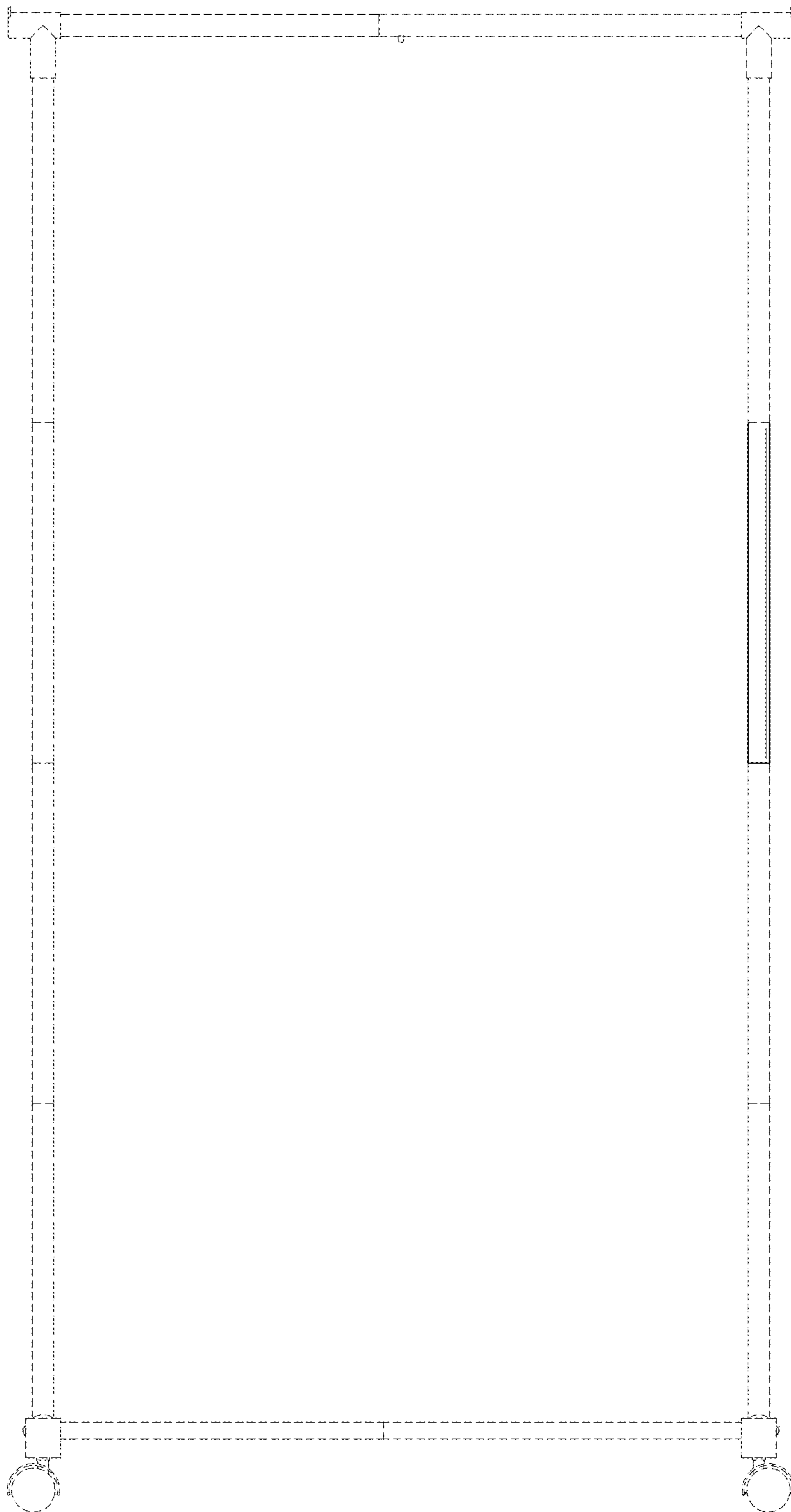

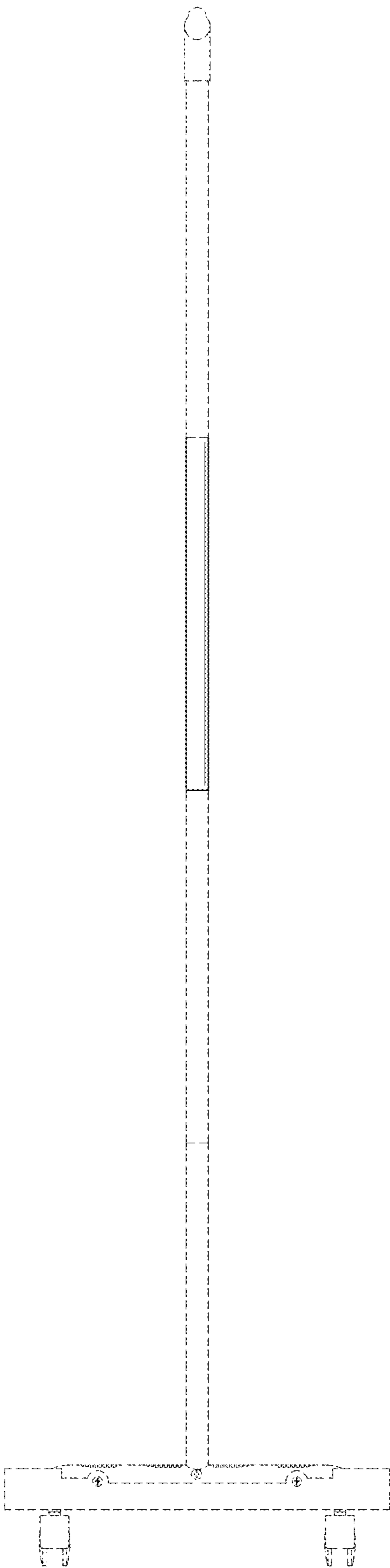

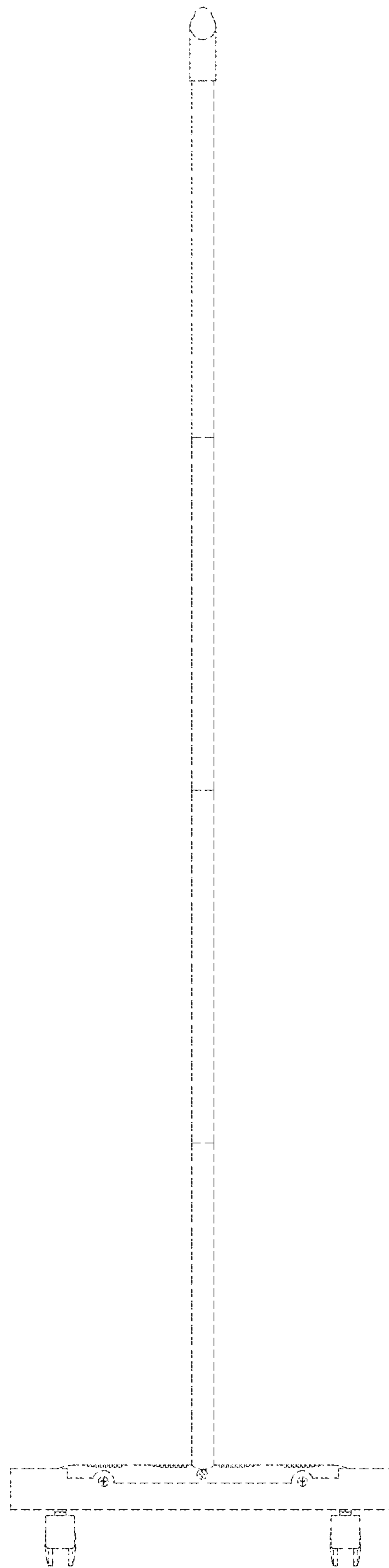

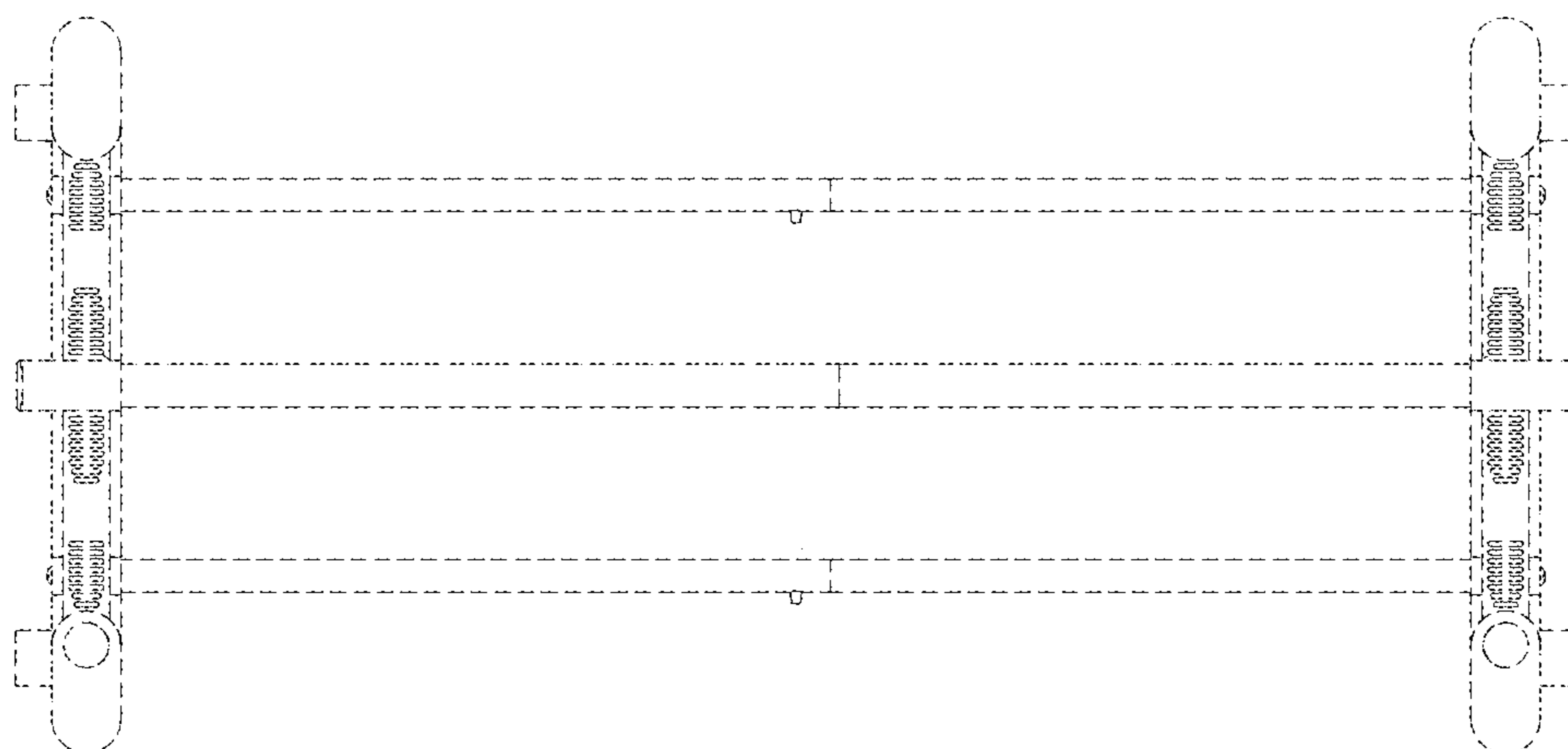

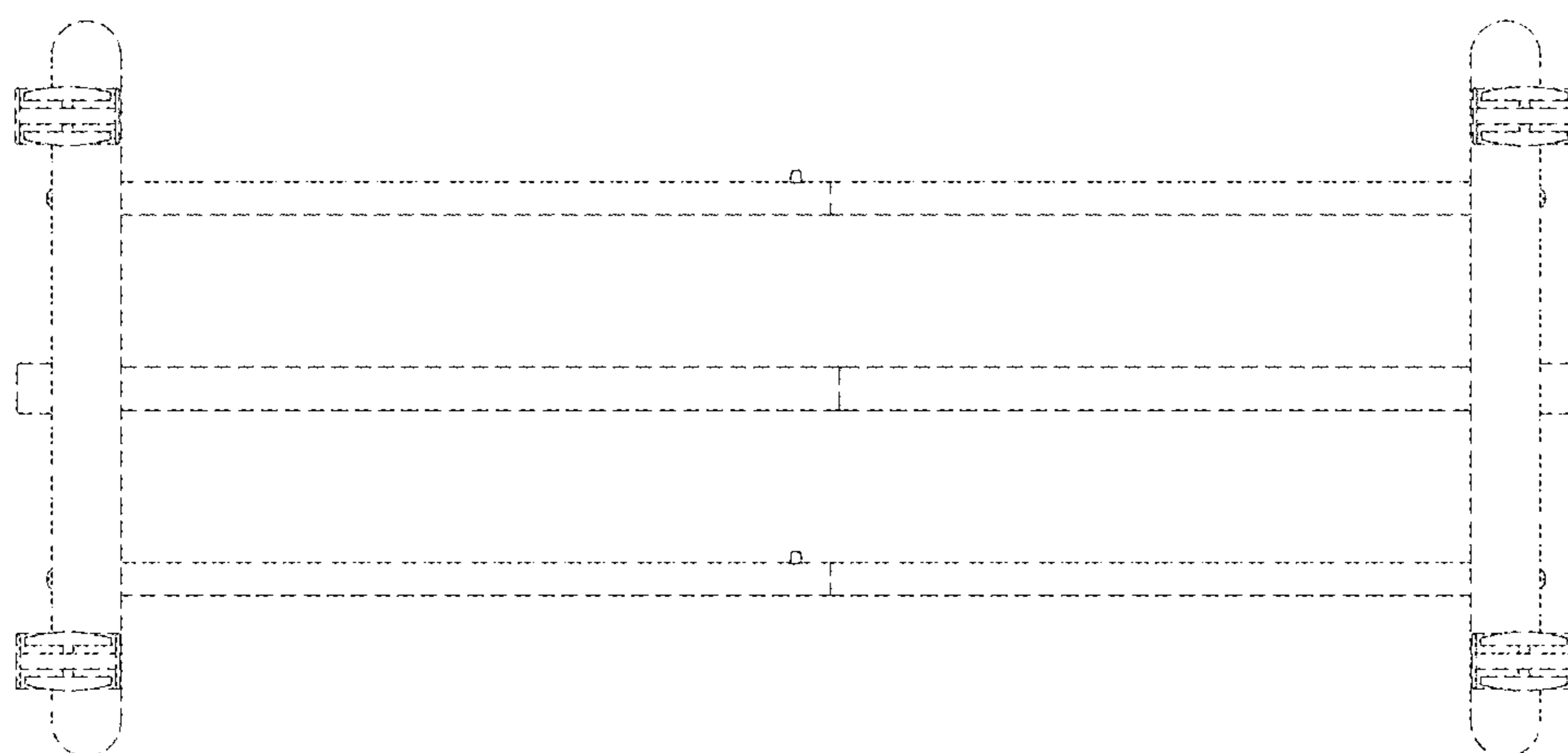
