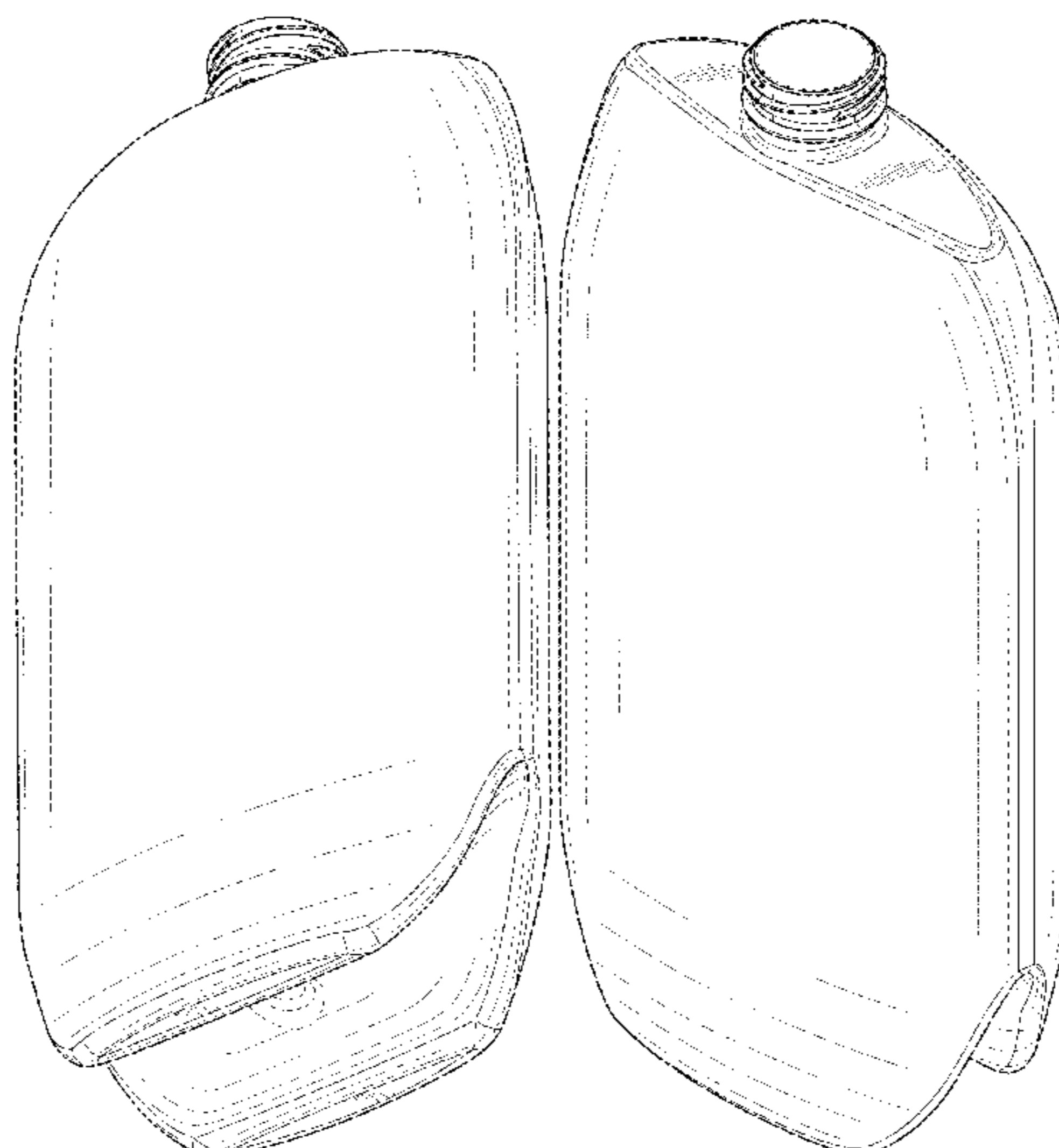

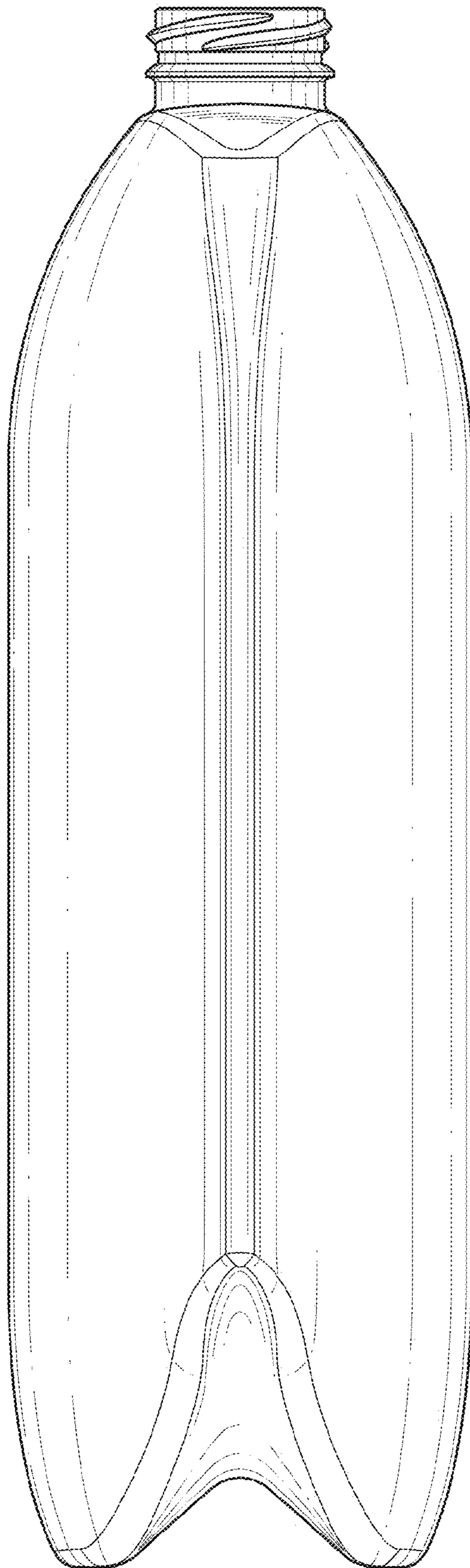

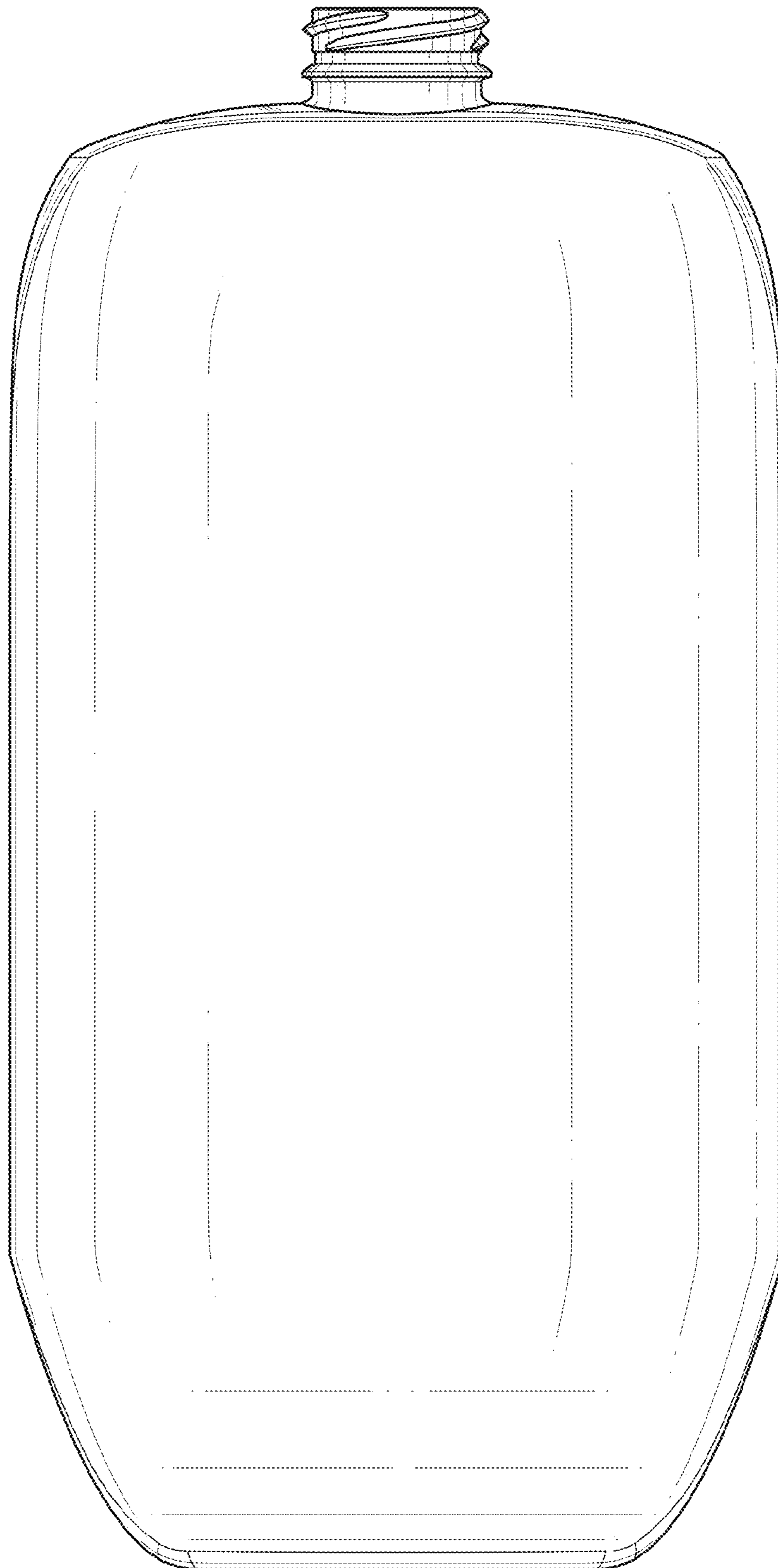
The broken lines of FIGS. 1.3, 1.5 and 1.7 illustrate portions of the bottle that form no part of the claimed design.

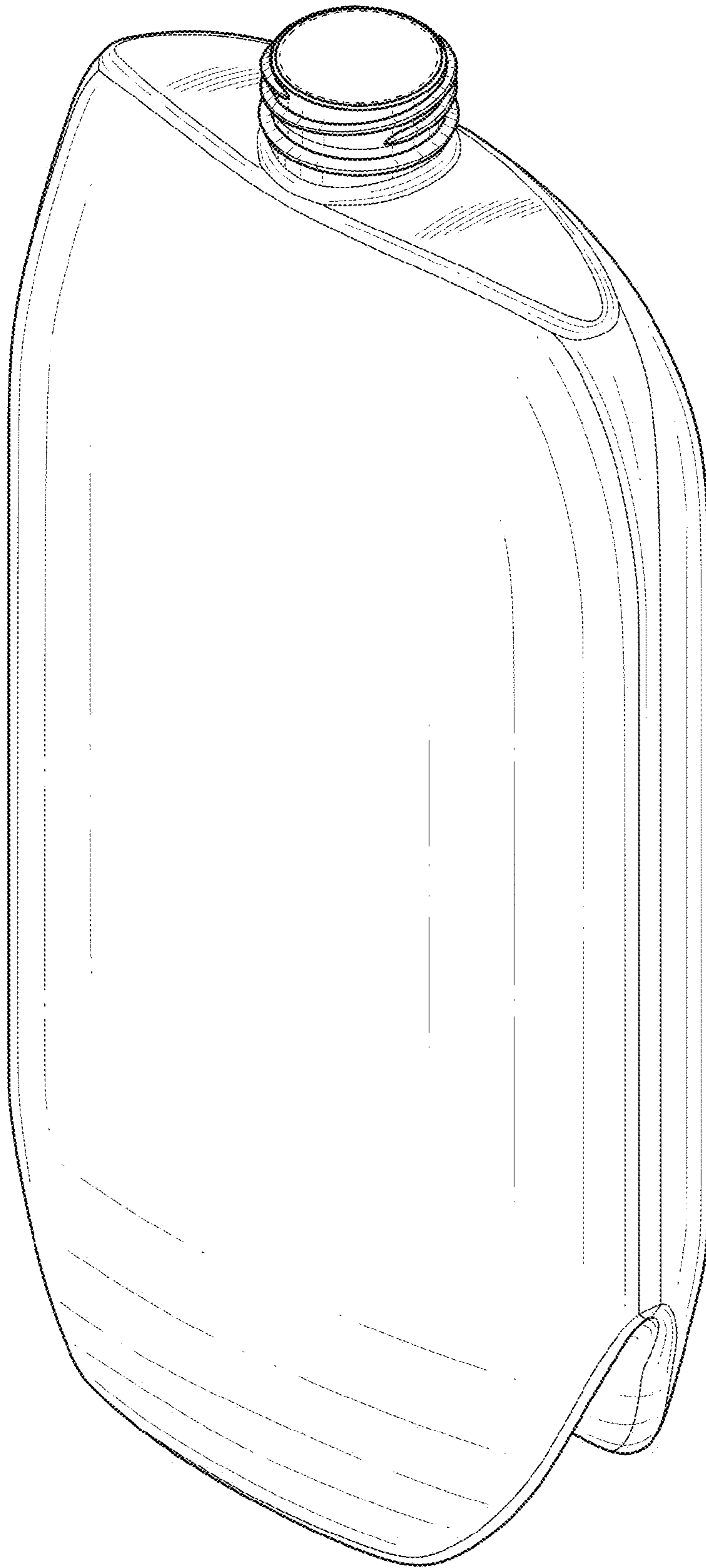

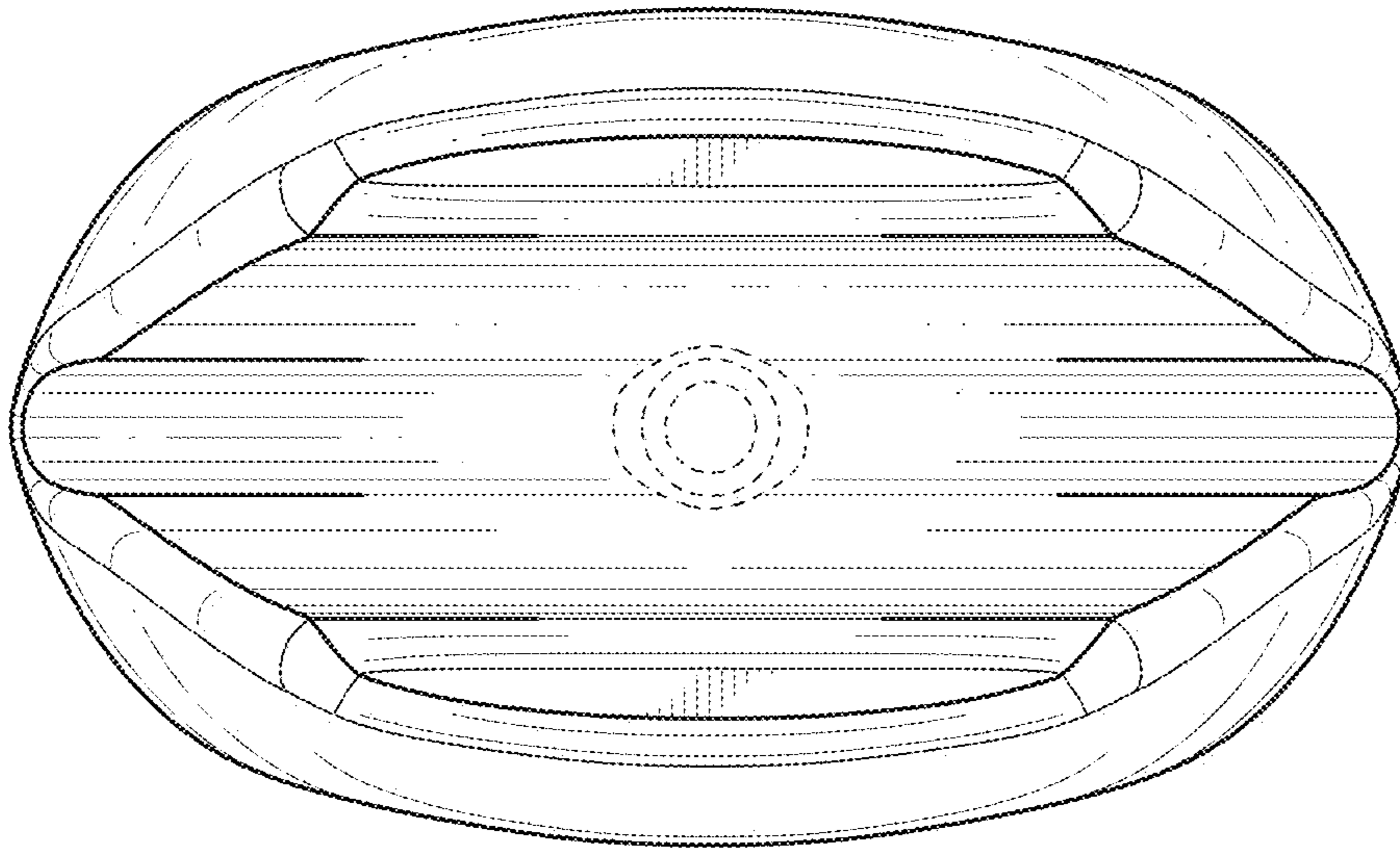

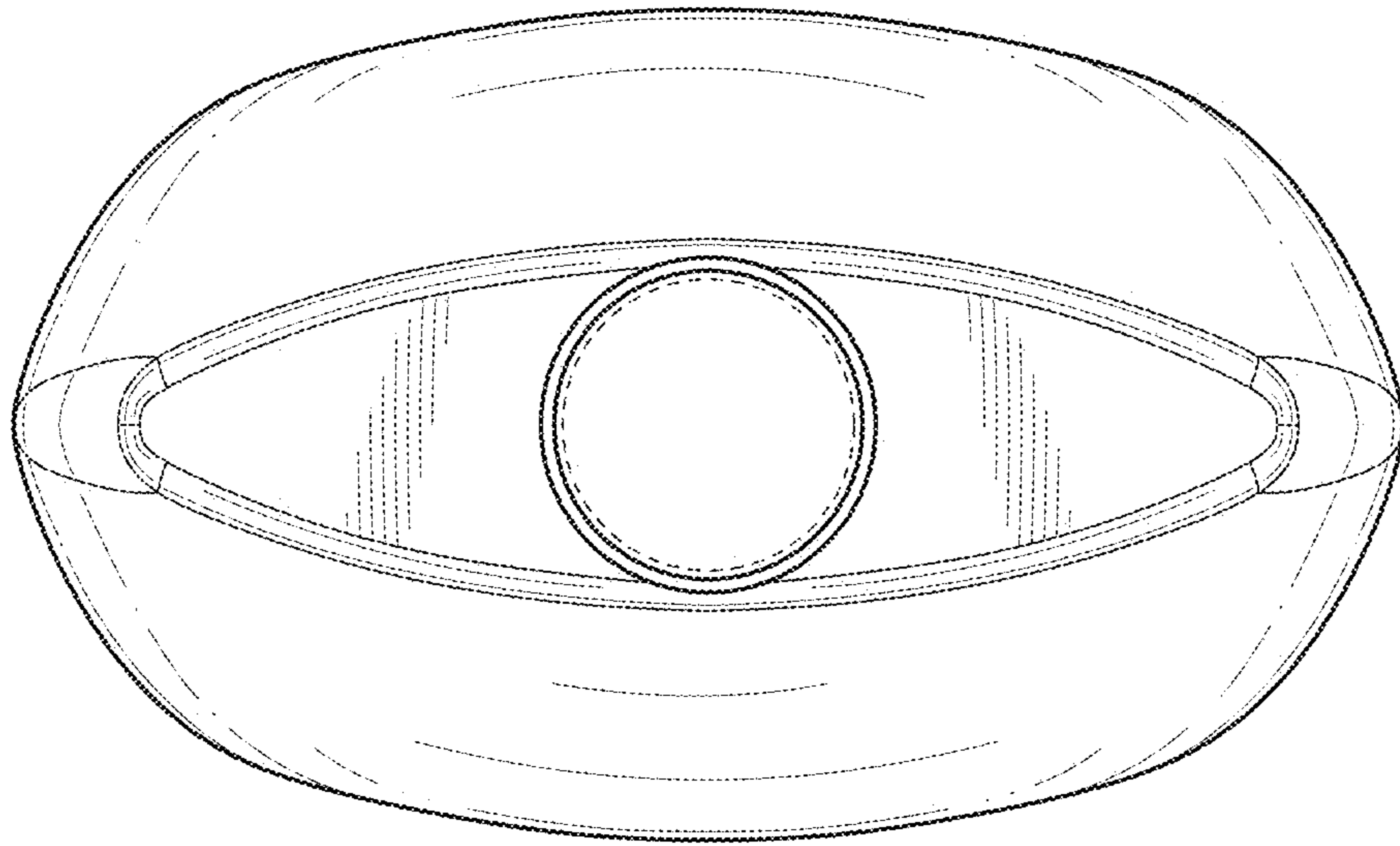

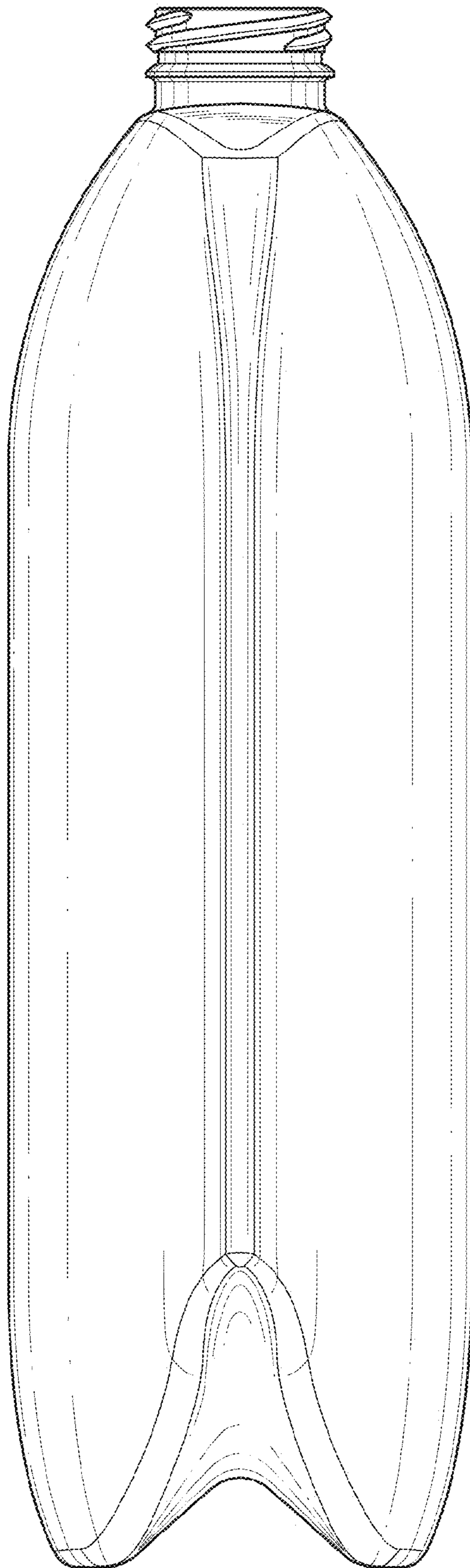
