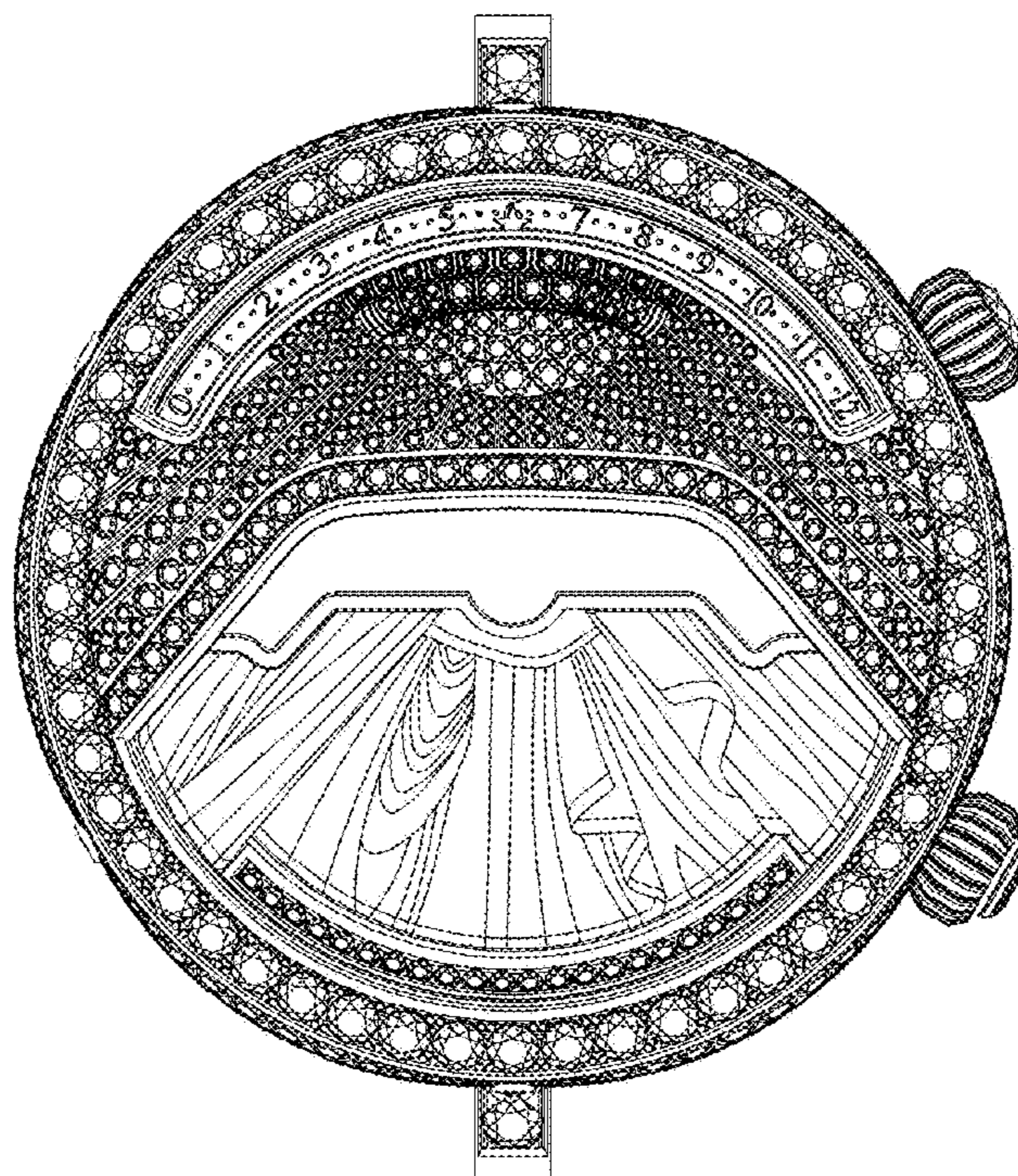

The ornamental design for a watch, as shown and described.

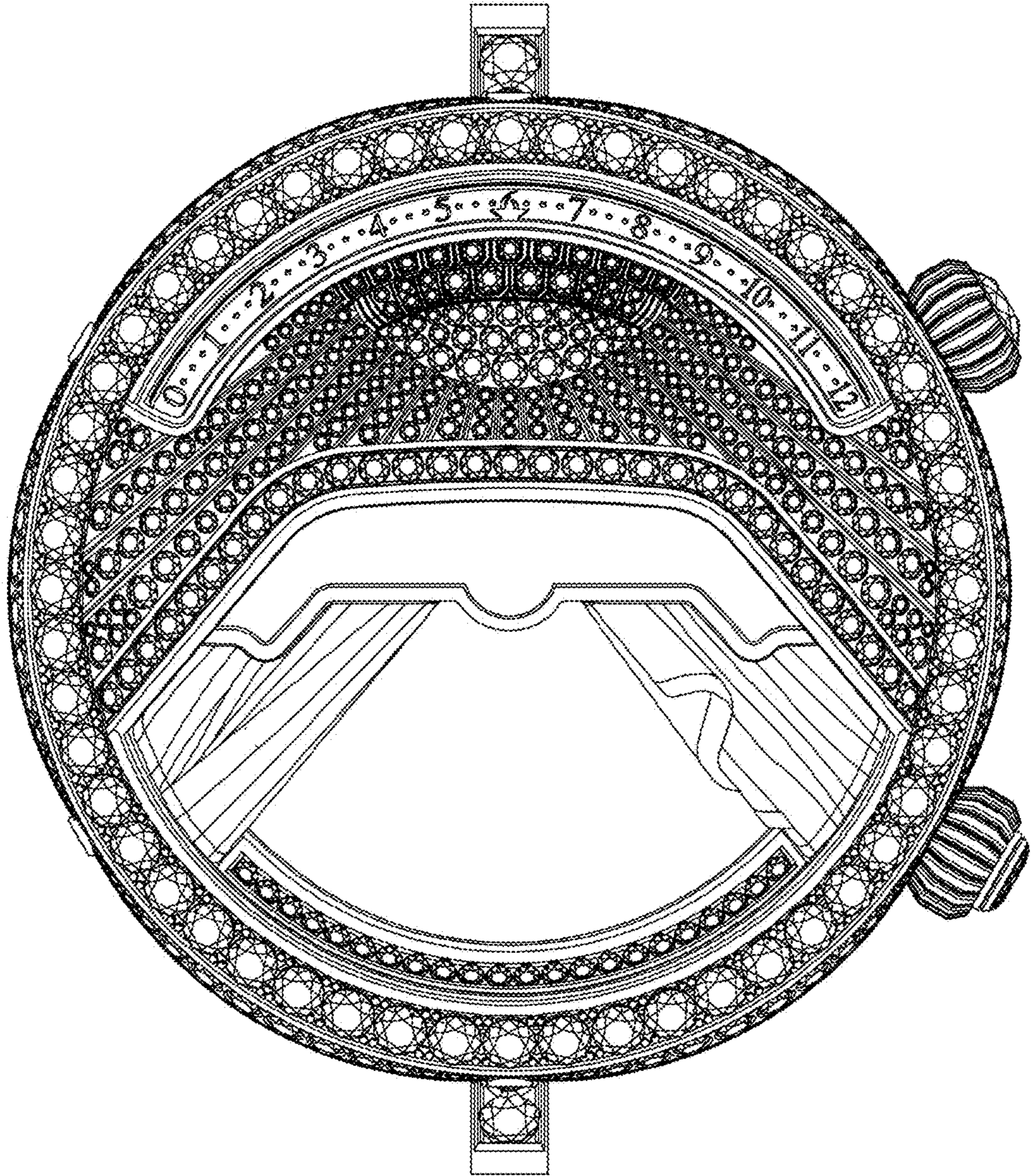
DESCRIPTION

- 1.9 is a front view show in an alternate position.

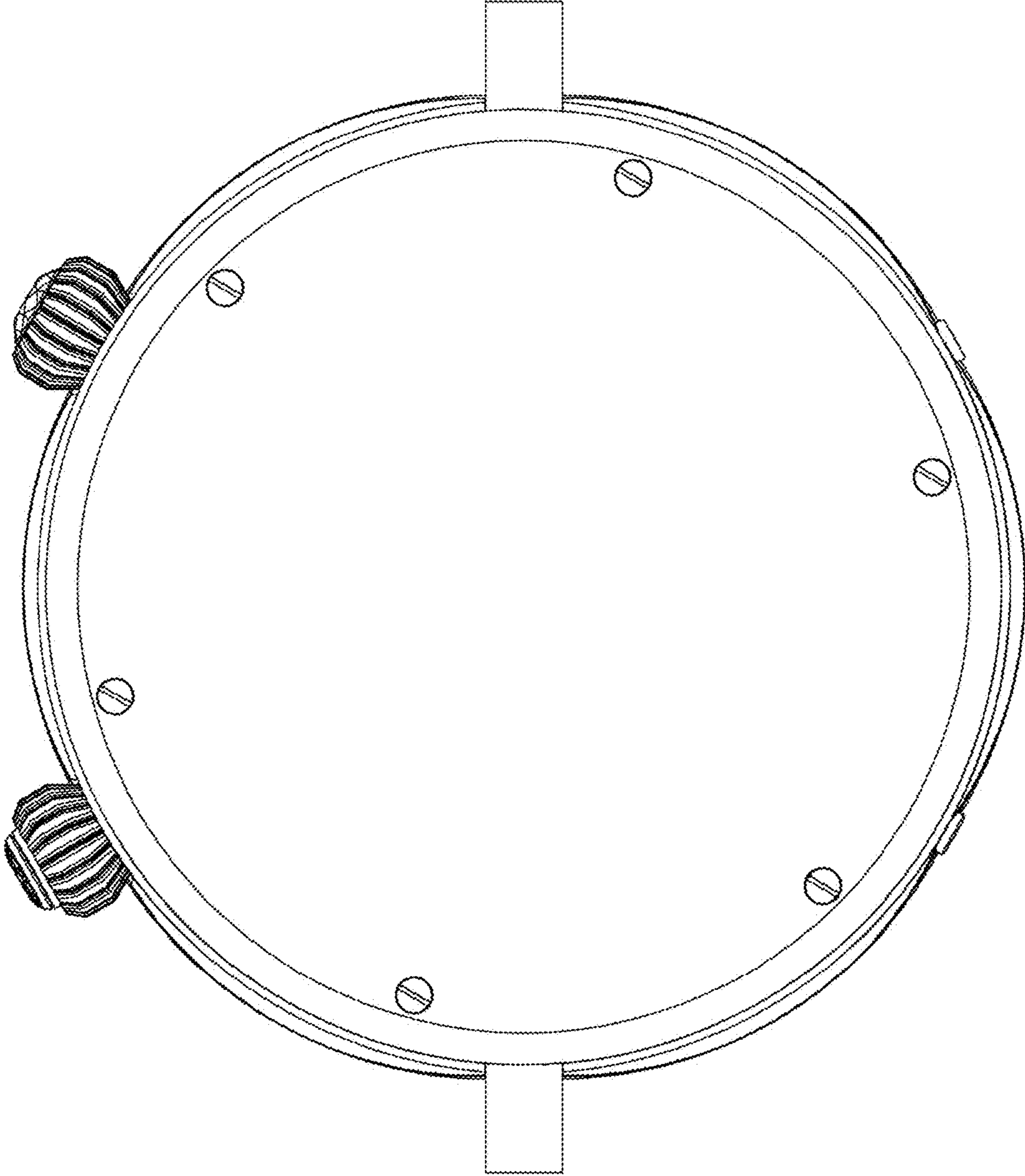

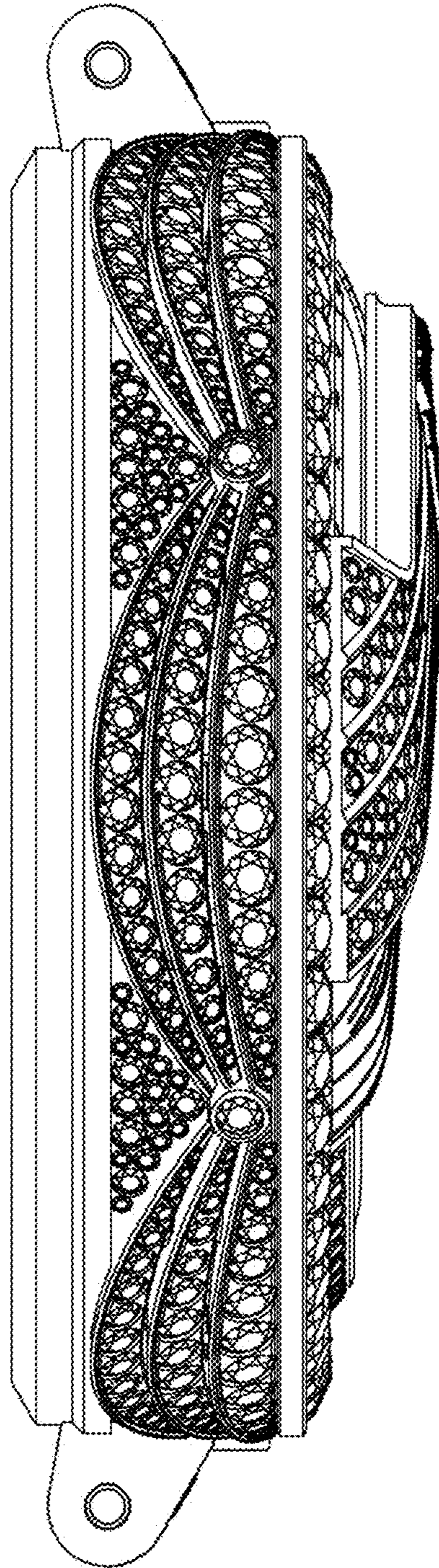

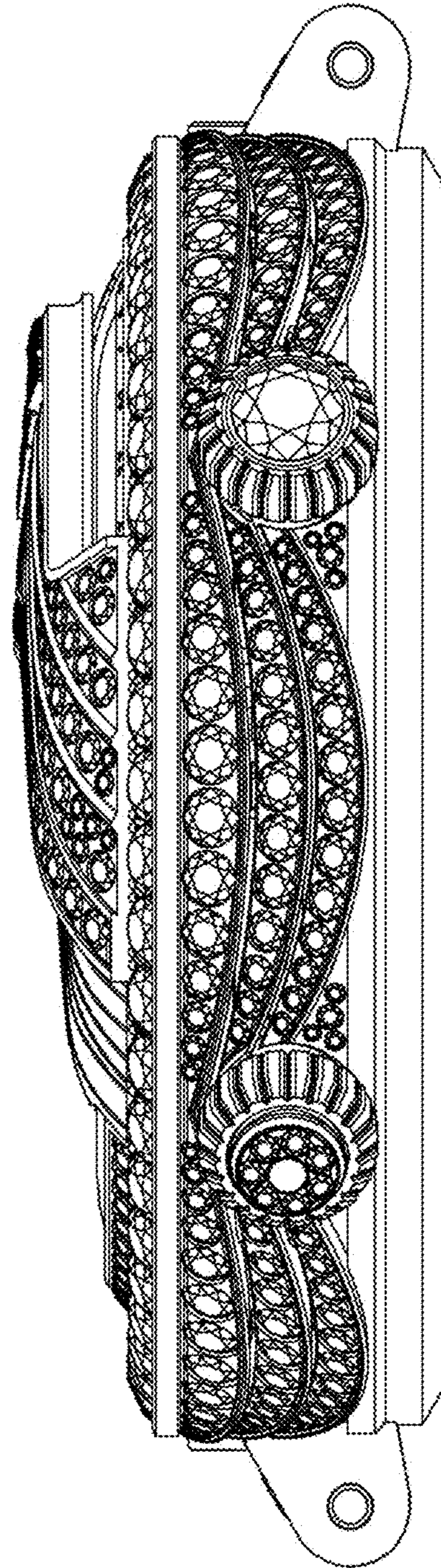

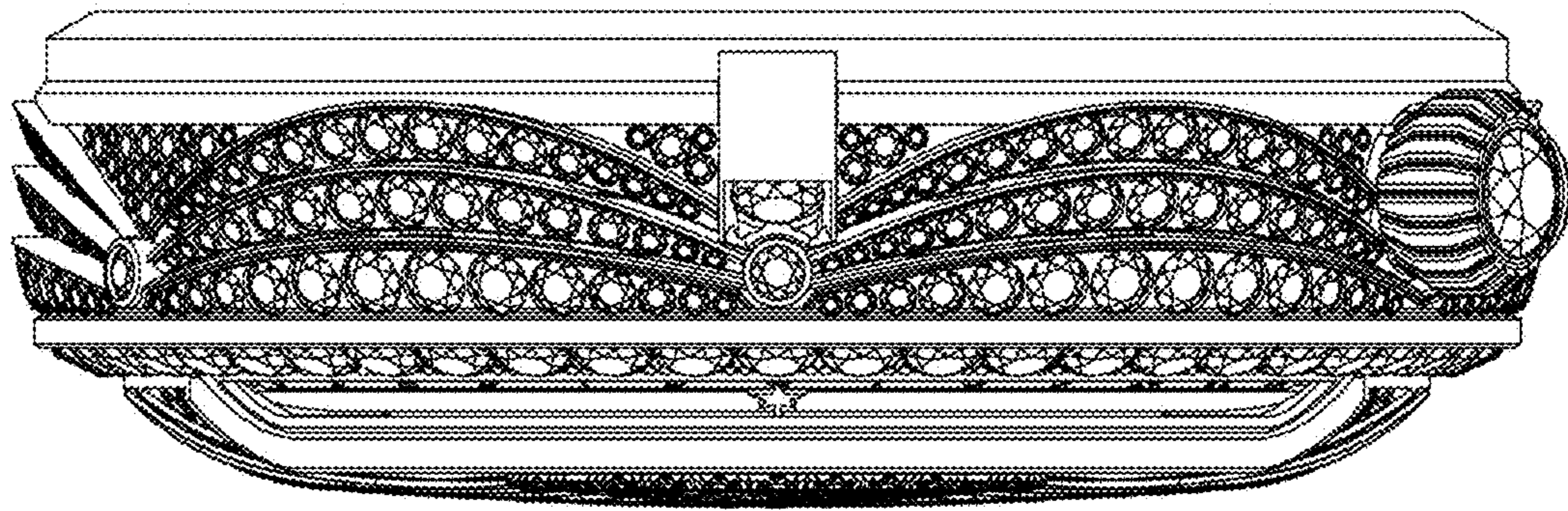

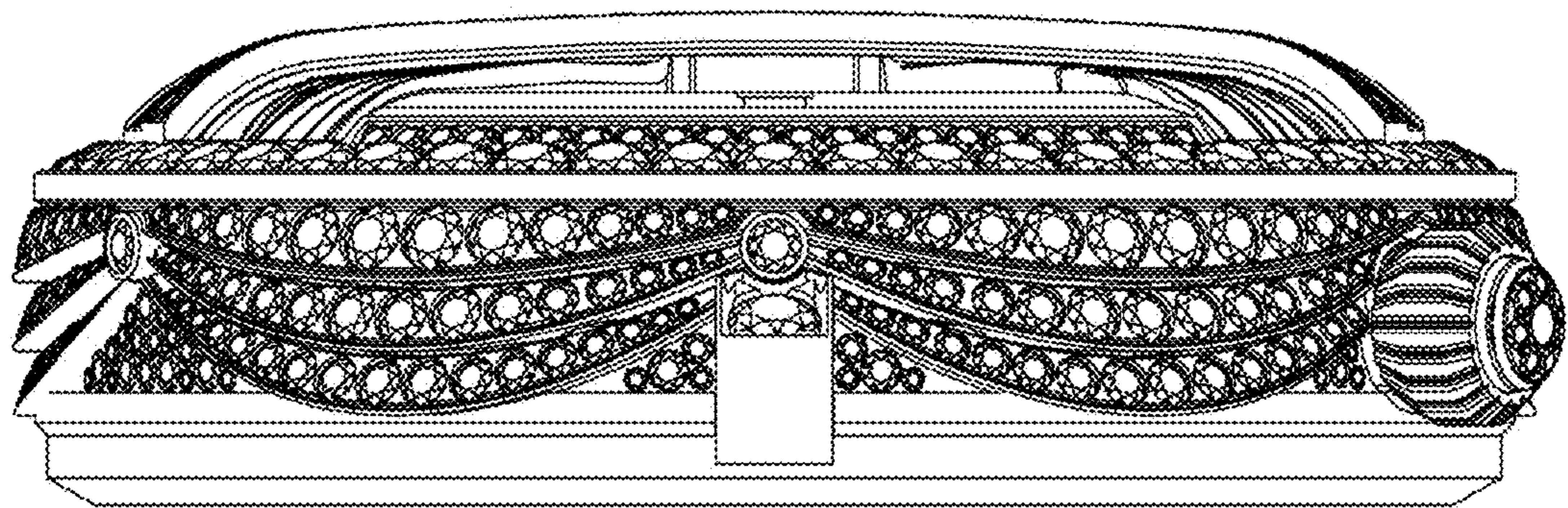

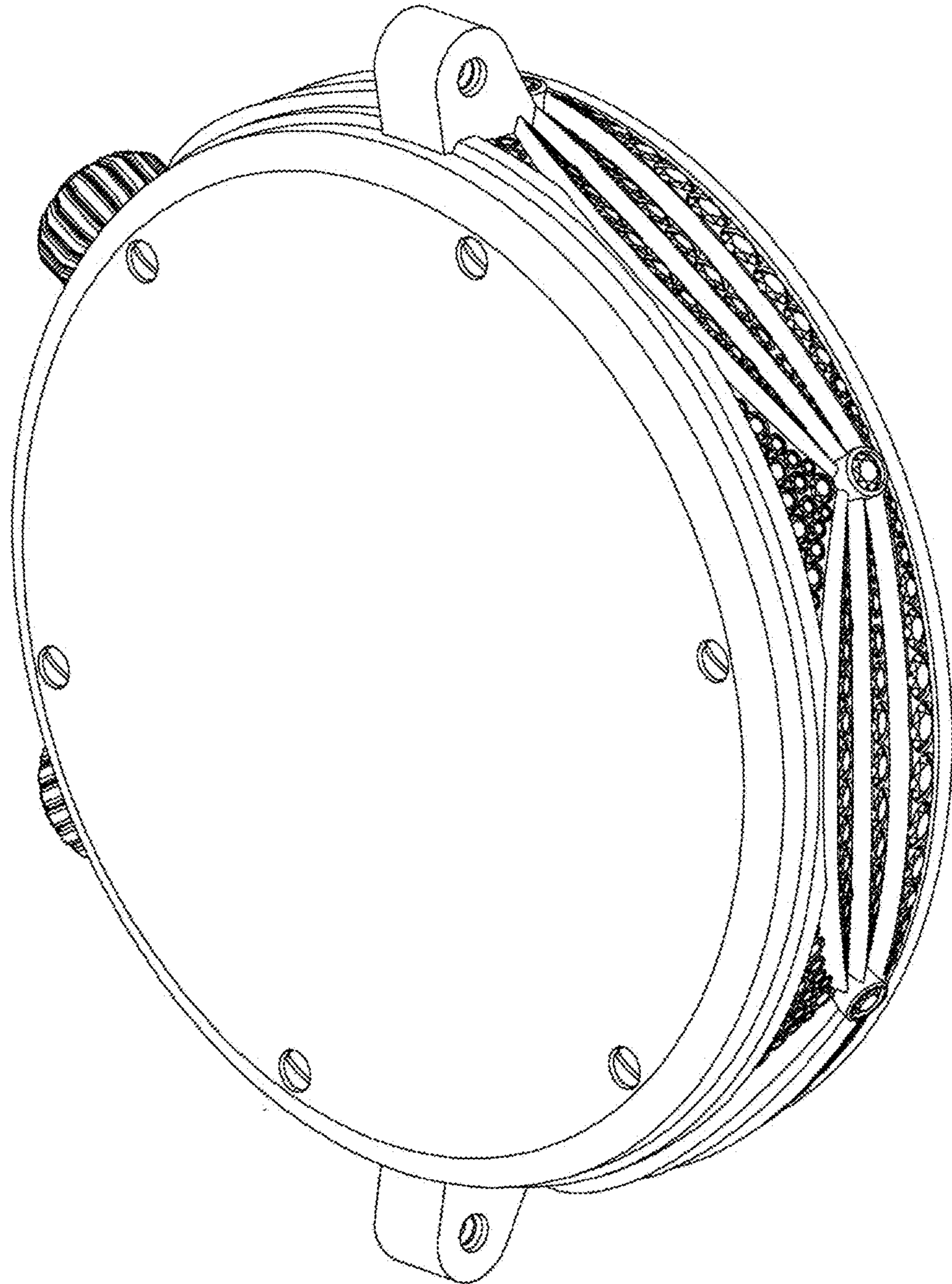
