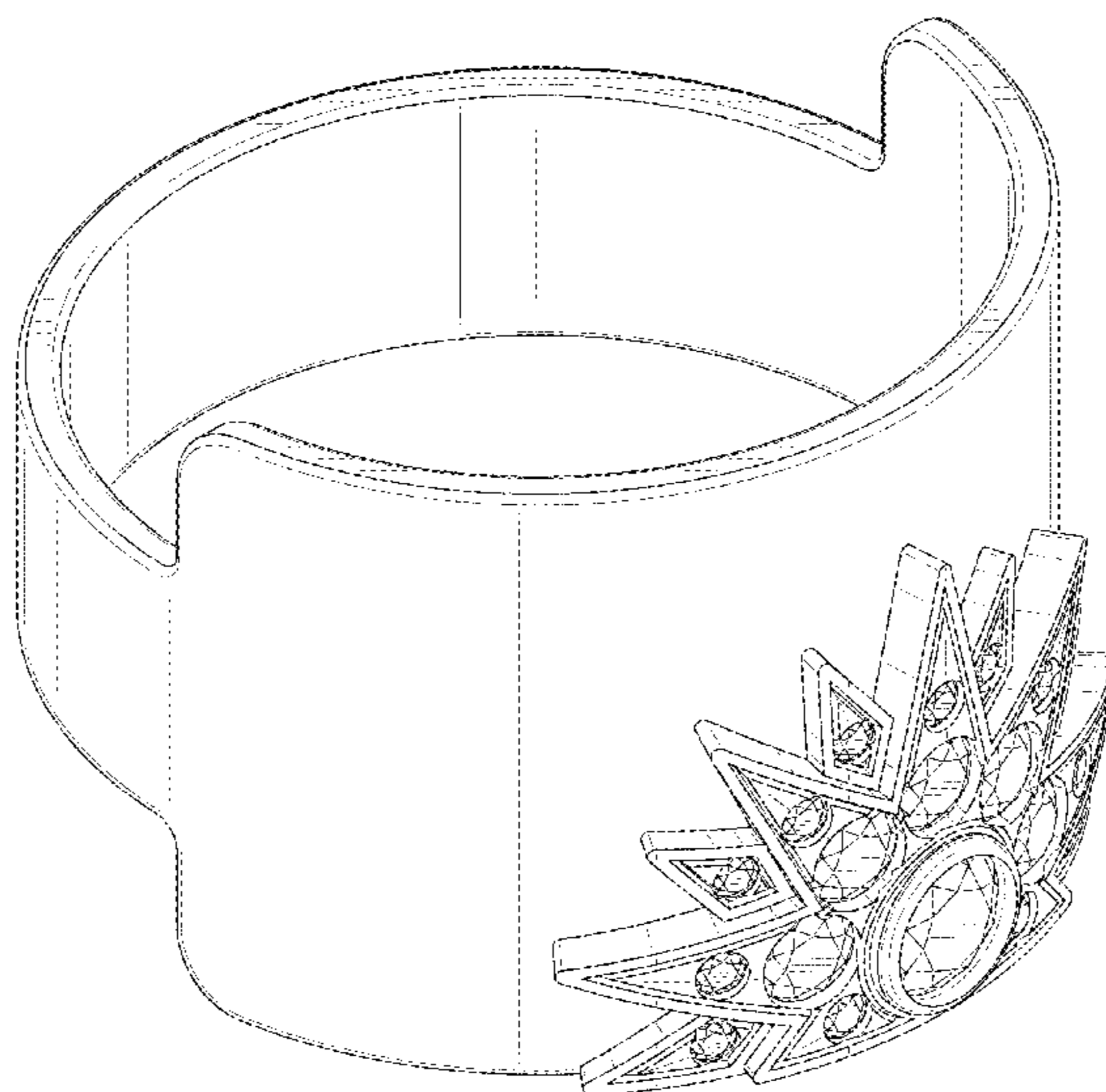
(57) **CLAIM**

The ornamental design for an article of jewelry, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left-side, top perspective view of the article of jewelry, showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear-elevational view thereof;  
FIG. 4 is a left-side elevational view thereof;  
FIG. 5 is a right-side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

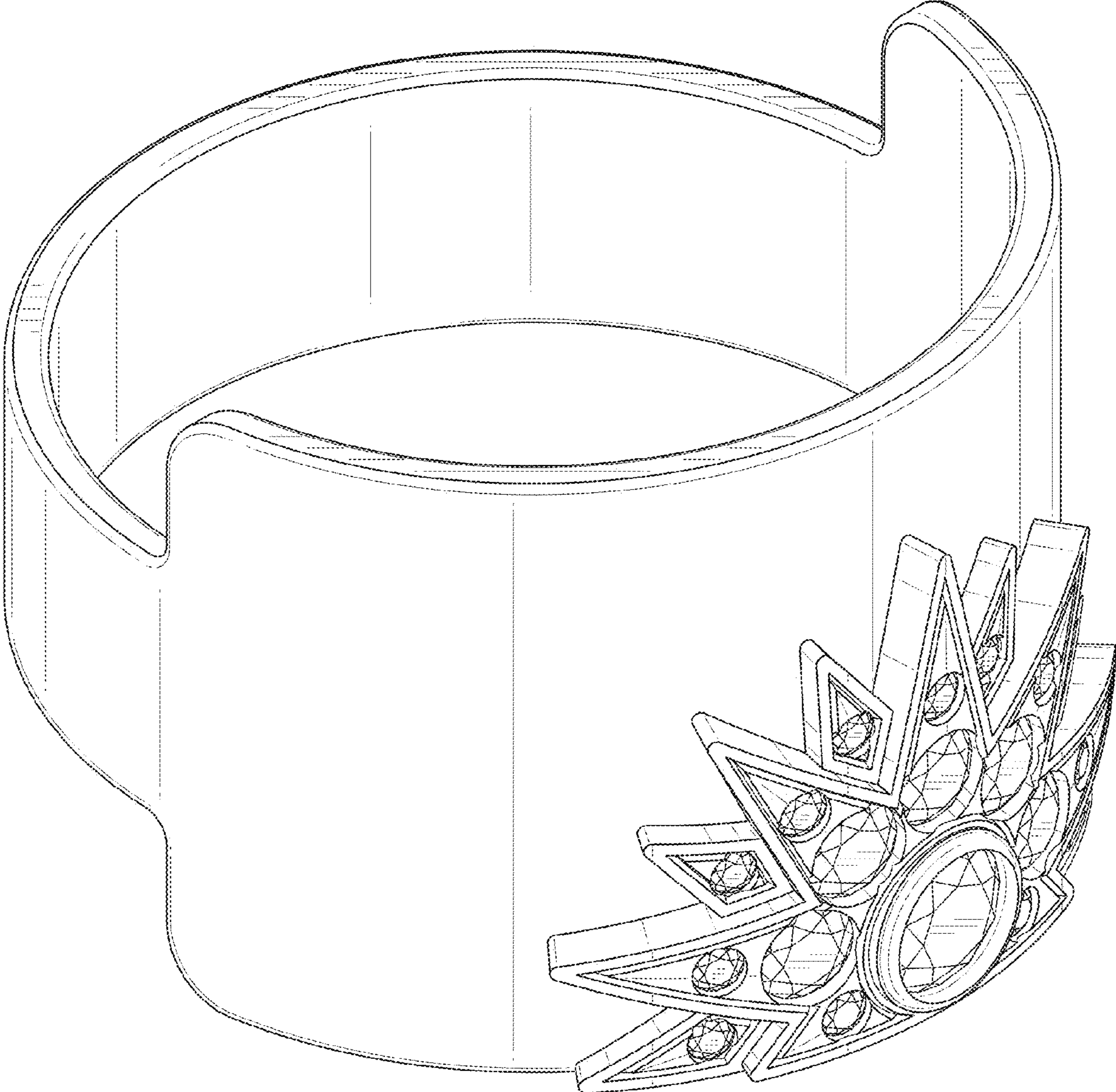

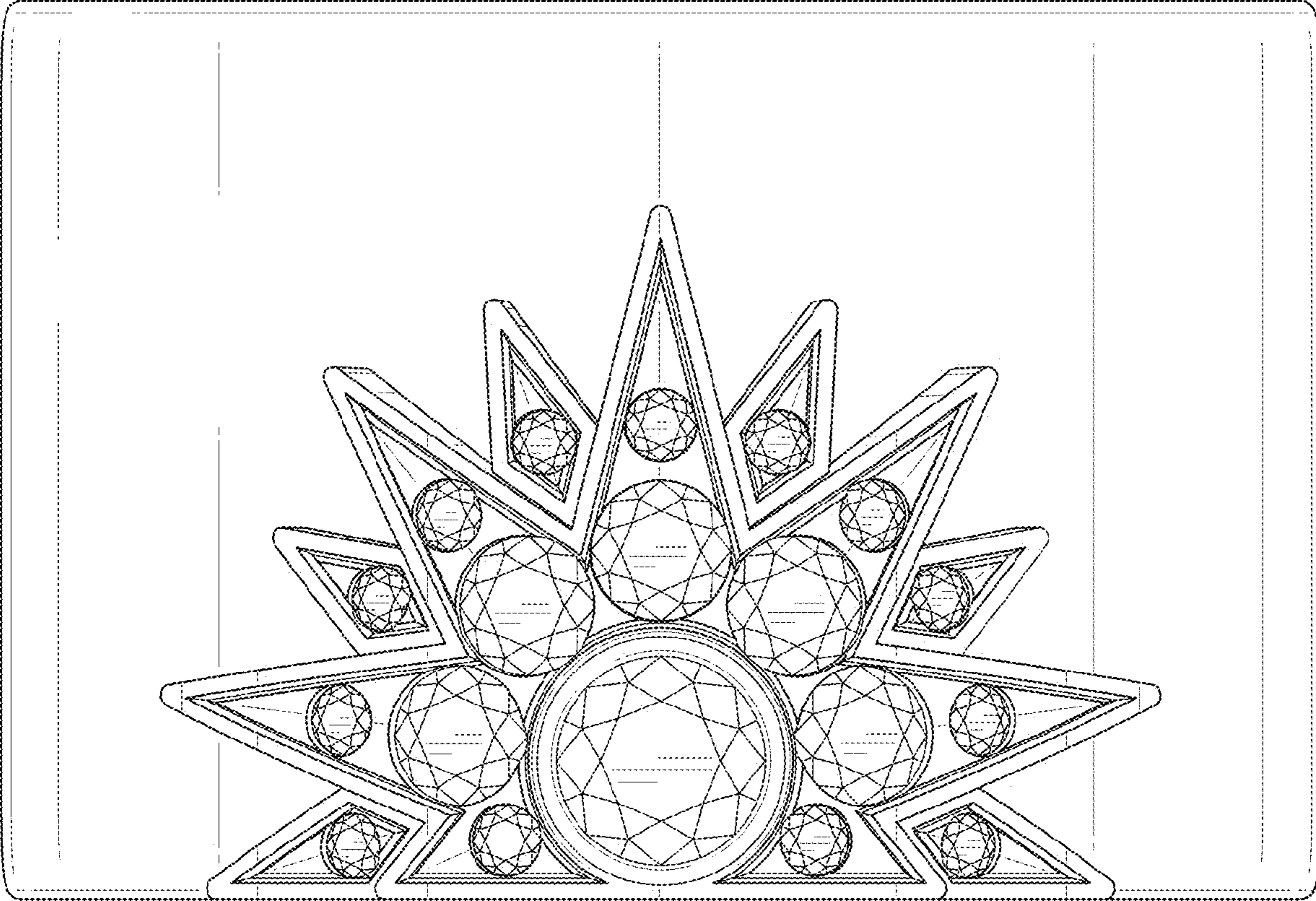

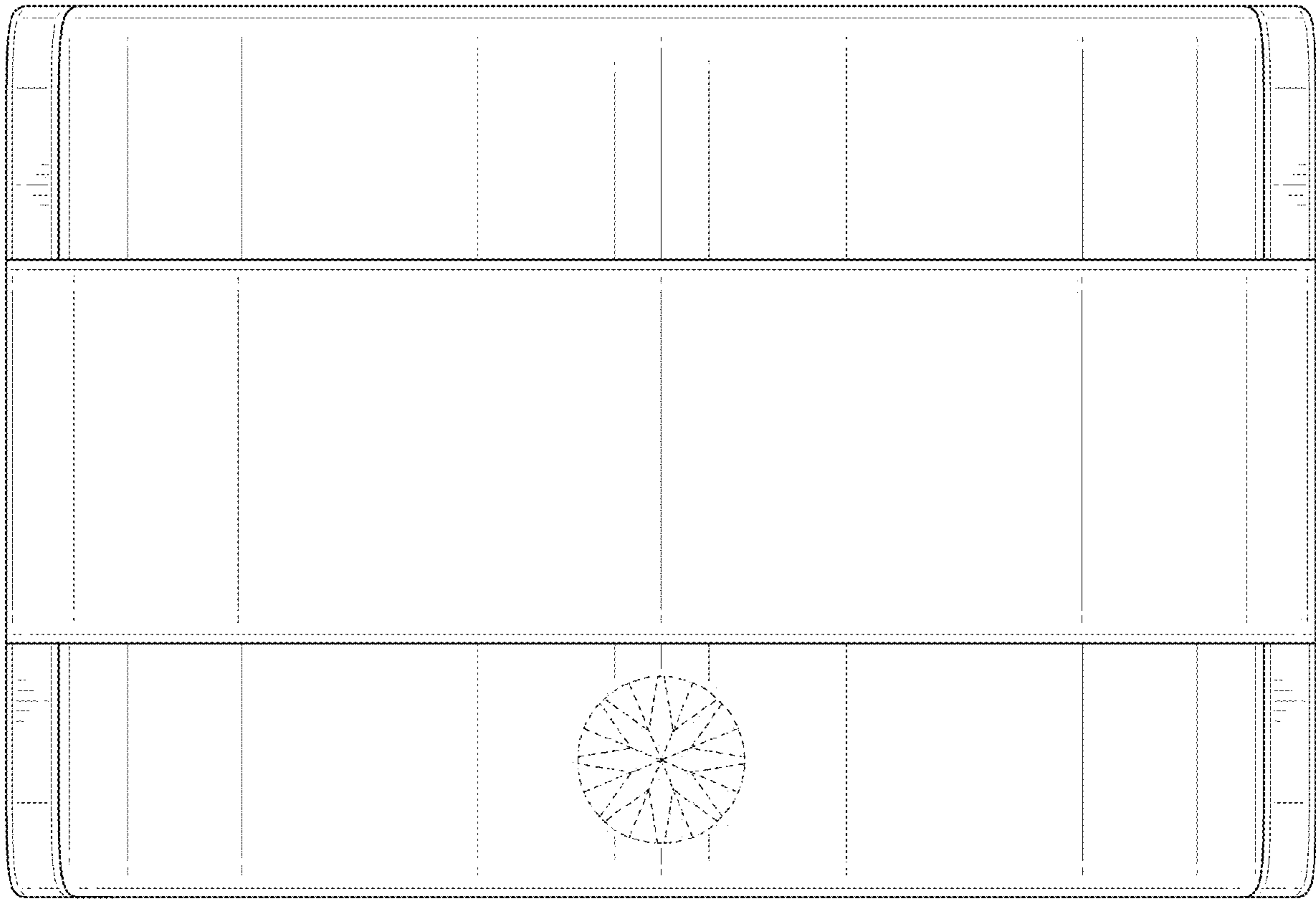

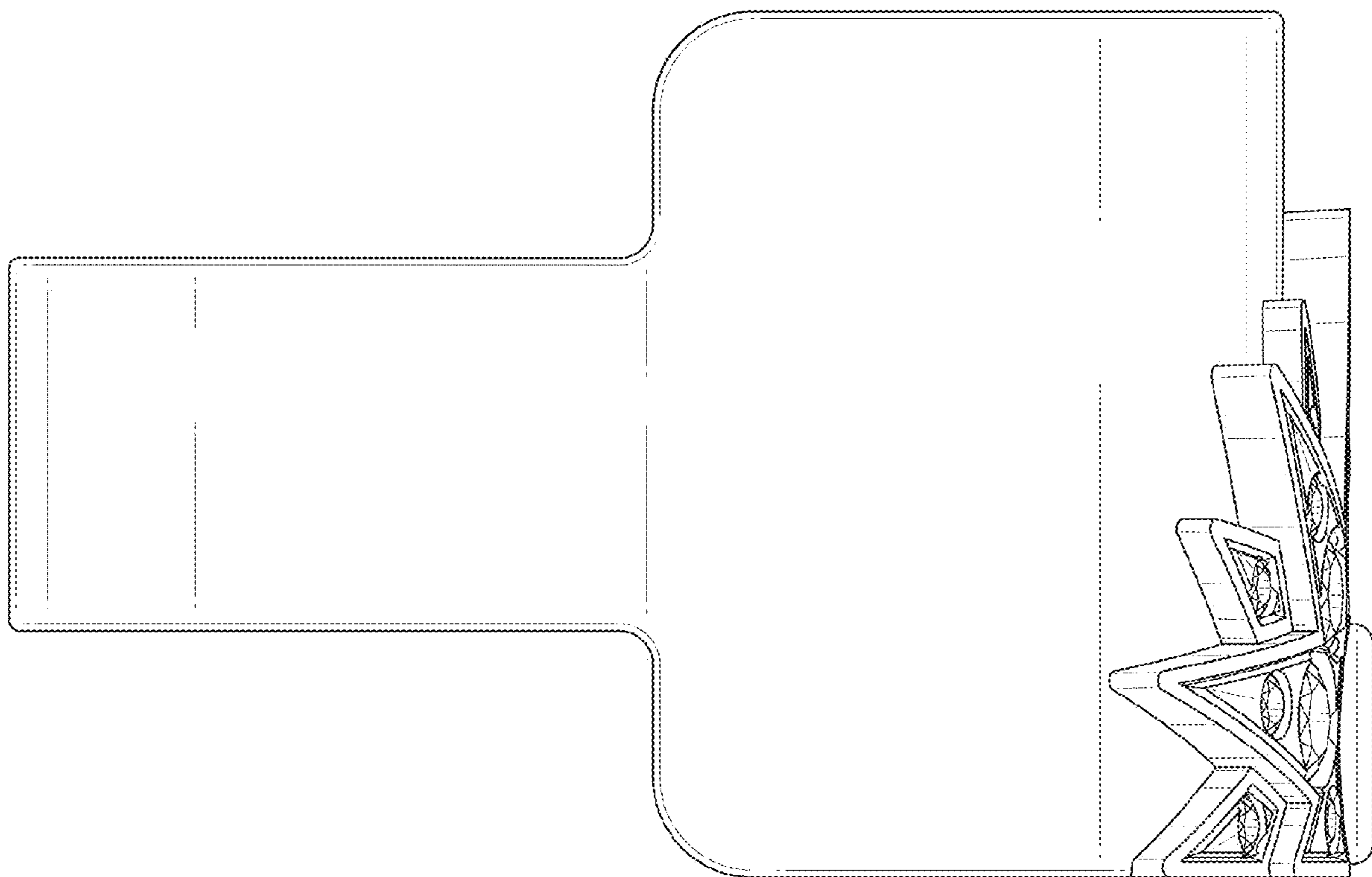

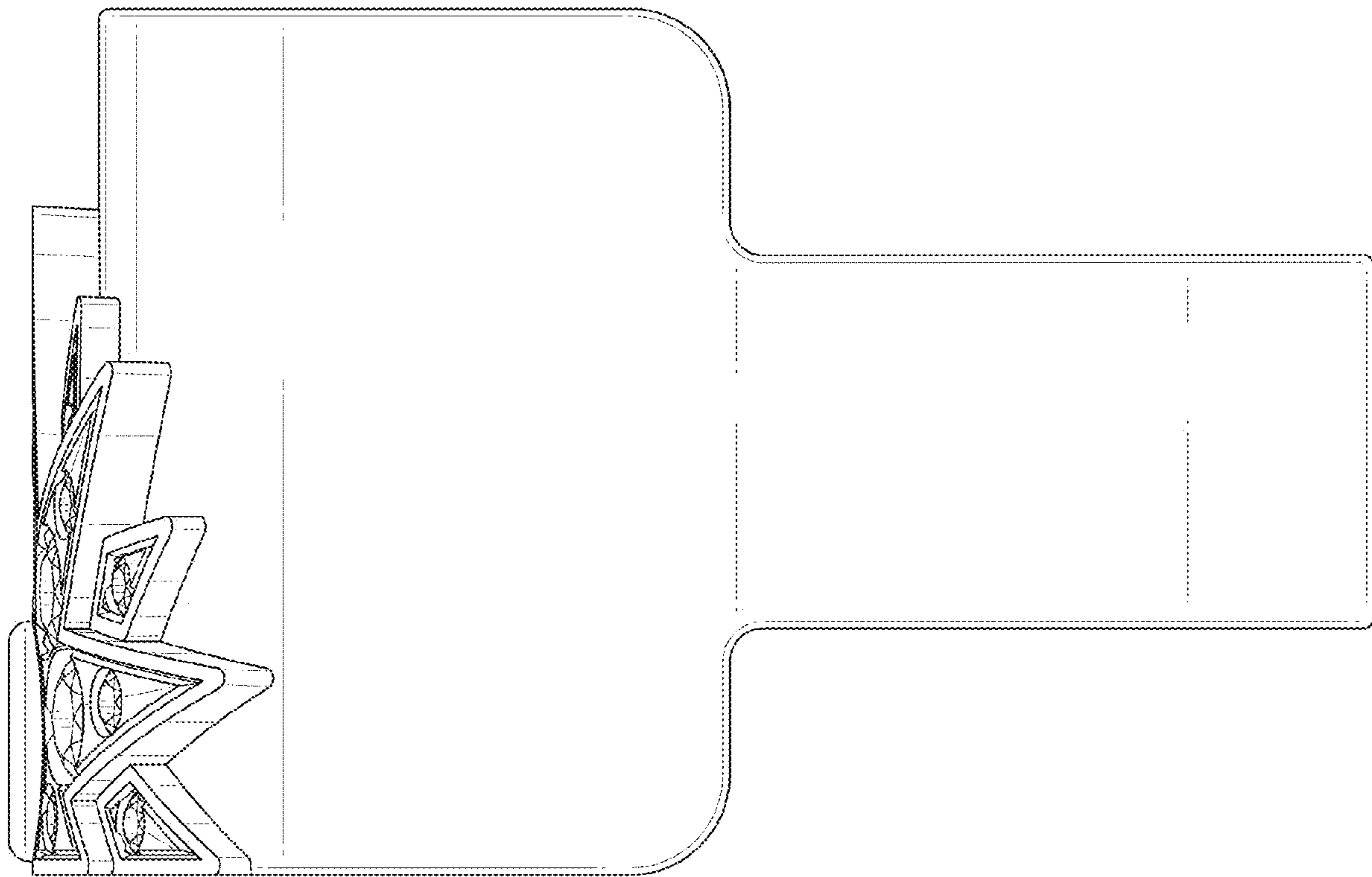

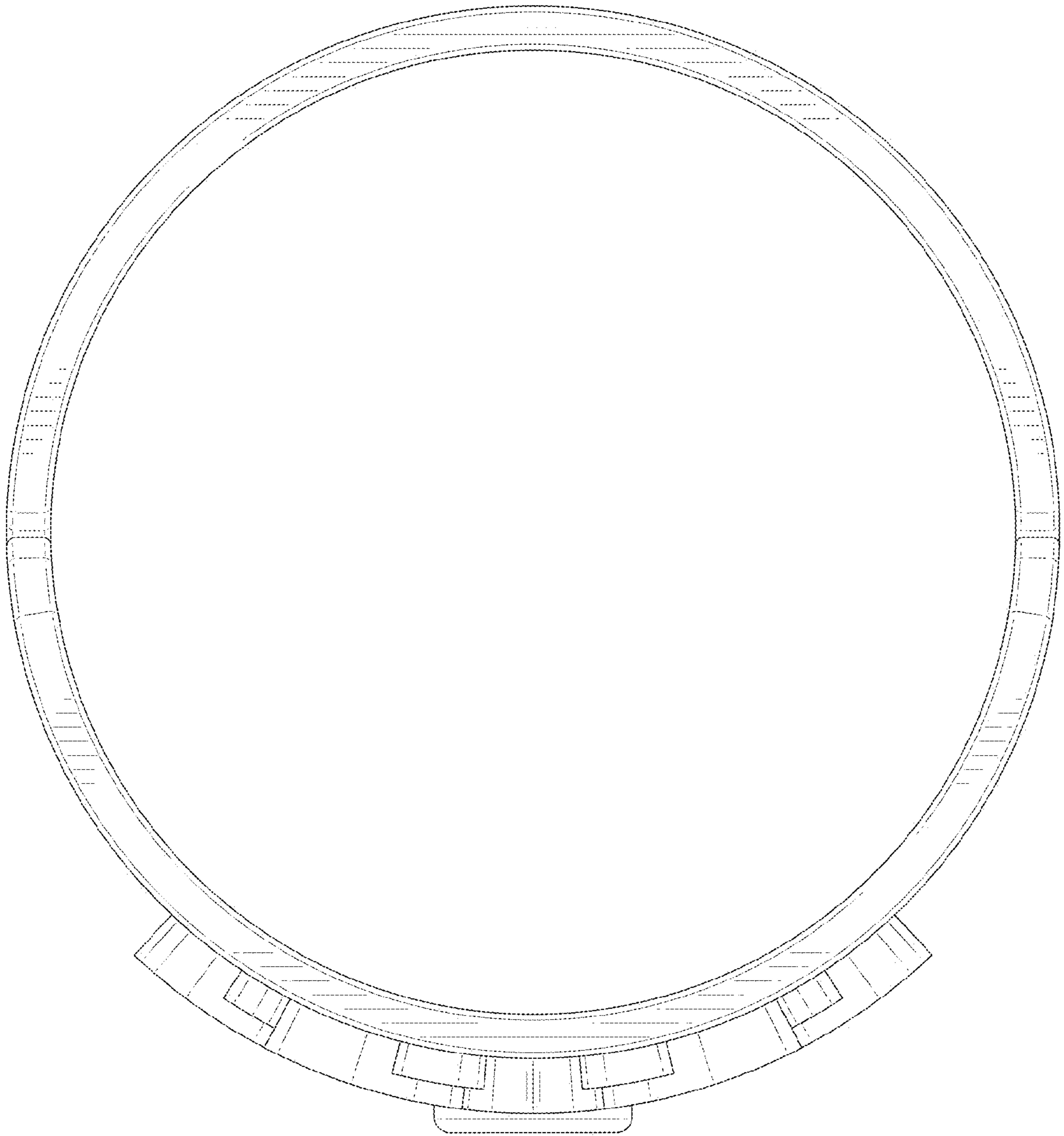

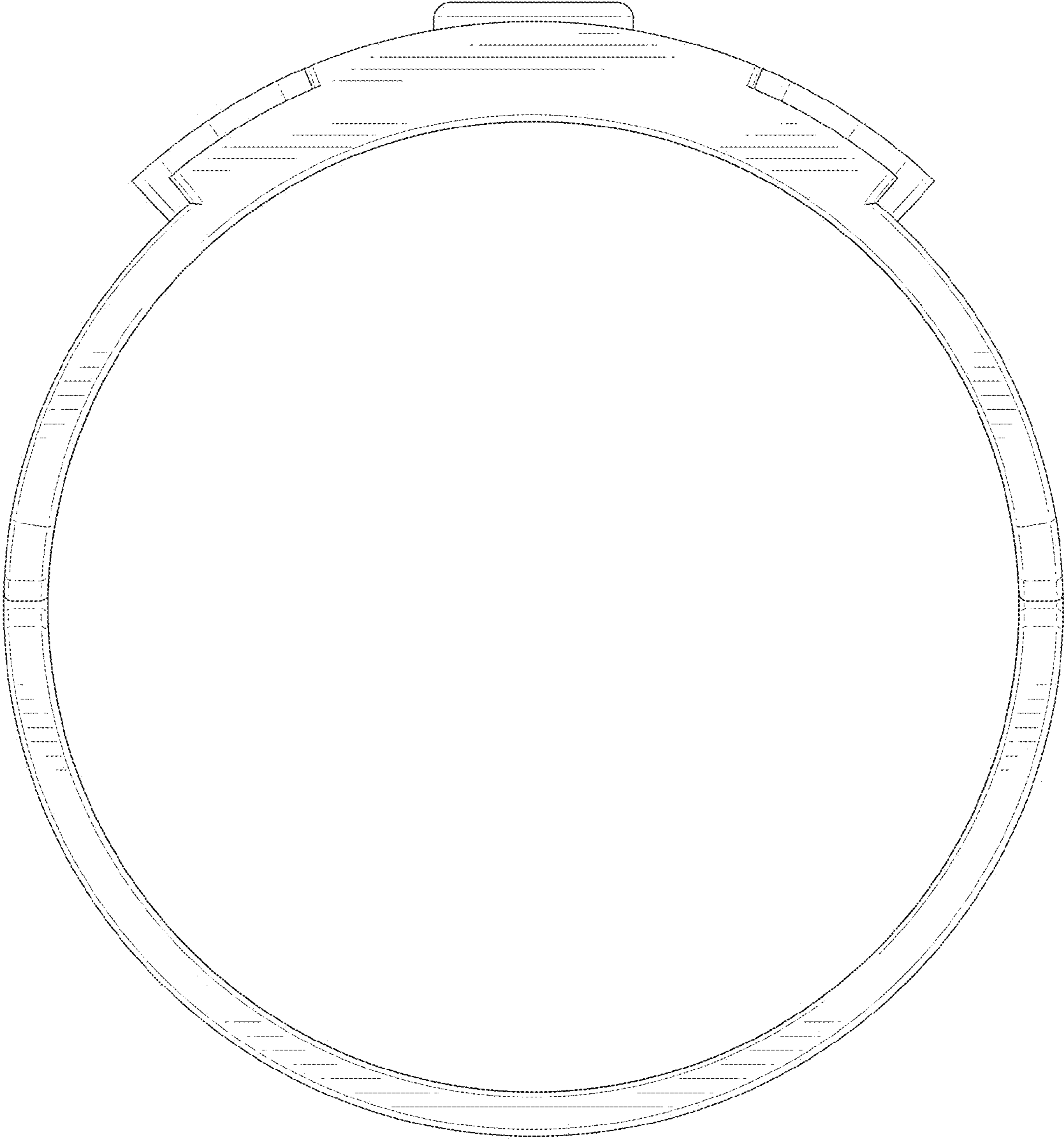
