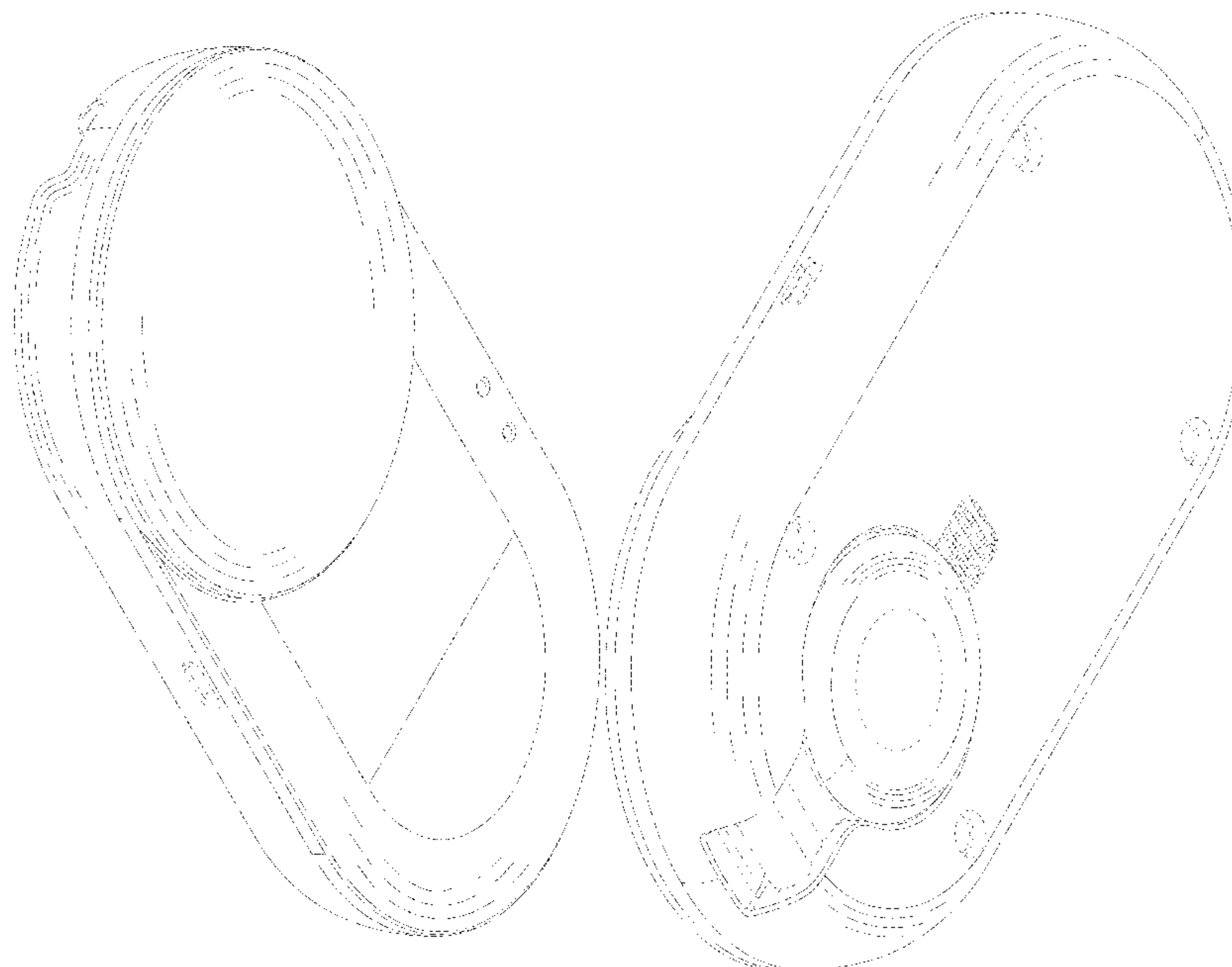
(57) **CLAIM**

The ornamental design for a wireless charger, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a wireless charger showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is an enlarged left elevational view thereof;
FIG. 4 is an enlarged right elevational view thereof;
FIG. 5 is an enlarged top plan view thereof;
FIG. 6 is an enlarged bottom plan view thereof;
FIG. 7 is a bottom, front, left perspective view thereof; and,
FIG. 8 is a bottom, rear, right perspective view thereof.
The broken lines in the drawings depict portions of the wireless charger that form no part of the claimed design.

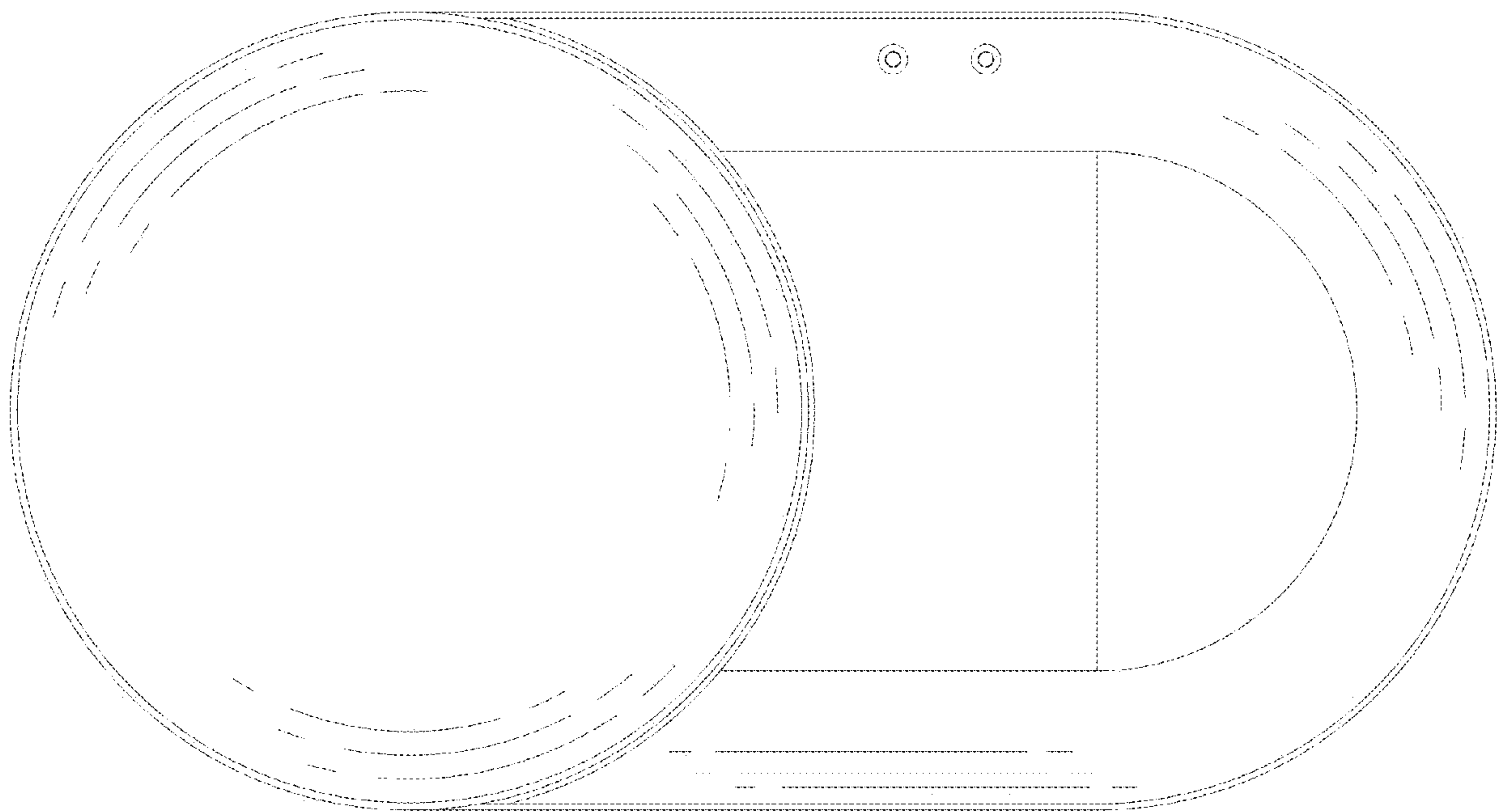

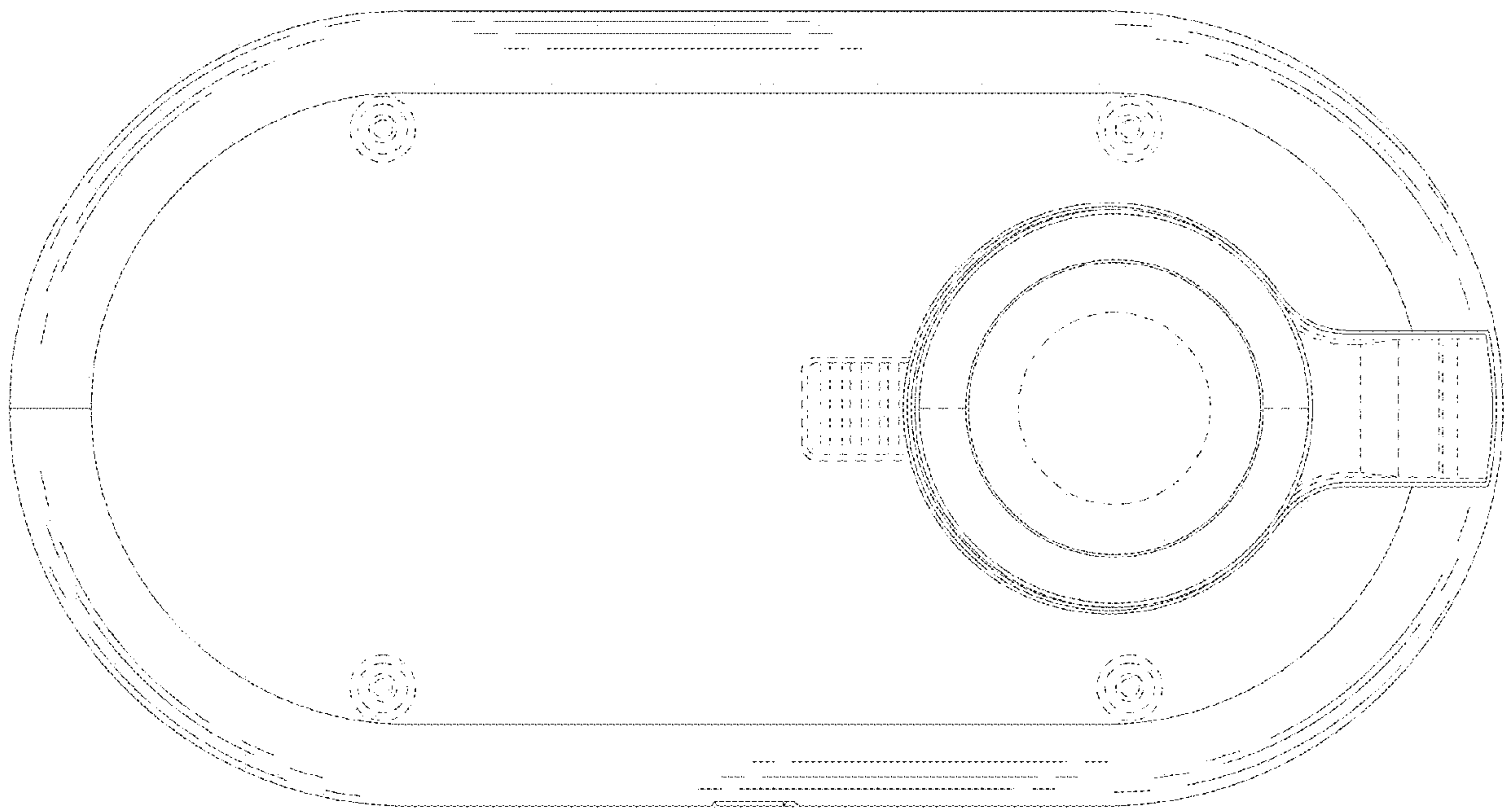

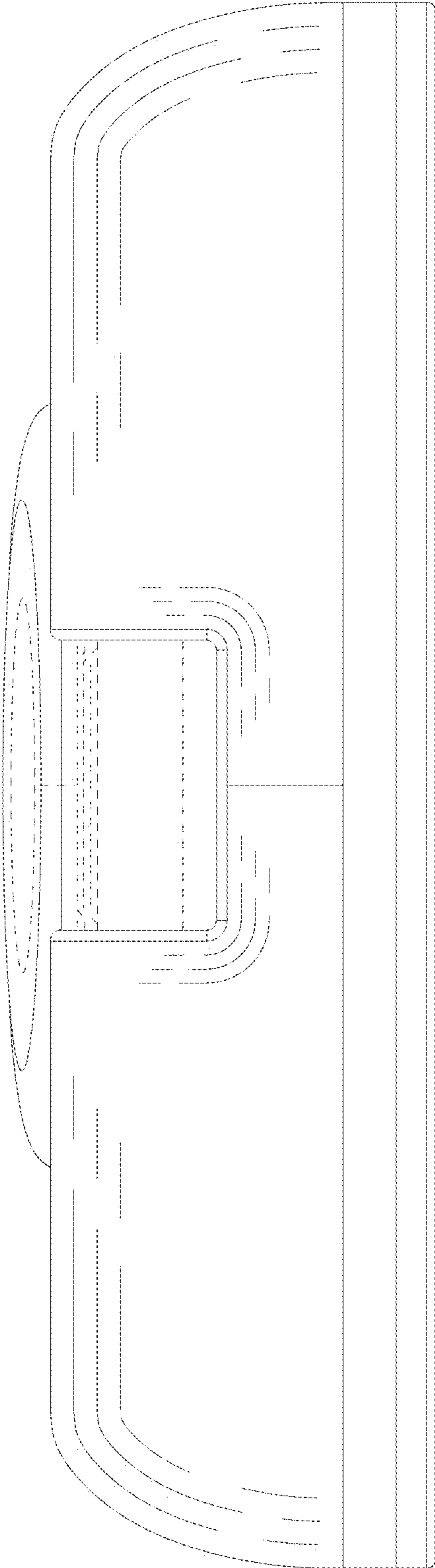

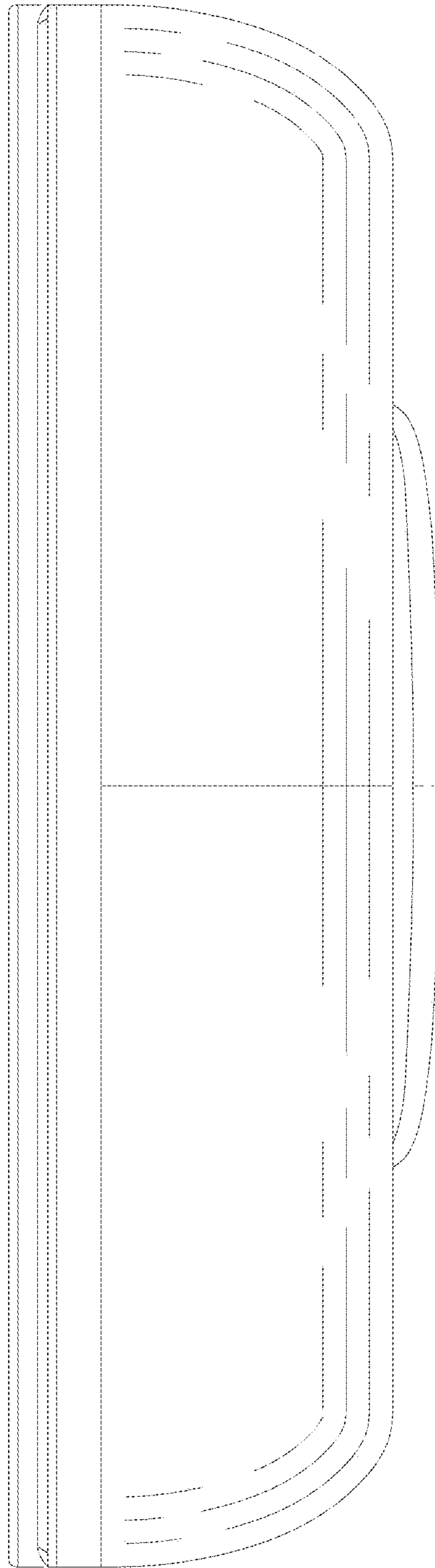

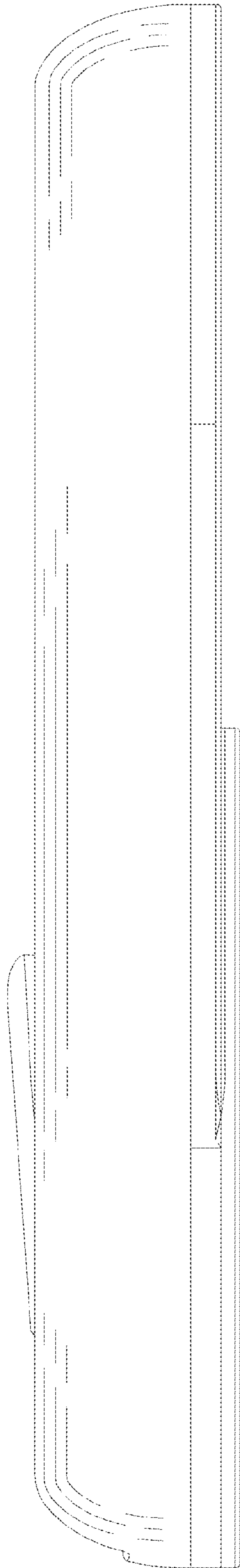

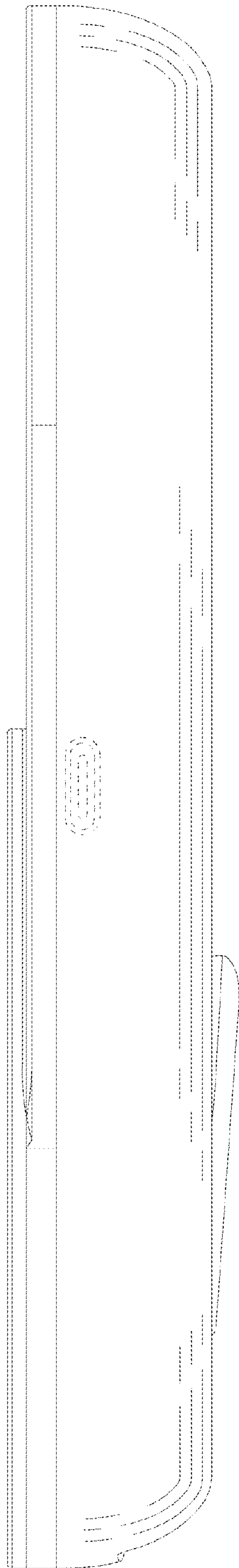

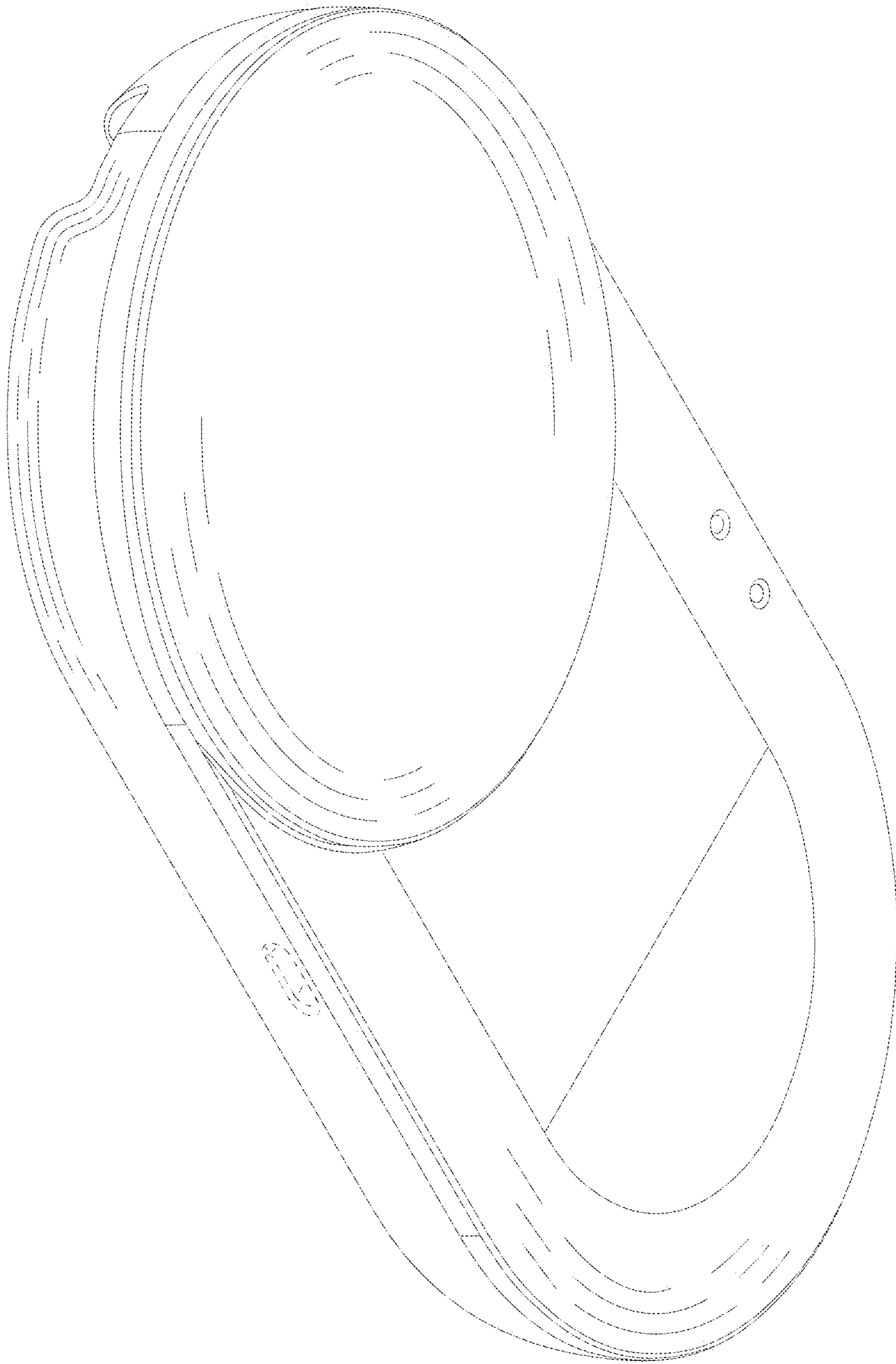

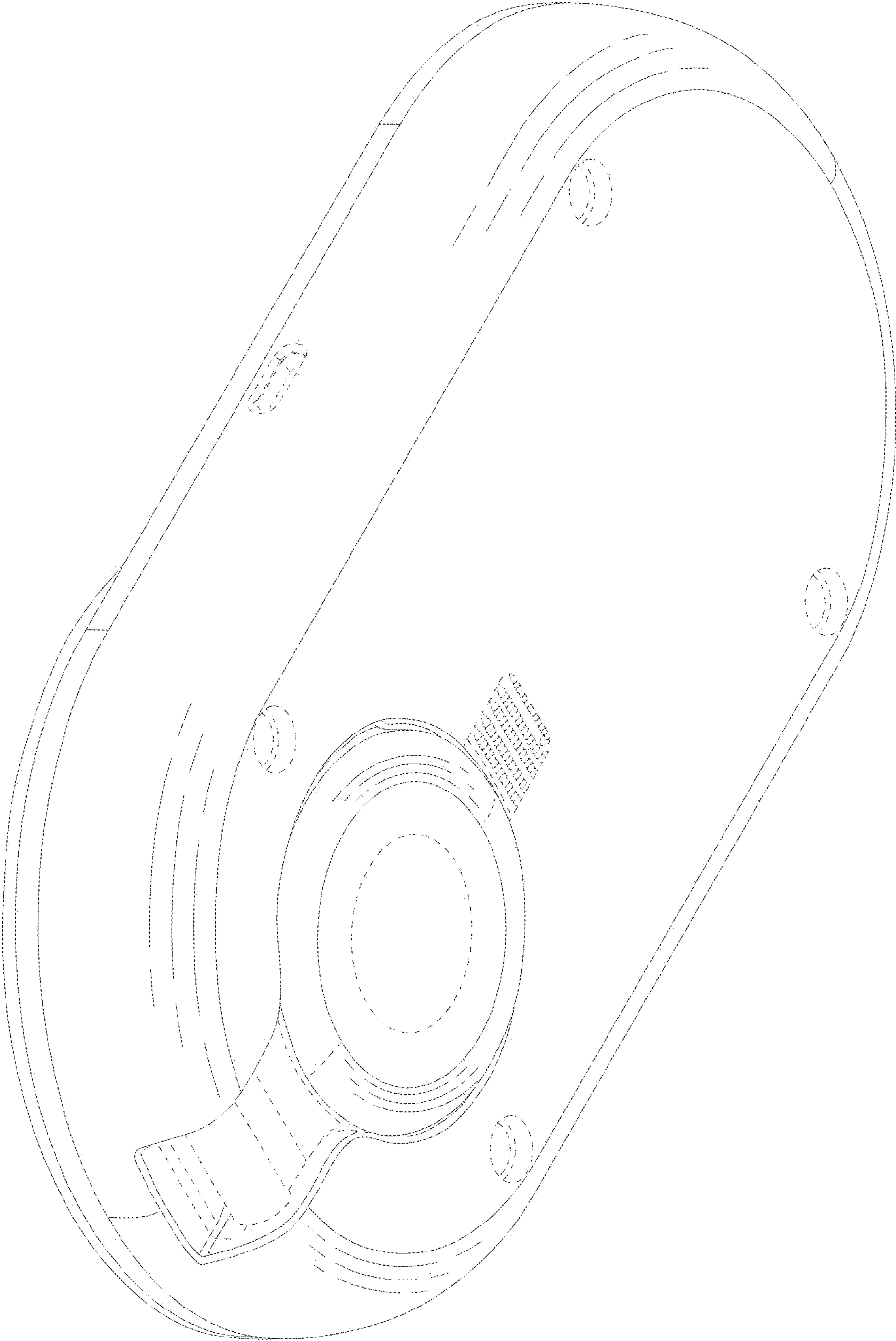
