**DESCRIPTION**

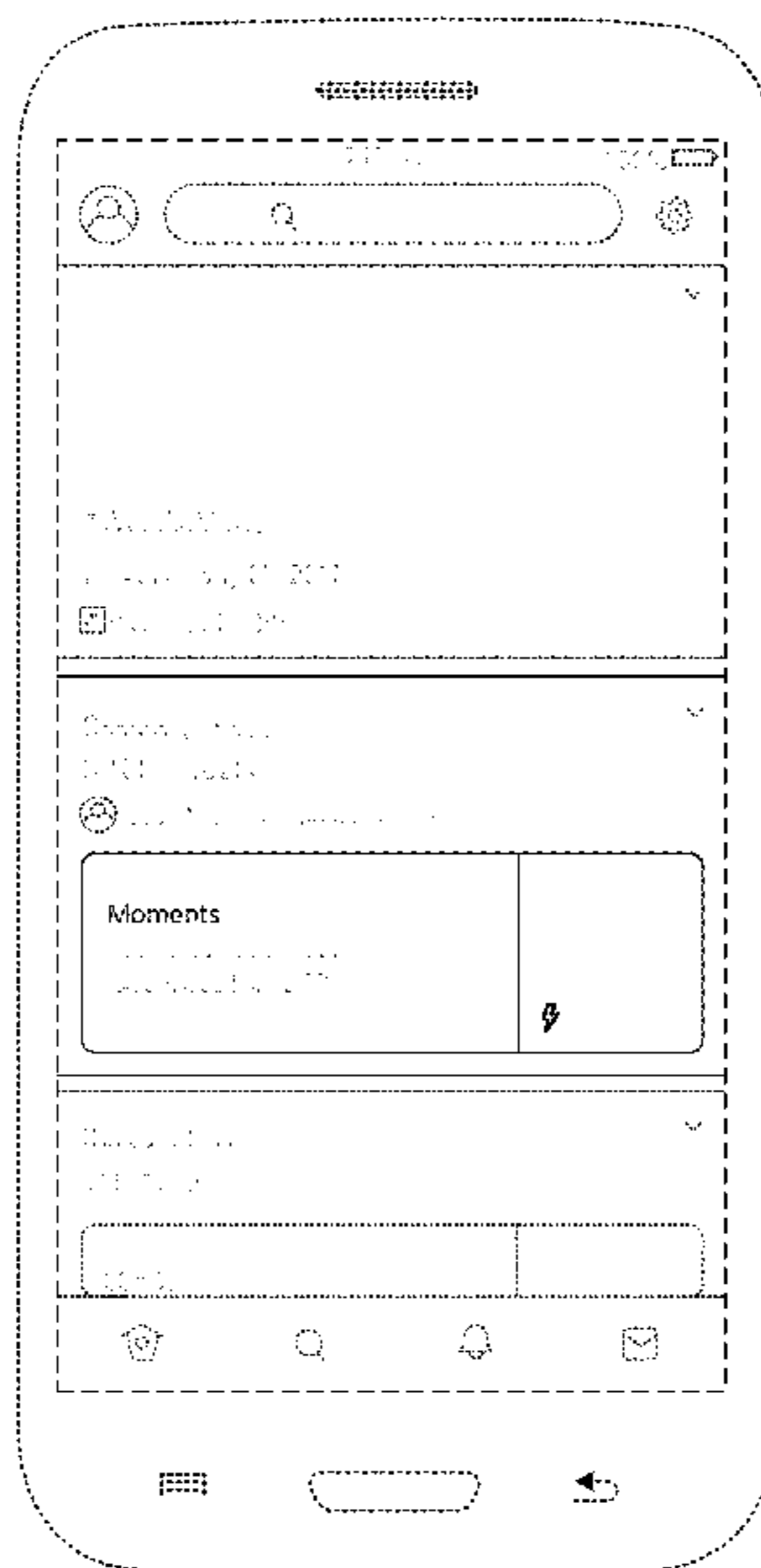
FIG. 1 is a front view of a display screen with graphical user interface, showing a first embodiment of the new design.

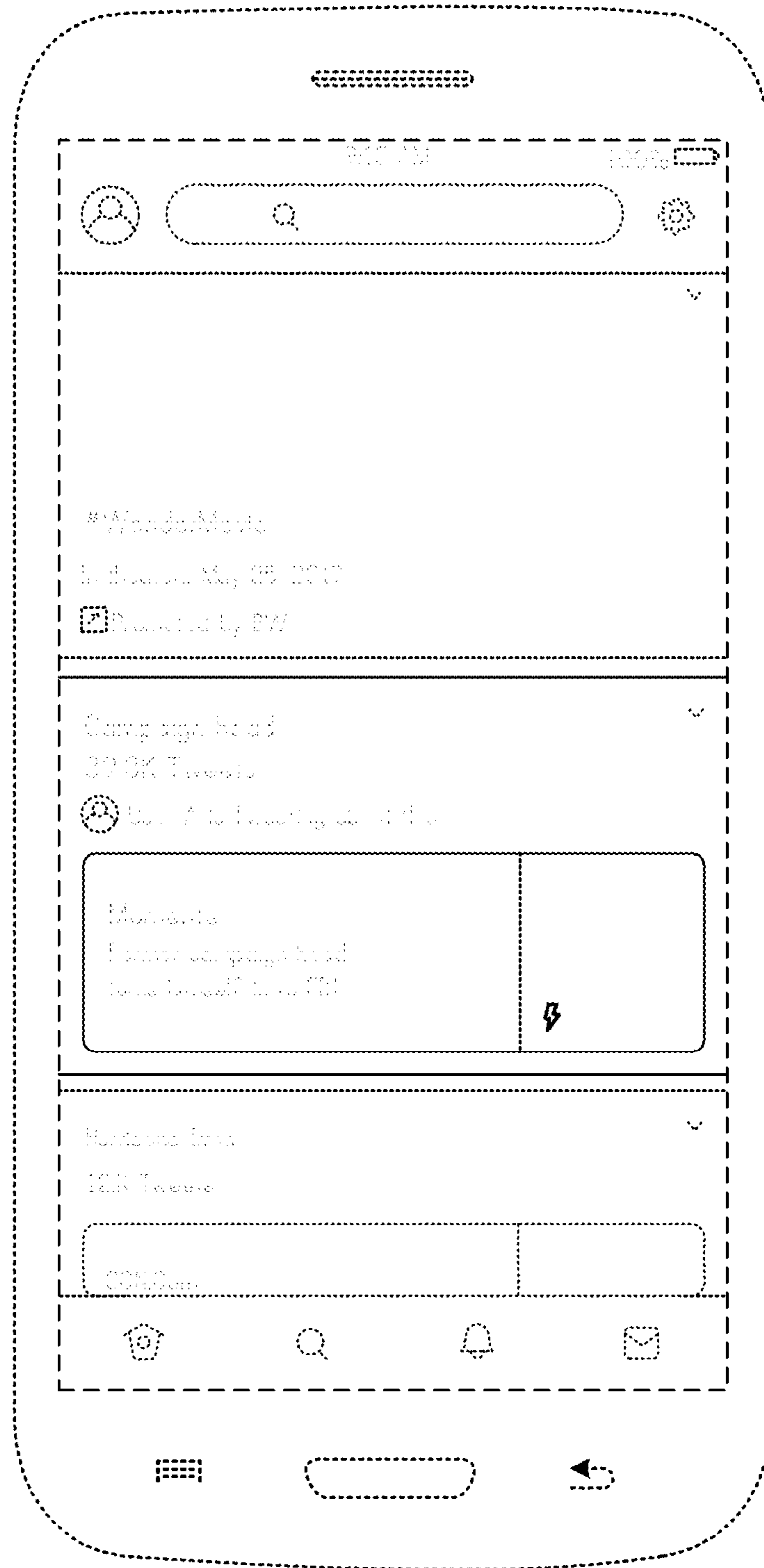

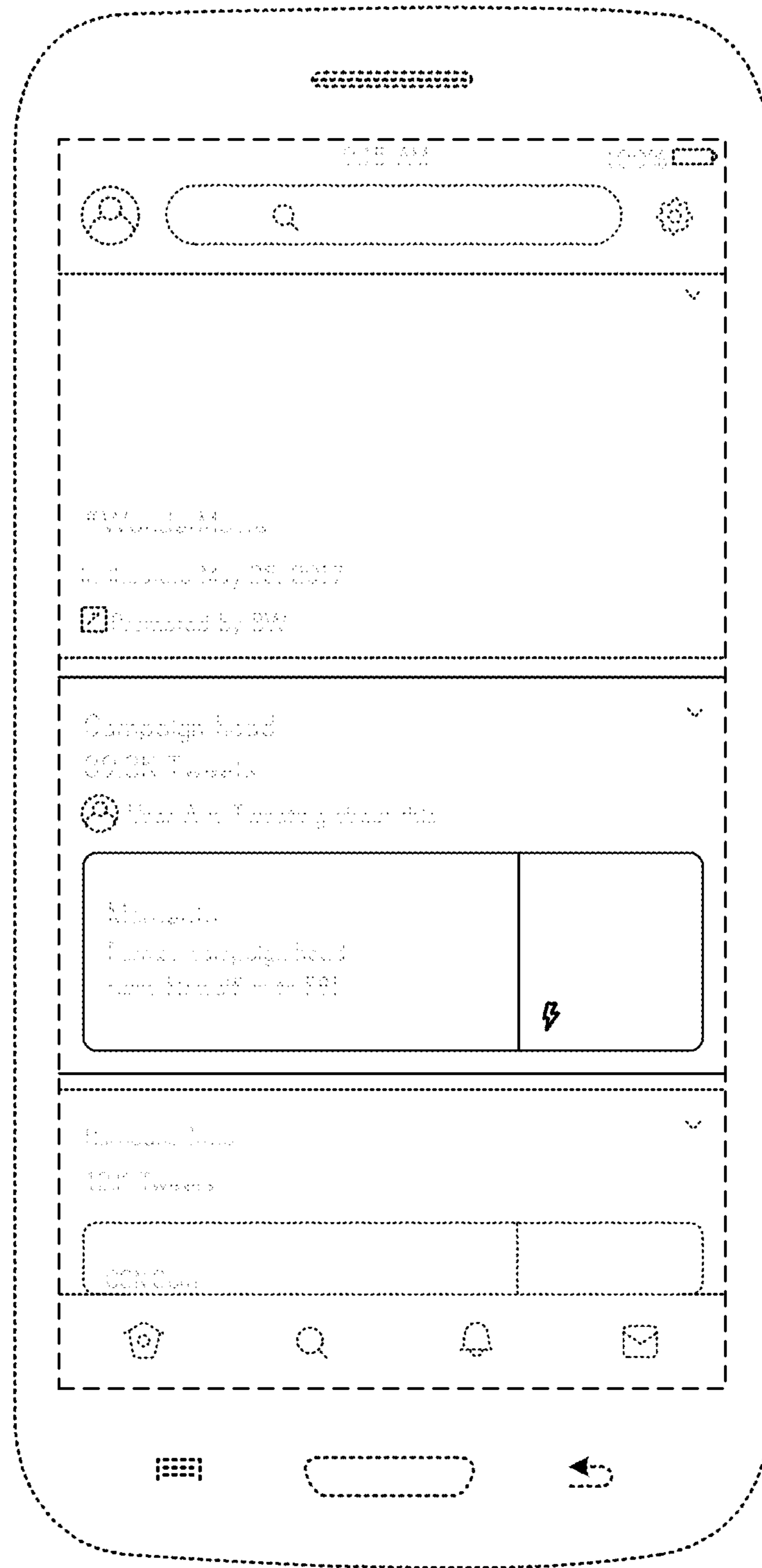

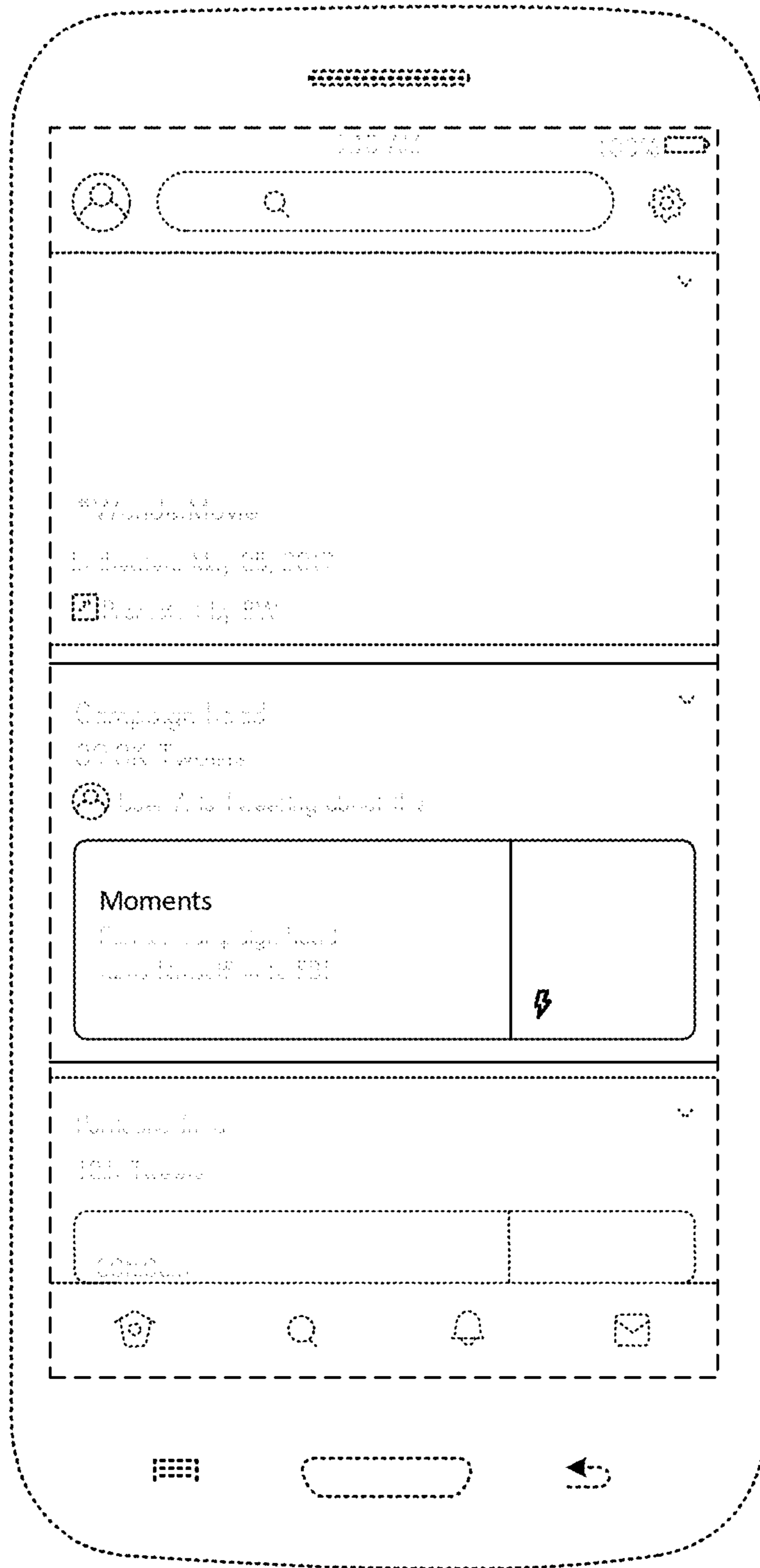
