DESCRIPTION

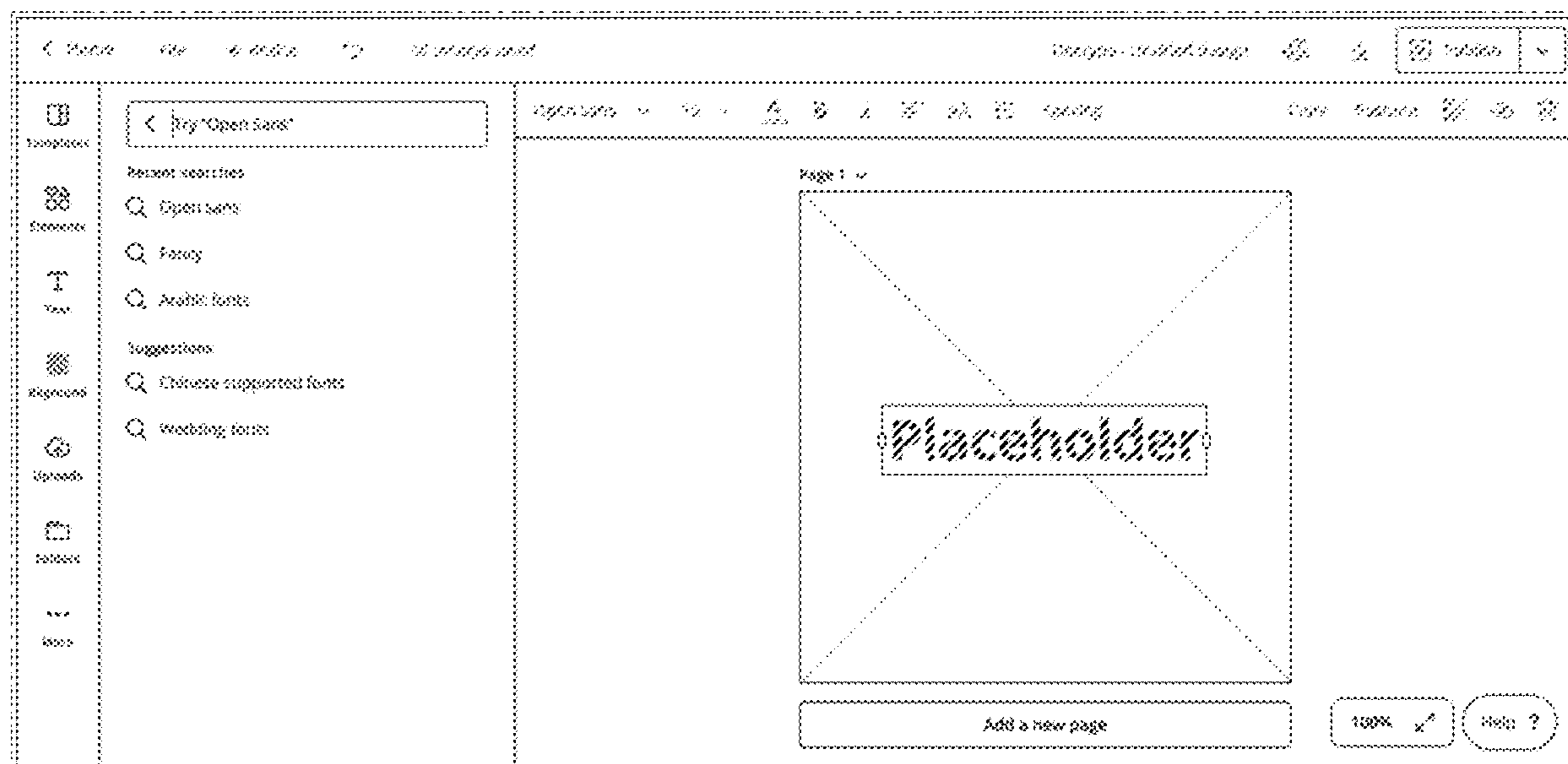
FIG. 1. is a front view of a display screen or portion thereof with a graphical user interface in accordance with a first embodiment;

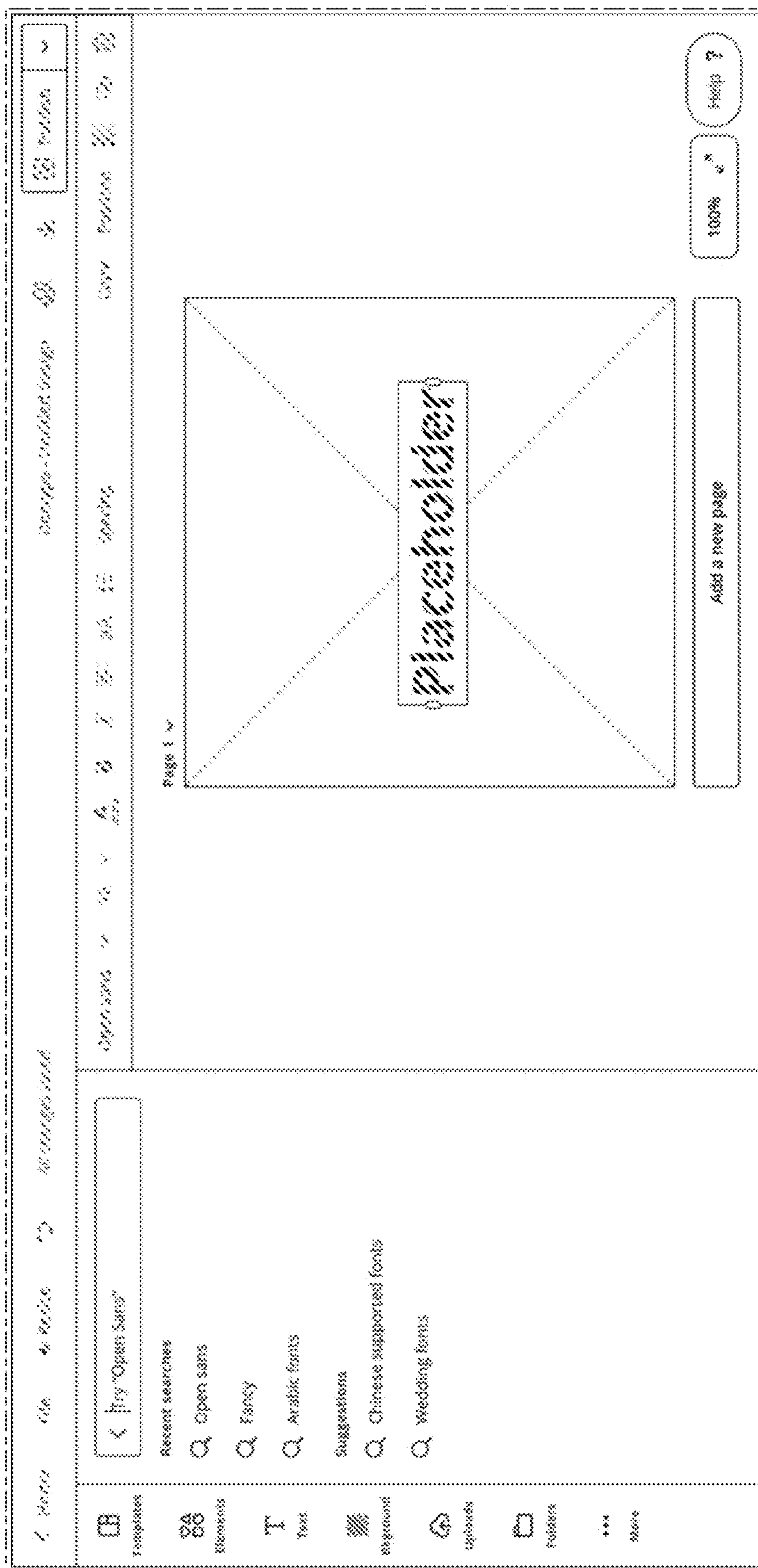

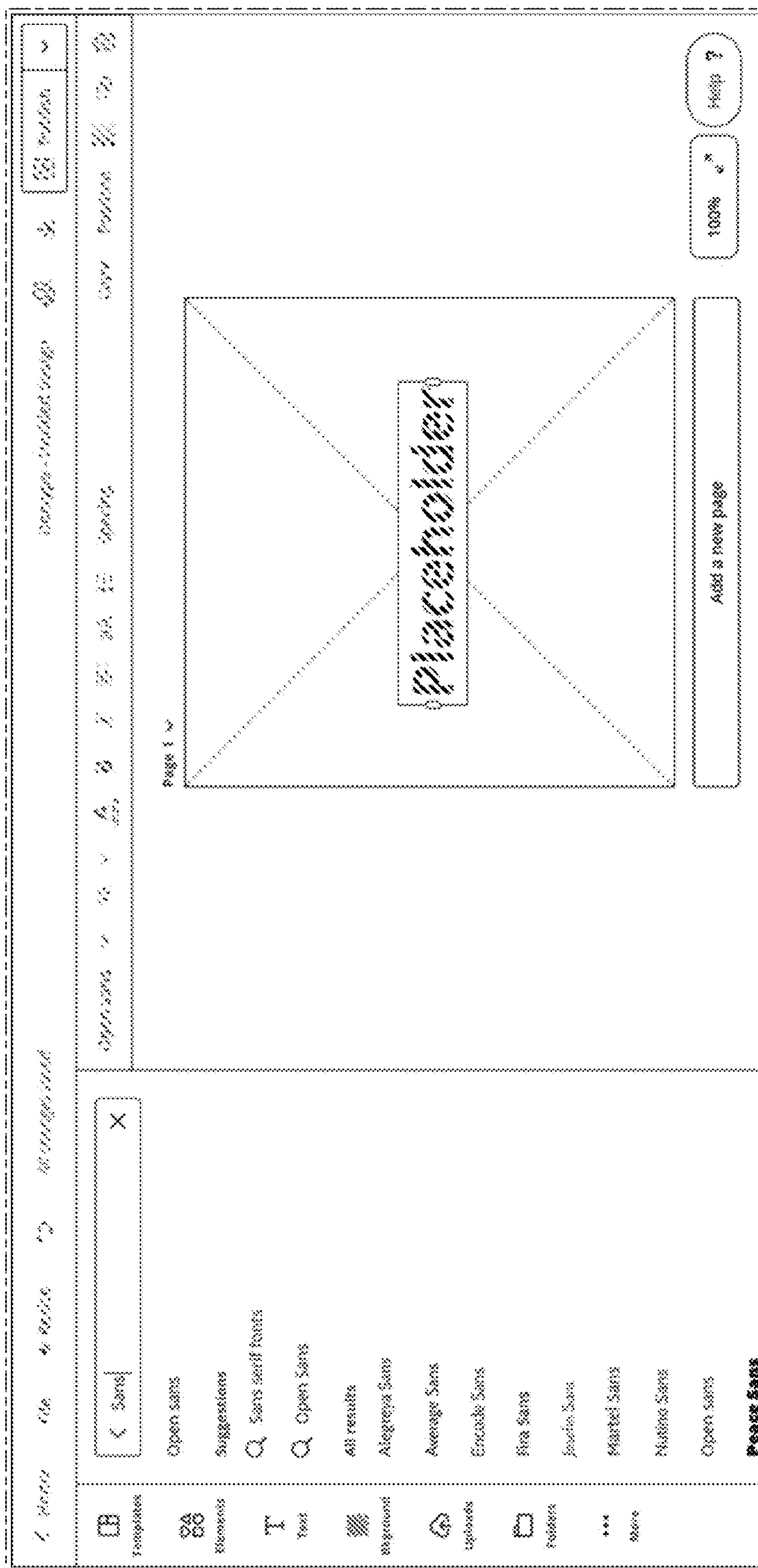

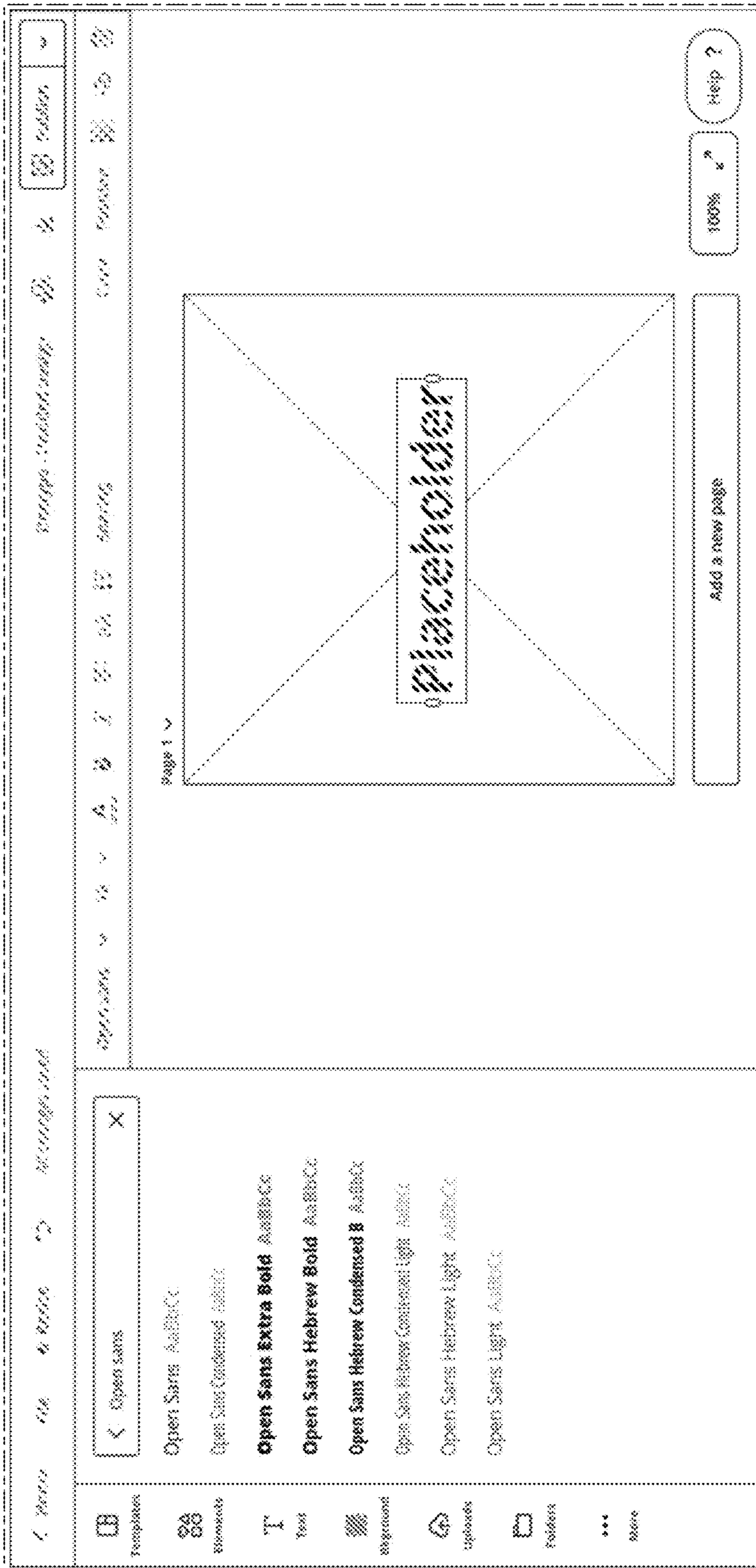
