FIG. 1.10 is another perspective view shown thereof, in an open configuration.

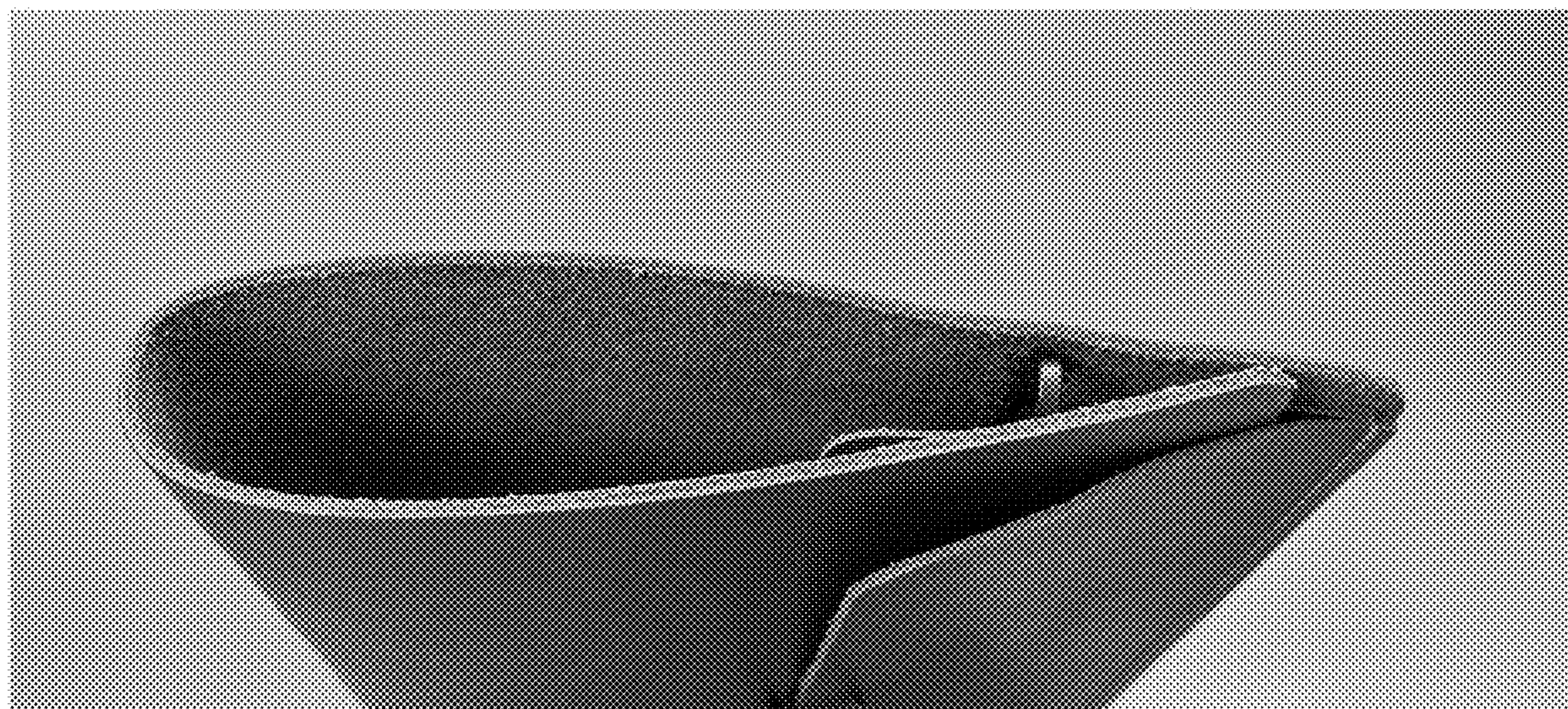

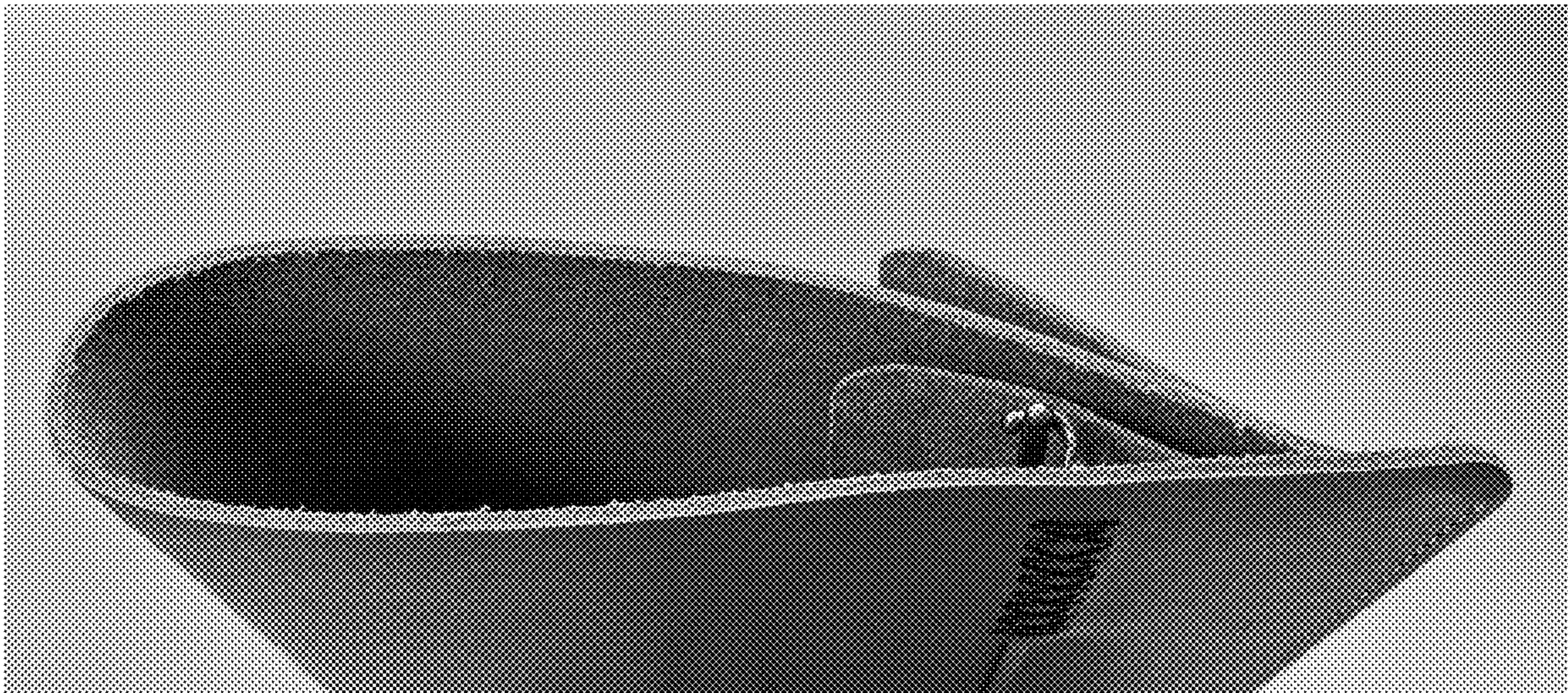

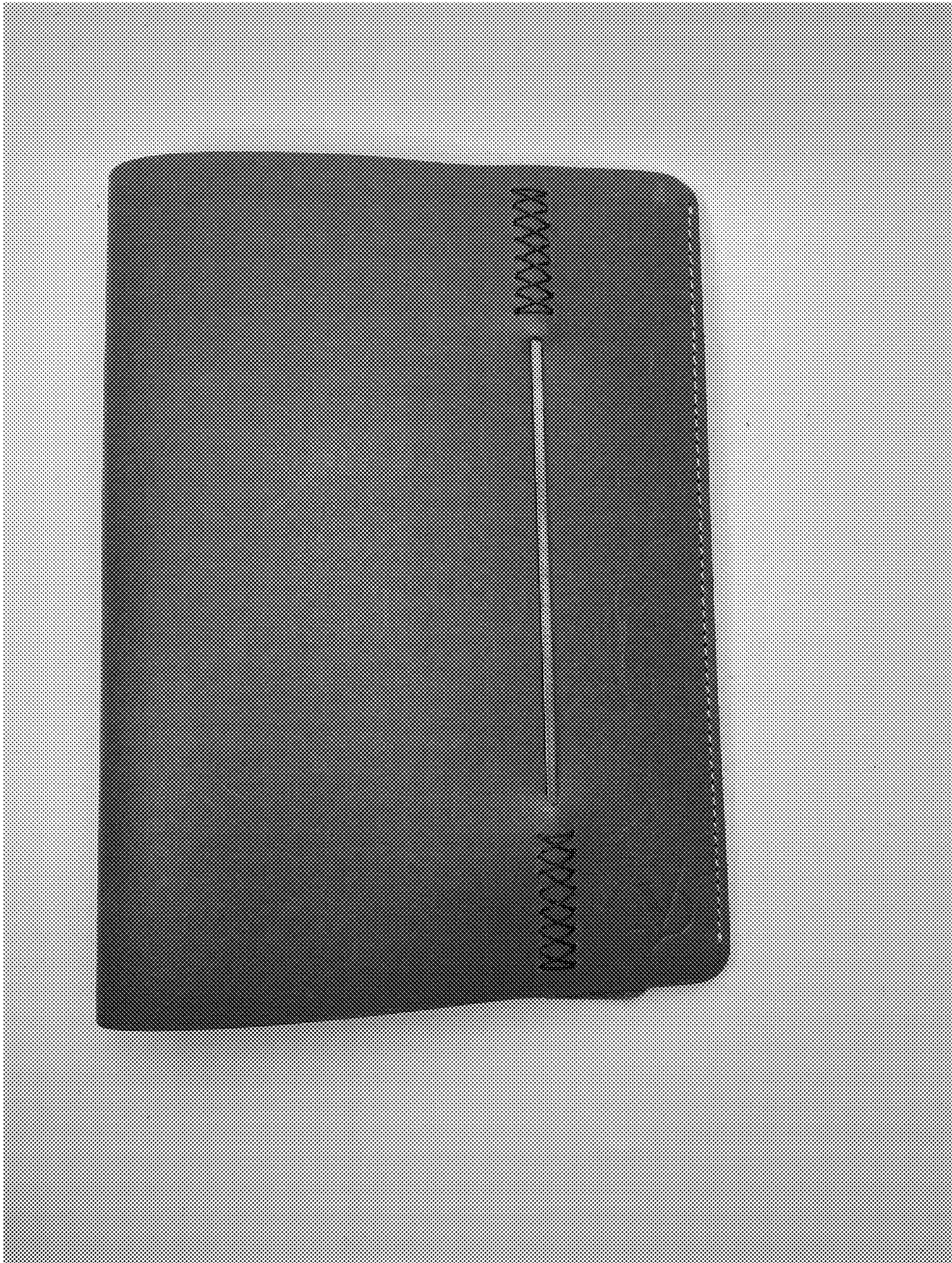

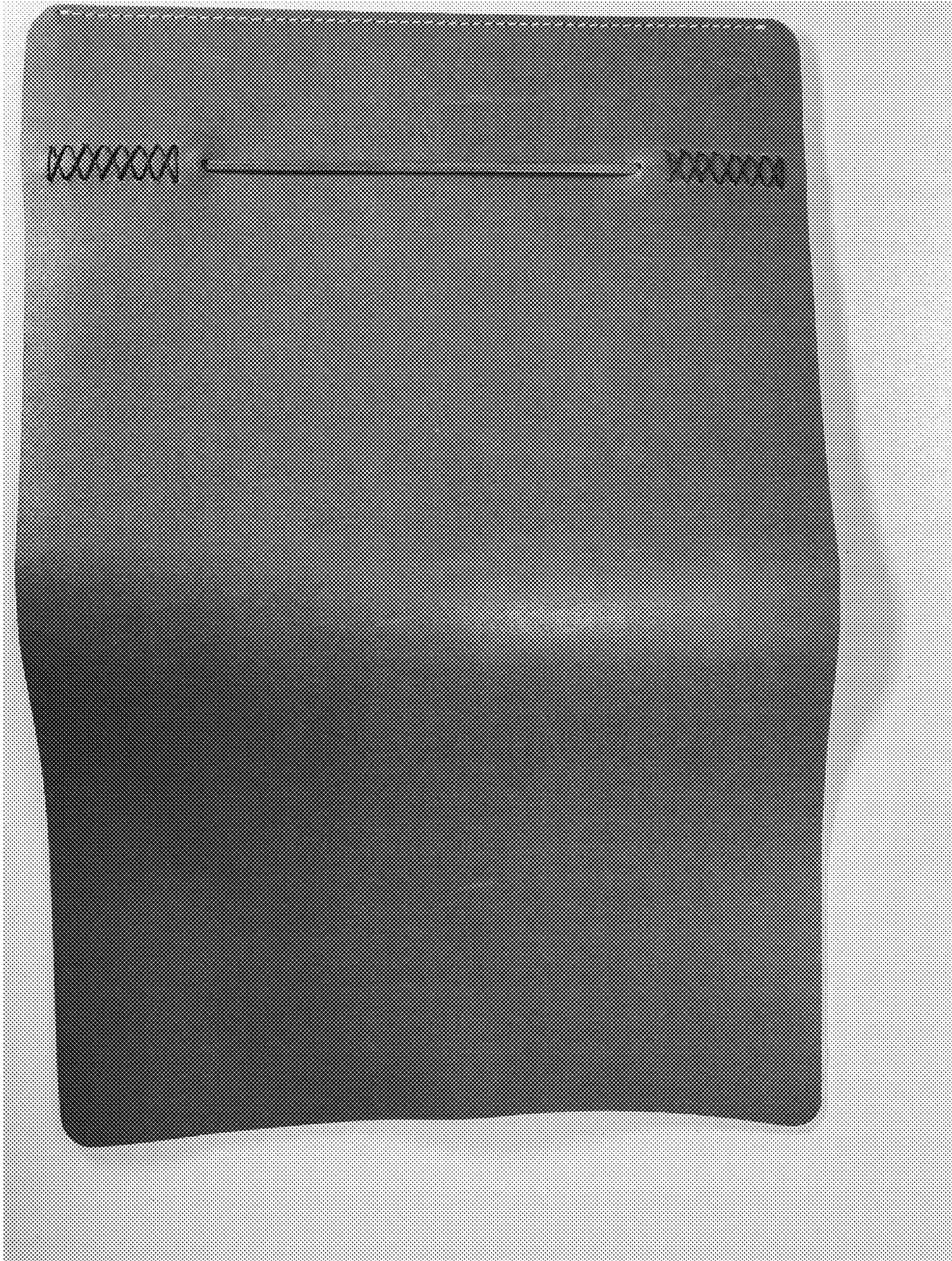

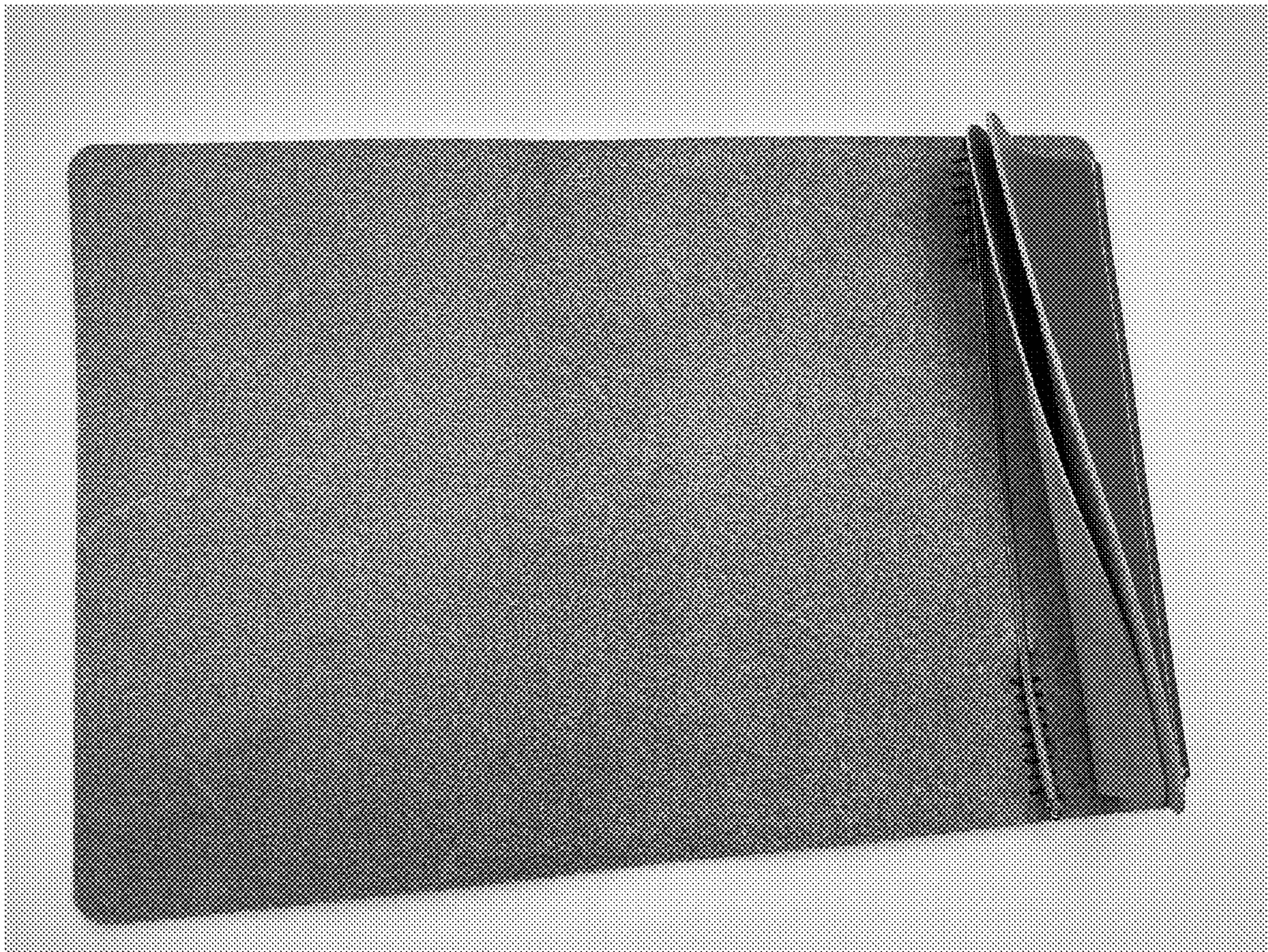
