DESCRIPTION

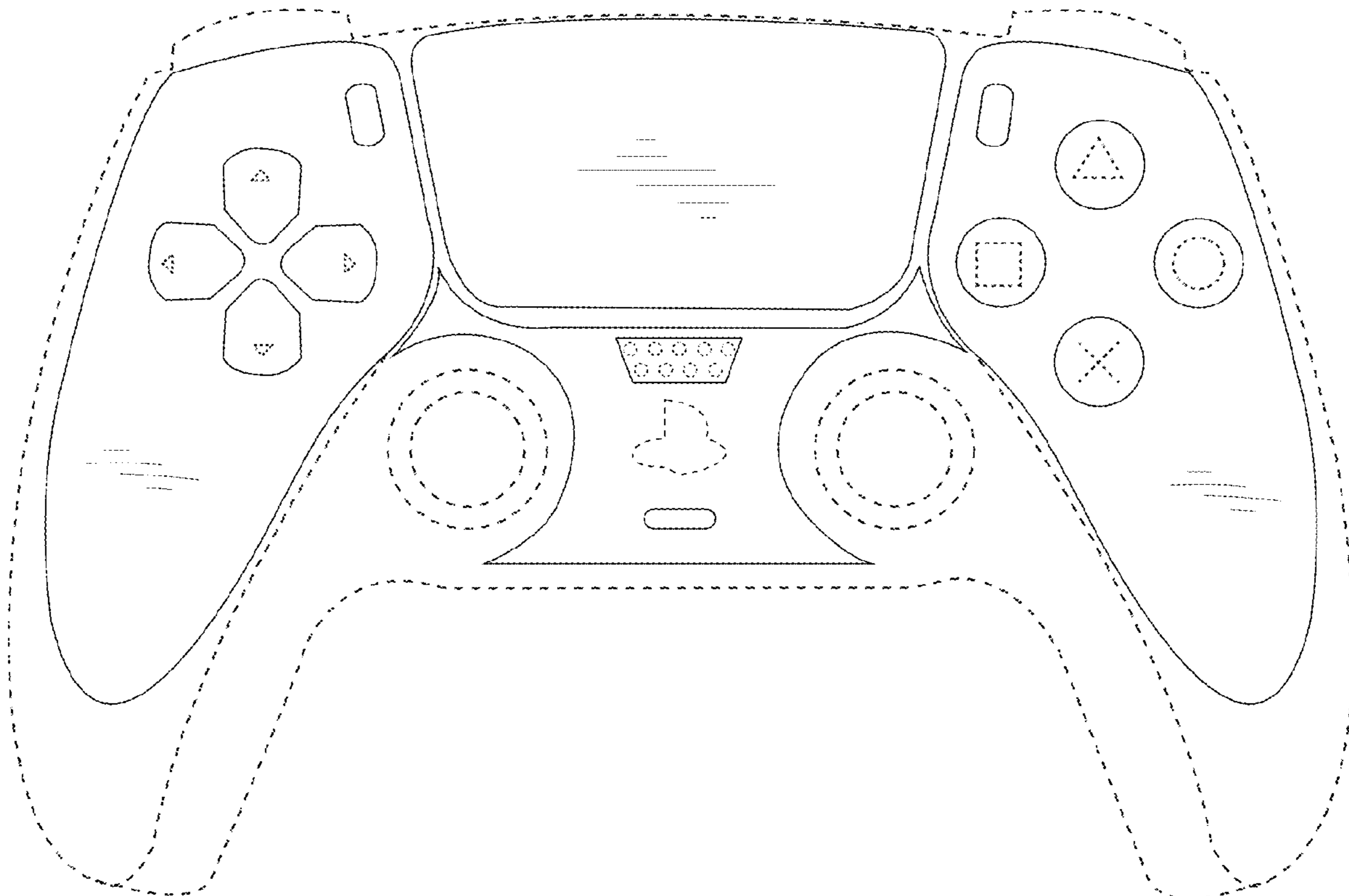
FIG. 1 is a front view of a sticker, embodying my new design;

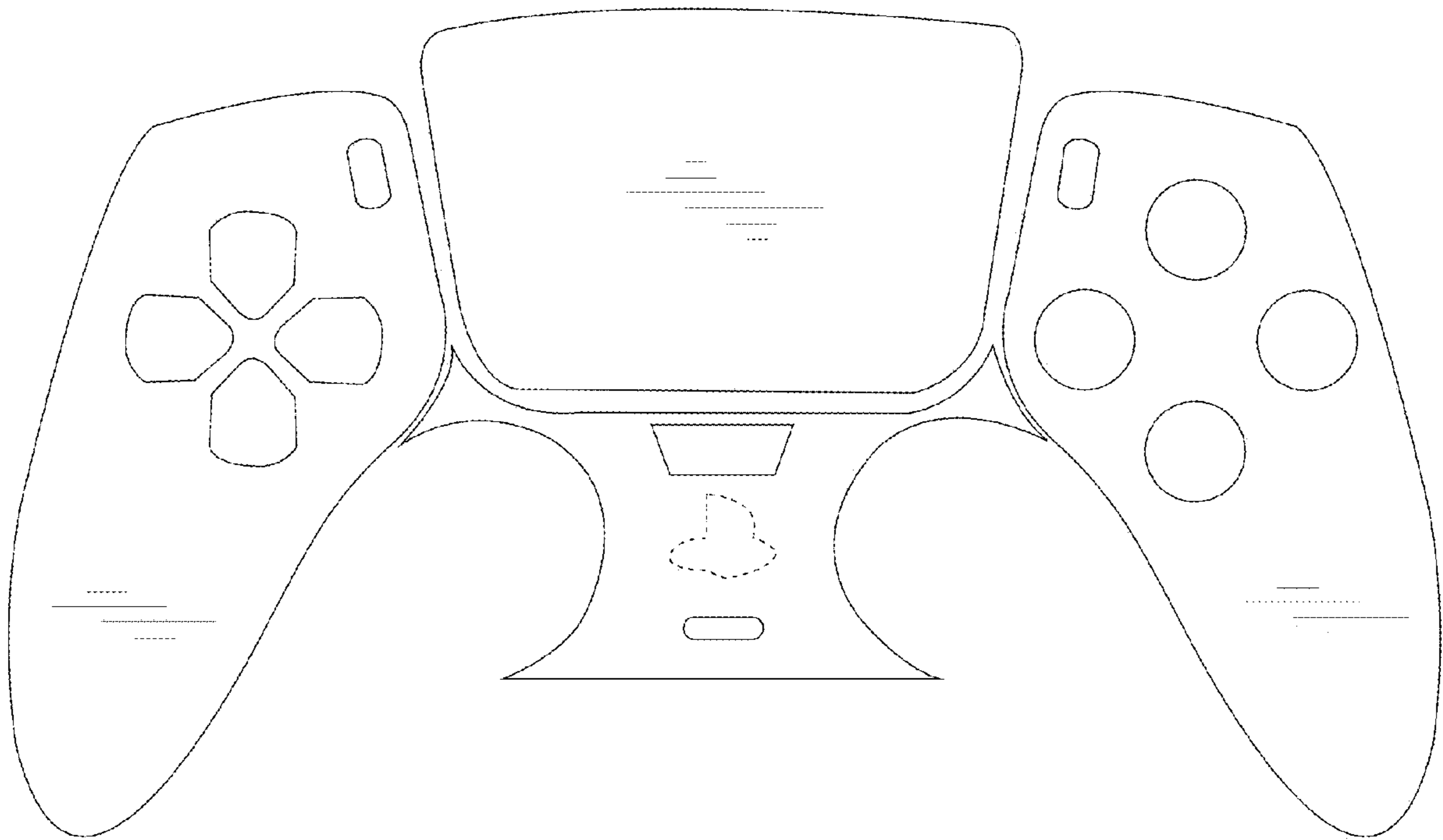

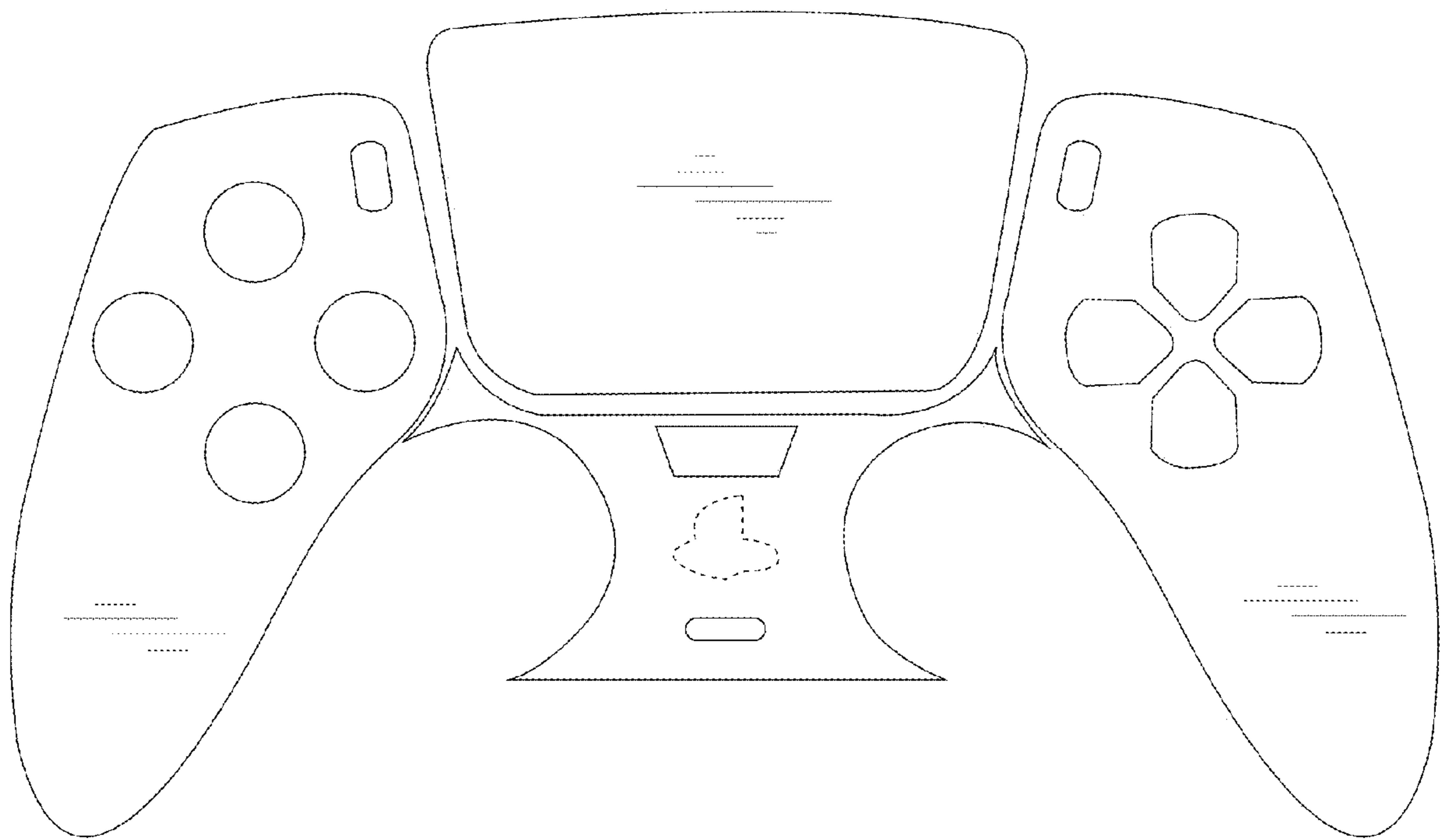

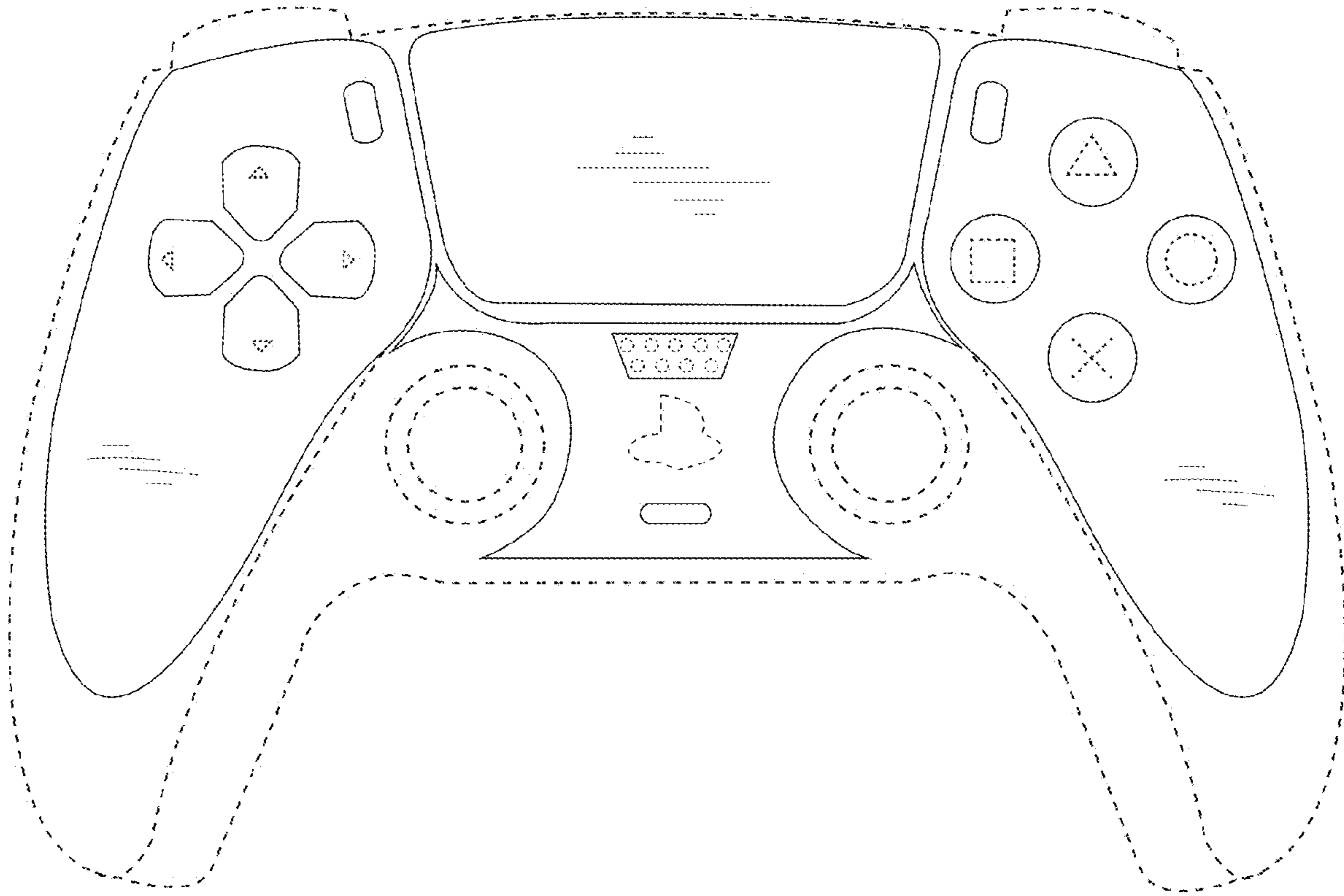
