(57) **CLAIM**

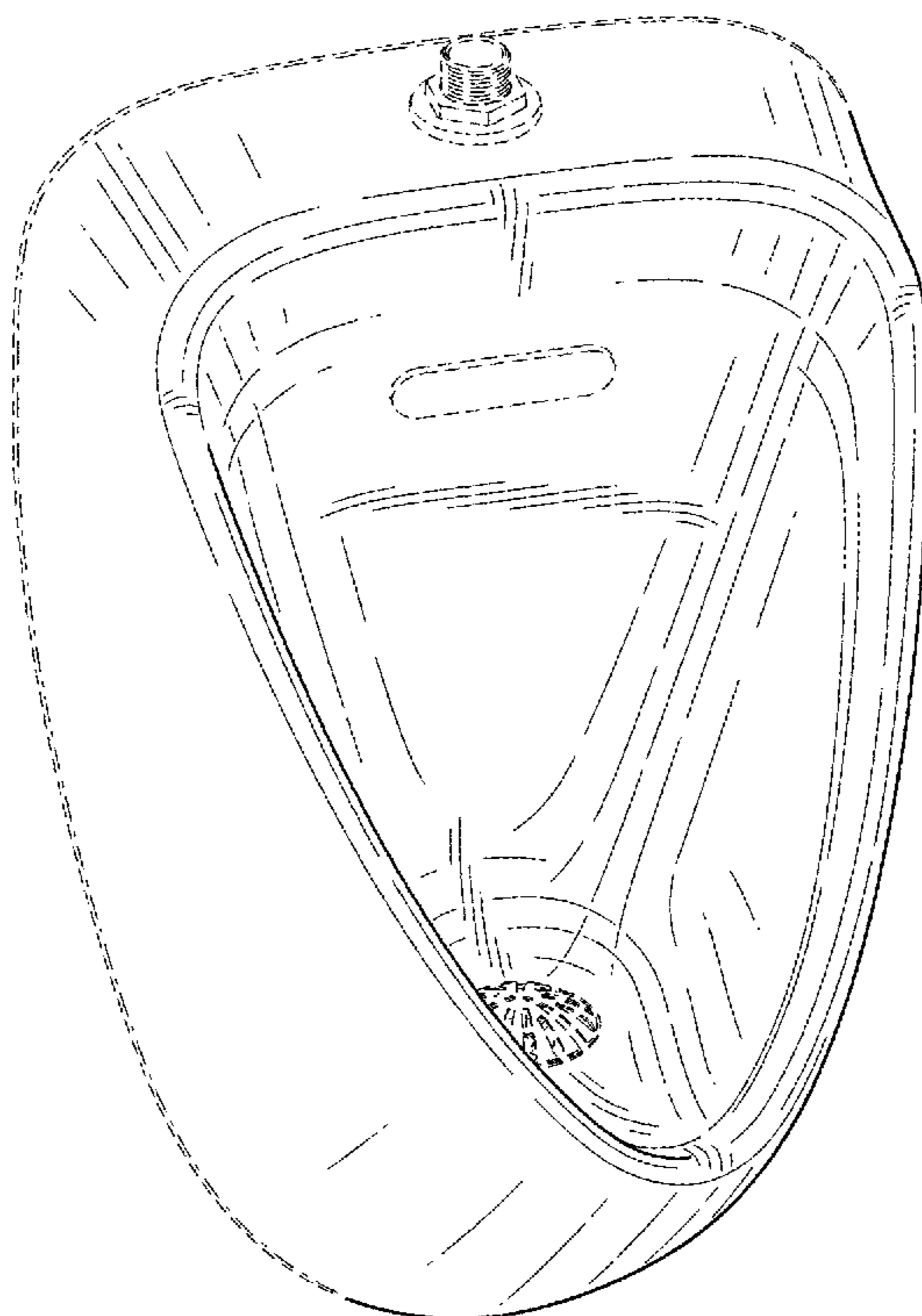
We claim the ornamental design for a urinal, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of the claimed design;  
FIG. 2 is a front view of the claimed design shown in FIG. 1;  
FIG. 3 is a rear view of the claimed design shown in FIG. 1;  
FIG. 4 is a side view of the claimed design shown in FIG. 1;

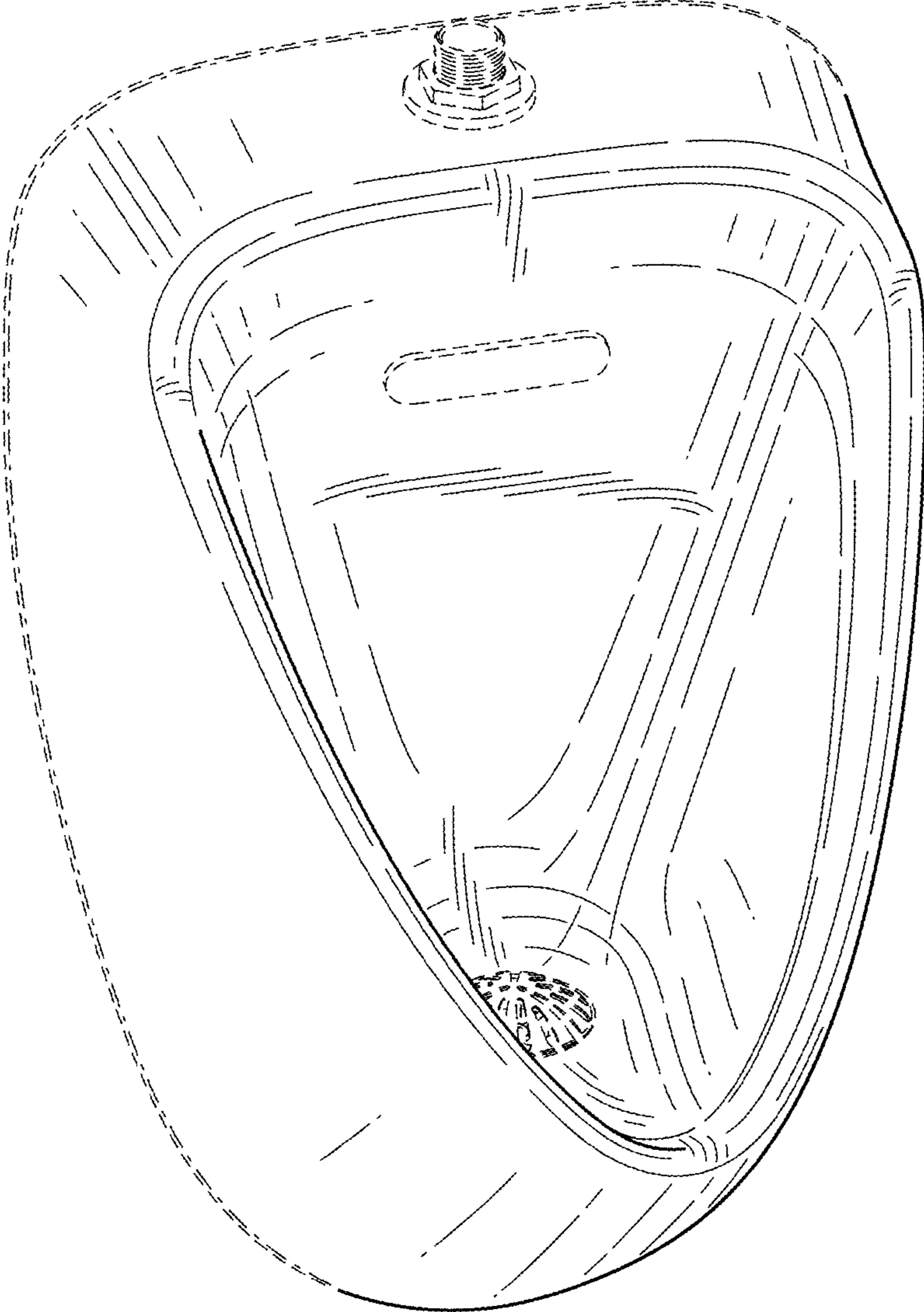

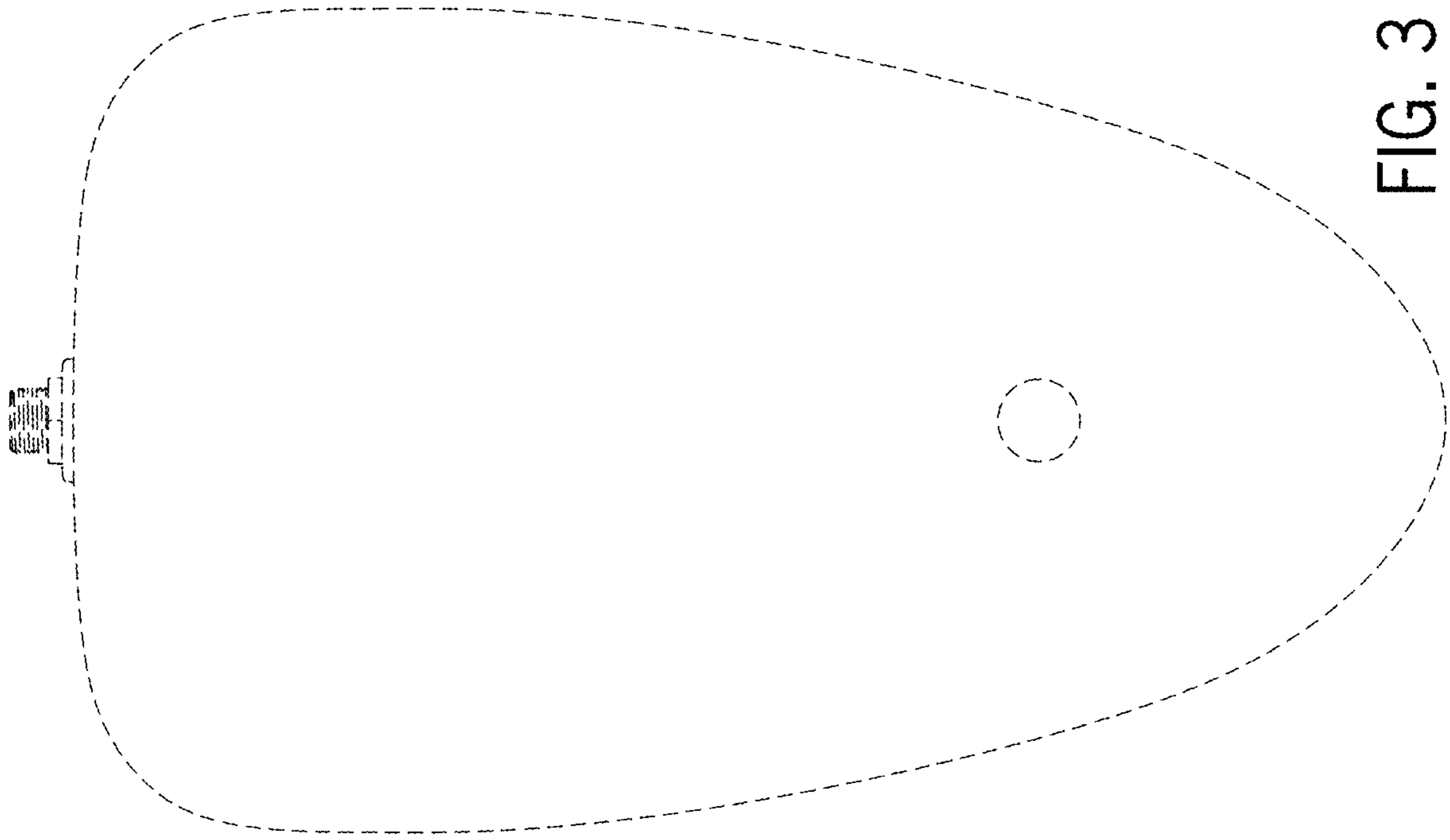

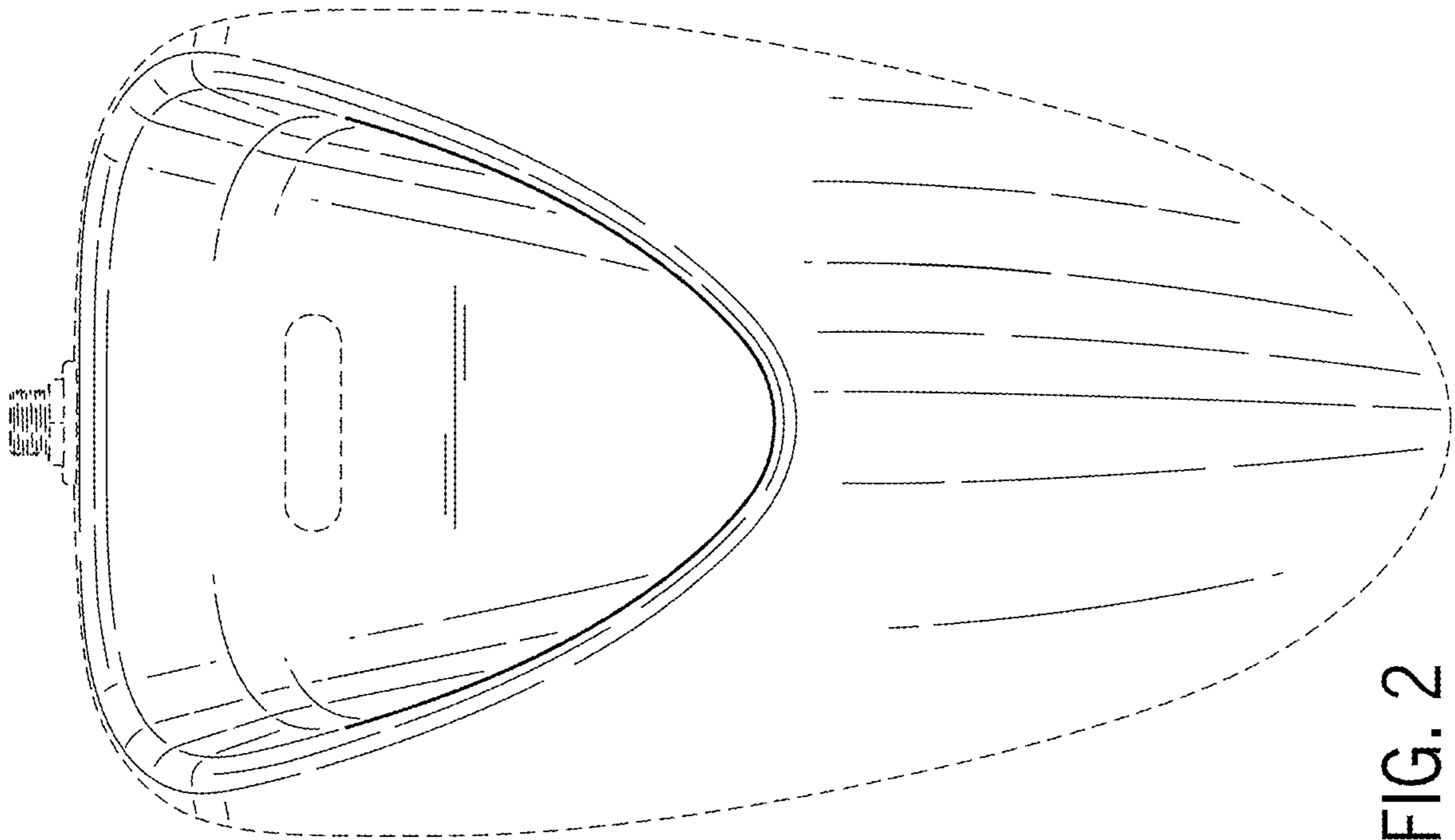

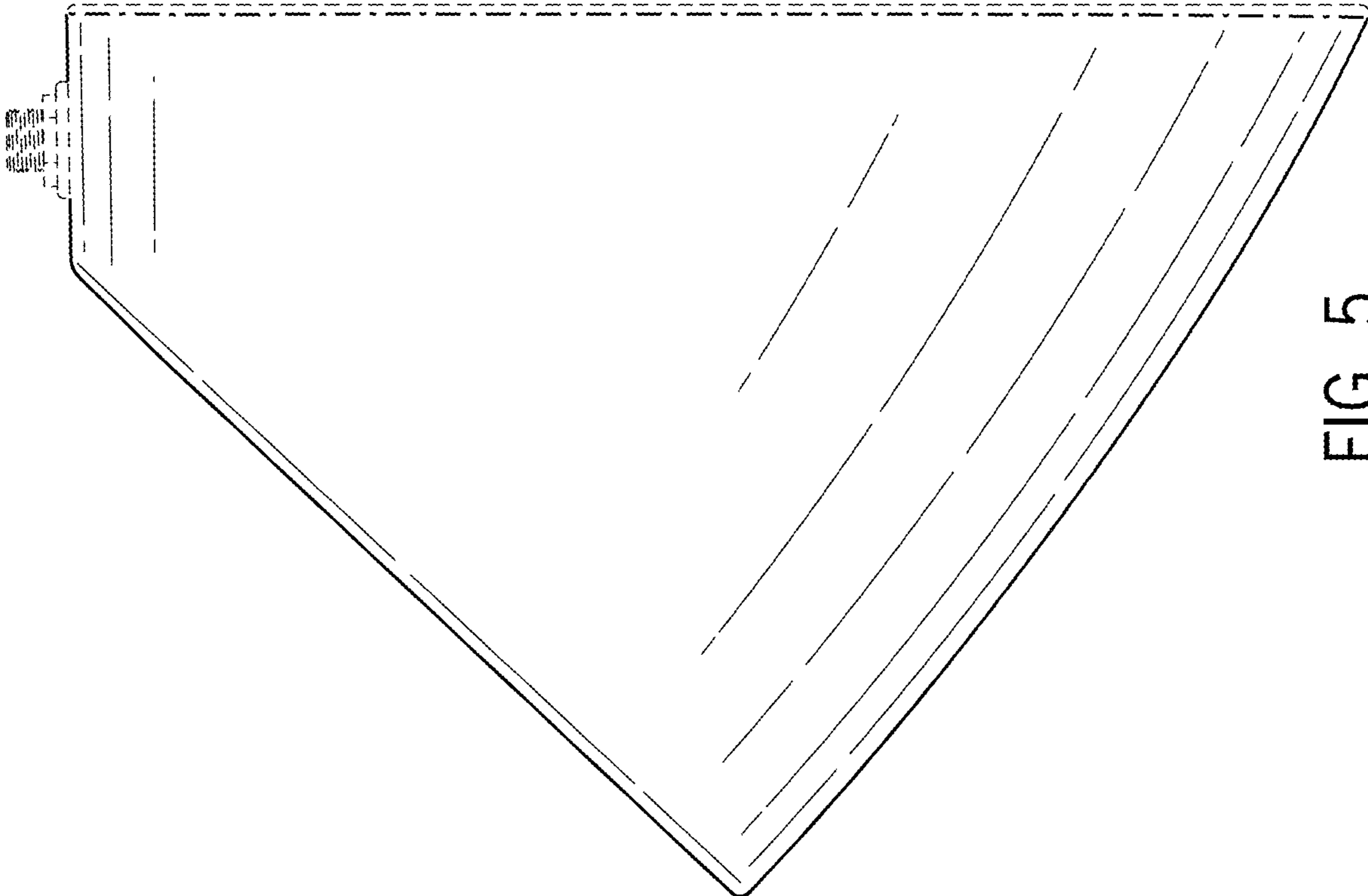

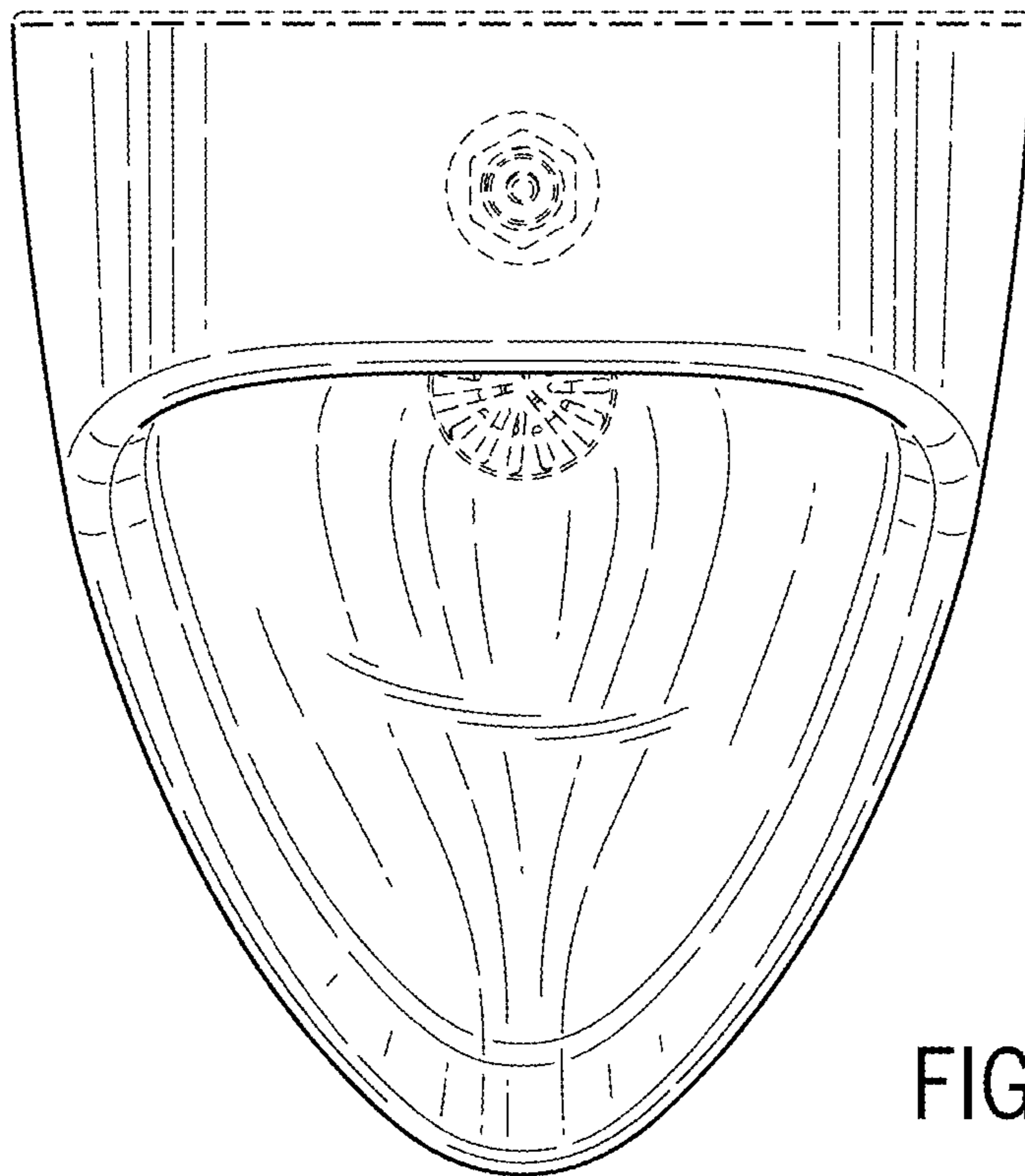

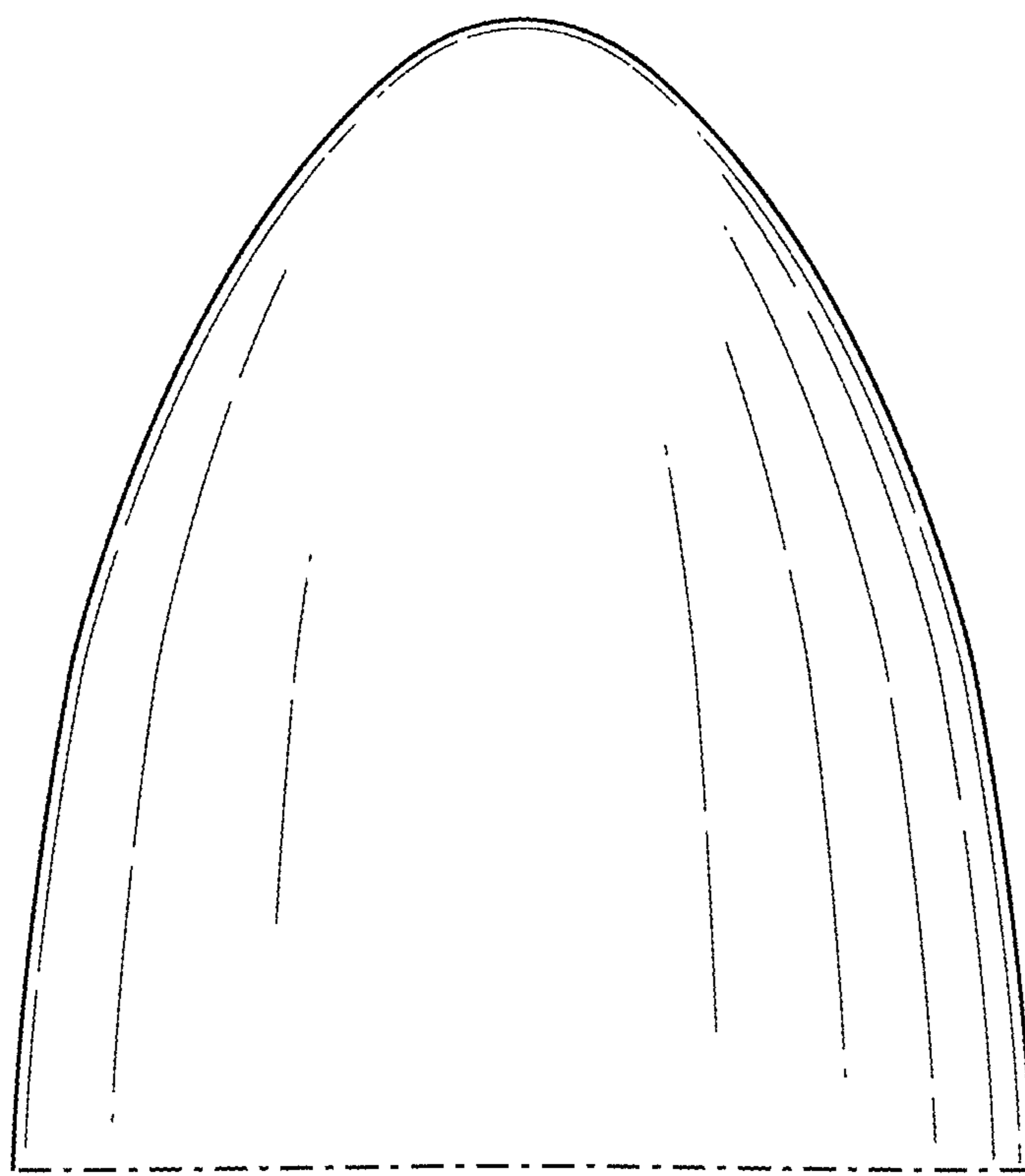
