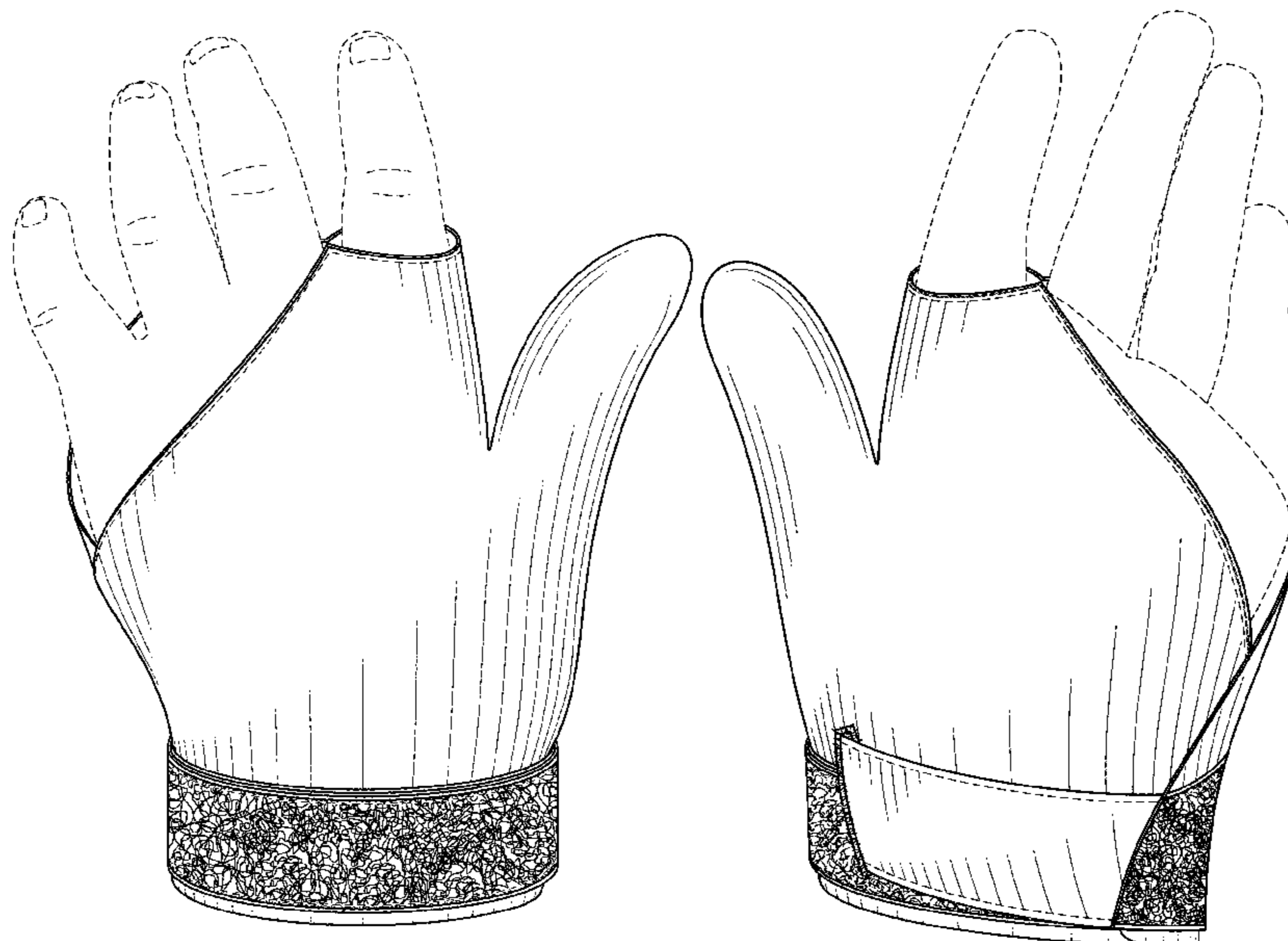
(57) **CLAIM**

The ornamental design for an adjustable thumb sucking prevention glove, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an adjustable thumb sucking prevention glove in a fastened position showing the claimed design.
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a right-side view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a front perspective view of the adjustable thumb sucking prevention glove in an unfastened position; and,
FIG. 6 is a rear perspective view thereof.
The broken line showing of a hand in FIGS. 1 through 4 is for the purpose of showing the design in a condition of use, and the broken lines and environment they depict form no part of the claimed design. The broken lines on the surface of the adjustable thumb sucking prevention glove depict stitching, which also forms no part of the claimed design.

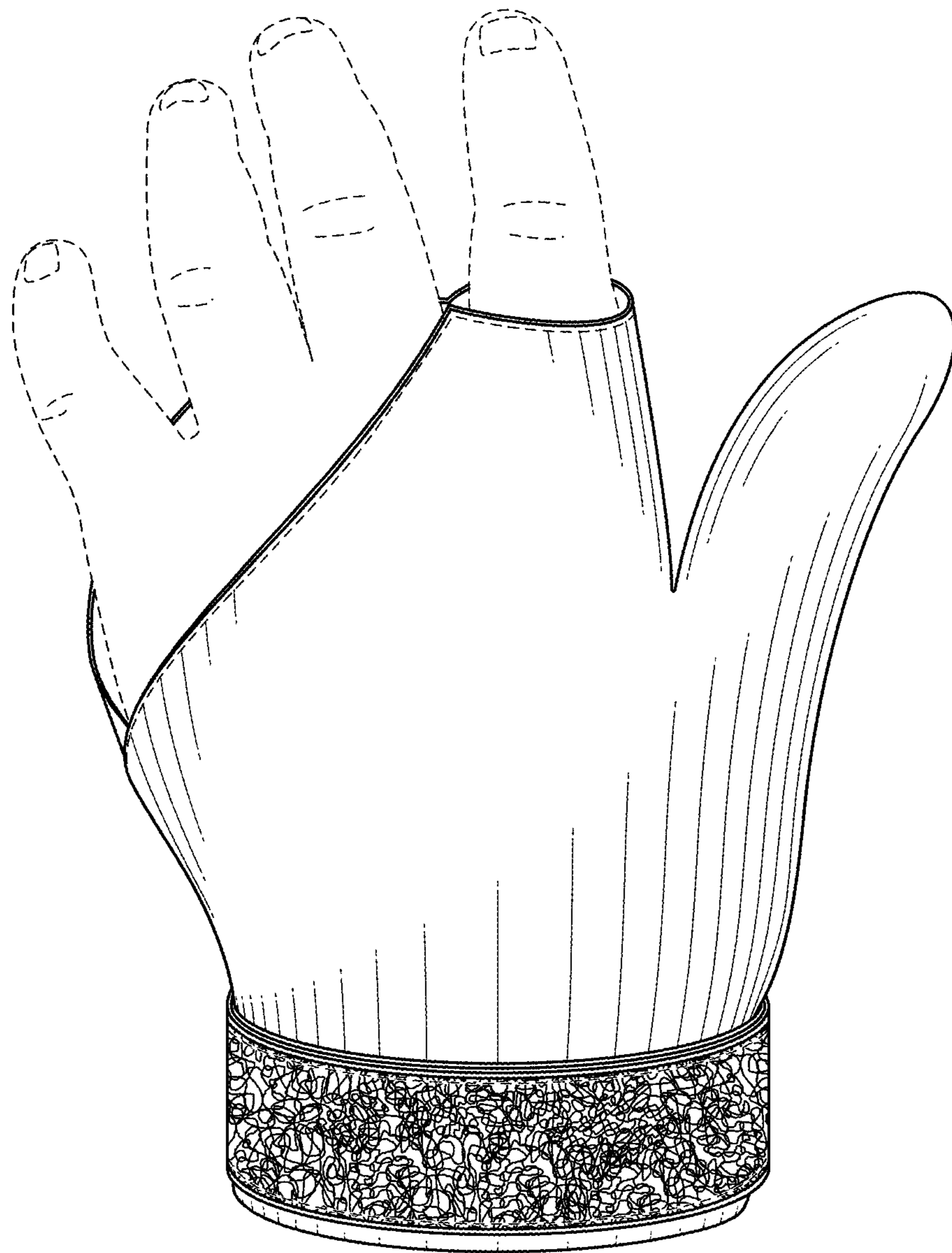

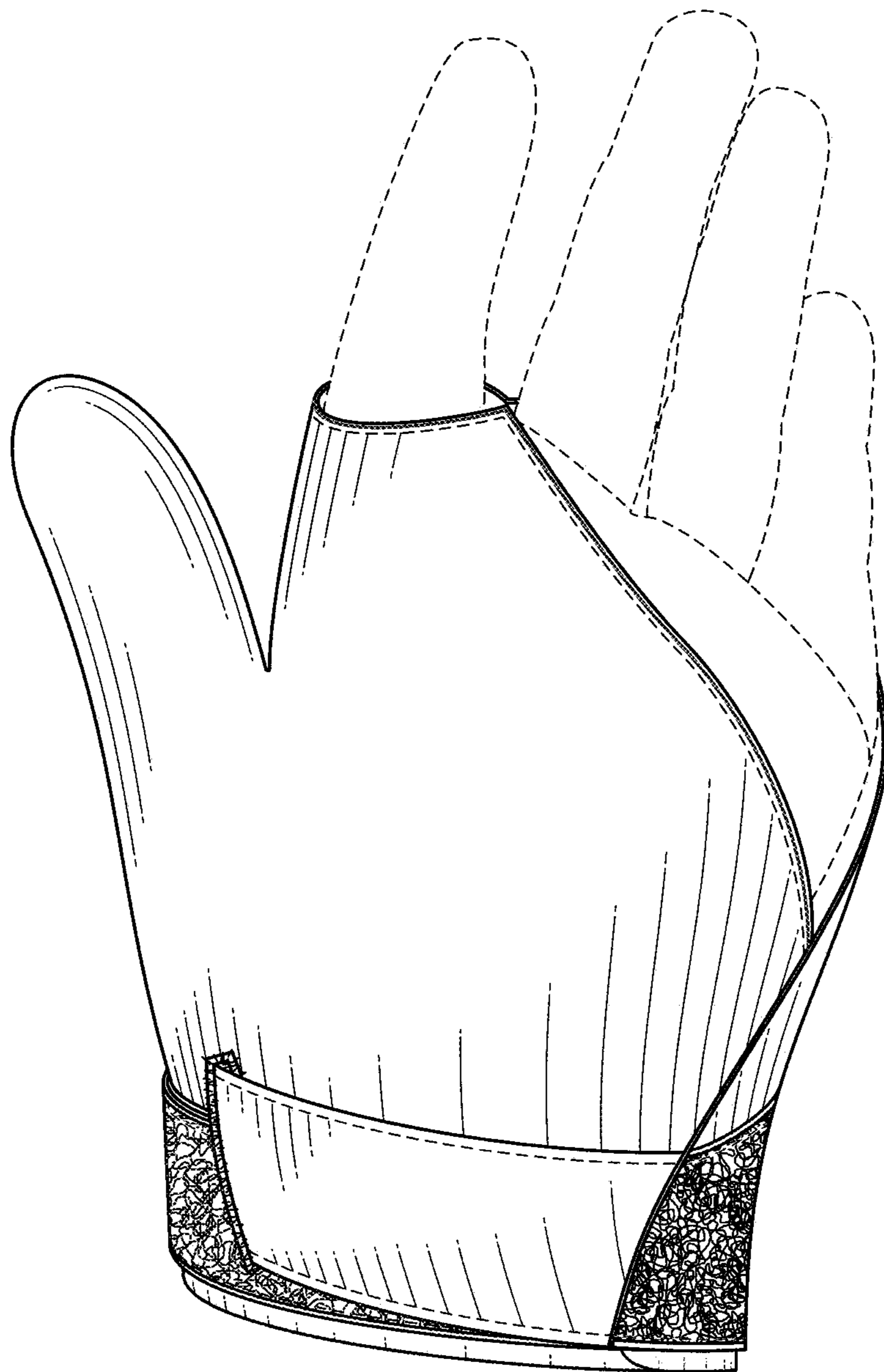

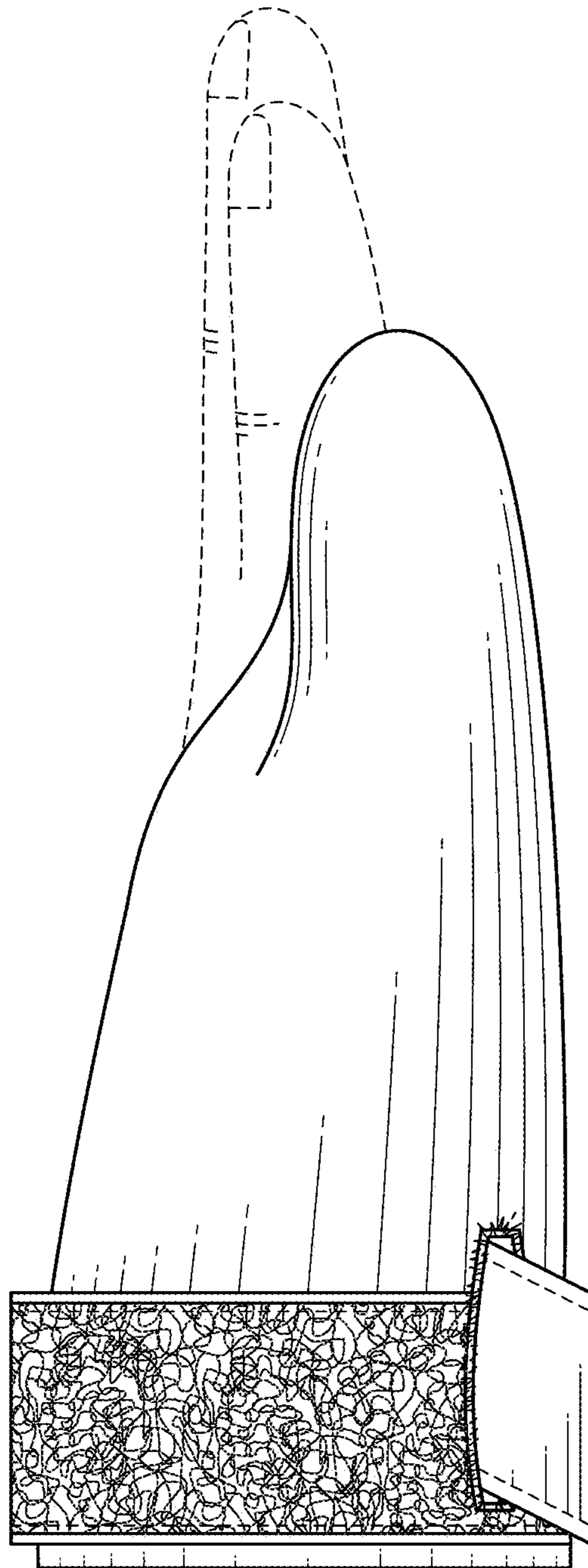

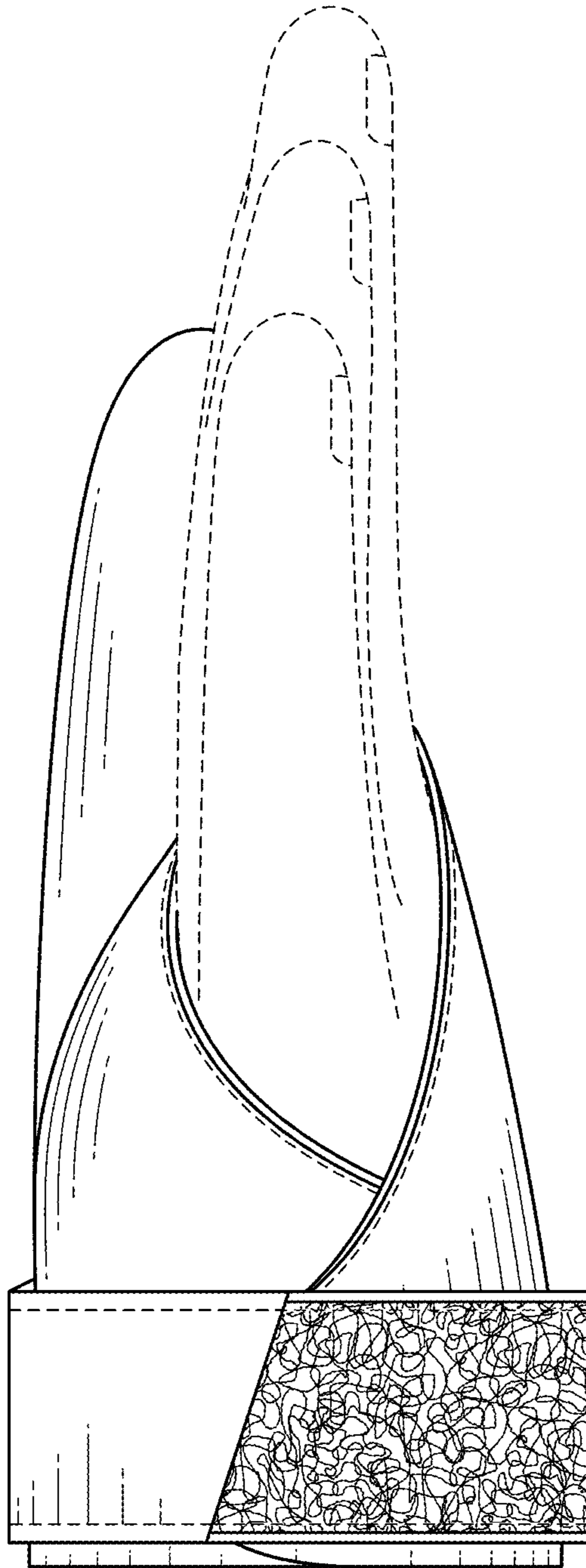

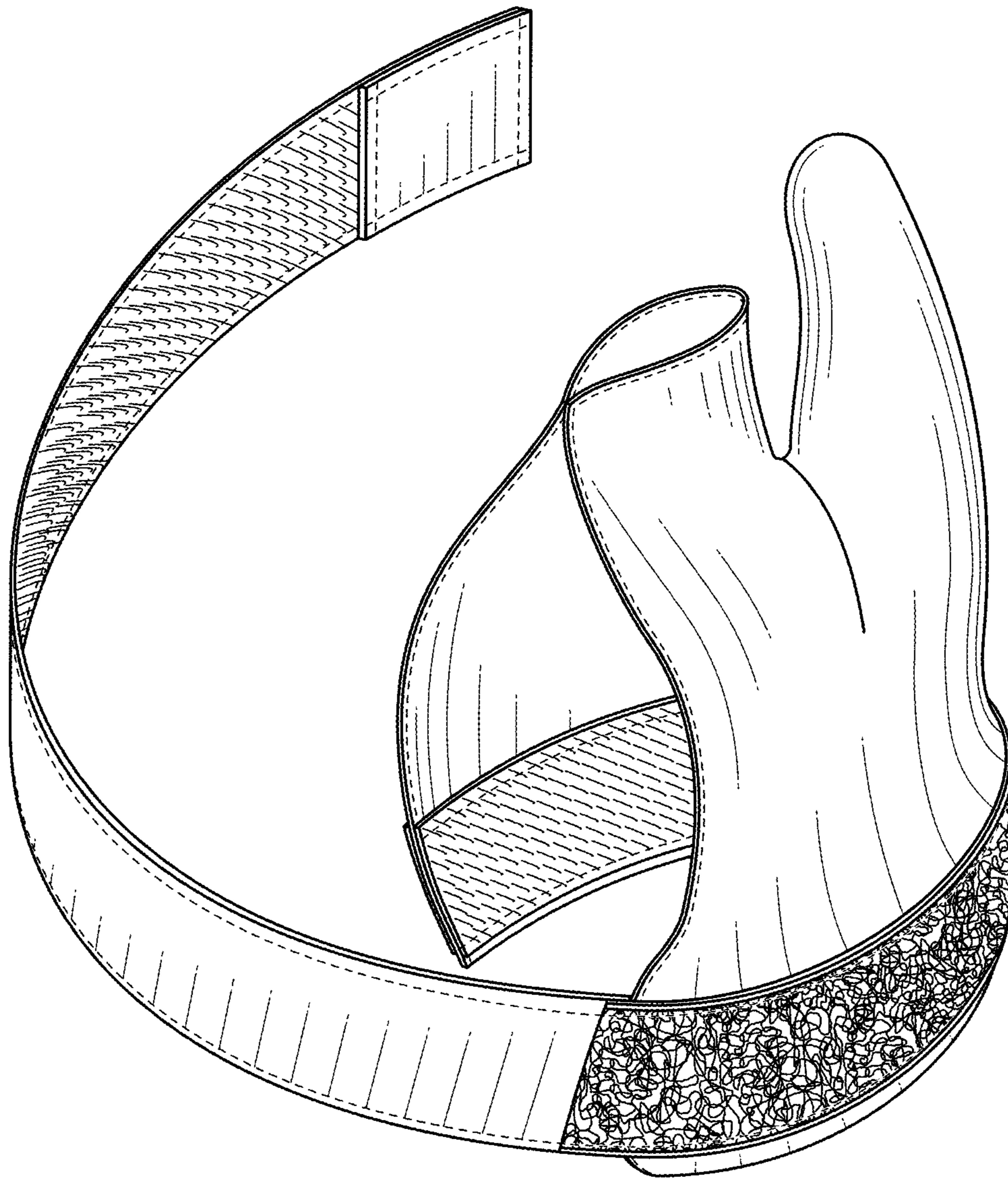

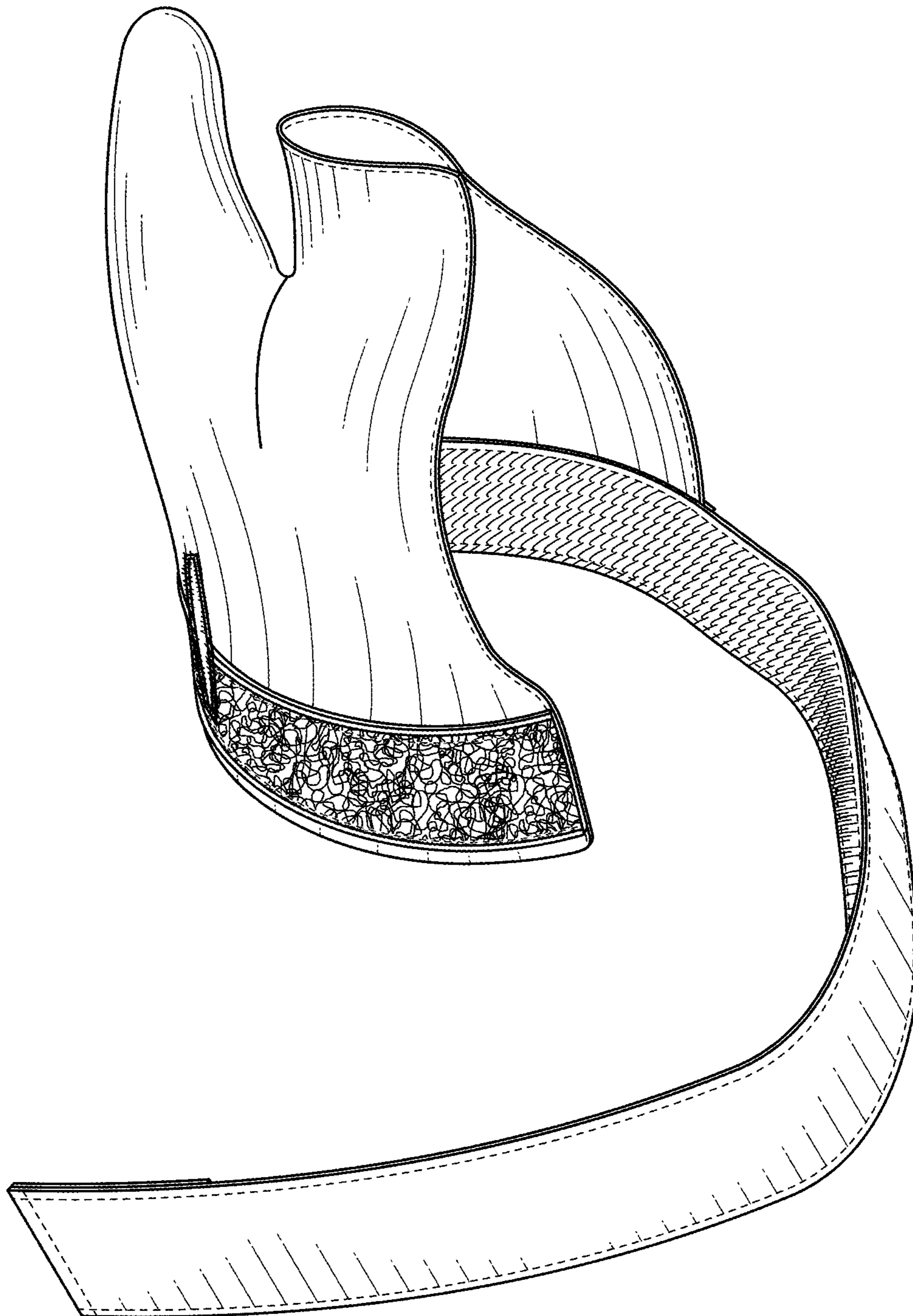
