FIG. 4 is a front elevational view showing the new design with the bottom side facing up.

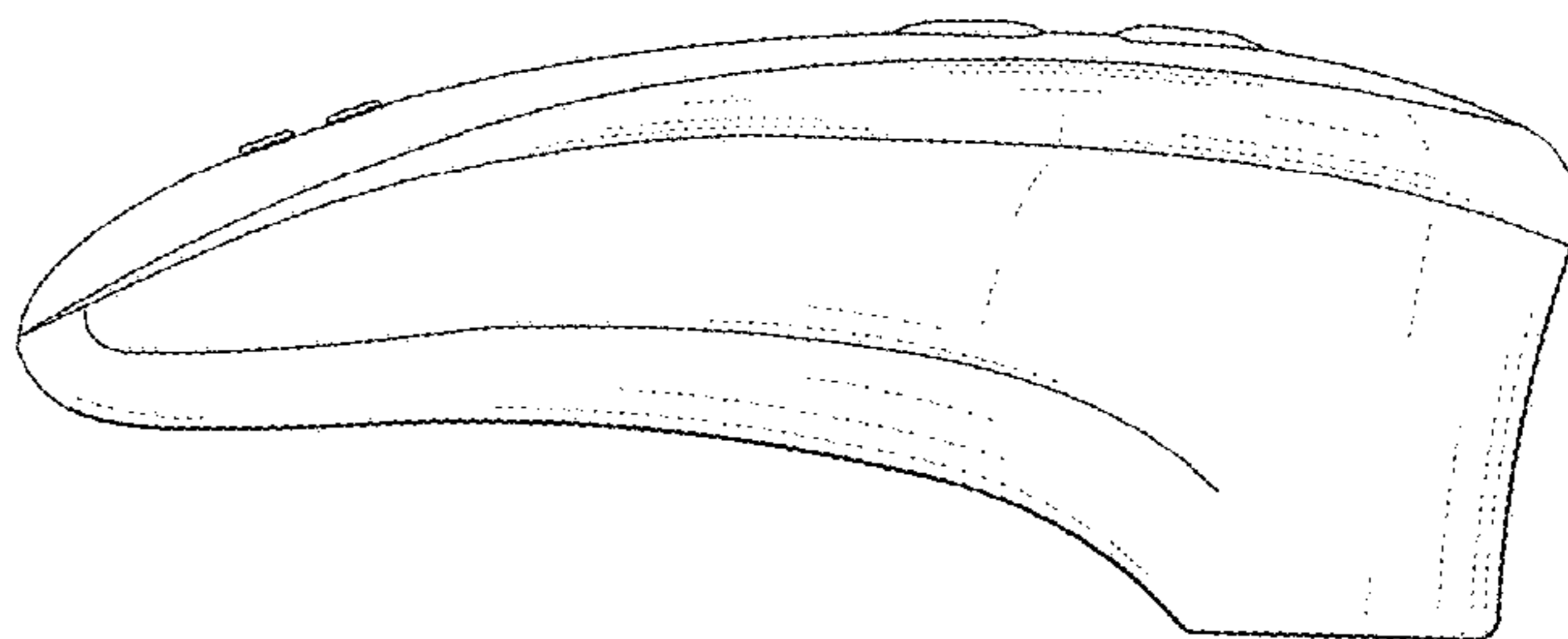
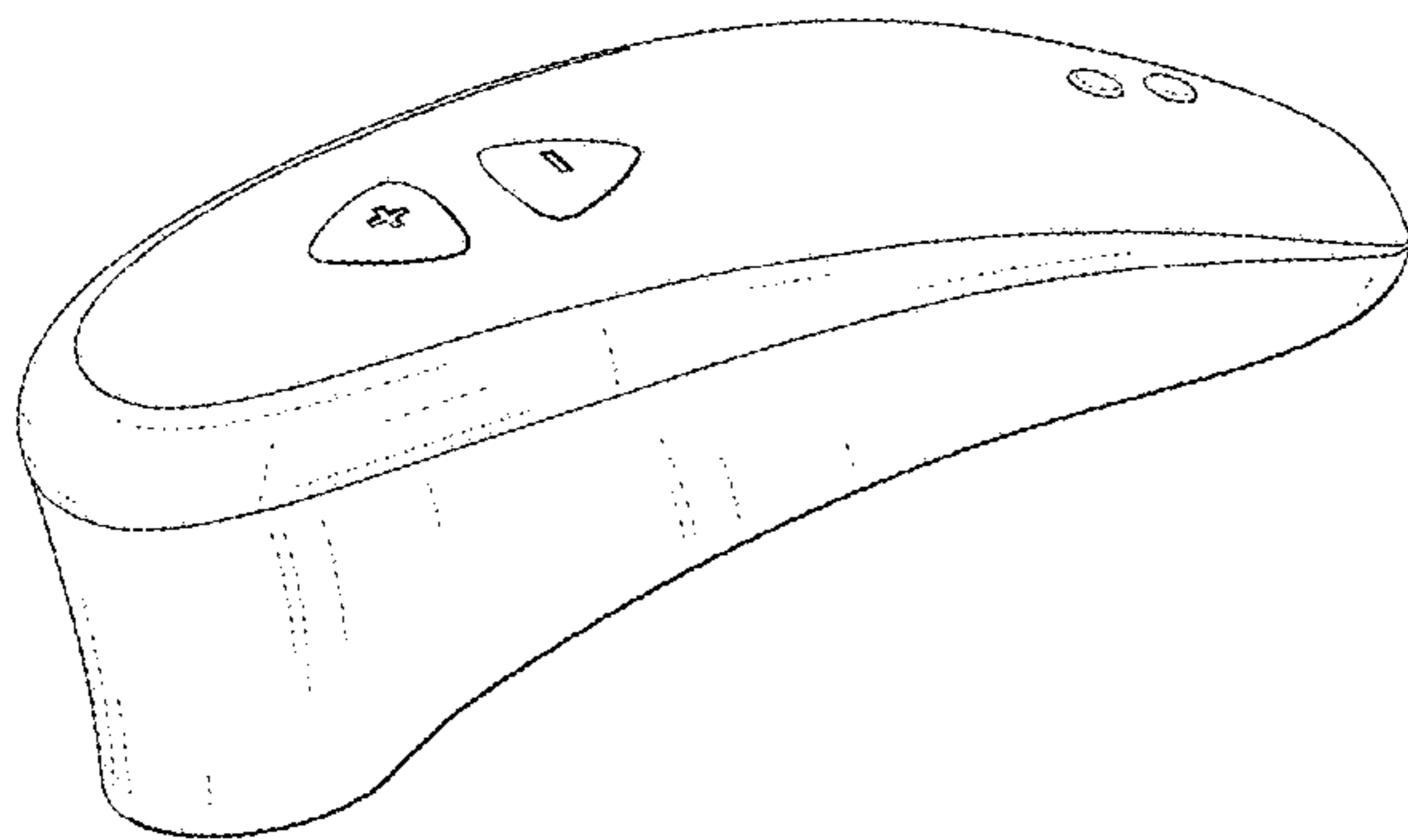
FIG. 5 is a bottom plan view showing the new design.

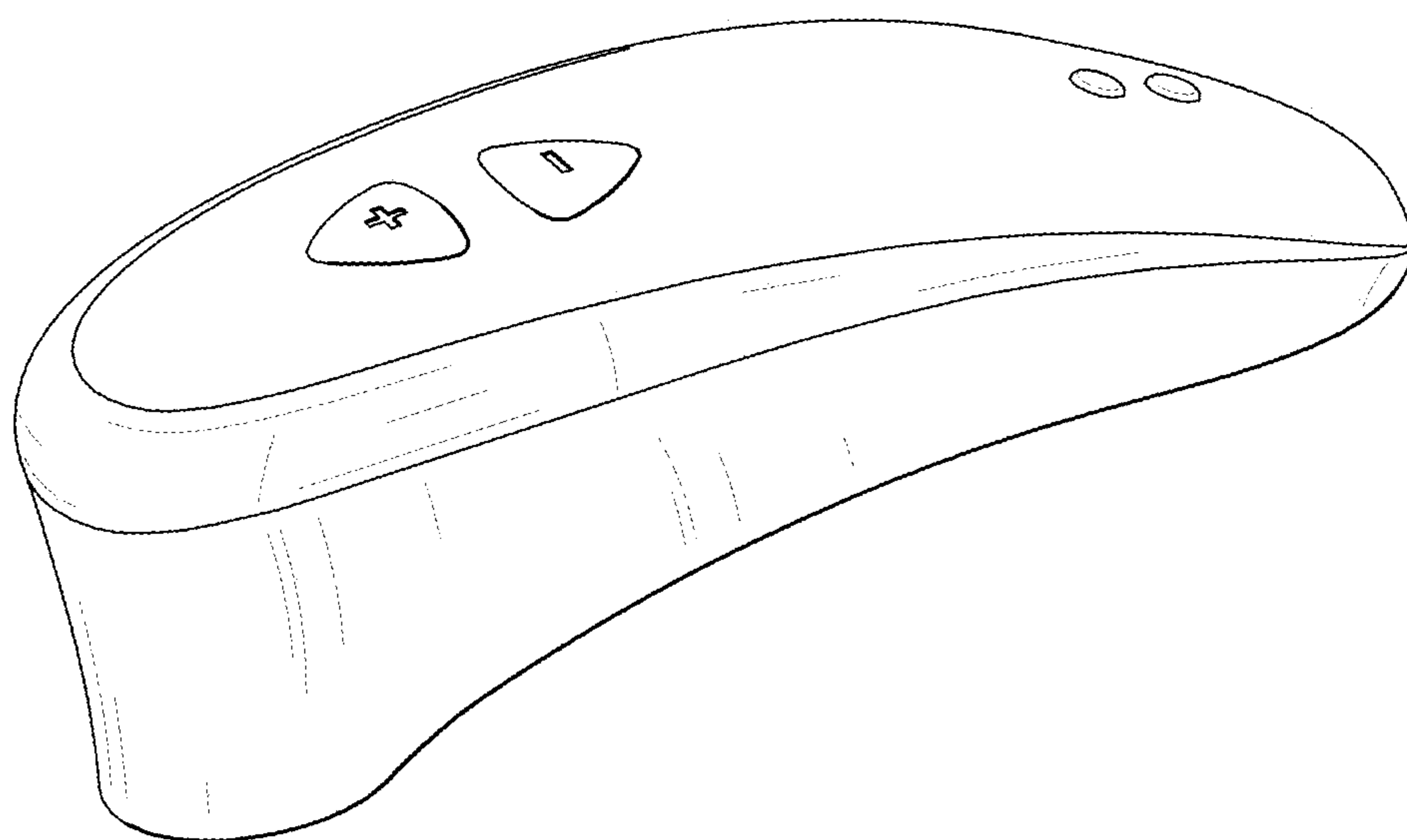

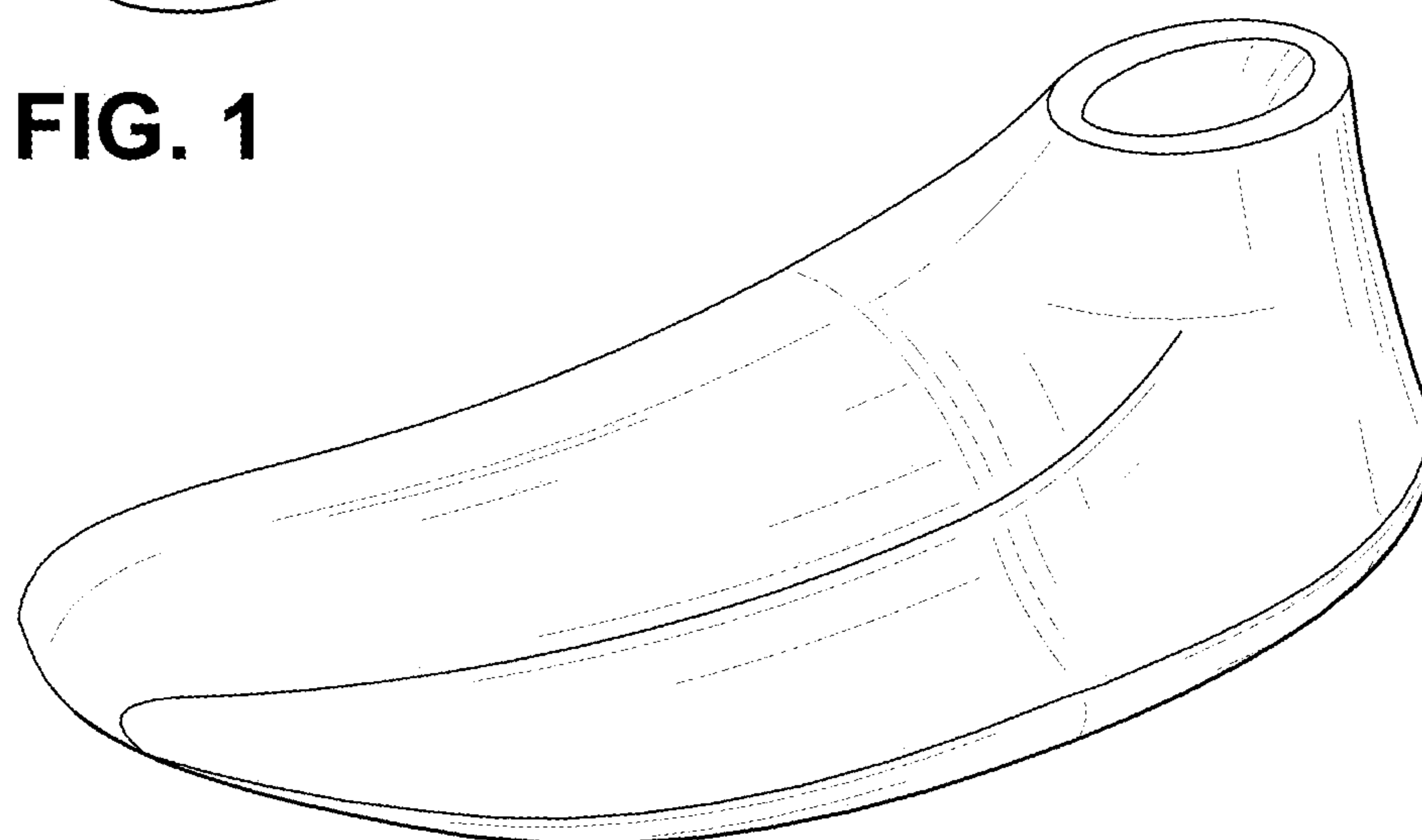

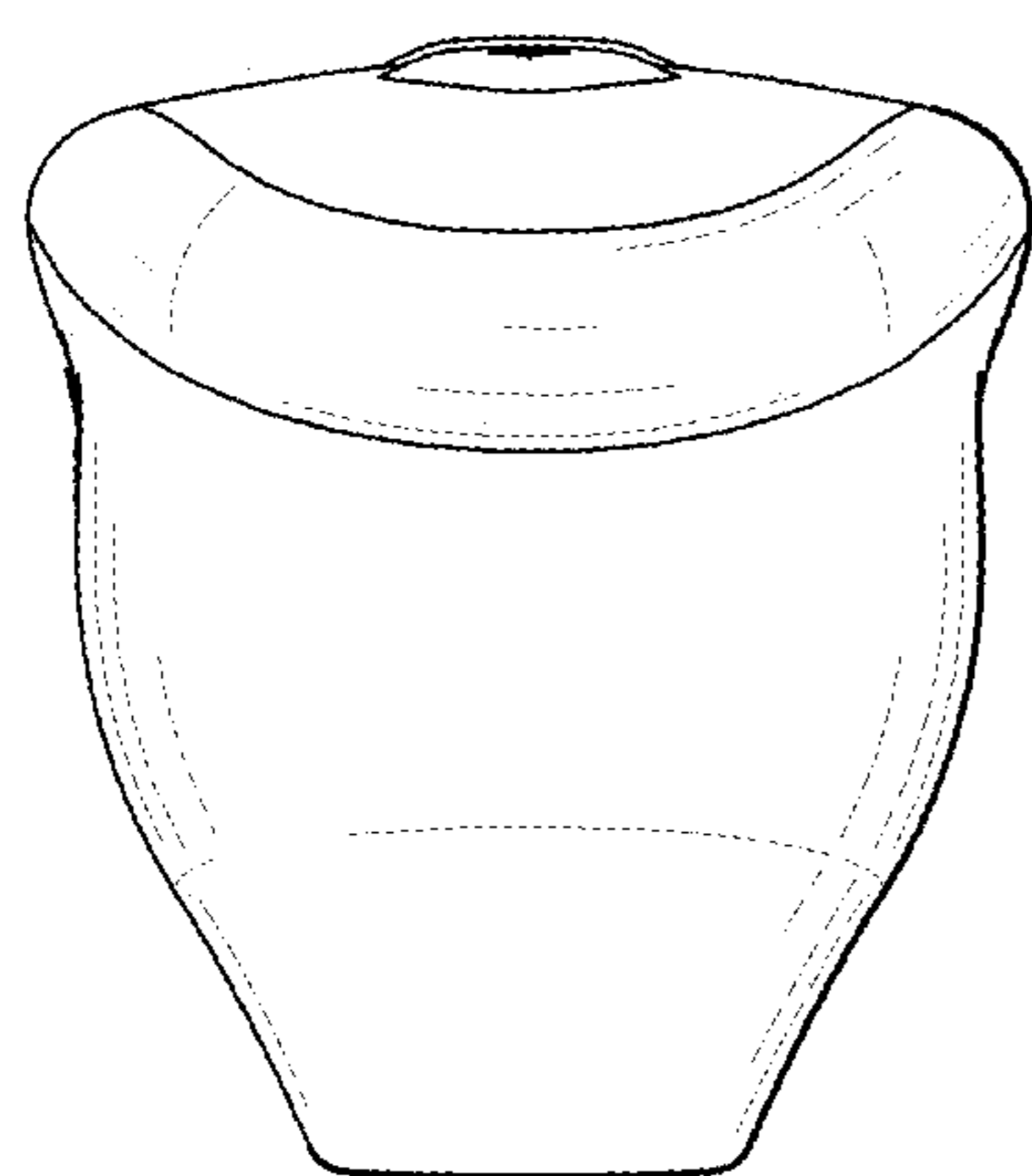

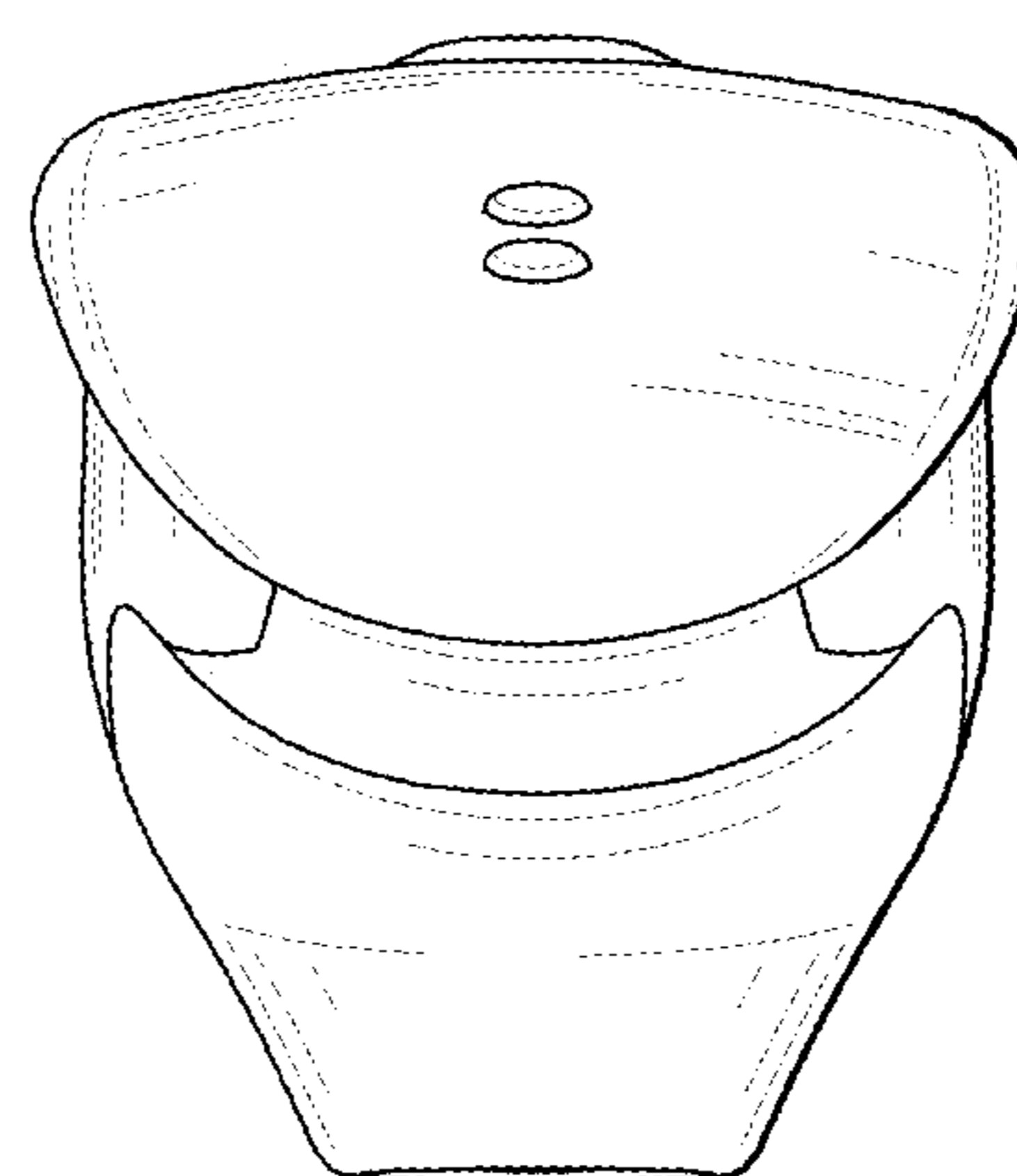

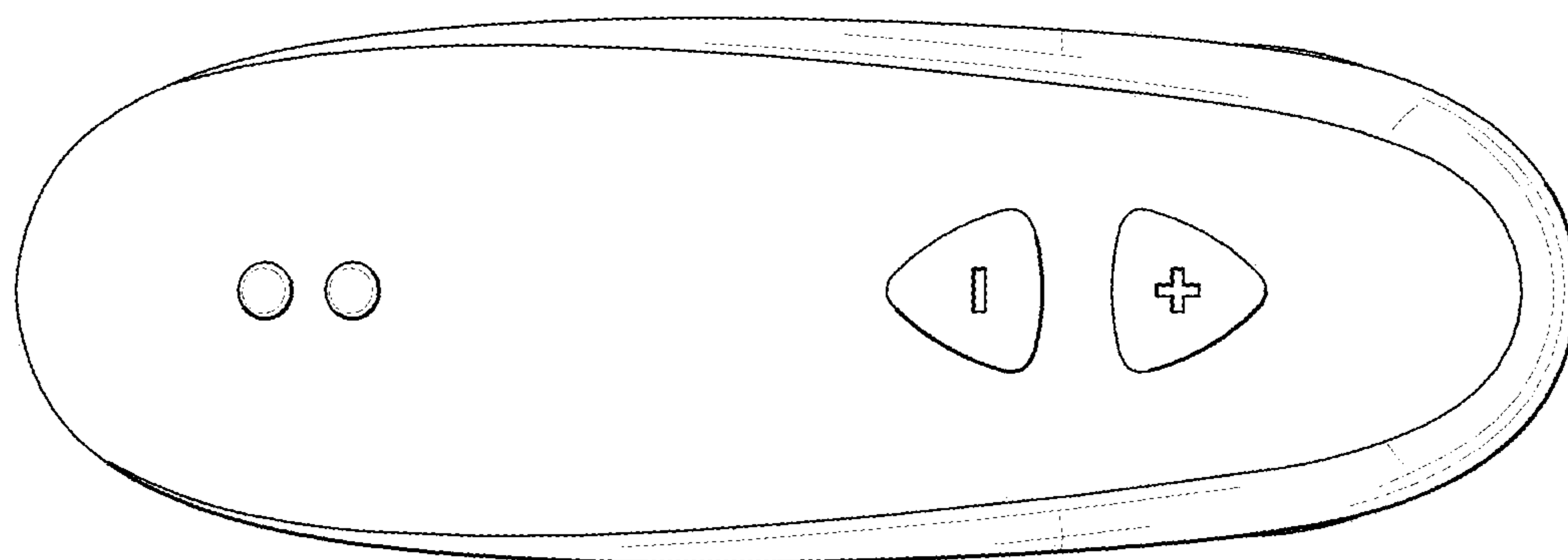

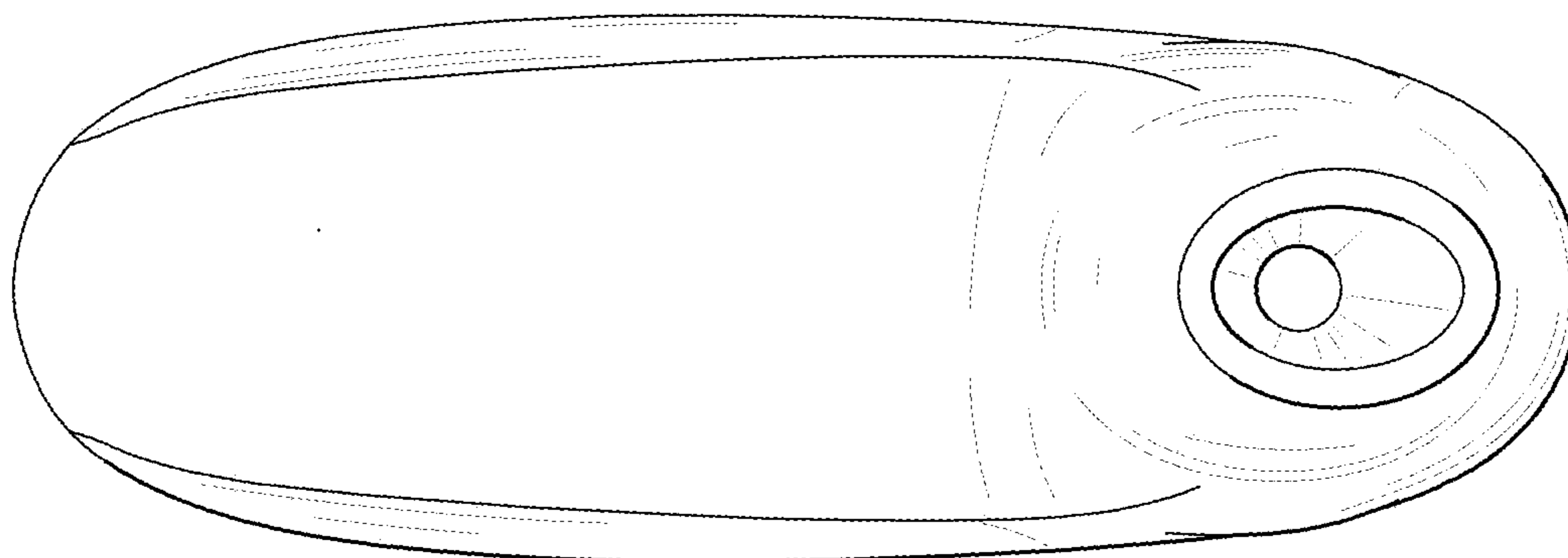

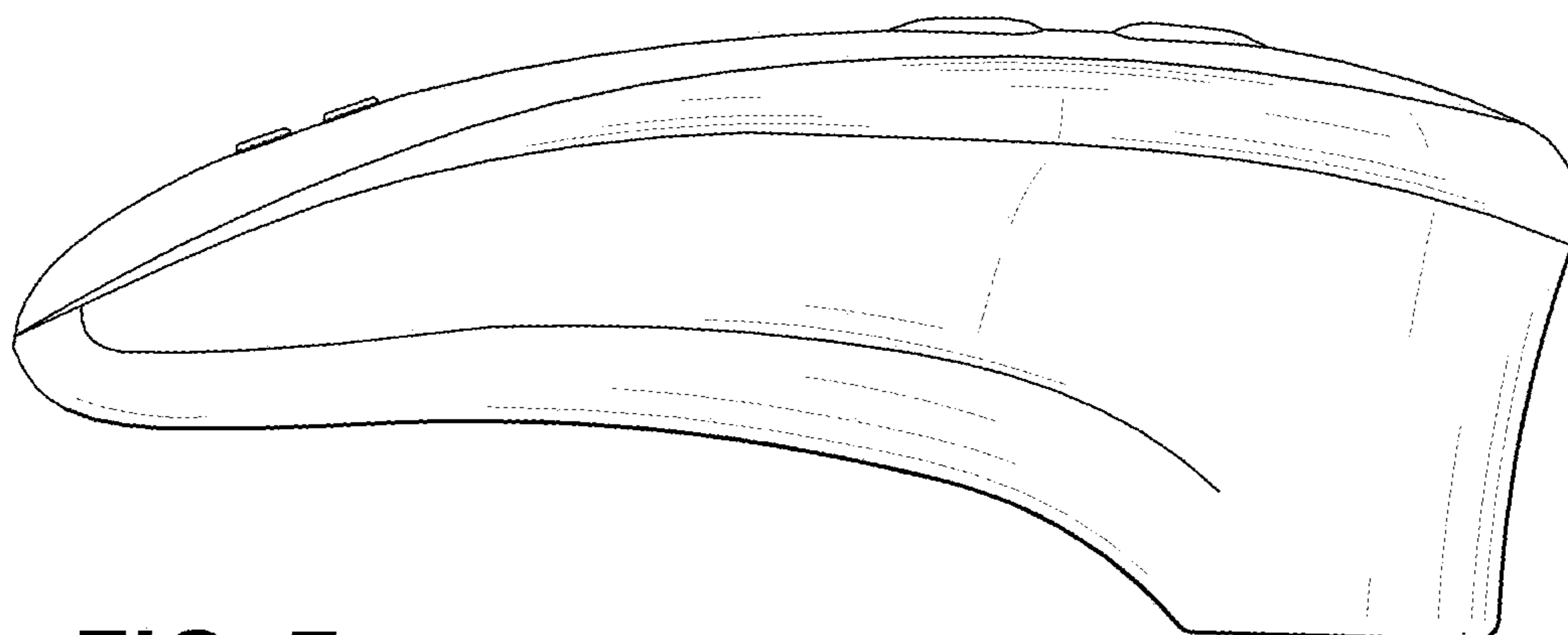

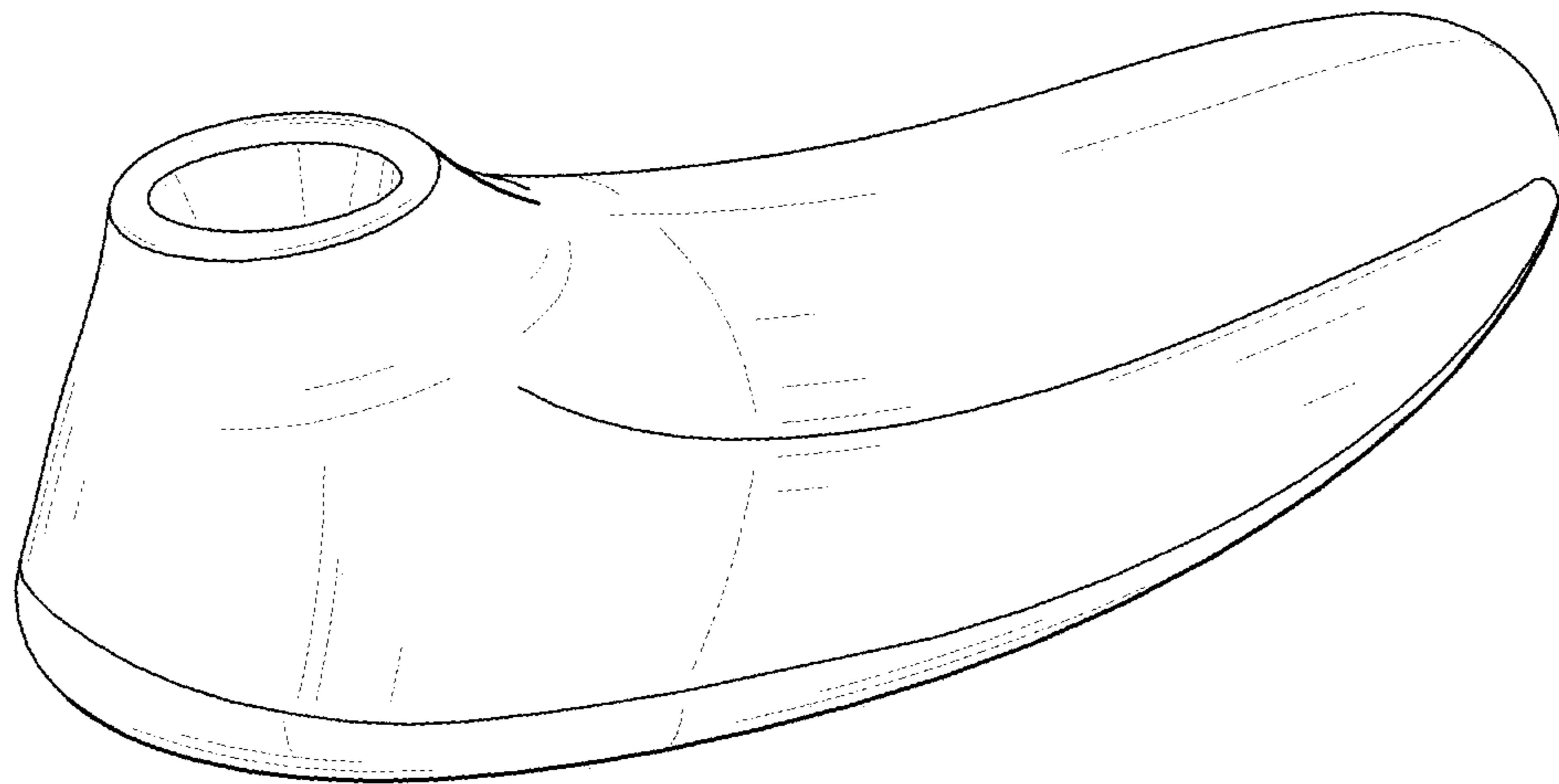
