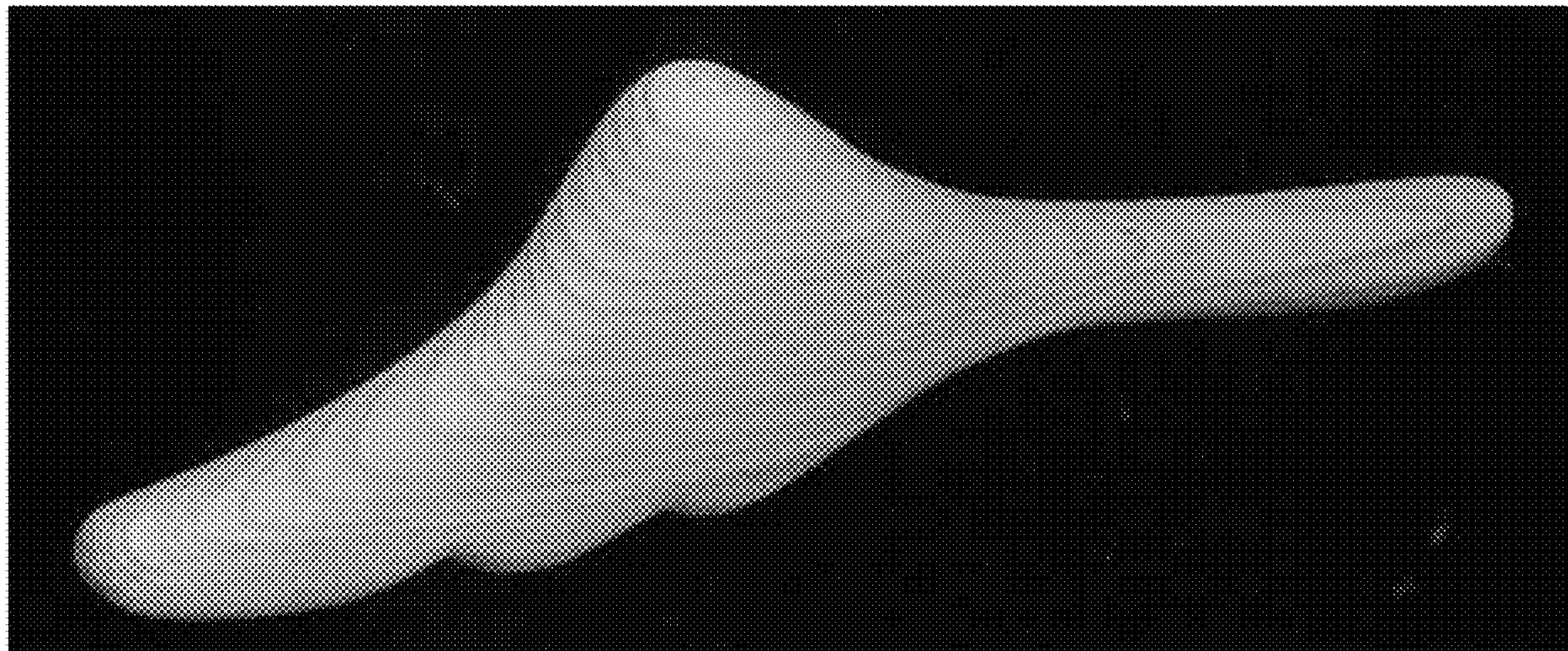
The ornamental design for a massage equipment, as shown and described.

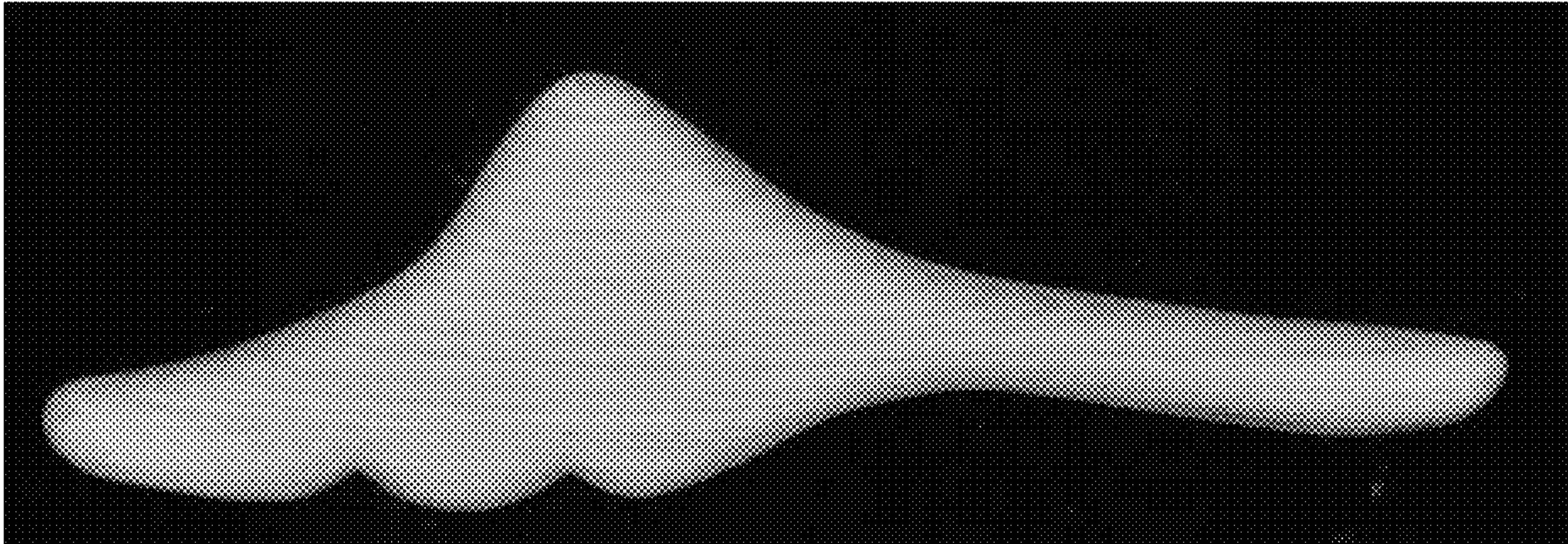

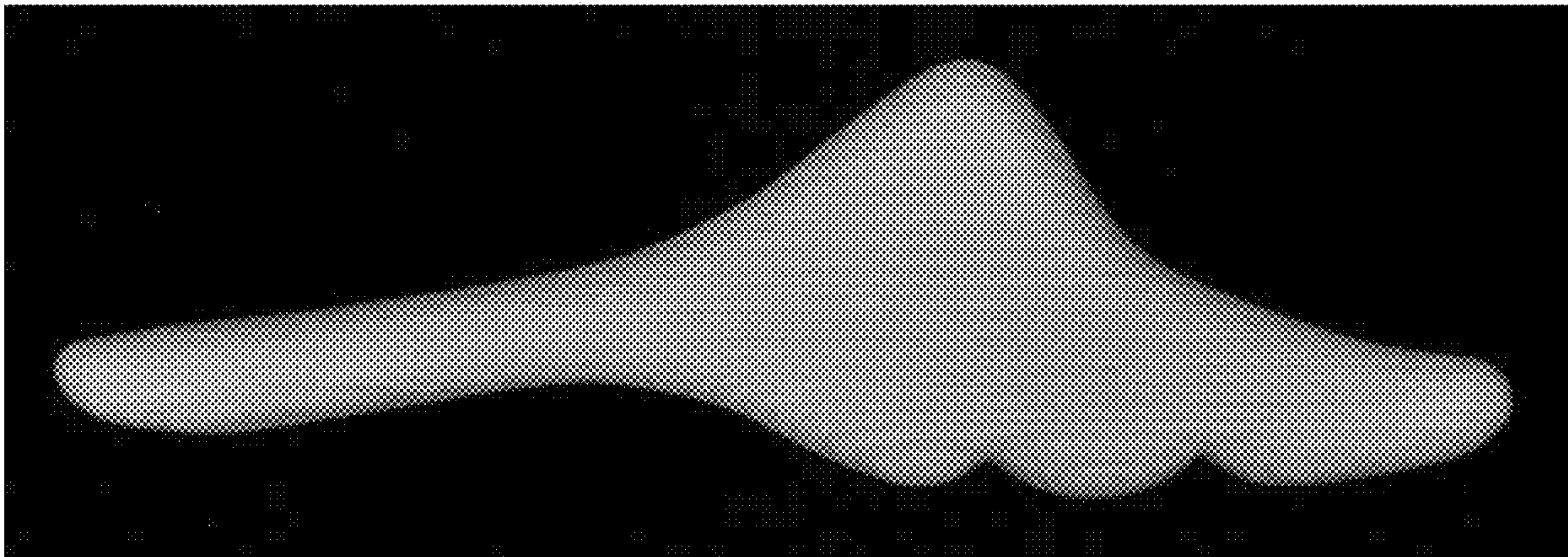

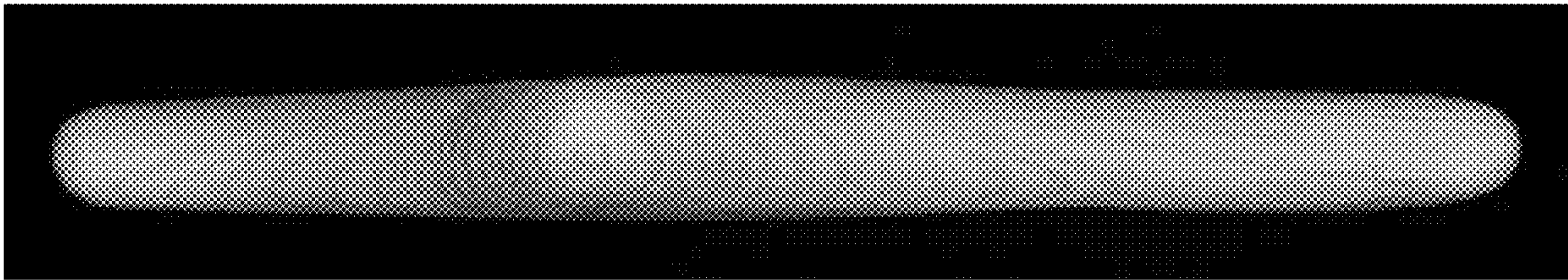

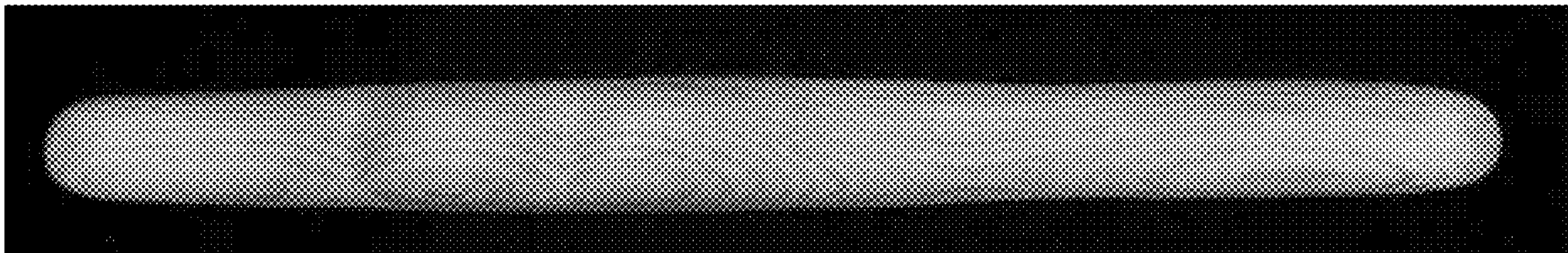

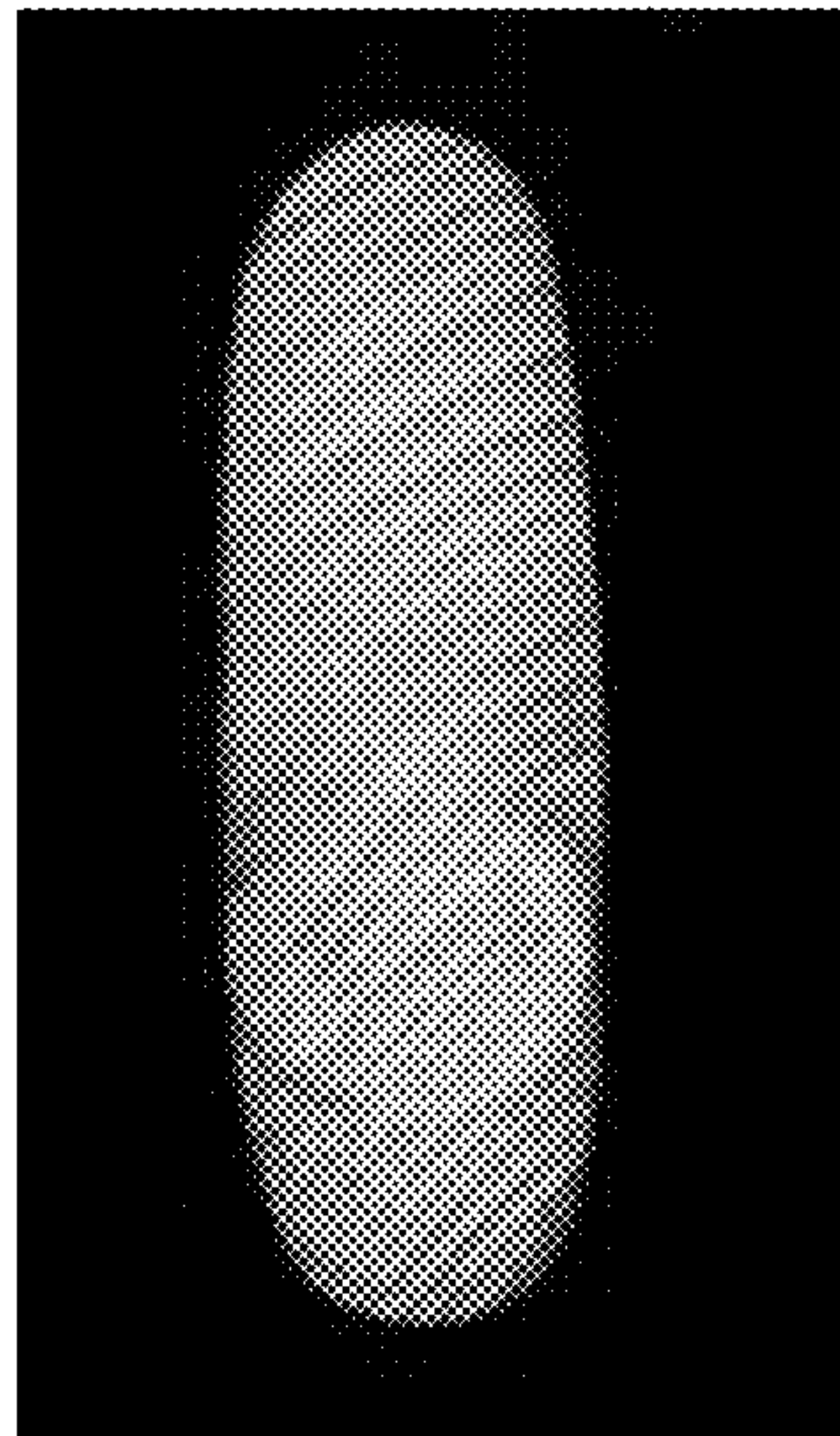

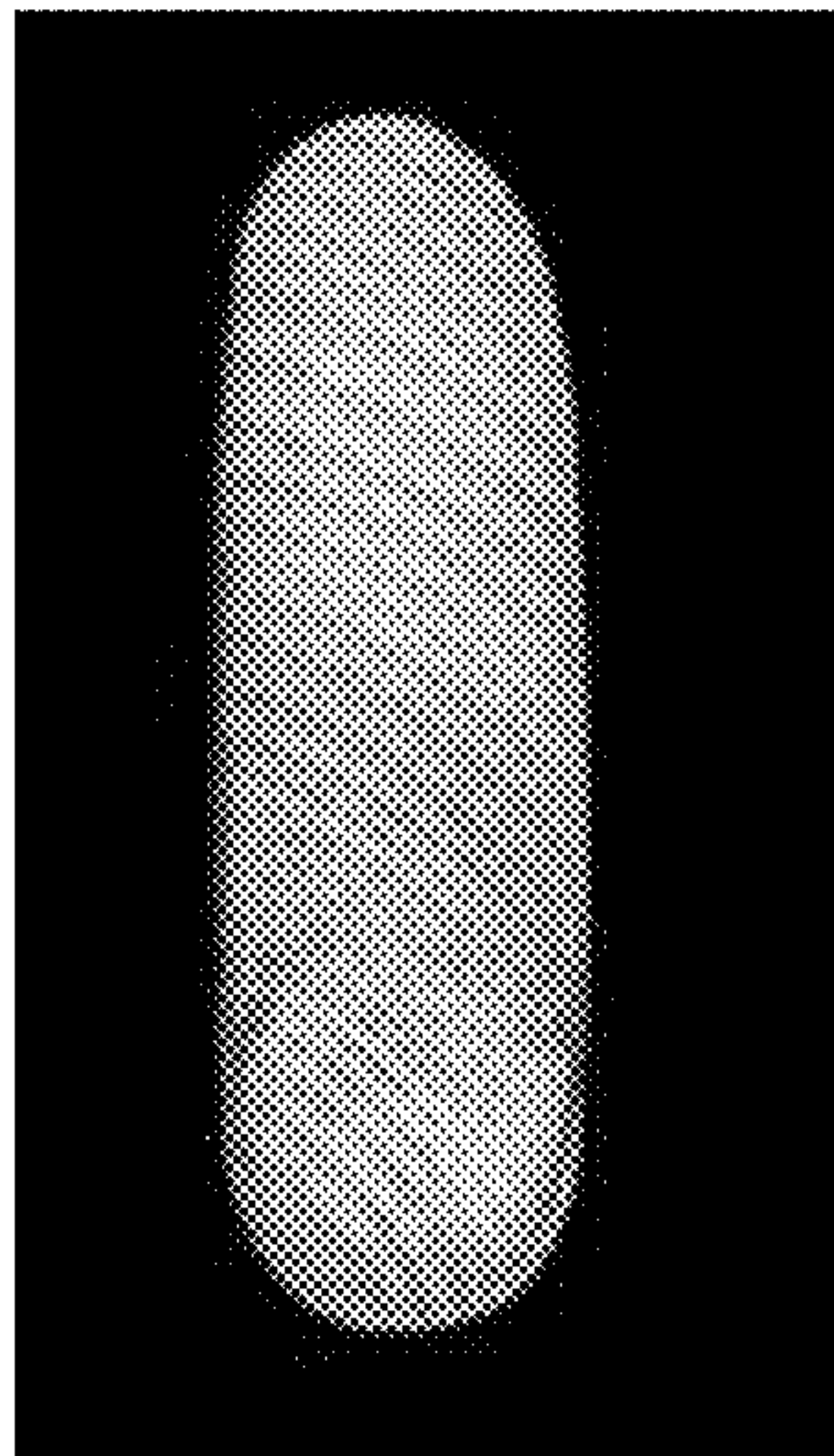

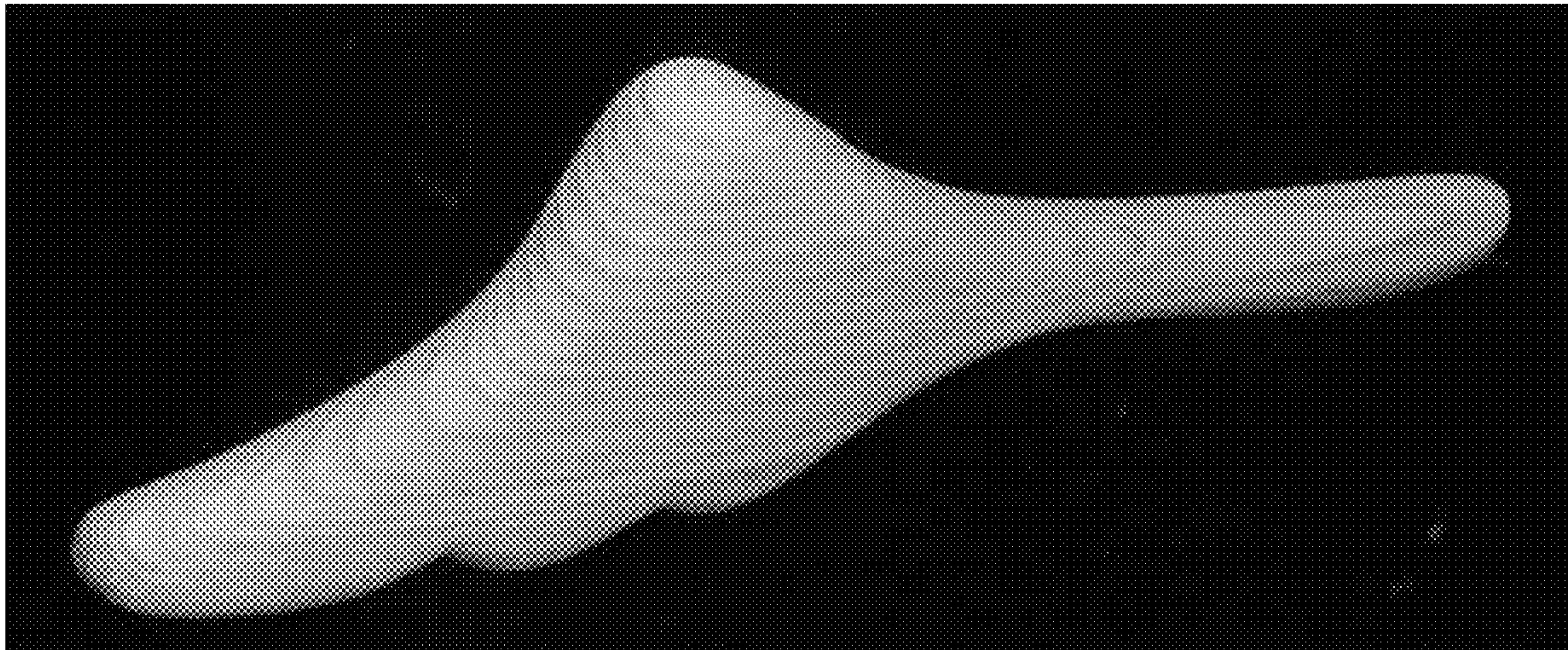
