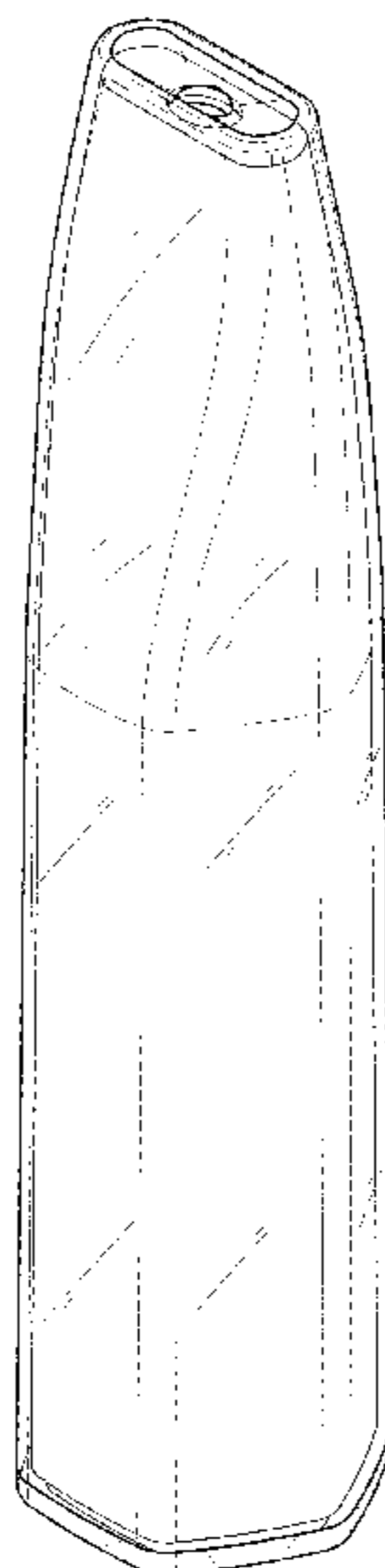
(57) **CLAIM**

The ornamental design for a disposable electronic cigarette, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a disposable electronic cigarette showing our new design; FIG. 2 is a bottom, rear and right side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The oblique shade lines in the drawings represent a transparent surface.

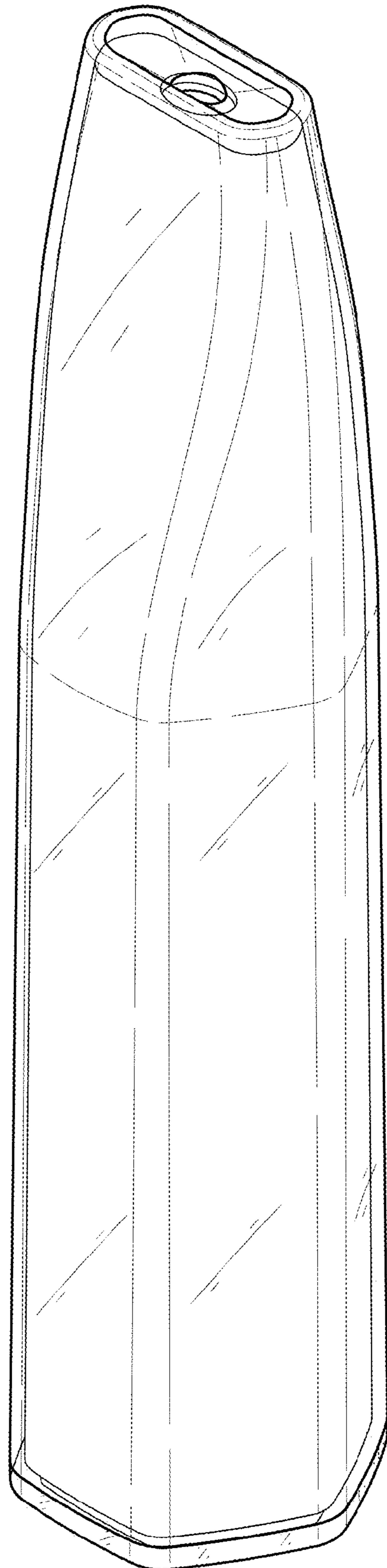

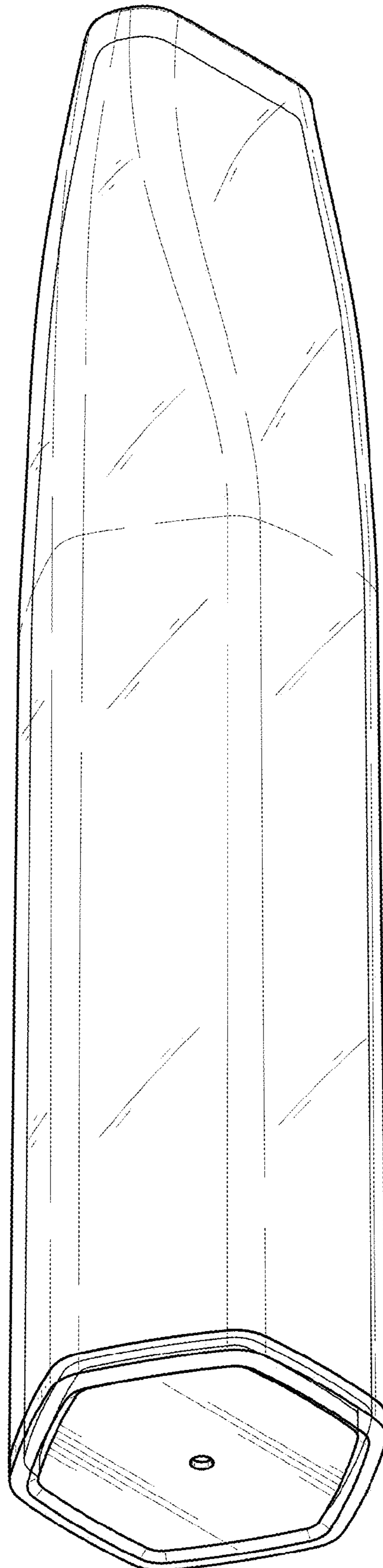

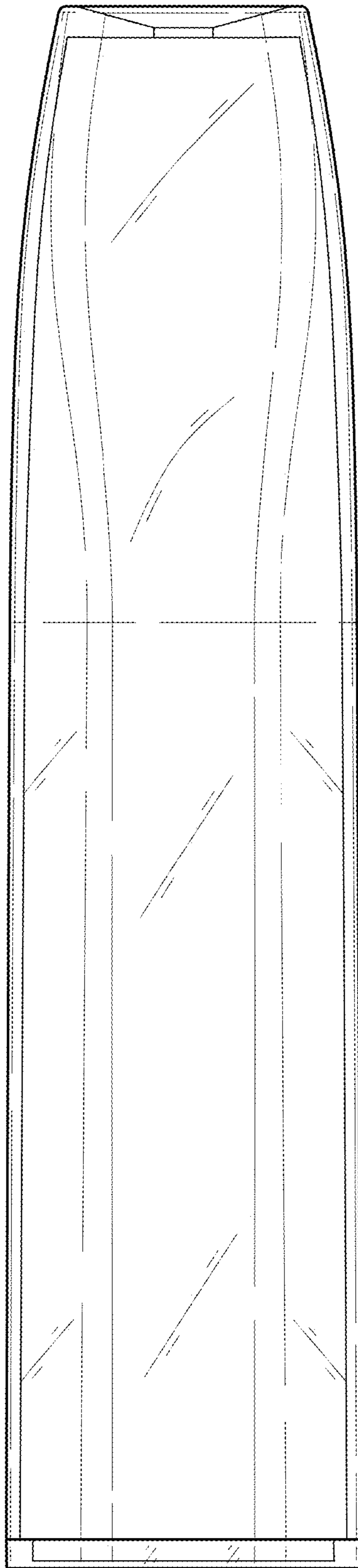

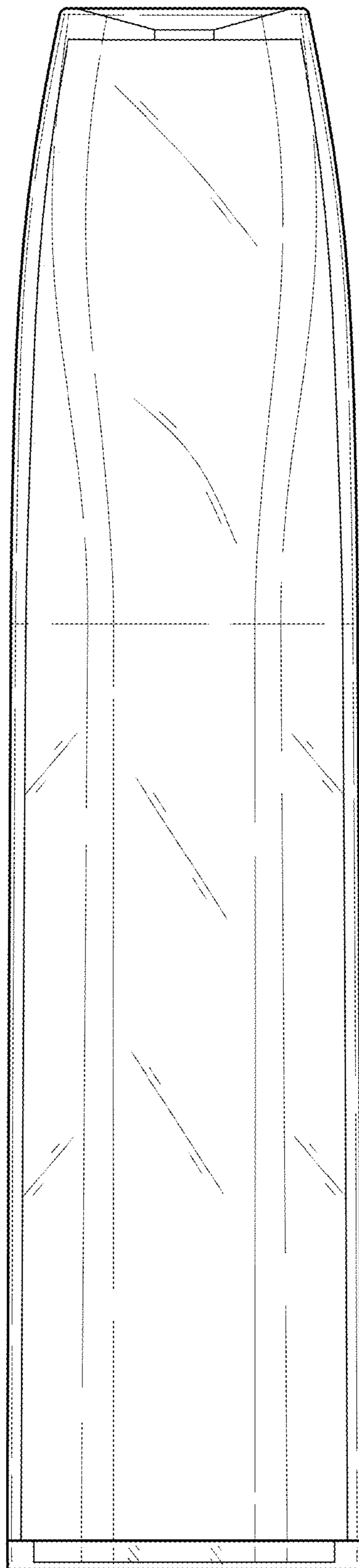

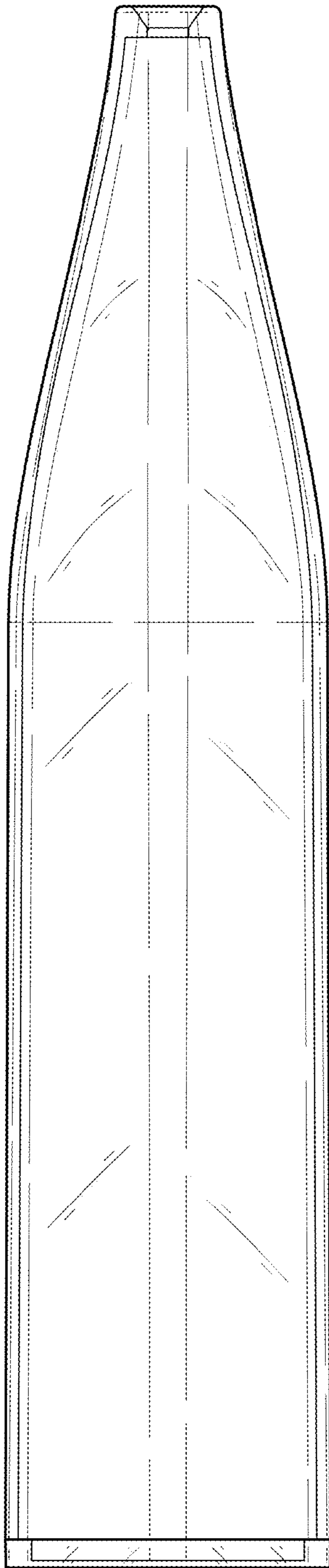

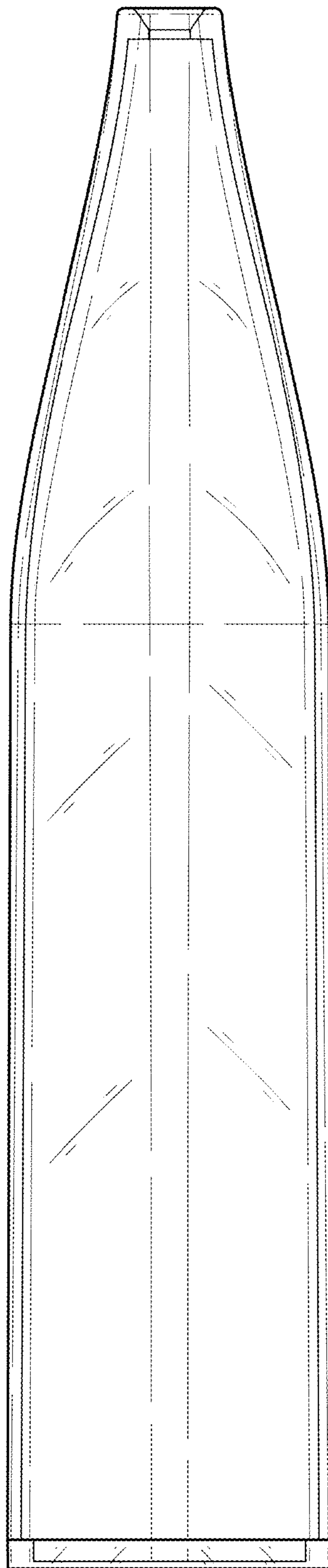

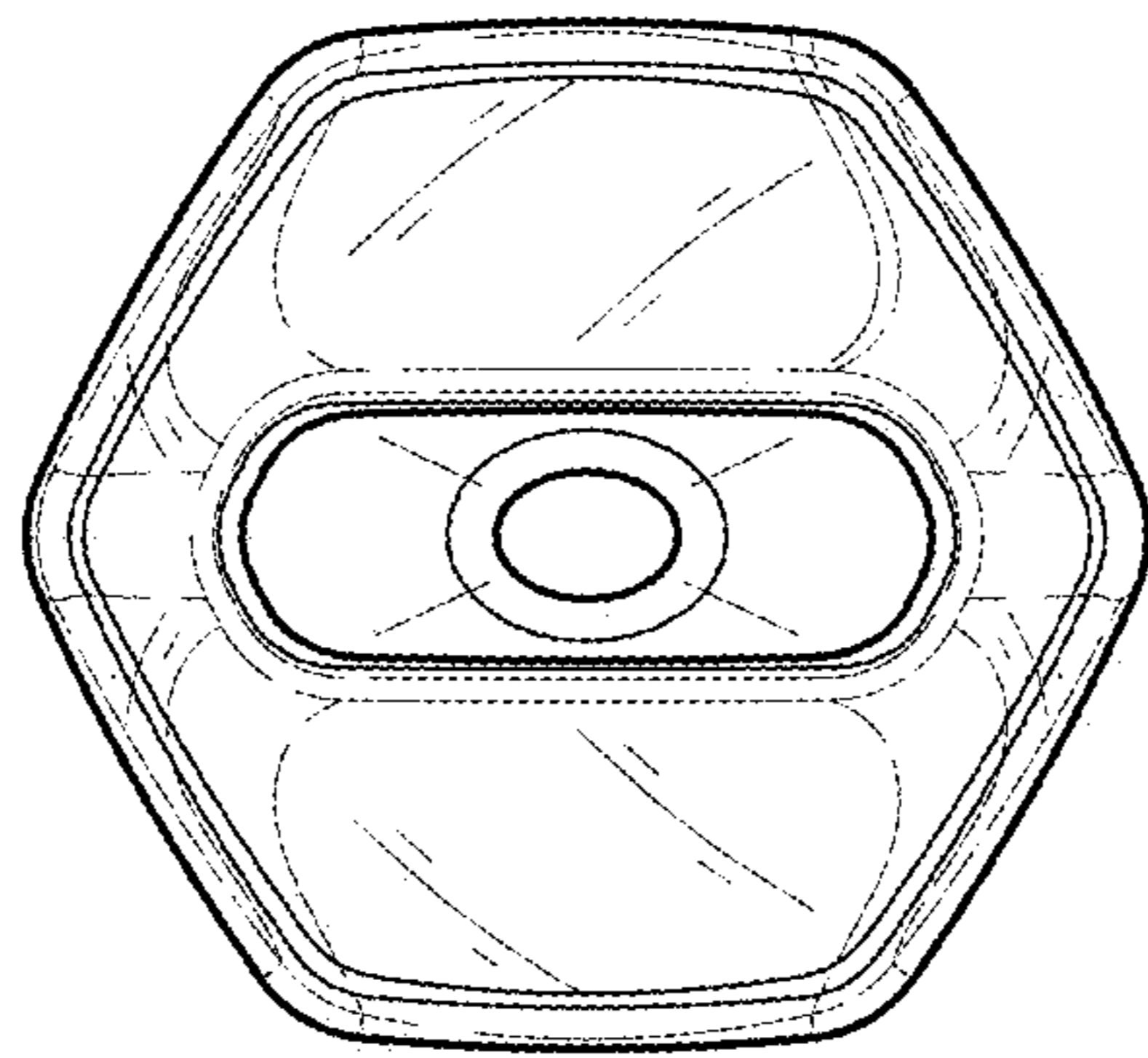

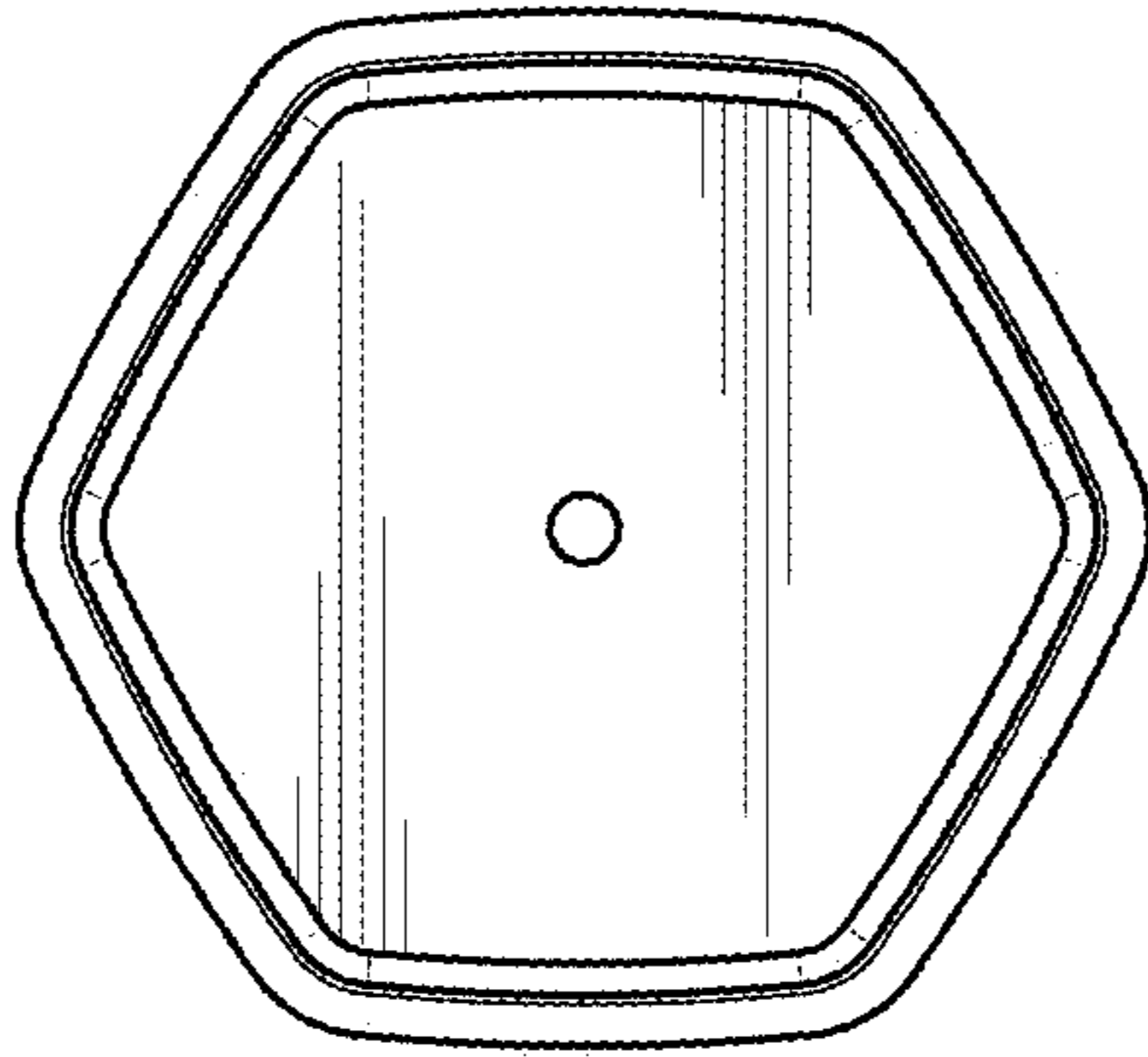
