(57) **CLAIM**

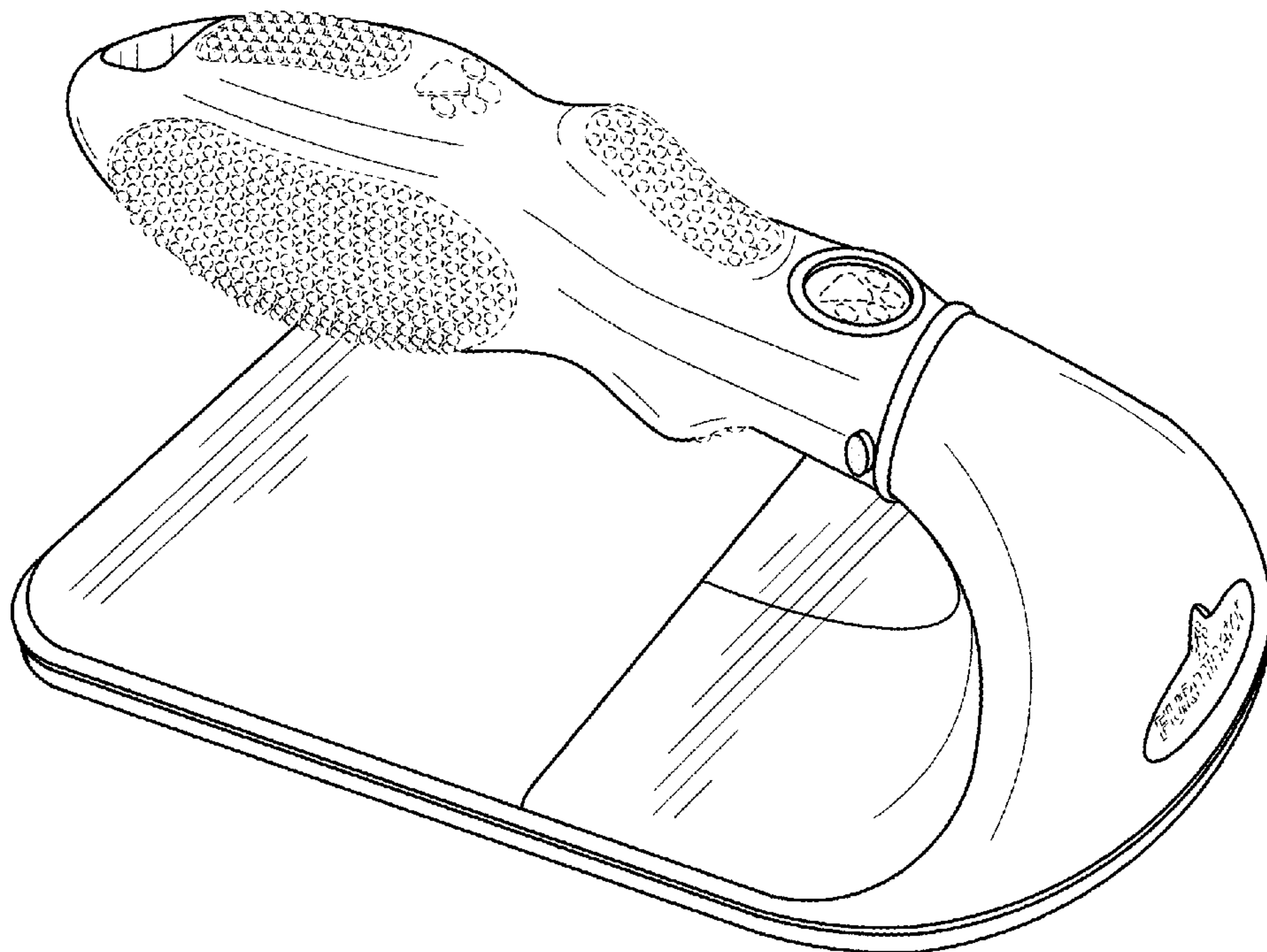
The ornamental design for a grooming hair accumulator for animal, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the new design; FIG. 2 is a bottom perspective view of the new design; FIG. 3 is a top view of the new design; FIG. 4 is a bottom view of the new design; FIG. 5 is a right side view the new design, the left side view being a mirror image thereof; FIG. 6 is another perspective view, but shown with the handle and head separated for completeness of illustration; FIG. 7 is another perspective view, but shown with the handle removed for completeness of illustration; FIG. 8 is another perspective view thereof; and, FIG. 9 is another perspective view thereof.

The broken lines illustrate portions of the grooming hair accumulator for animal that forms no part of the claimed design.

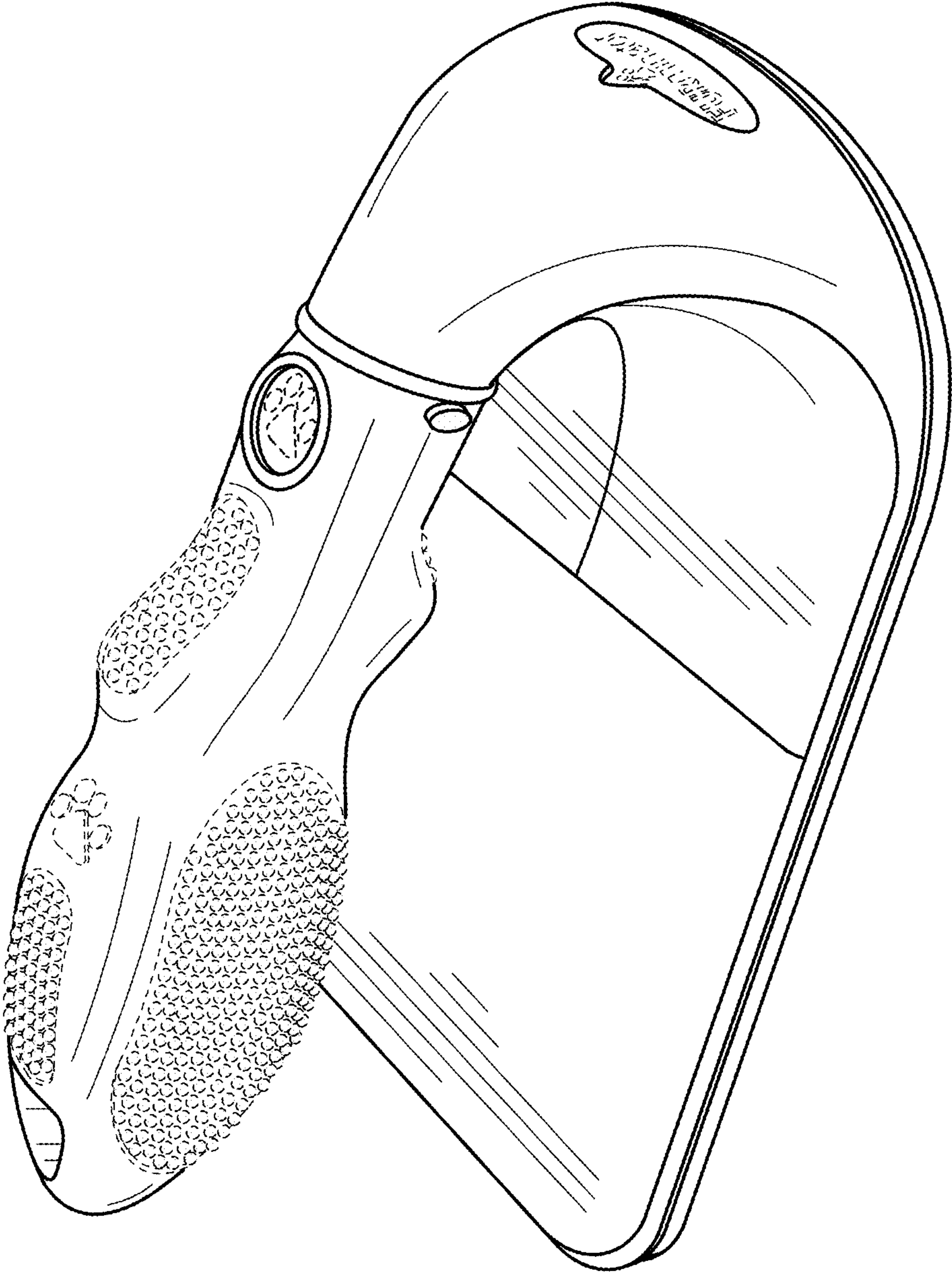

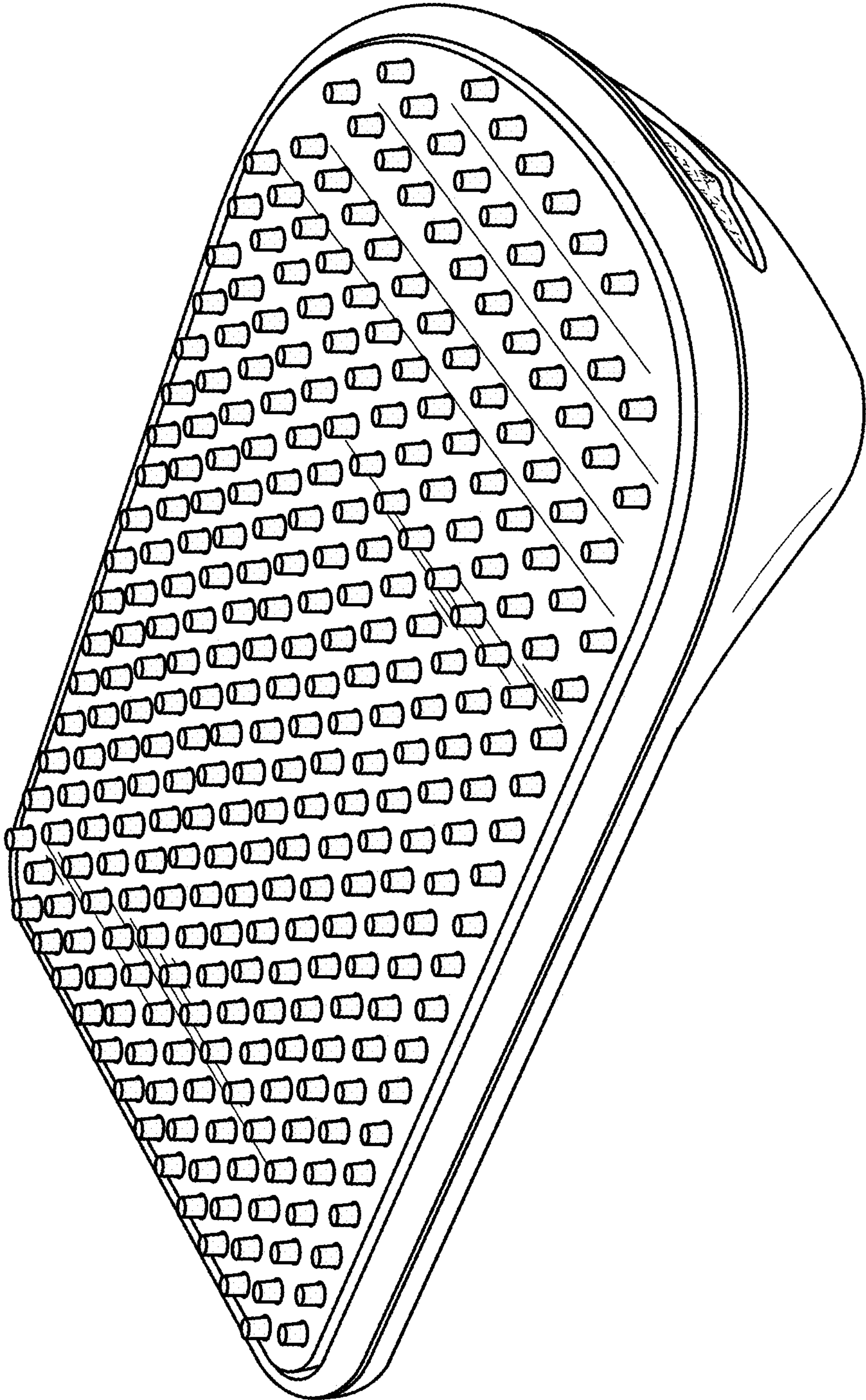

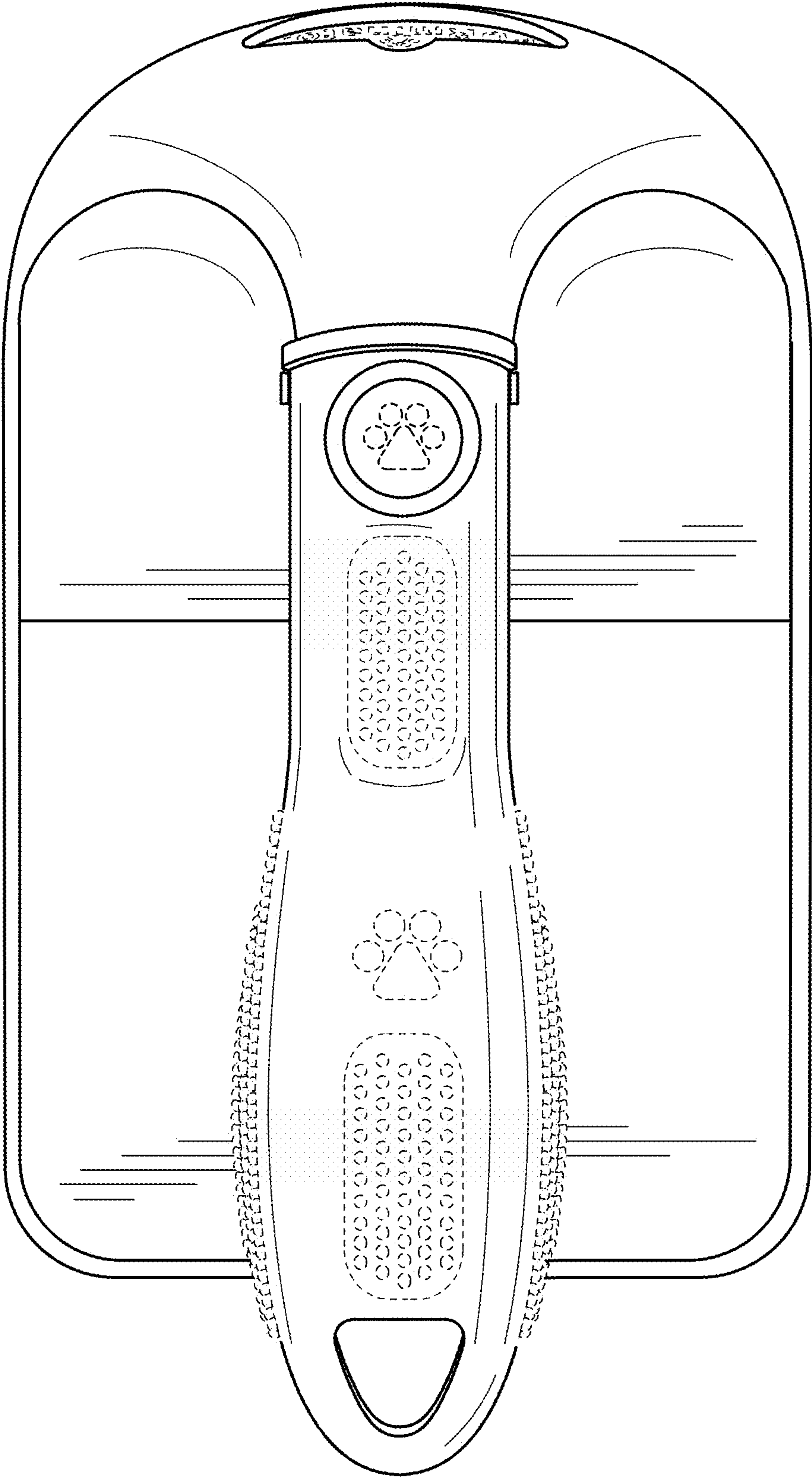

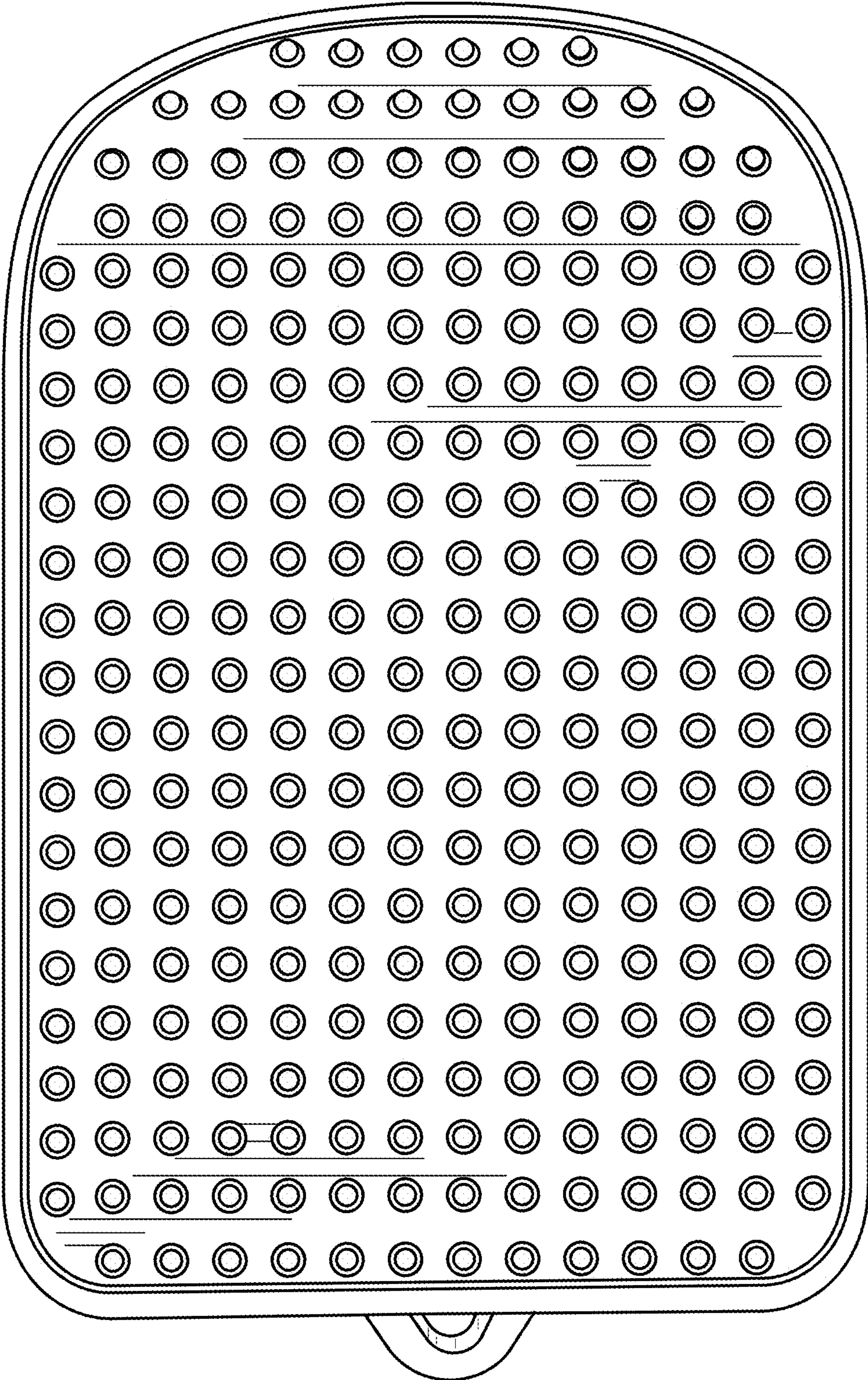

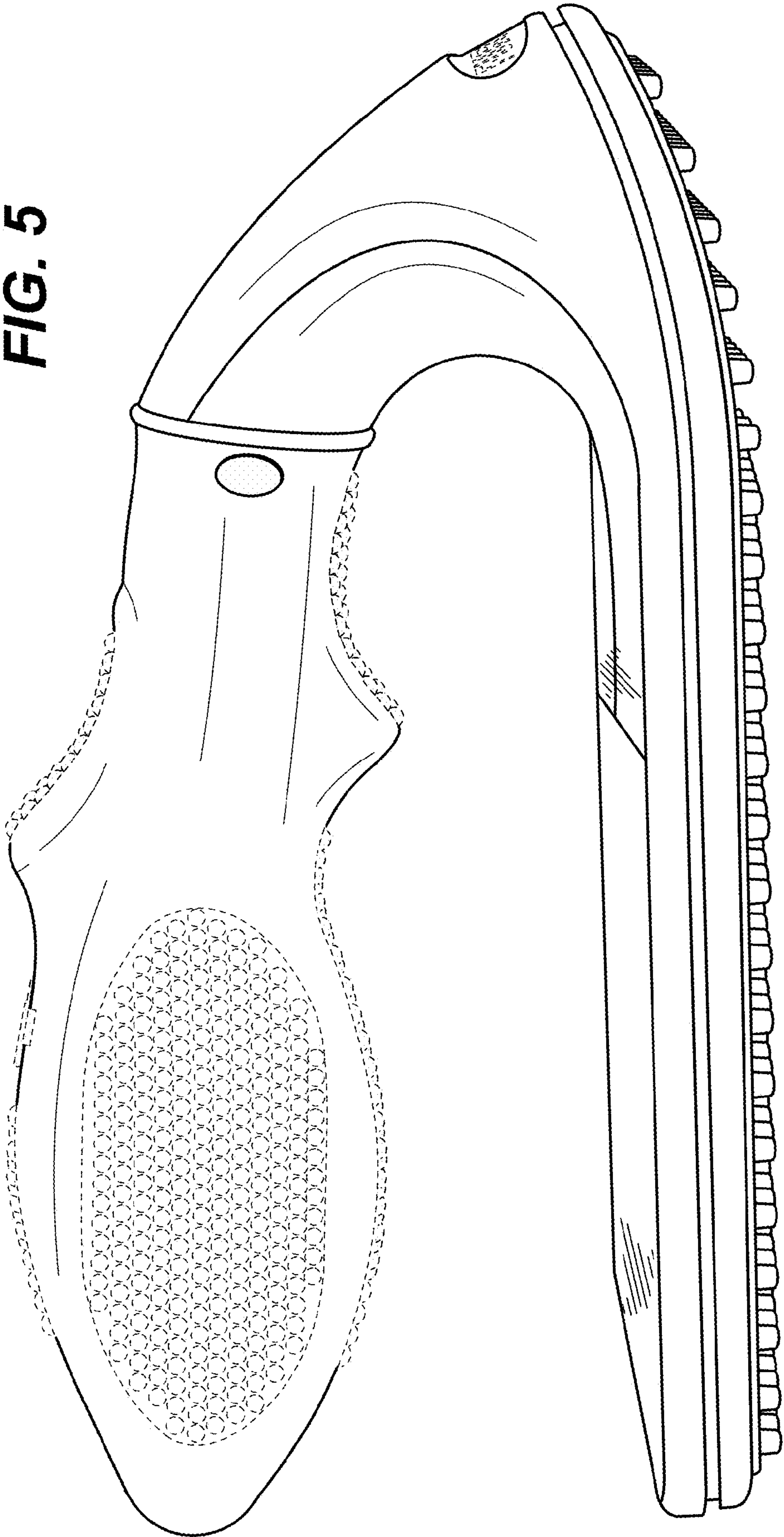
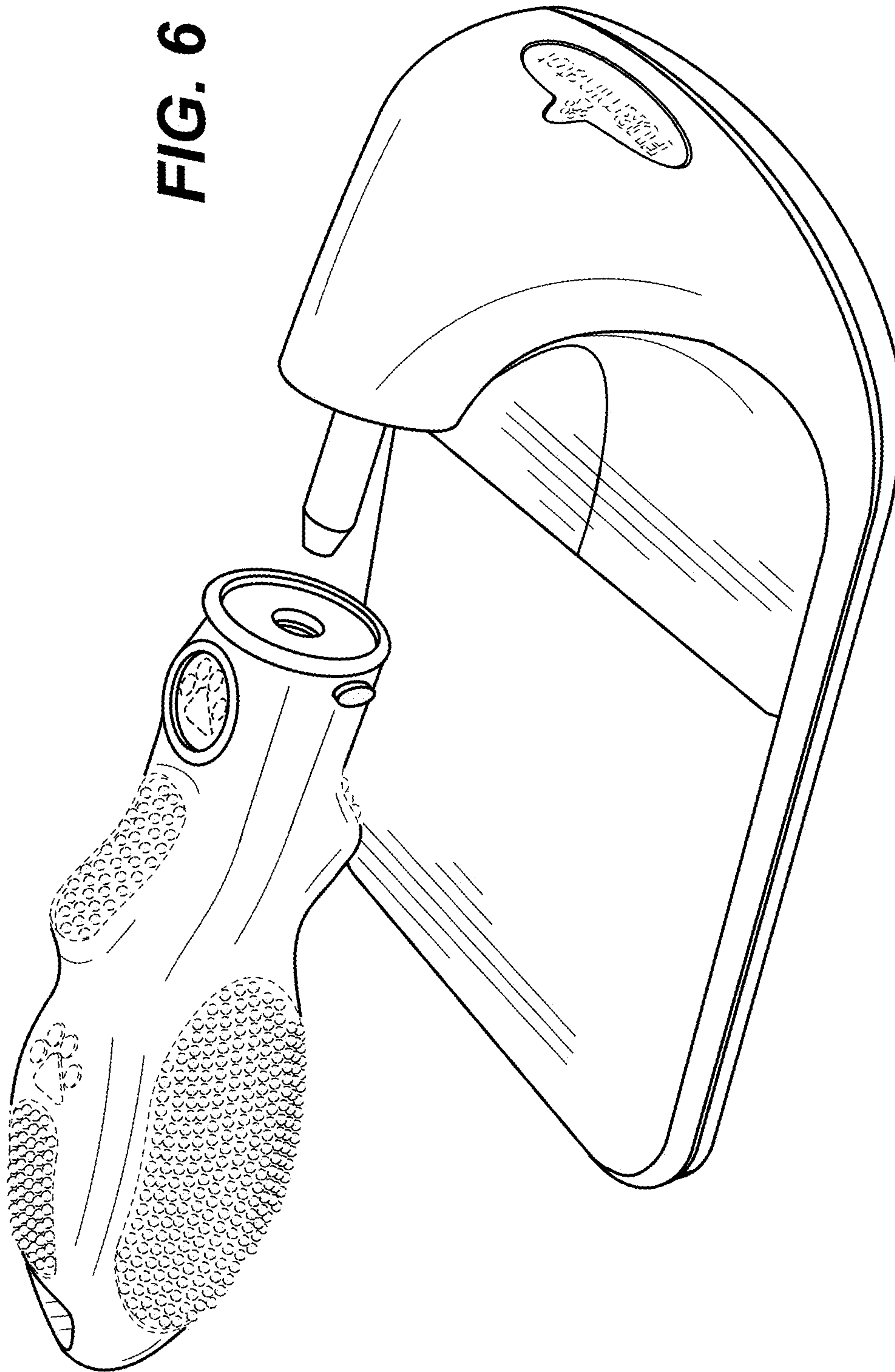

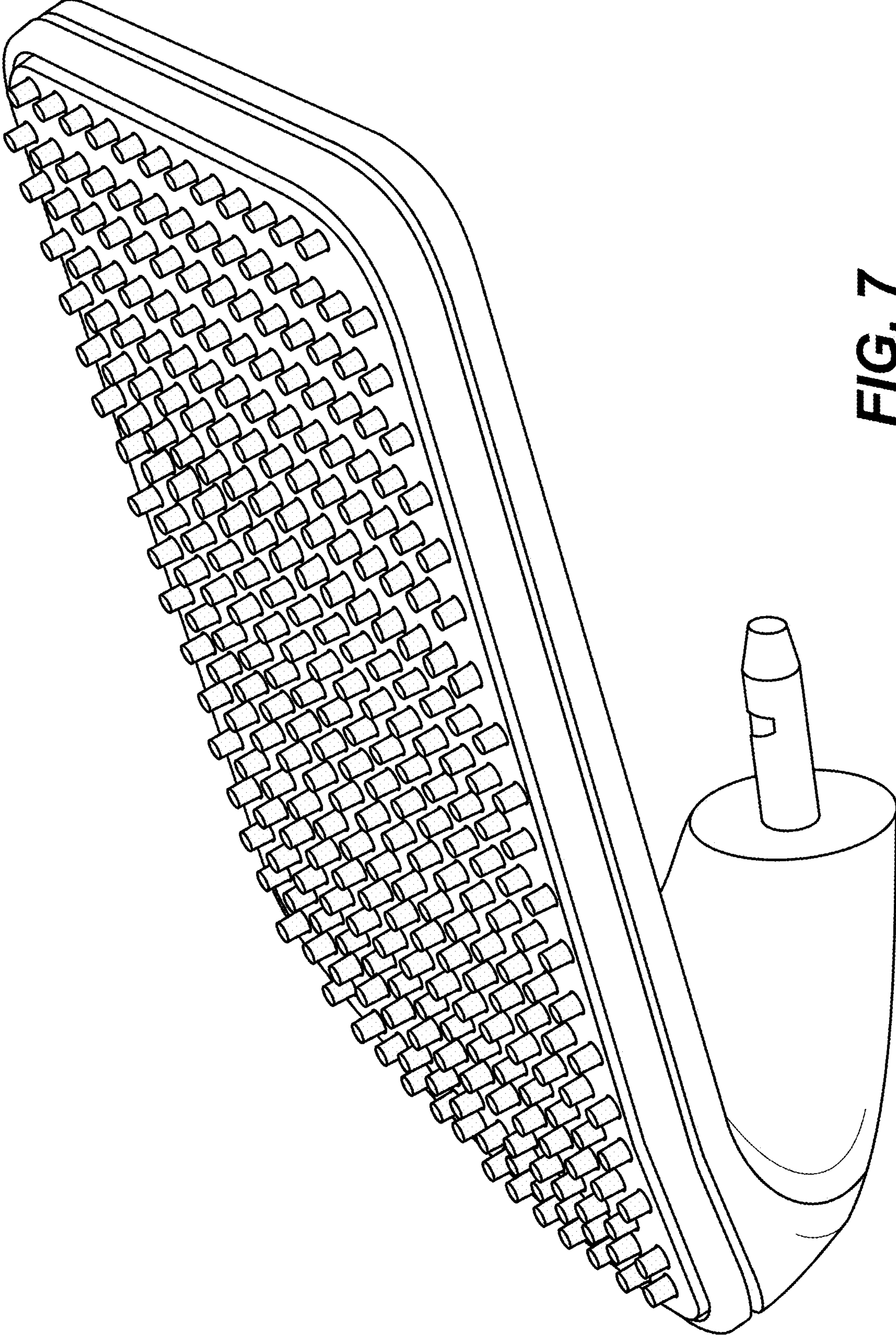

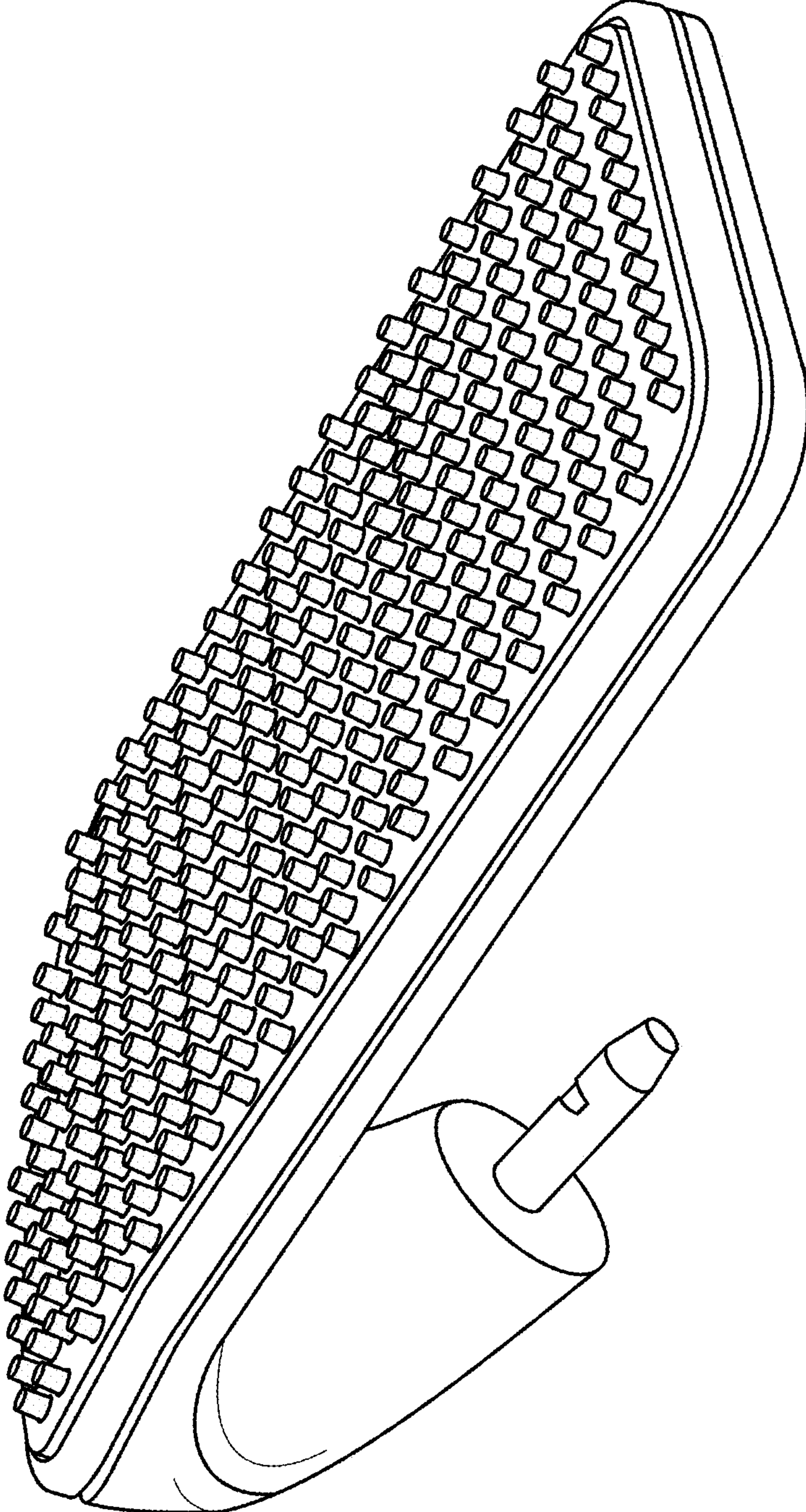

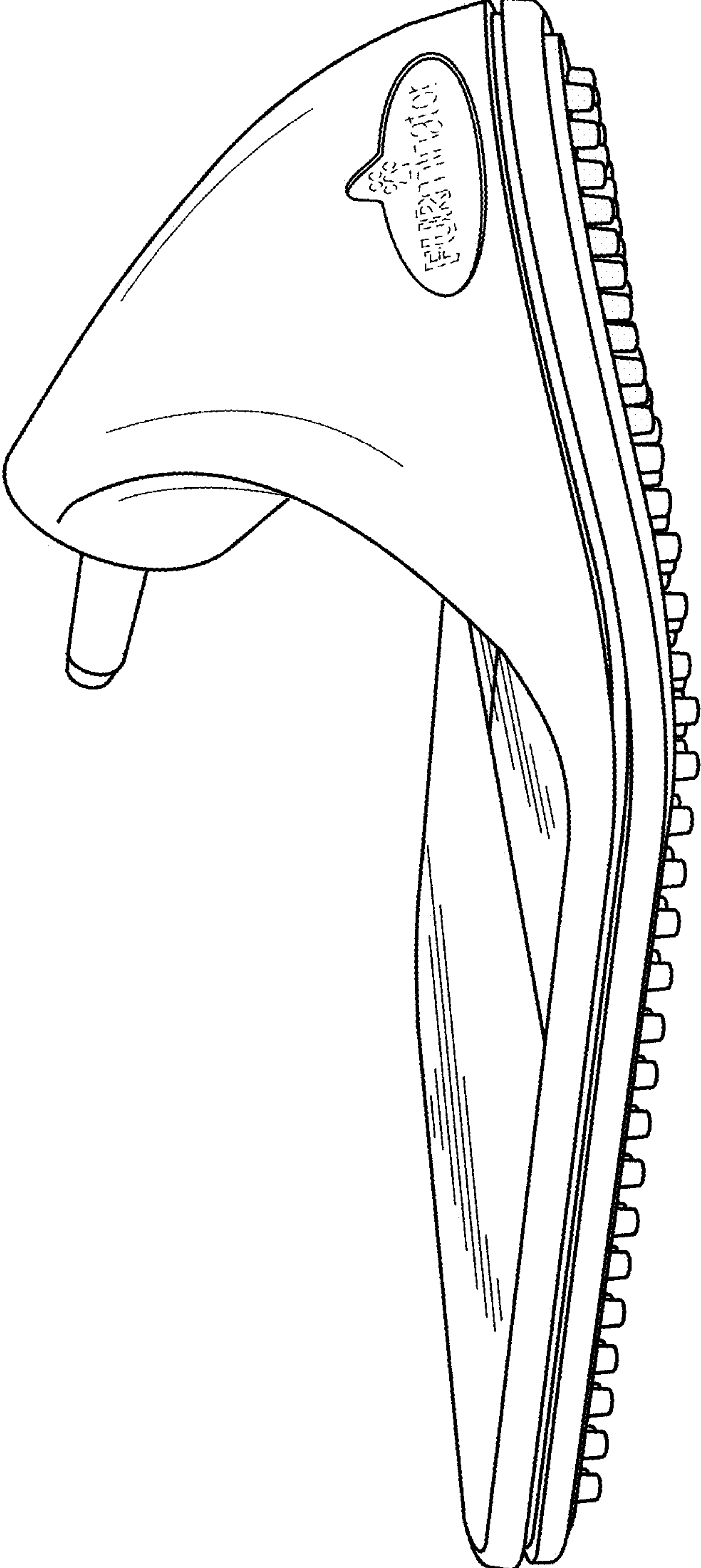
