DESCRIPTION

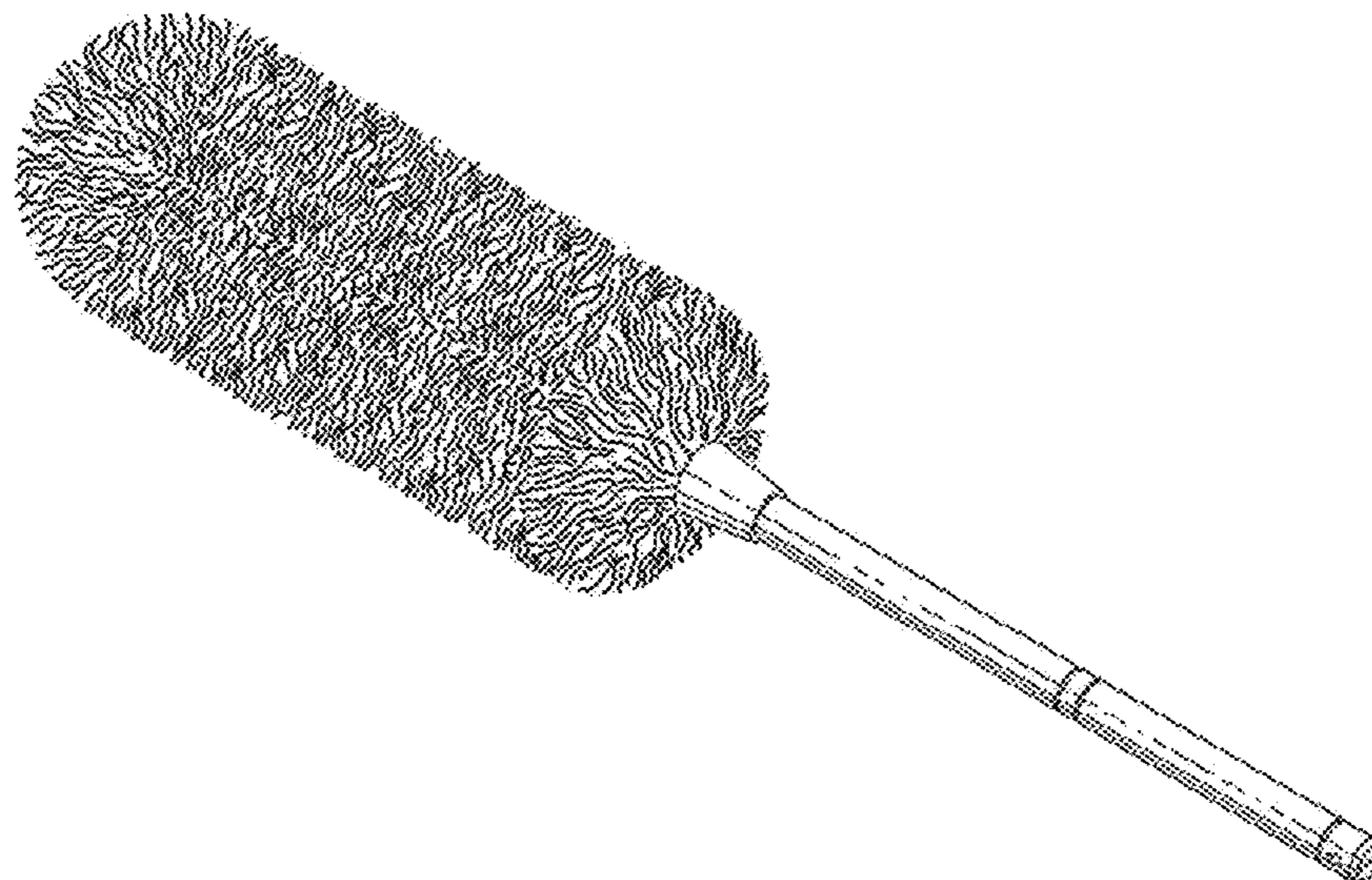
FIG. 1 is a perspective view of a handle of a dusting tool according to my new design;

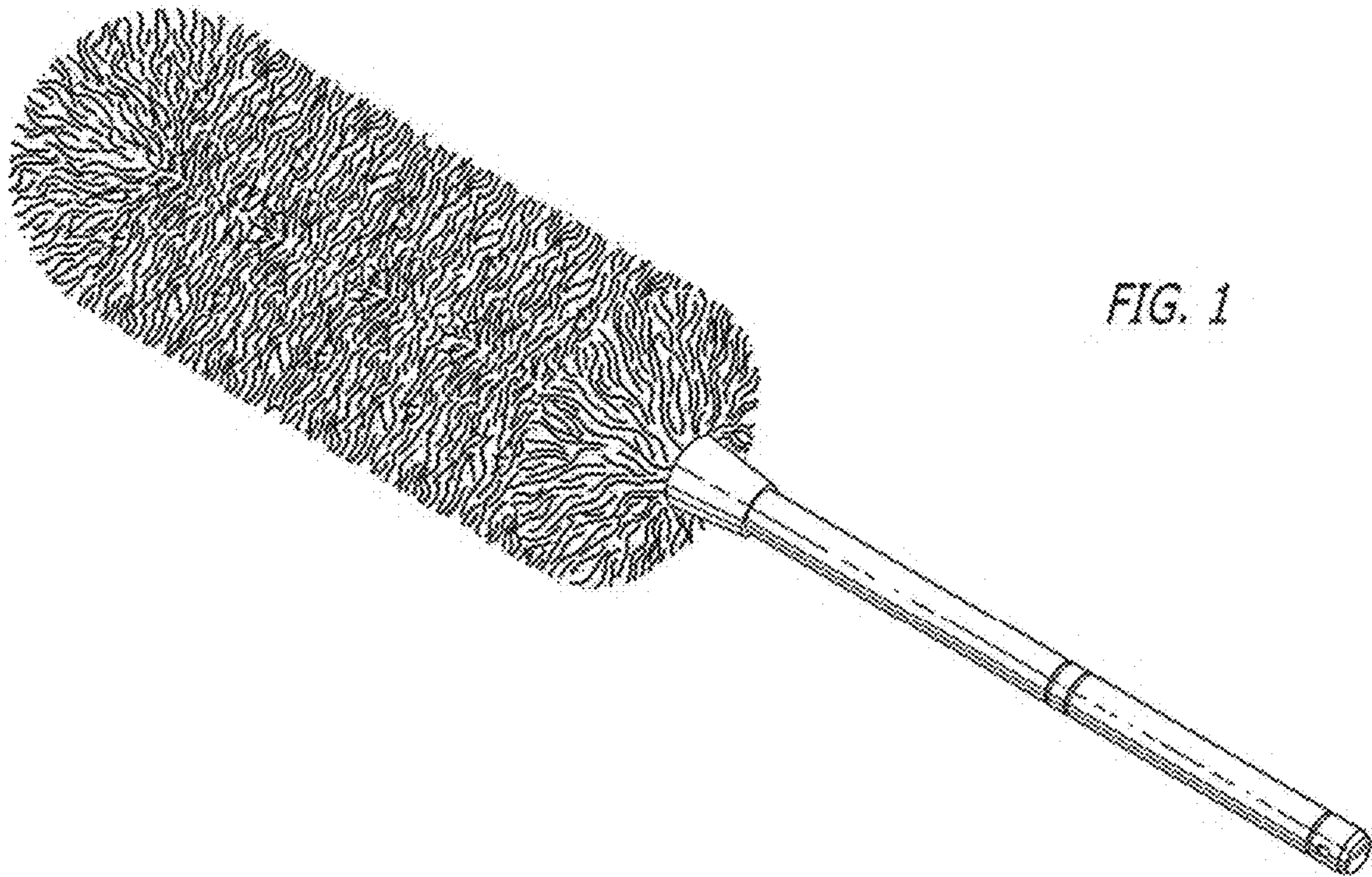

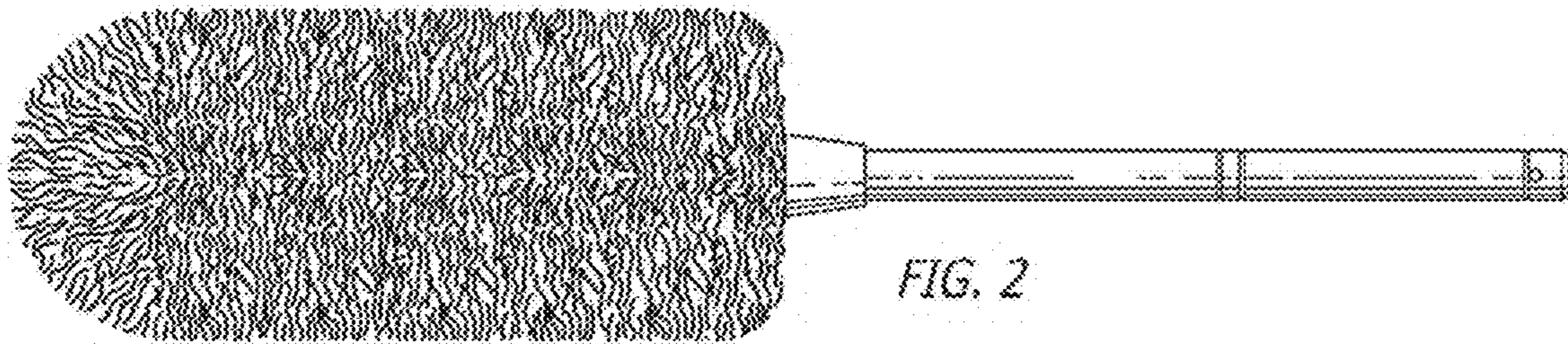

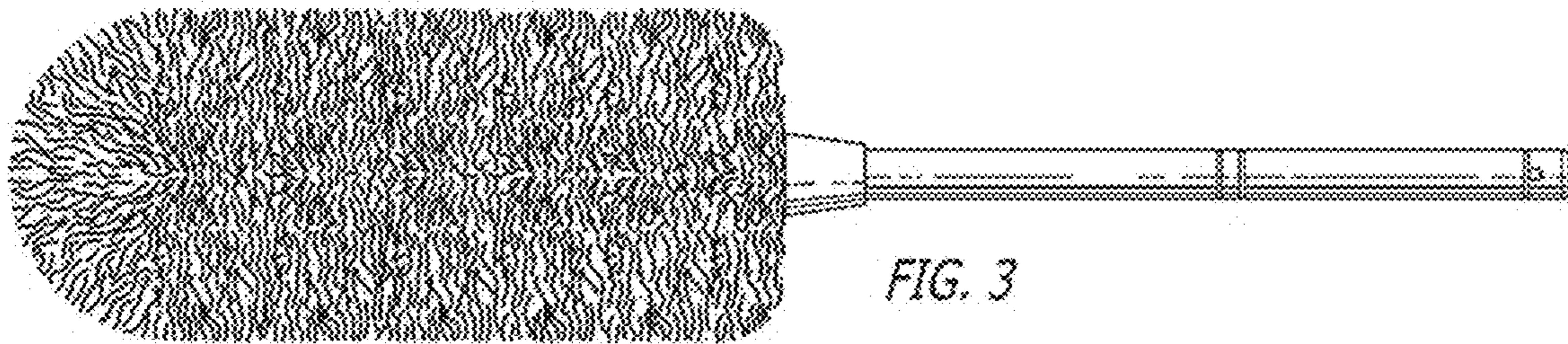

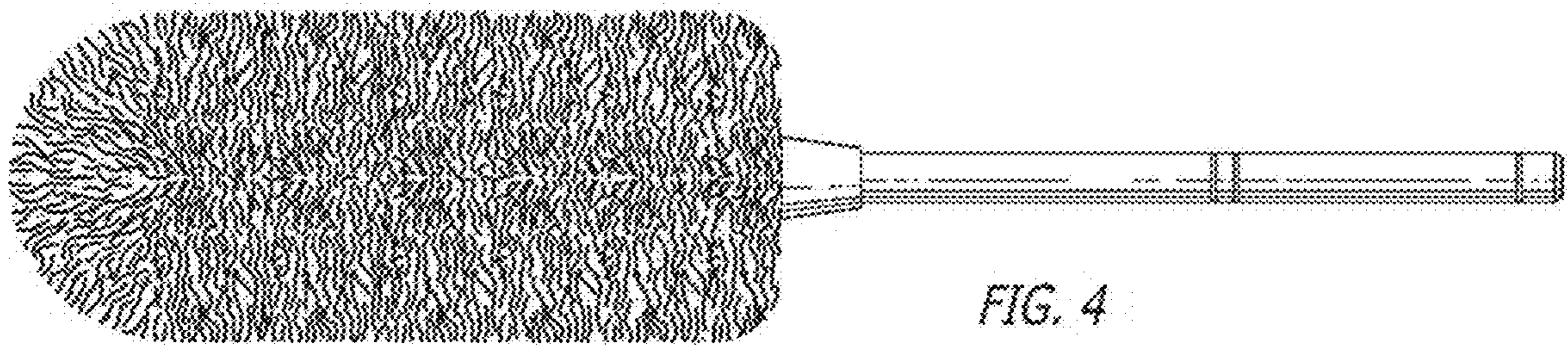

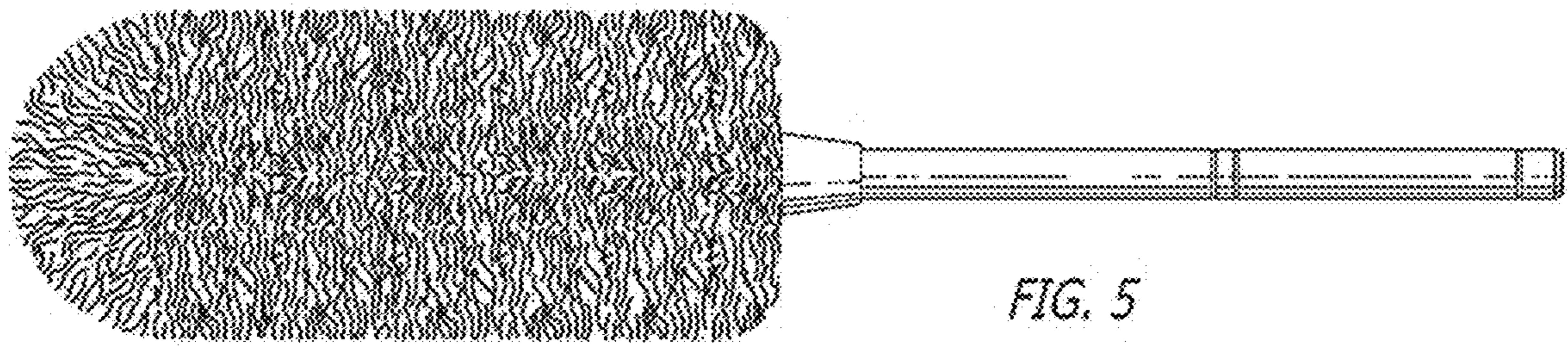

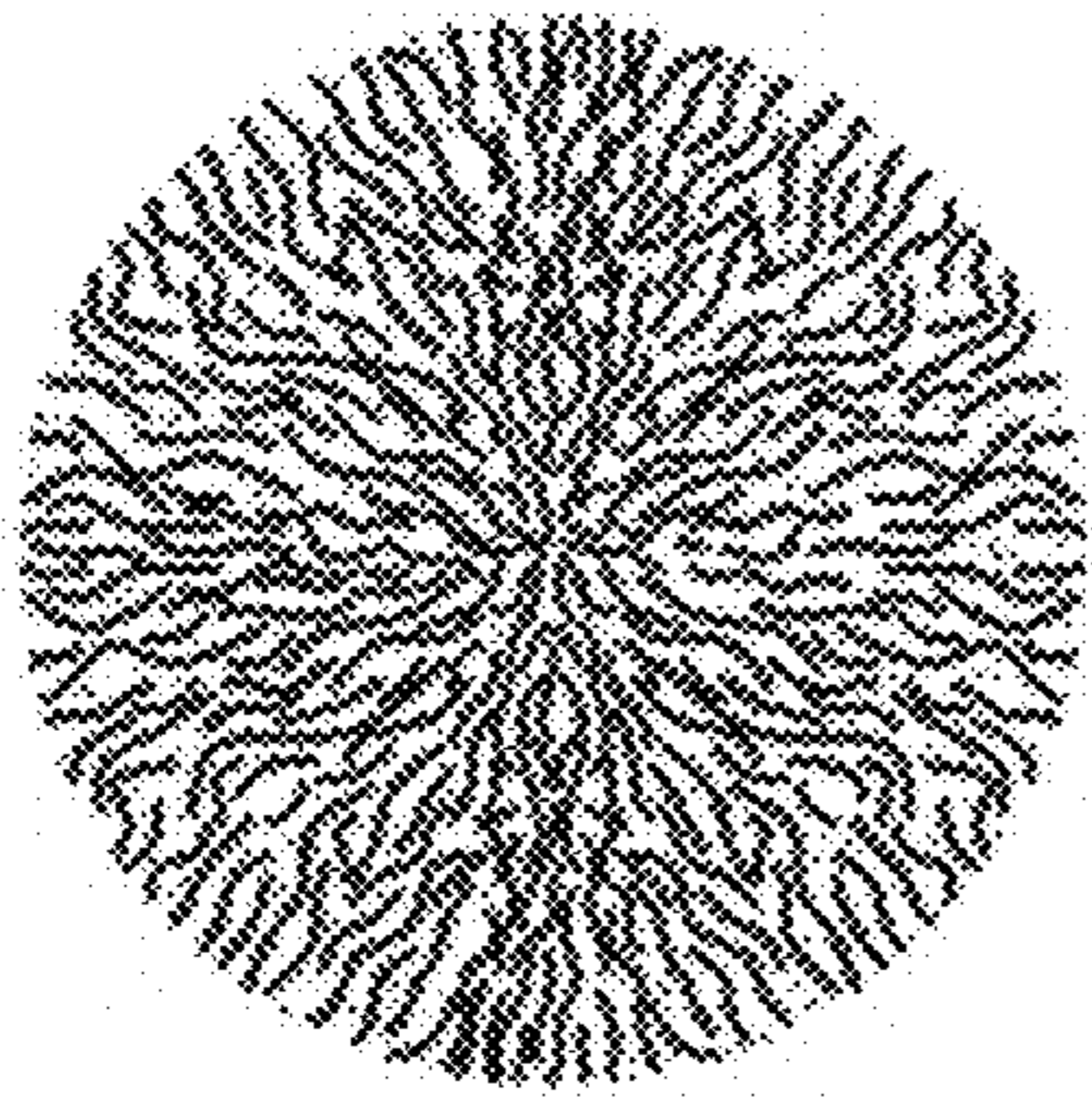

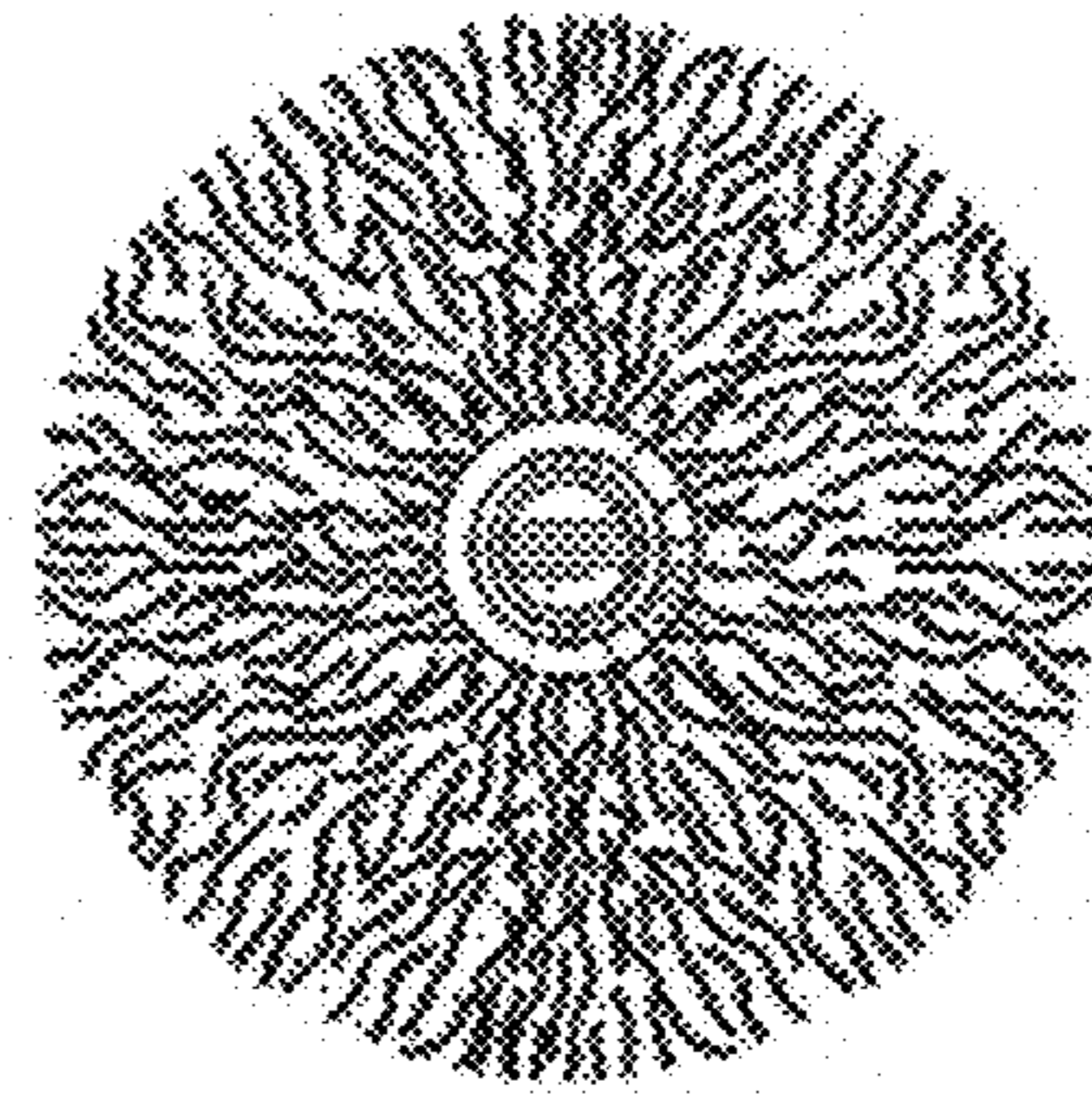
